FIG. 4 is a bottom, right-side perspective view thereof;

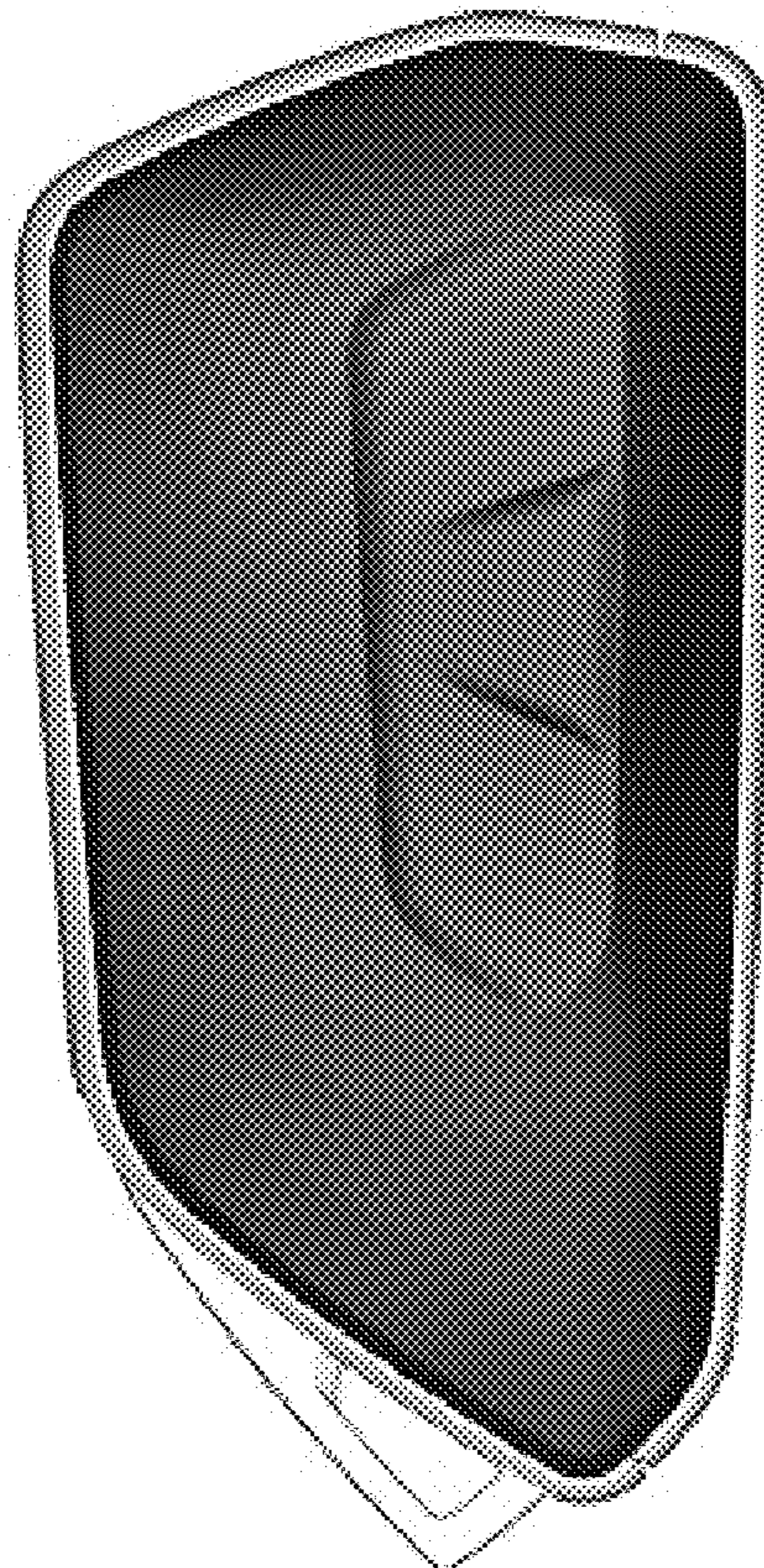
FIG. 5 is a left side view thereof;

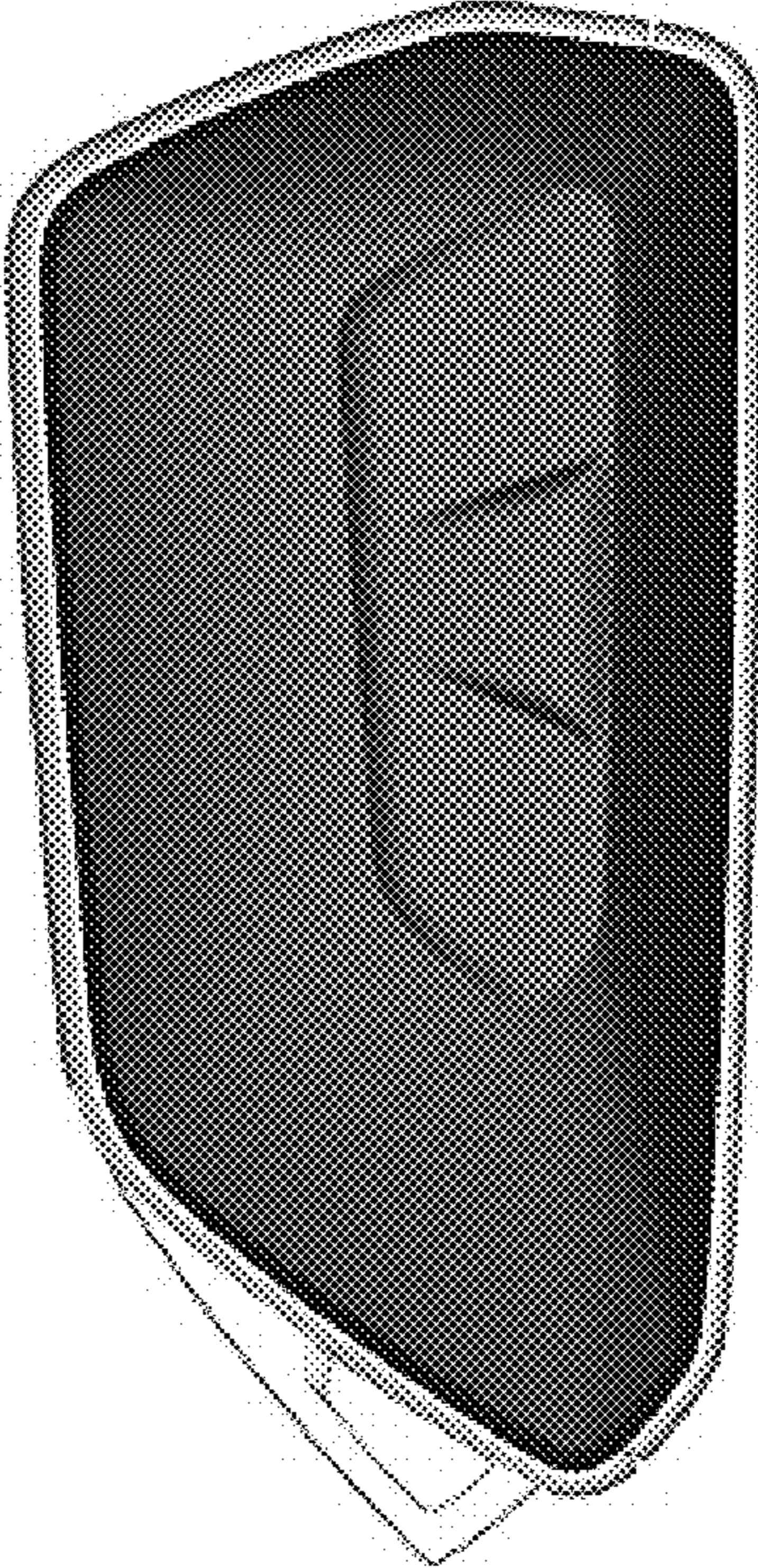

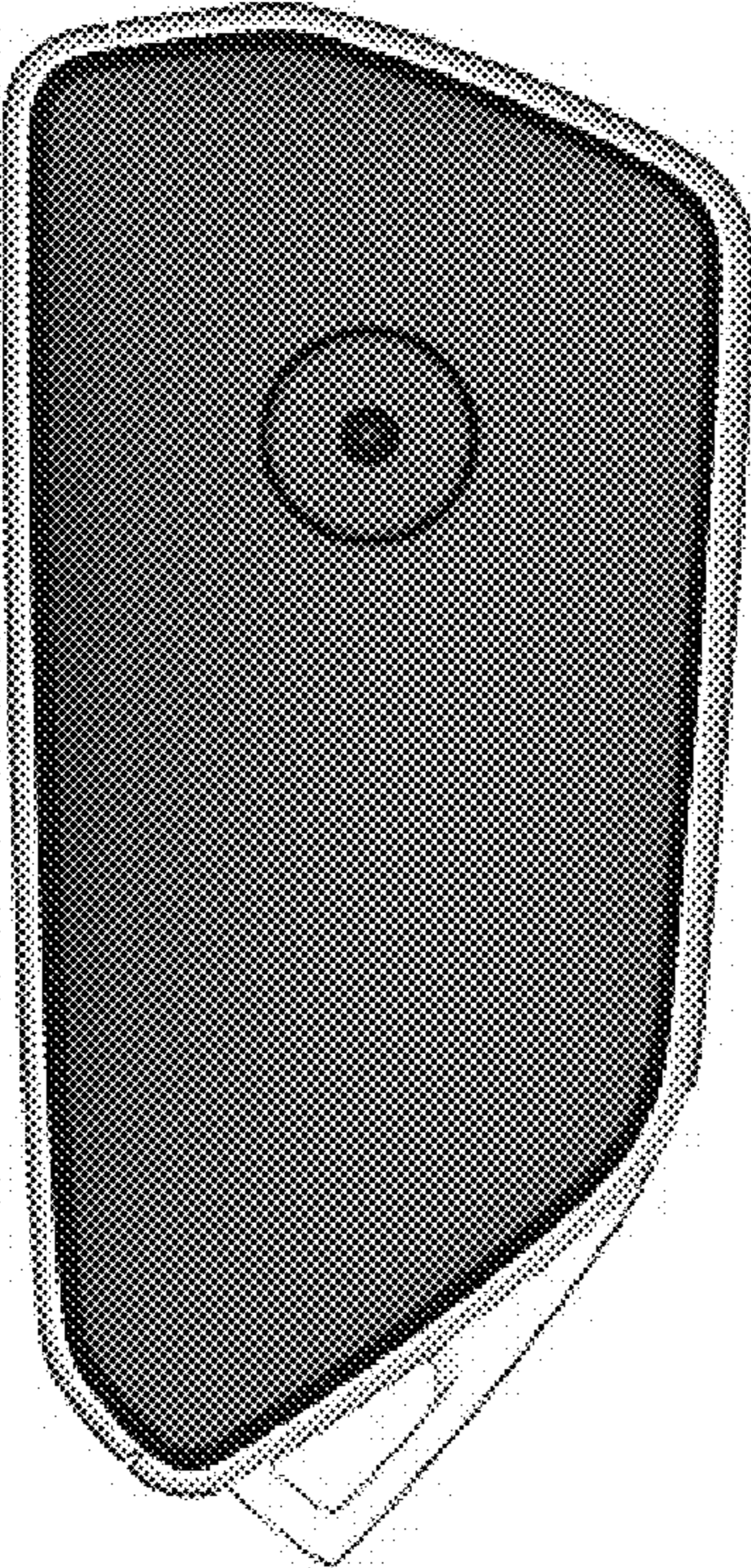

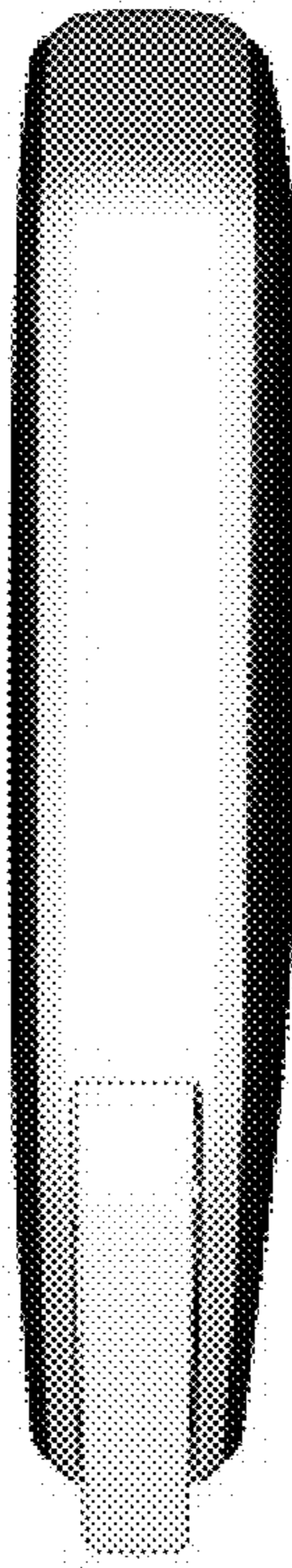

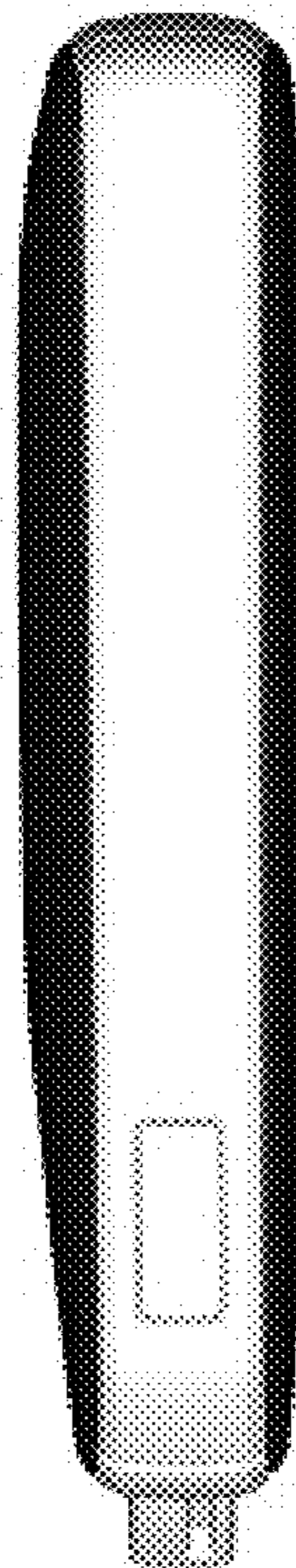

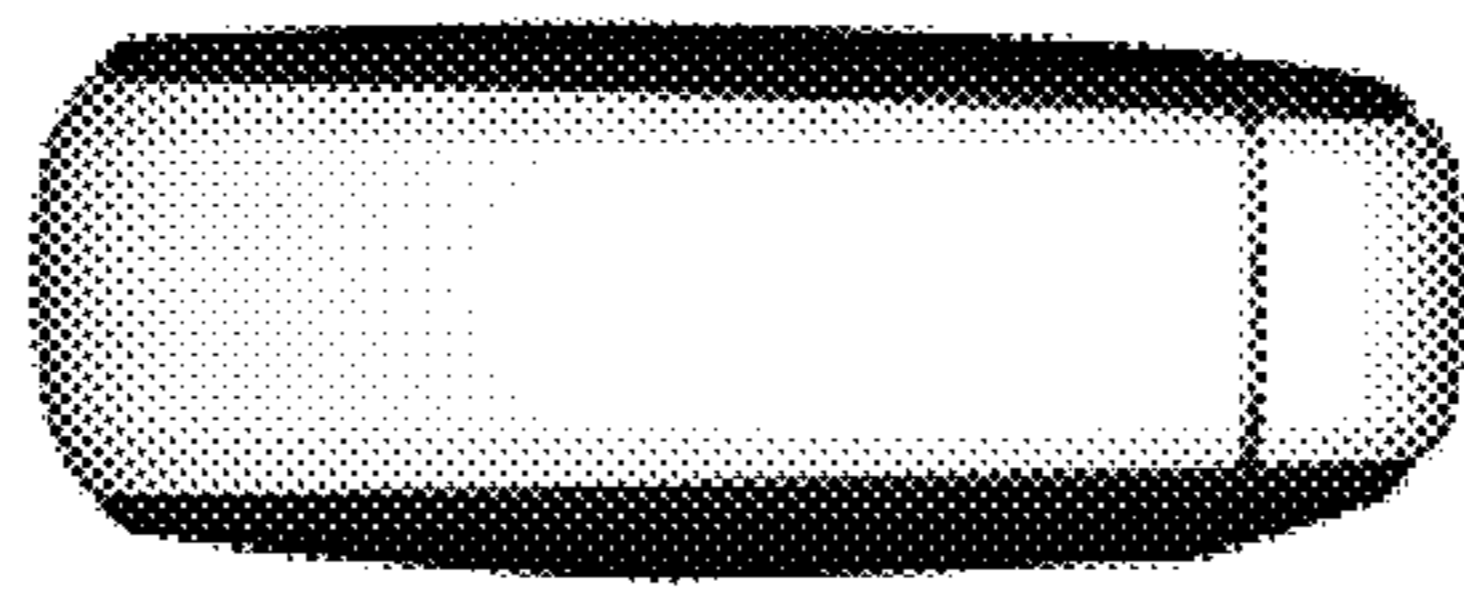

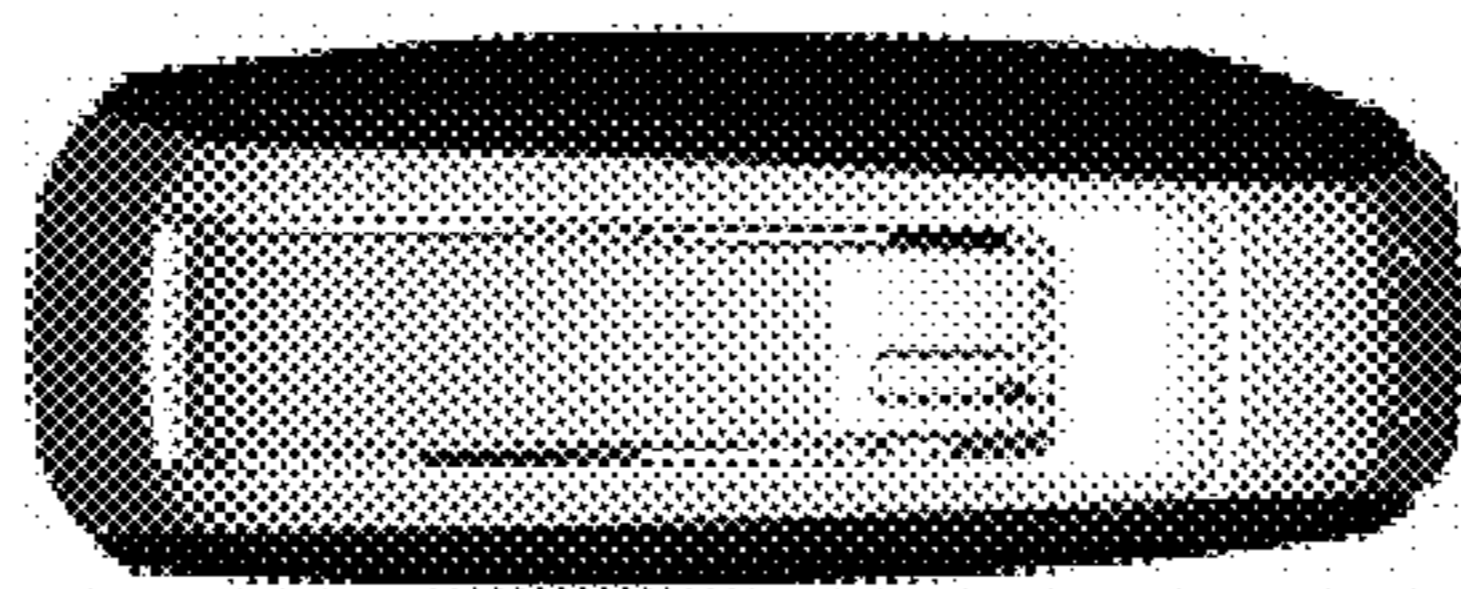
