(57) **CLAIM**

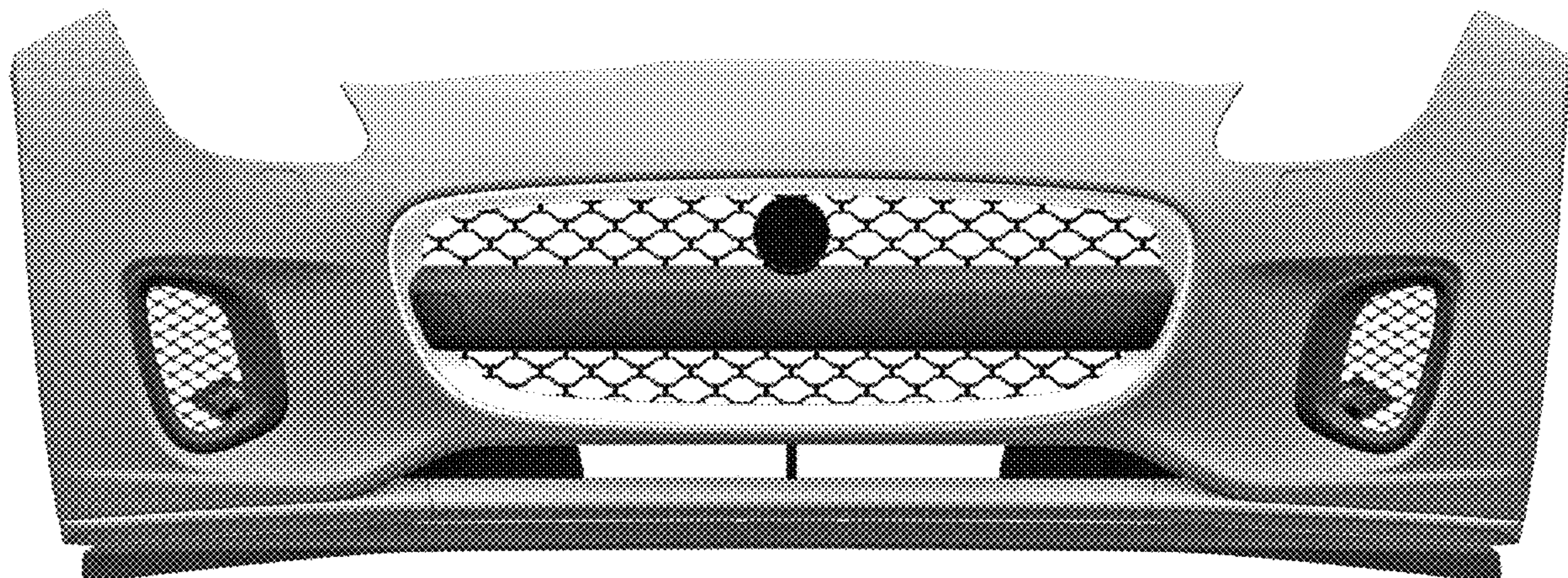
The ornamental design for a front bumper, as shown and described.

**DESCRIPTION**

FIG. 1 is a right, front perspective view of a front bumper showing our new design;

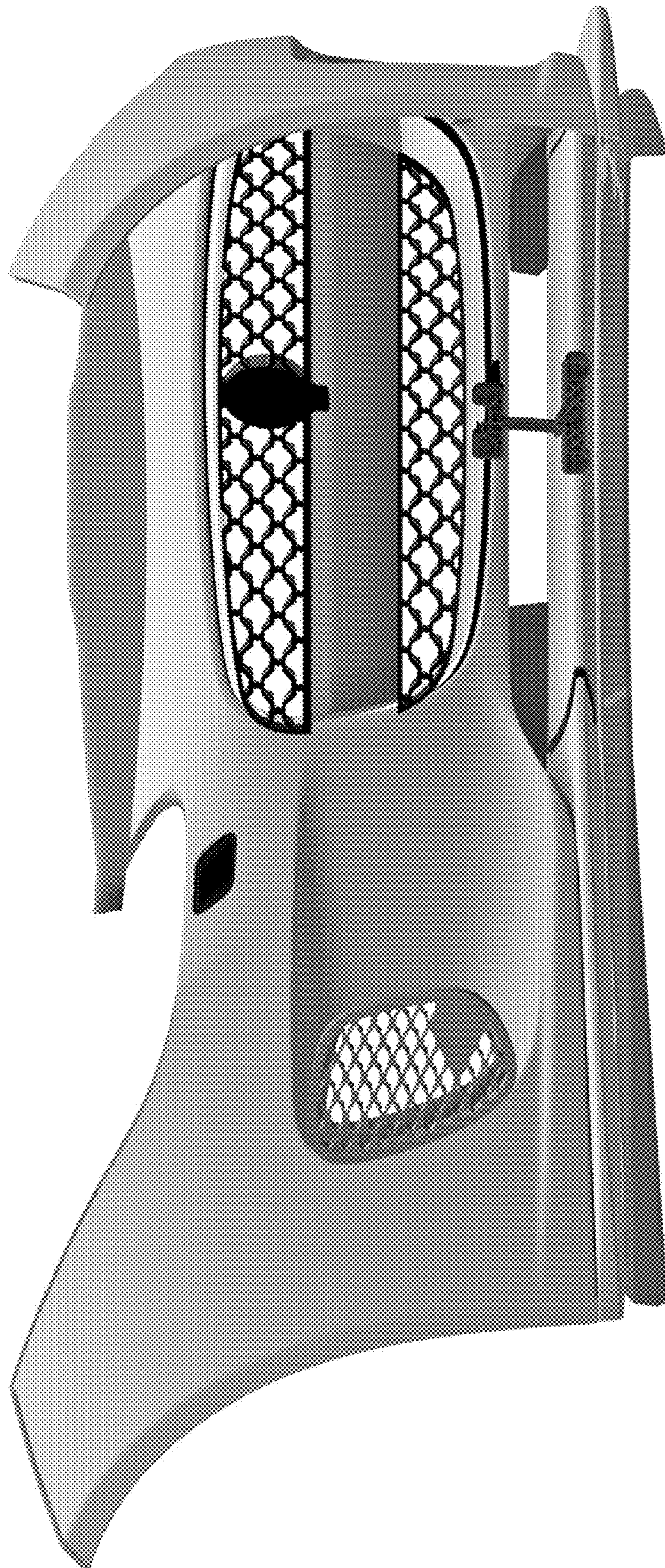

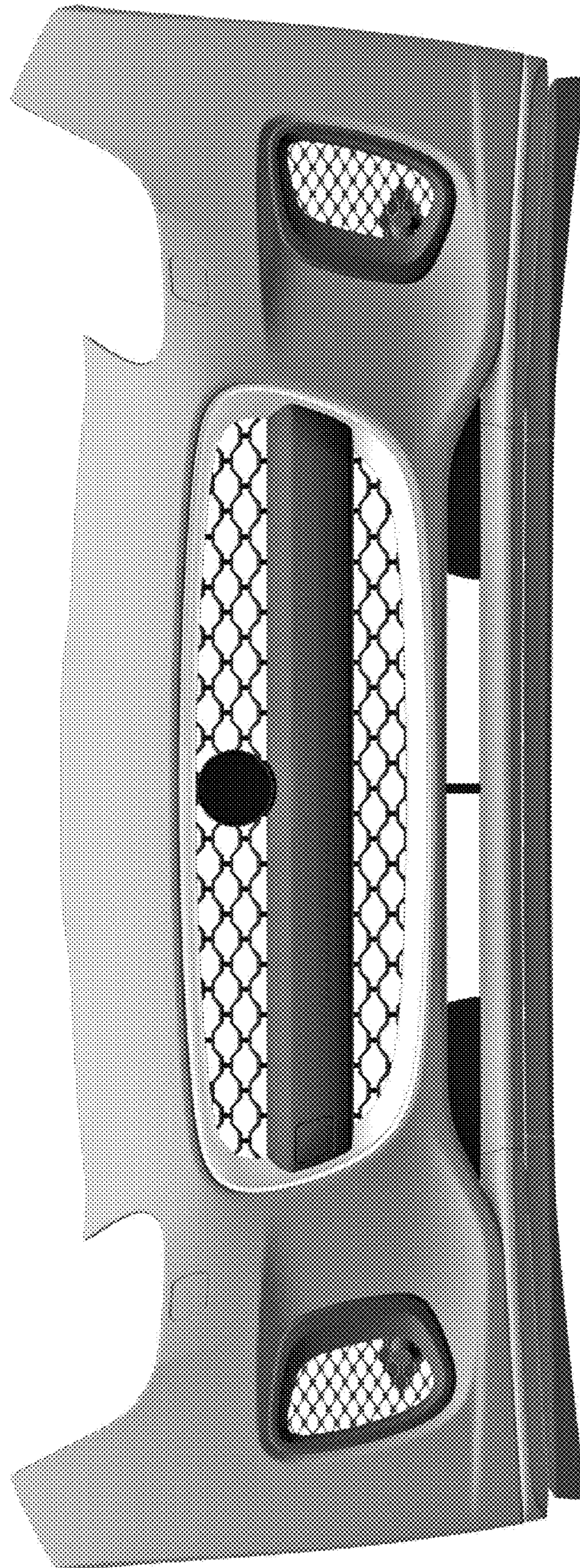

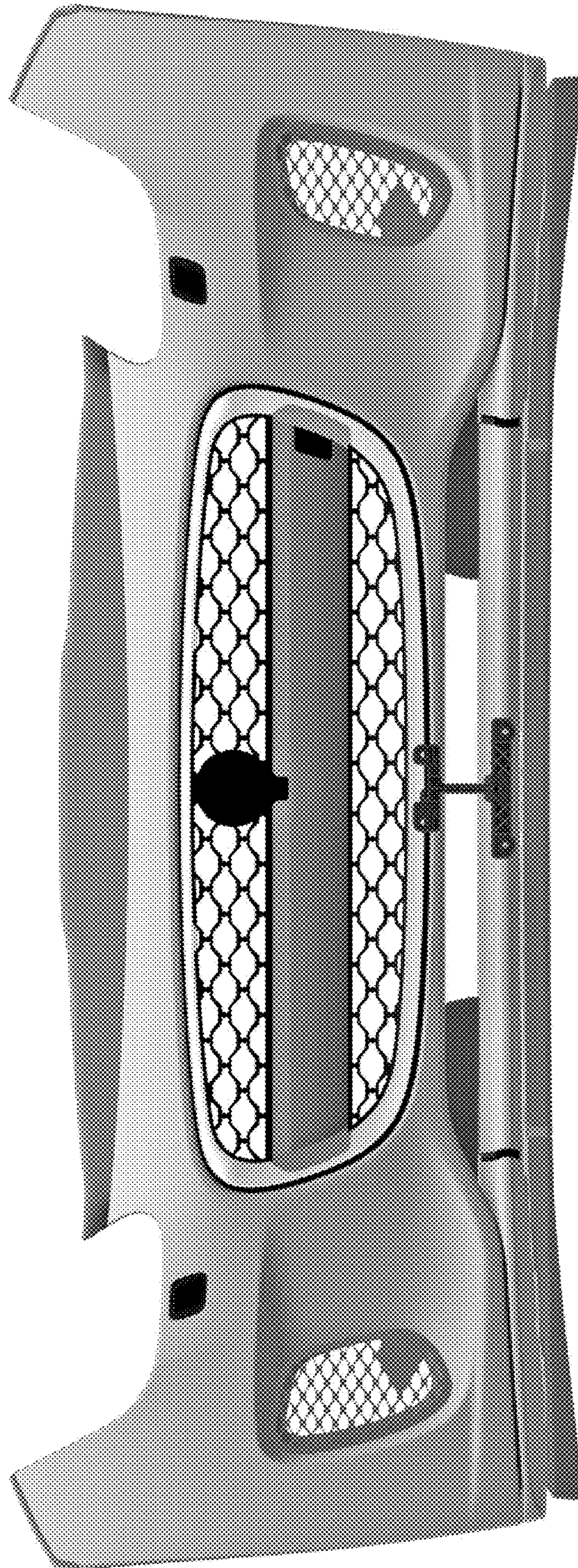

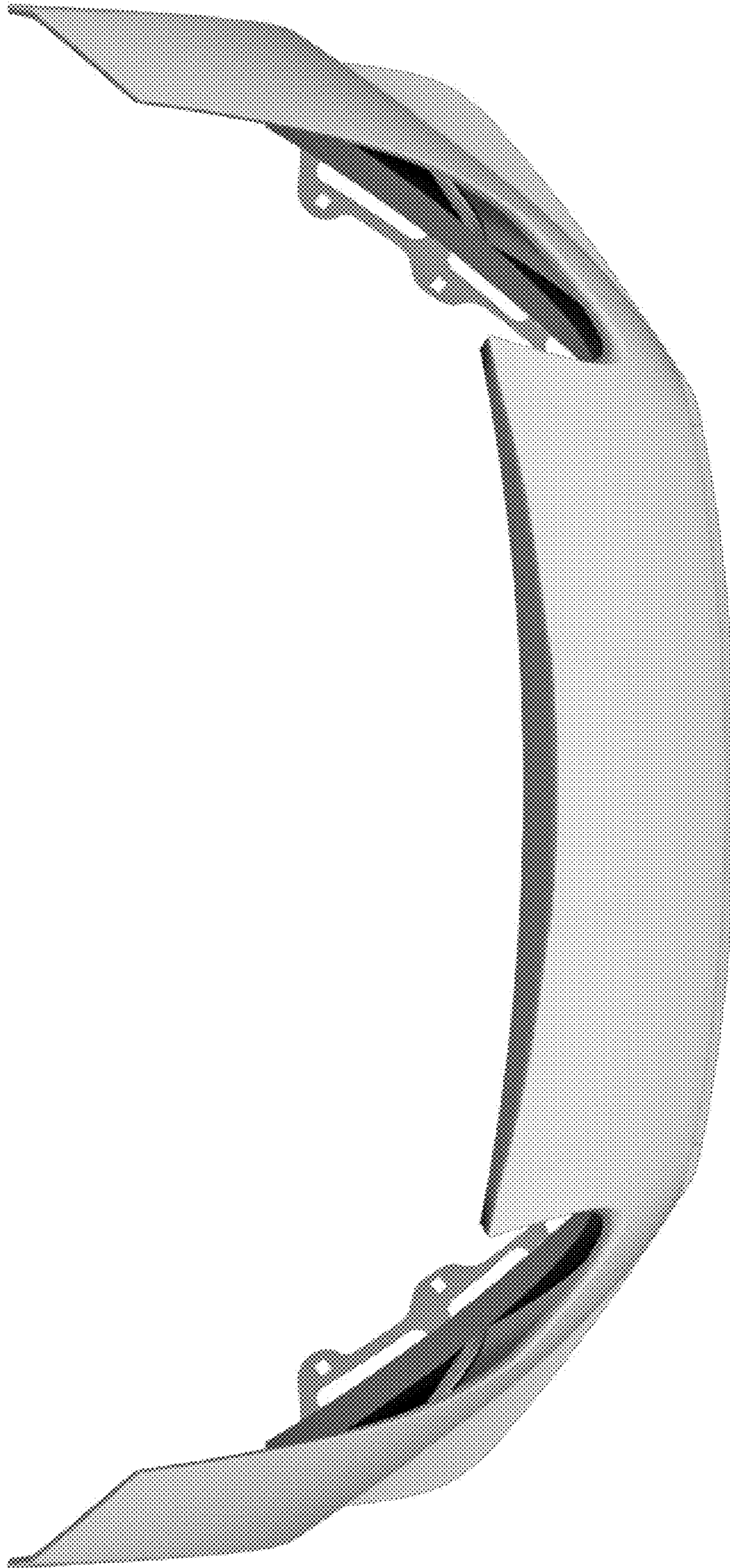

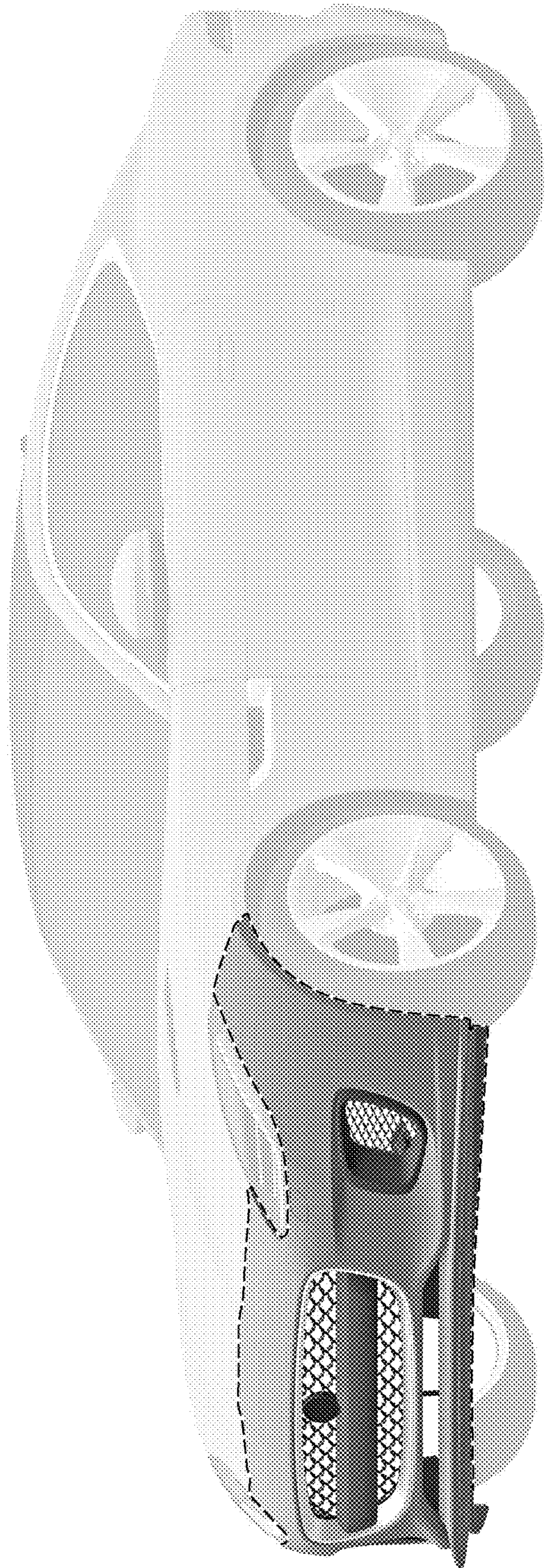
