The ornamental design for an aircraft fuselage, substantially as shown and described.

**DESCRIPTION**

FIG. 3 is a top plan view of the aircraft fuselage as shown in FIG. 1;

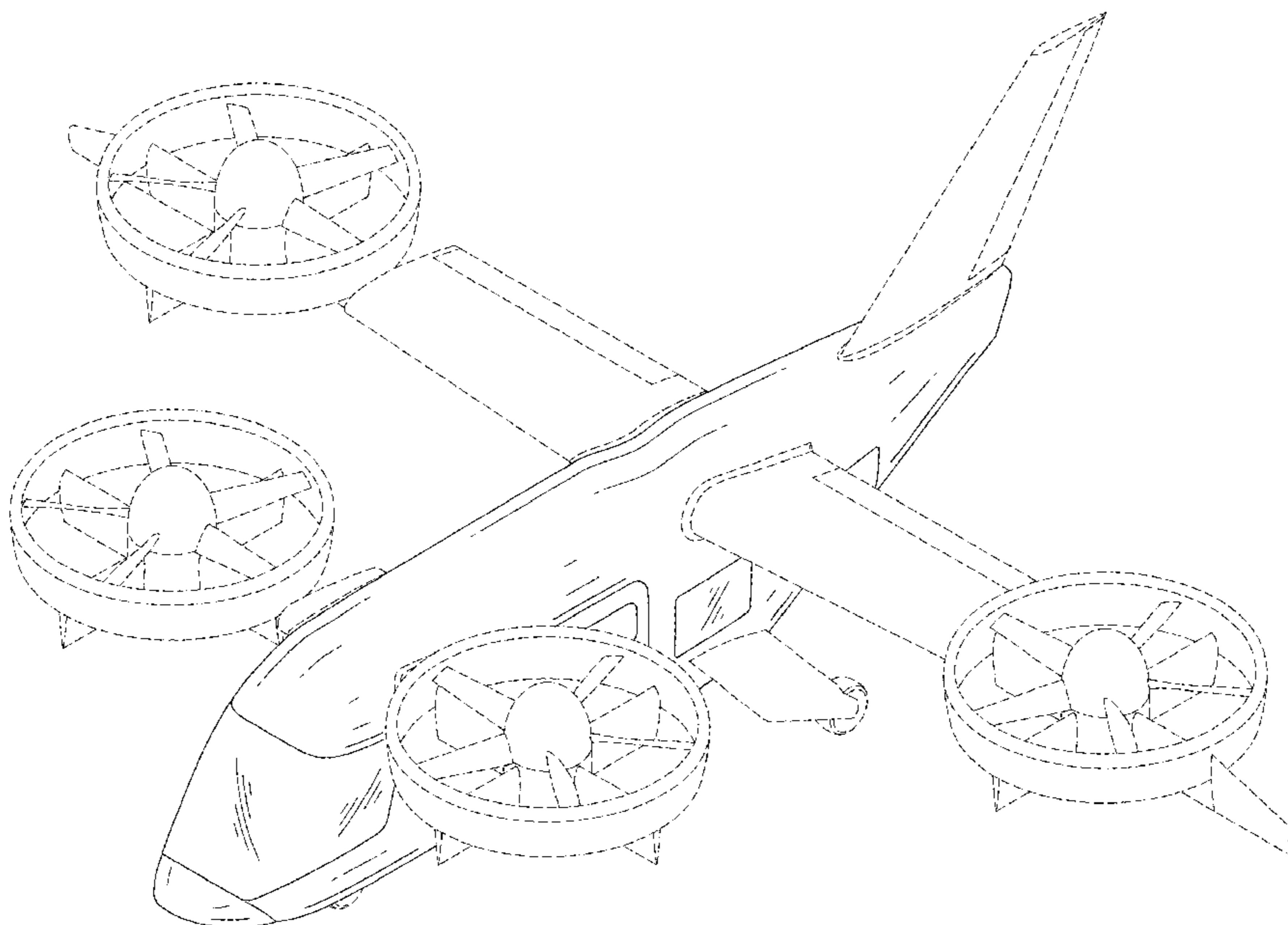
FIG. 4 is a front elevational view of the aircraft fuselage as shown in FIG. 1;

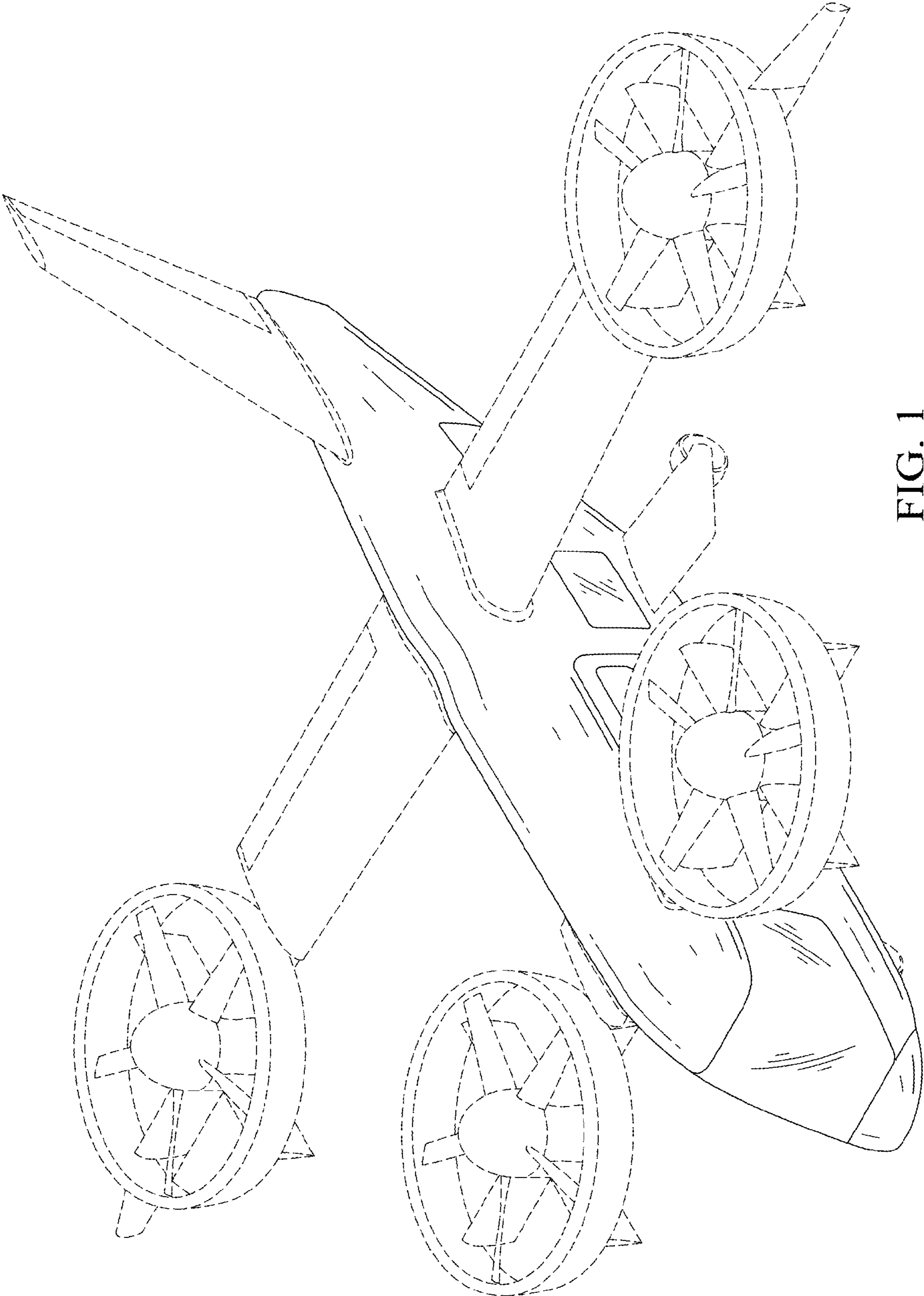

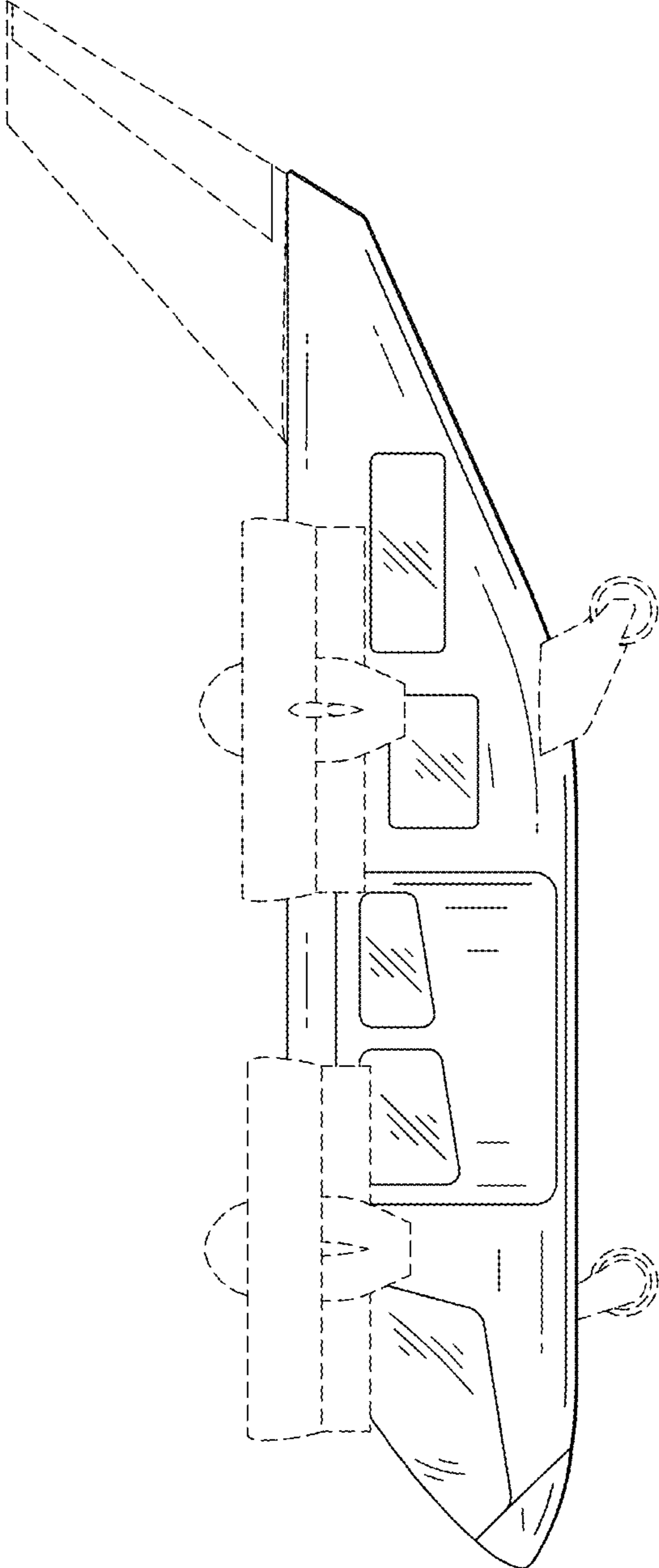
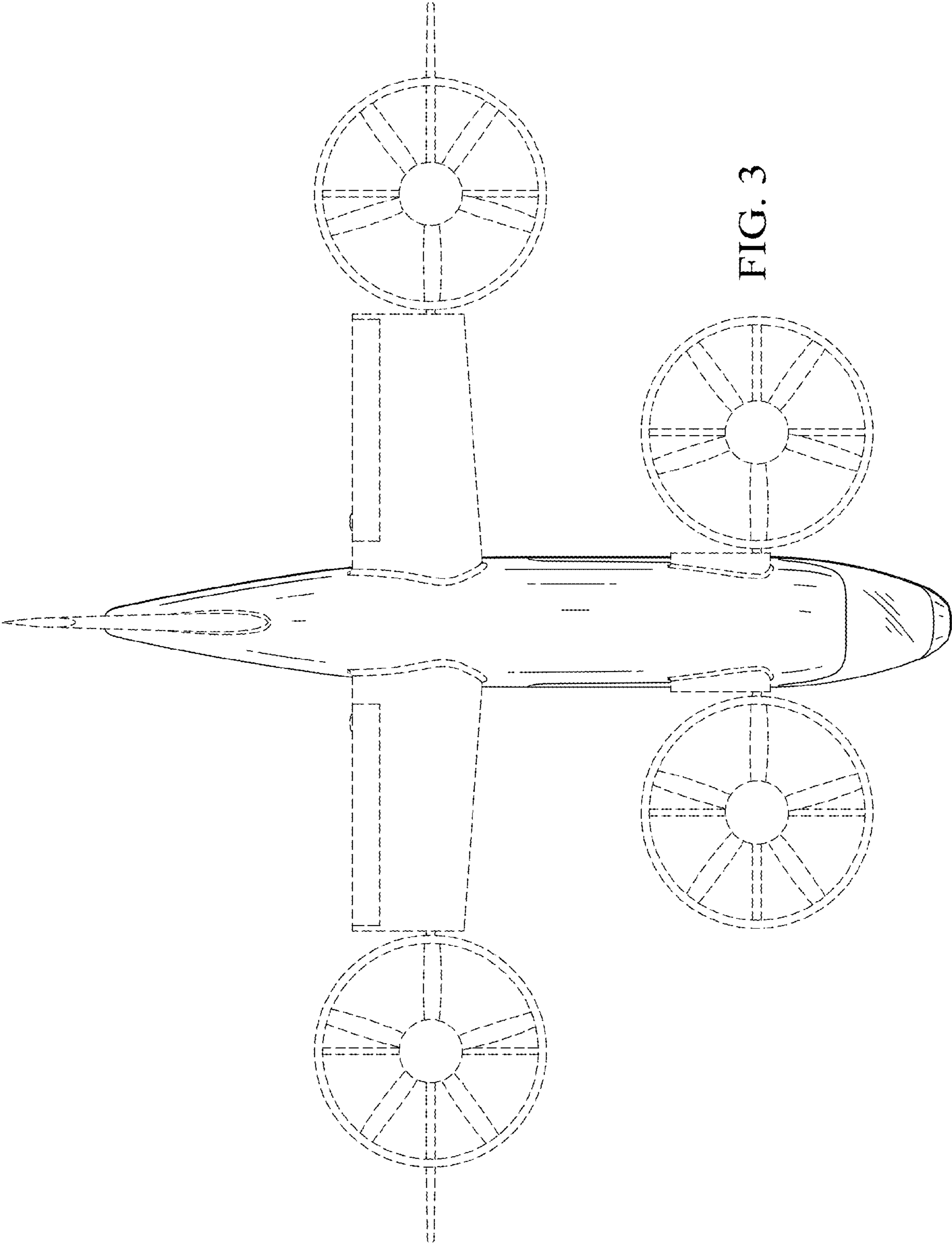

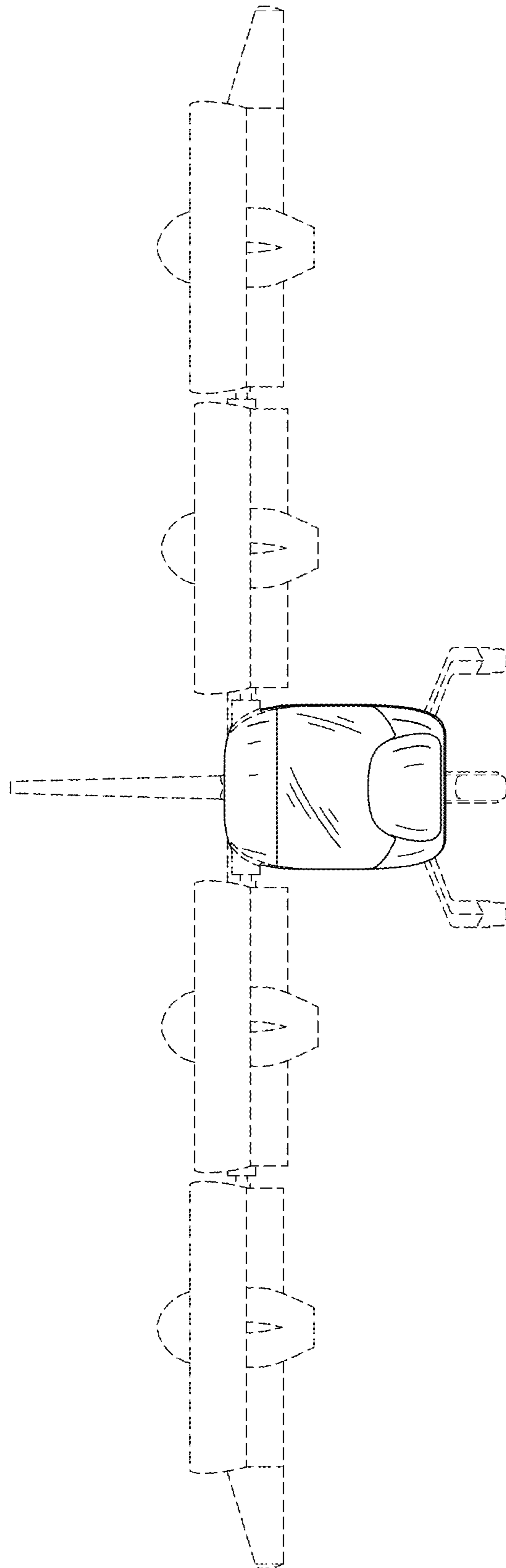

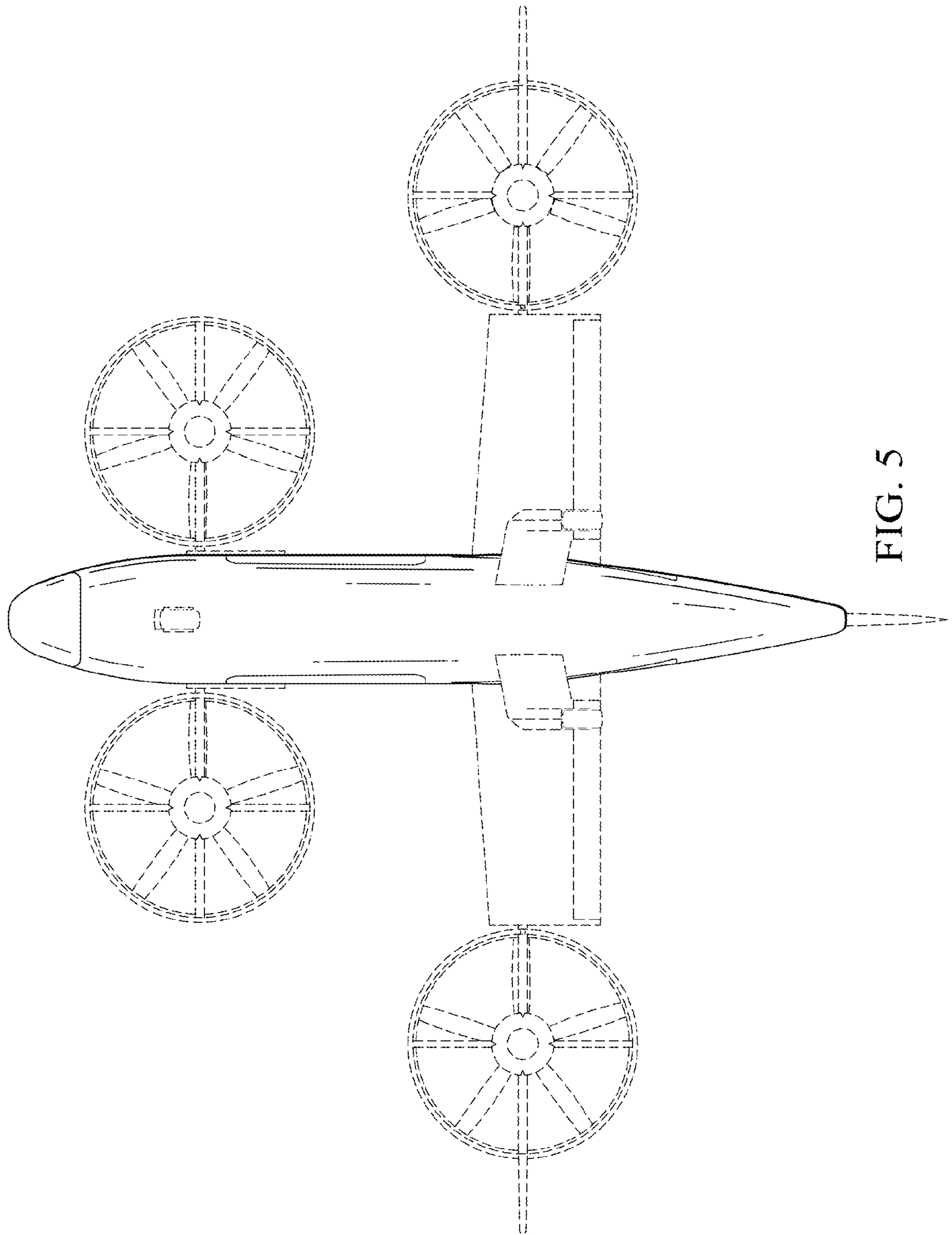

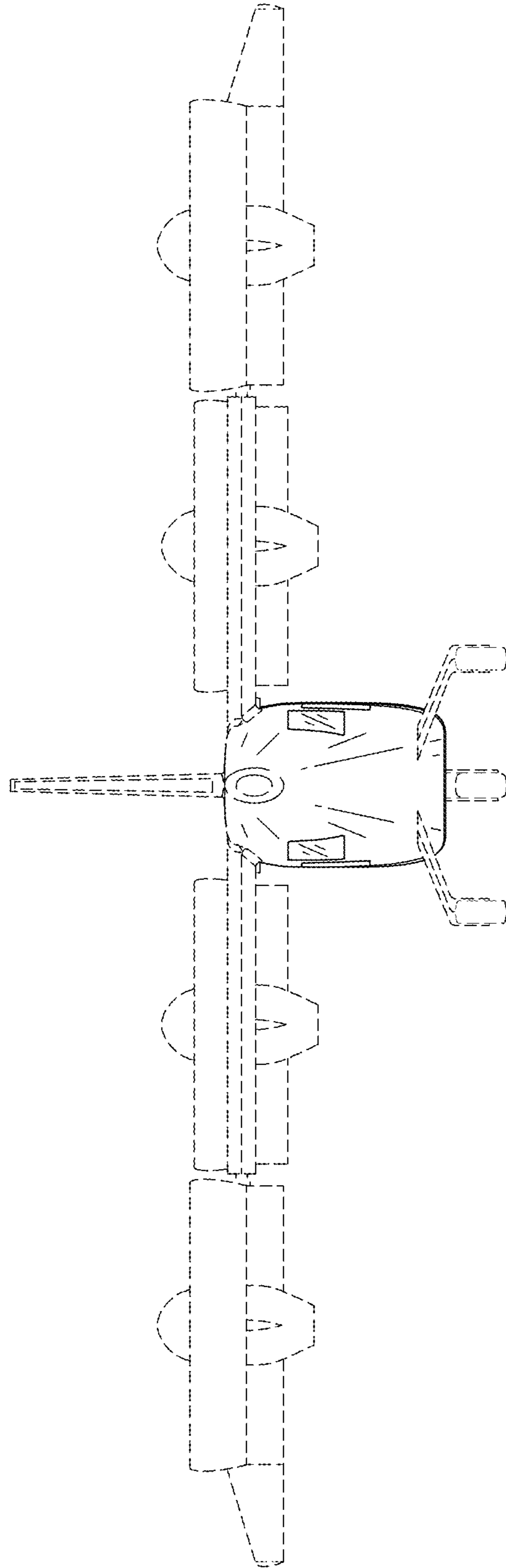
