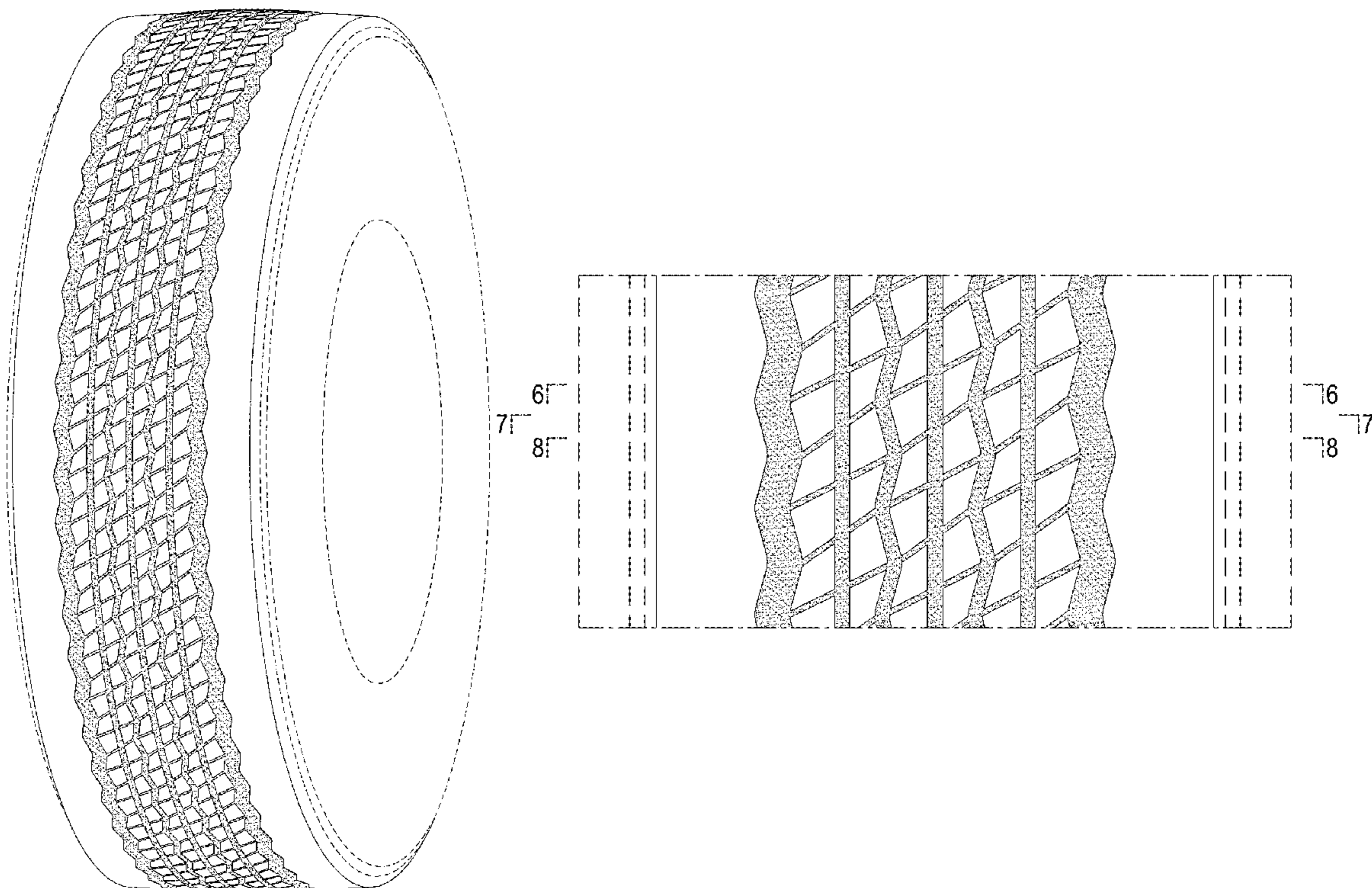
- (57) **CLAIM**

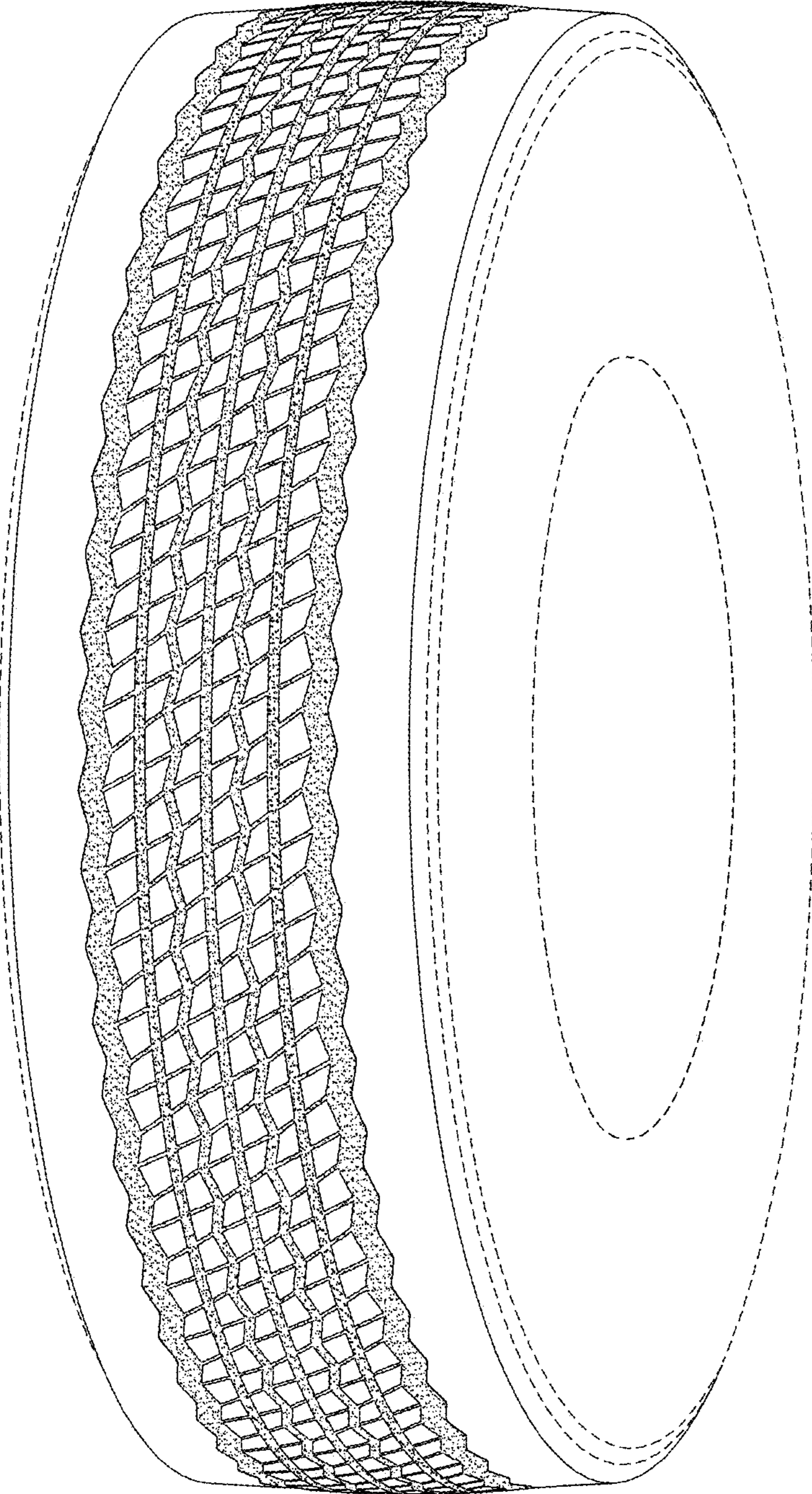

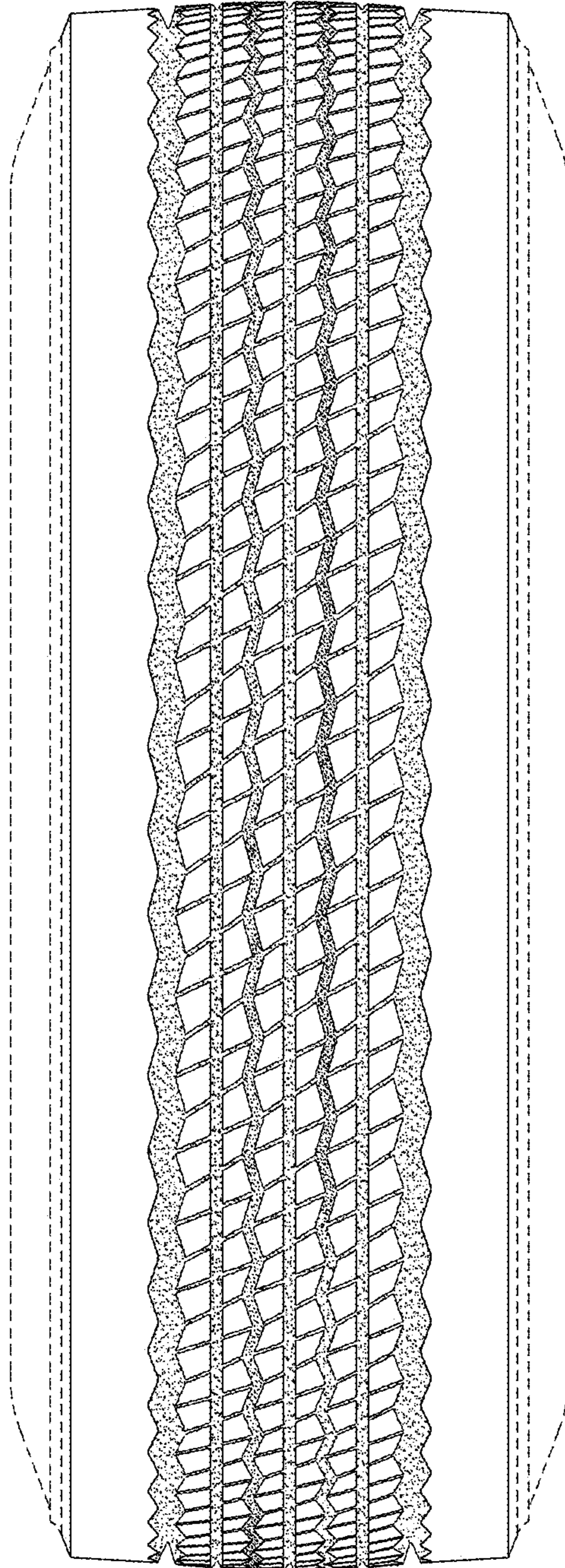

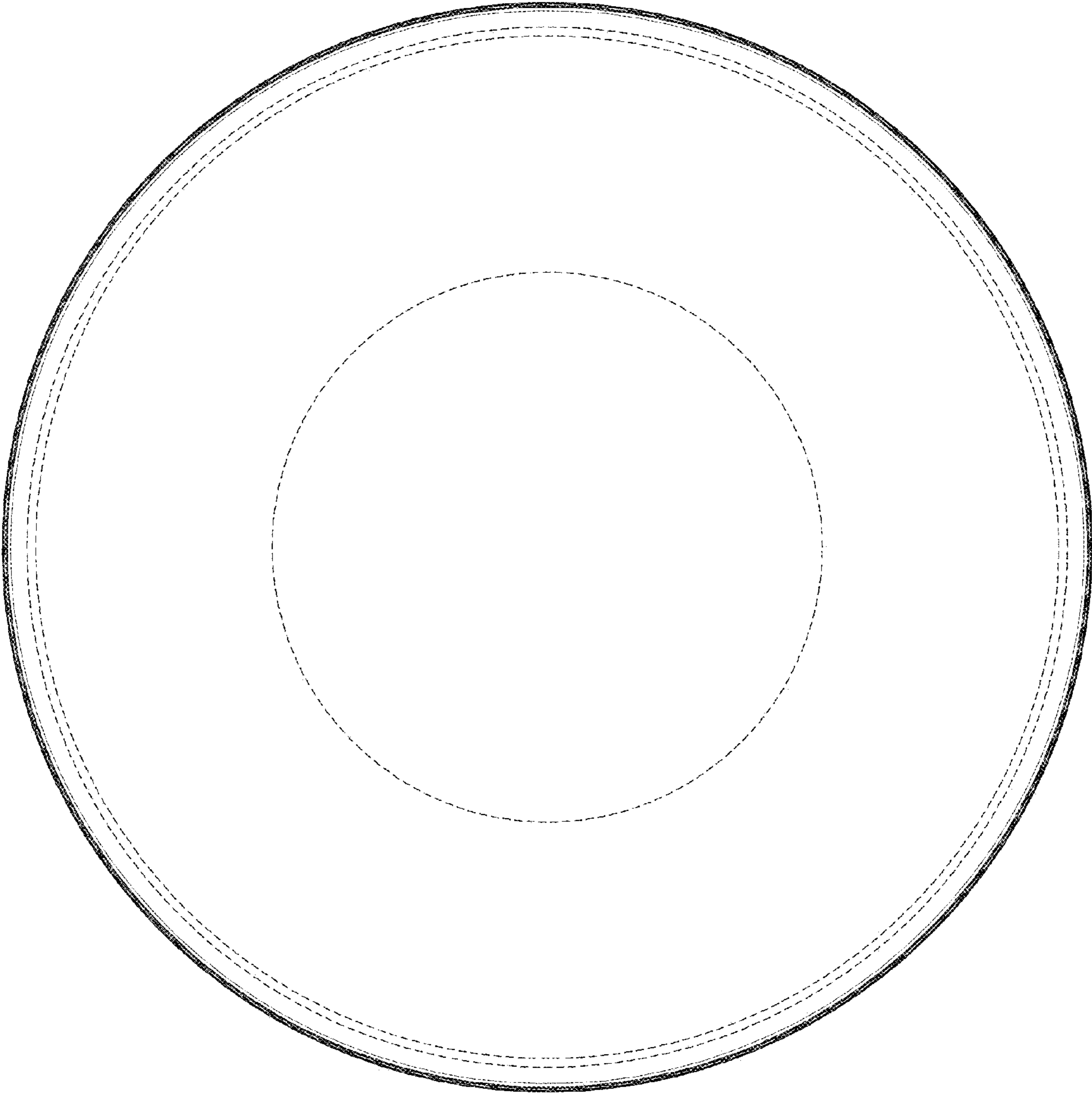

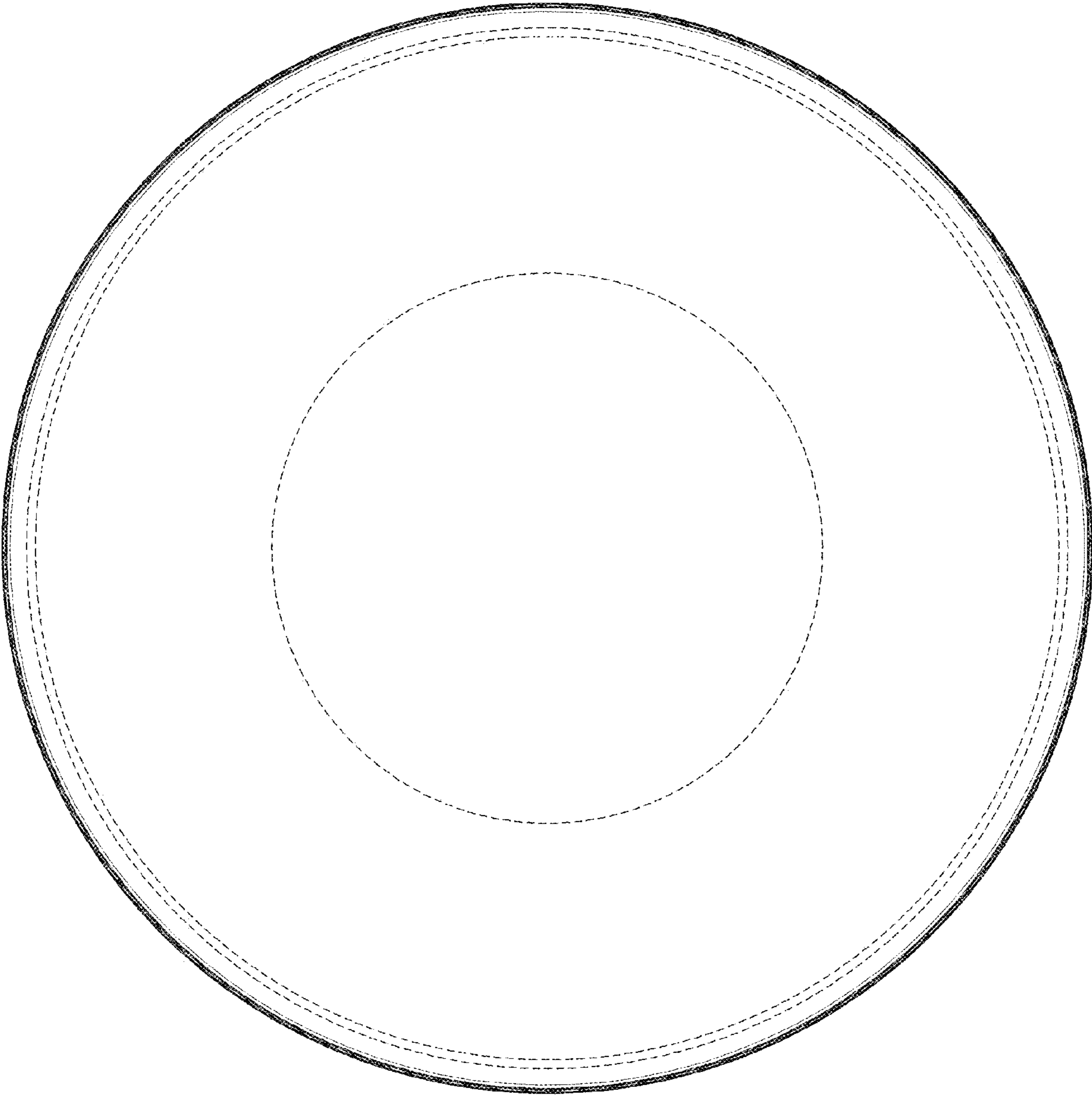

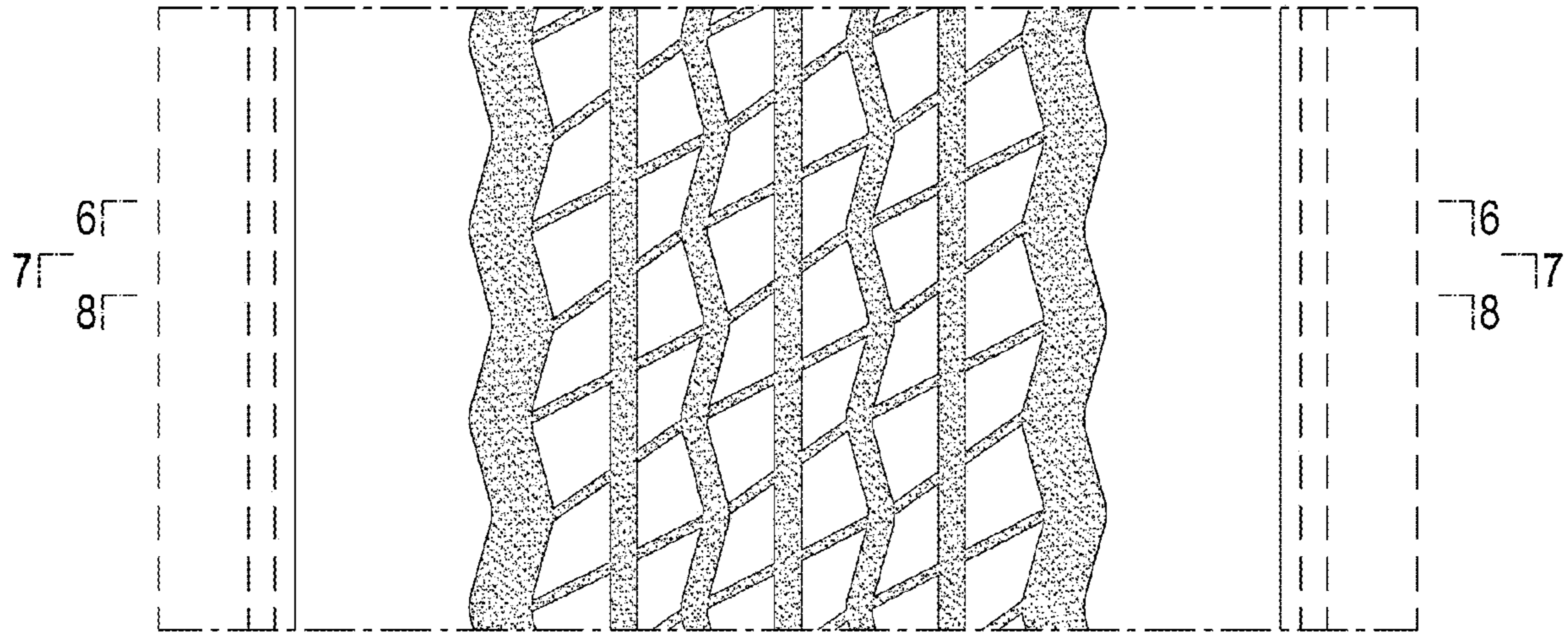

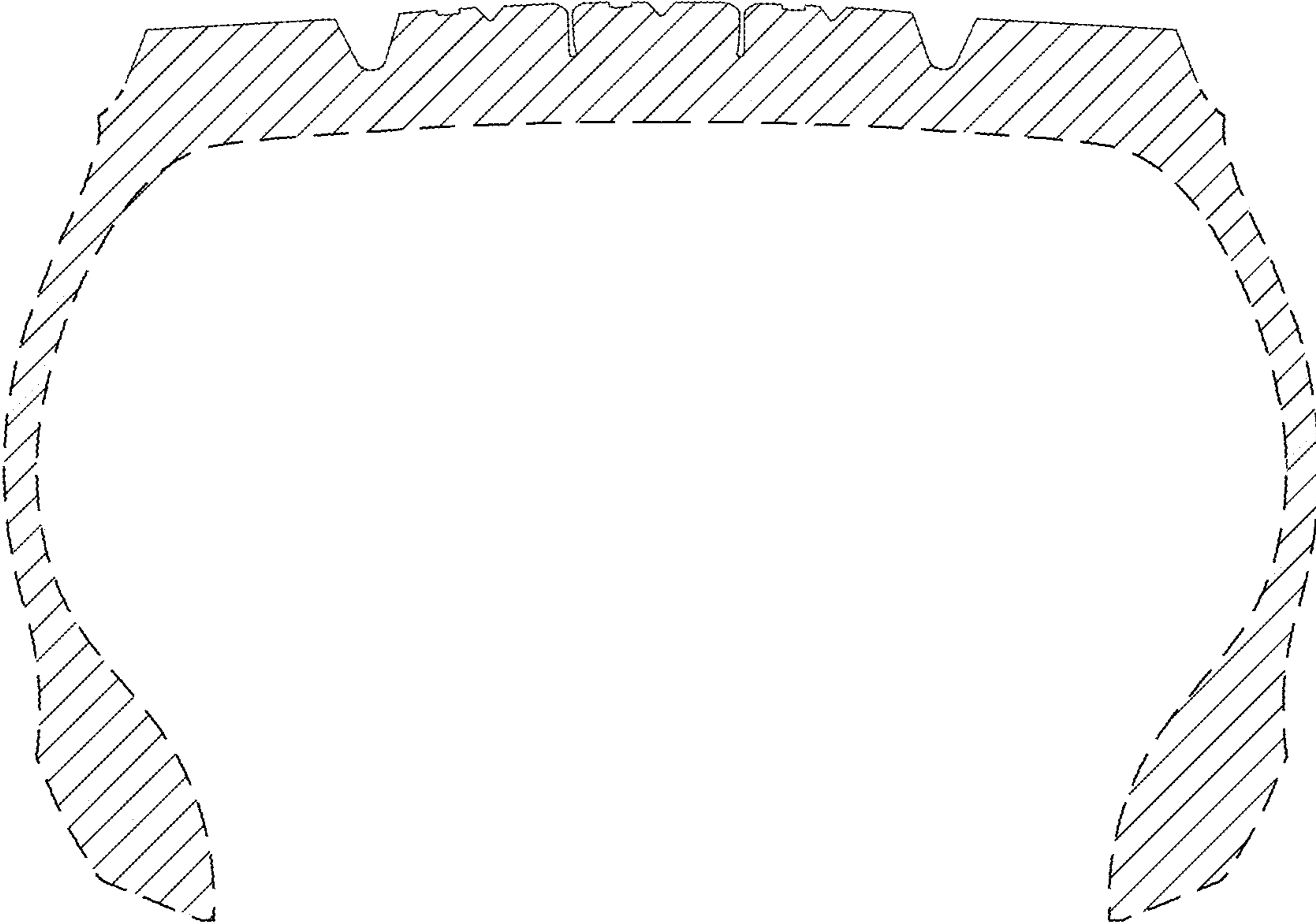

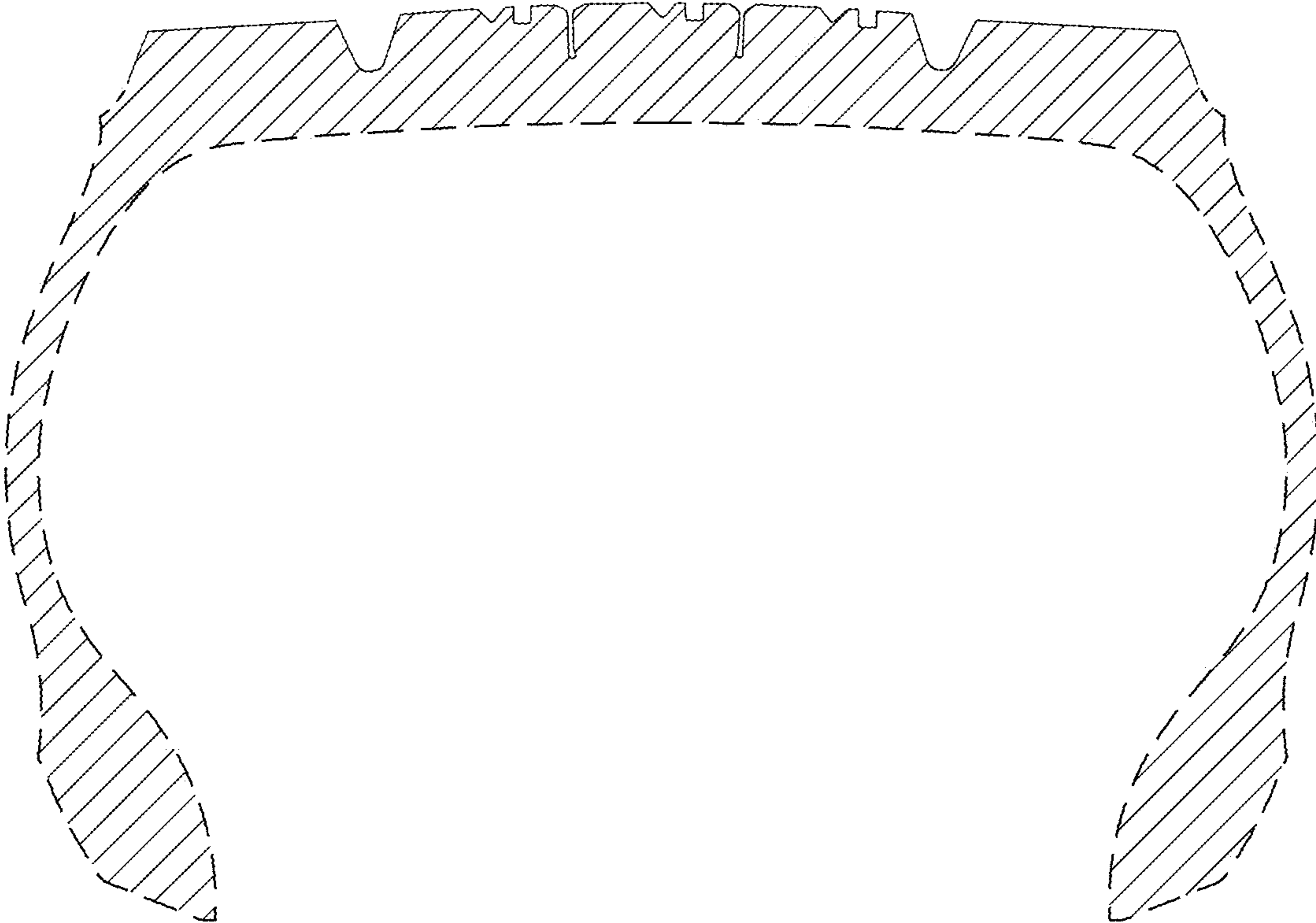

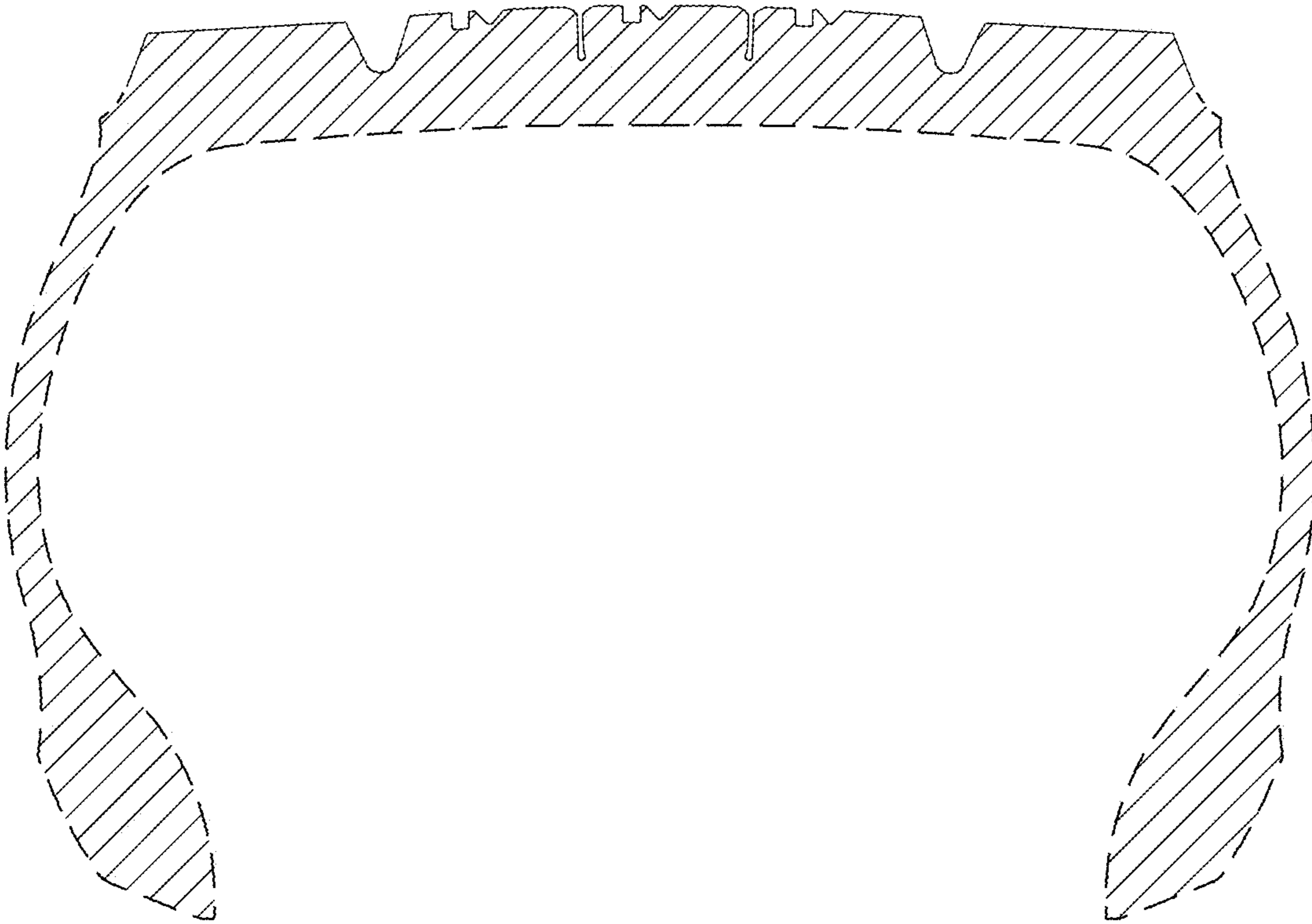
