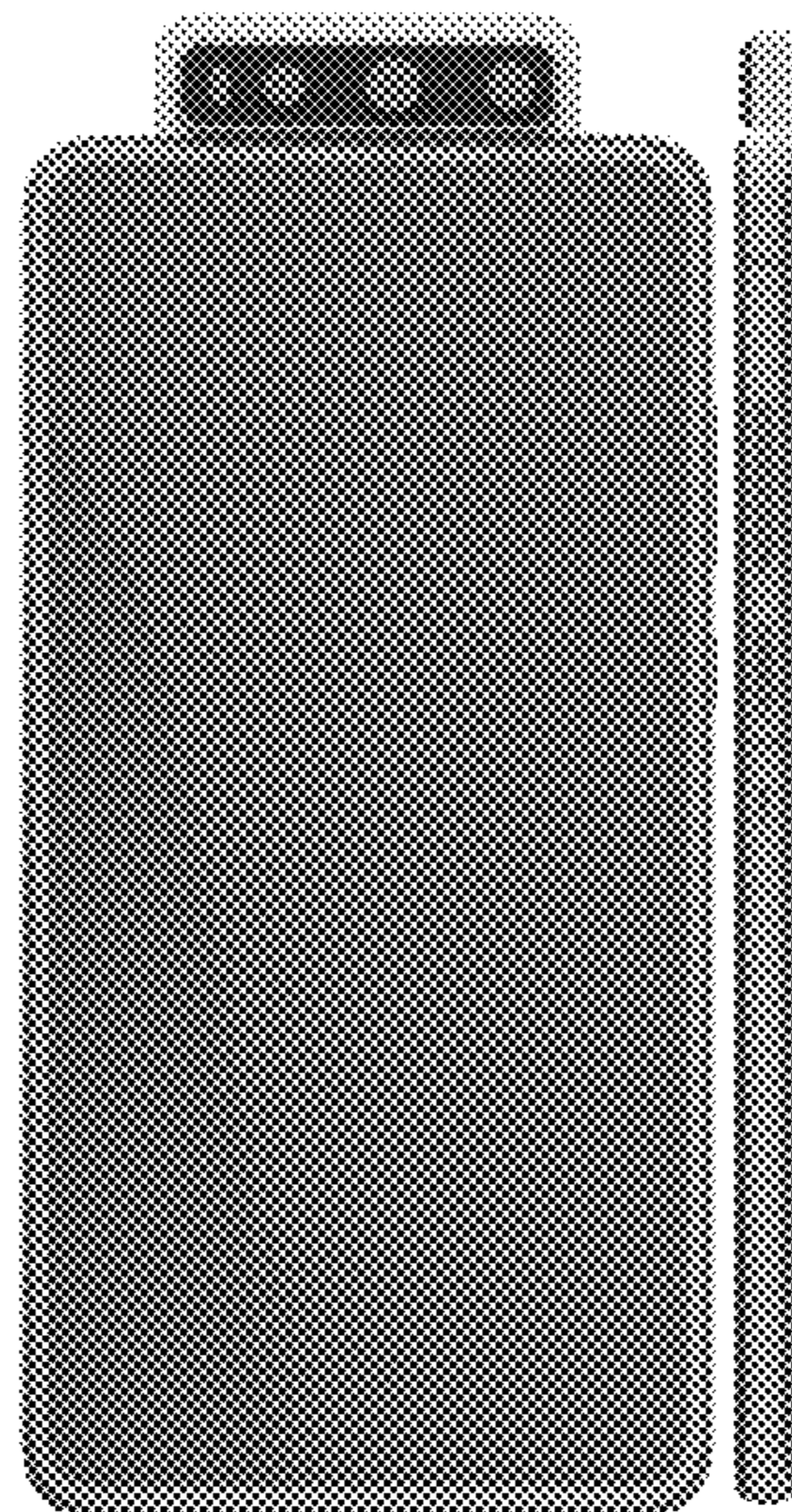
FIG. 1 is a front elevation view of a mobile phone in a first use state, showing our new design;

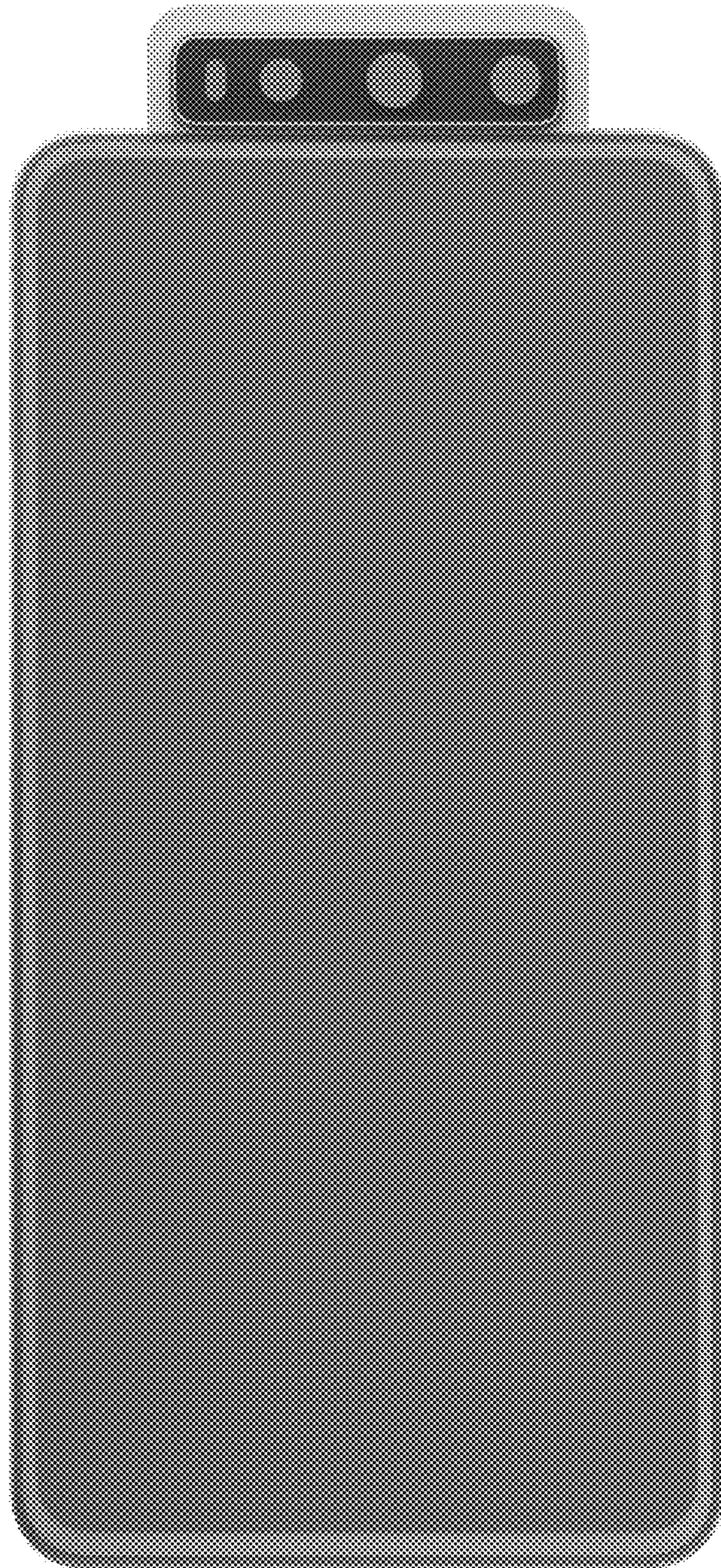

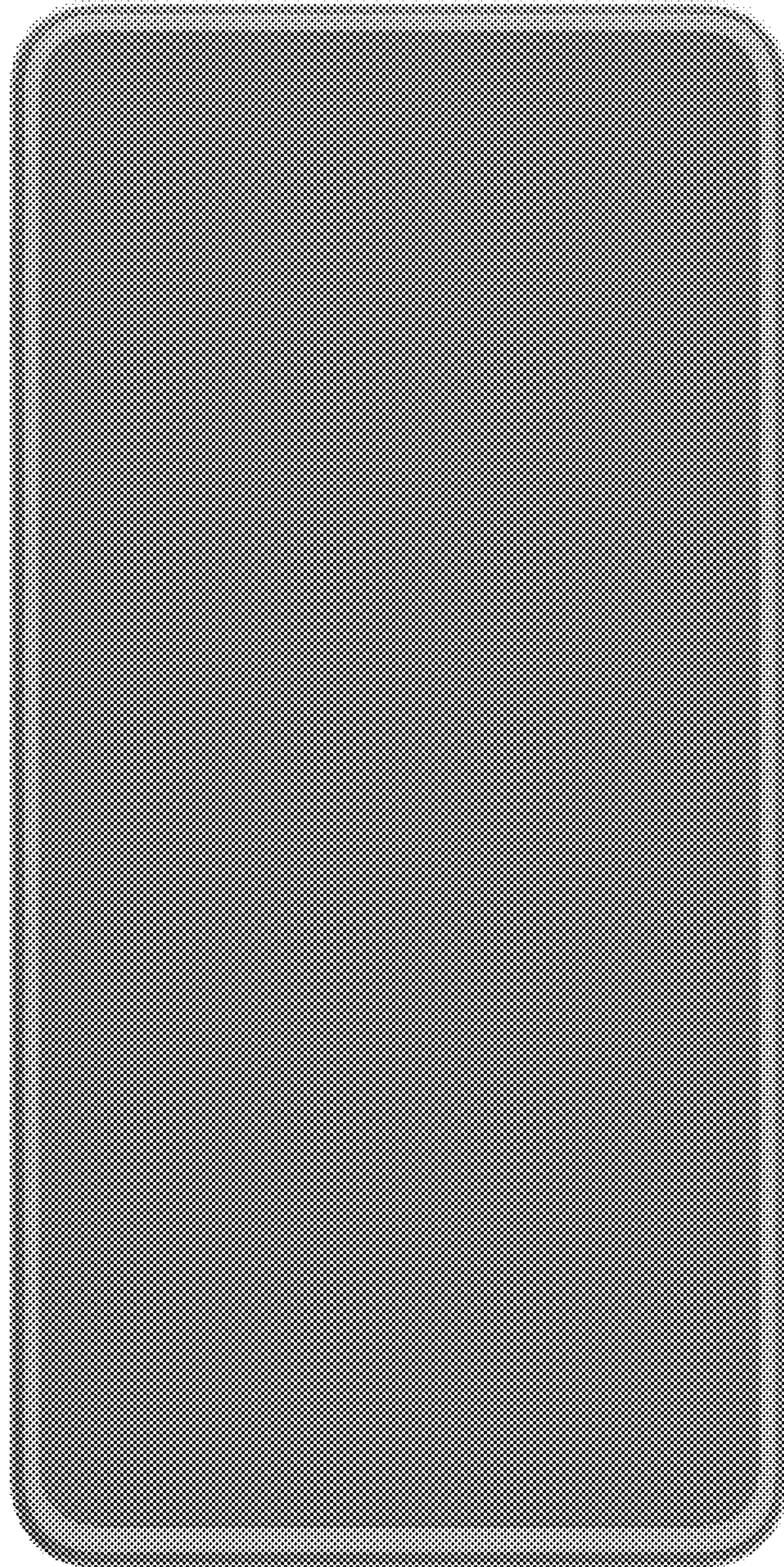

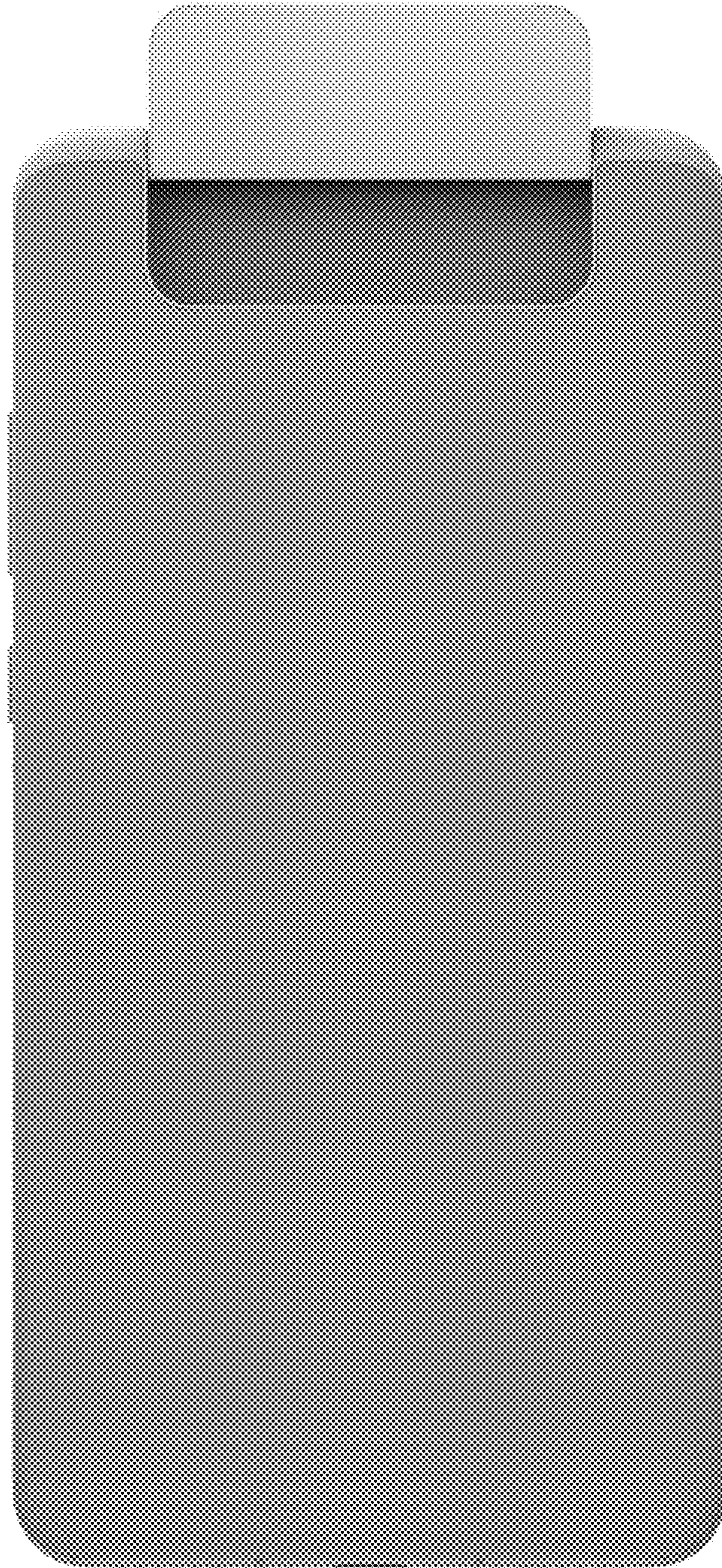

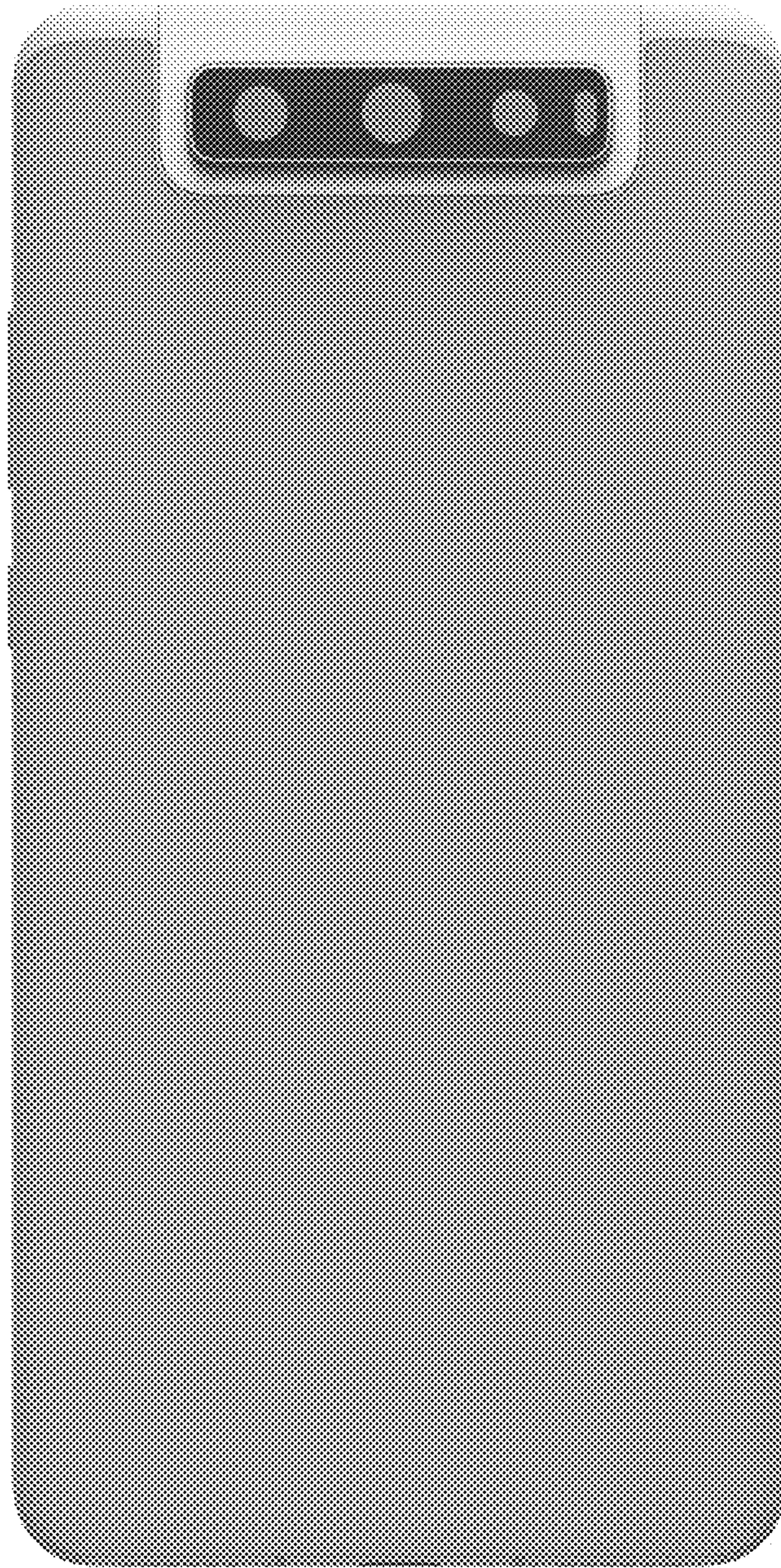
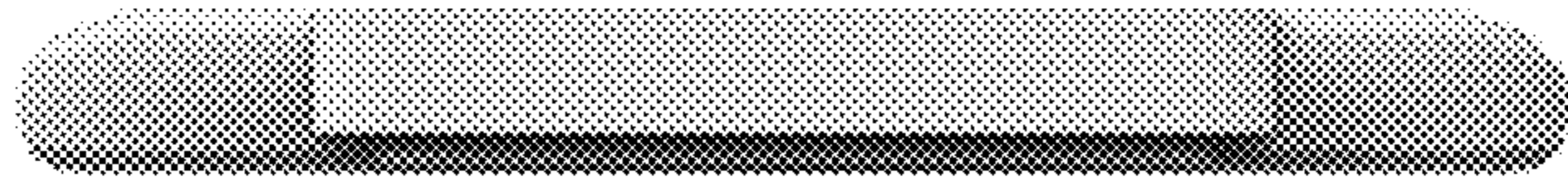
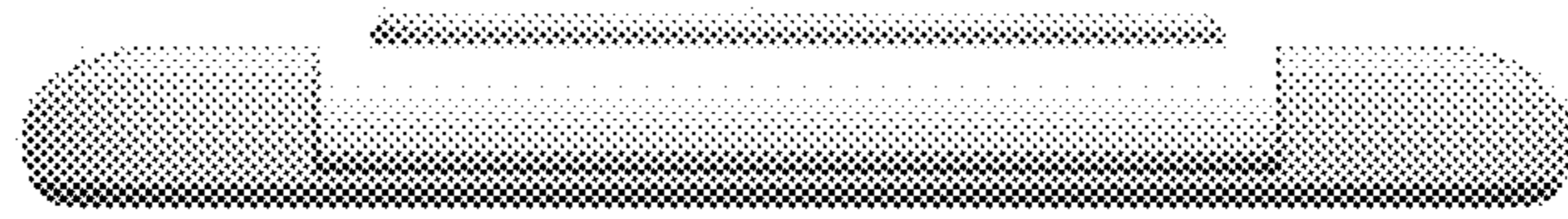

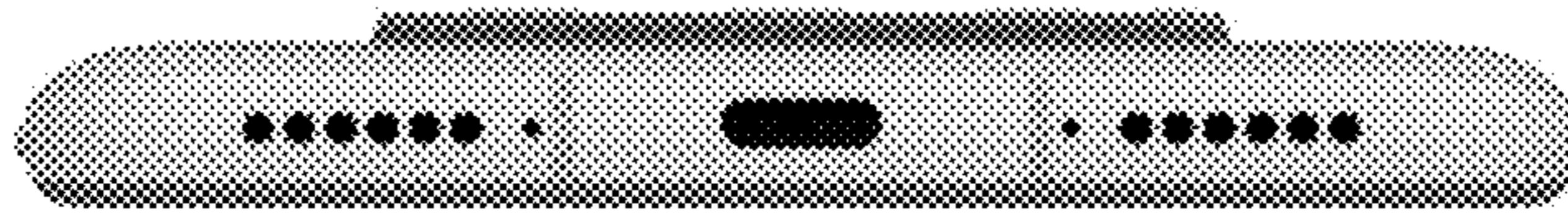

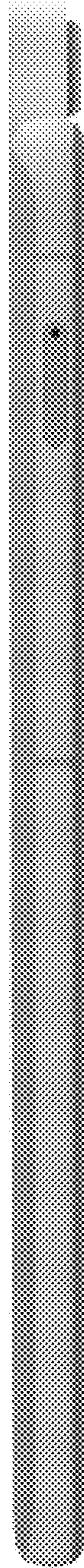

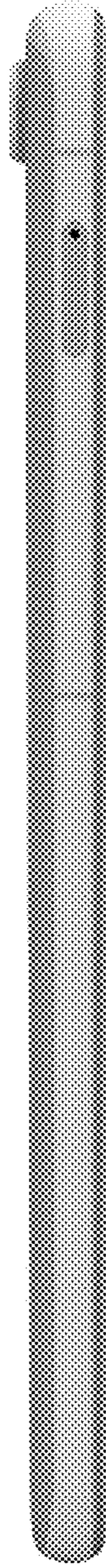

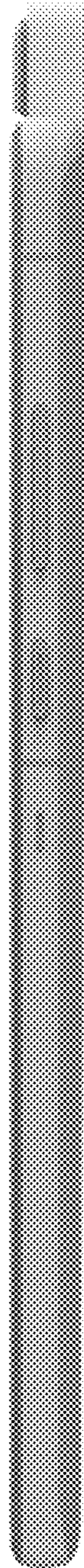

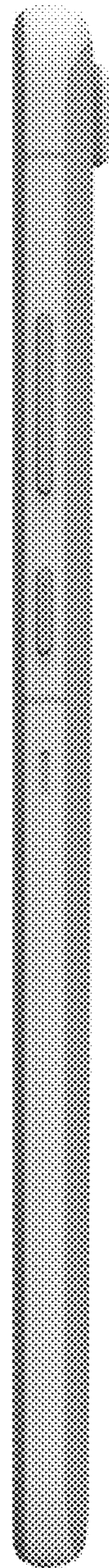
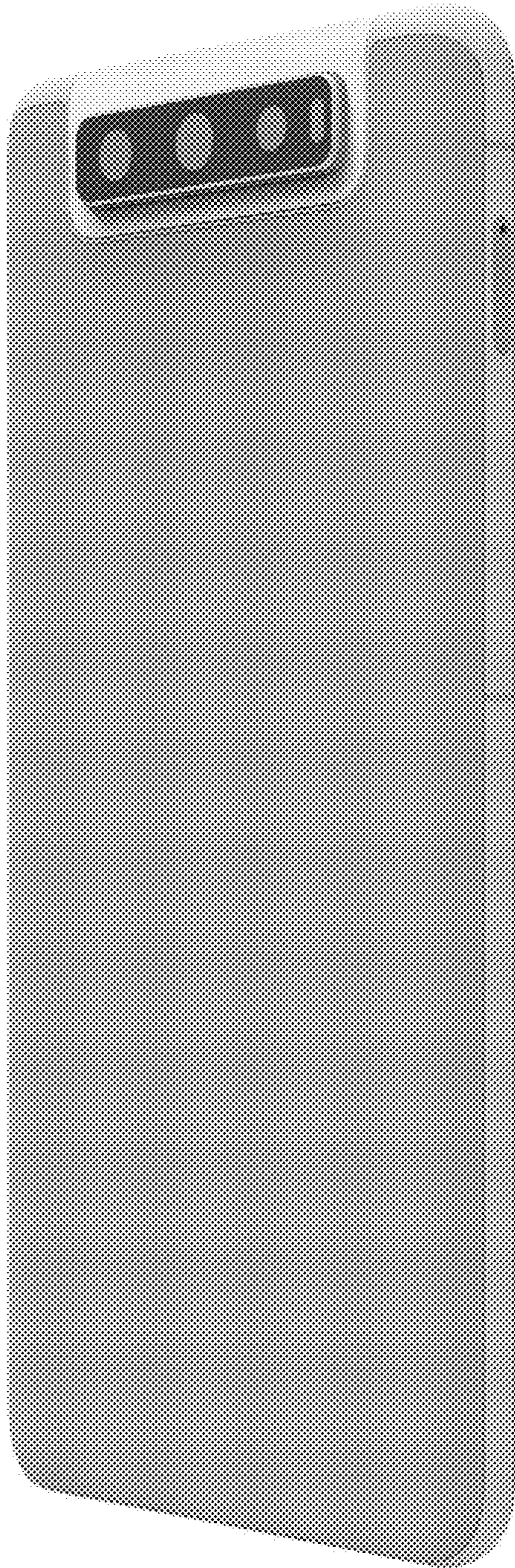

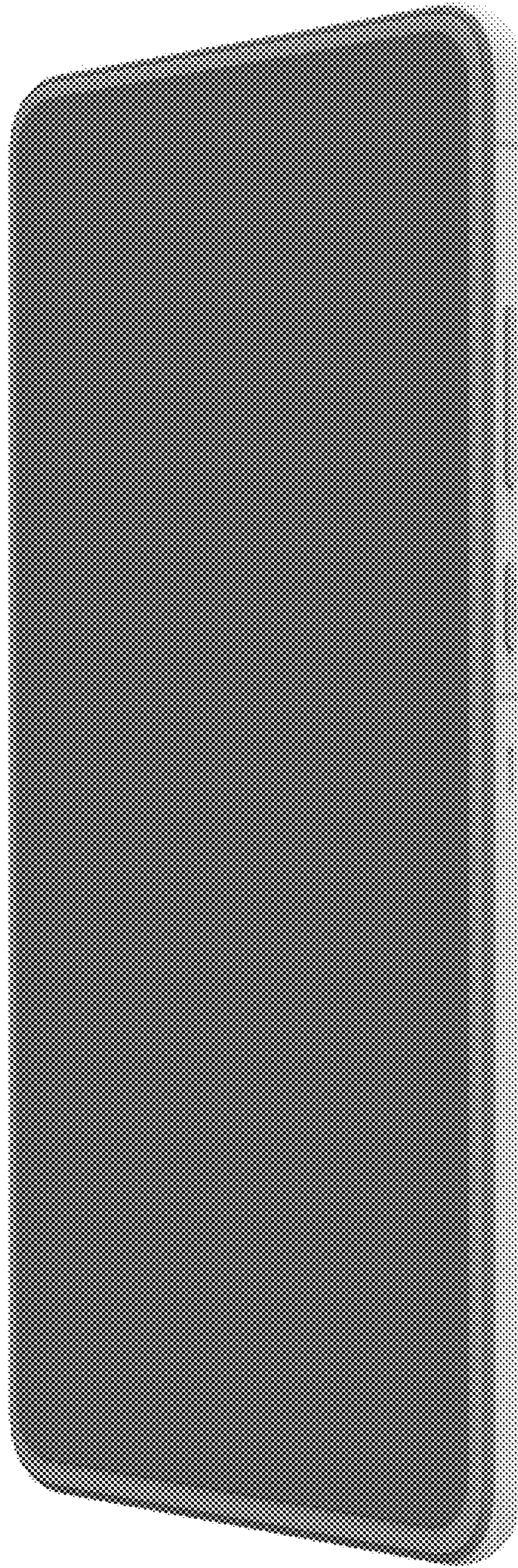

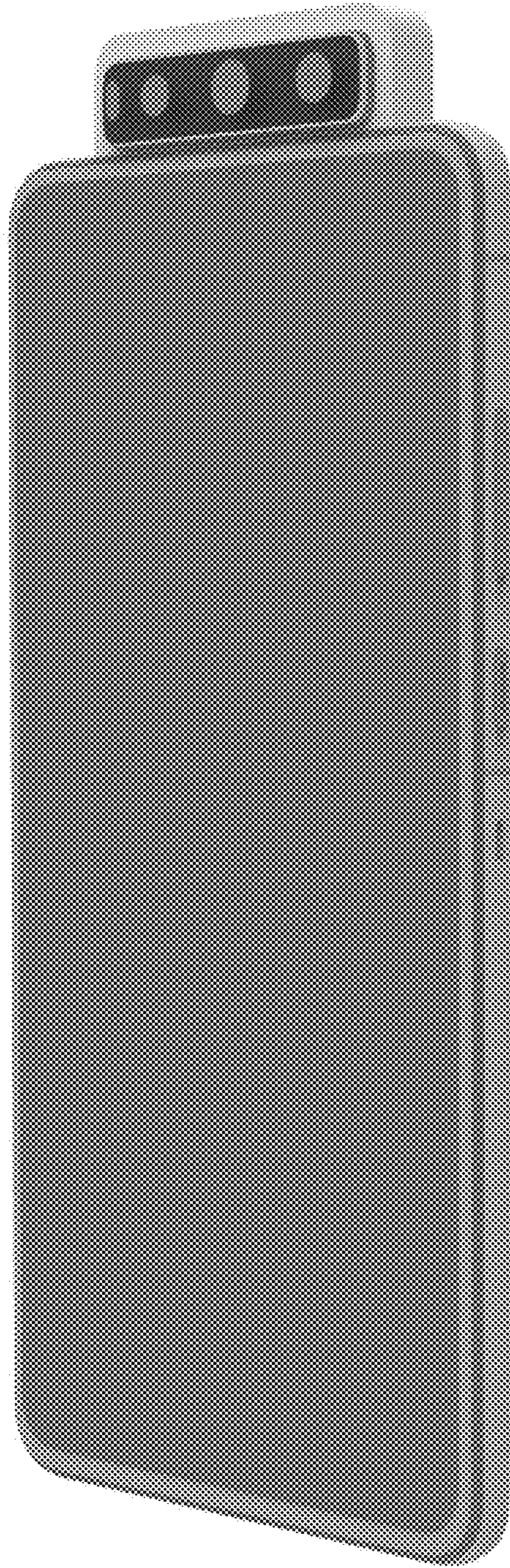

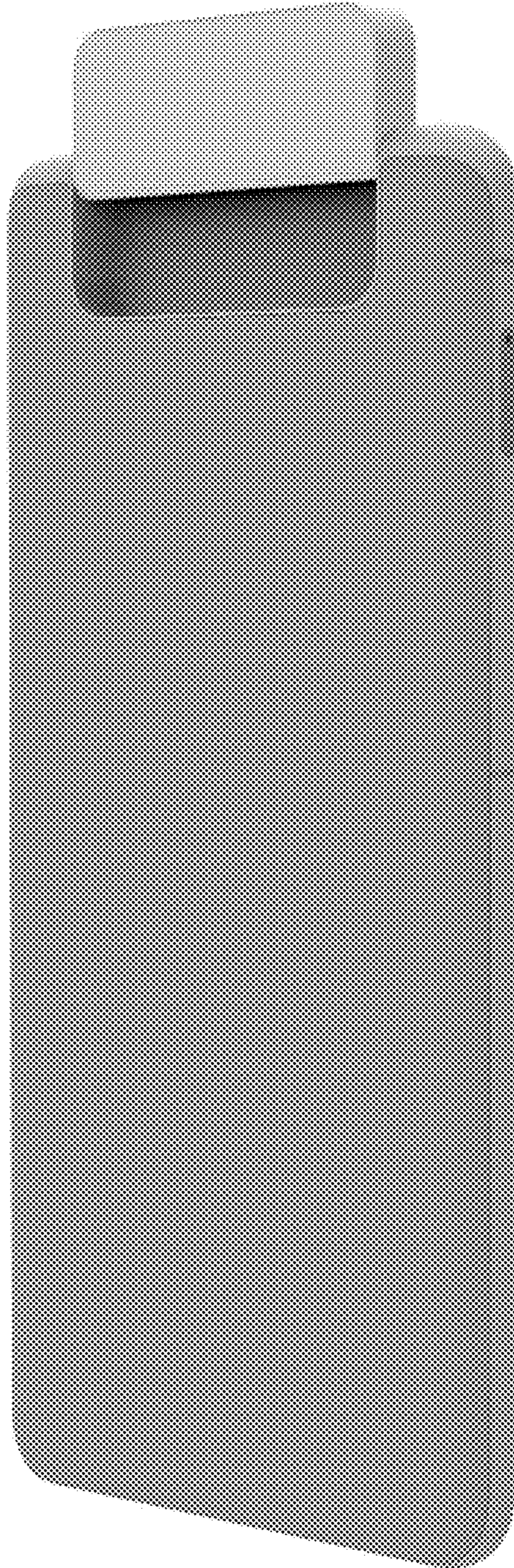
