(57) **CLAIM**

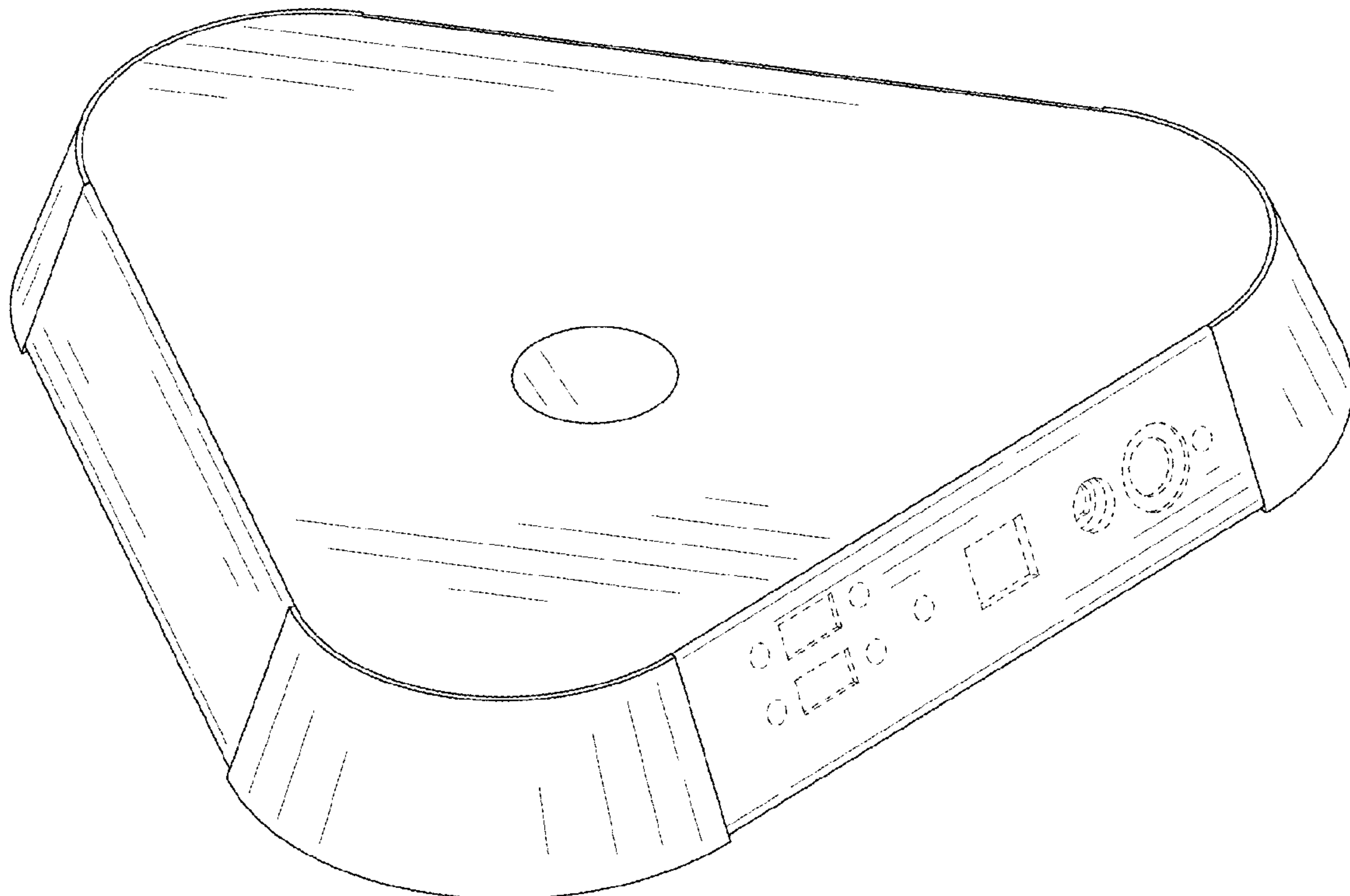
The ornamental design for an attendance machine, as shown and described.

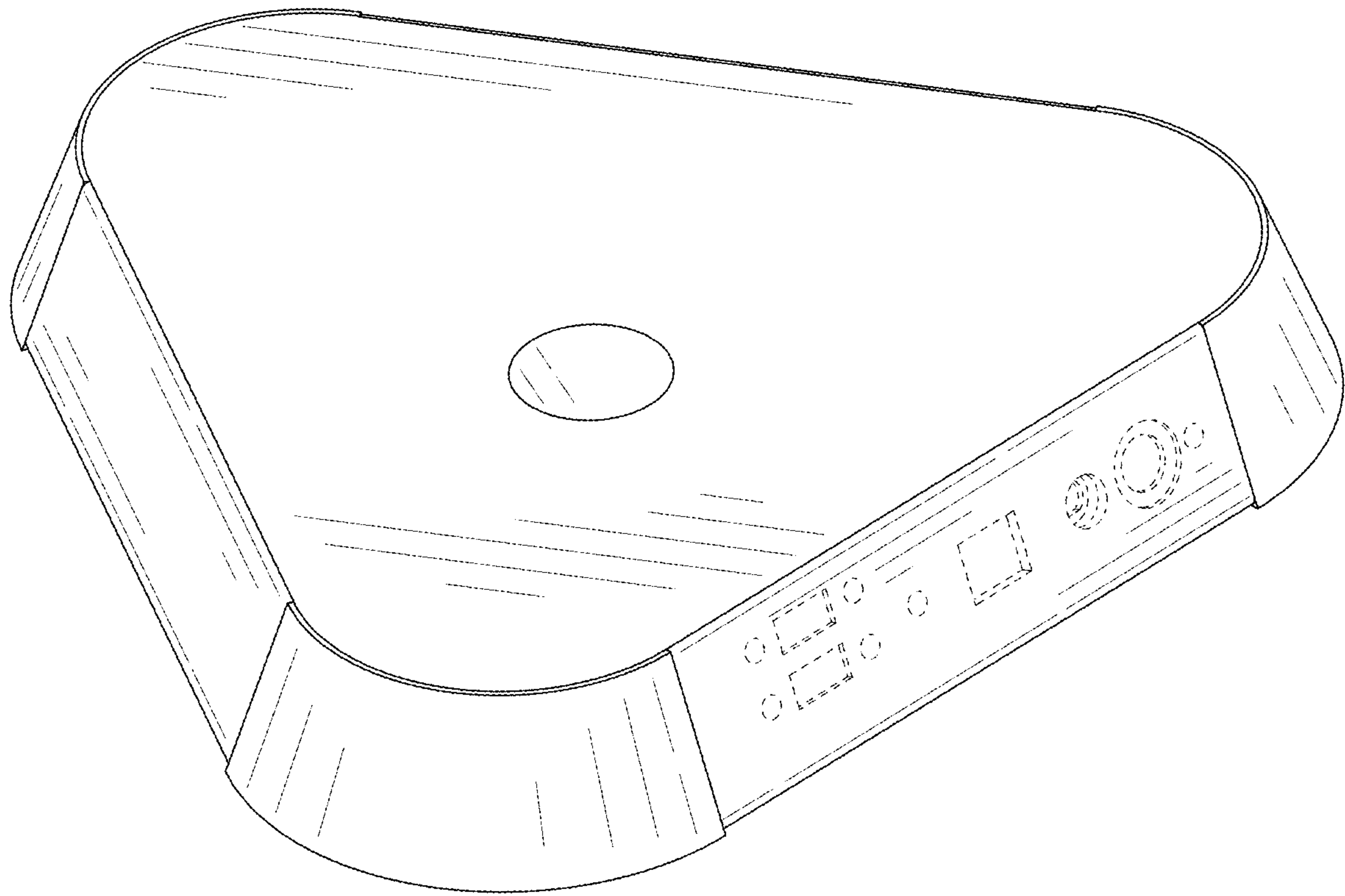

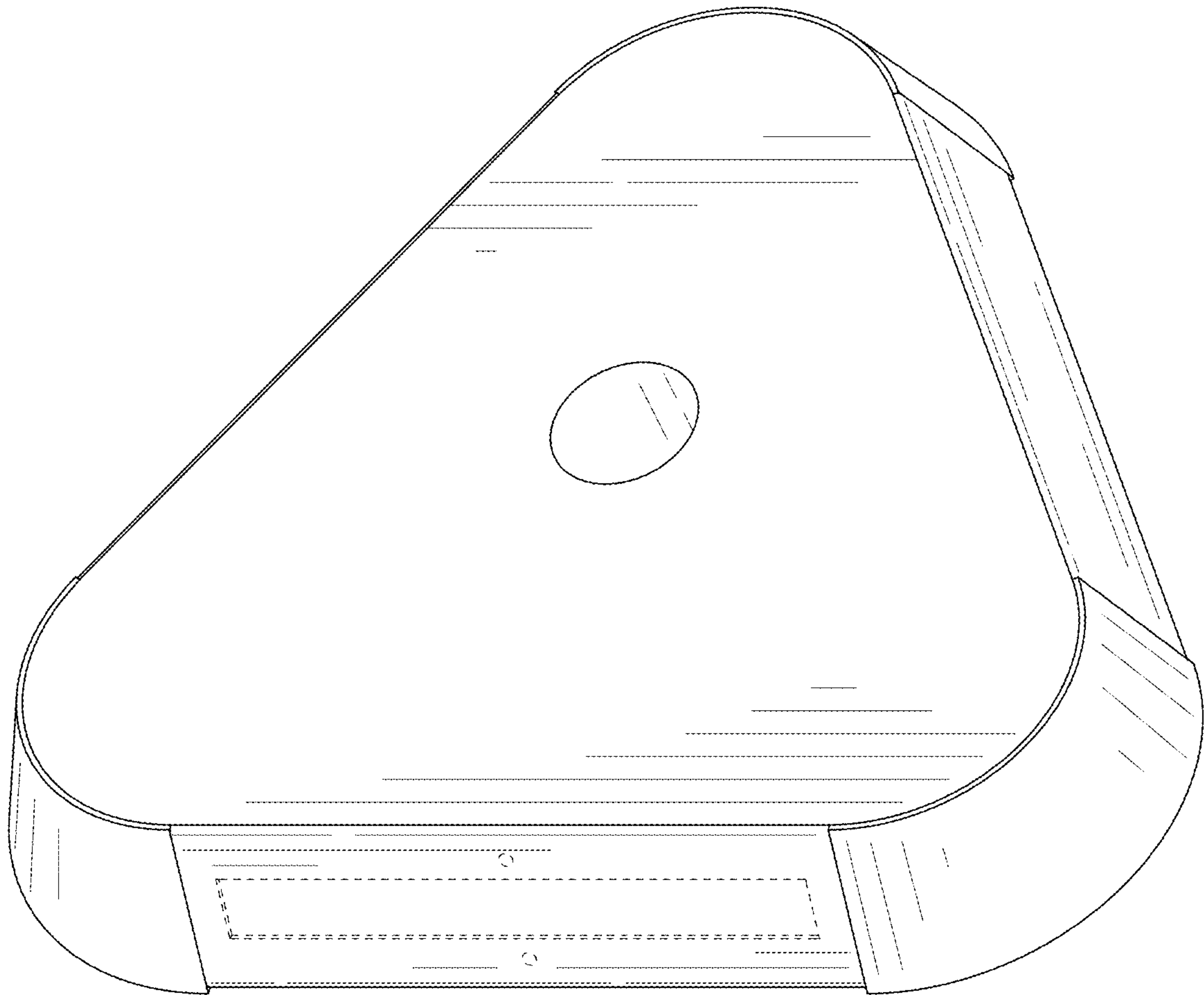

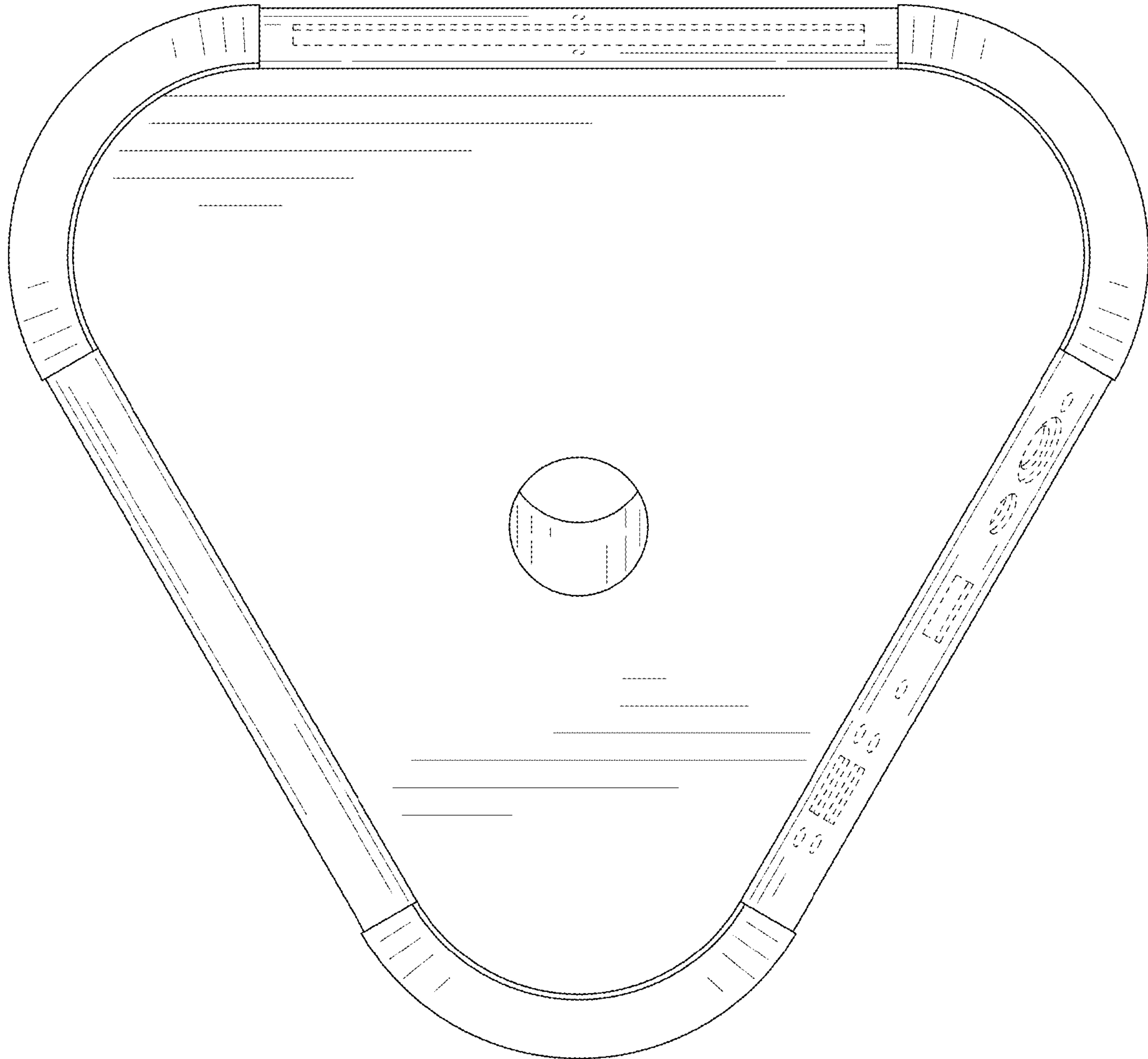

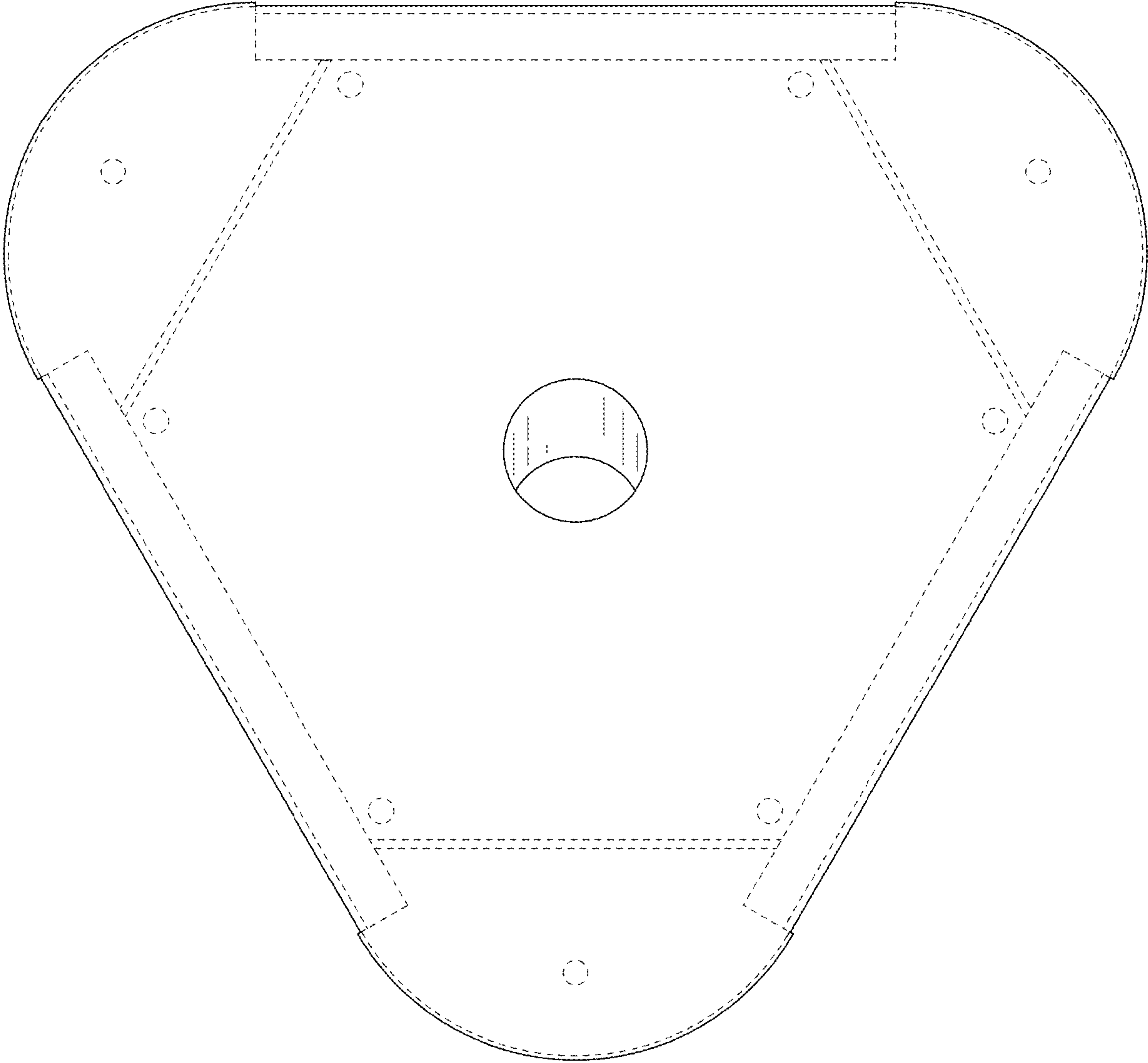

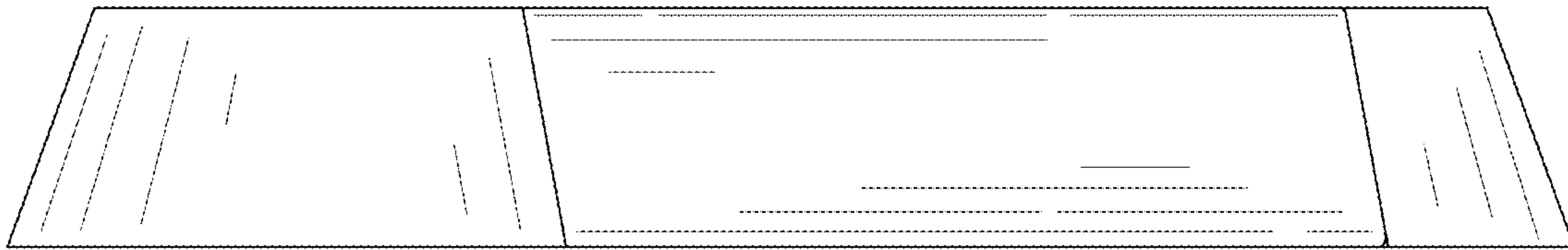

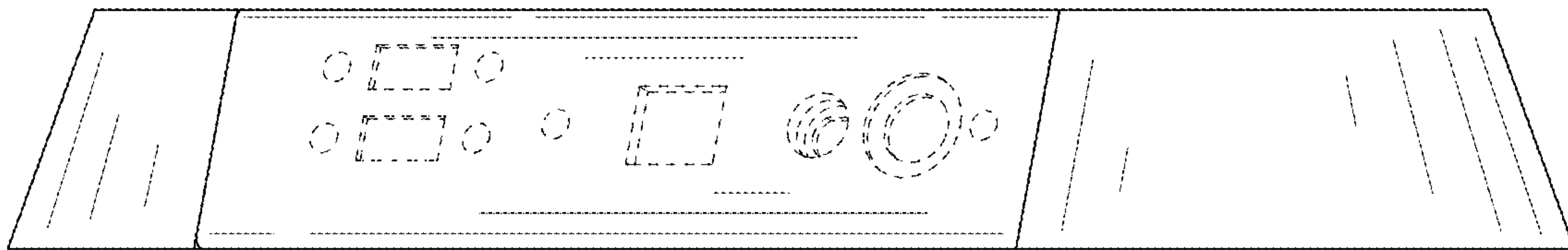

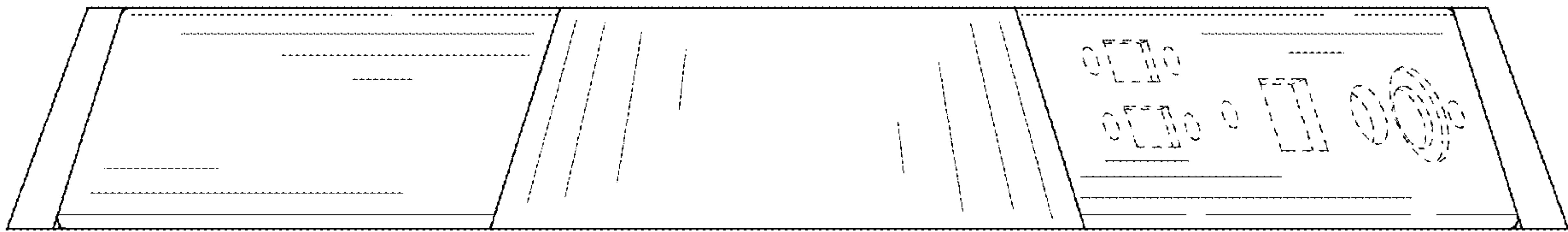

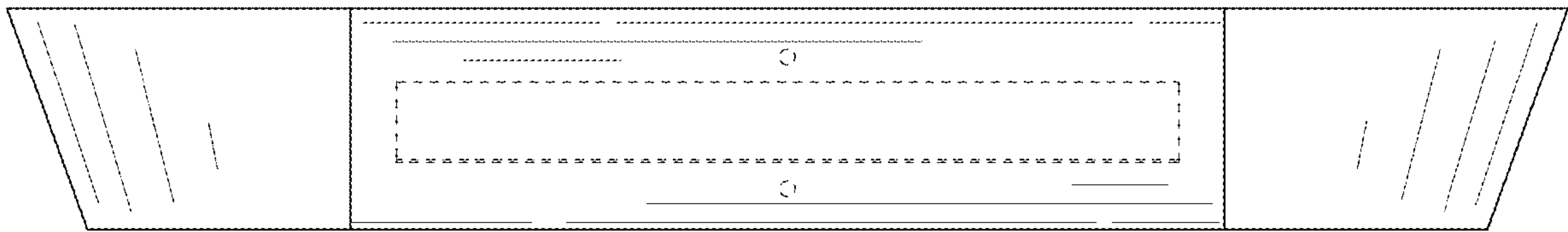
