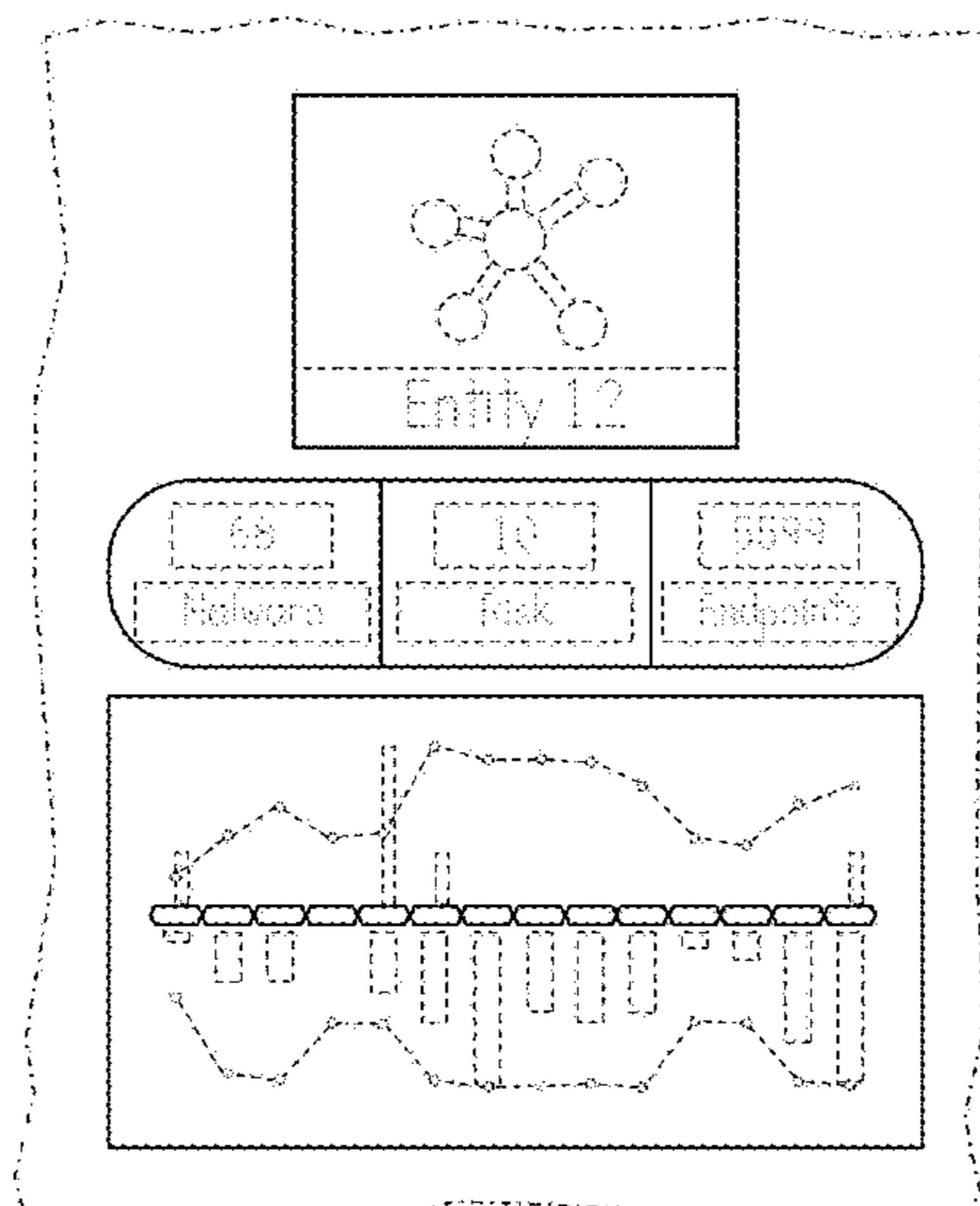
DESCRIPTION

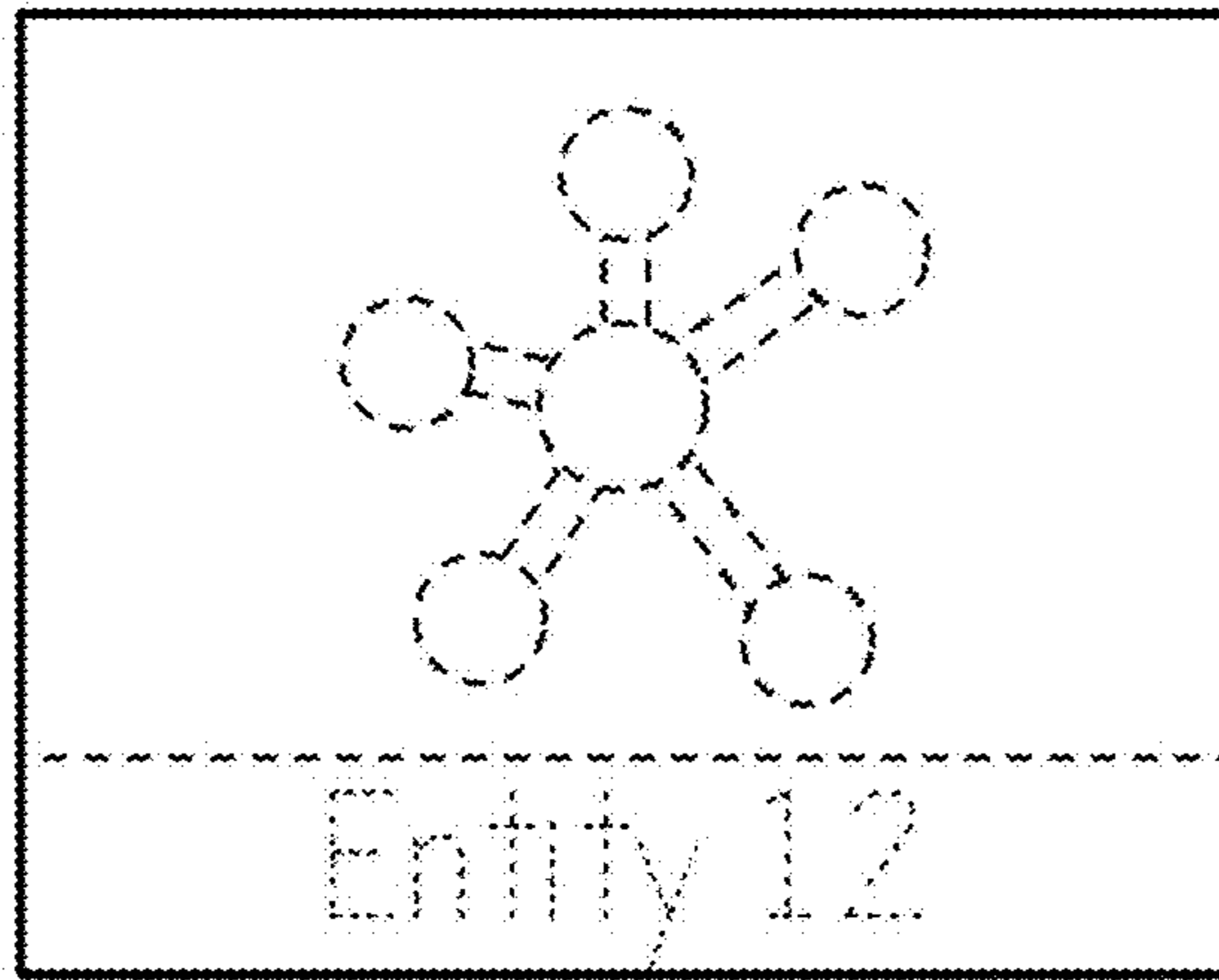
