The ornamental design for a display screen portion with icon for sphygmomanometer, as shown and described.

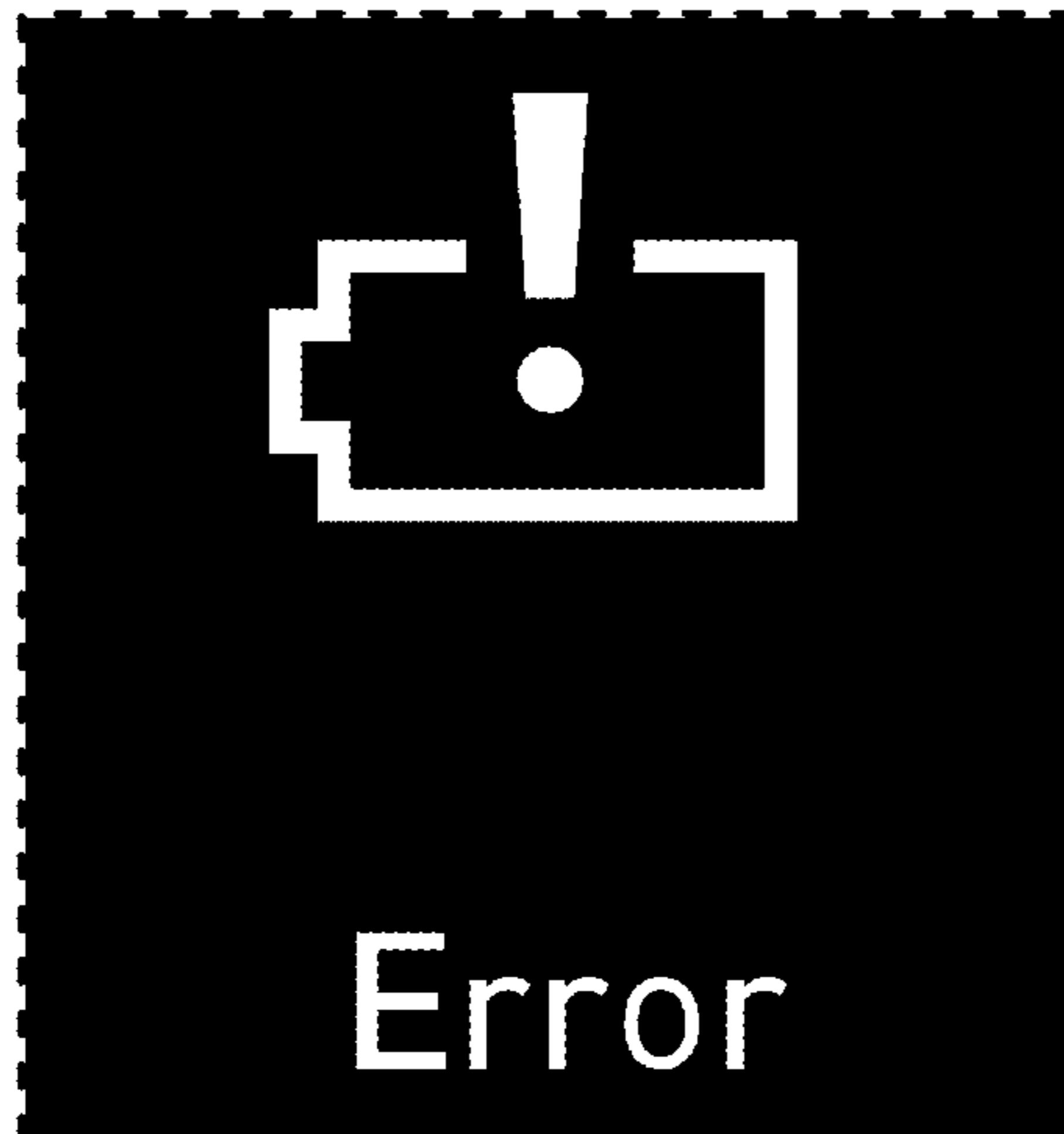
**DESCRIPTION**

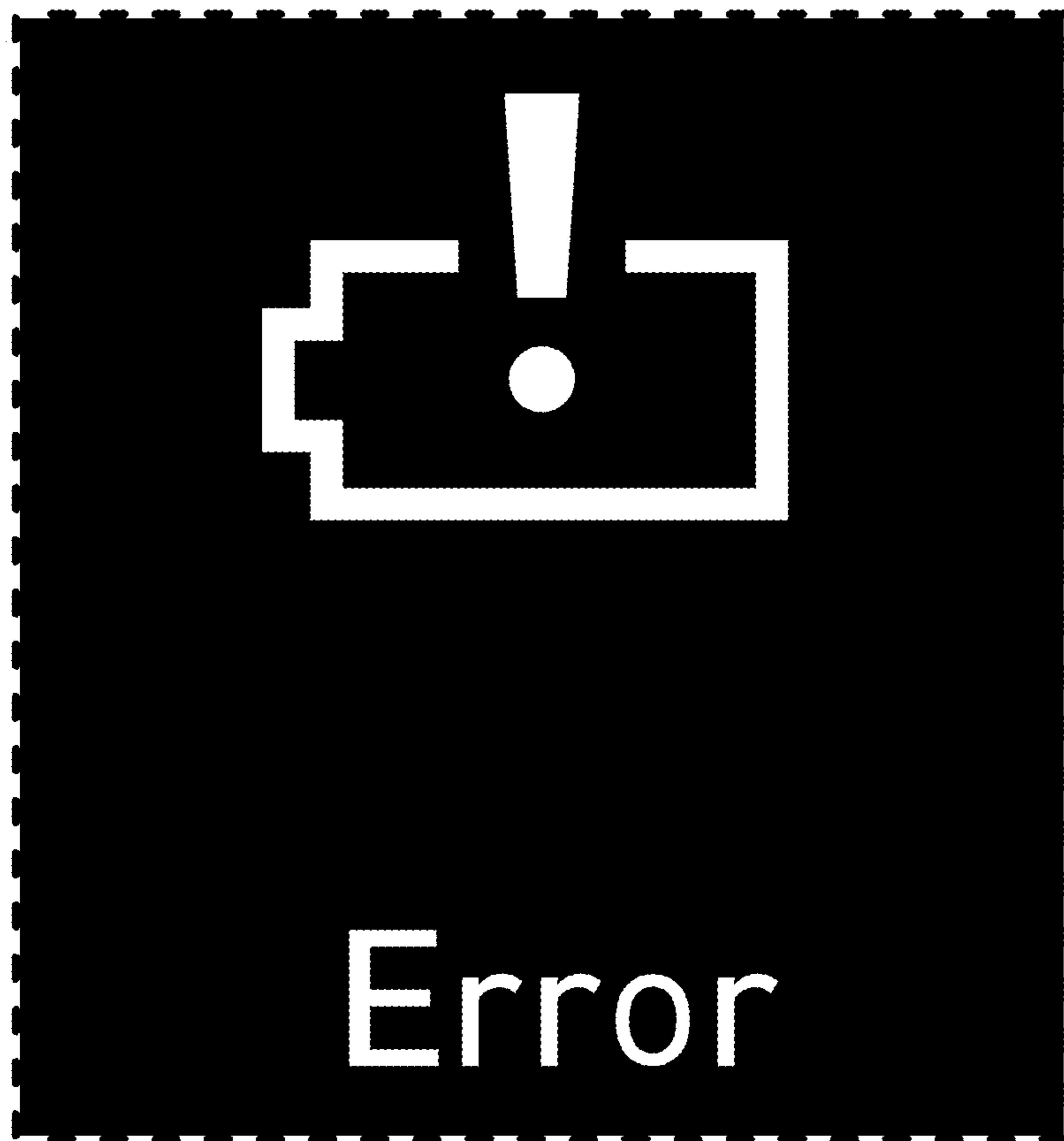

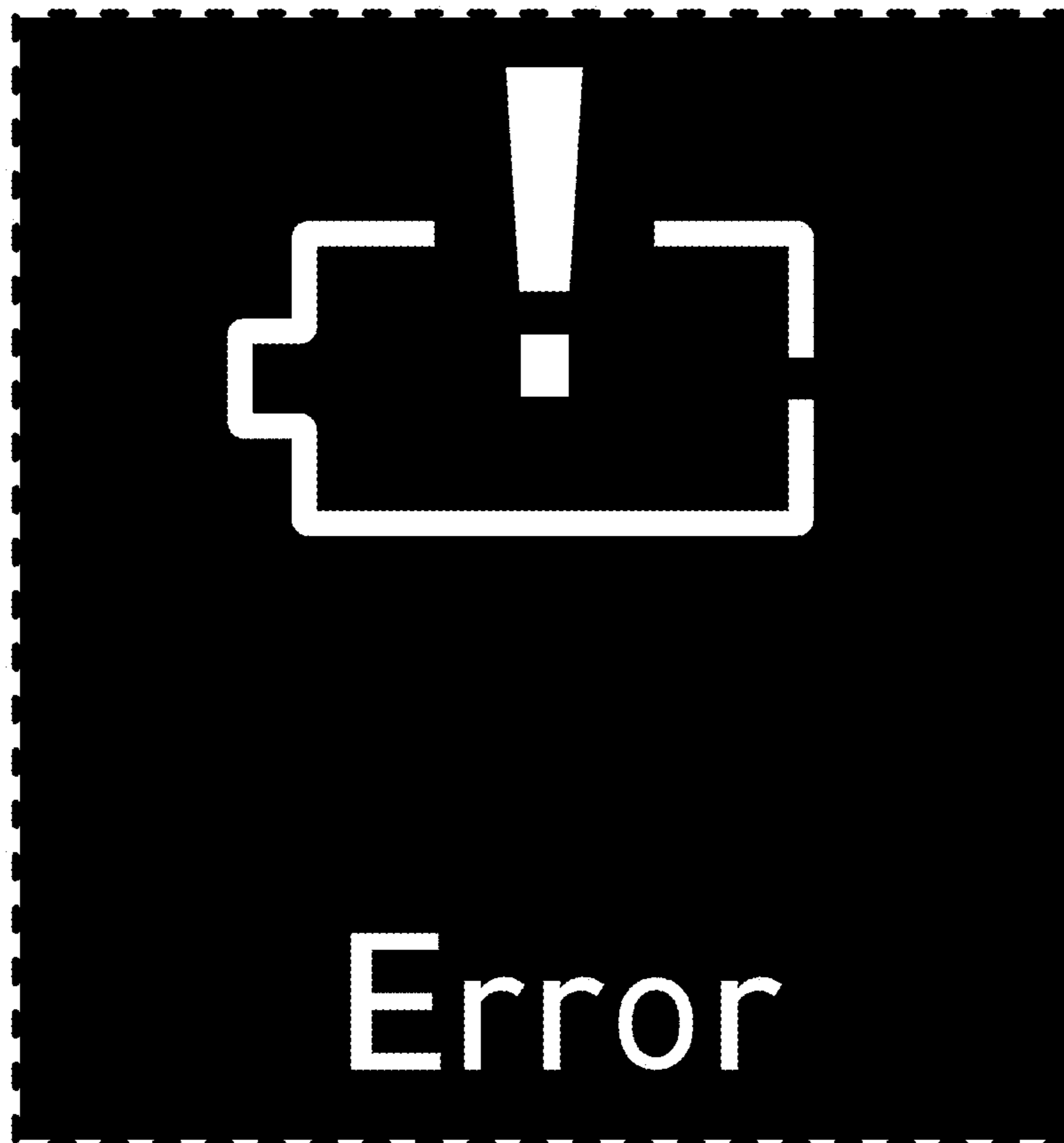
