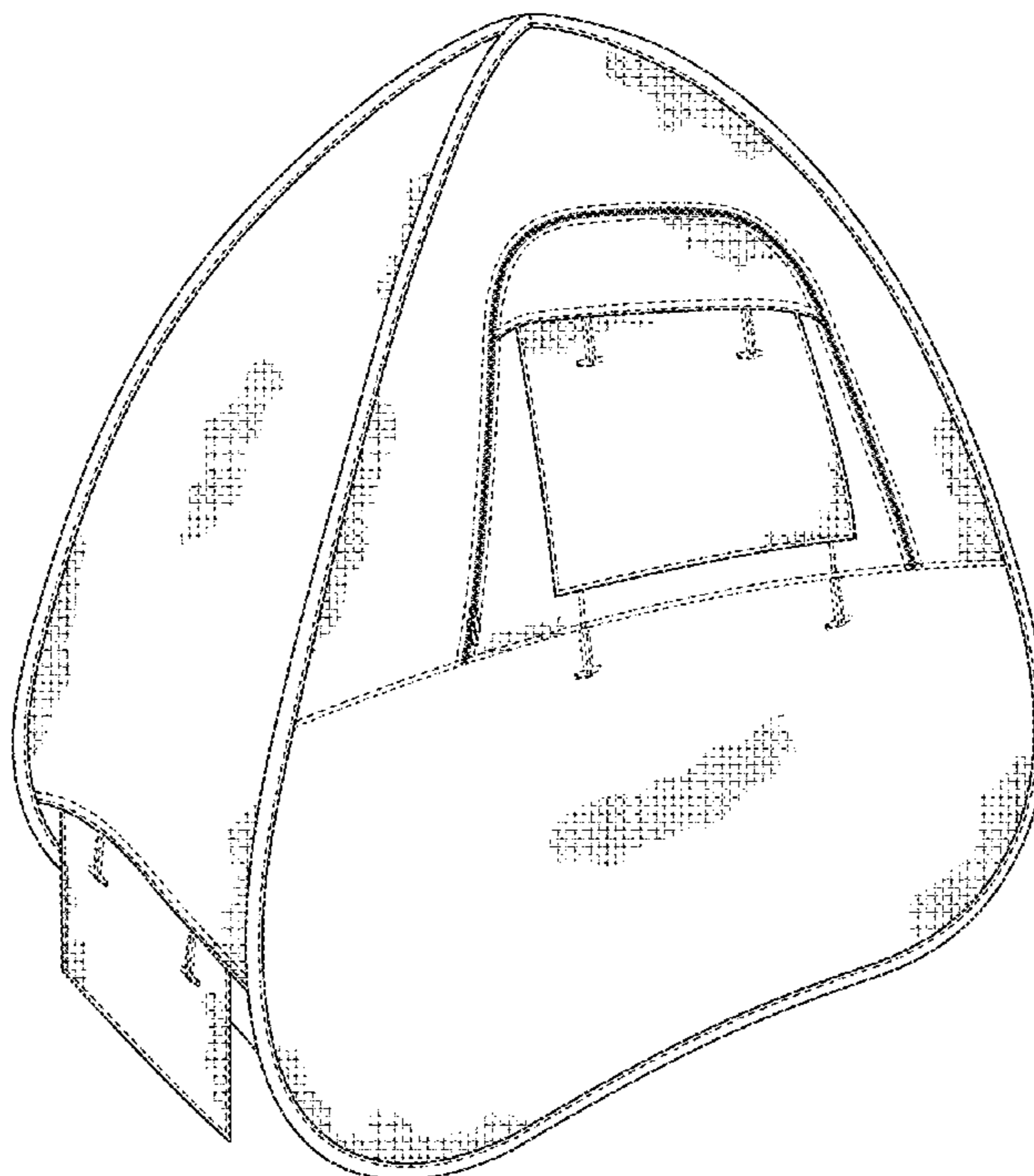
The ornamental design for a crib cover, as shown and described.

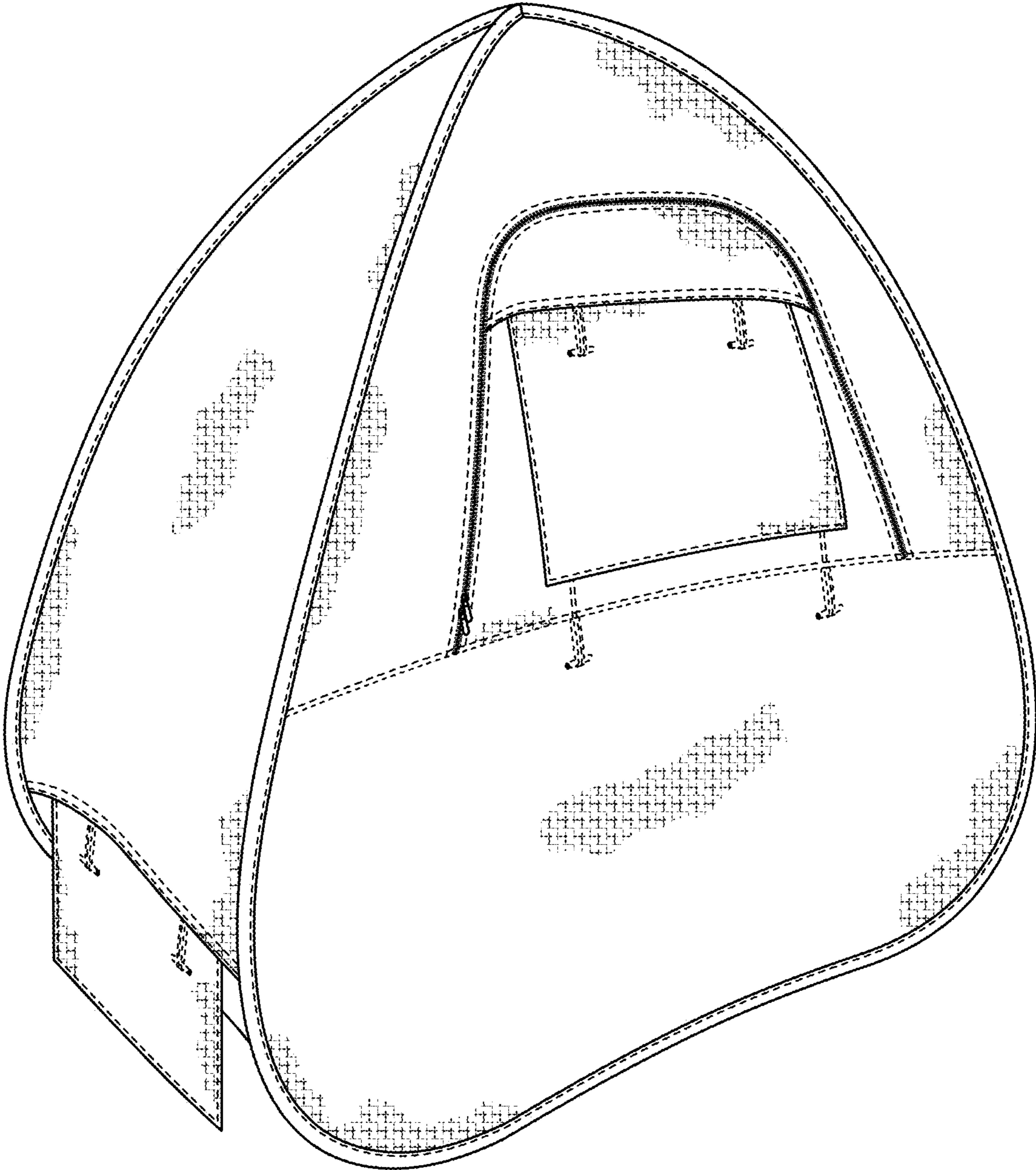

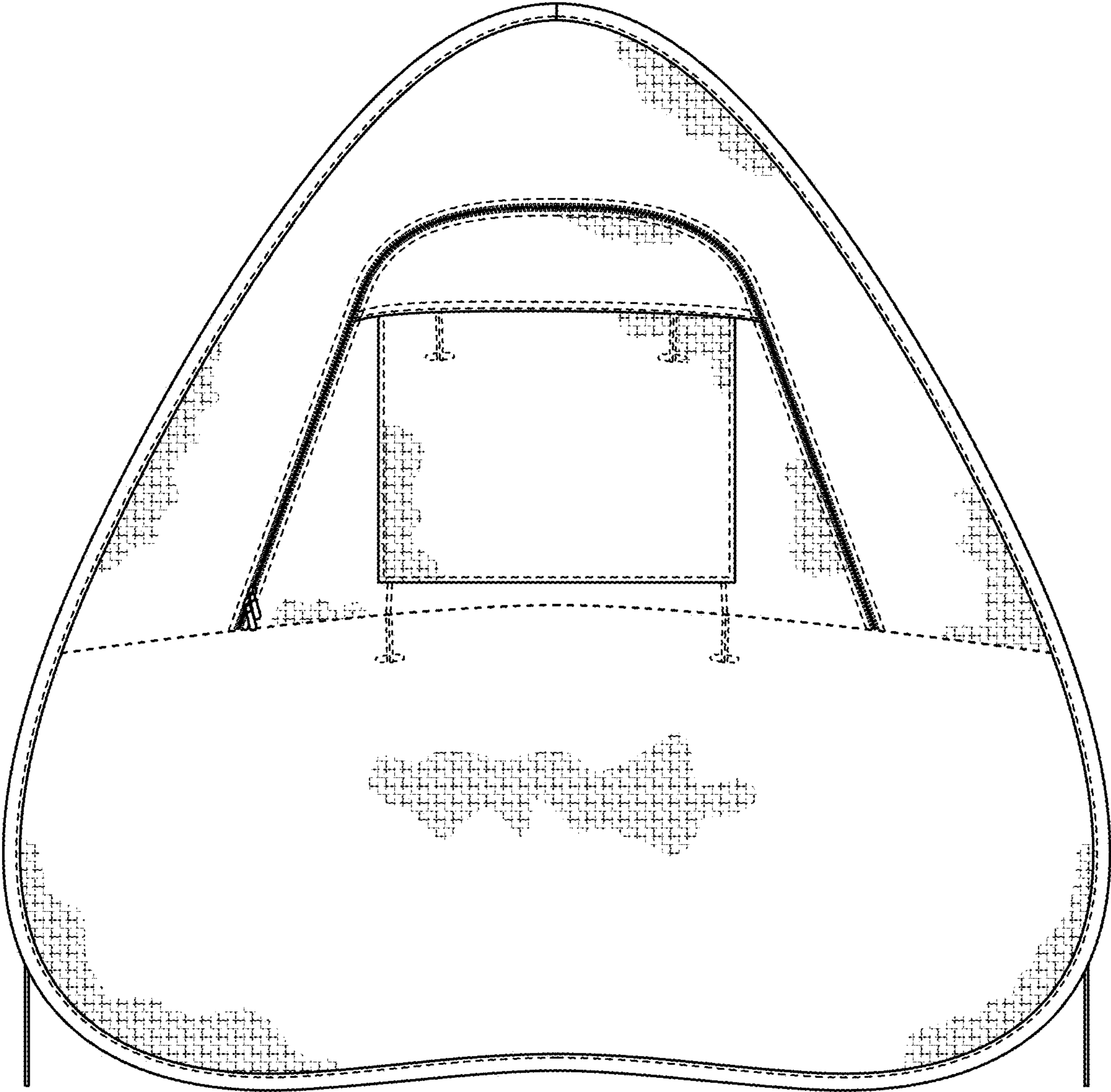

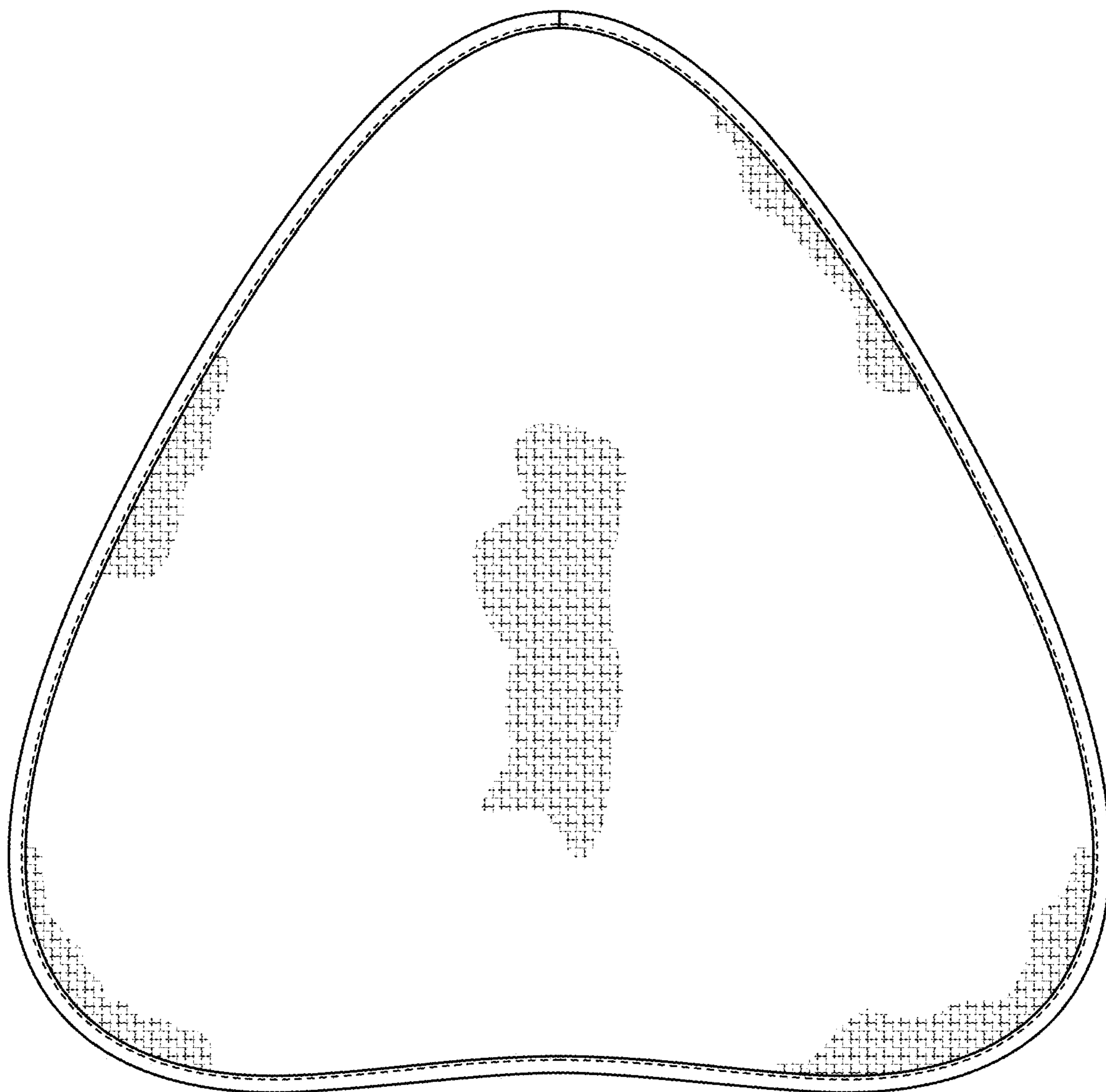

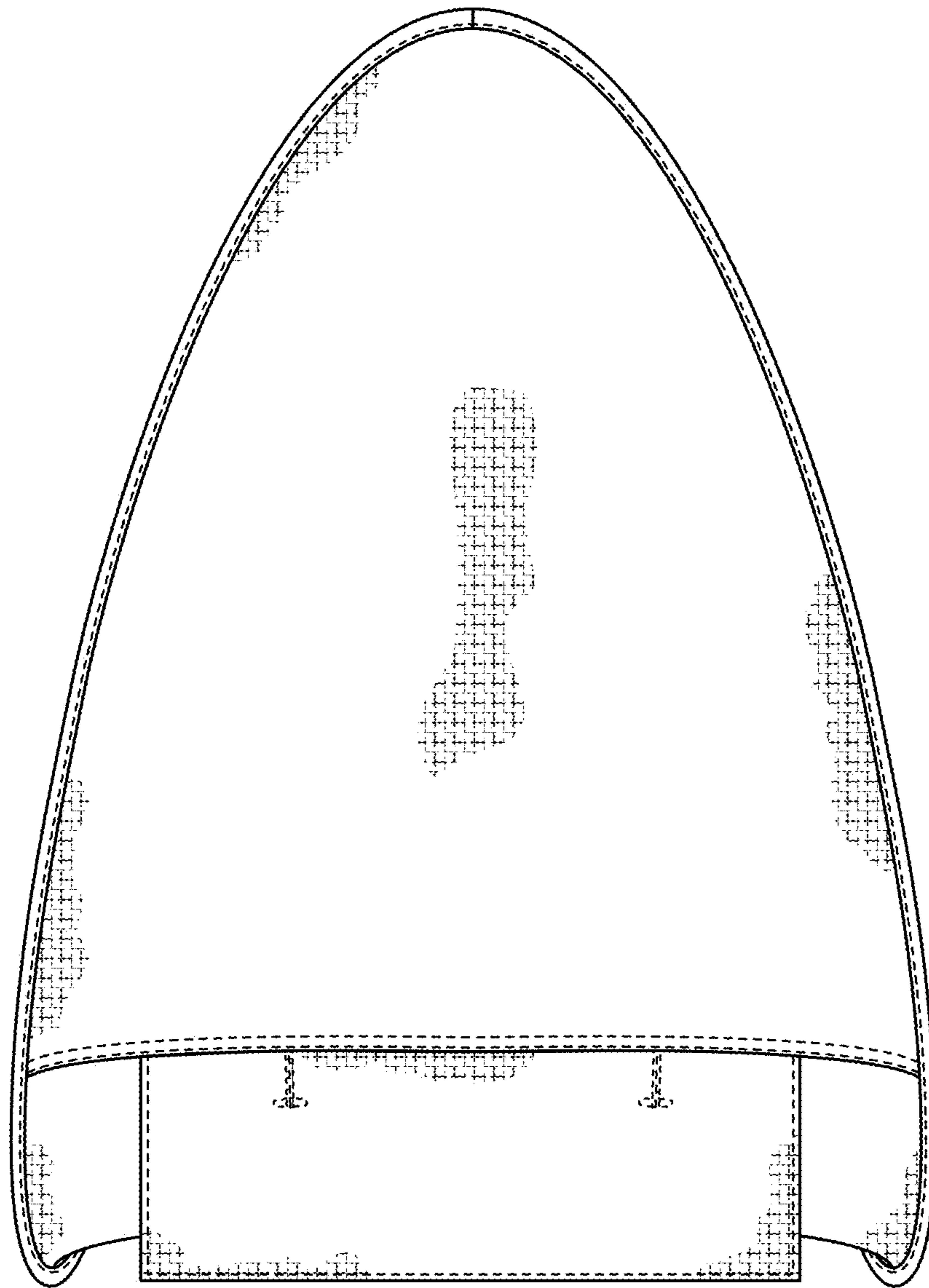

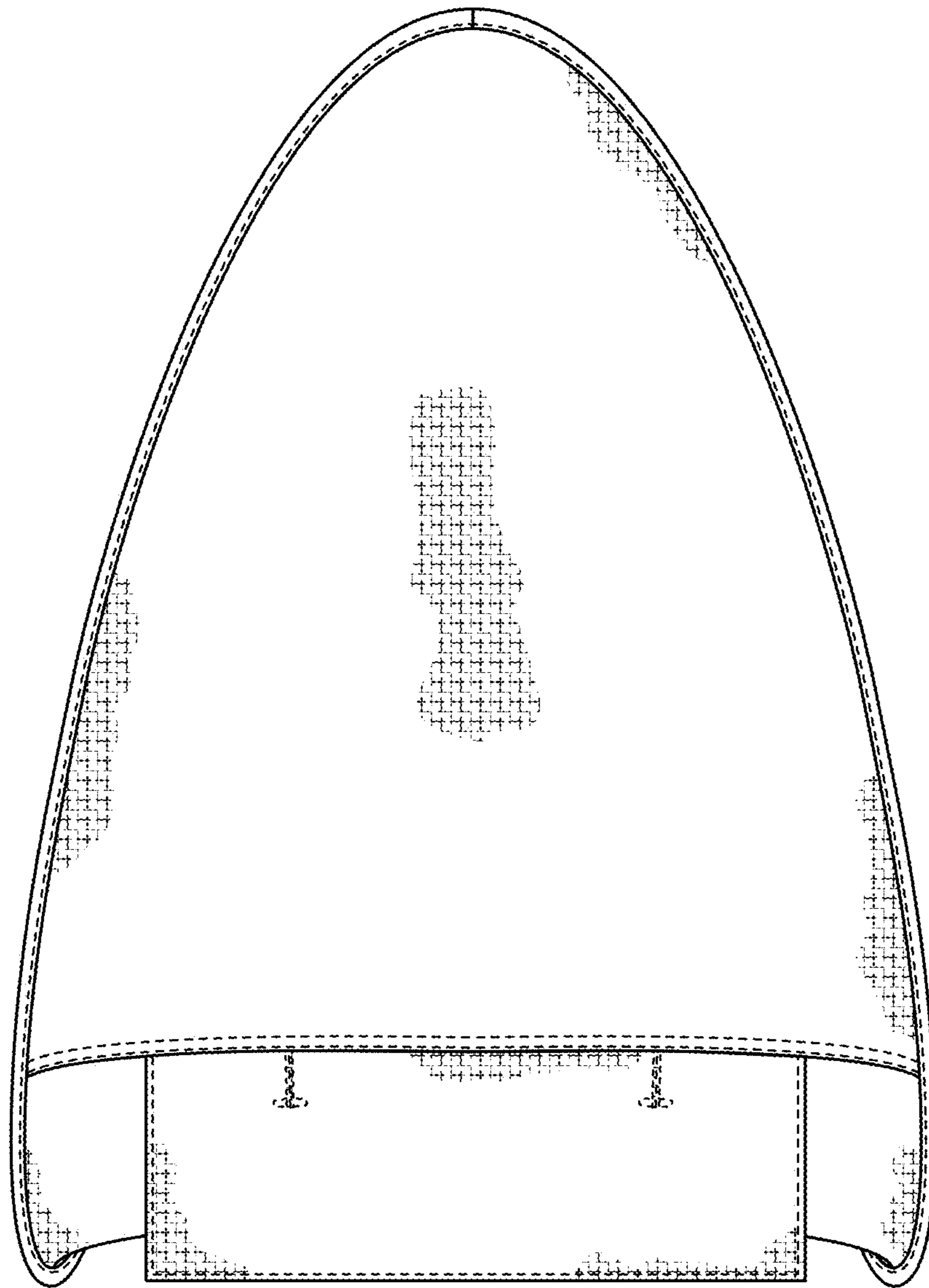

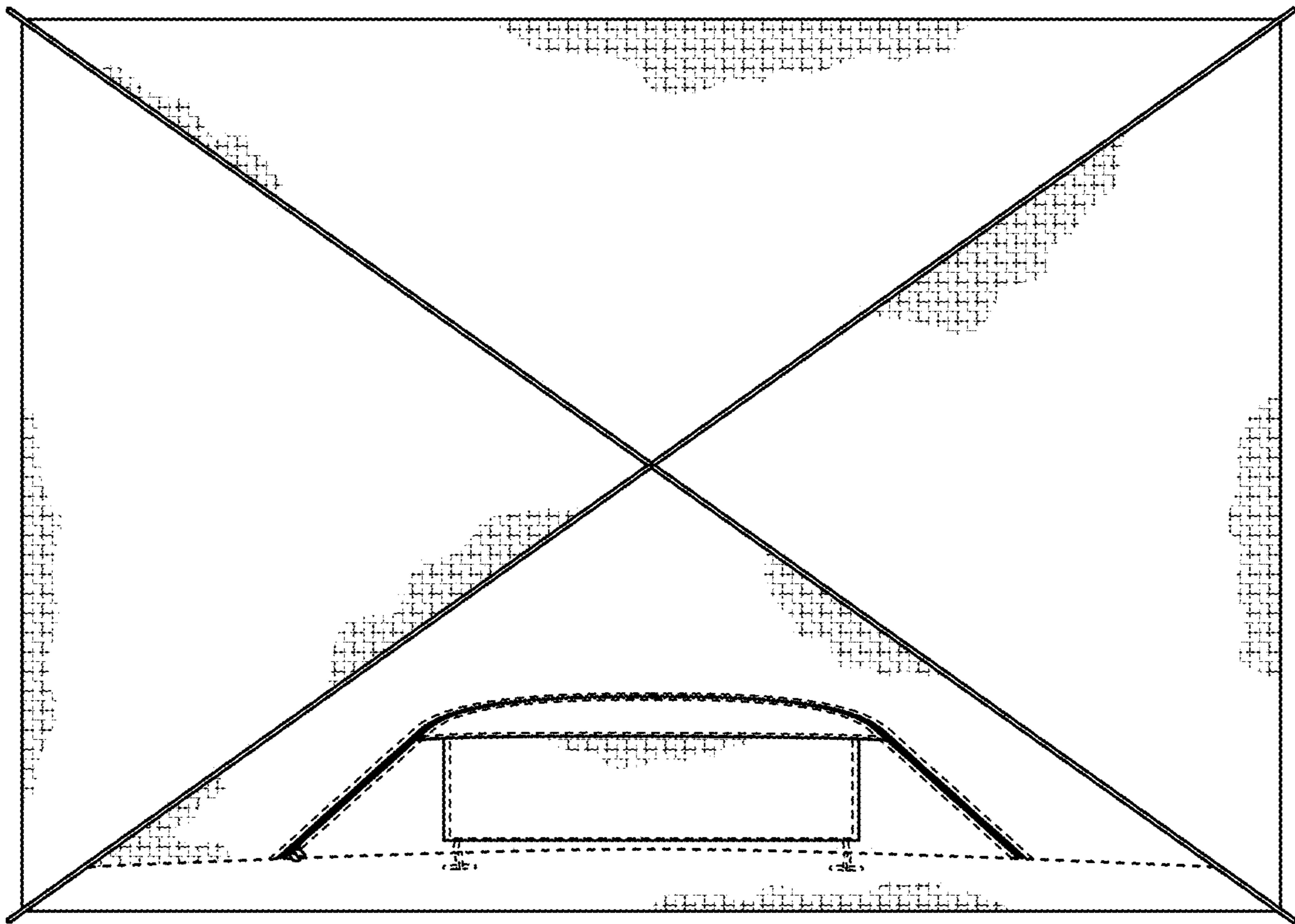

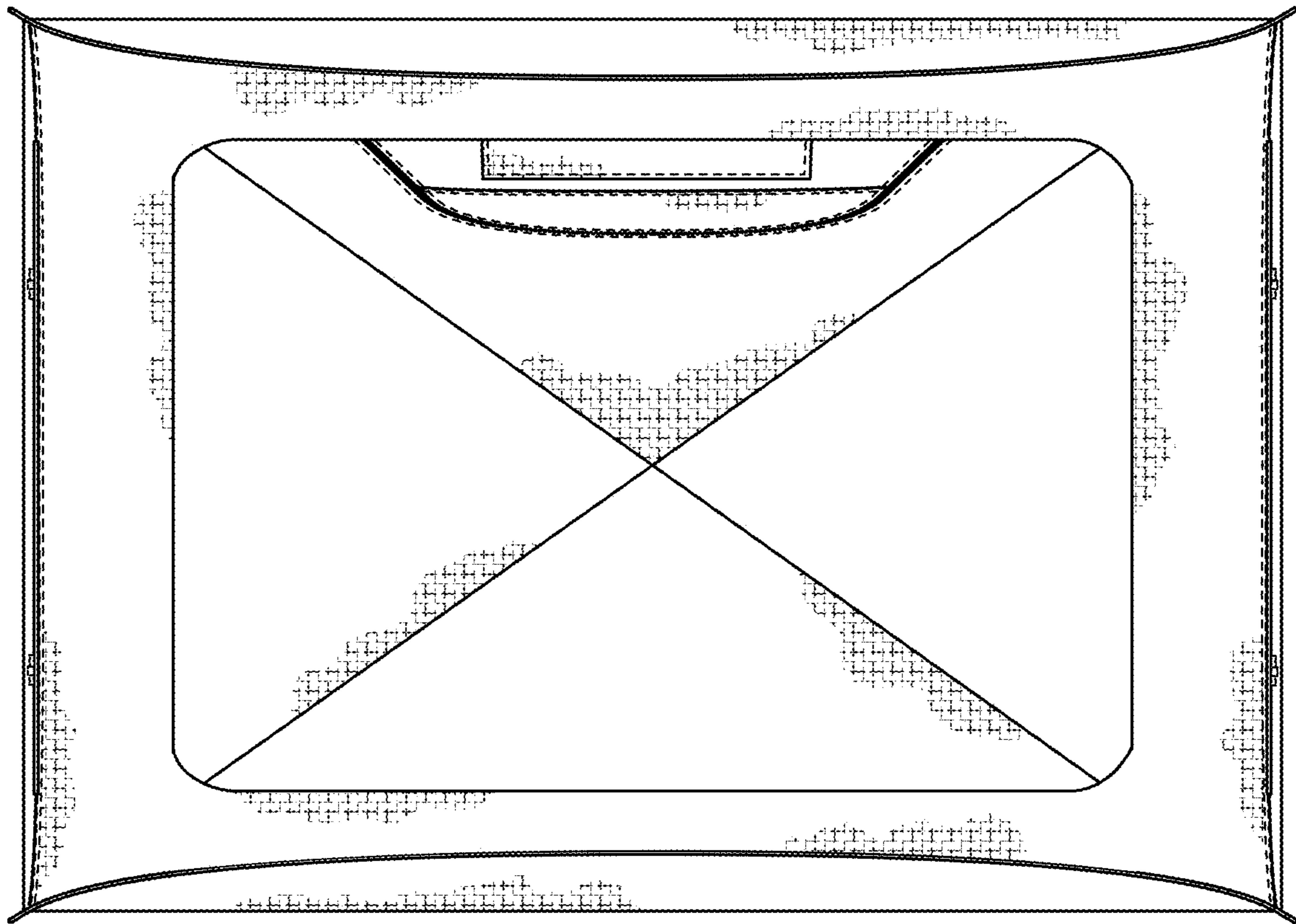
