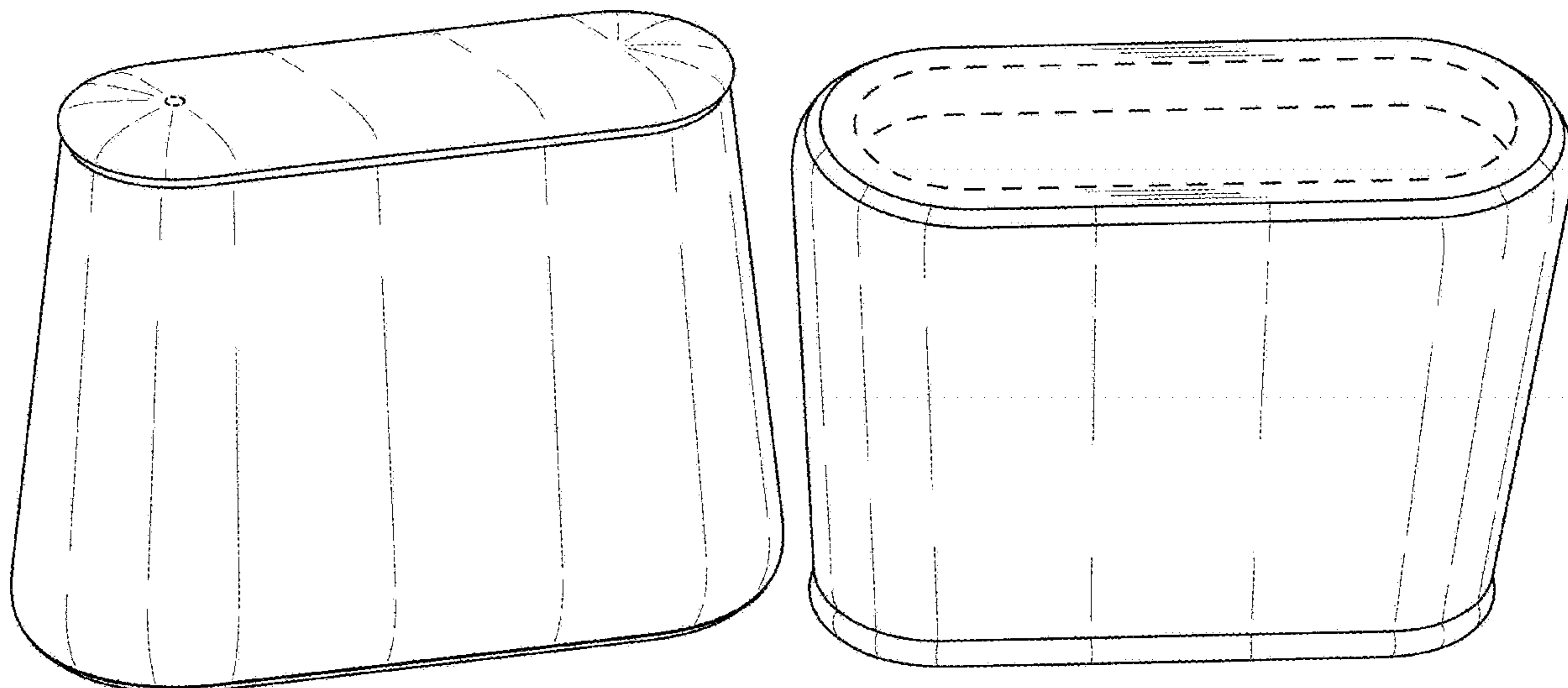
(57) **CLAIM**

The ornamental design for an aroma diffuser, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an aroma diffuser showing my new design;
FIG. 2 is a rear elevational view thereof;

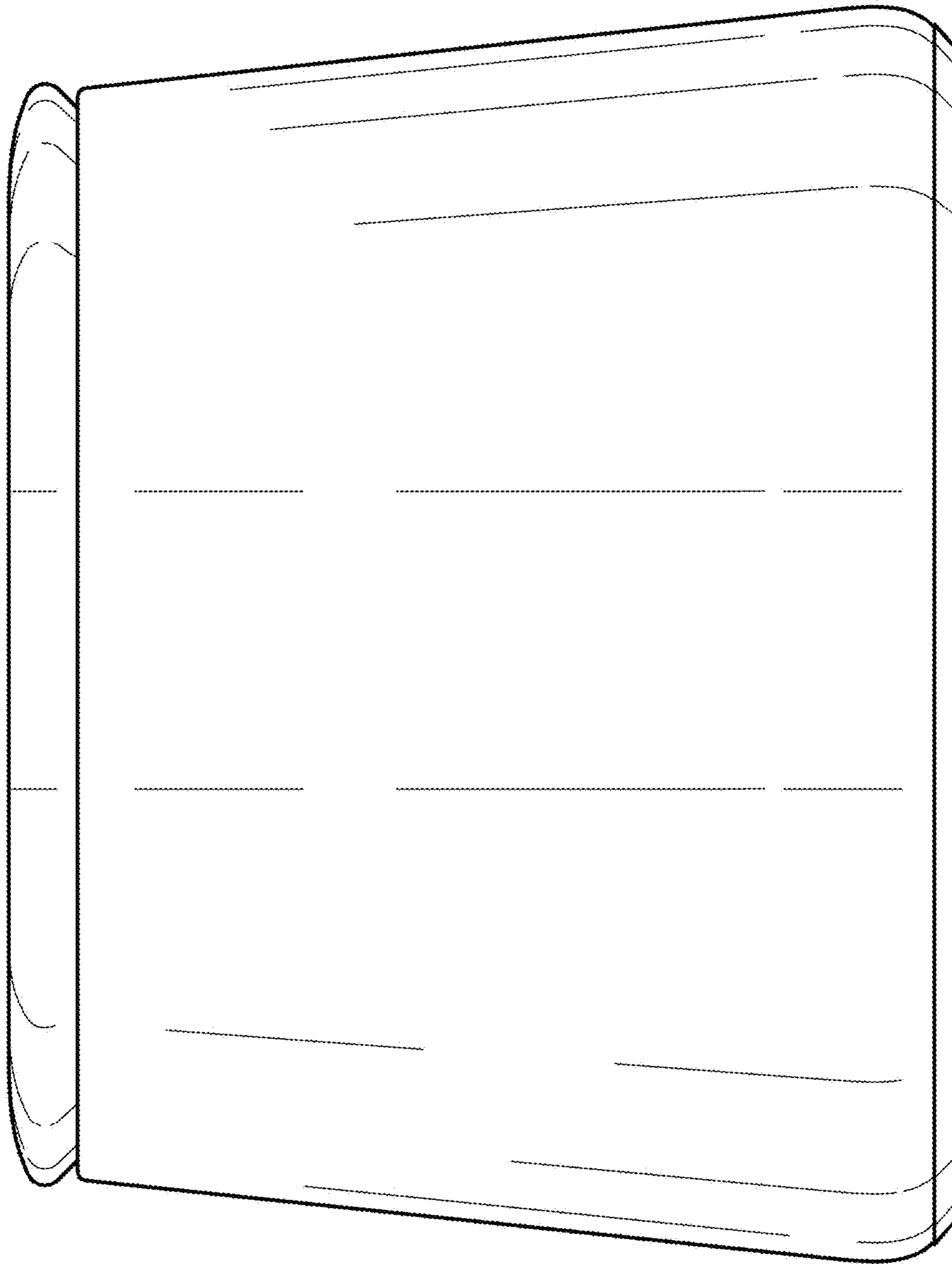

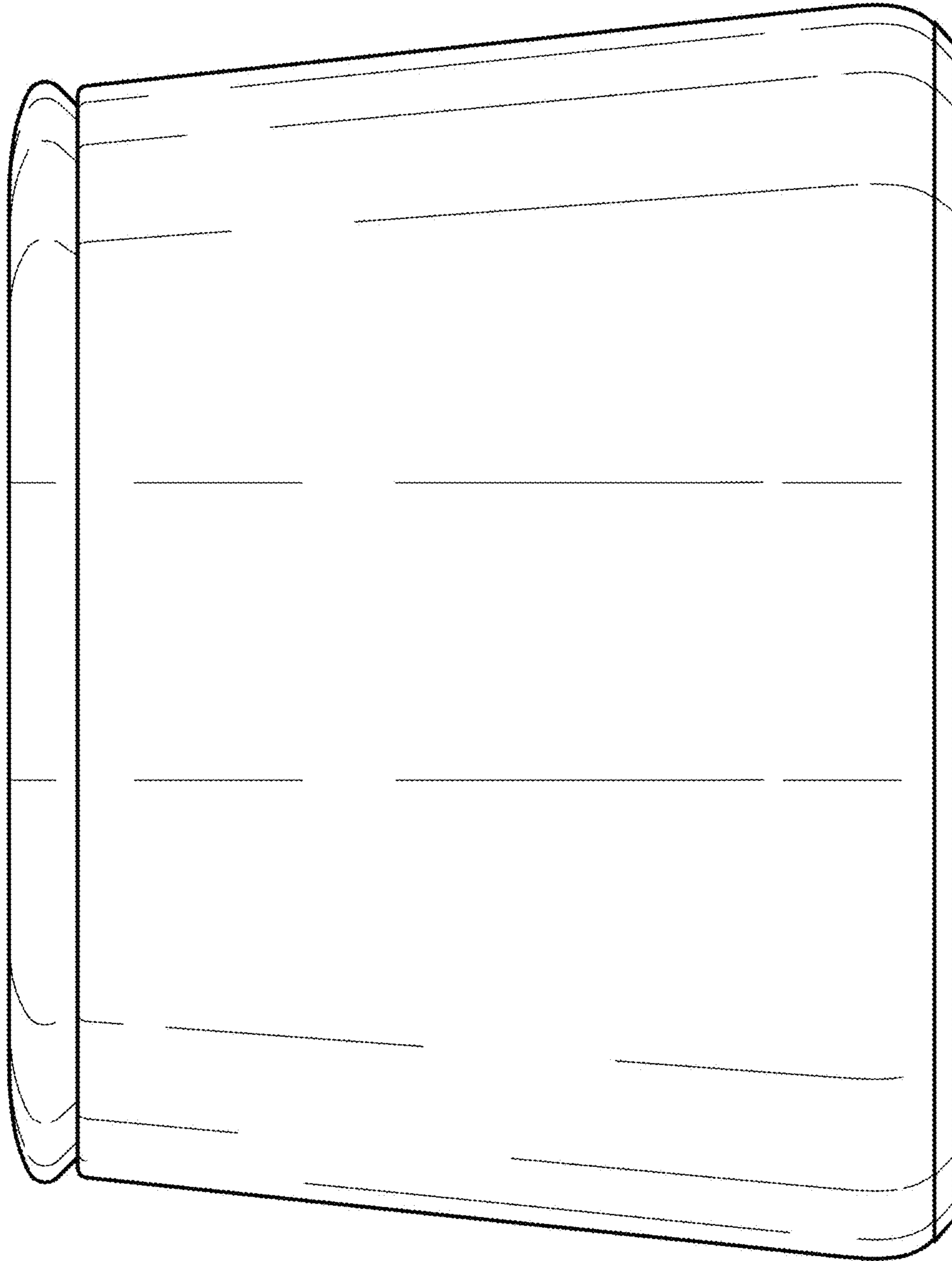

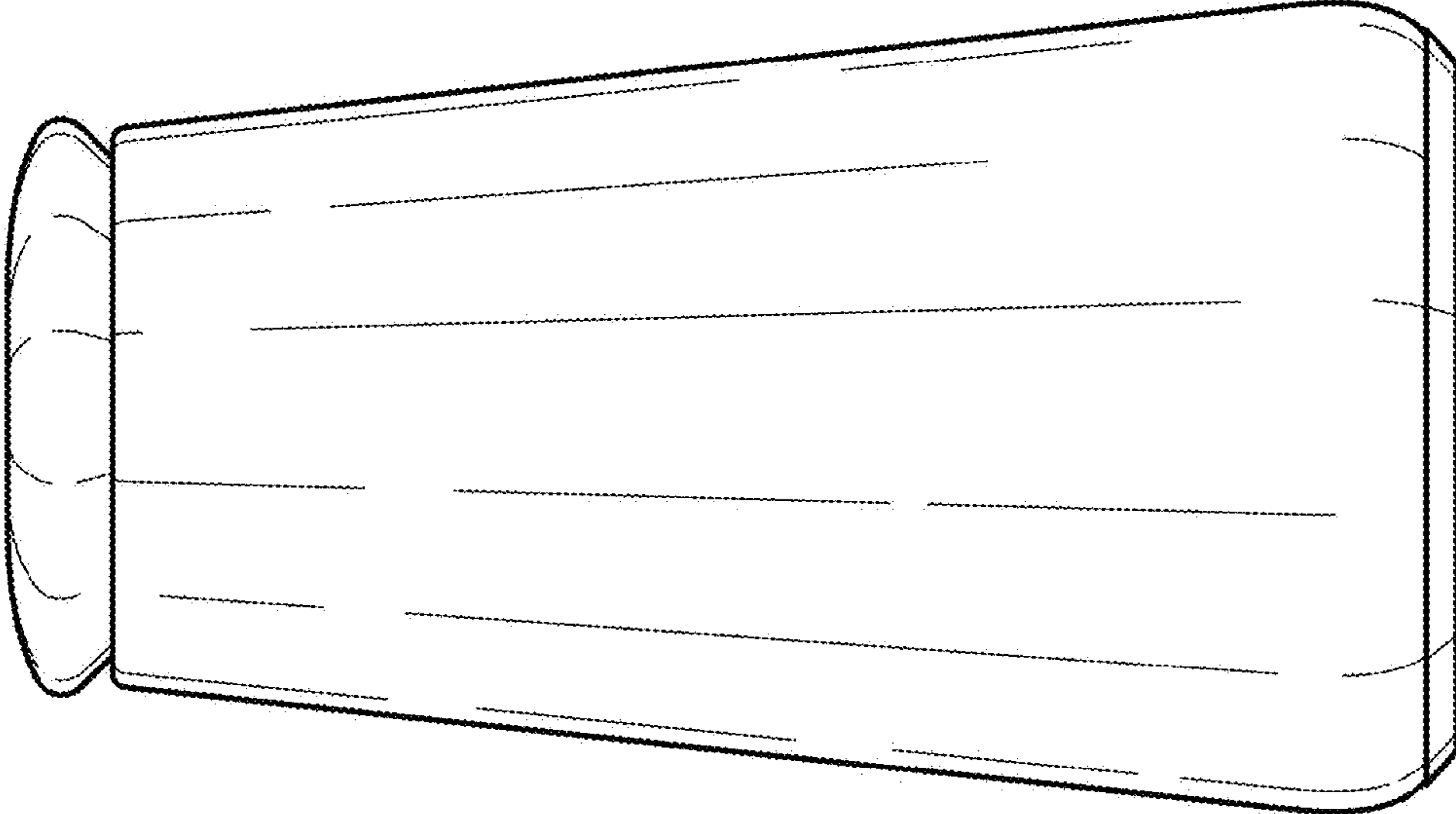

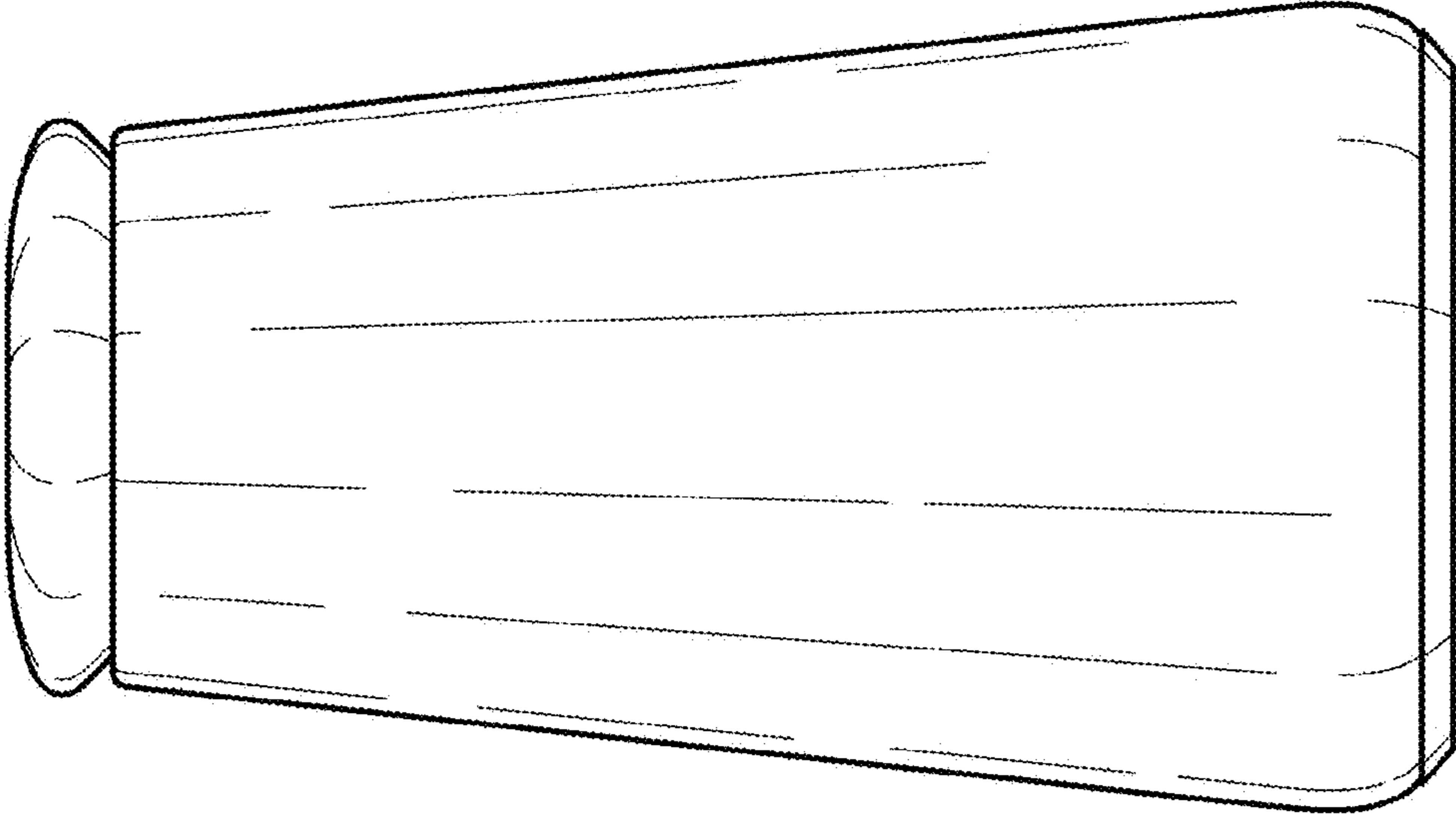

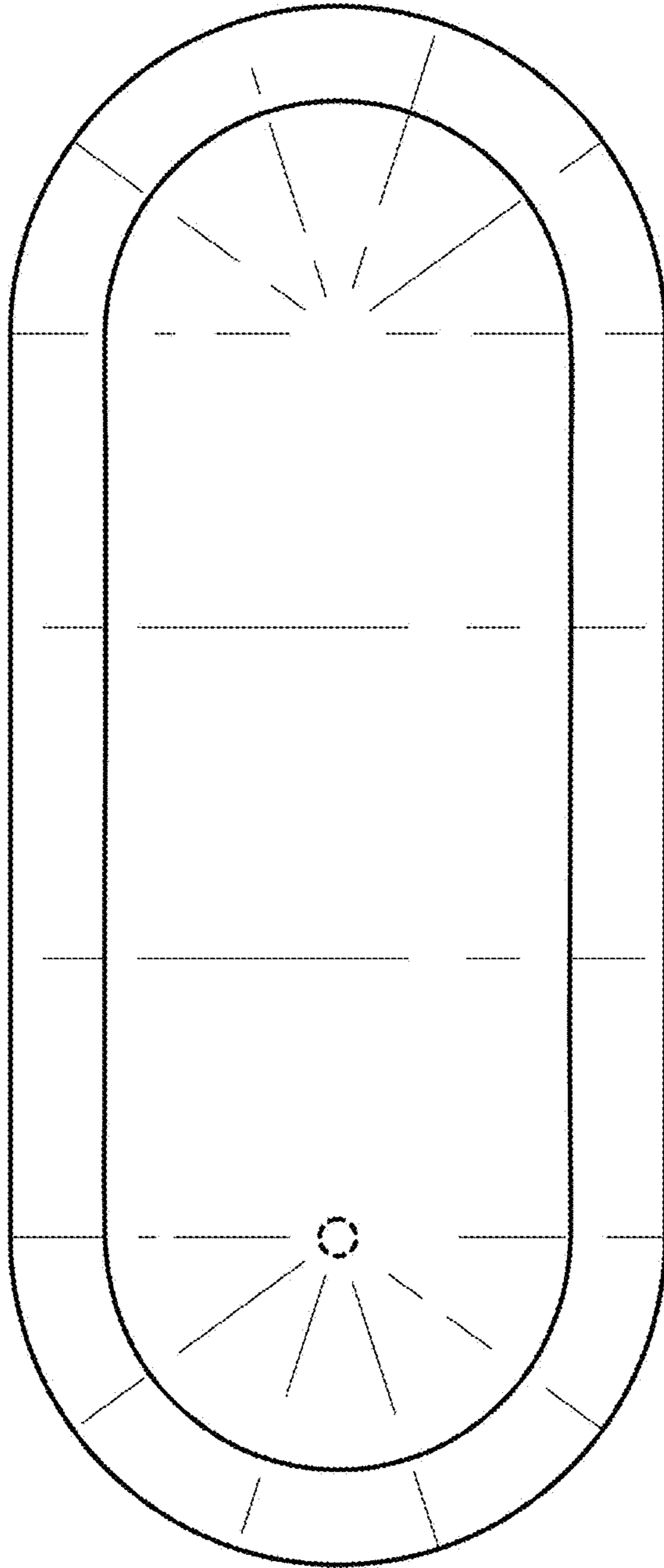

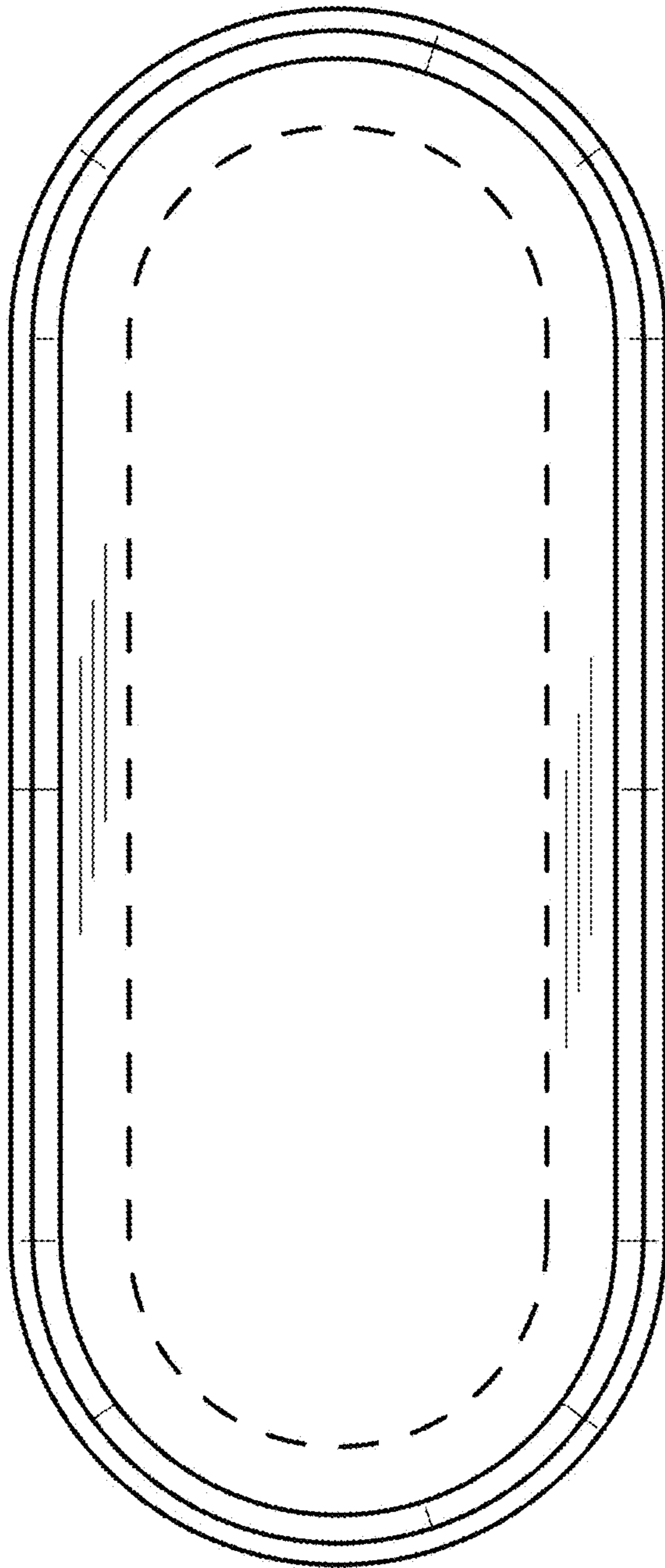

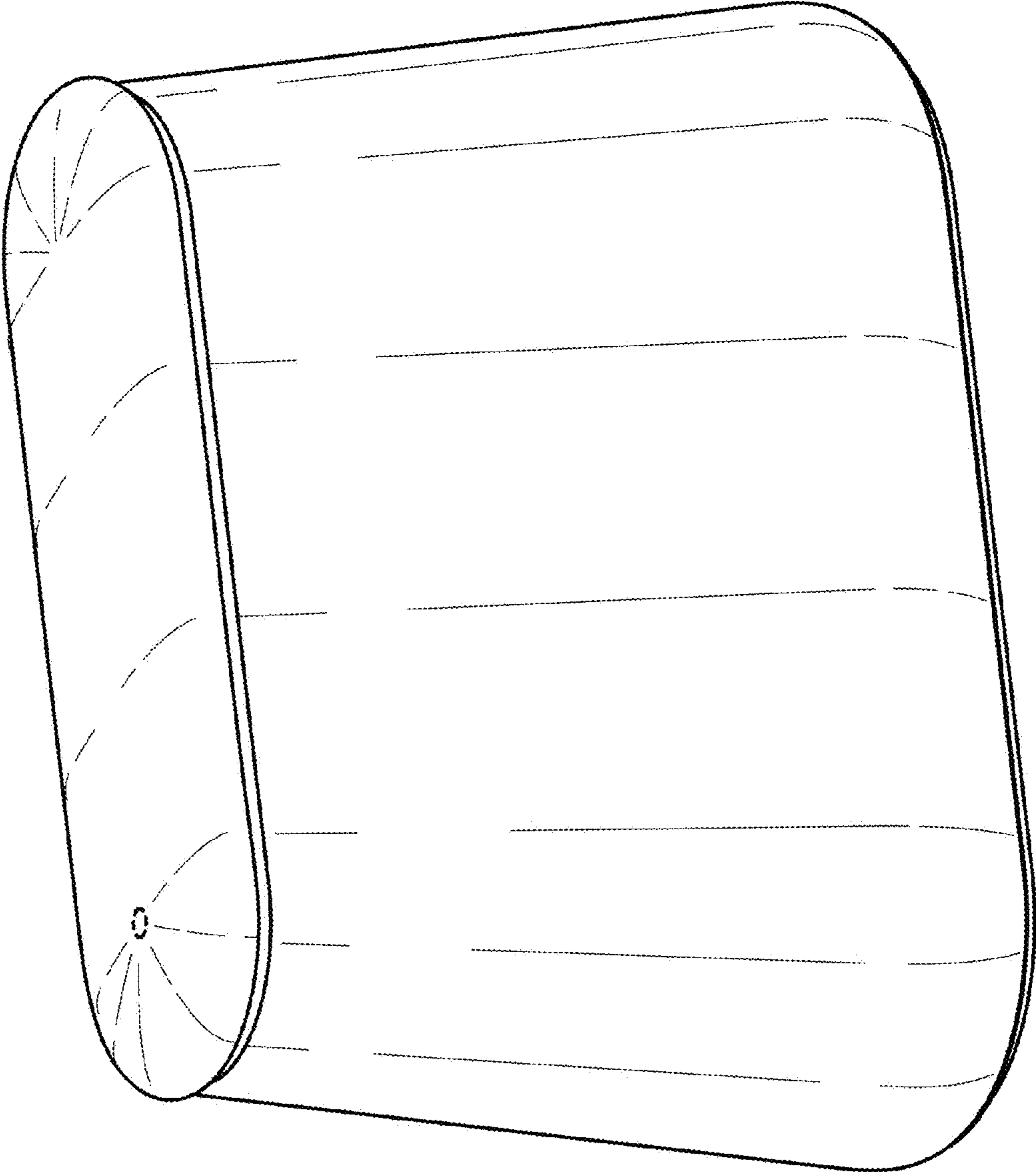

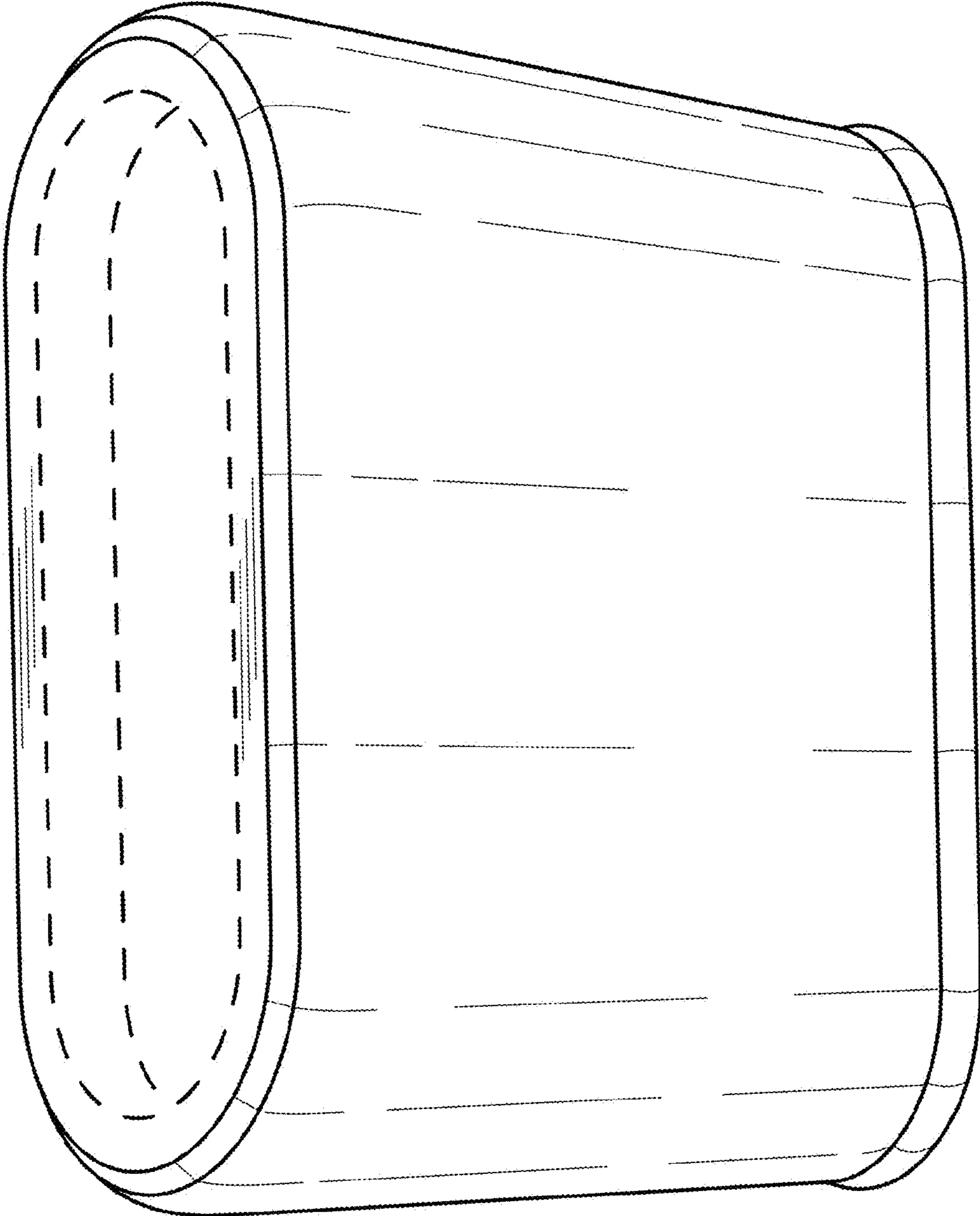
