The ornamental design for a tourniquet, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a tourniquet, showing our new design;

FIG. 2 is a rear view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a right side view thereof;

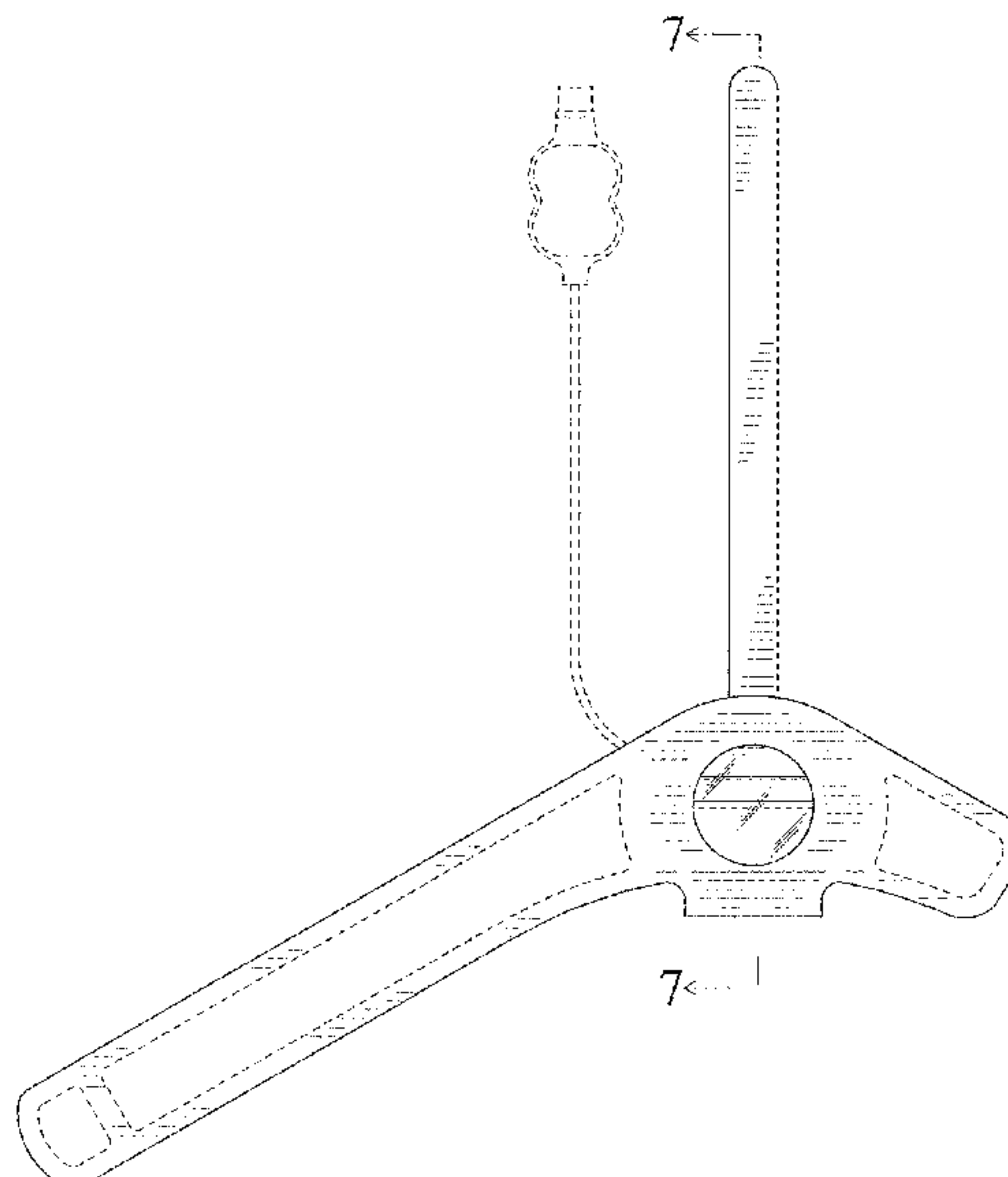
FIG. 6 is a left side view thereof;

FIG. 7 is a sectional view thereof, taken along line 7-7 in FIG. 1;

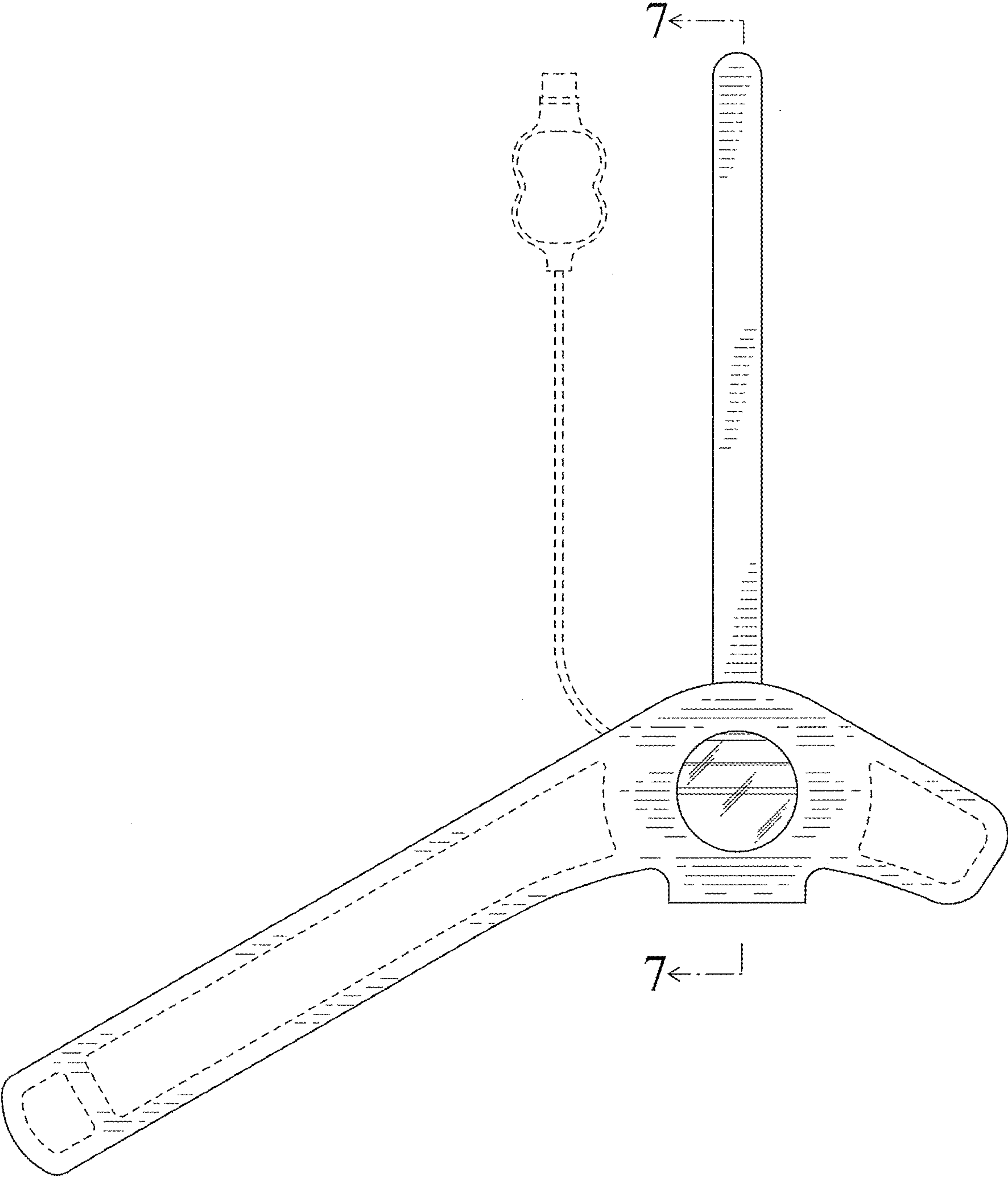

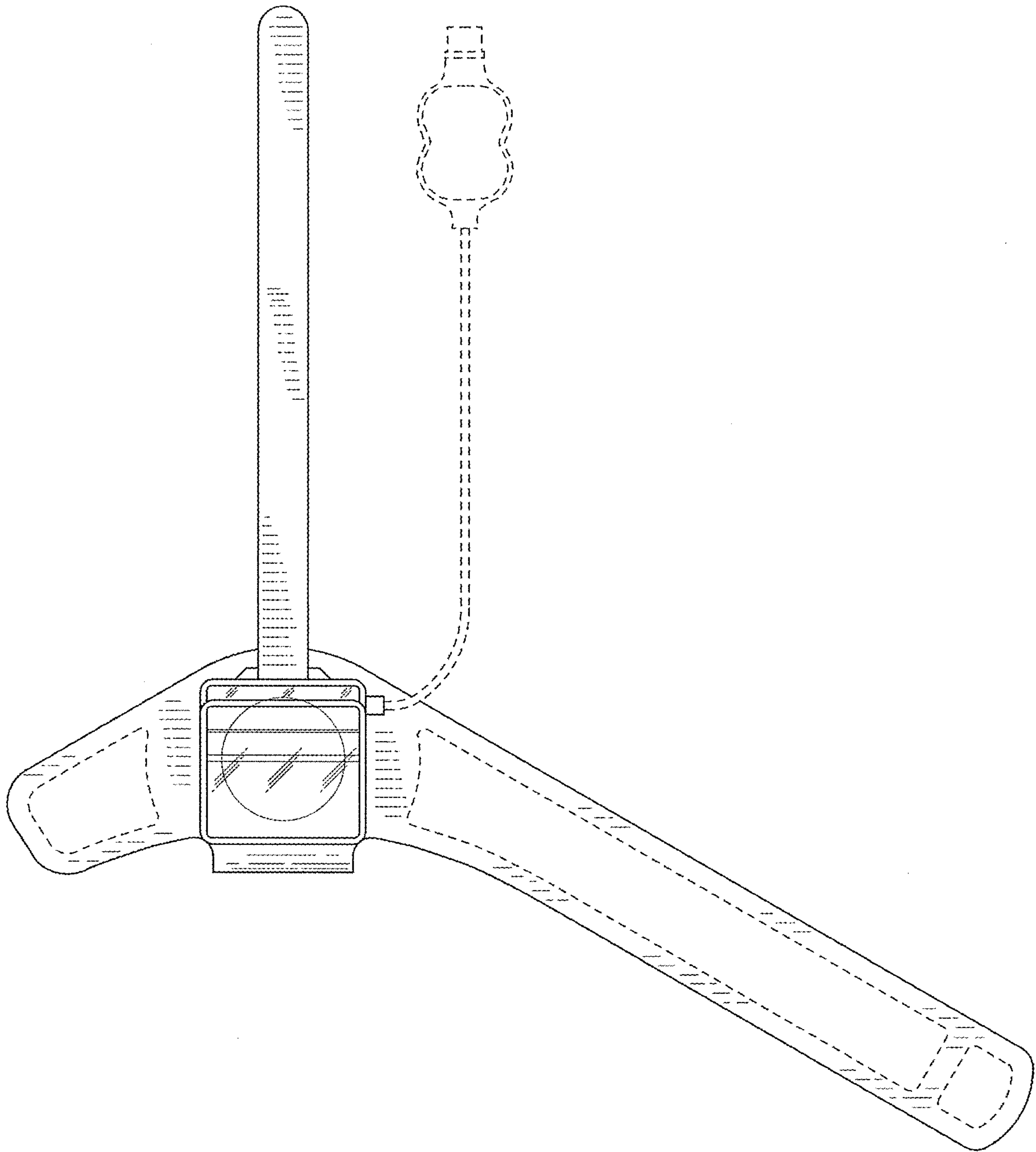

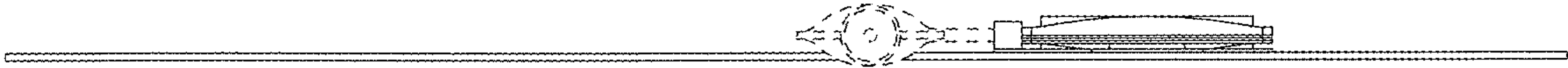

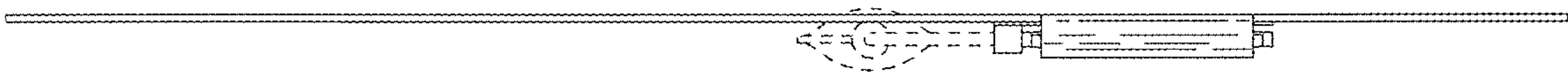

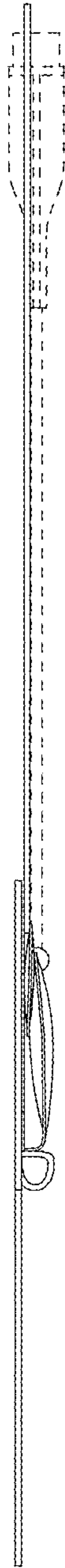

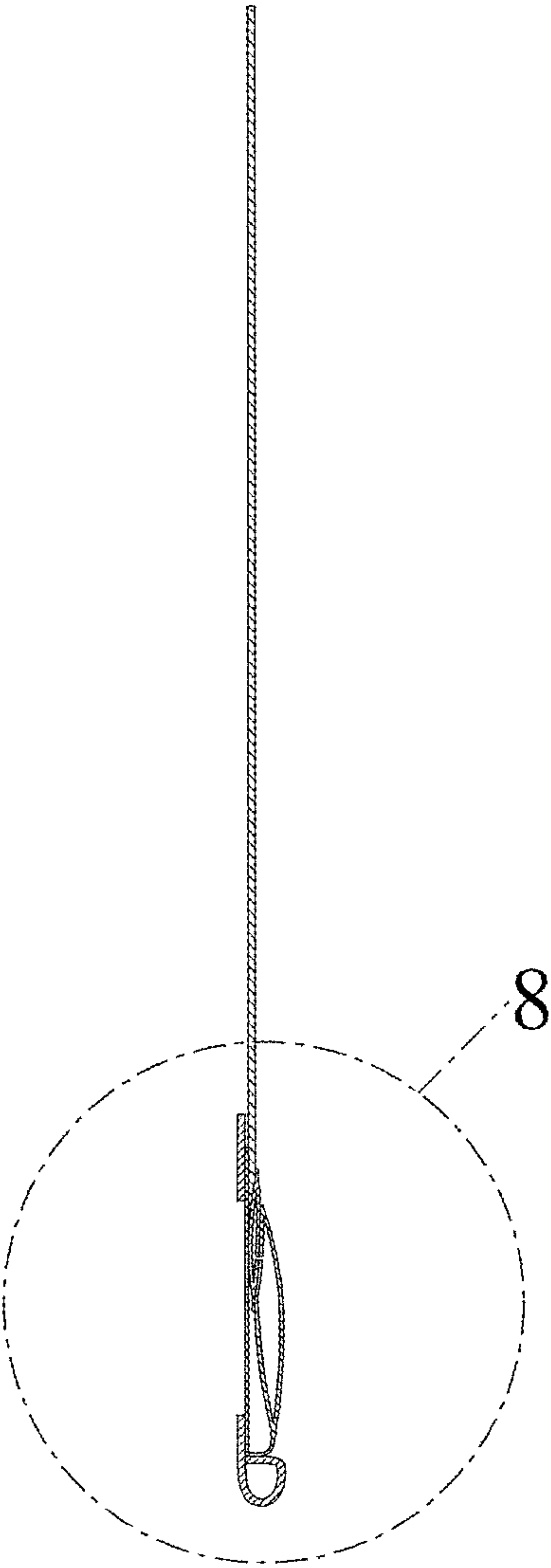

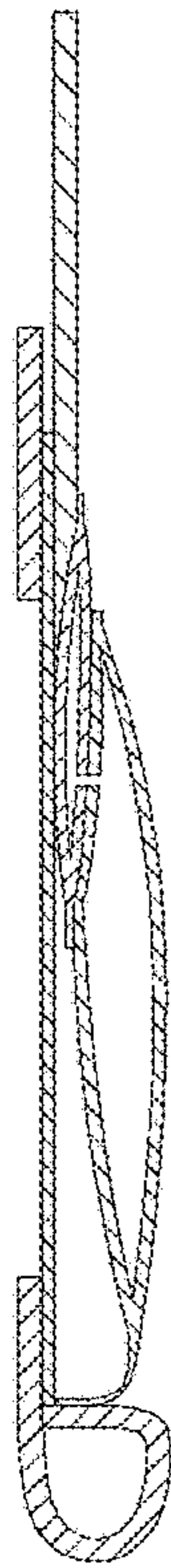

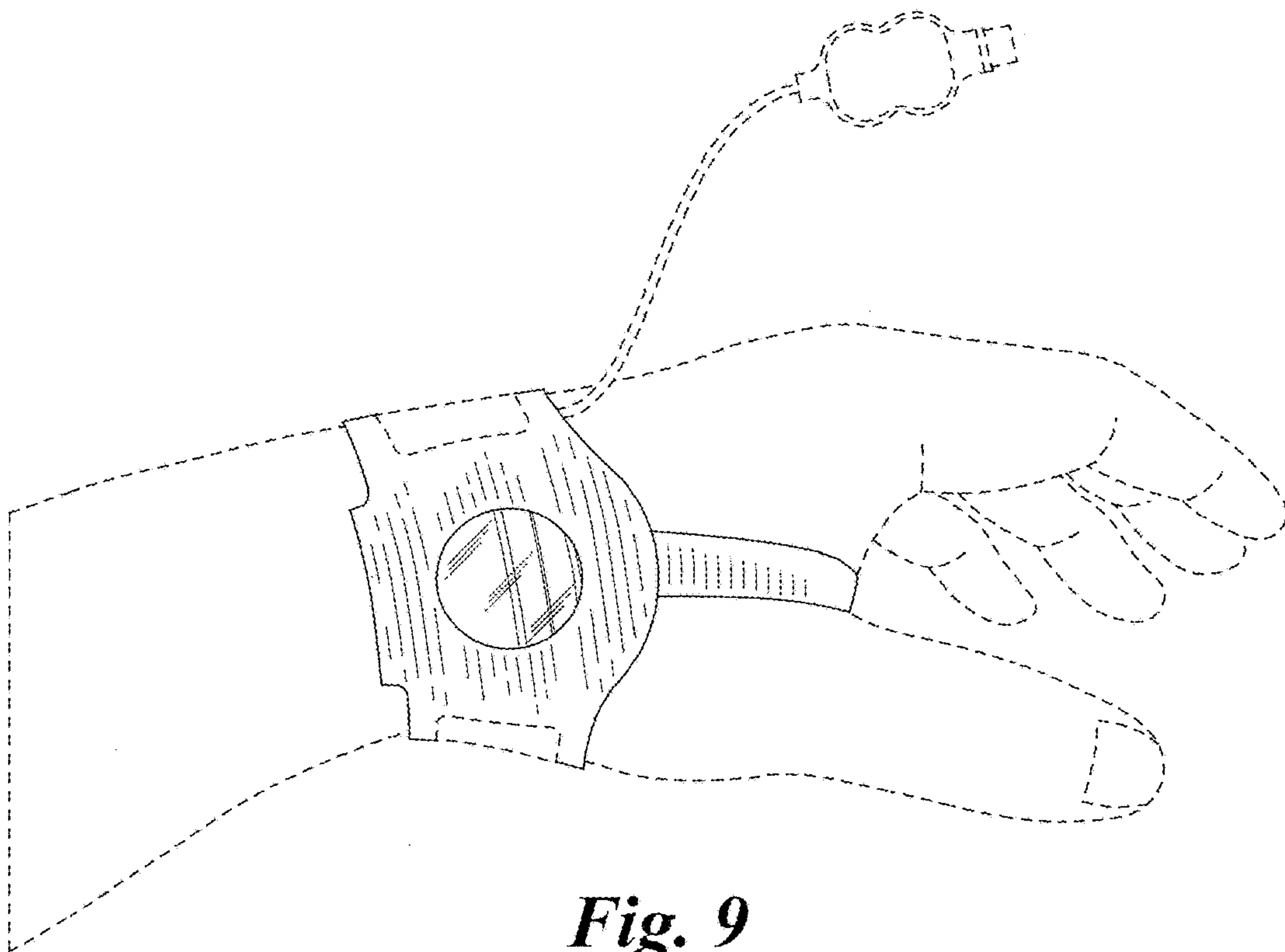
