FIG. 9 is a cross sectional view thereof, taken in the direction of line 9-9 of FIG. 3;

FIG. 13 is a cross-sectional view thereof, taken in the direction of line 13- 13 of FIG. 12;

FIG. 18 is a cross-sectional view thereof, taken in the direction of line 18-18 of FIG. 12.

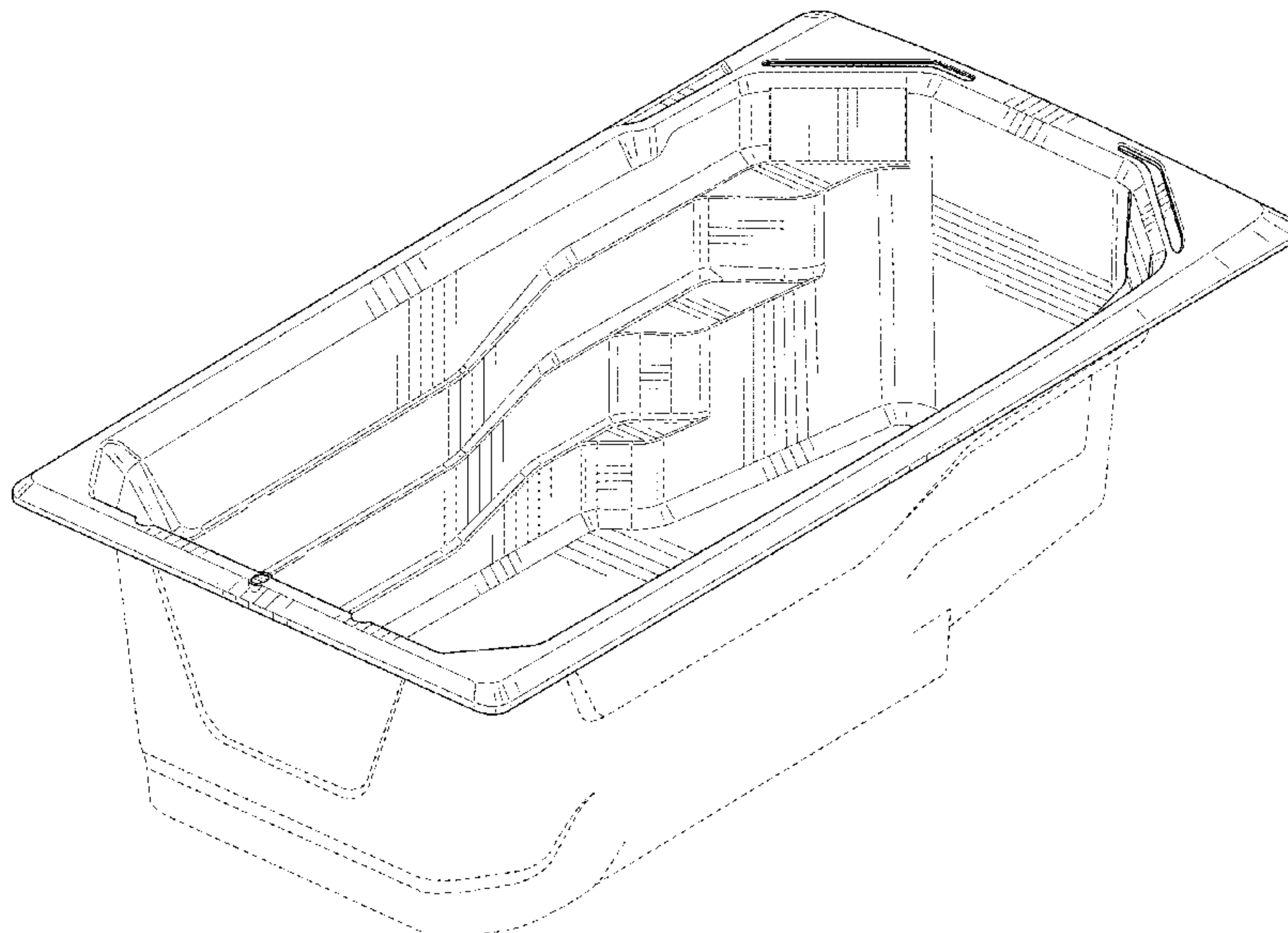

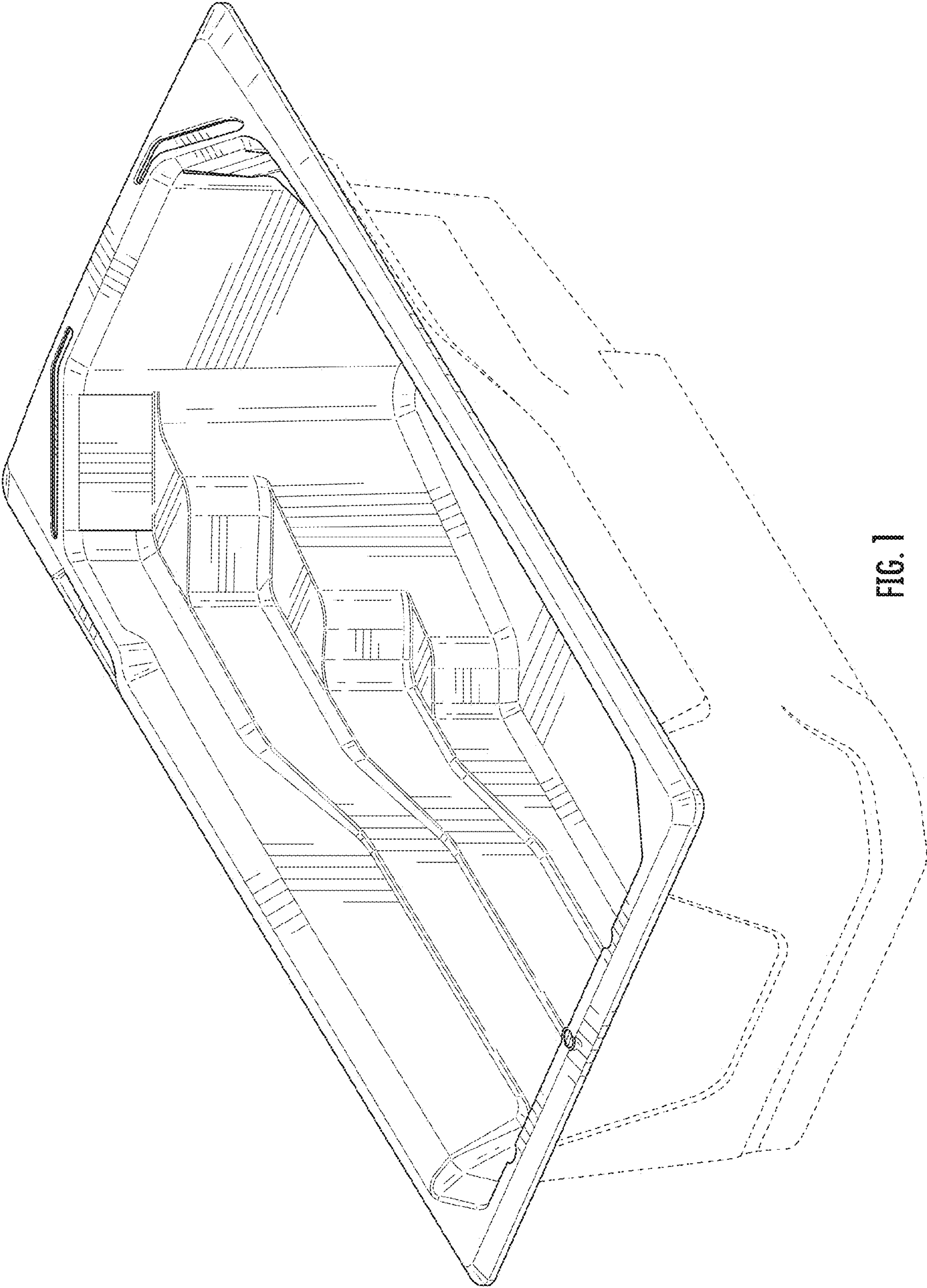

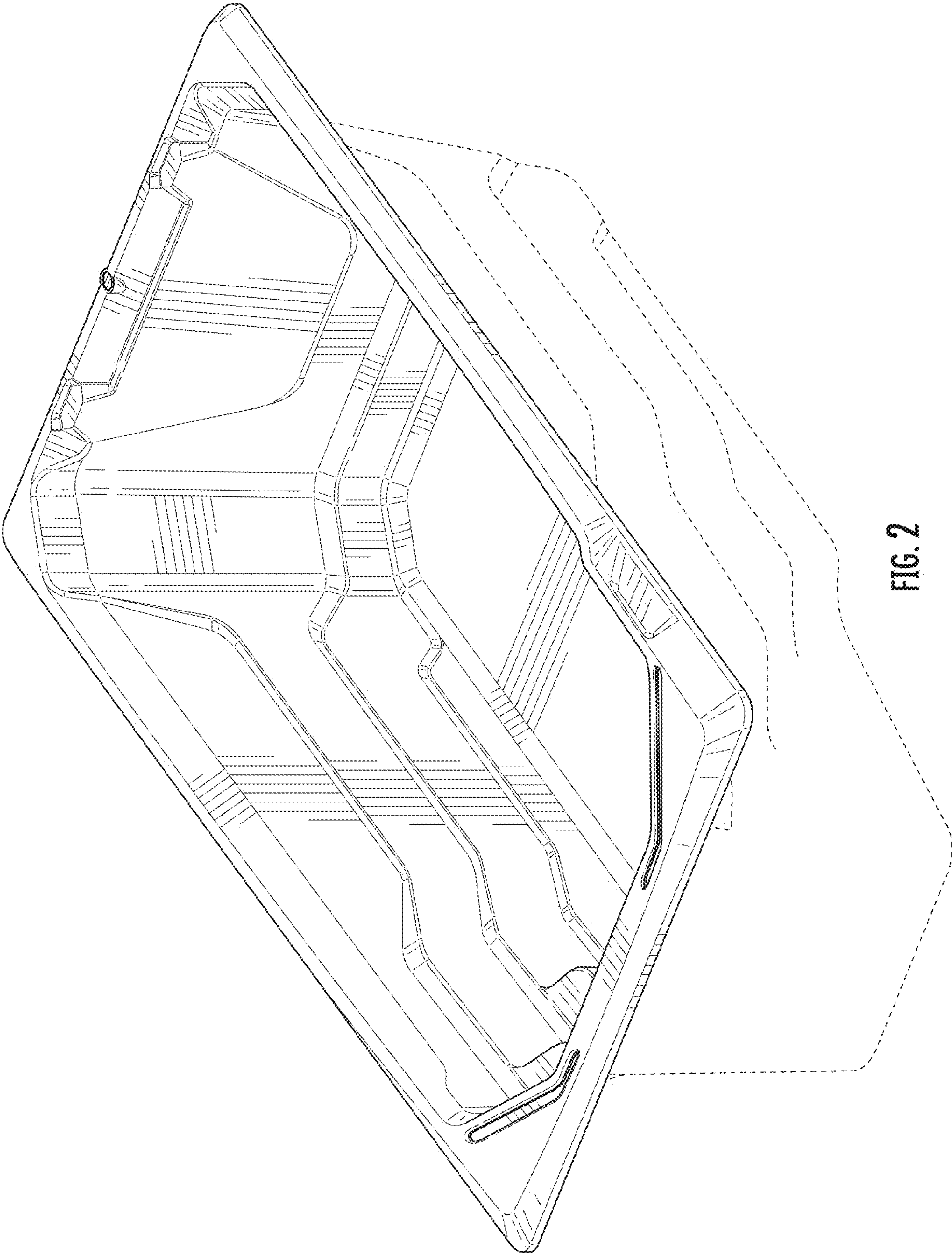

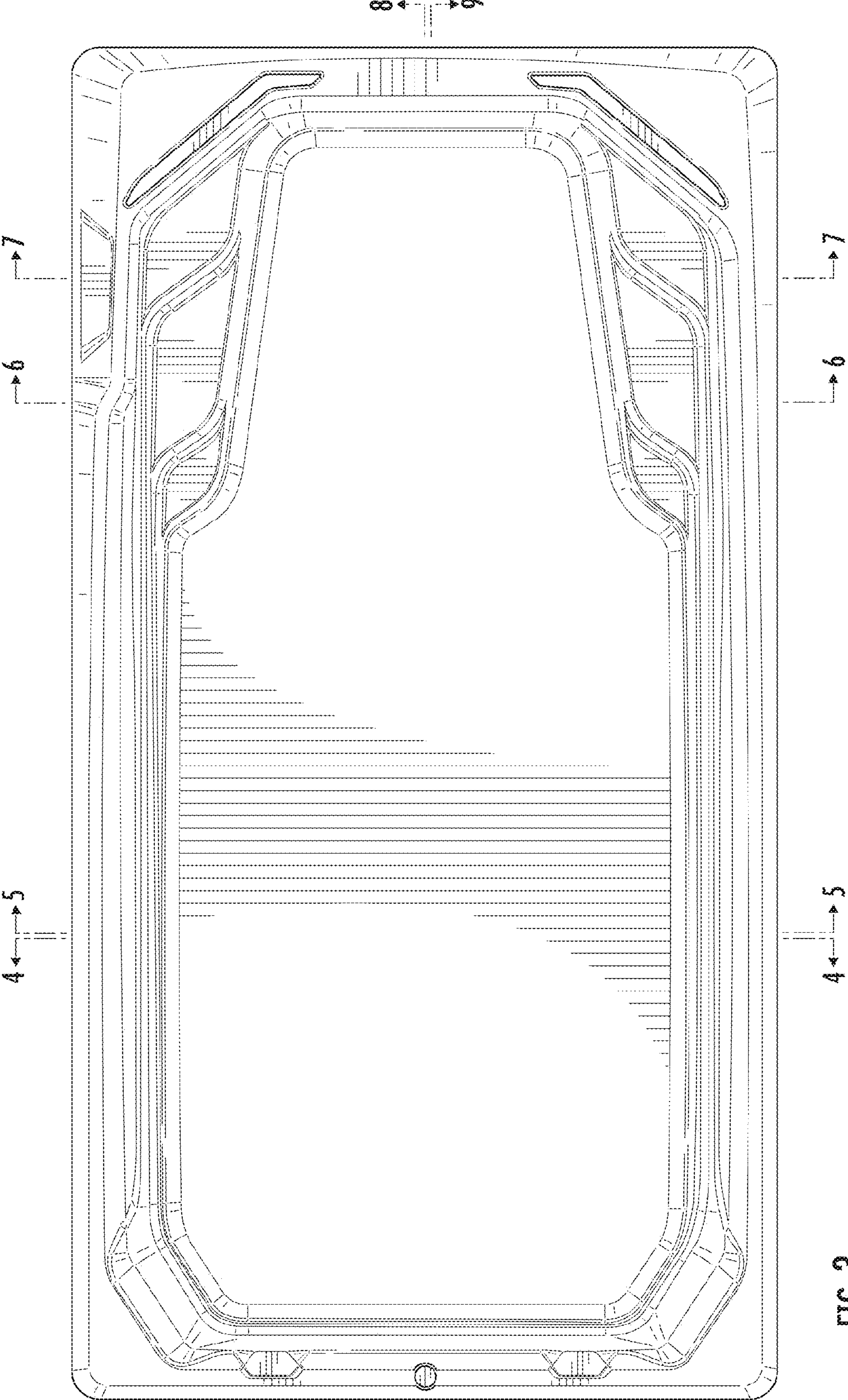

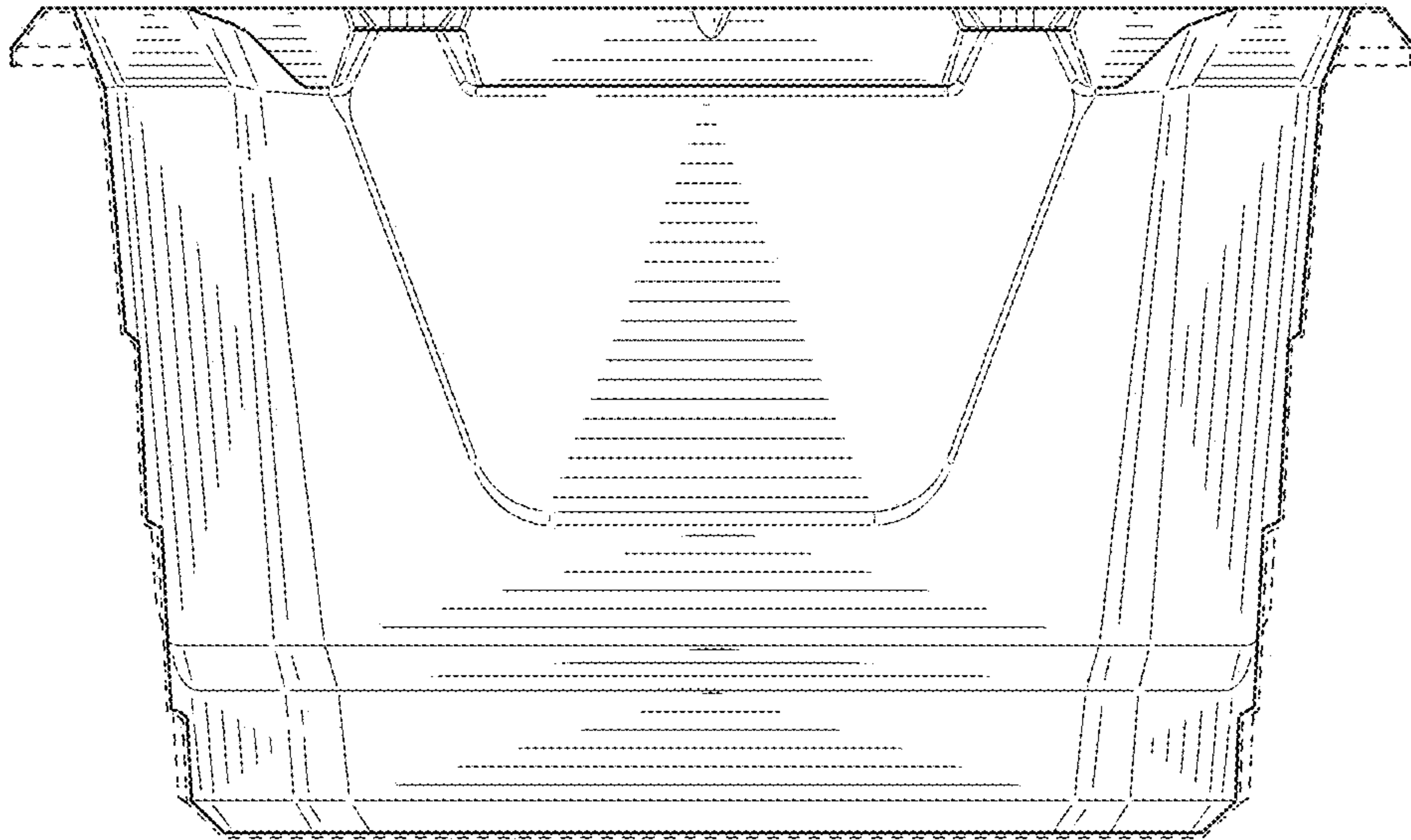

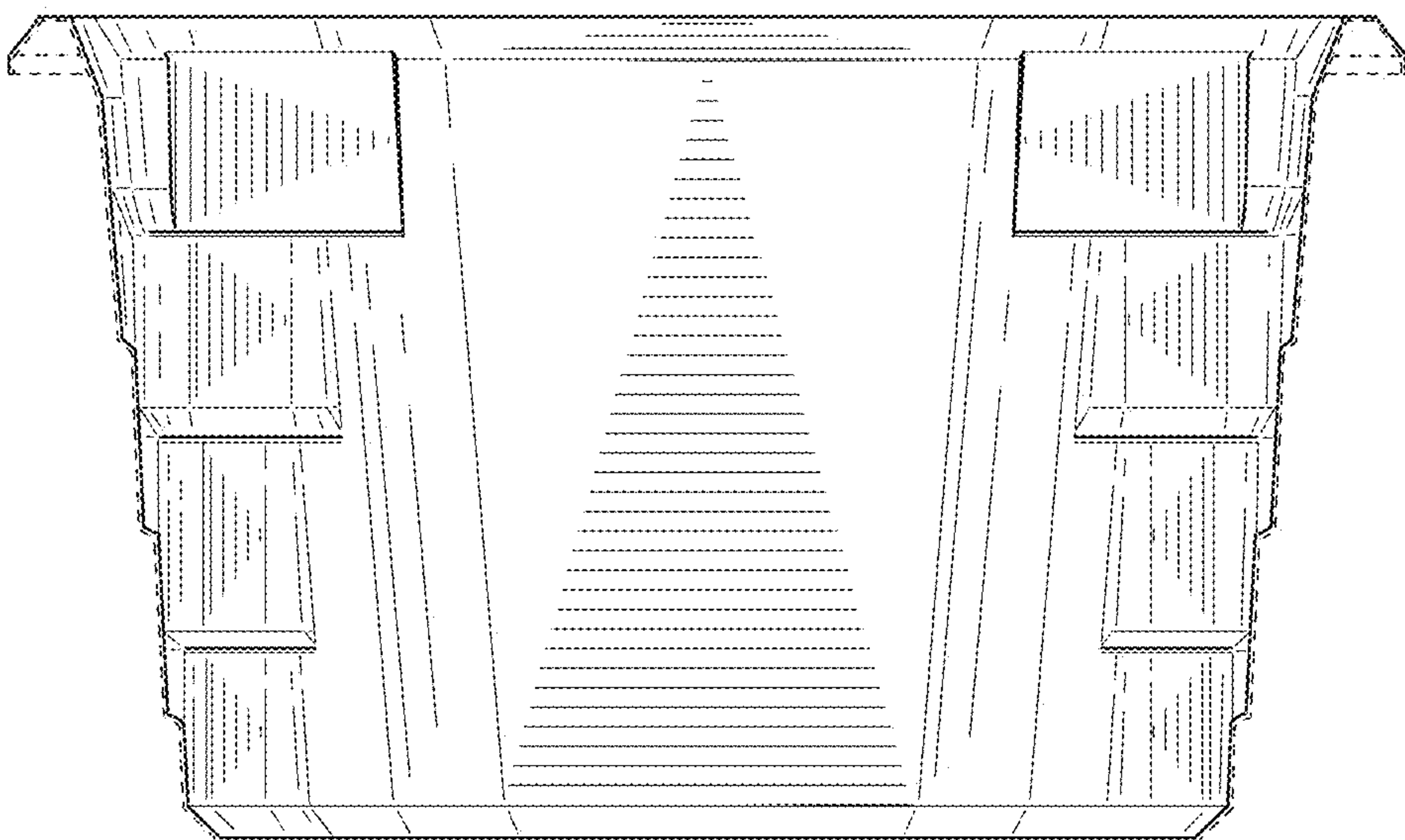

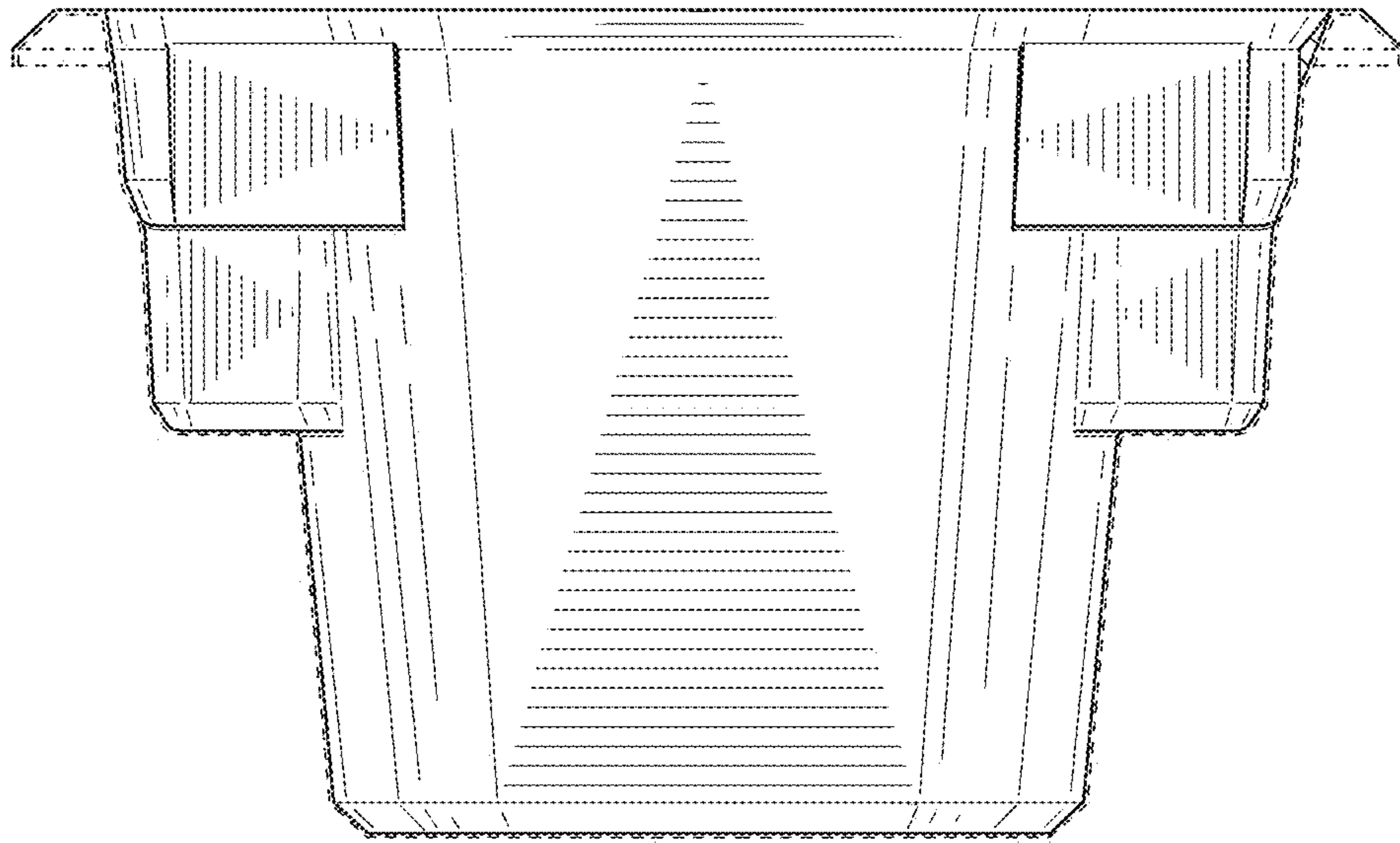

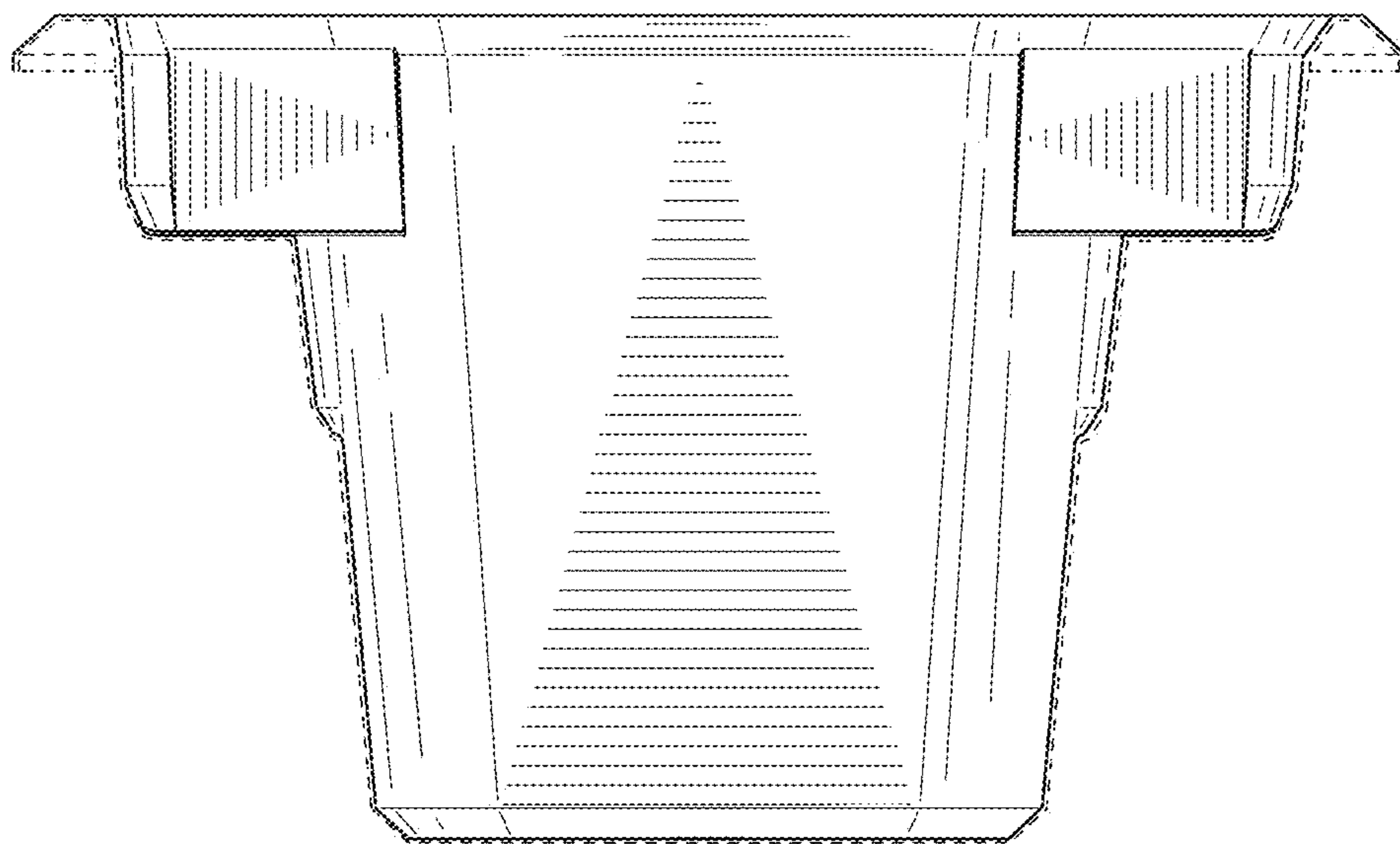

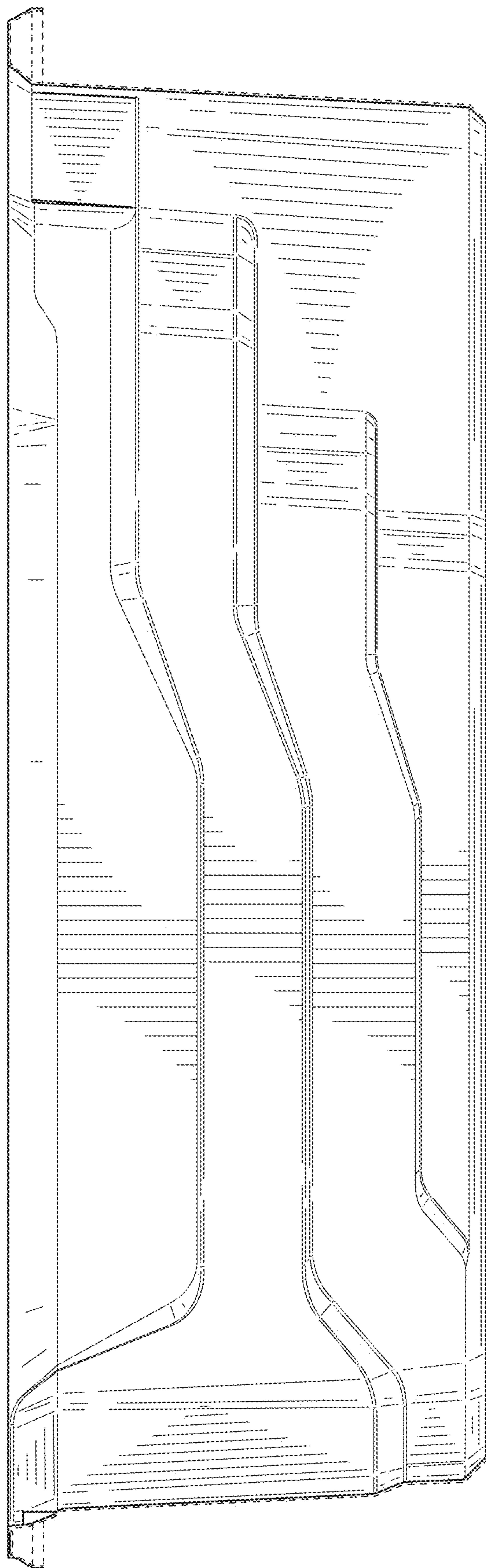

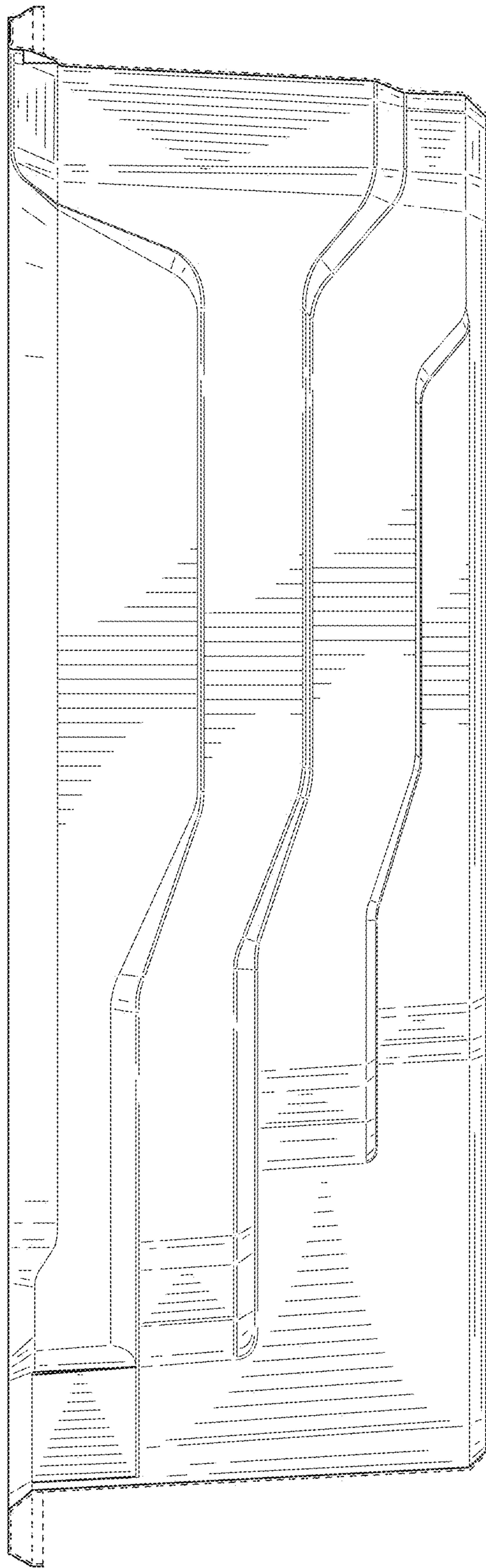

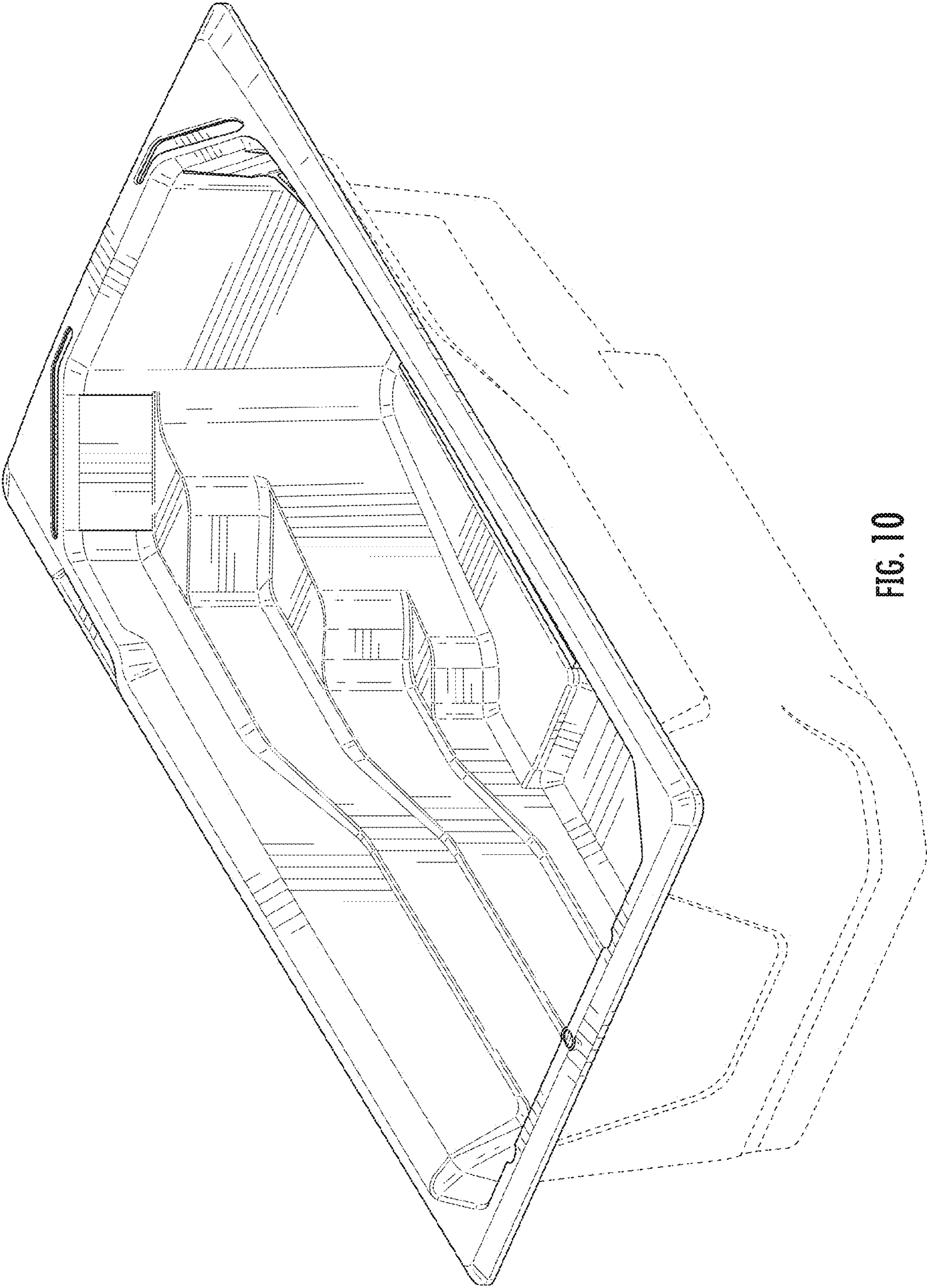

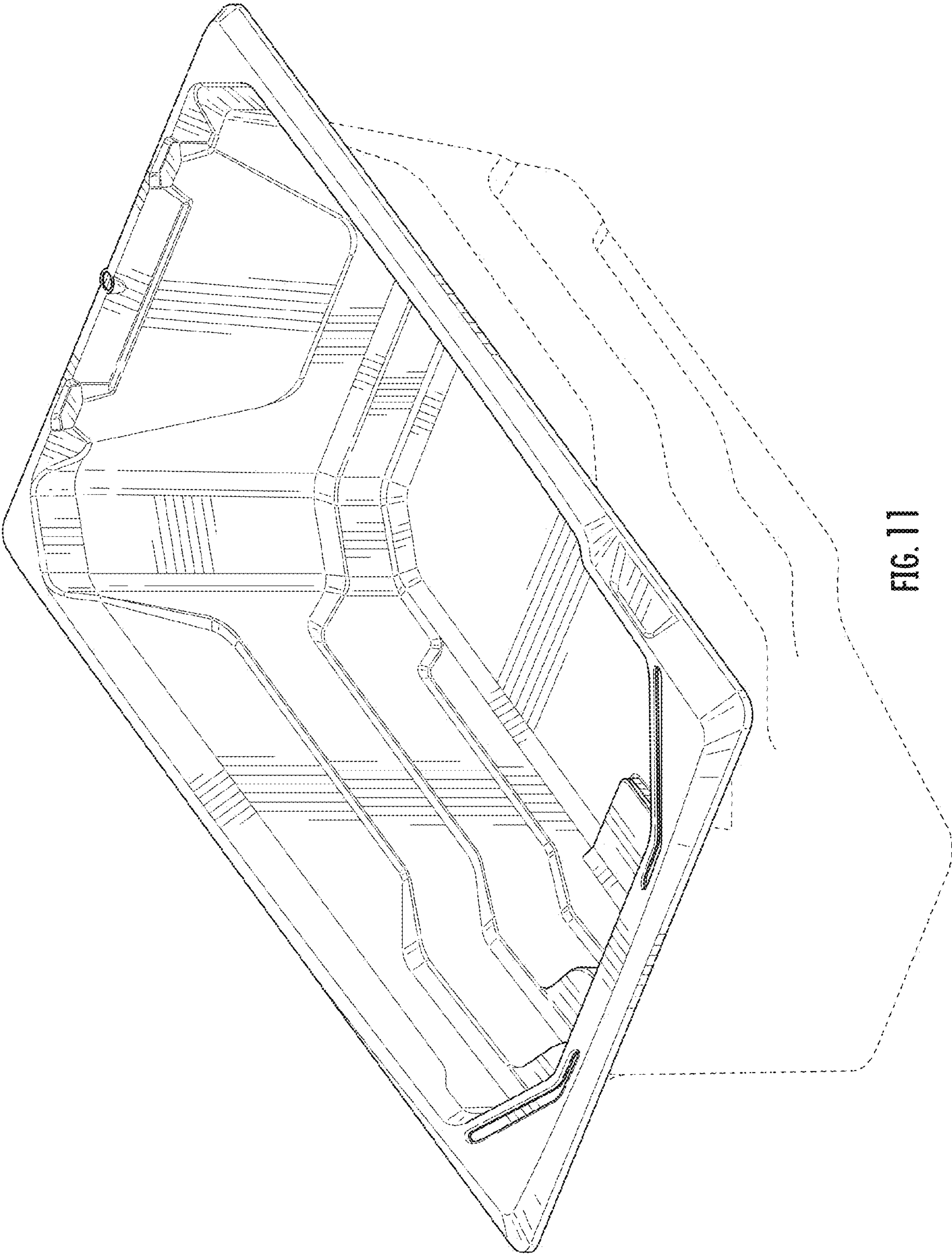

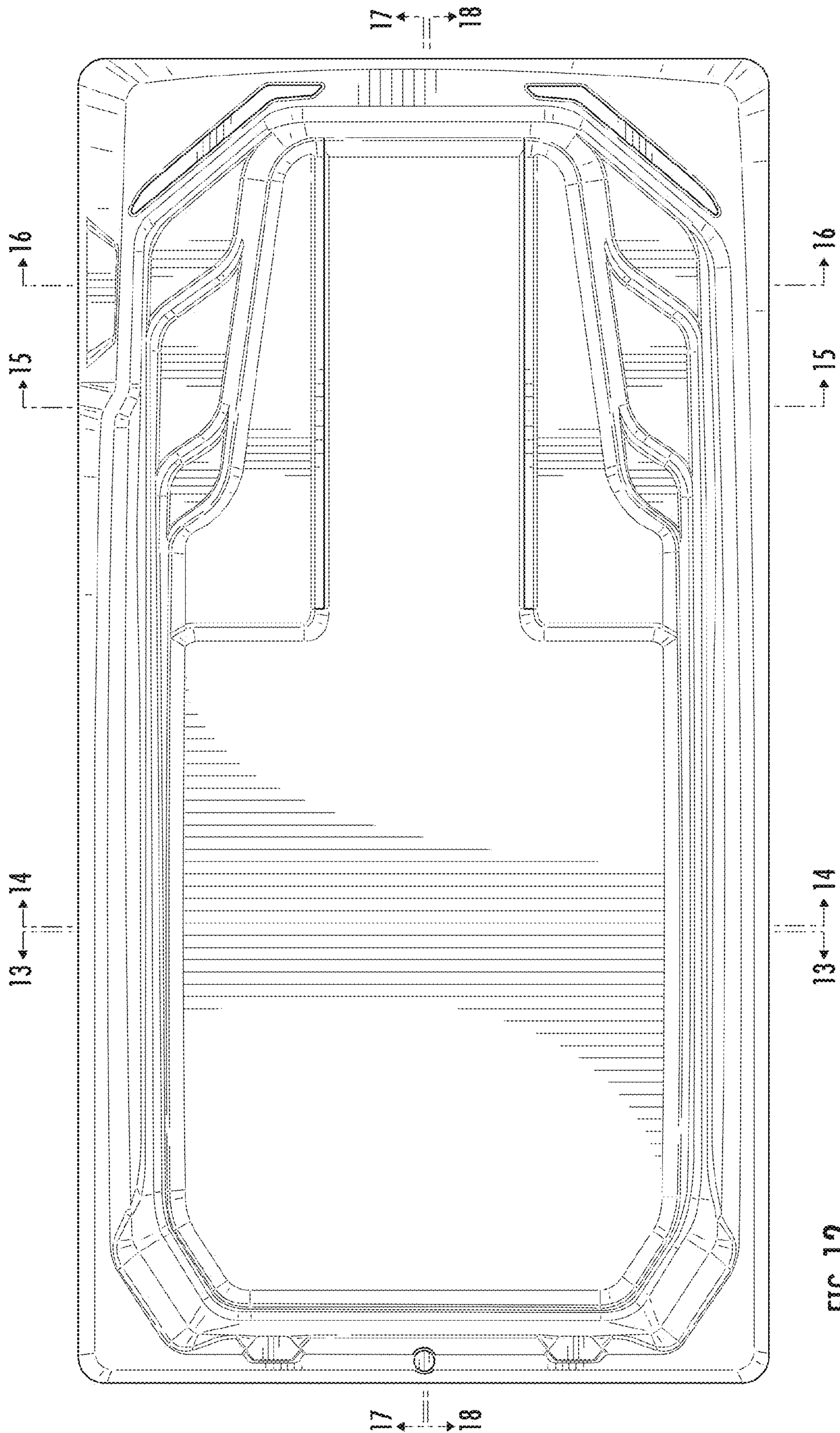

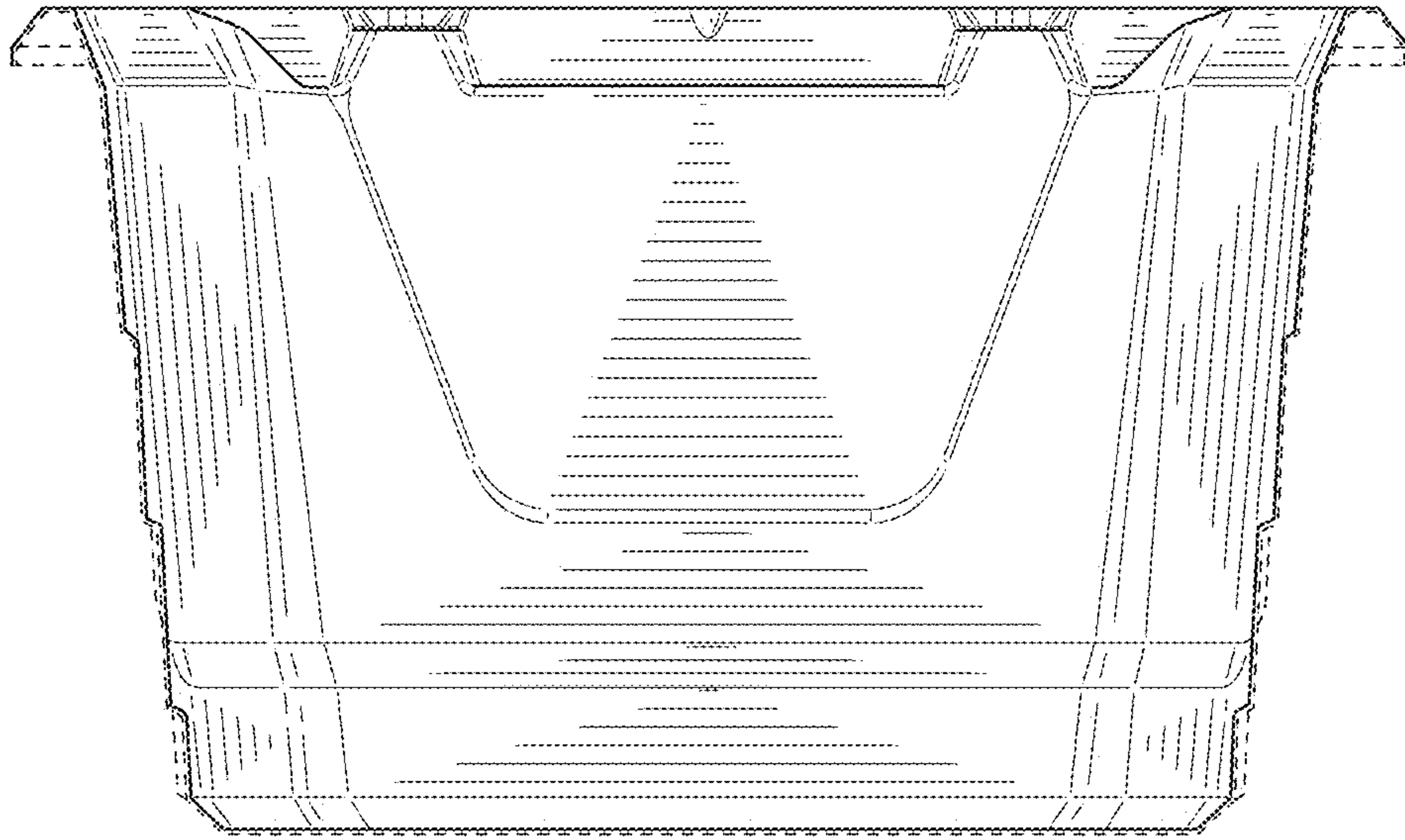

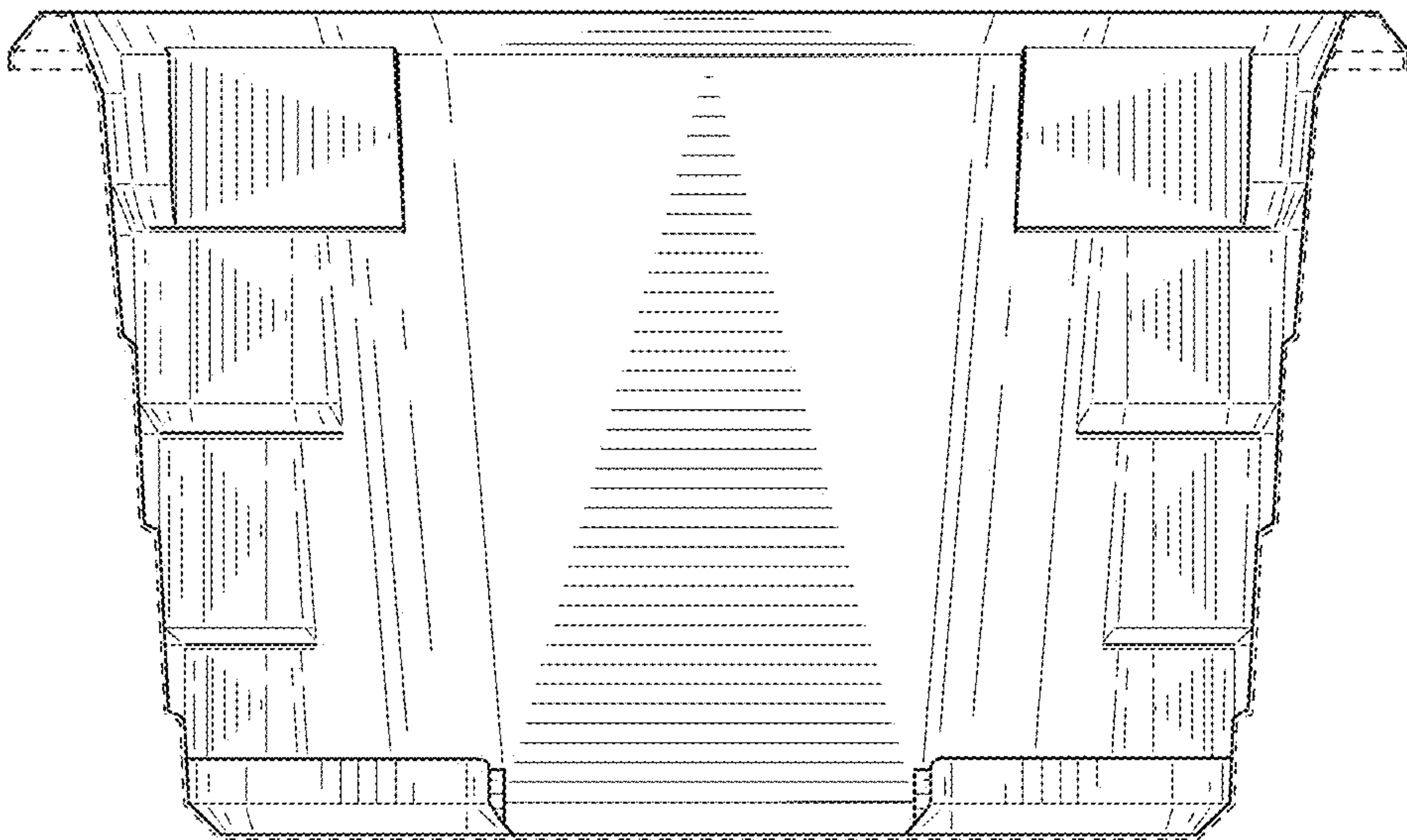

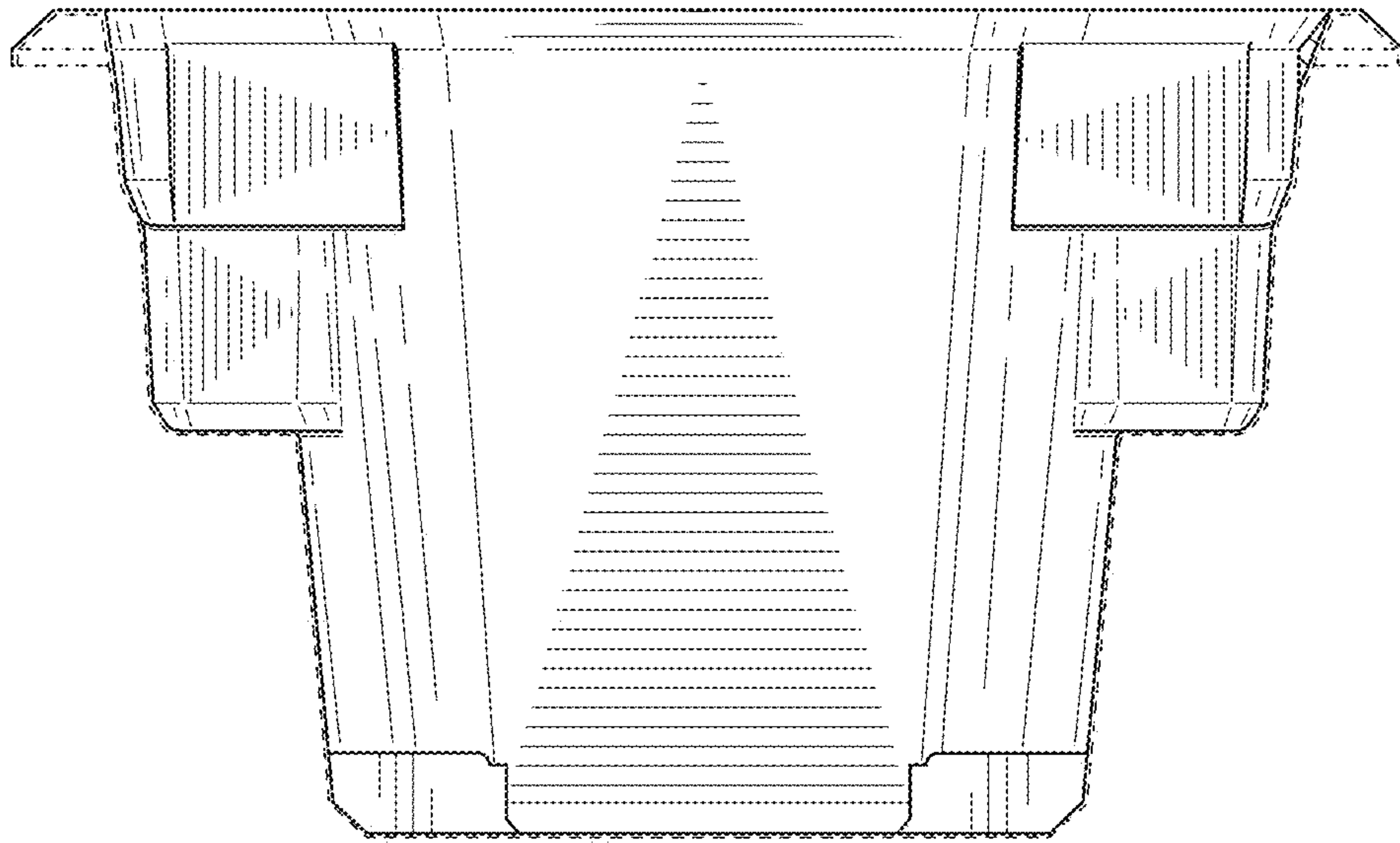

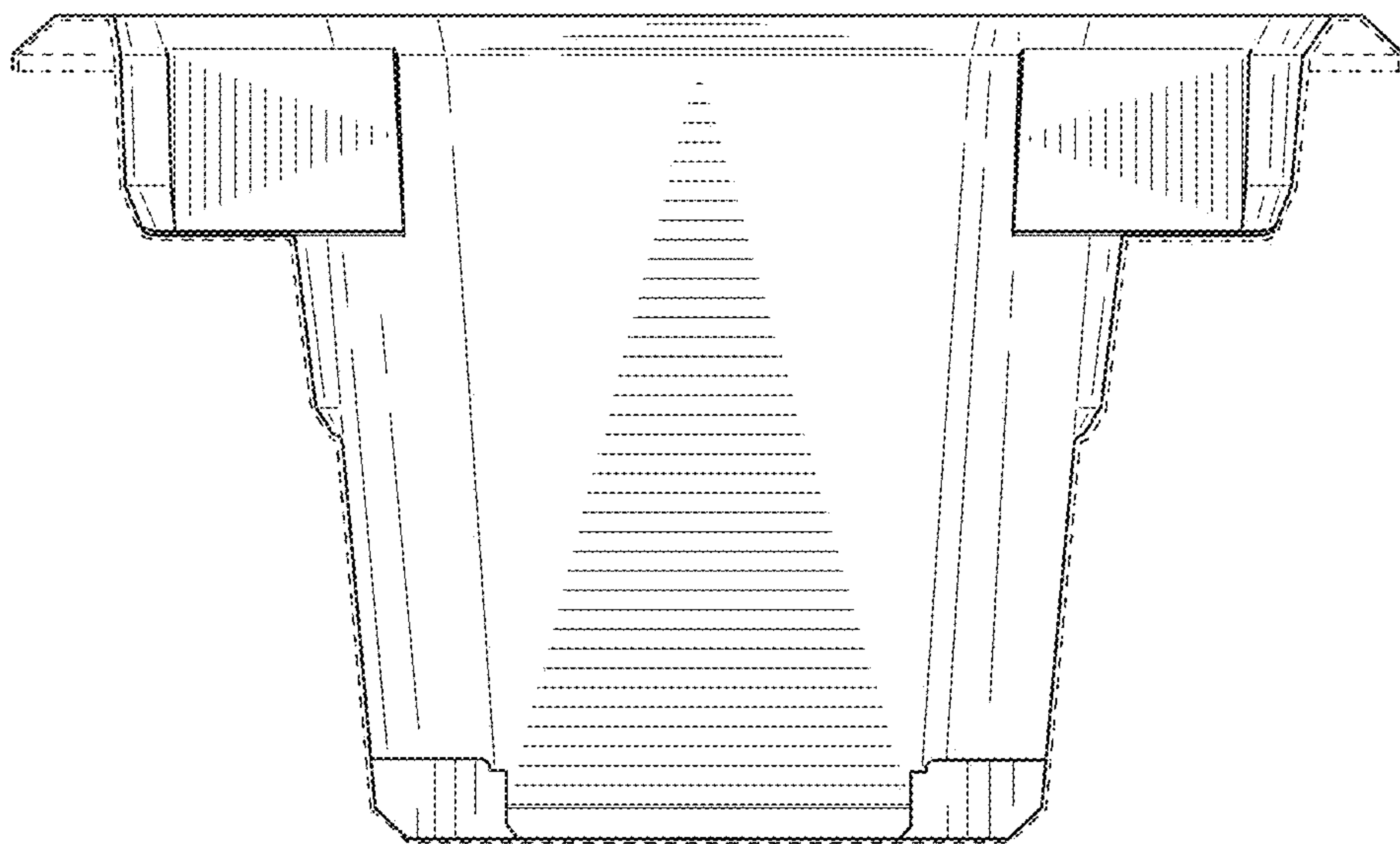

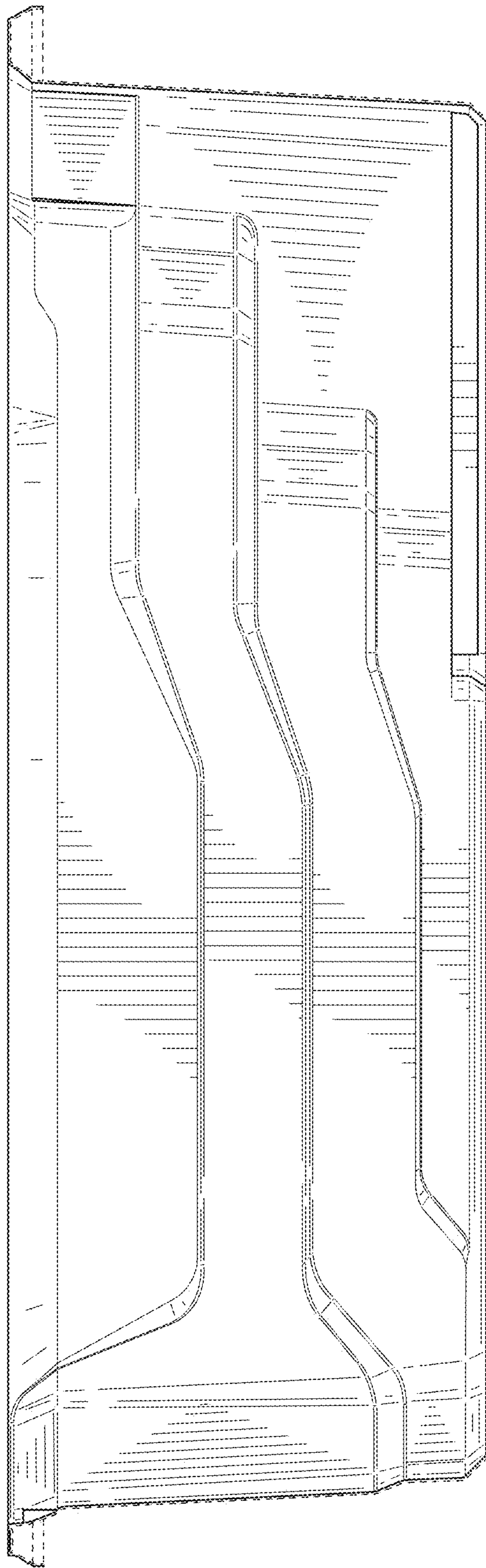

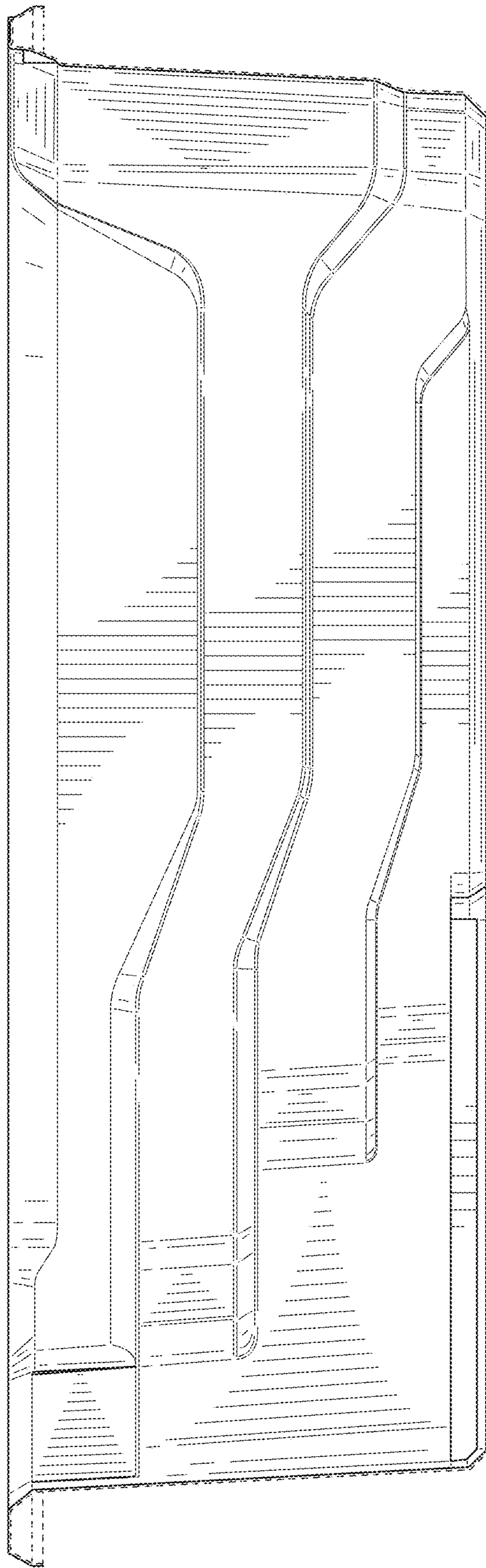
