(57) **CLAIM**

The ornamental design for a wall base with angled top, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the wall base with angled top, according to the invention;
 FIG. 2 is a top end view of the wall base with angled top shown in FIG. 1;
 FIG. 3 is a front view of the wall base with angled top shown in FIG. 1;
 FIG. 4 is a side view of the wall base with angled top shown in FIG. 1;
 FIG. 5 is a side view of the wall base with angled top shown in FIG. 1, shown from the opposite side of that shown in FIG. 4;
 FIG. 6 is a rear view of the wall base with angled top shown in FIG. 1; and,
 FIG. 7 is a bottom end view of the wall base with angled top shown in FIG. 1.
 The wall base with angled top is shown with a symbolic break in its length. Any portion of the wall base with angled top between the jagged break lines forms no part of the claimed design.

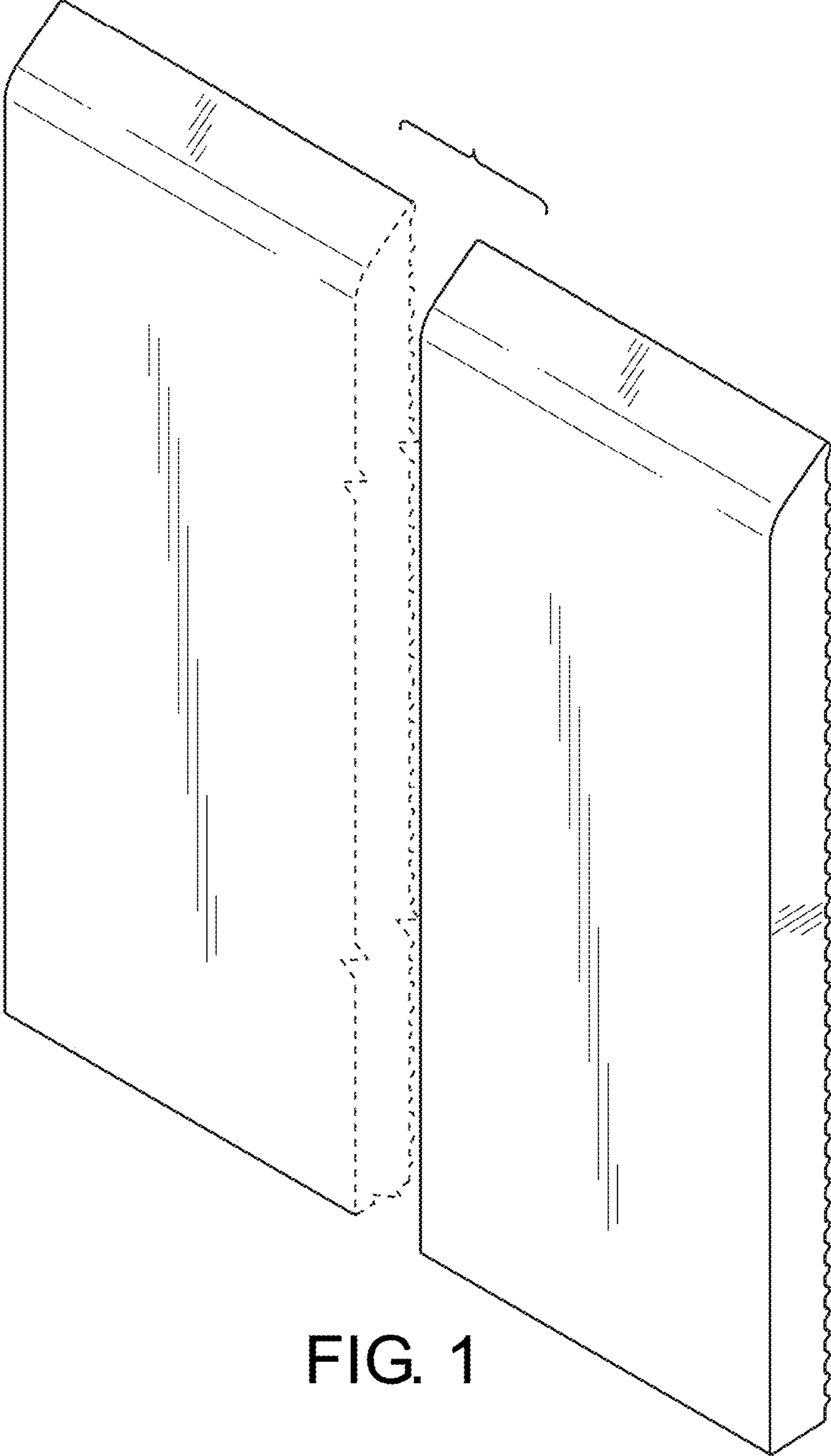

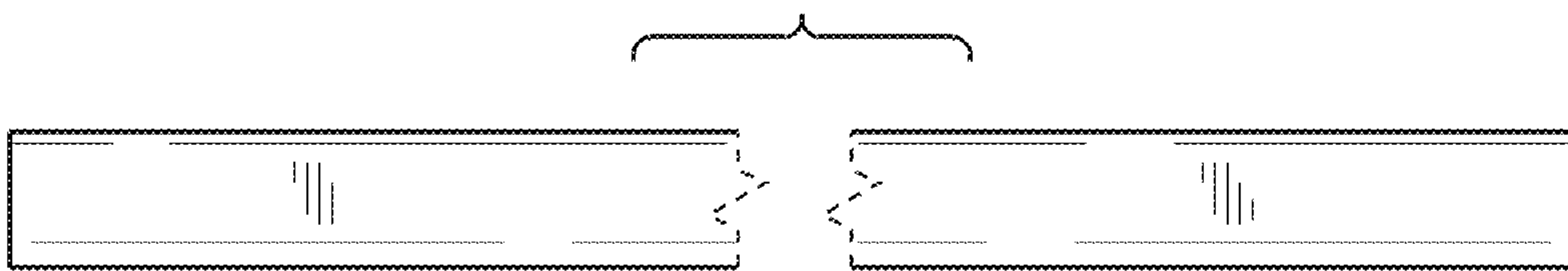

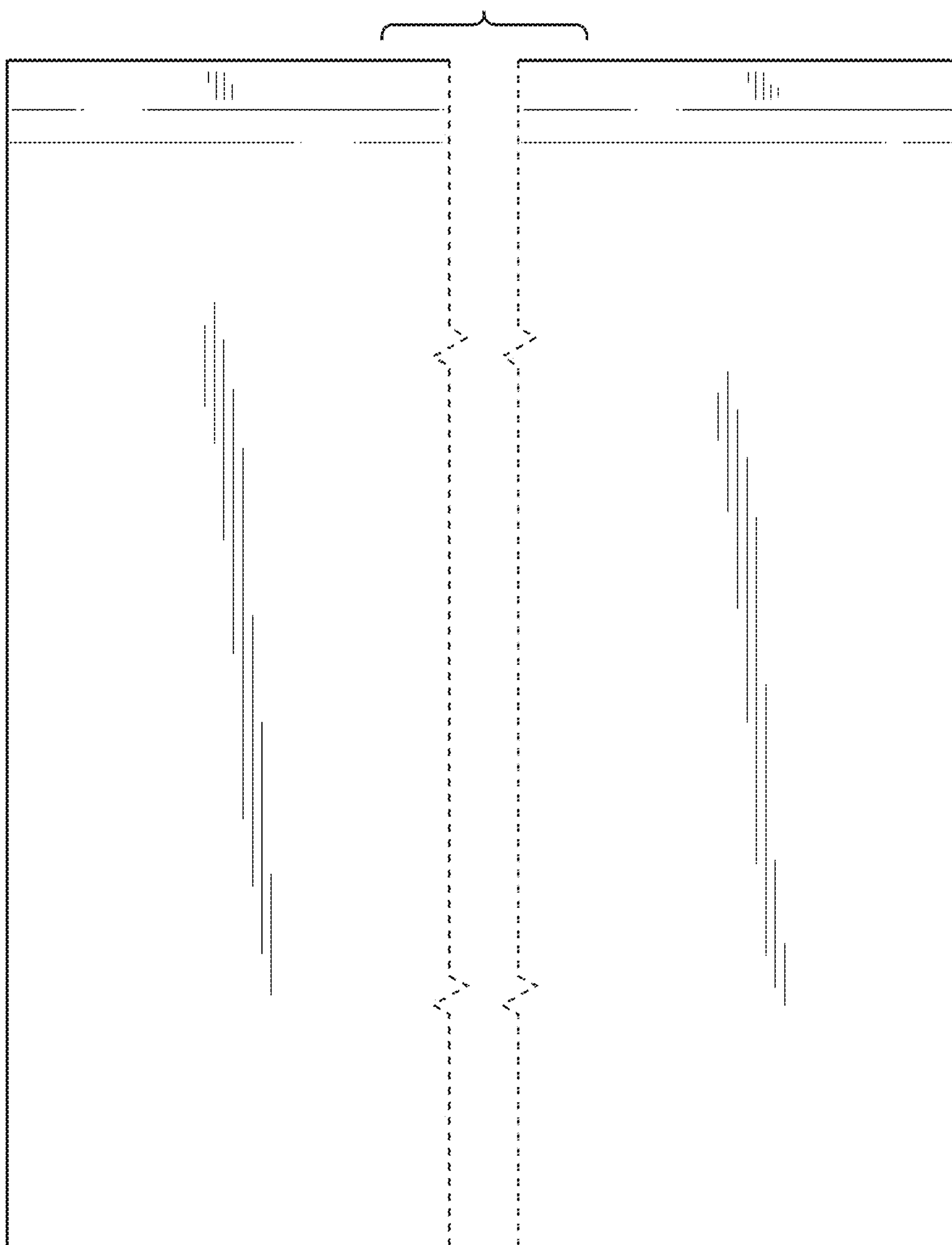

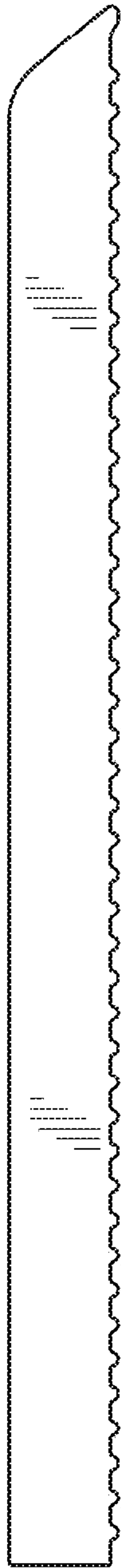

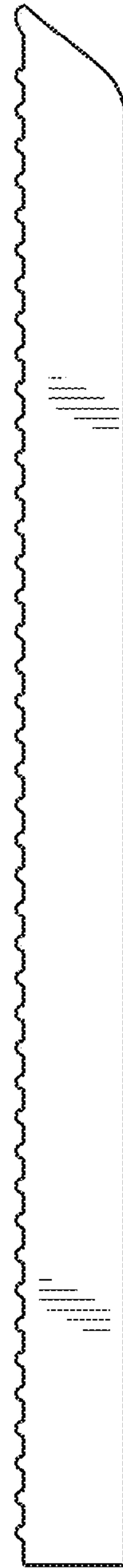

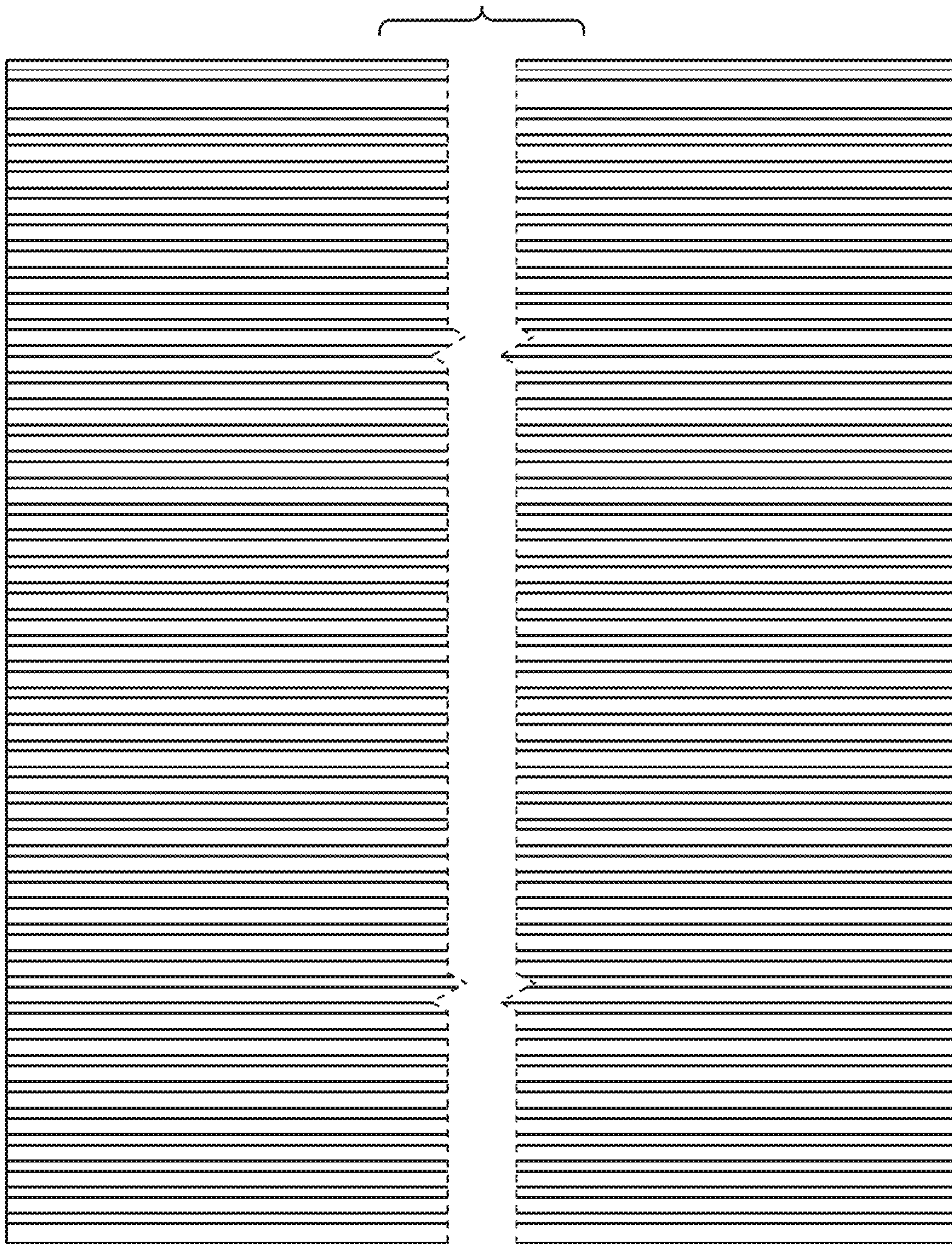

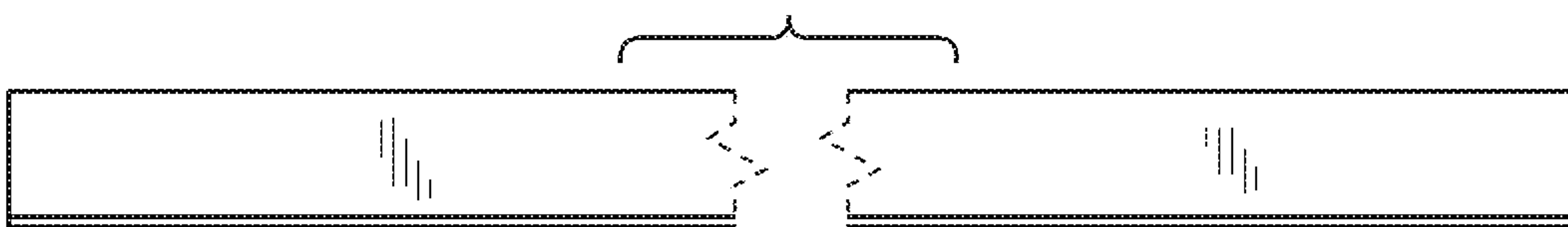
