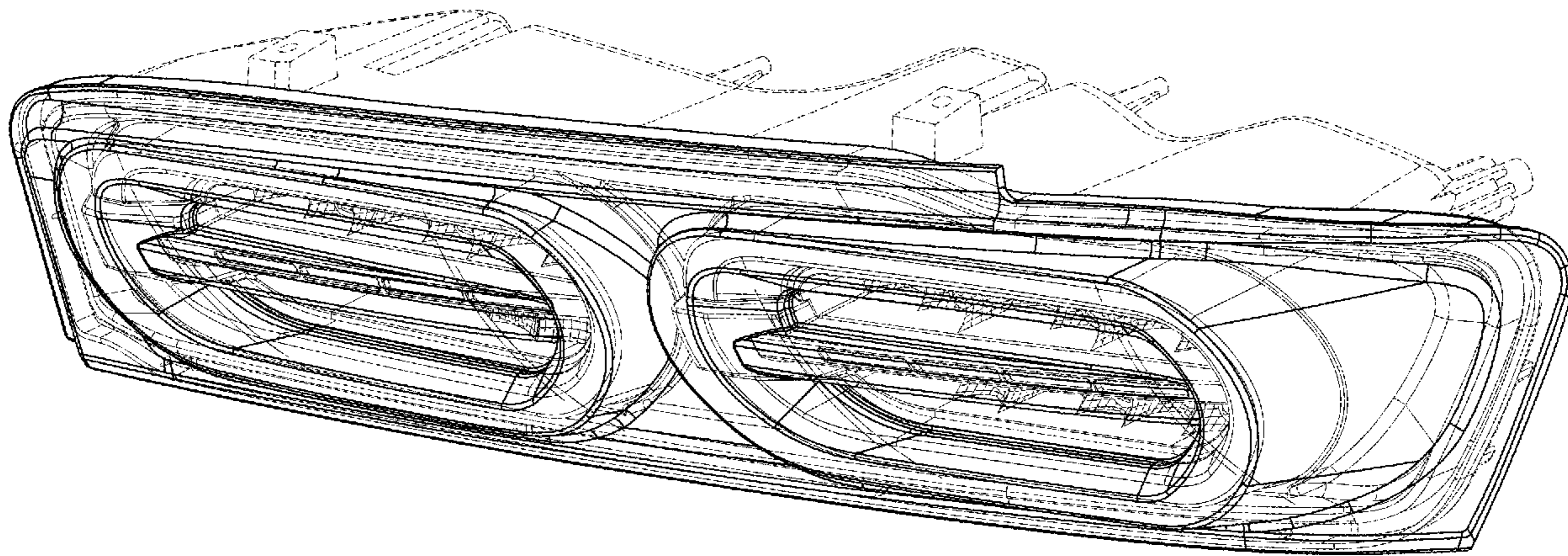
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, right and top perspective view of a vehicle tail light showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;

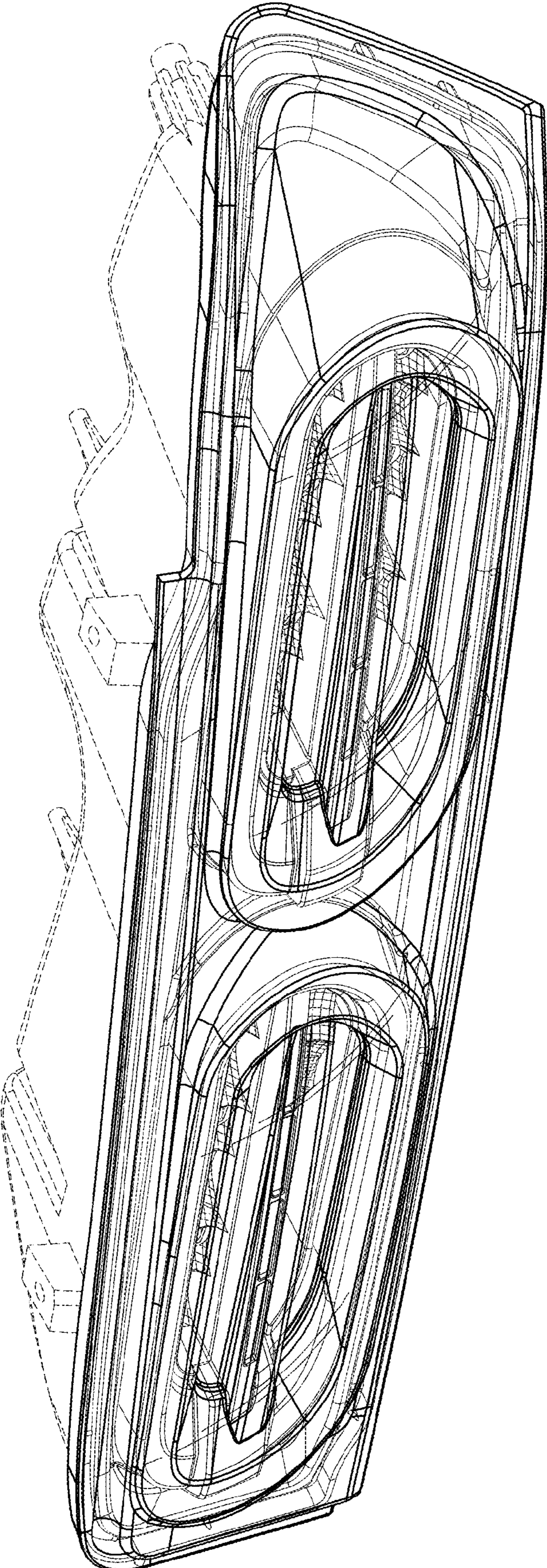

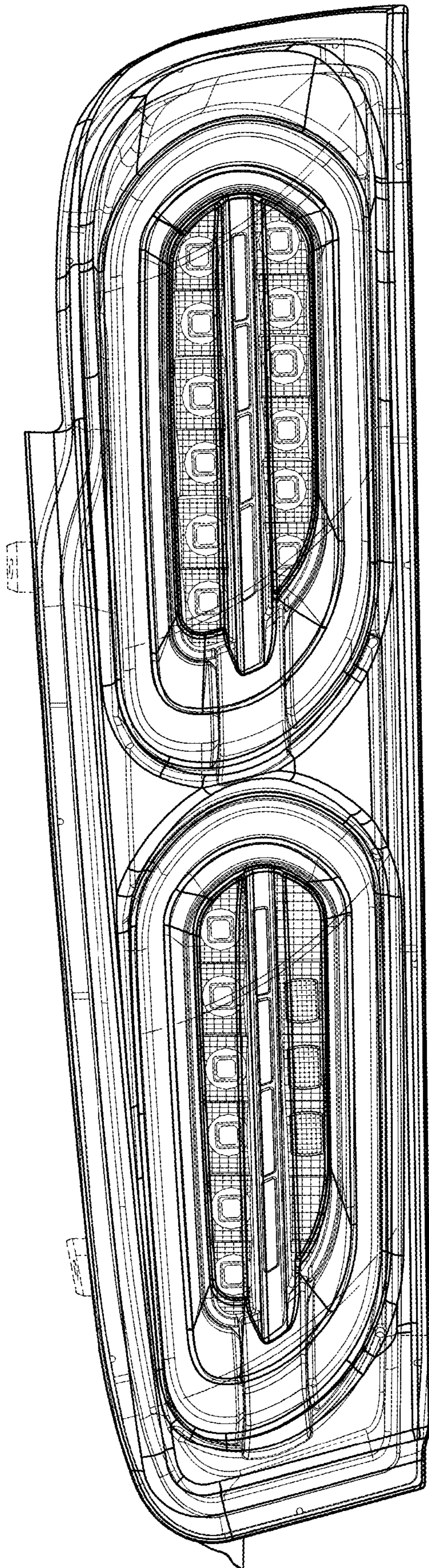

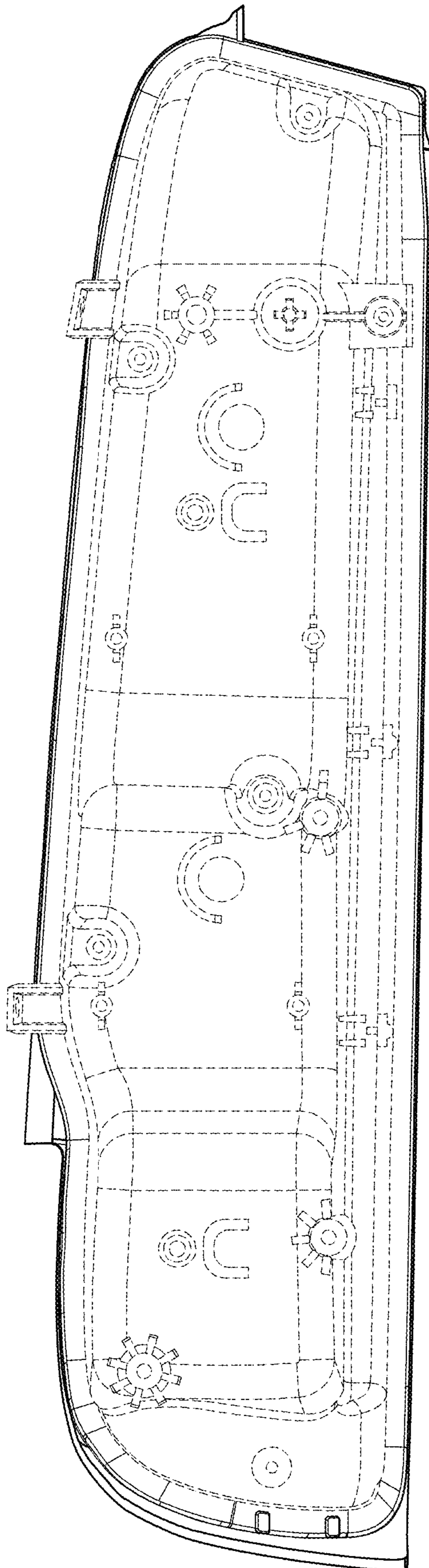

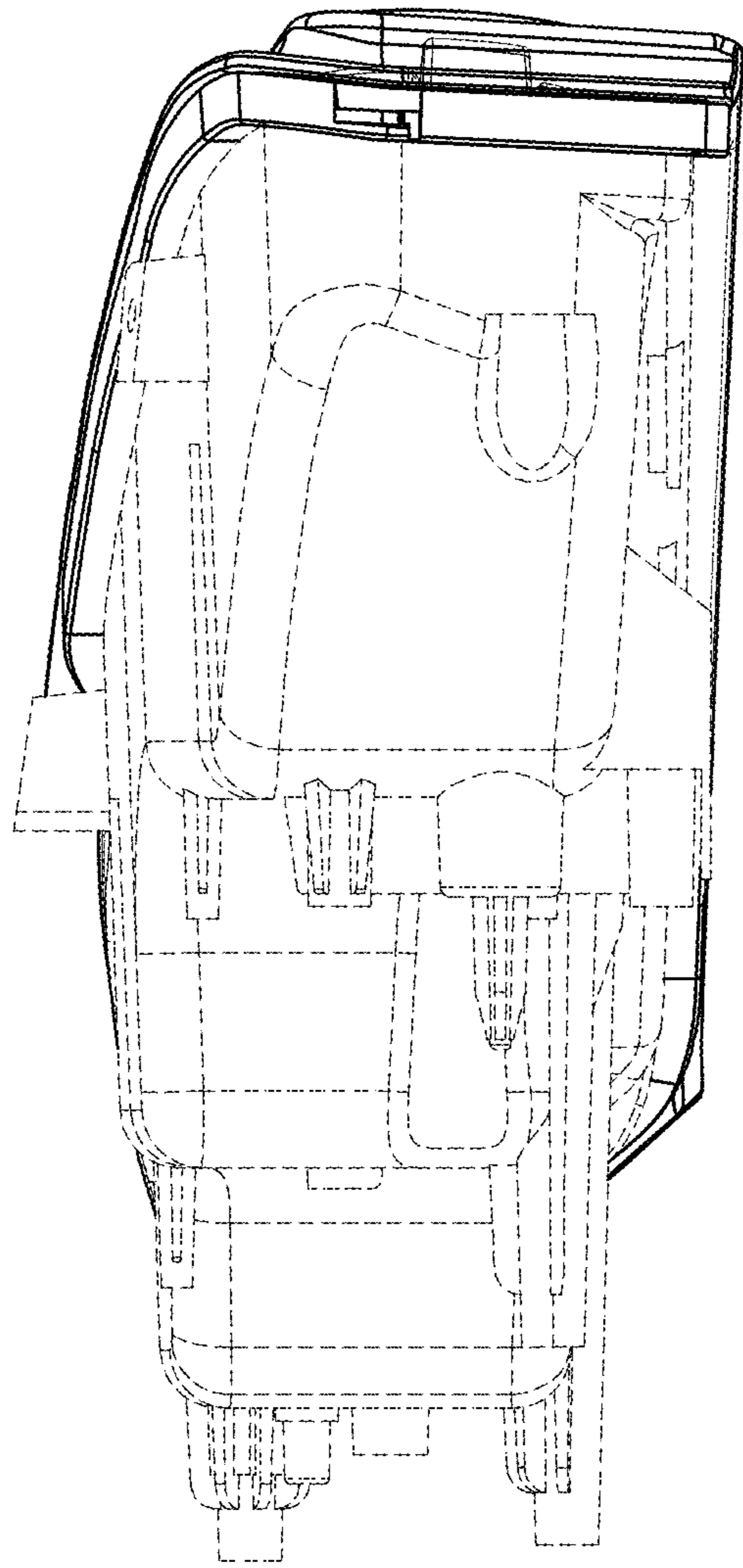

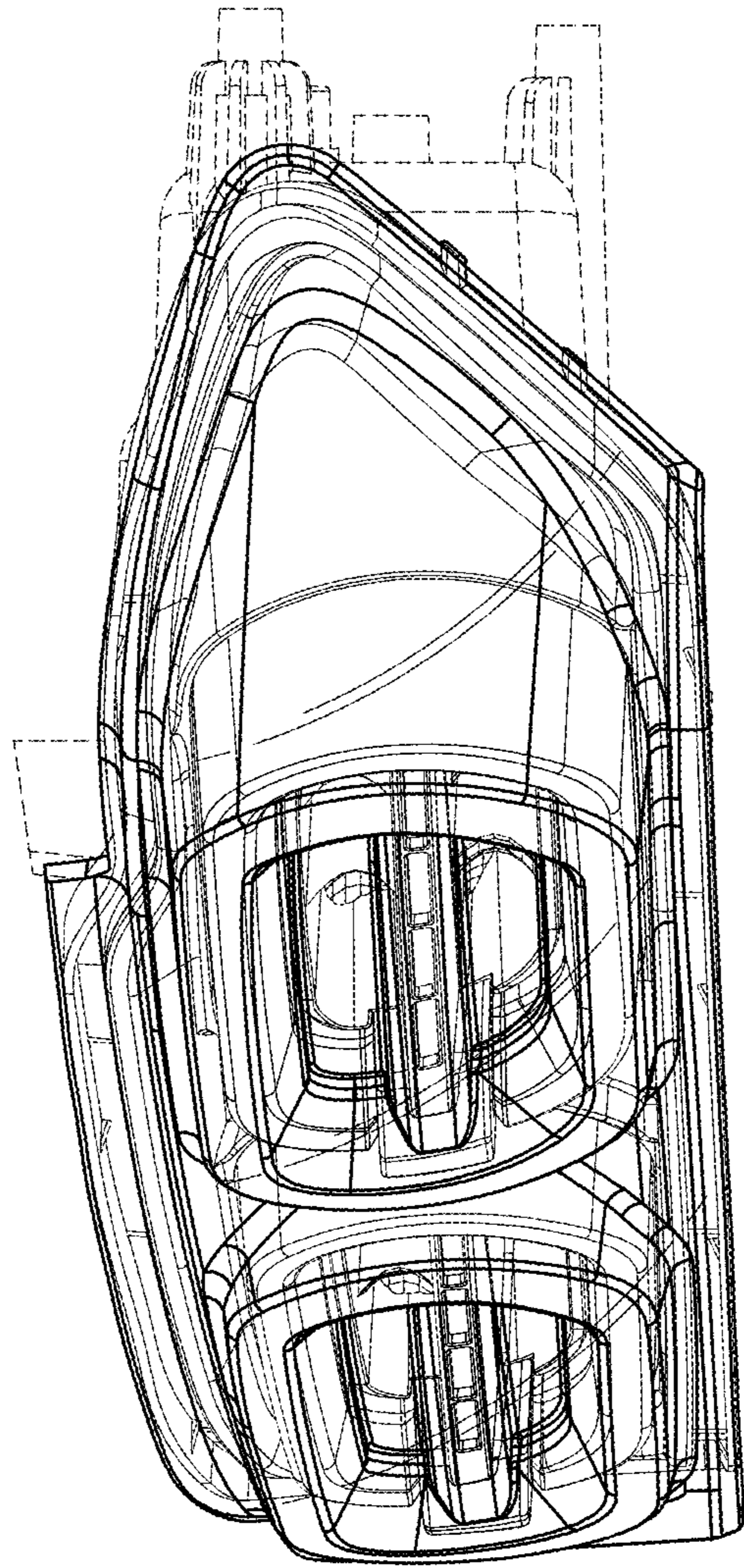

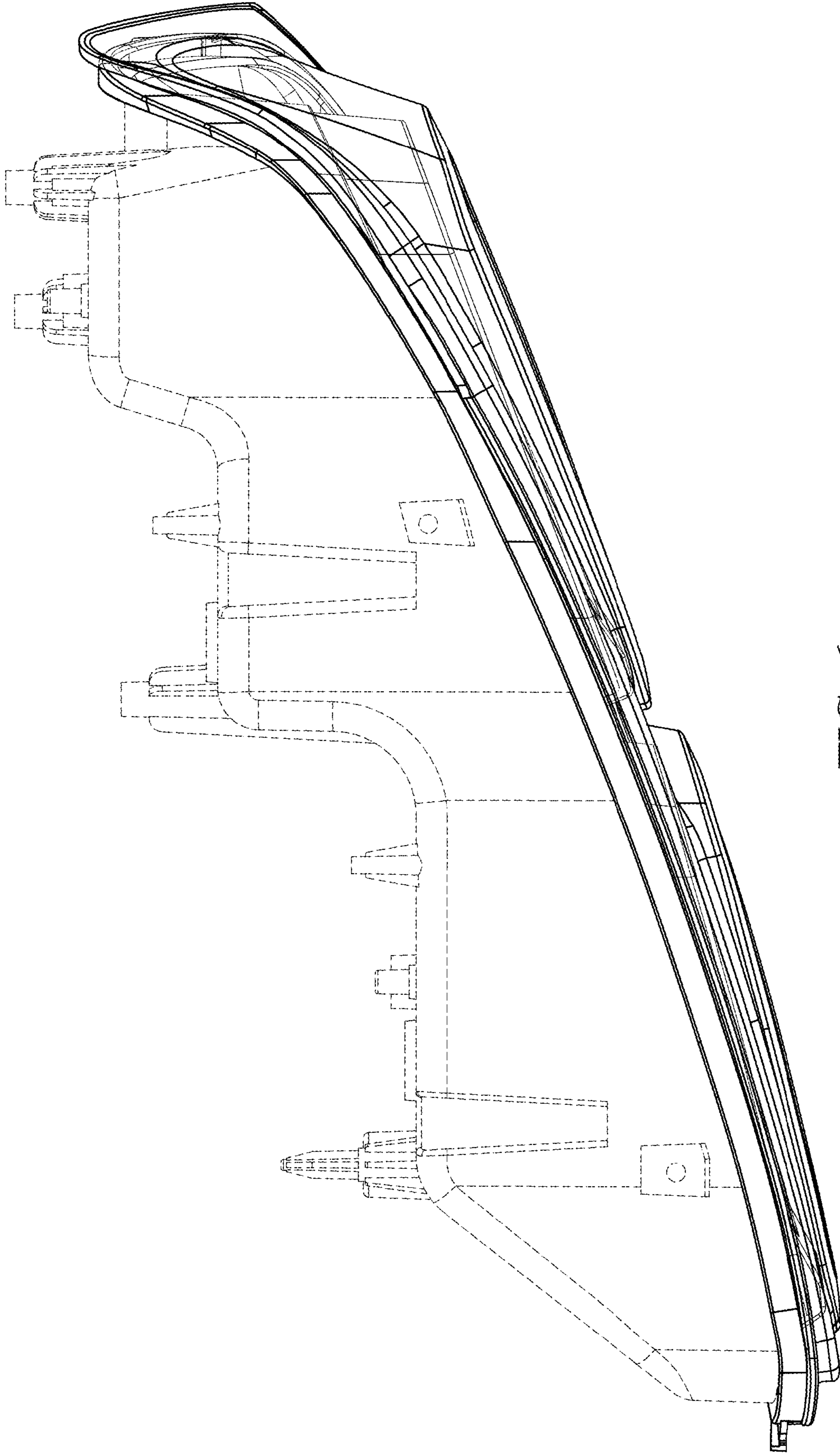

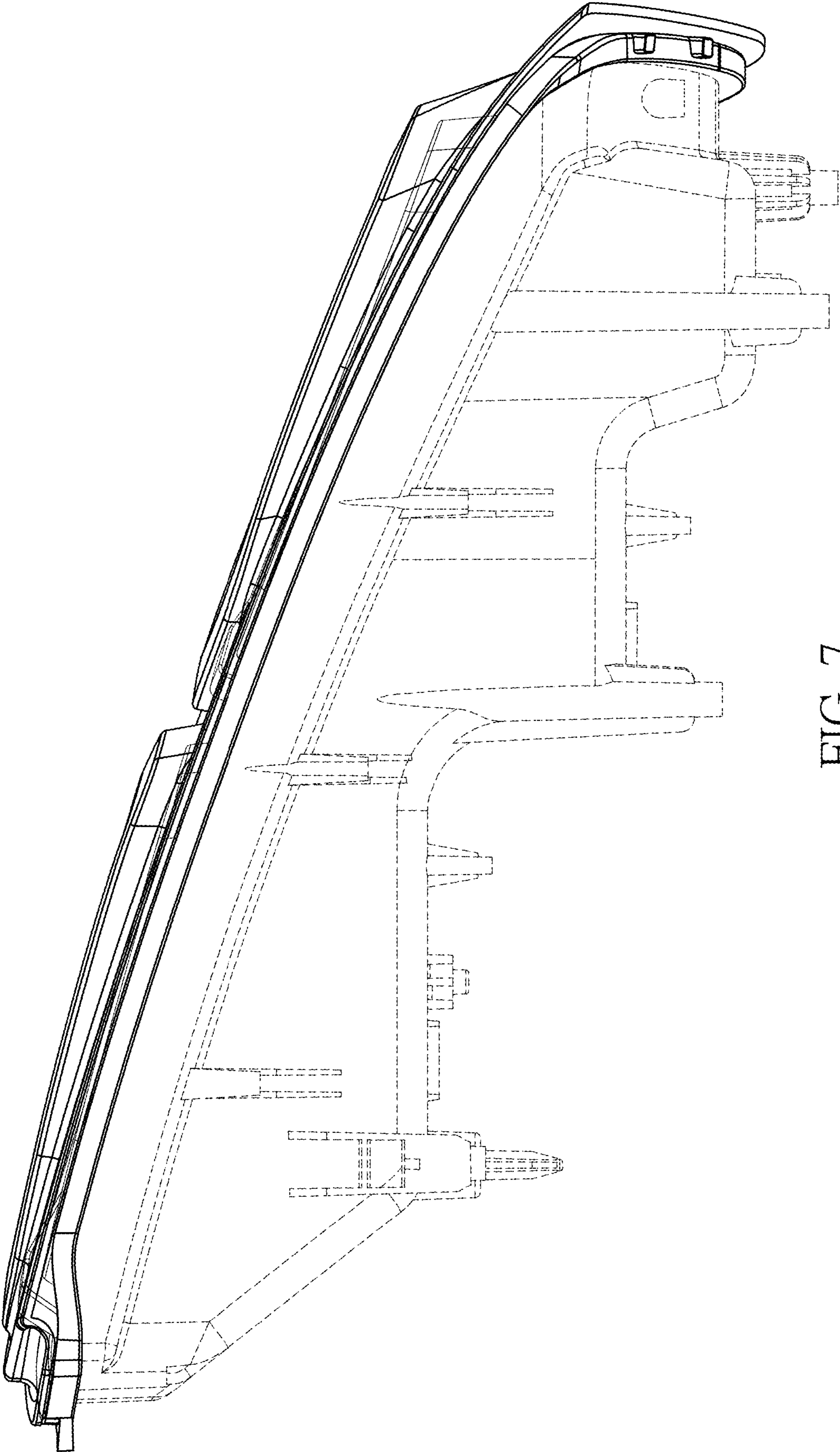
