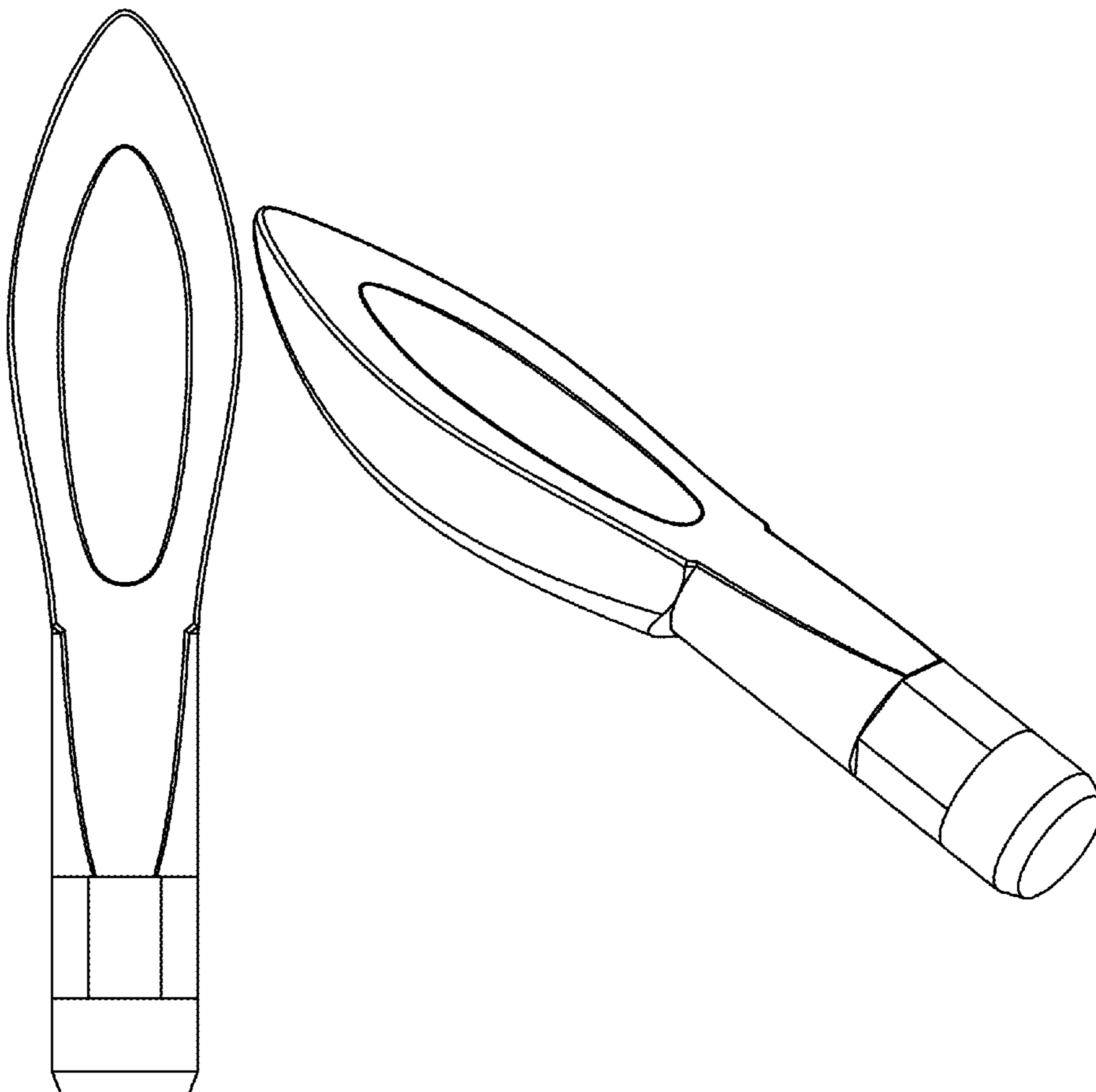

DESCRIPTION

FIG. 1 is a front elevation view of a lip gloss brush head embodying the new design;

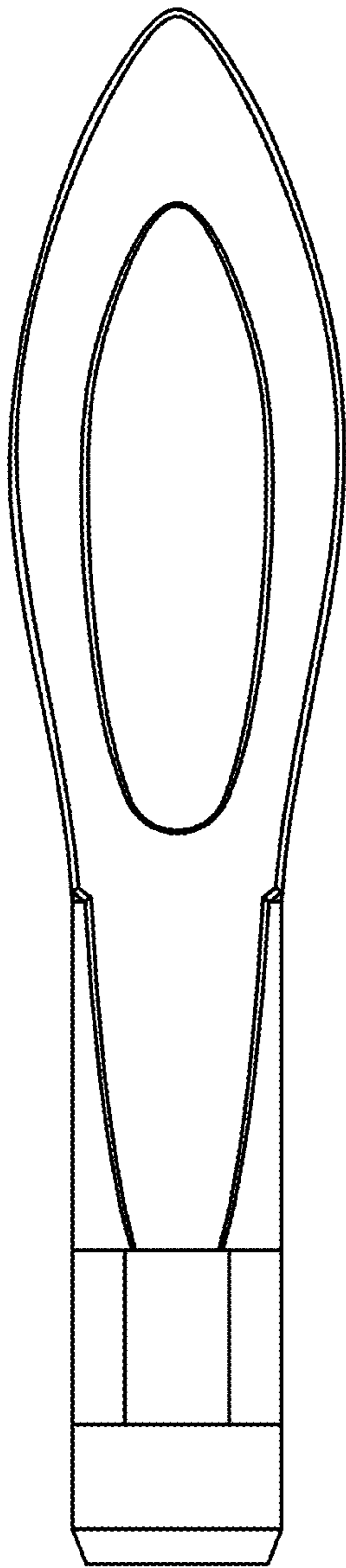

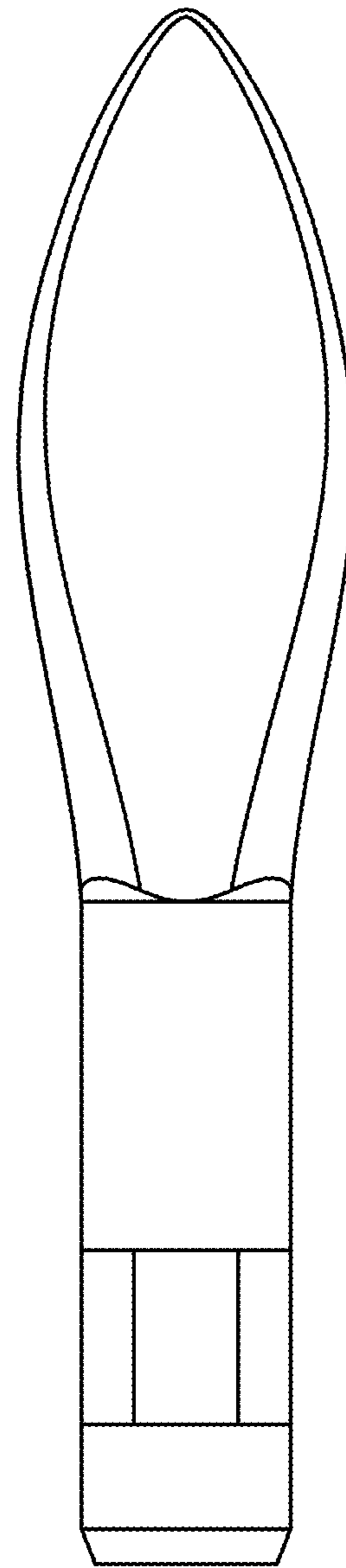

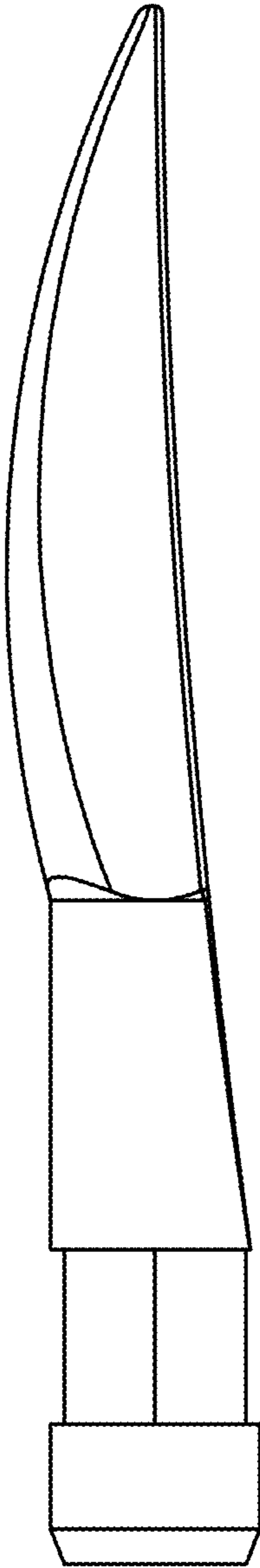

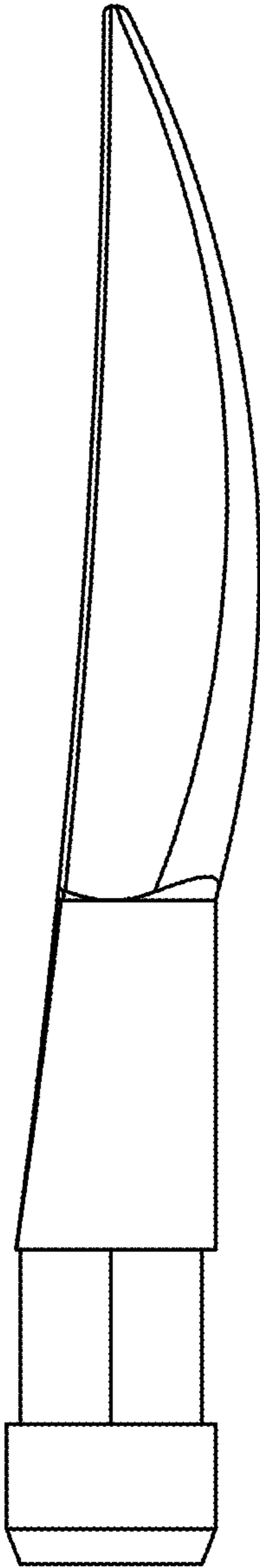

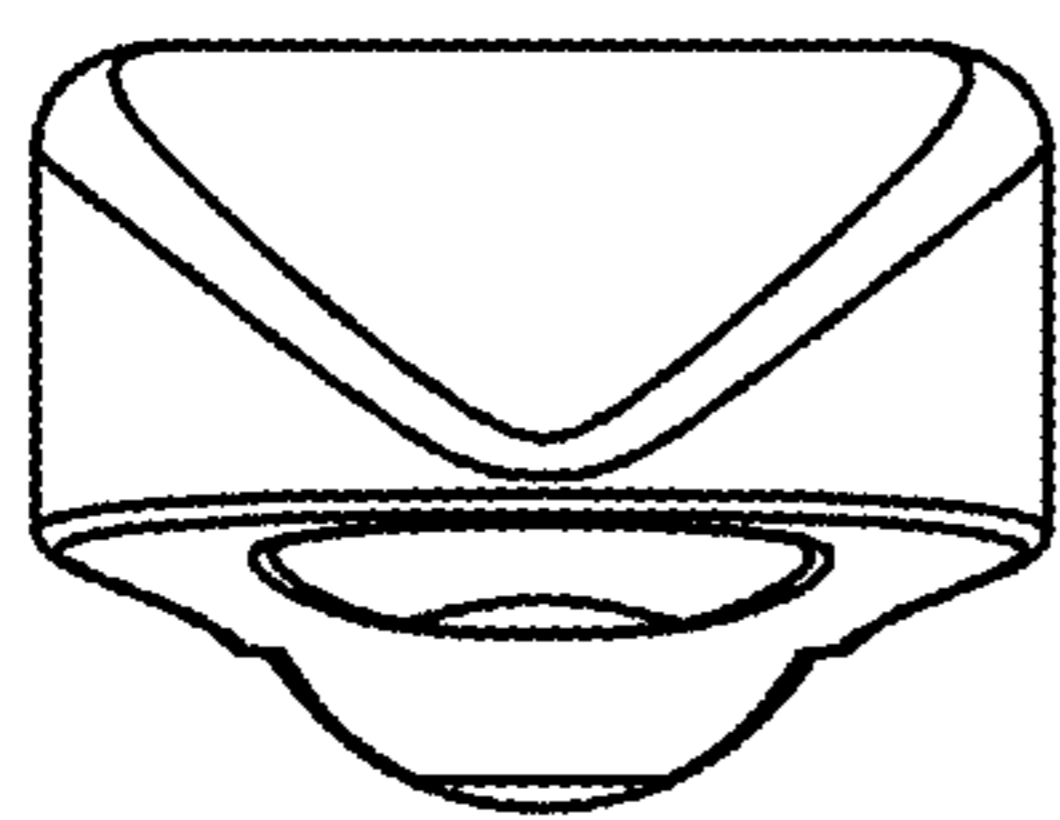

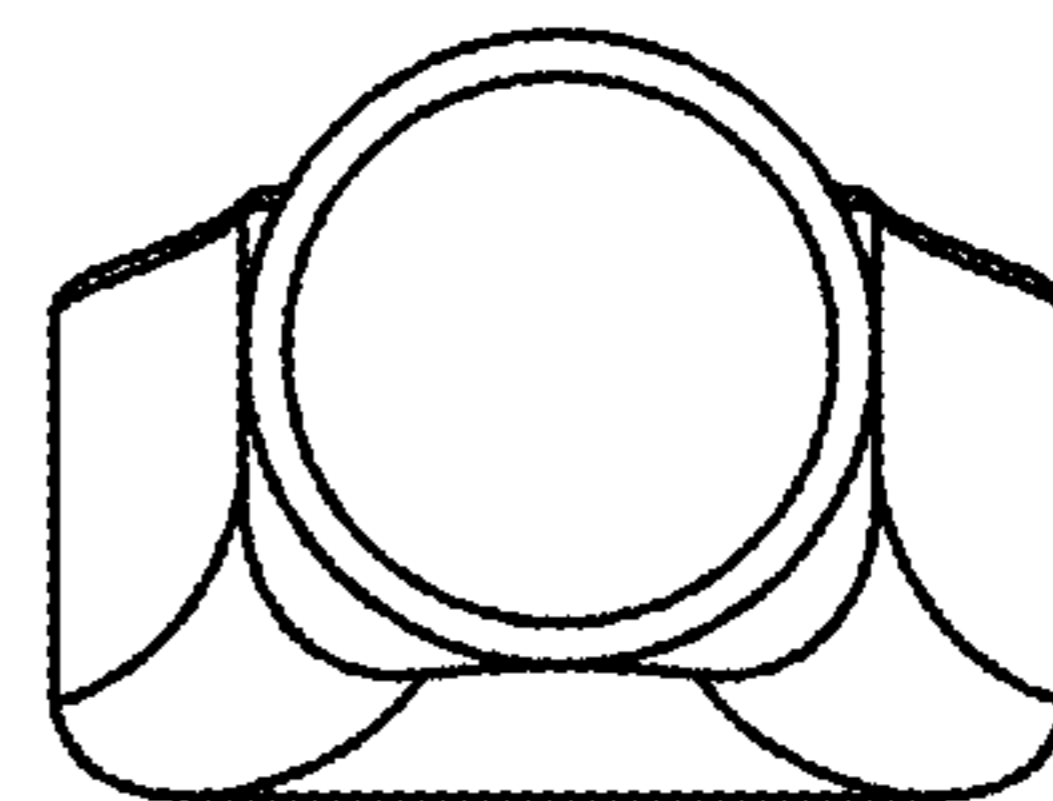

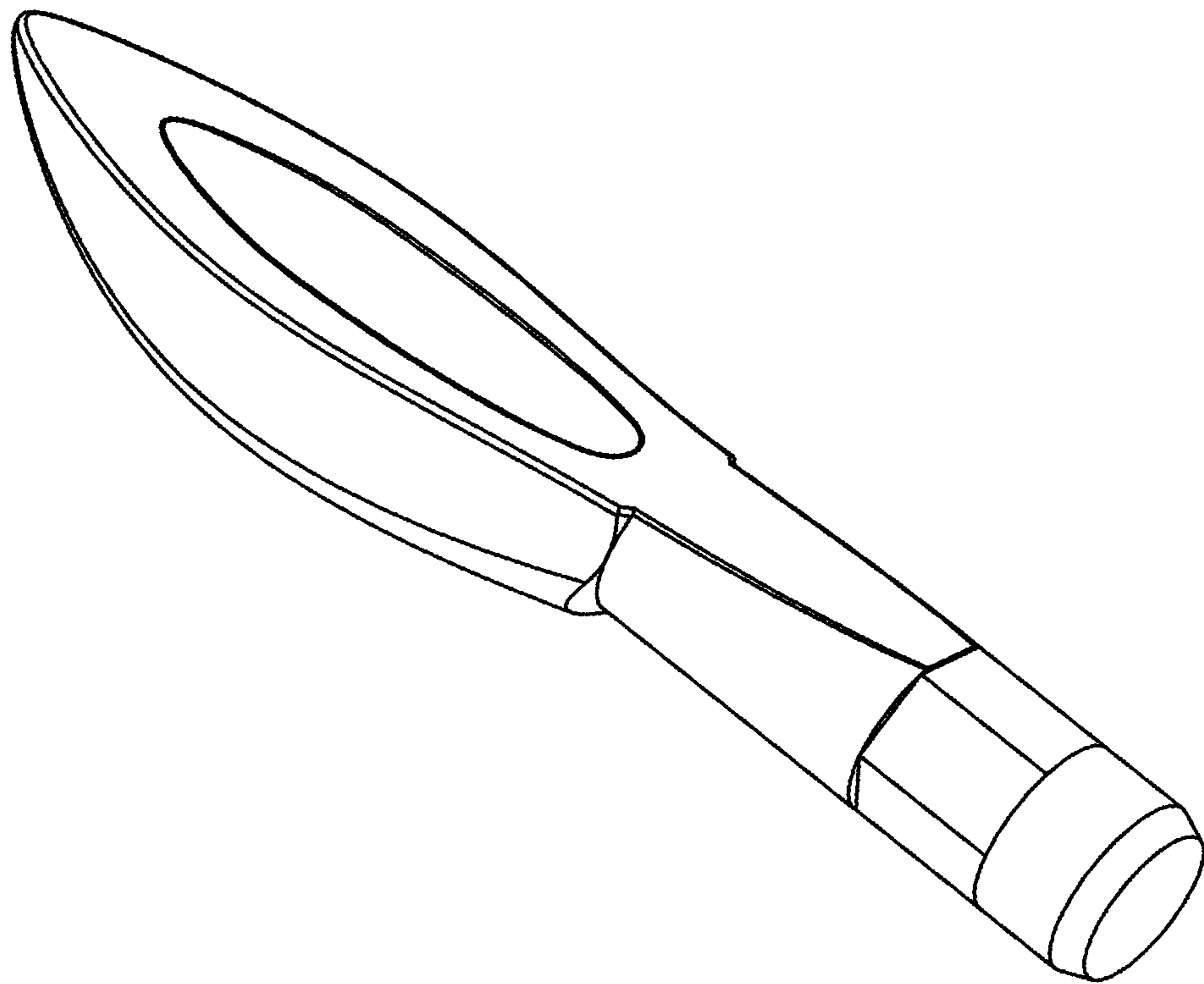
