I claim the ornamental design for a horse racing blinker, as shown and as described.

FIG. 5 is a left side view thereof.

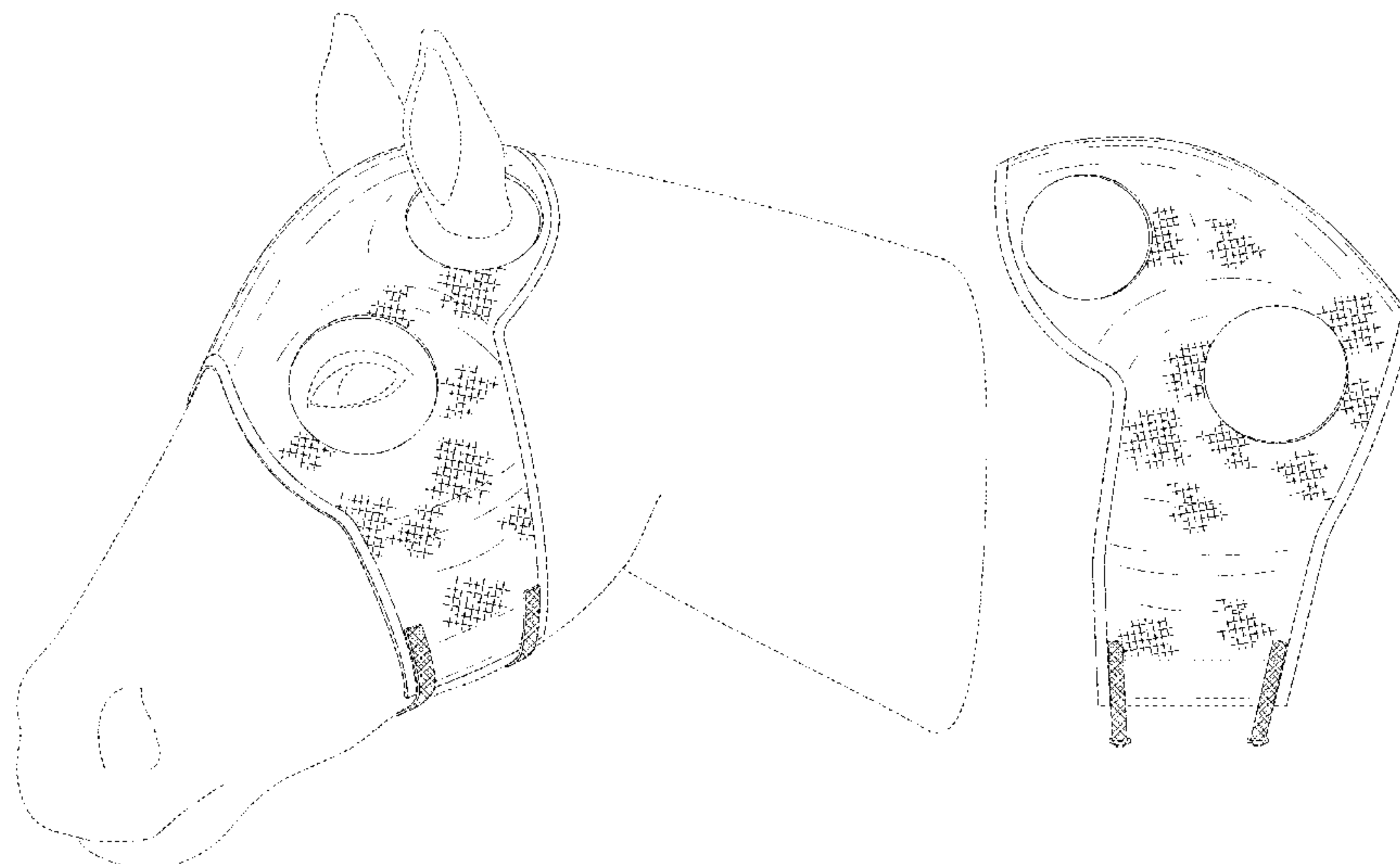
FIG. 6 is a right side view thereof.

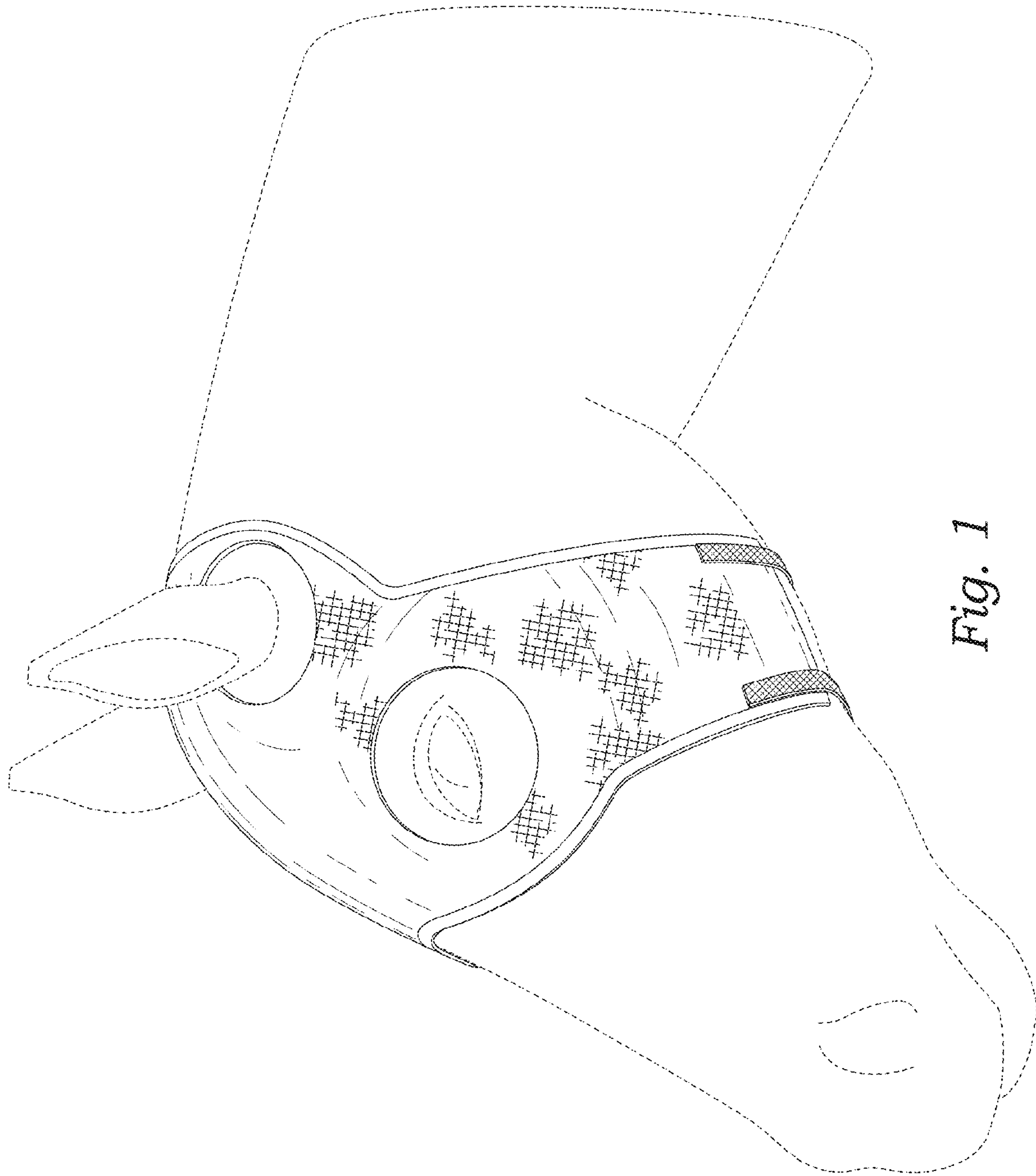

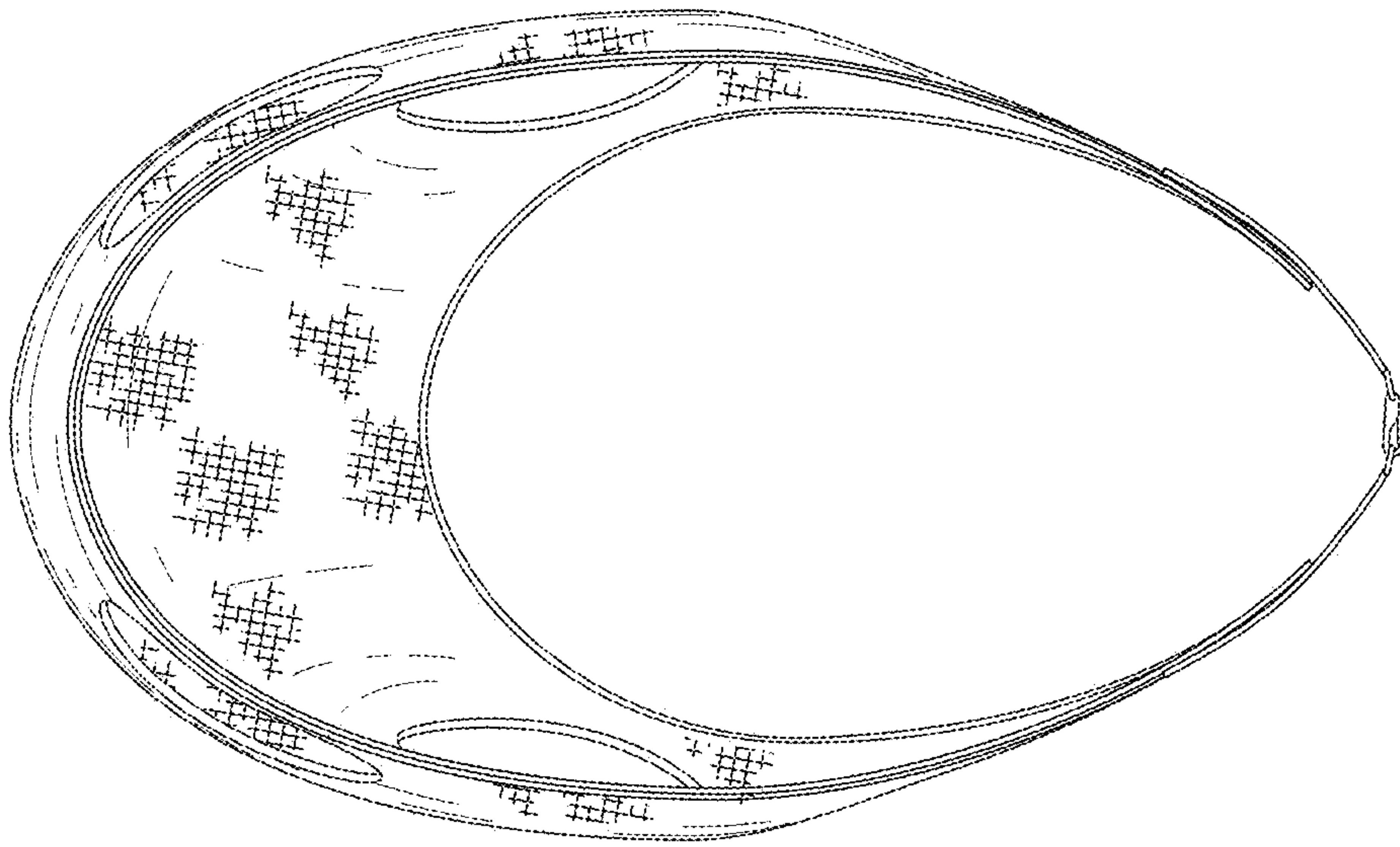

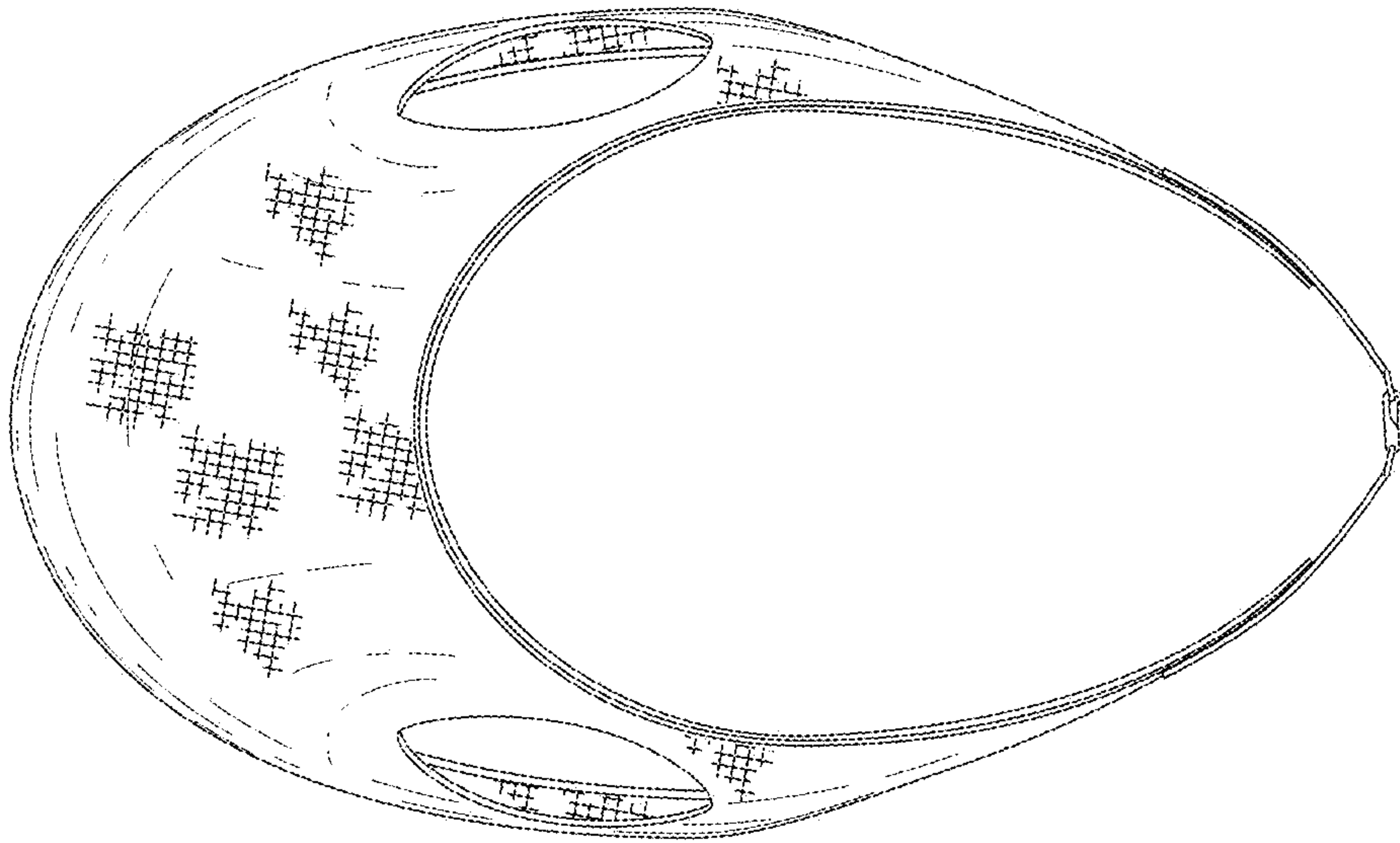

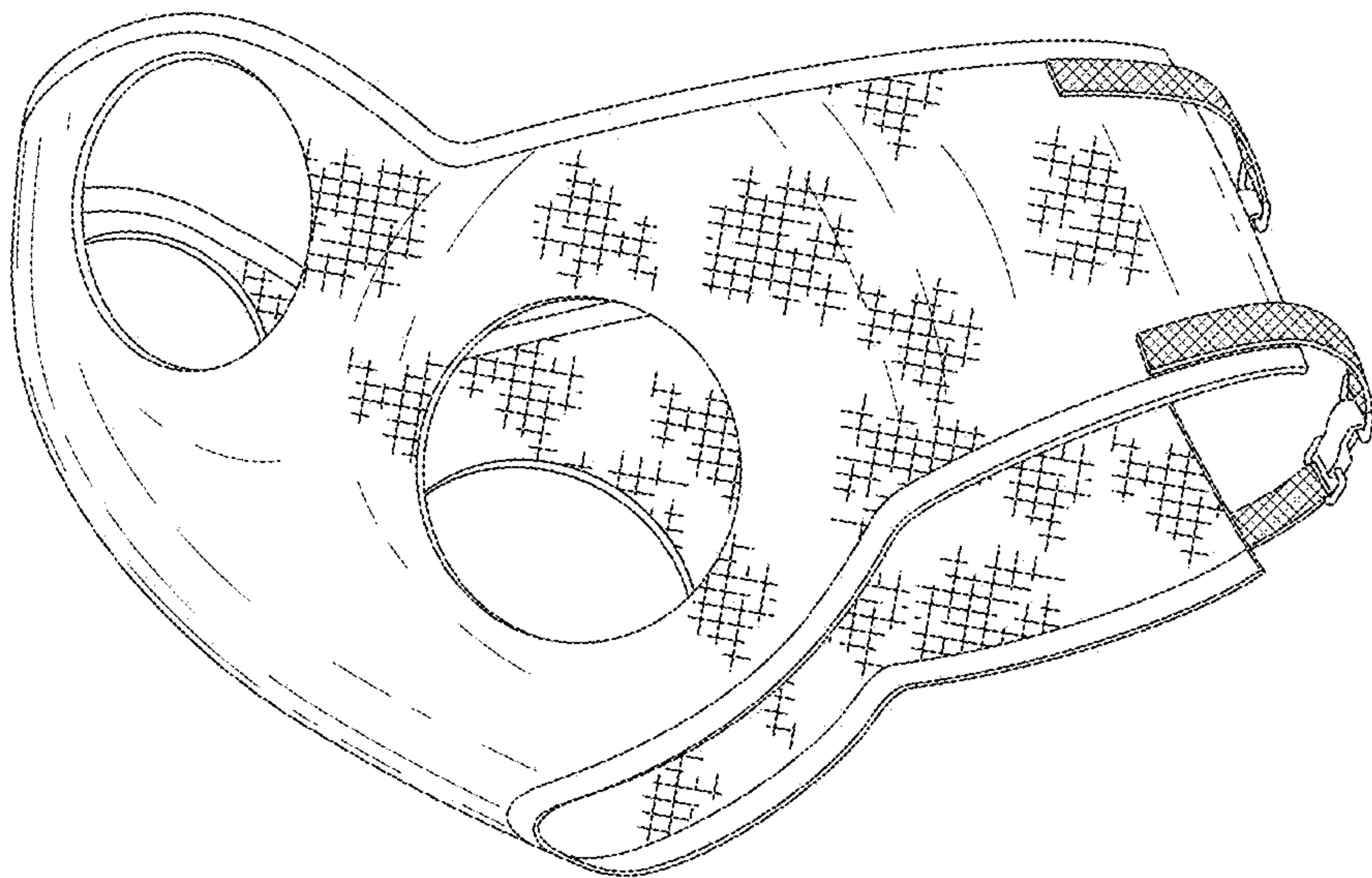

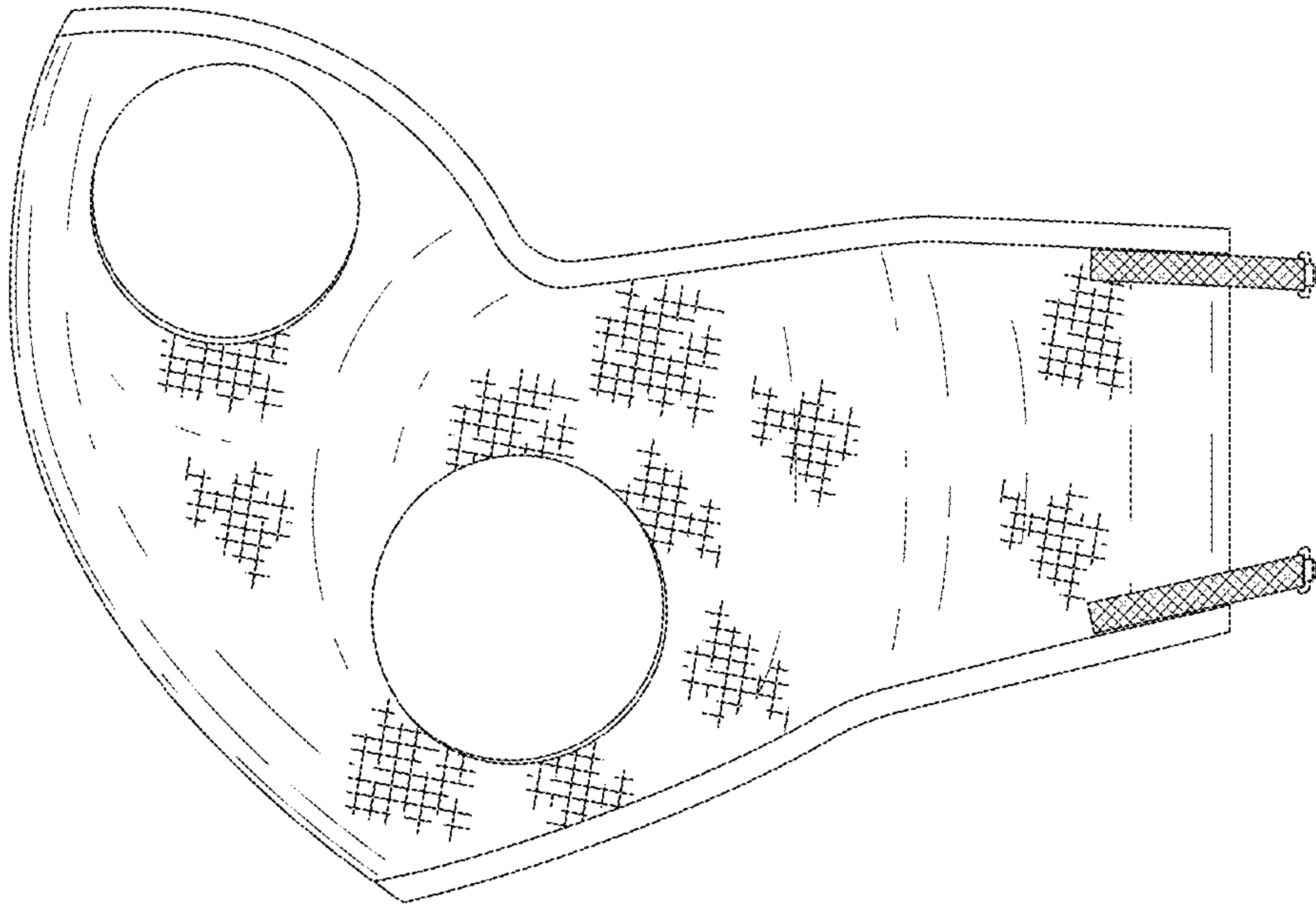

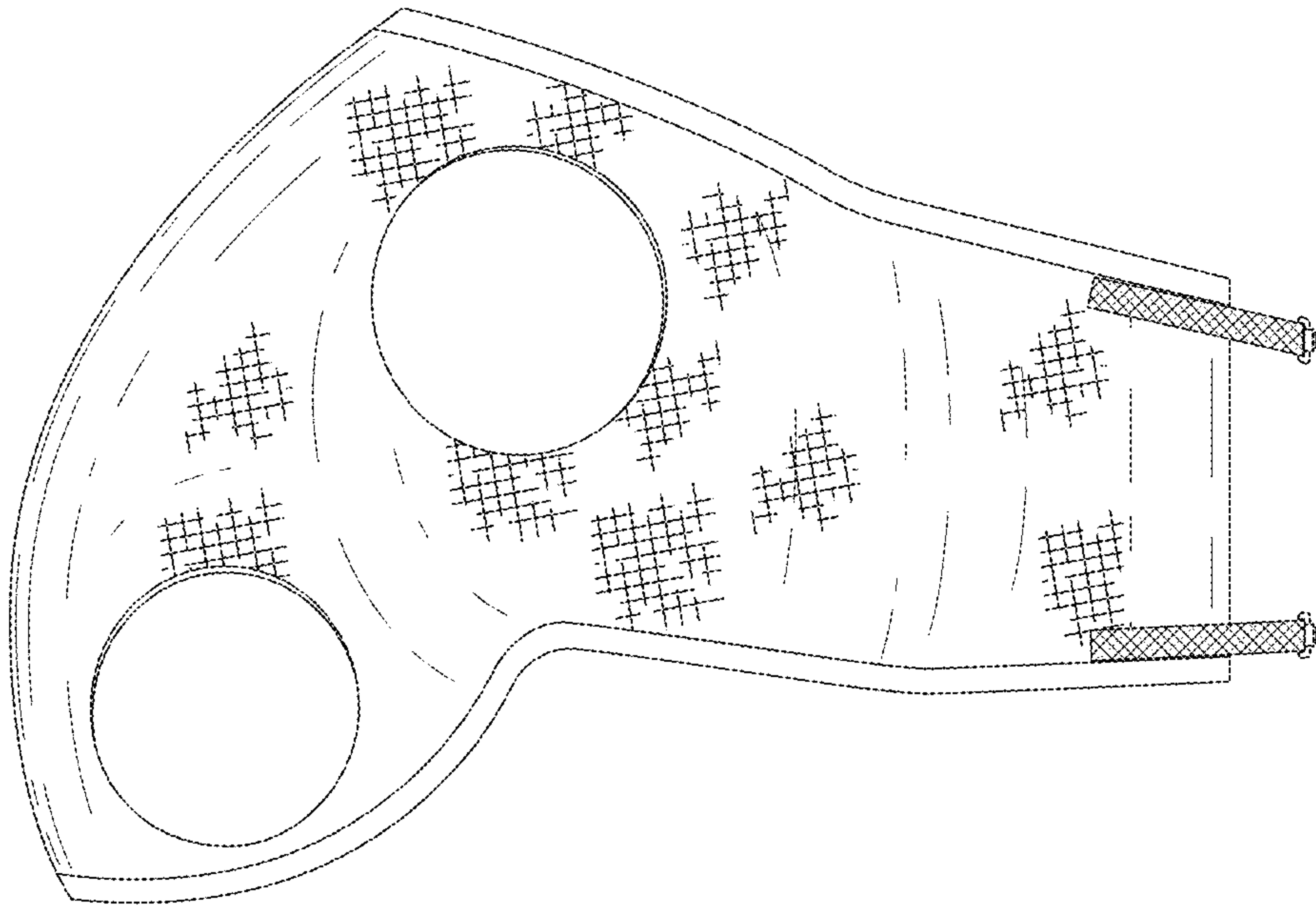
