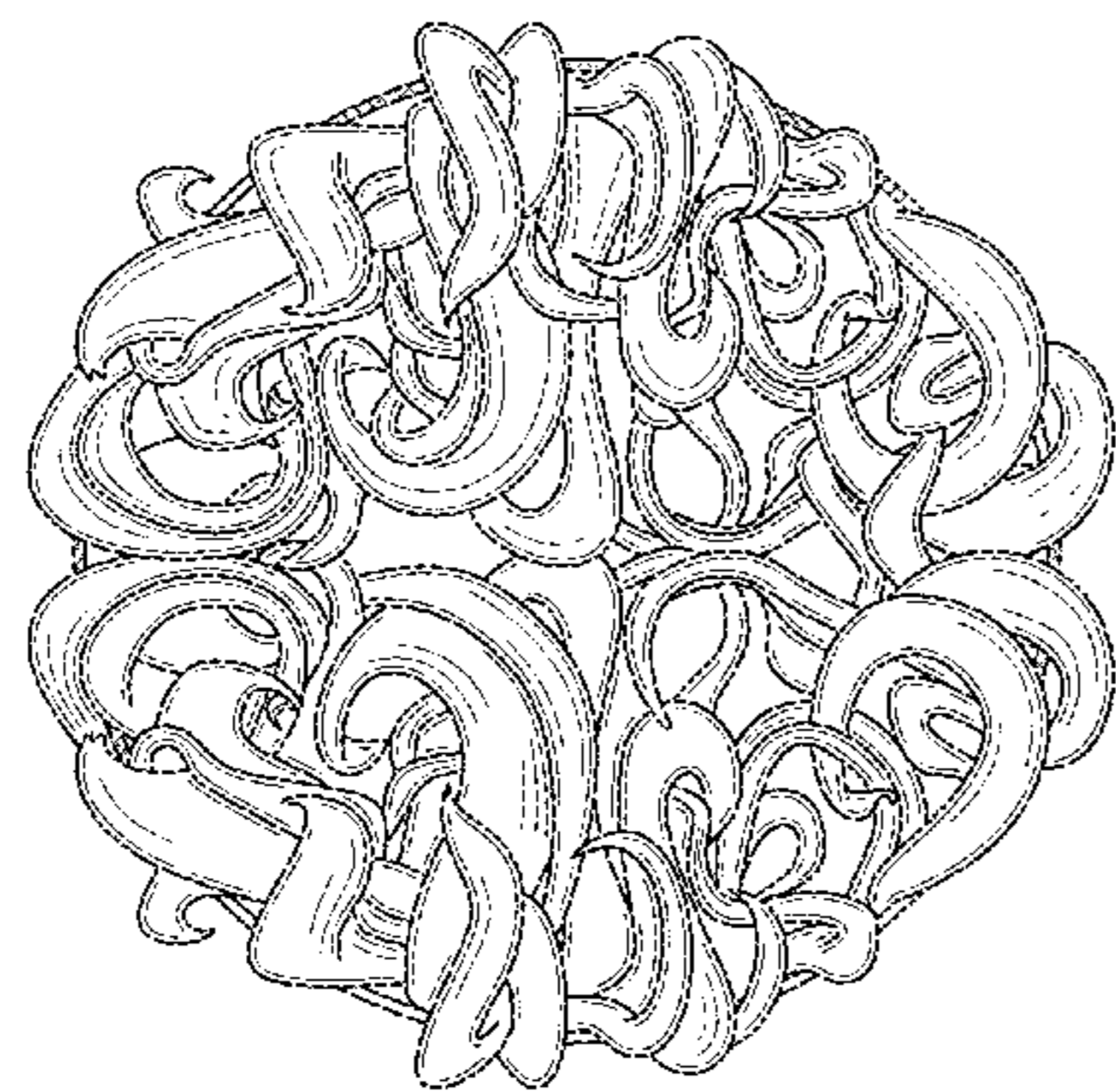
(57) **CLAIM**

The ornamental design for a head wrap, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a head wrap showing my new design;
FIG. 2 is a rear view of the head wrap;
FIG. 3 is a left side view of the head wrap;
FIG. 4 is a right side view of the head wrap;
FIG. 5 is a top view of the head wrap;
FIG. 6 is a bottom view of the head wrap; and,
FIG. 7 is a bottom front side perspective view of the head wrap in use.
The partial human figure outlined by broken lines assist to illustrate how the head wrap may appear when worn and forms no part of the claimed design.

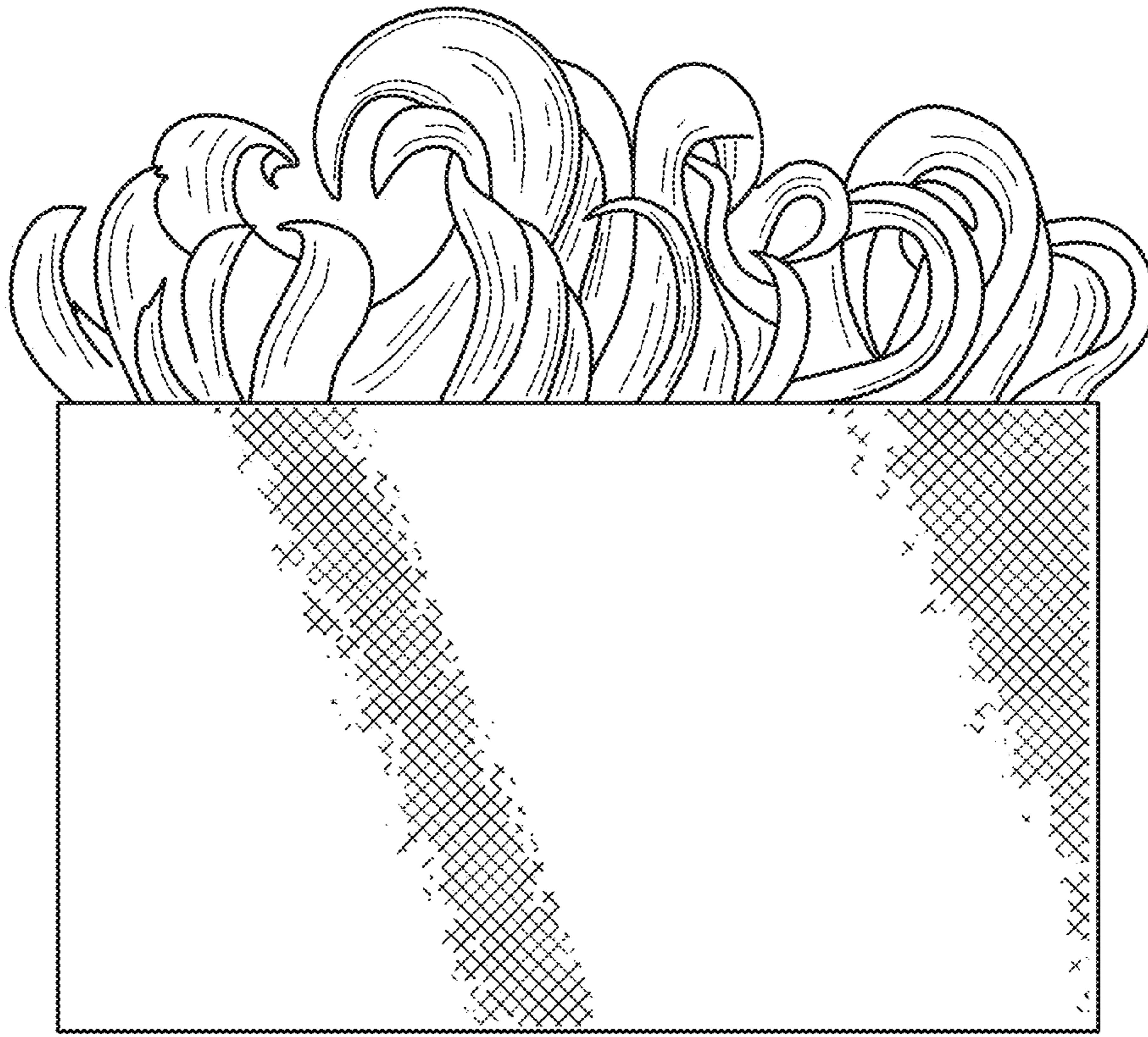

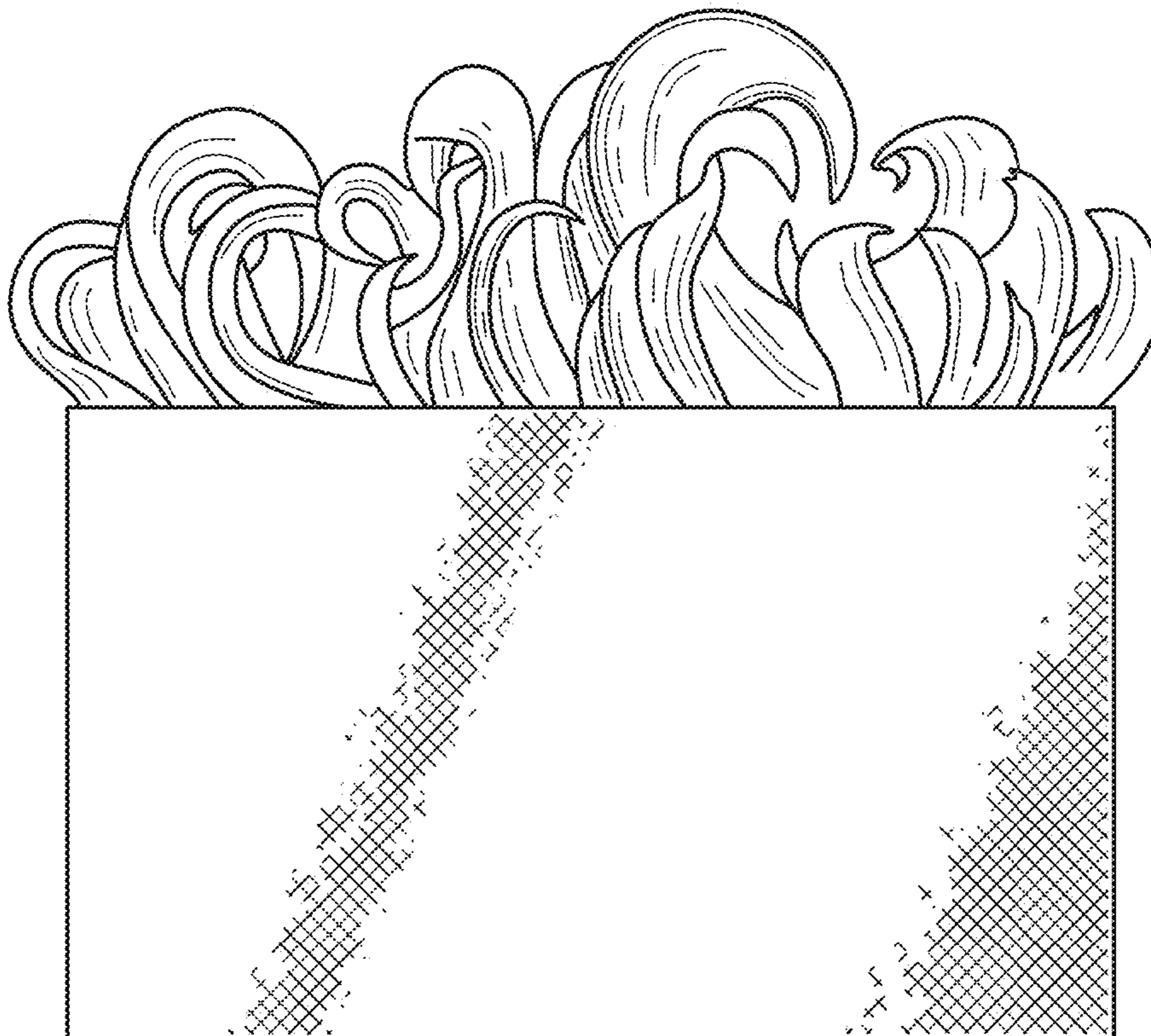

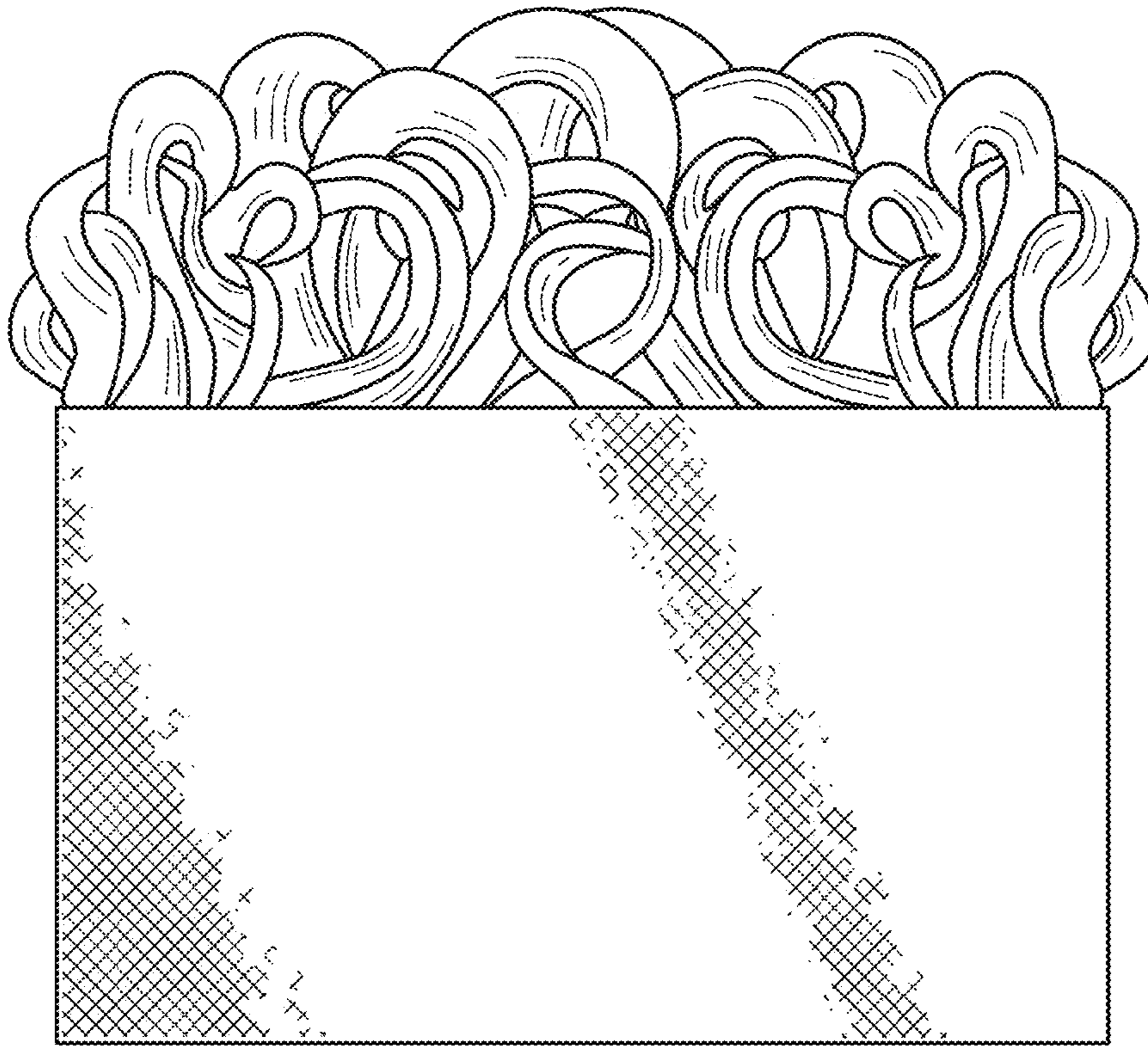

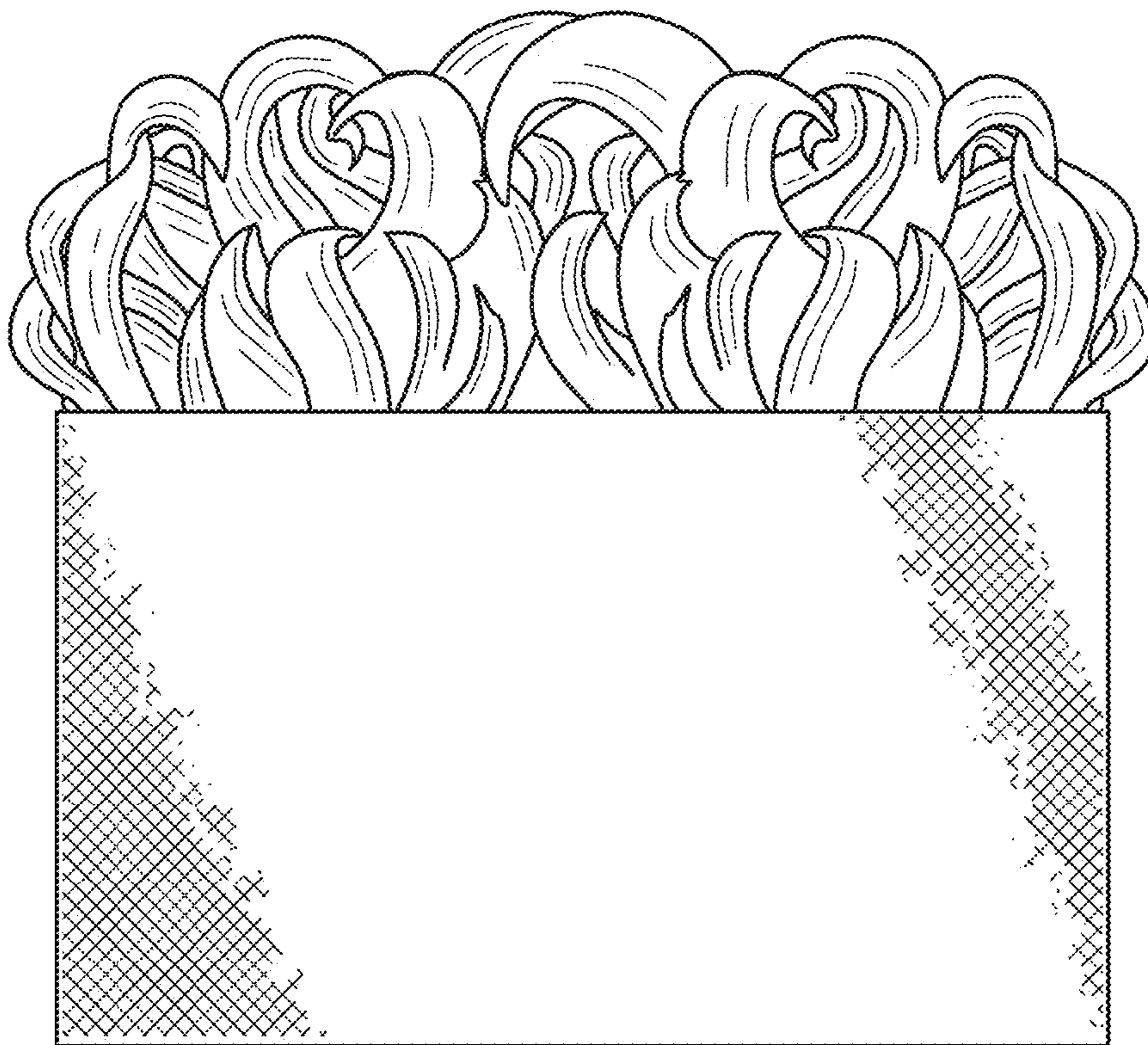

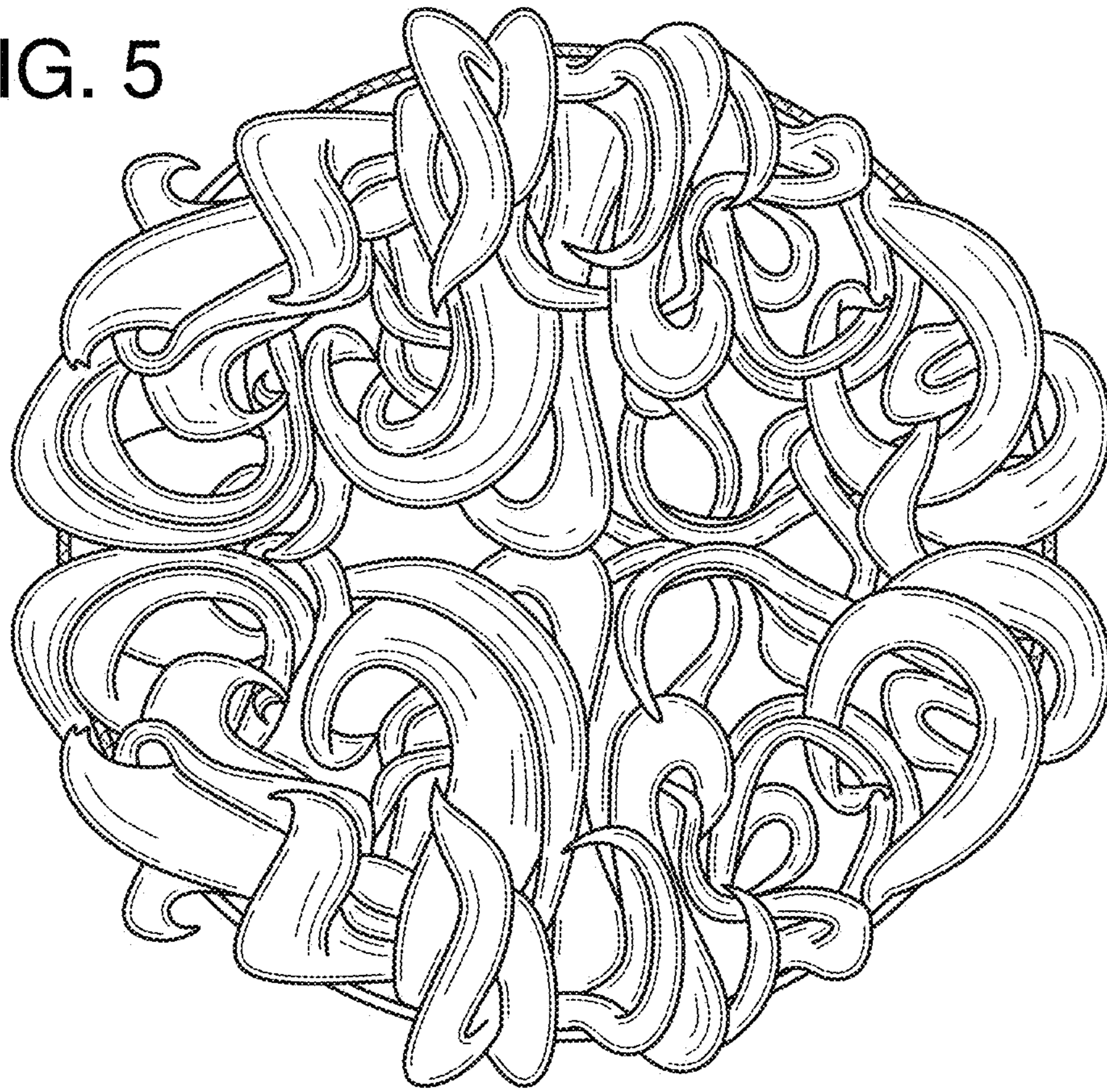

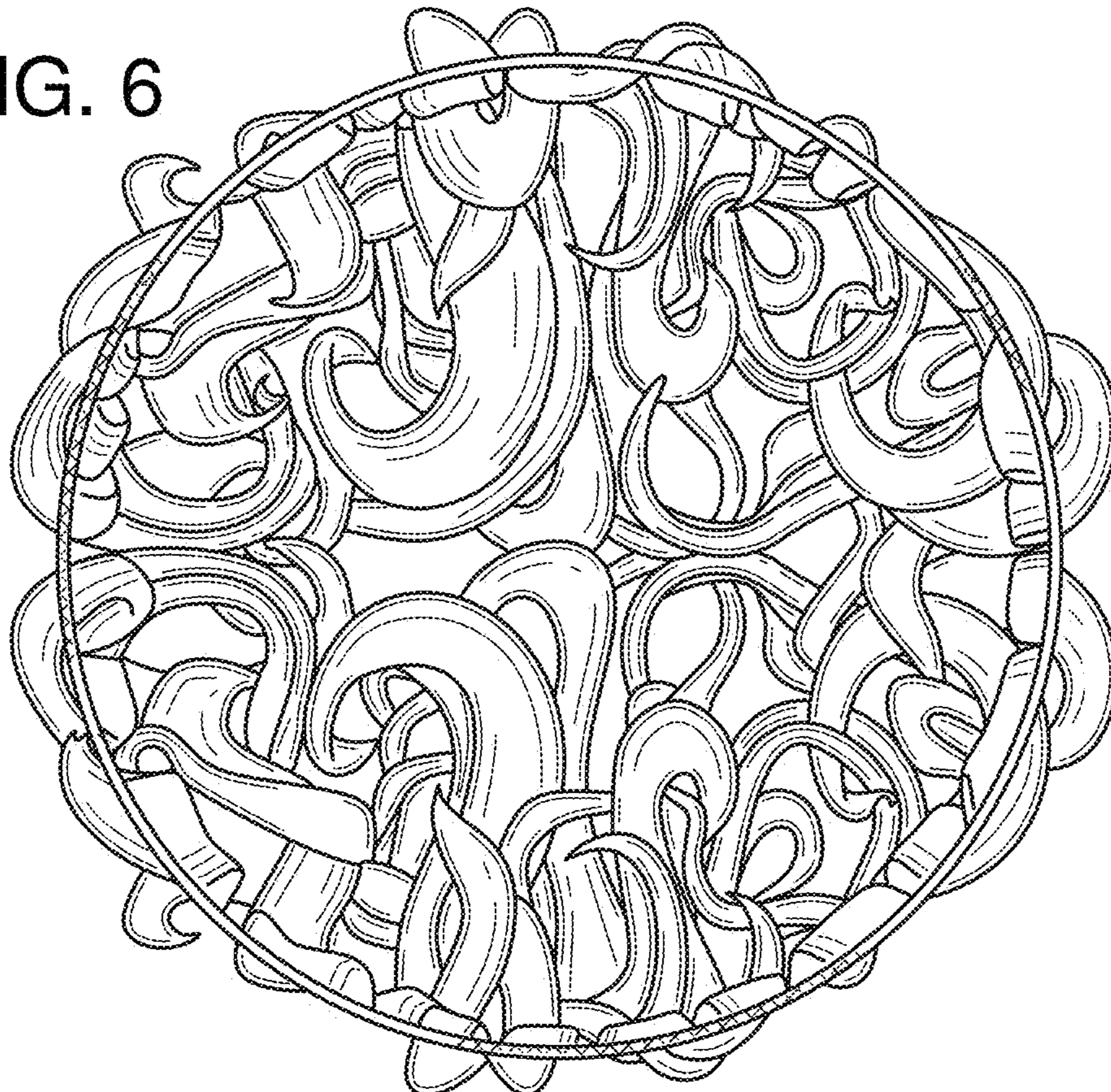
