(57) **CLAIM**

The ornamental design for a magnet phone grip for electronic devices, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a magnet phone grip for electronic devices in an expanded state showing the new design;

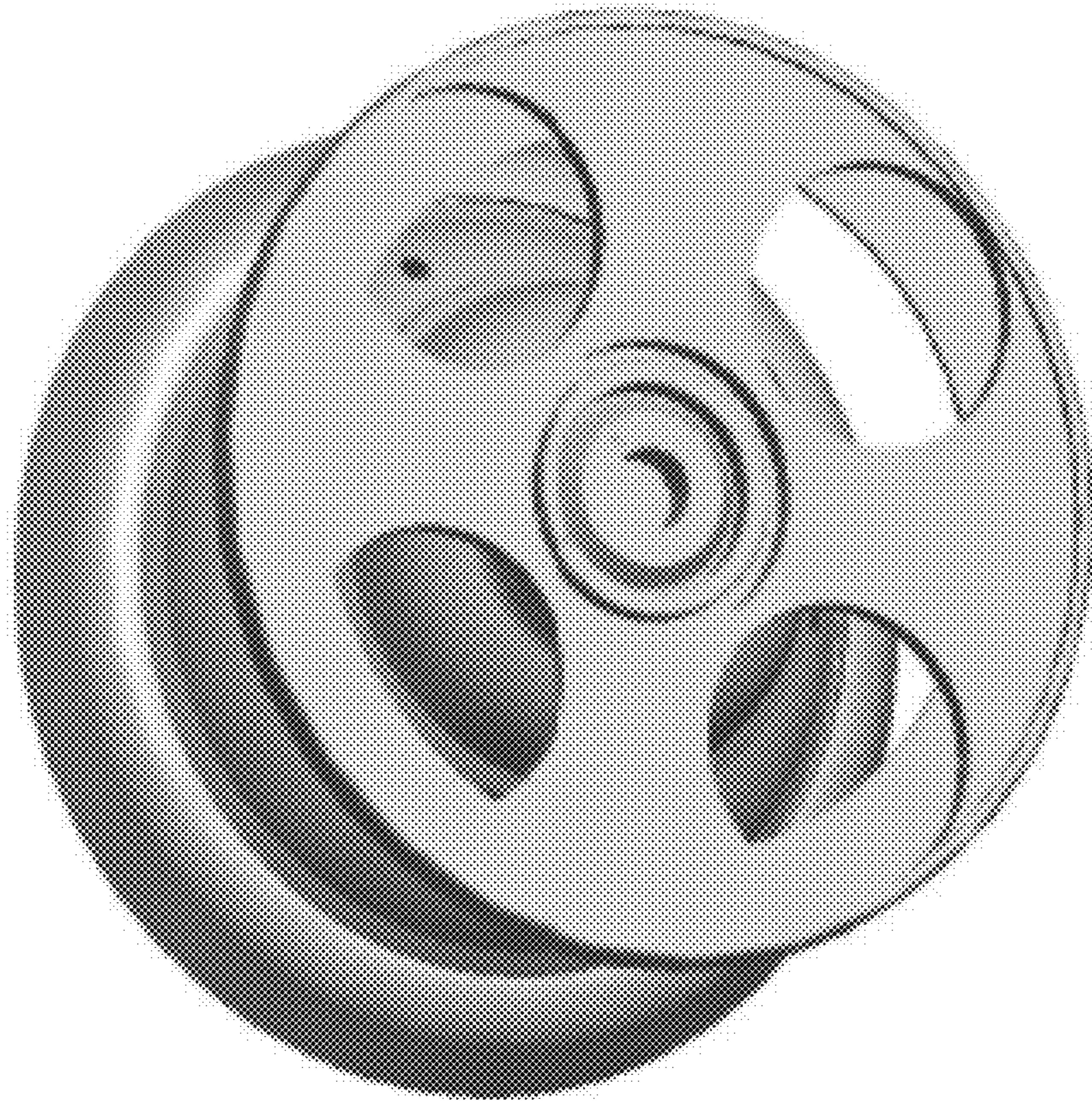

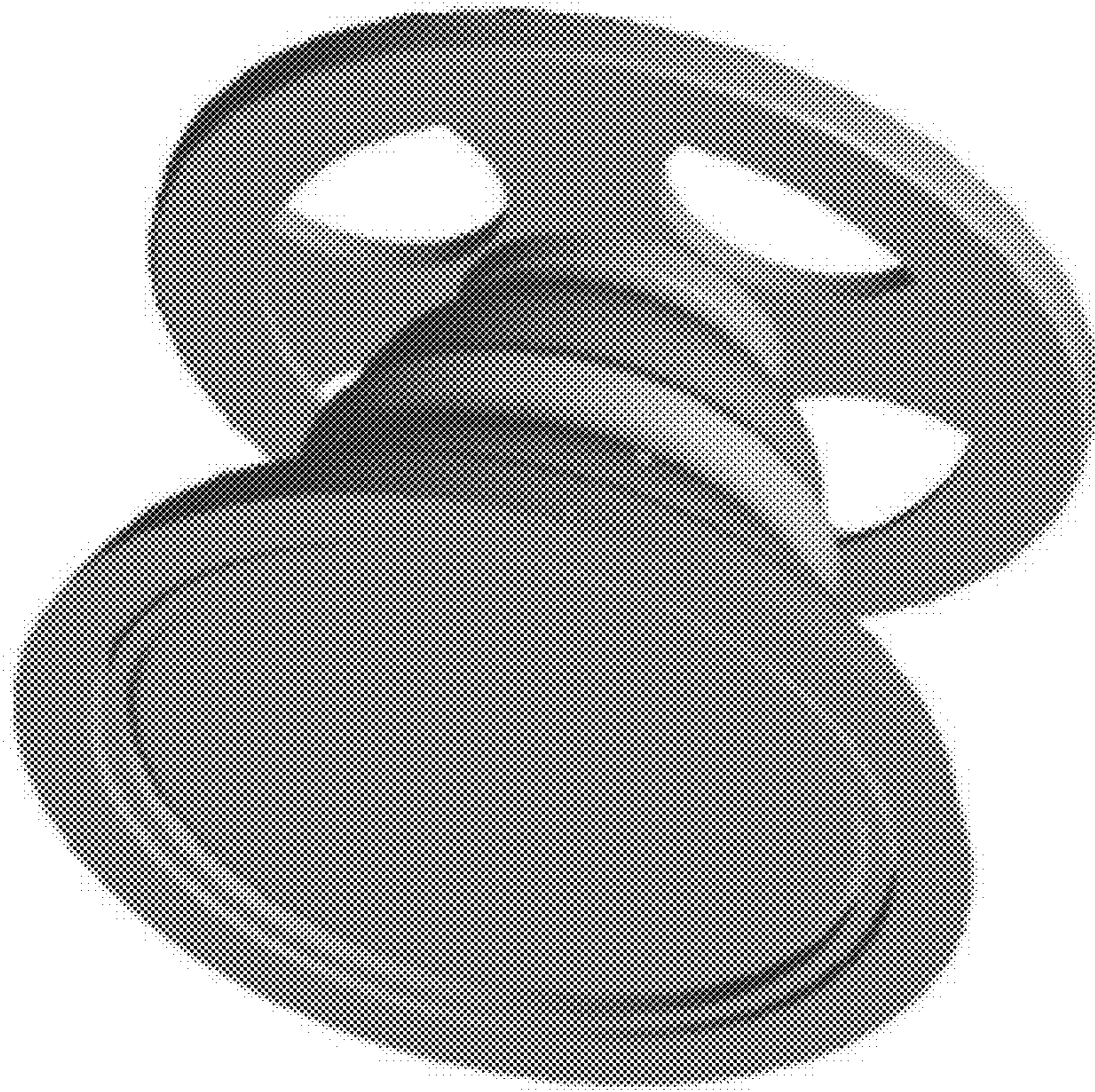

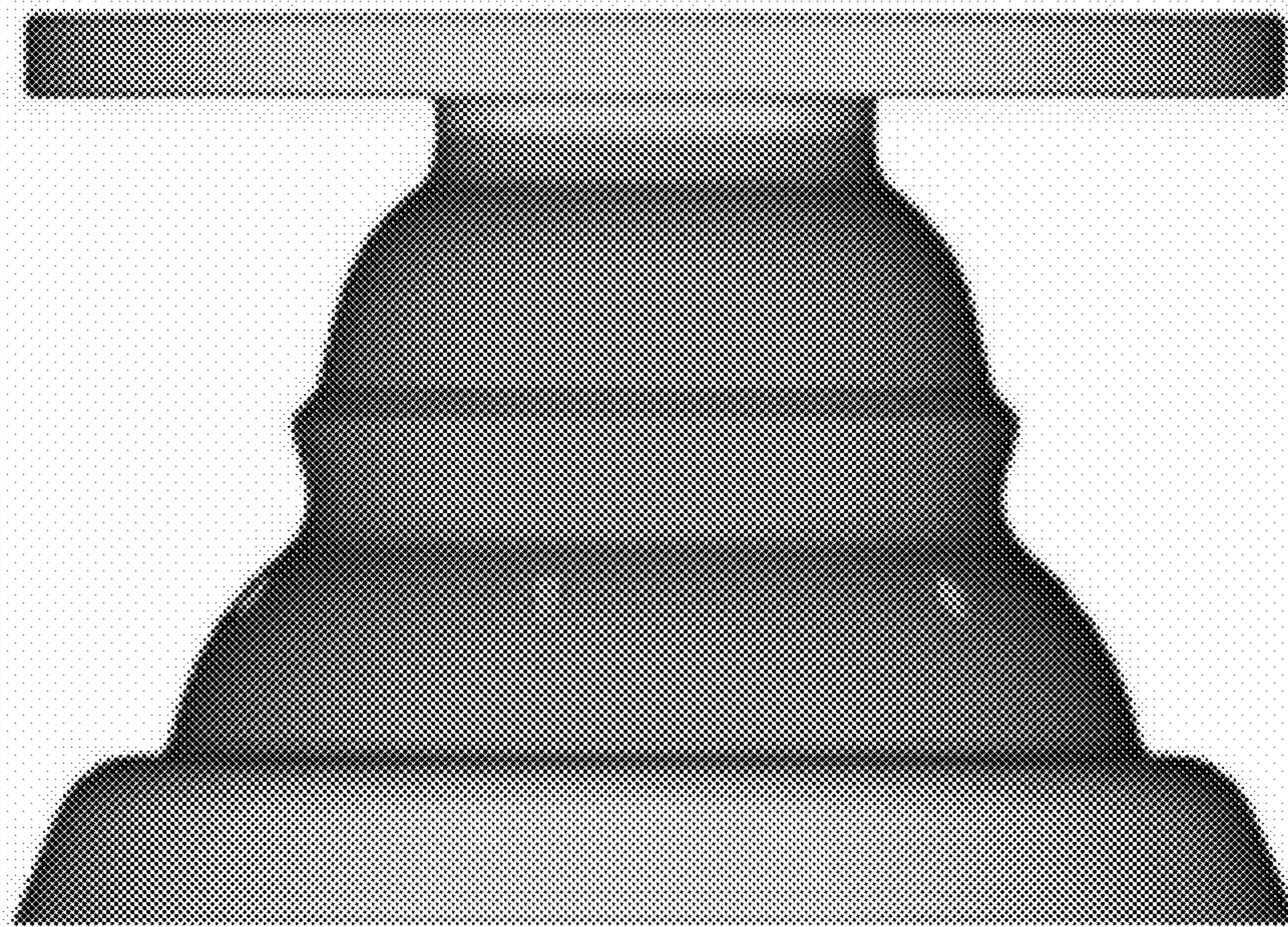

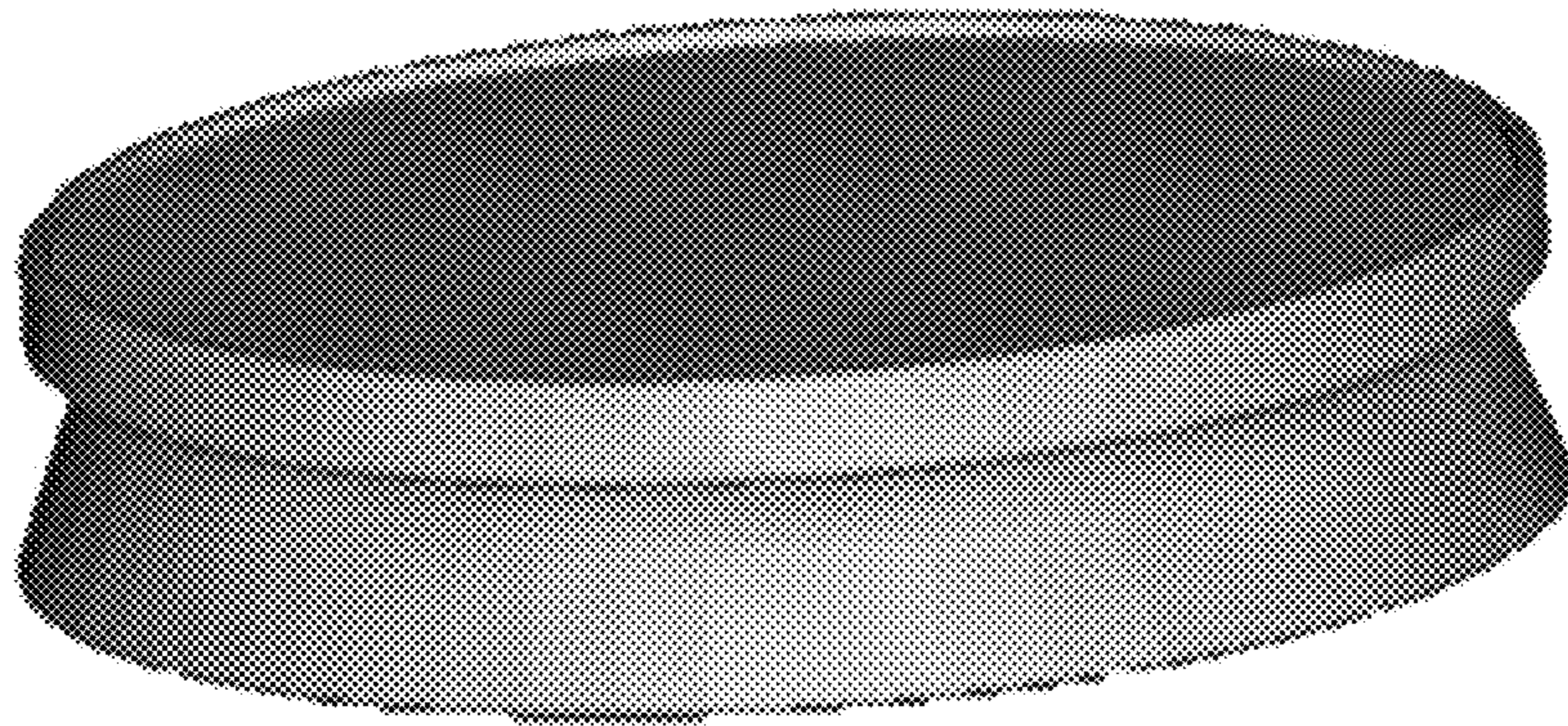
