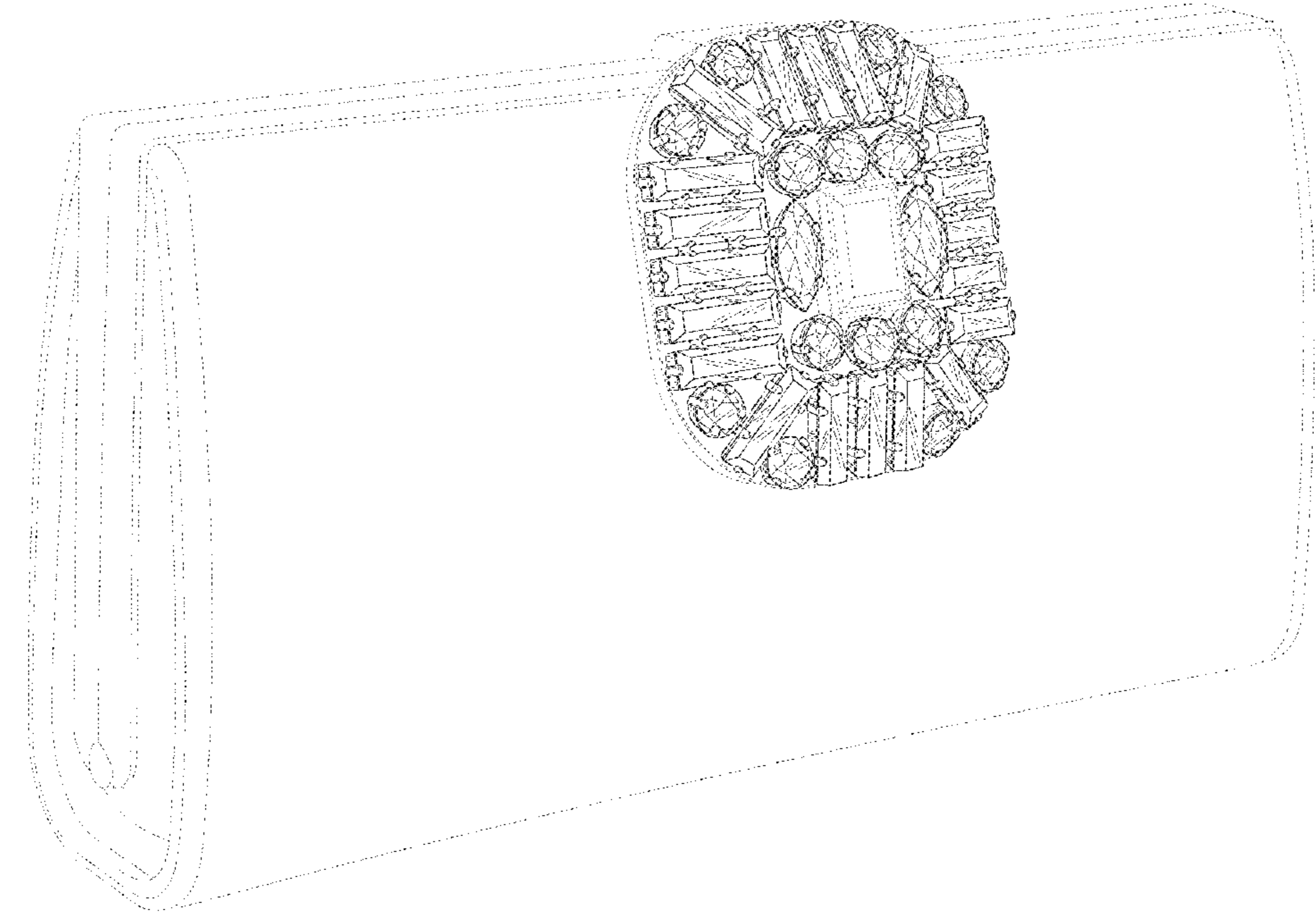

The ornamental design for a fashion ornament, as shown and described.

DESCRIPTION
FIG. 1 is a front perspective view of a fashion ornament showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a front view of the fashion ornament shown in FIG. 1, shown in the environment of a handbag;
FIG. 8 is a front perspective view of an alternative embodiment of the fashion ornament shown in FIG. 1;

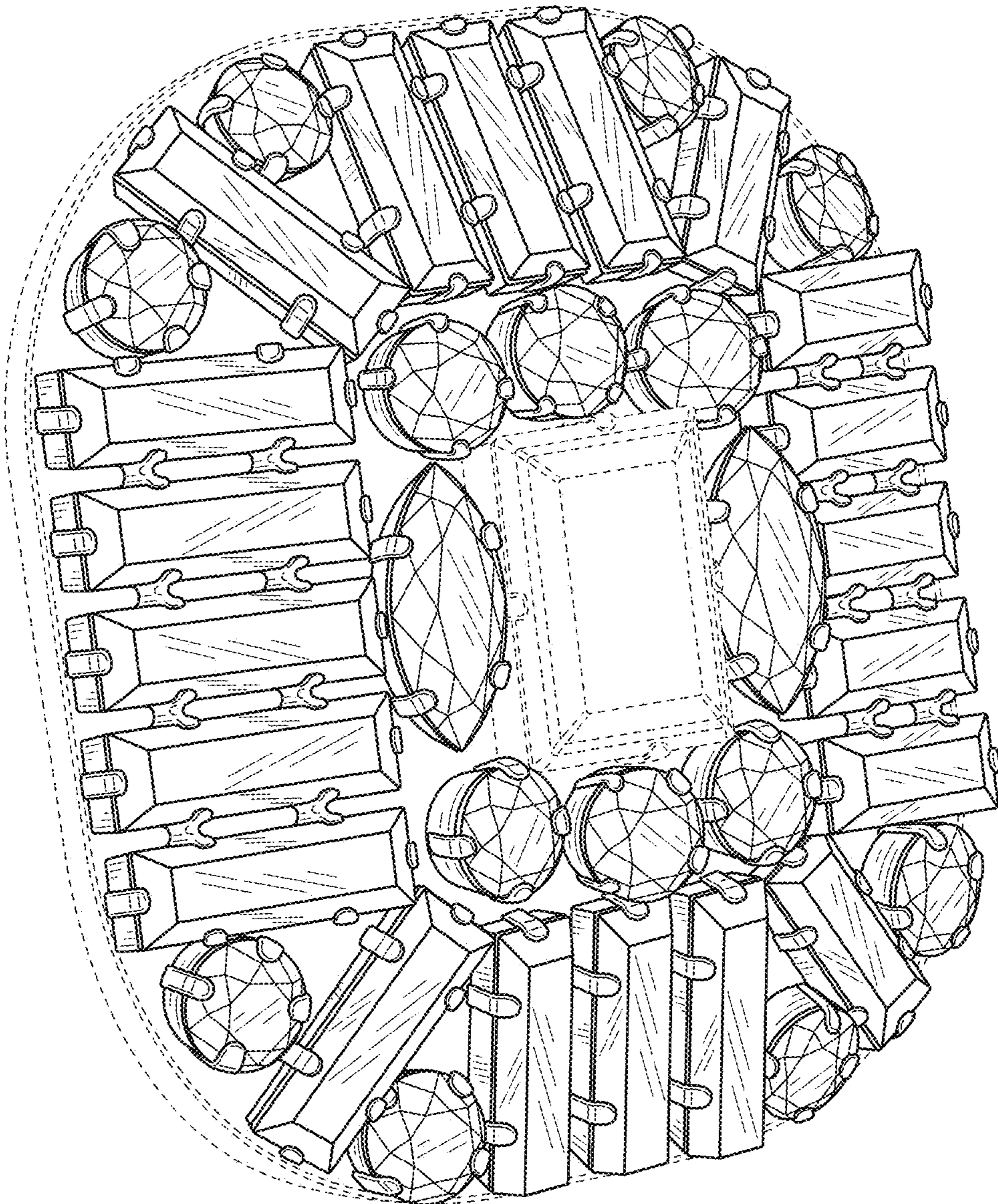

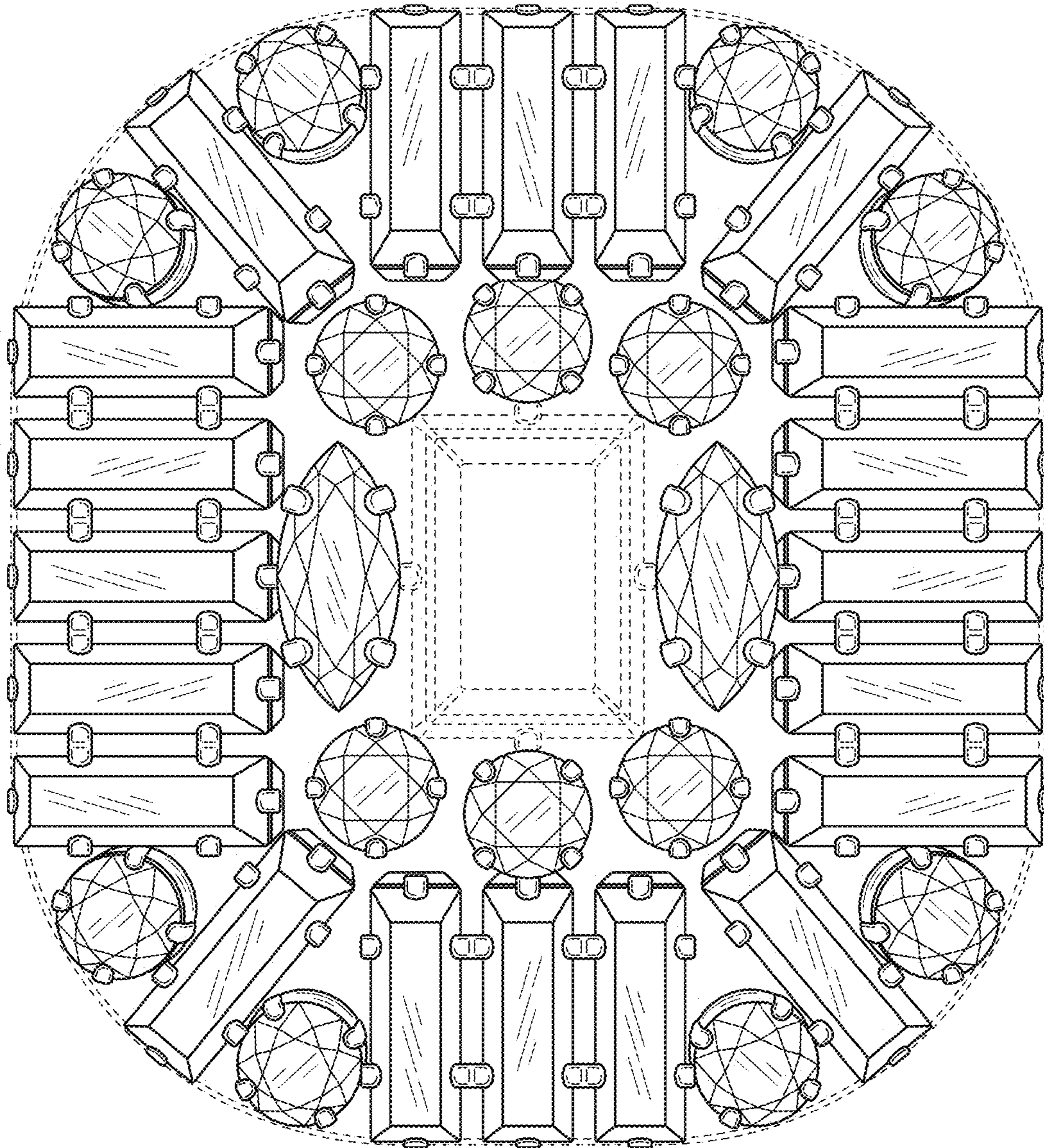

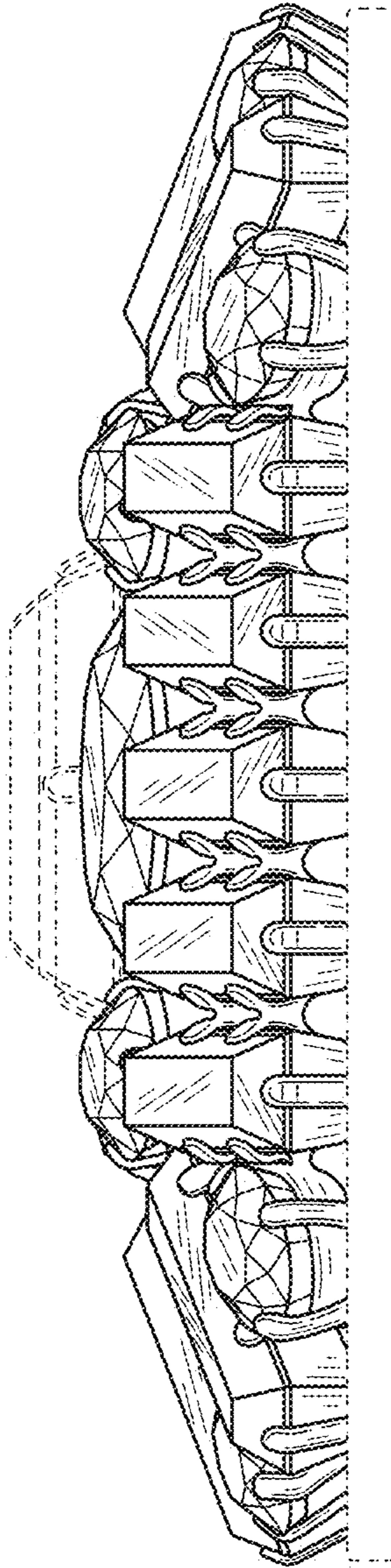

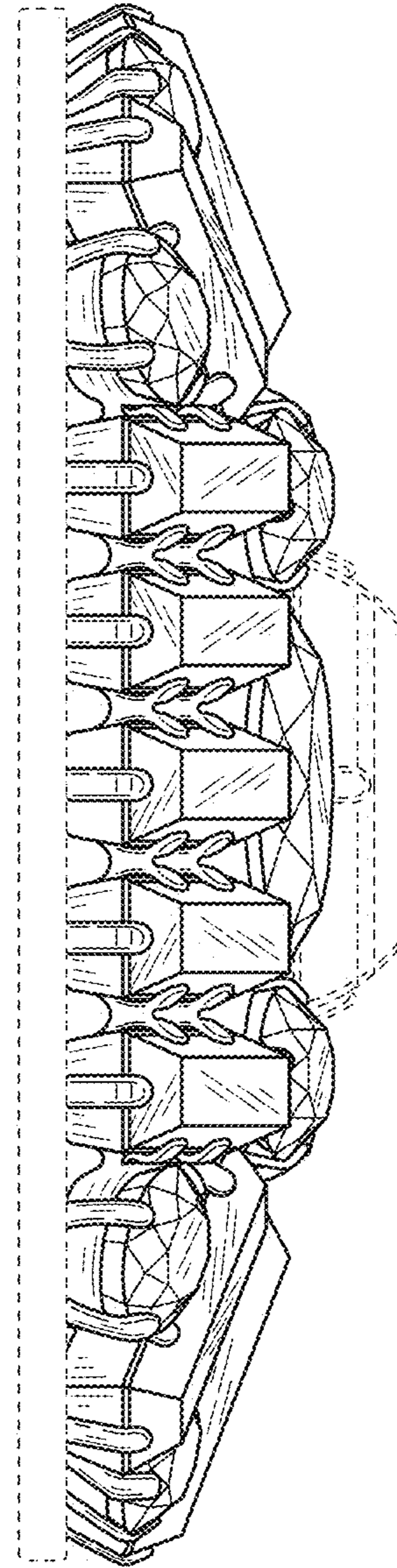

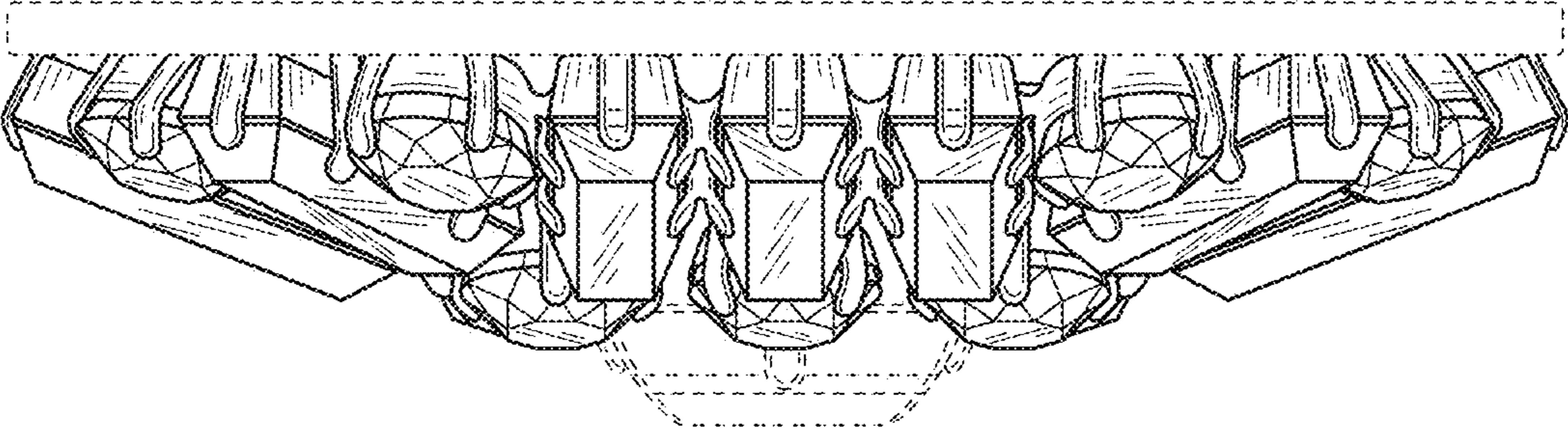

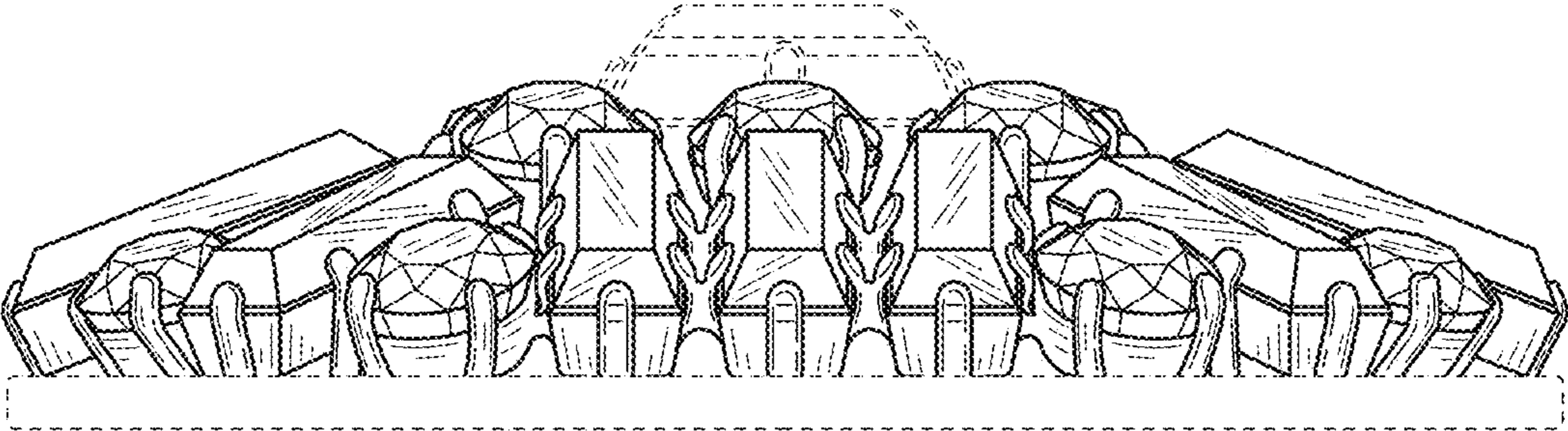

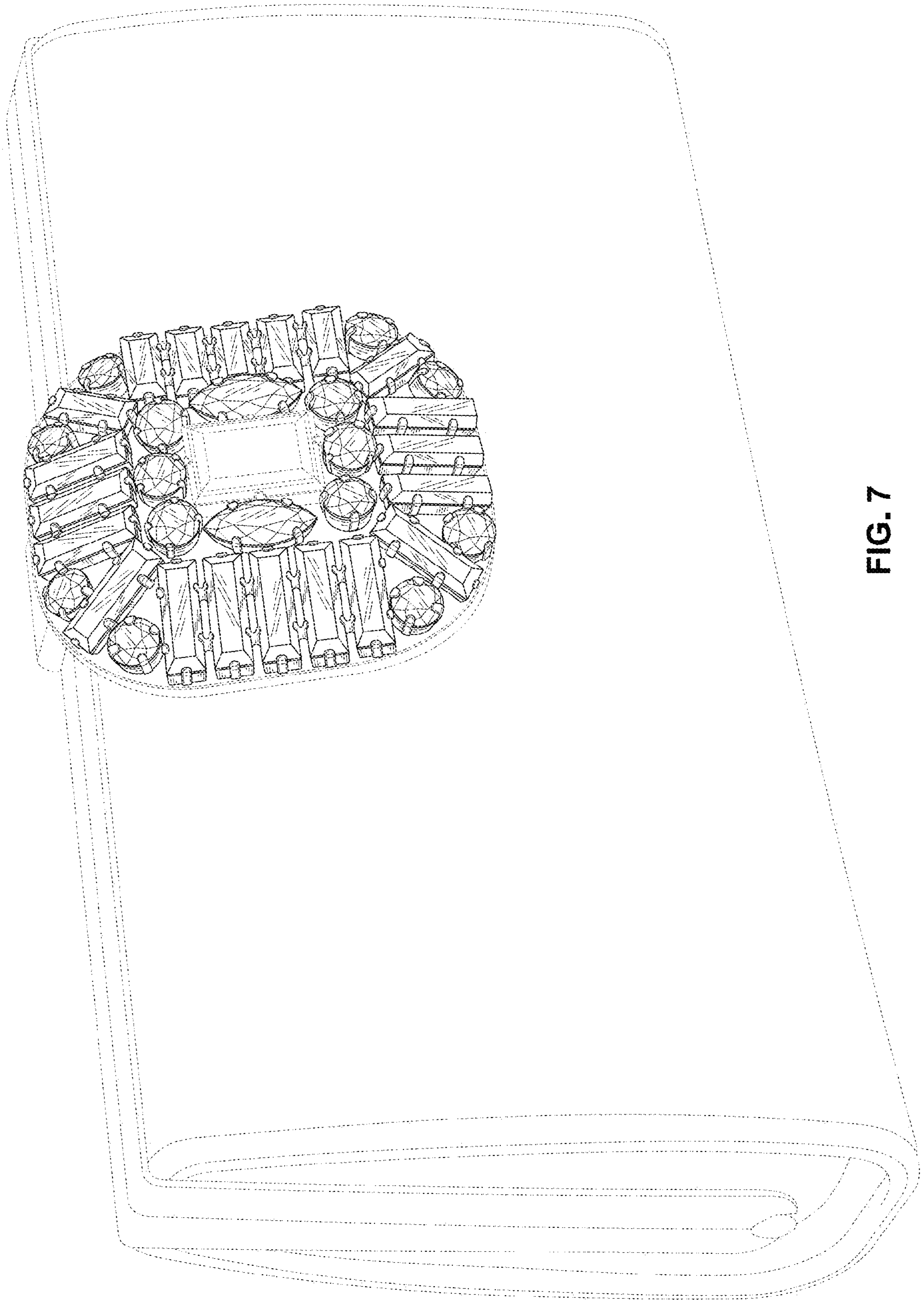

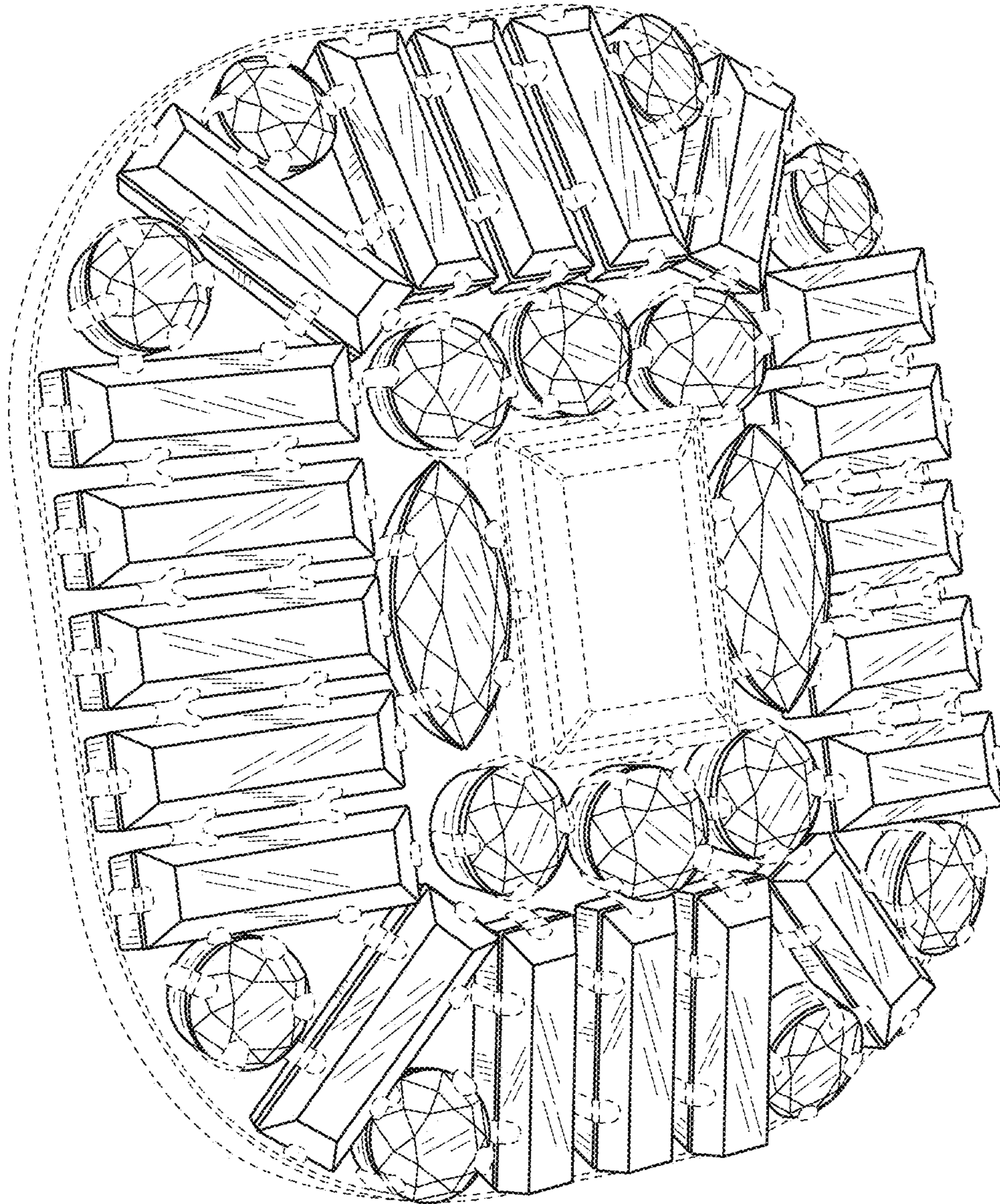

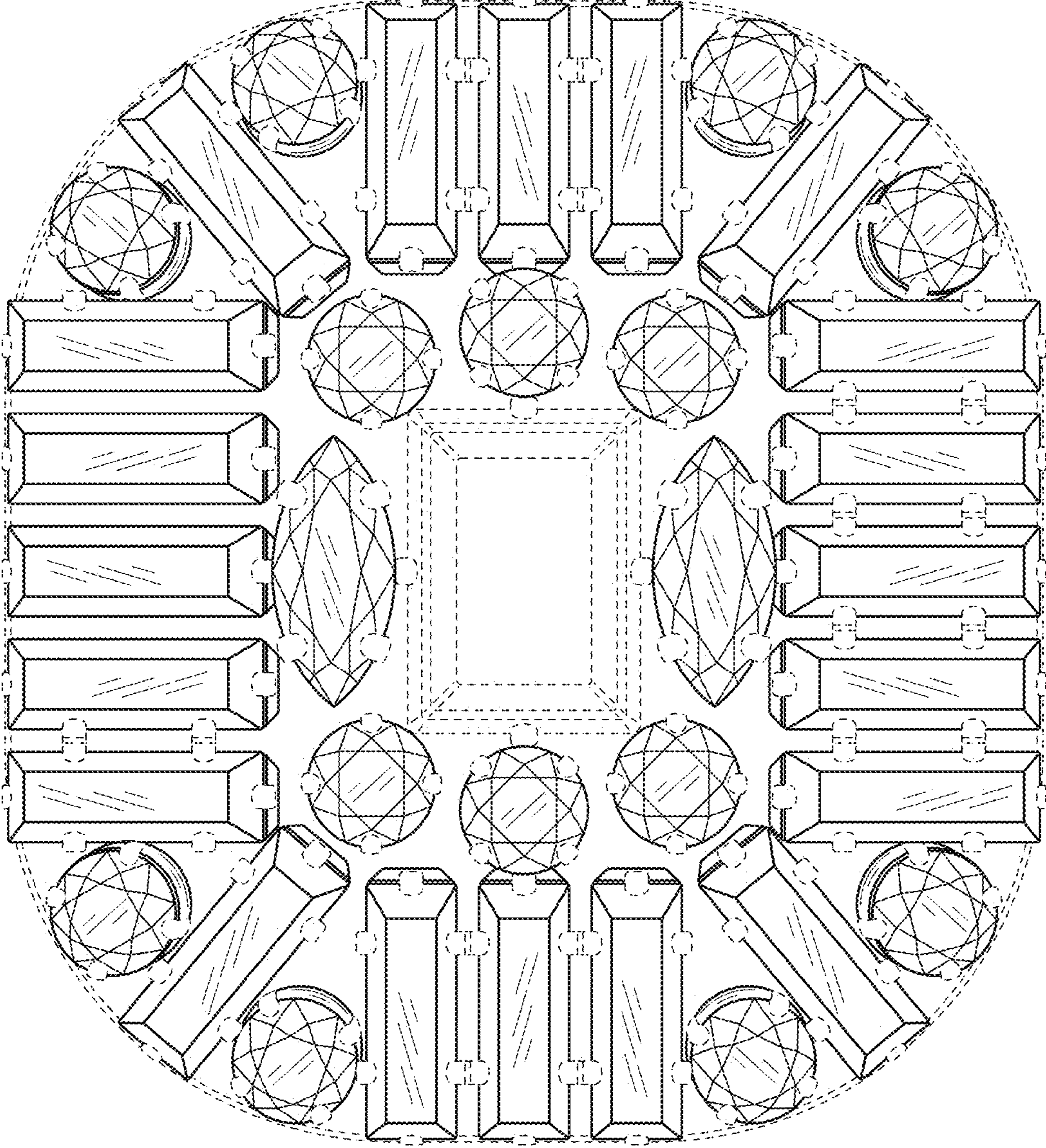

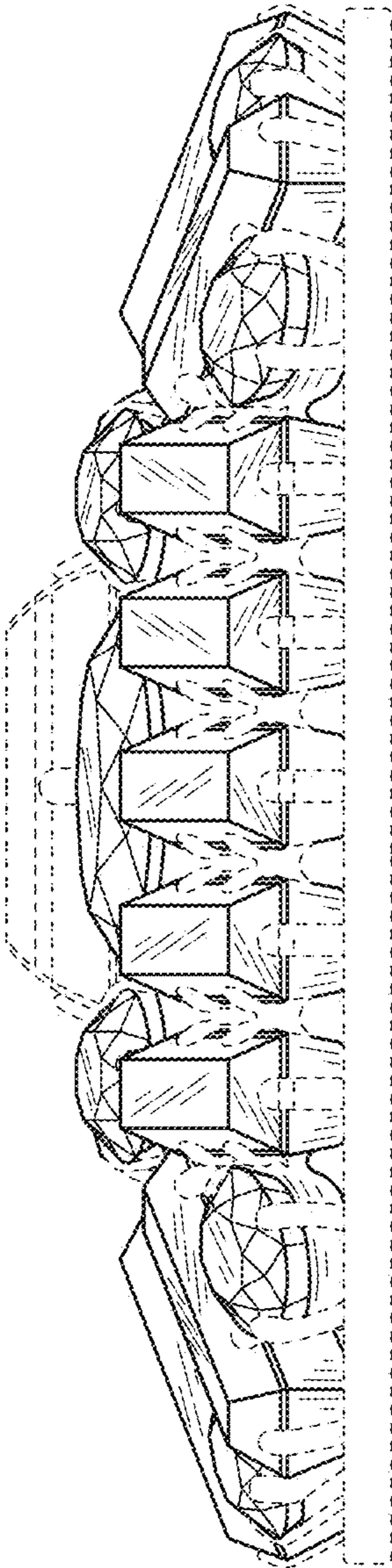

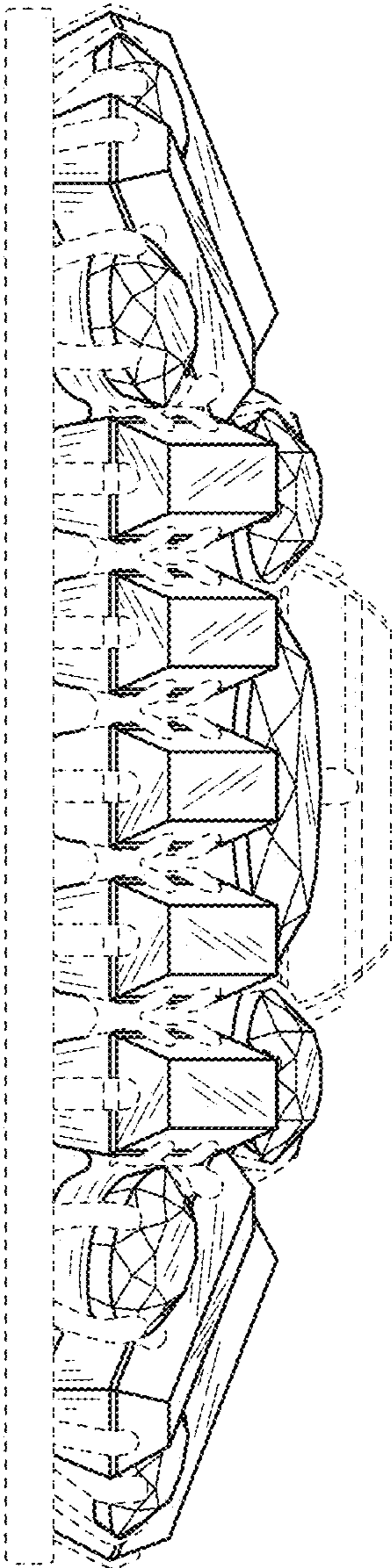

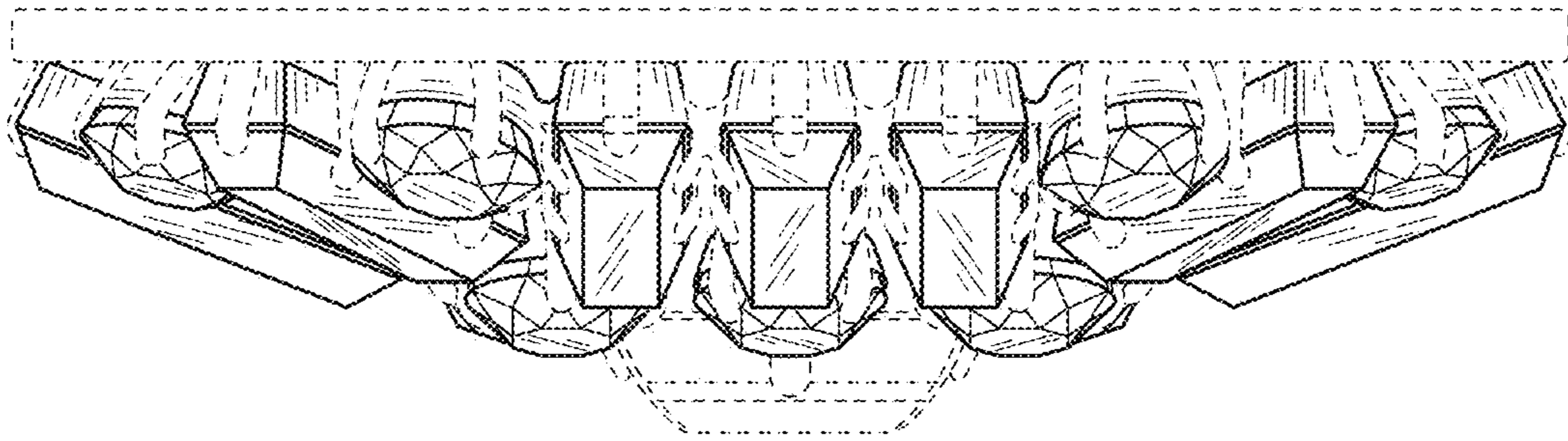

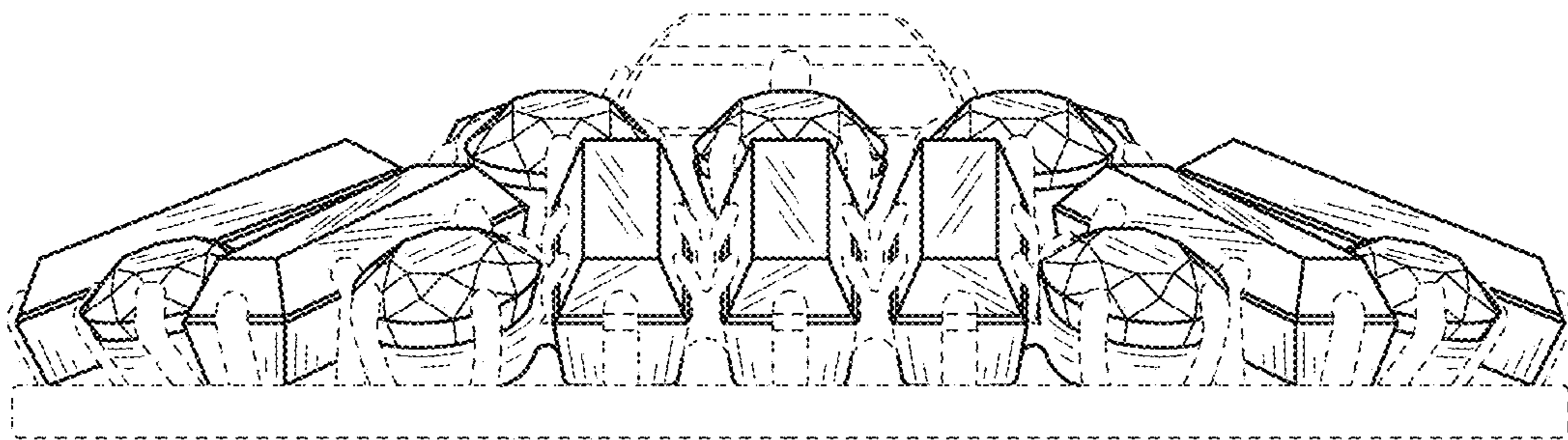

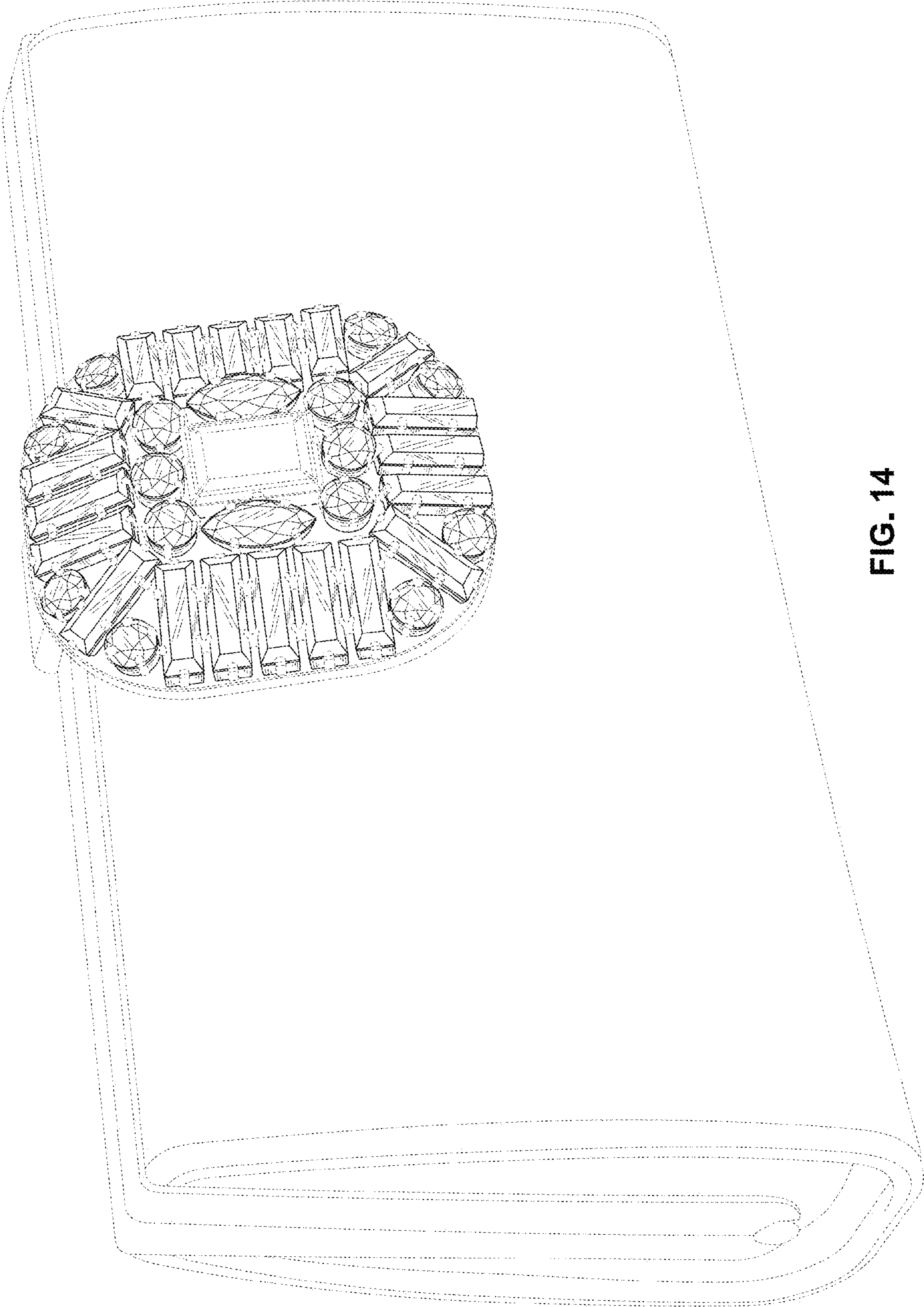
