FIG. 14 is a left-side view thereof;

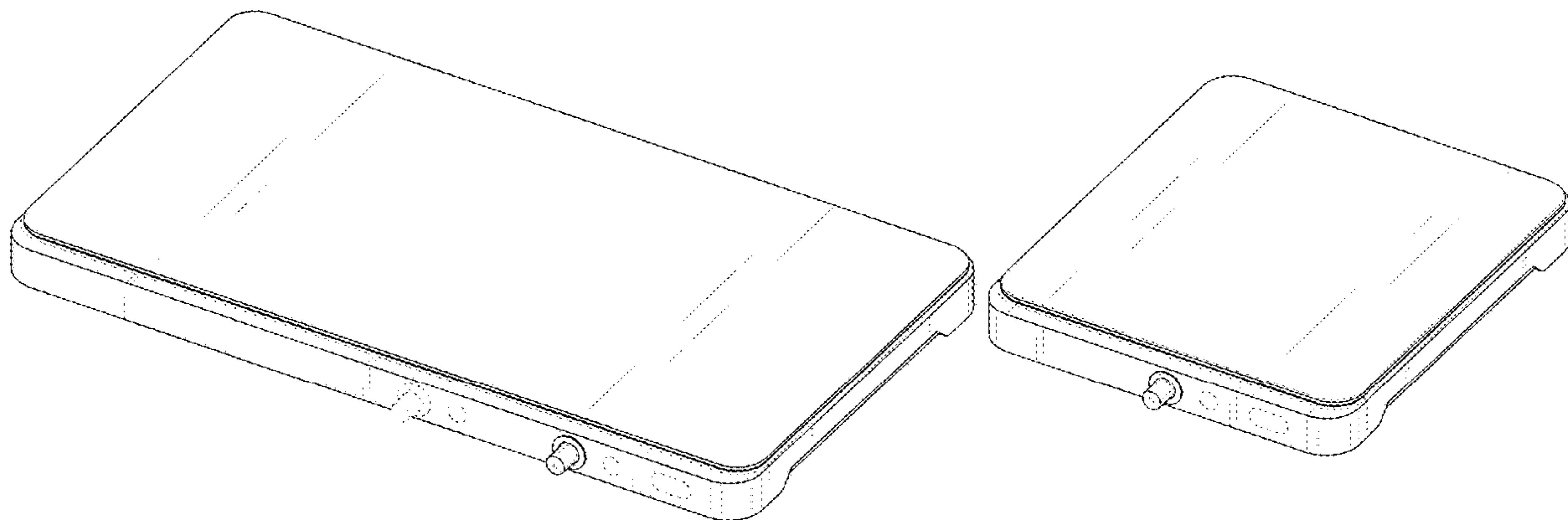
FIG. 15 is a right-side view thereof;

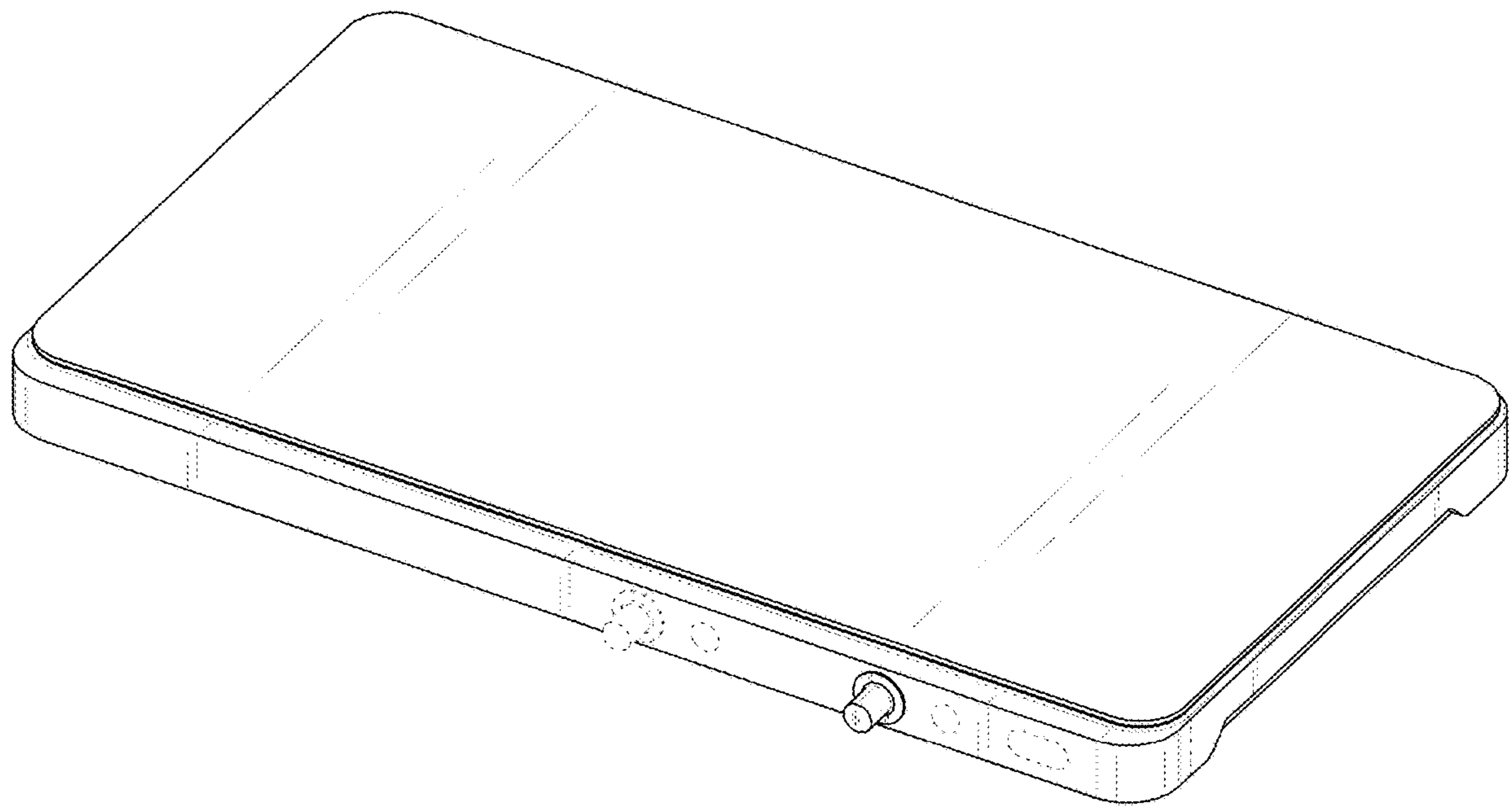

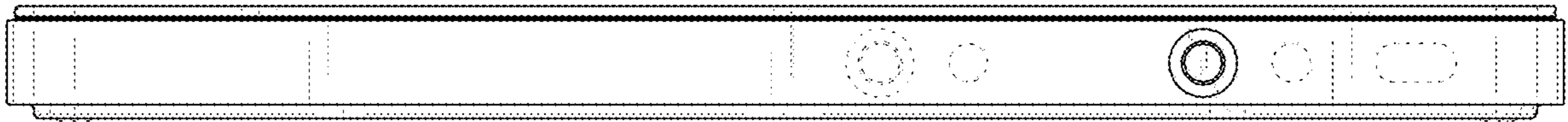

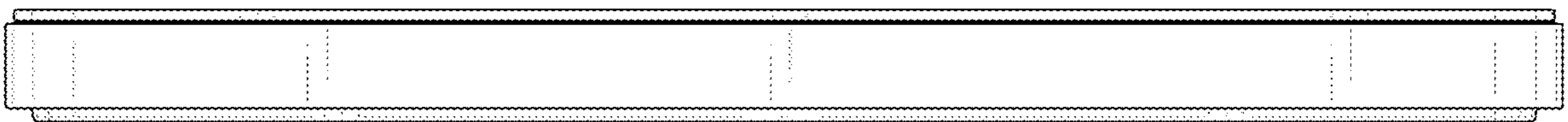

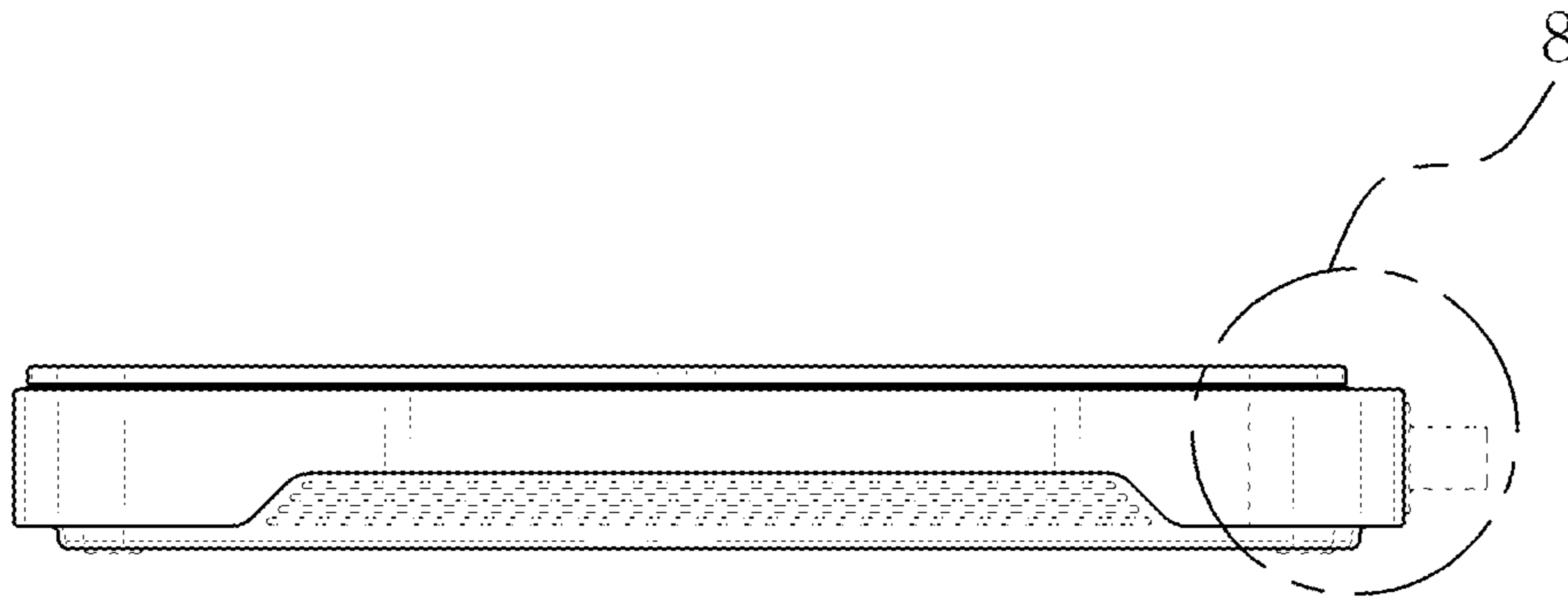

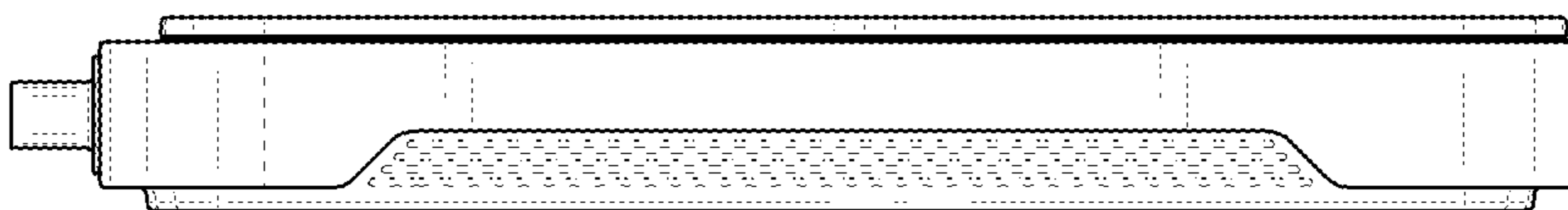

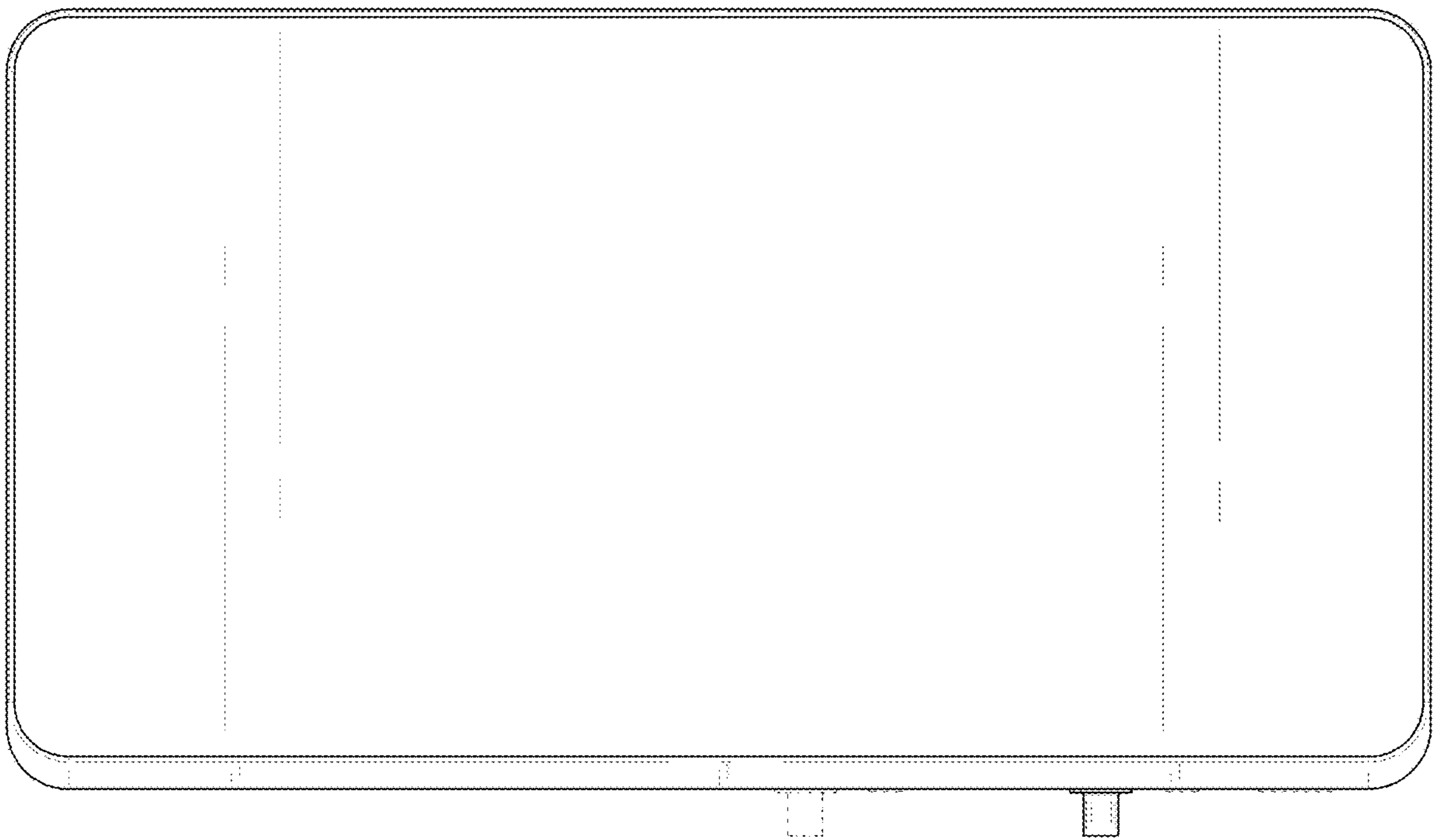

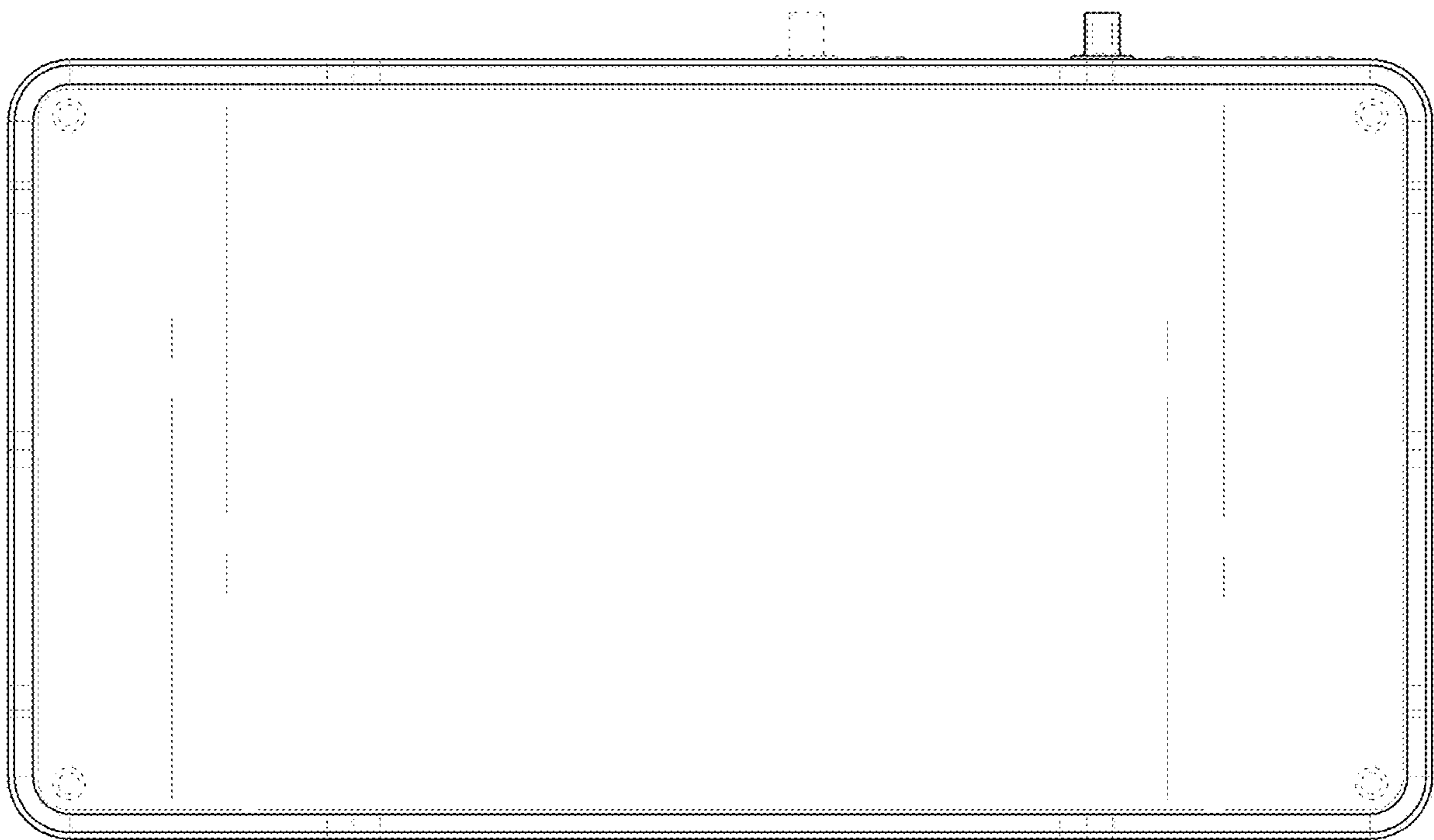

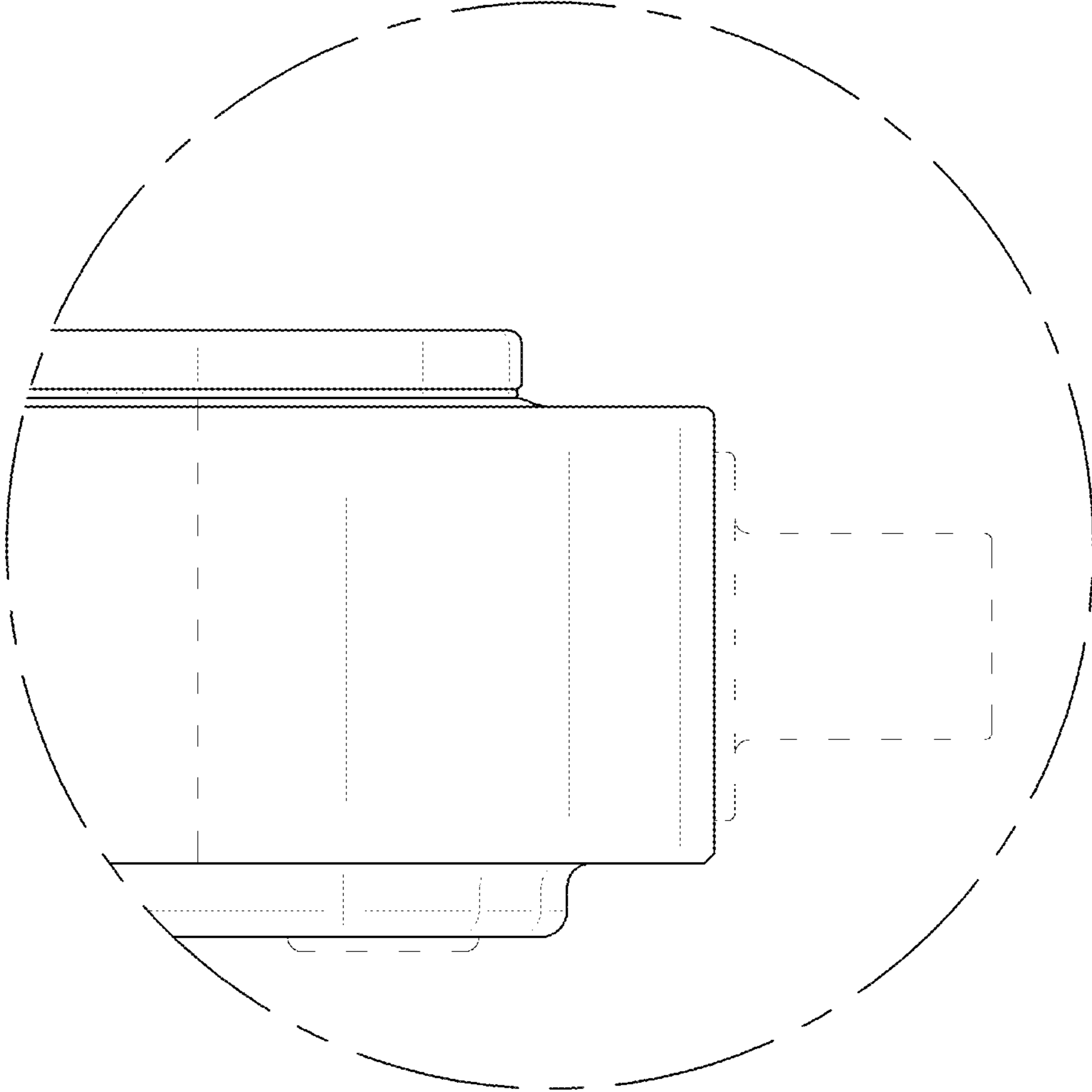

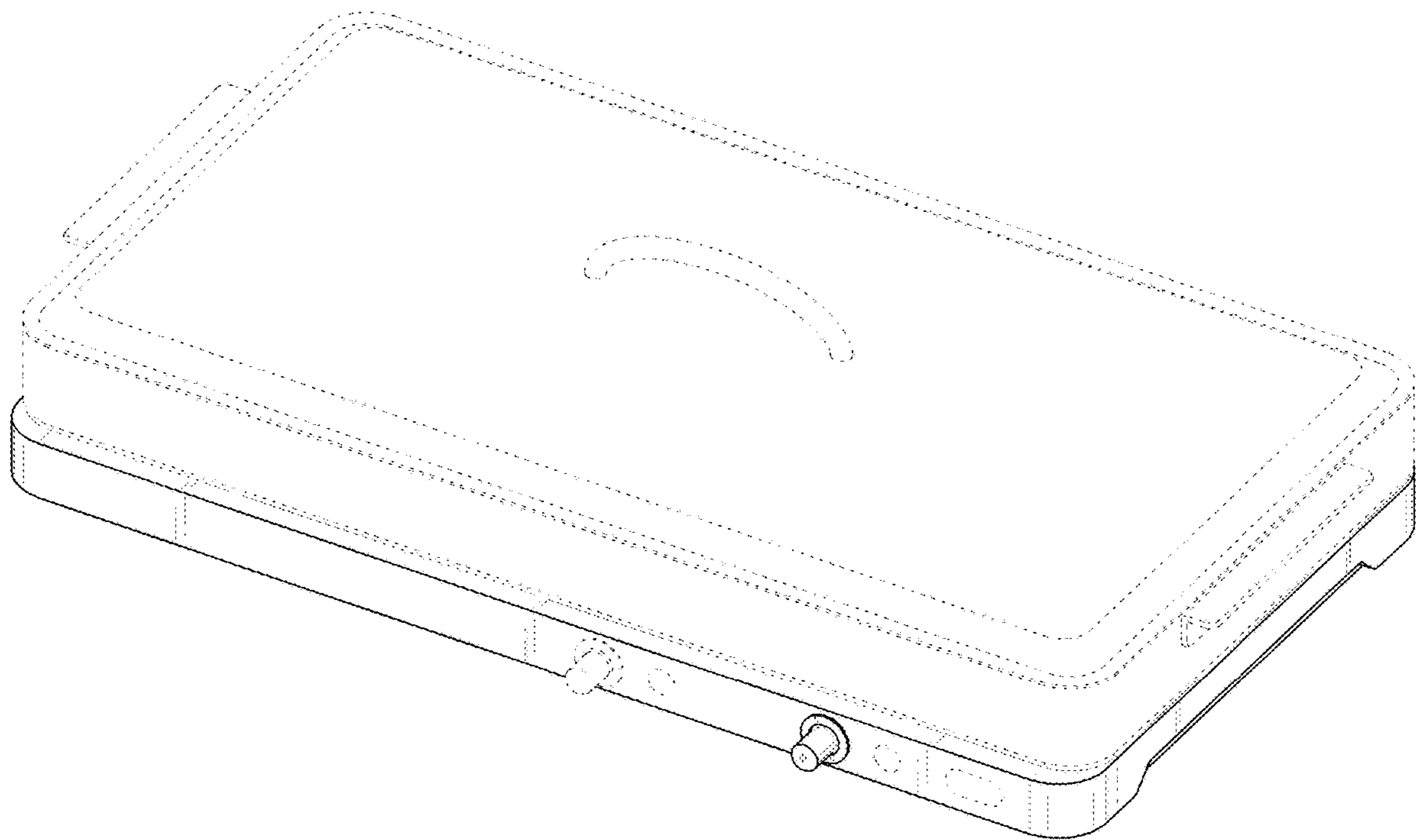

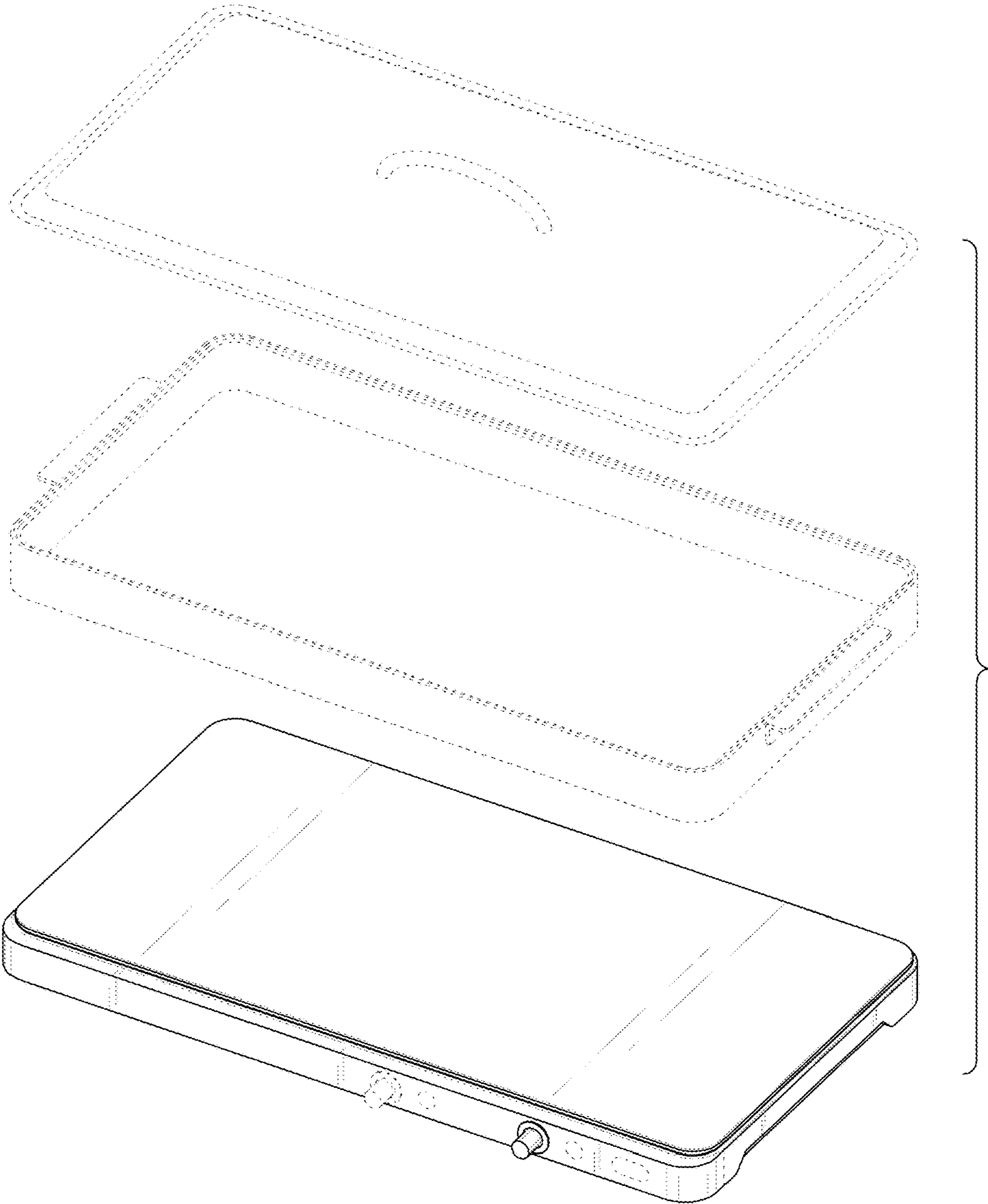

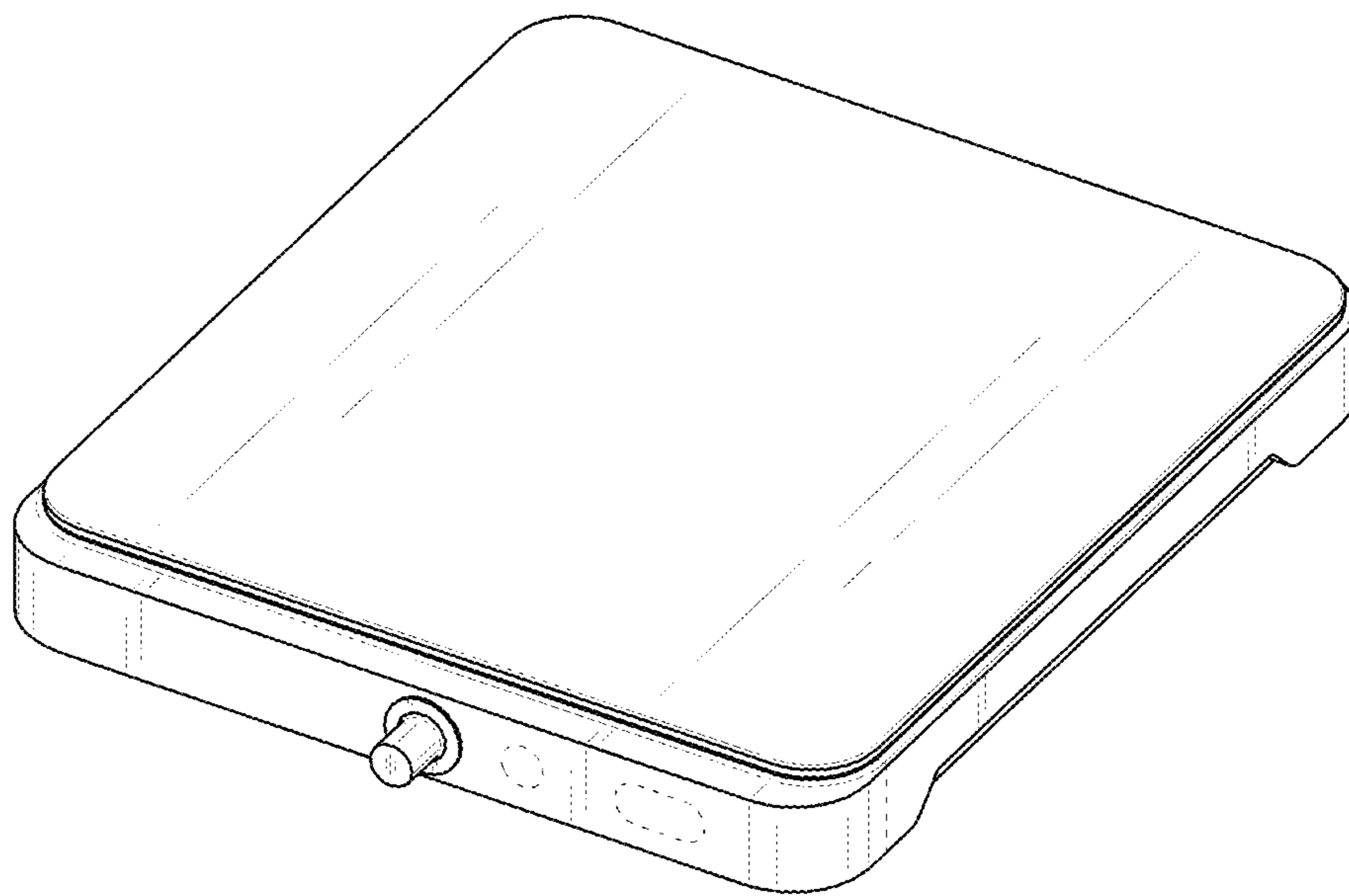

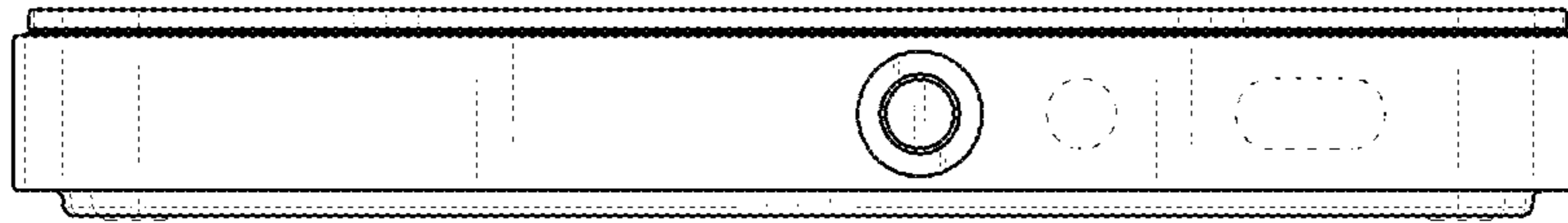

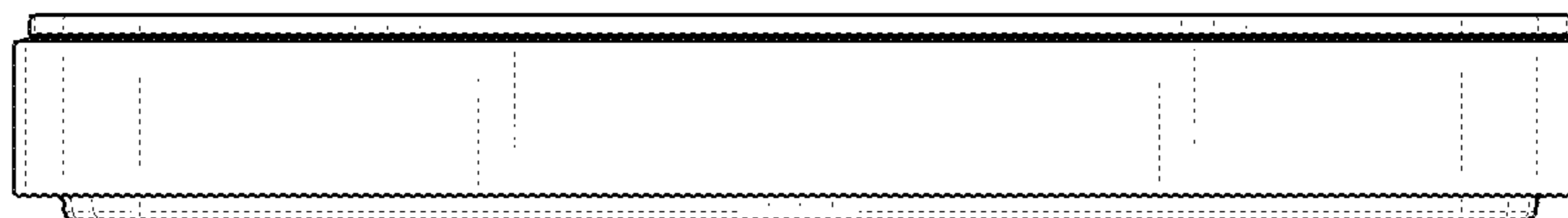

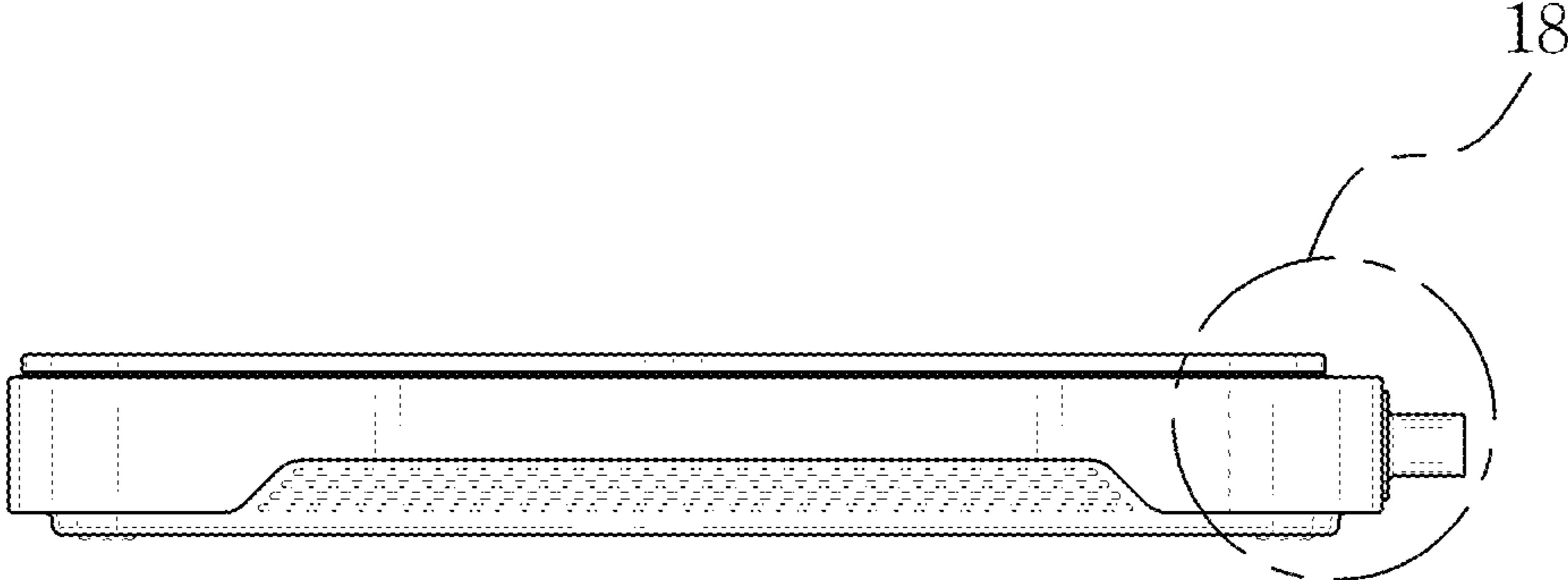

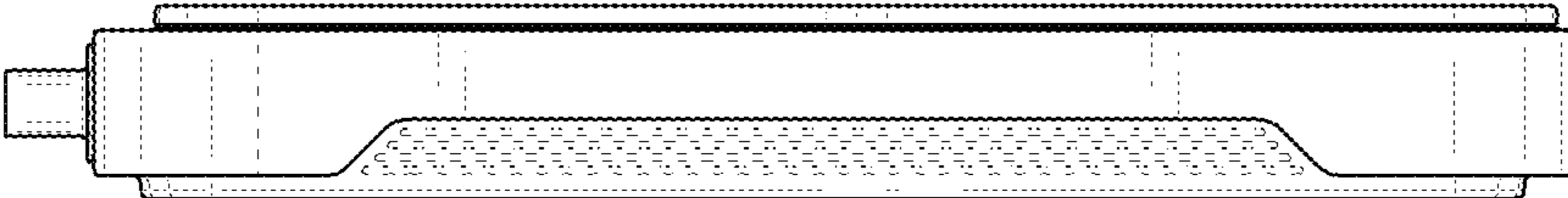

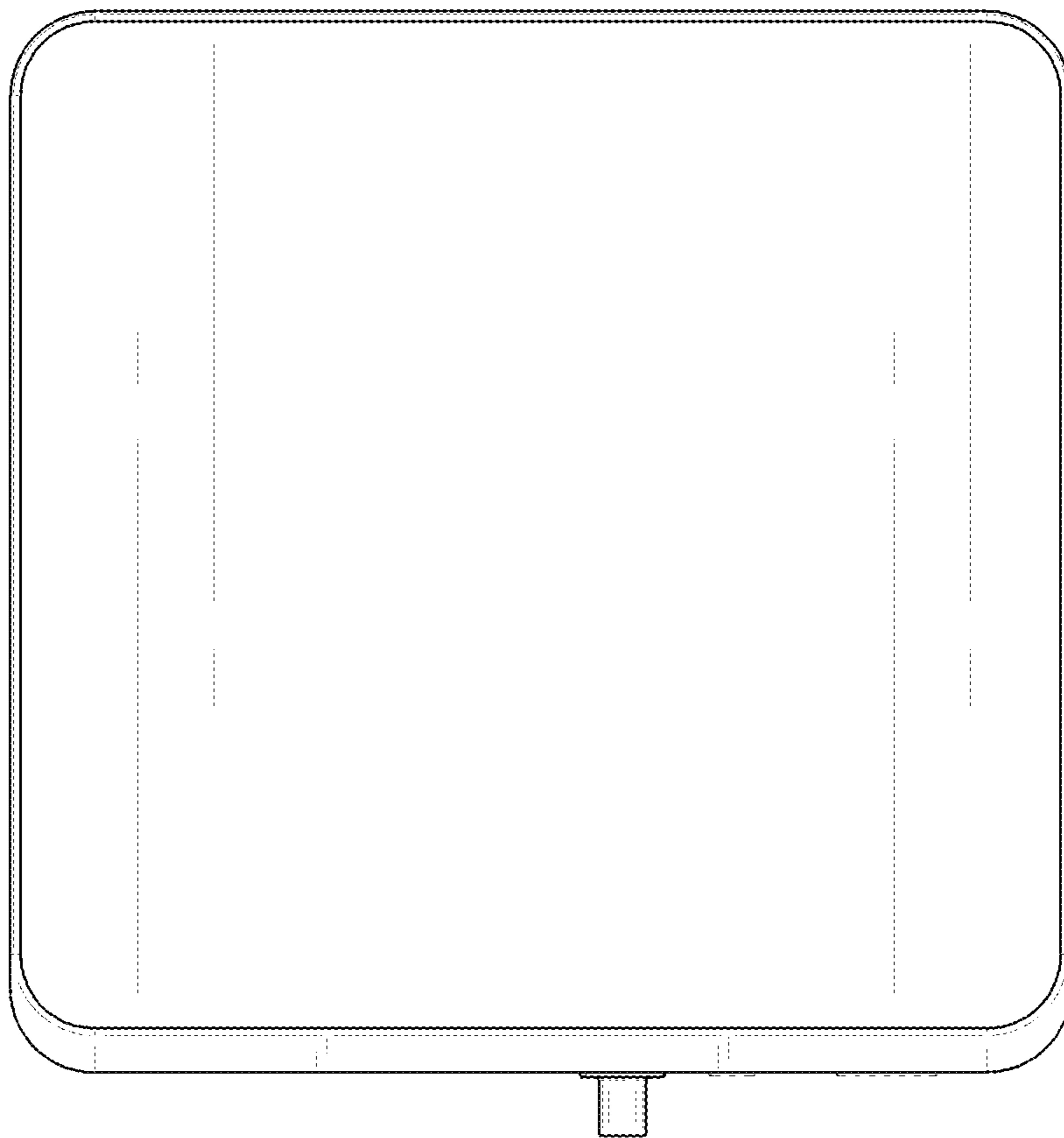

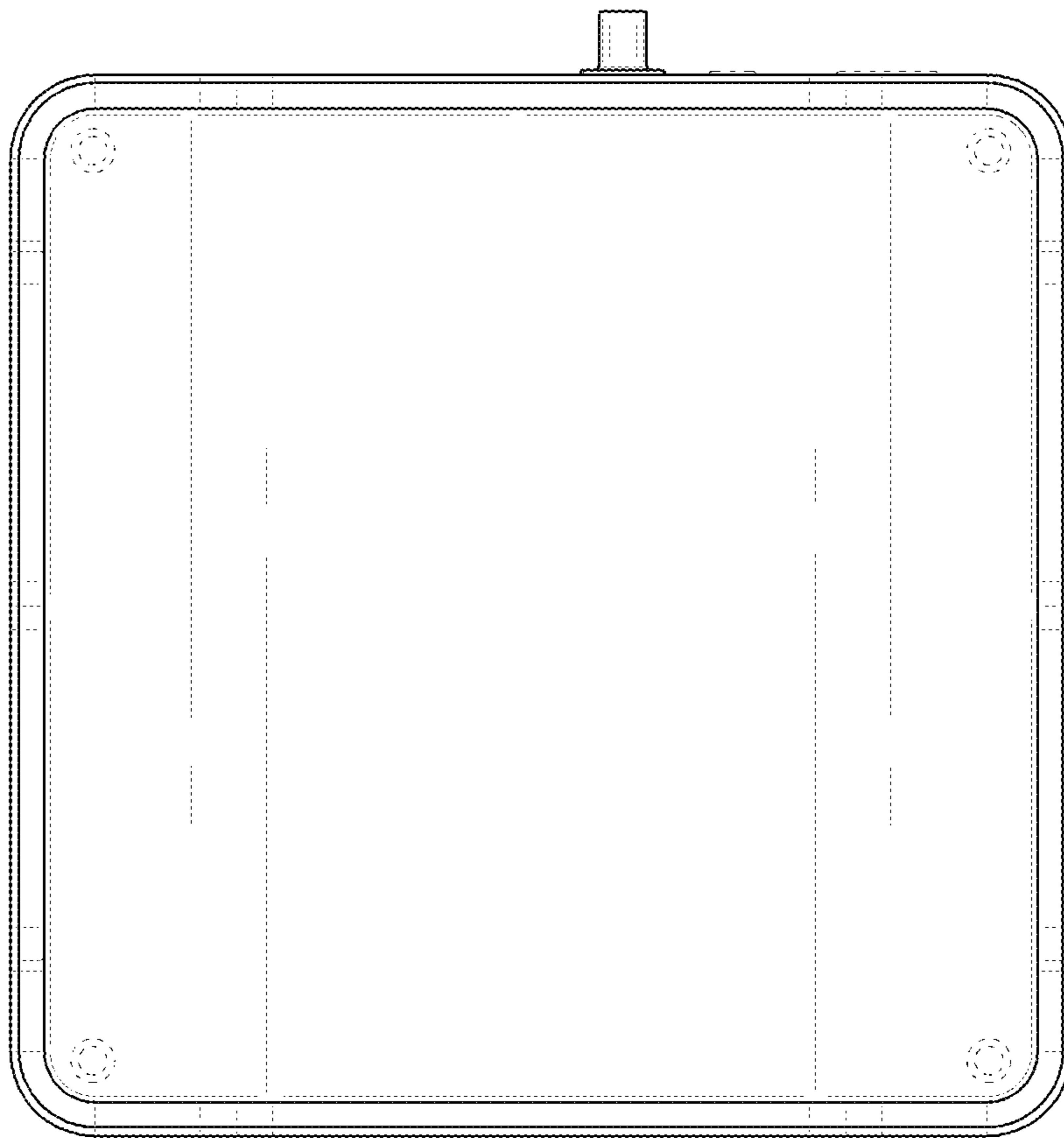
