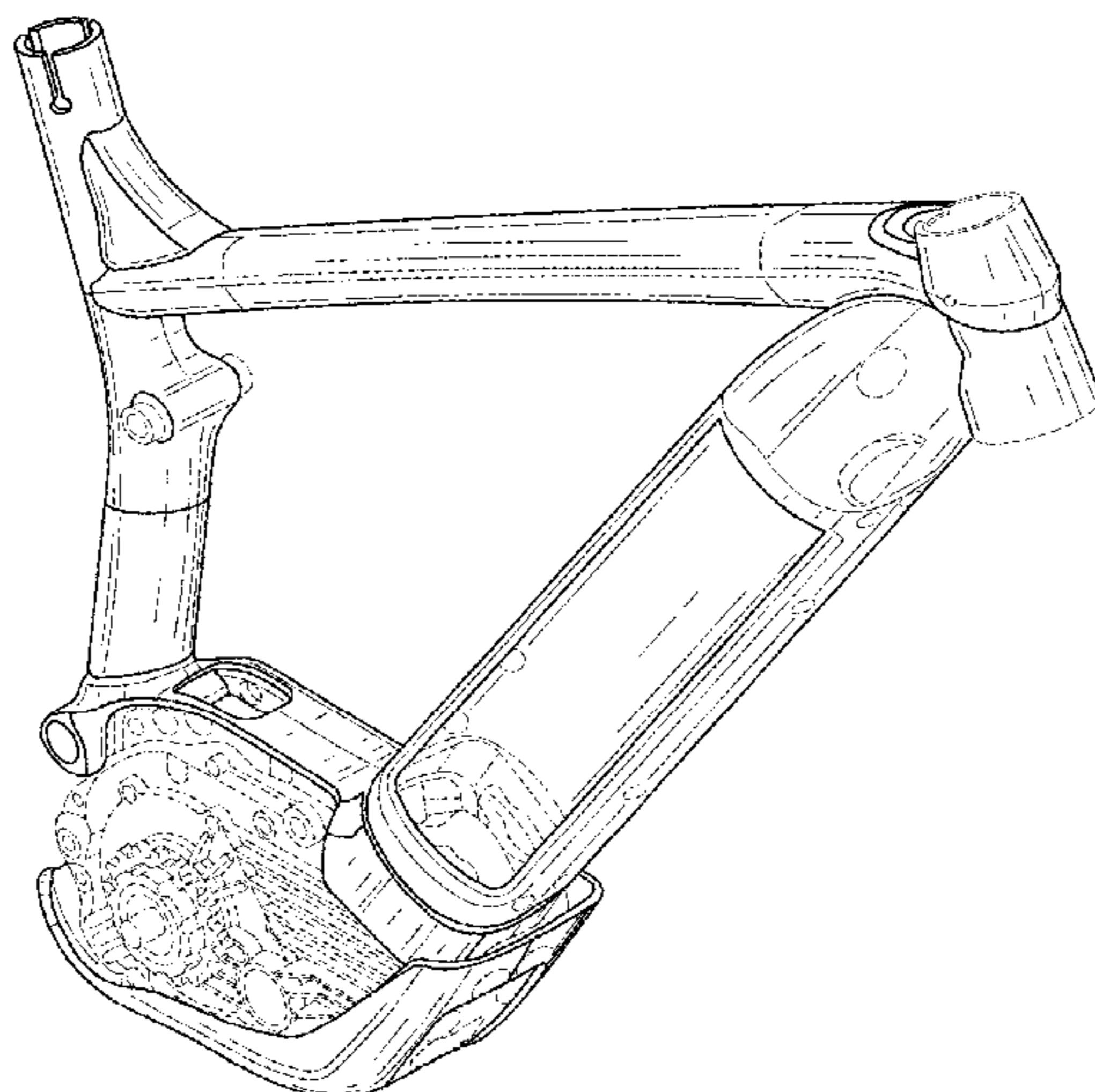
FIG. 1 is a front view of a bicycle frame showing my new

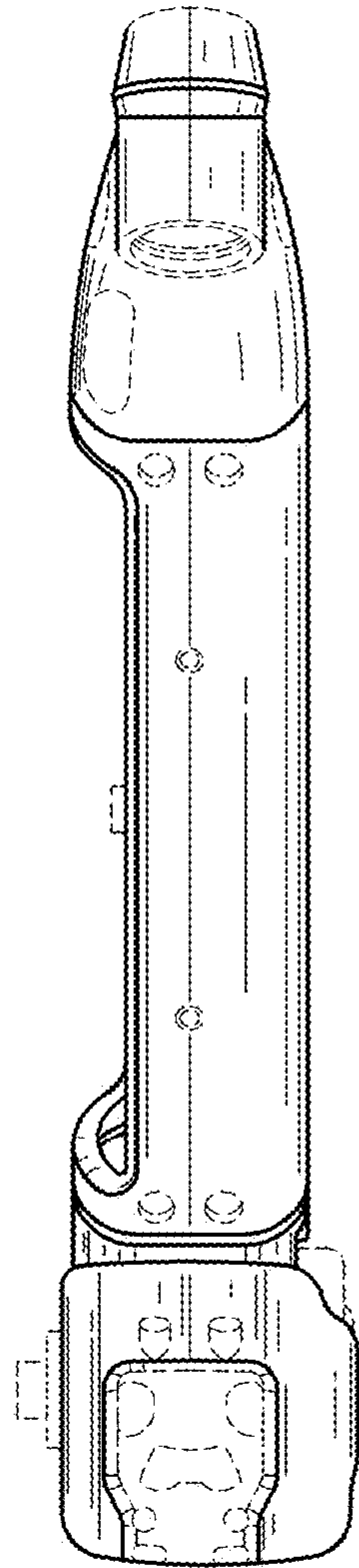

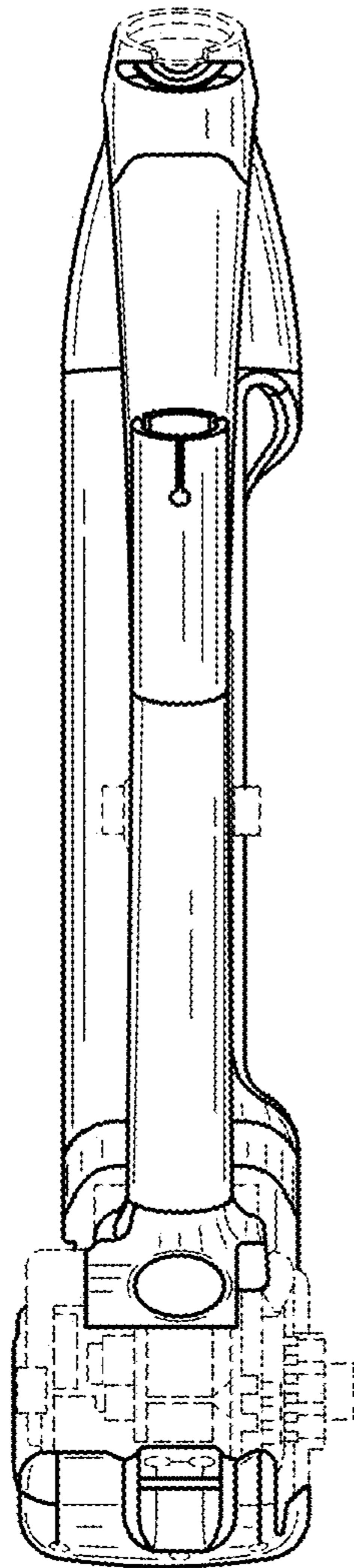

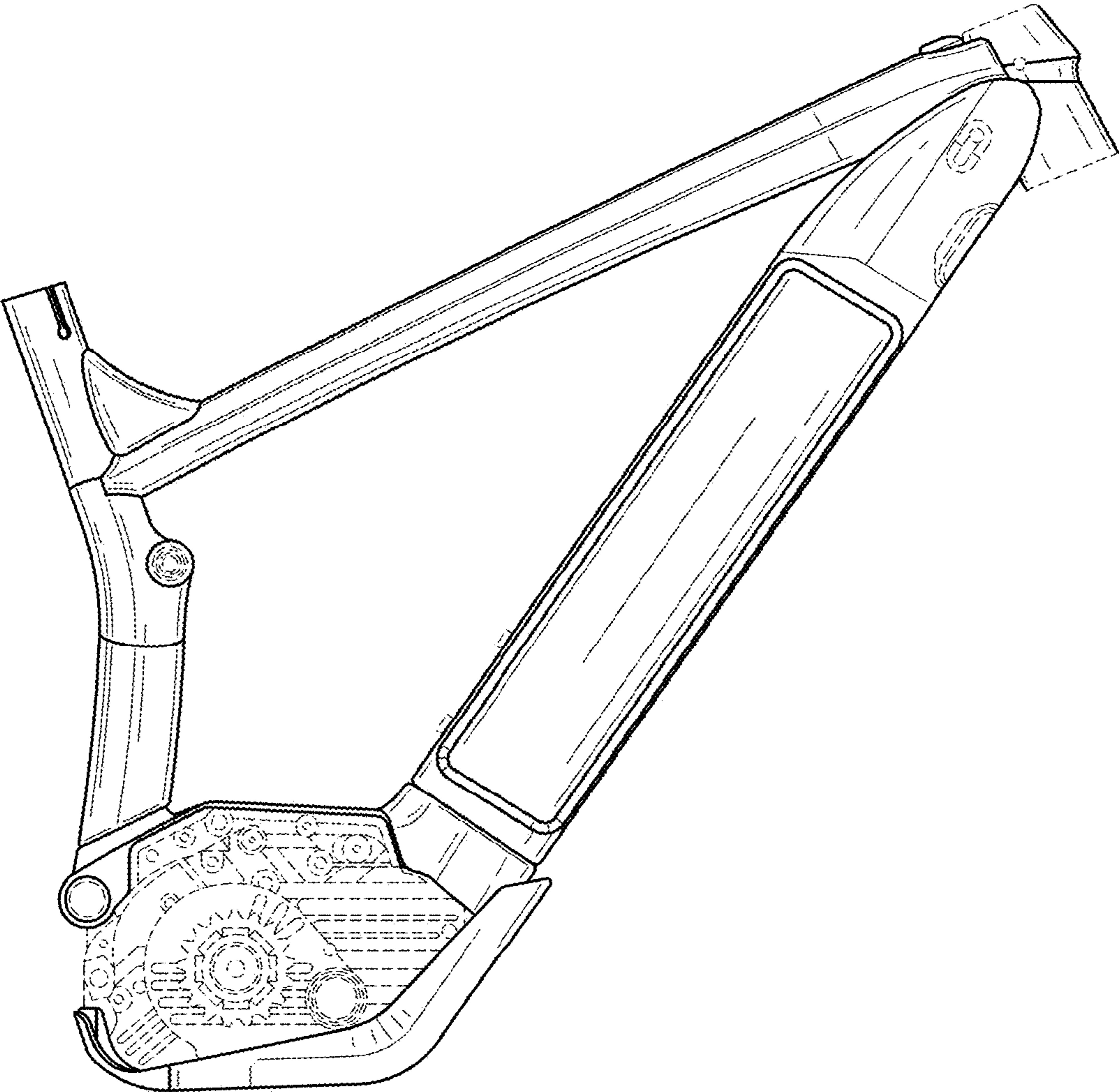

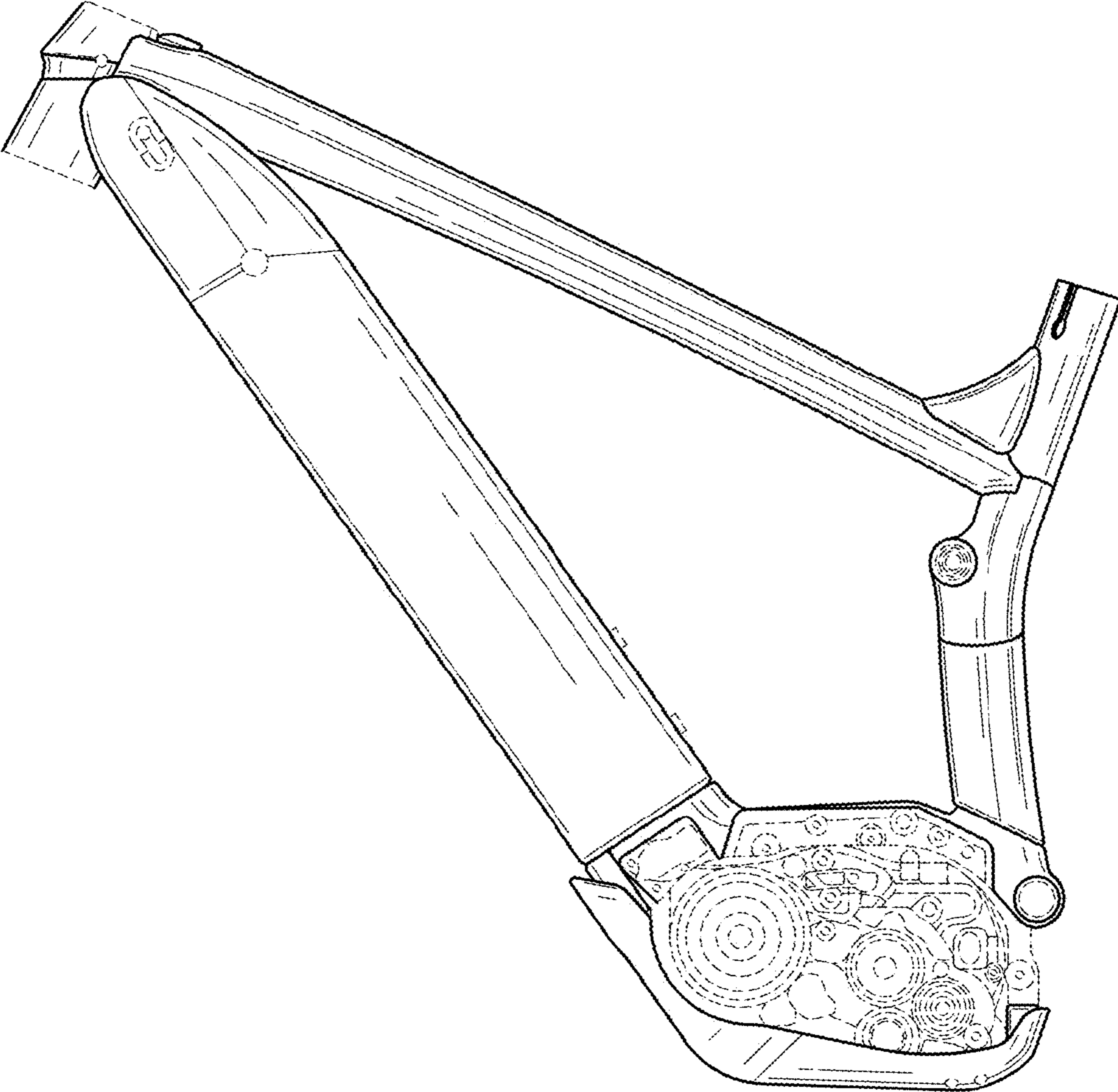

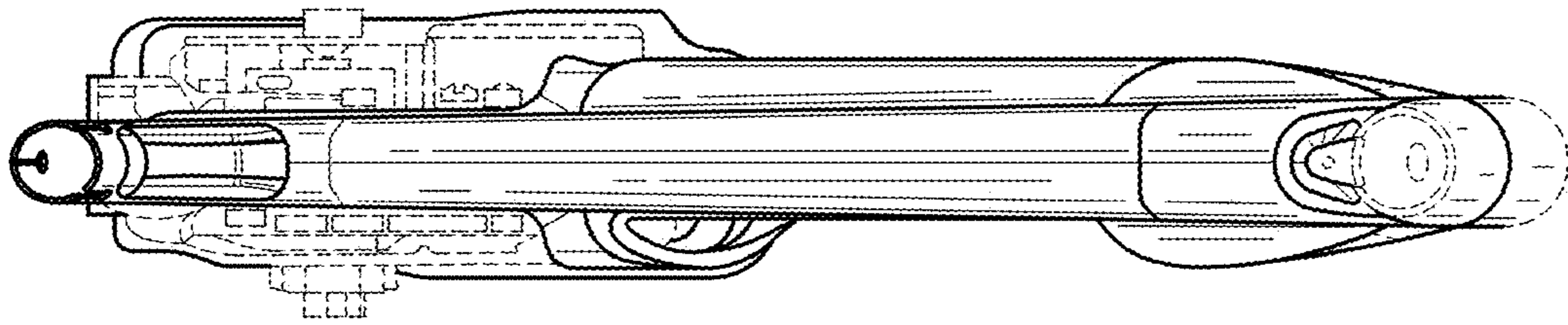

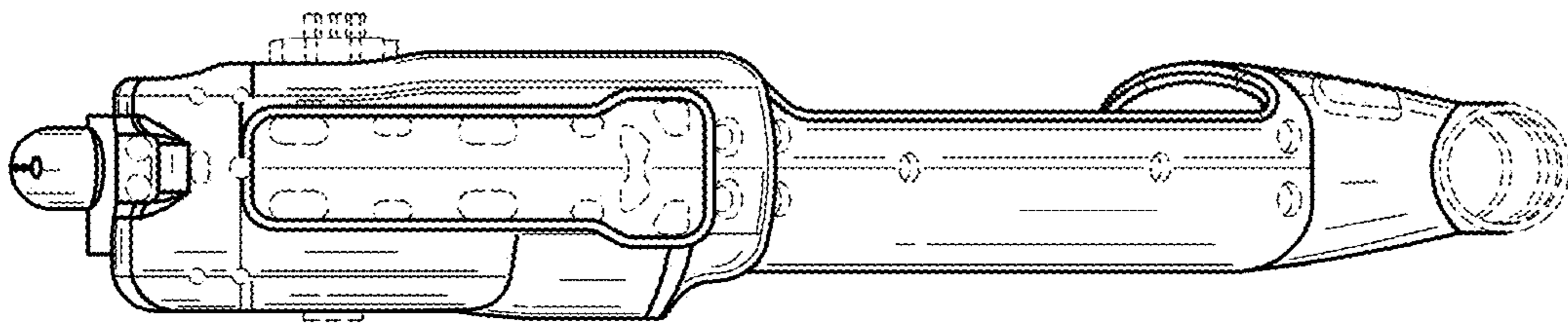

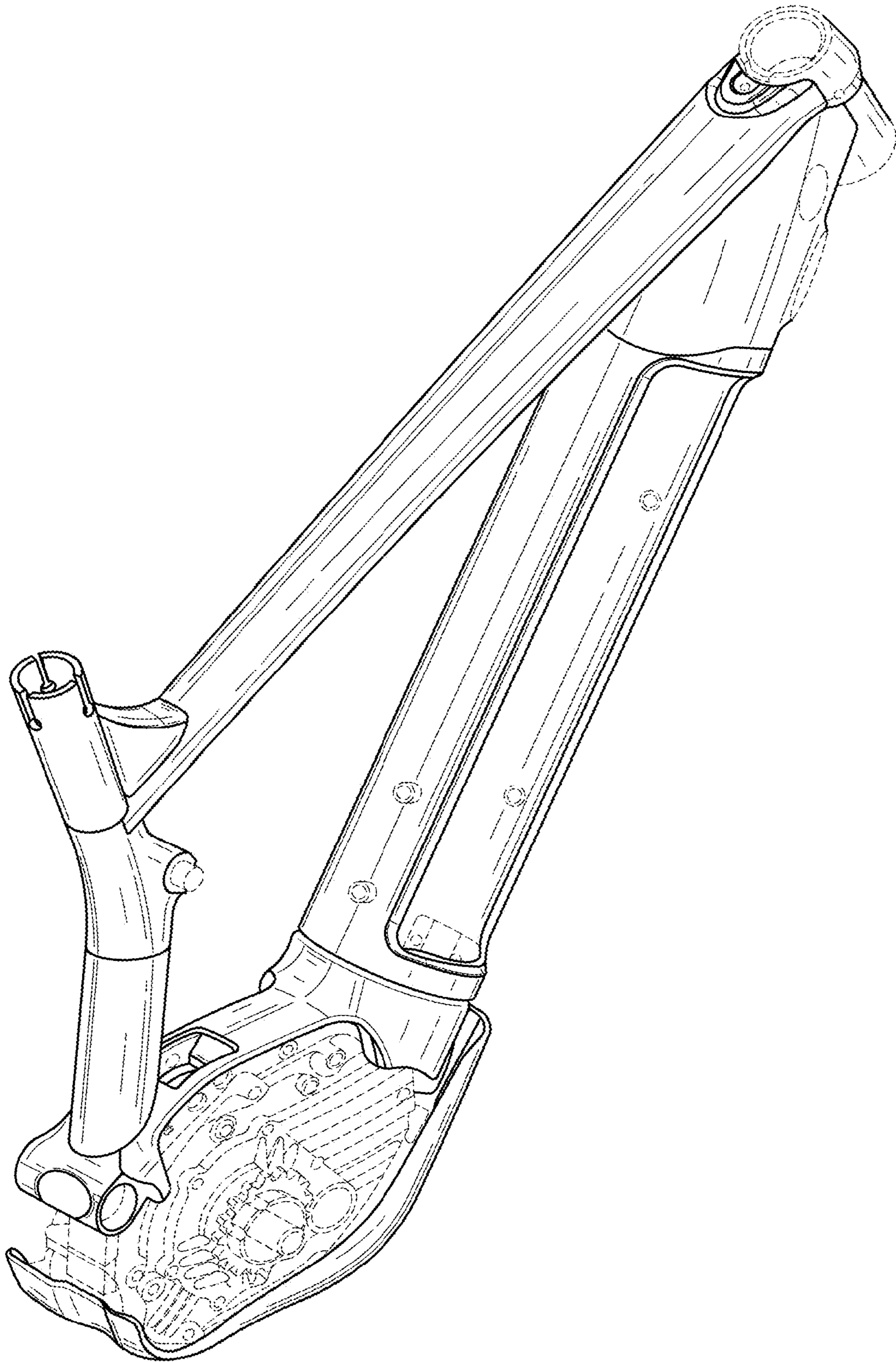

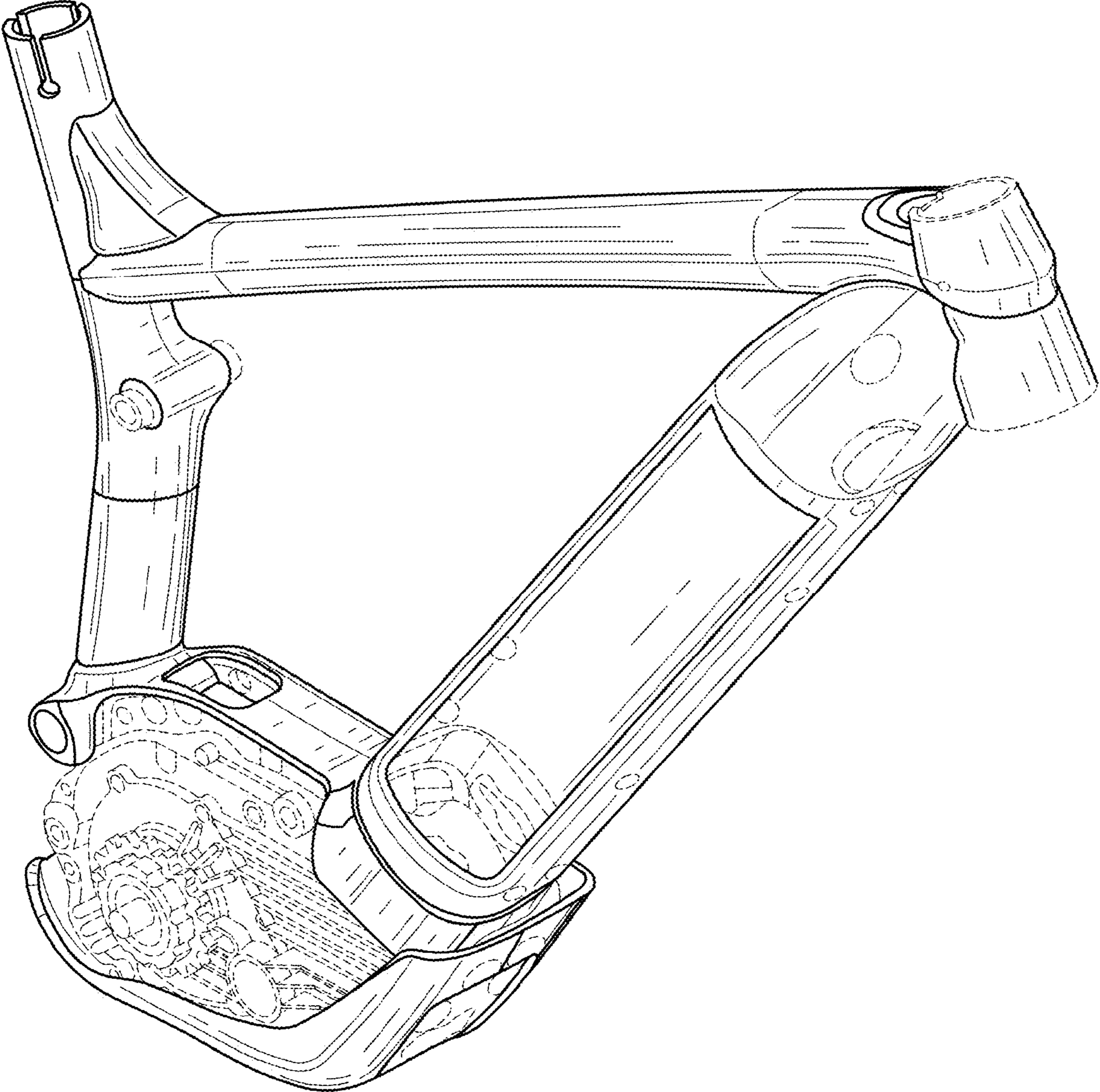

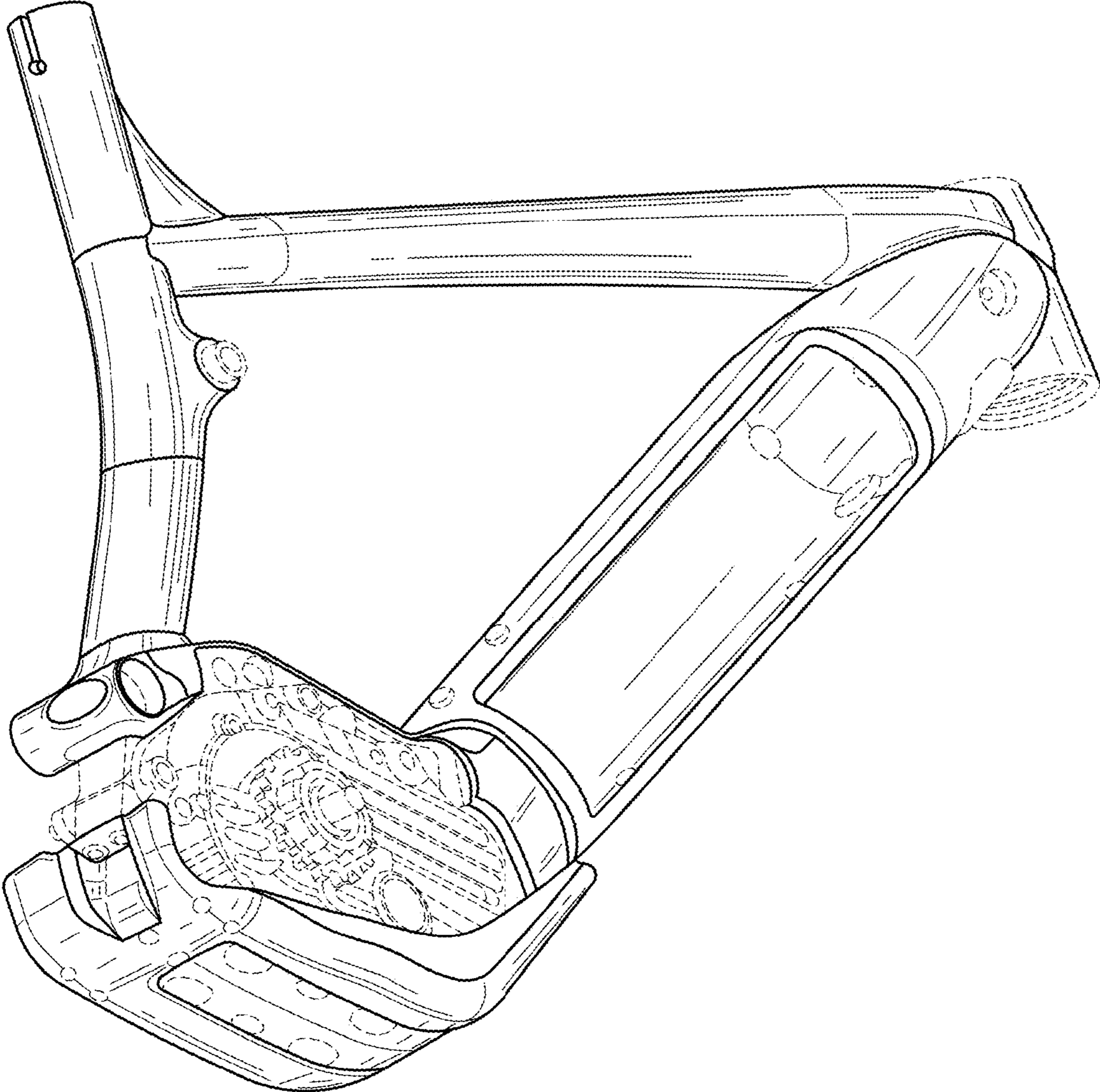

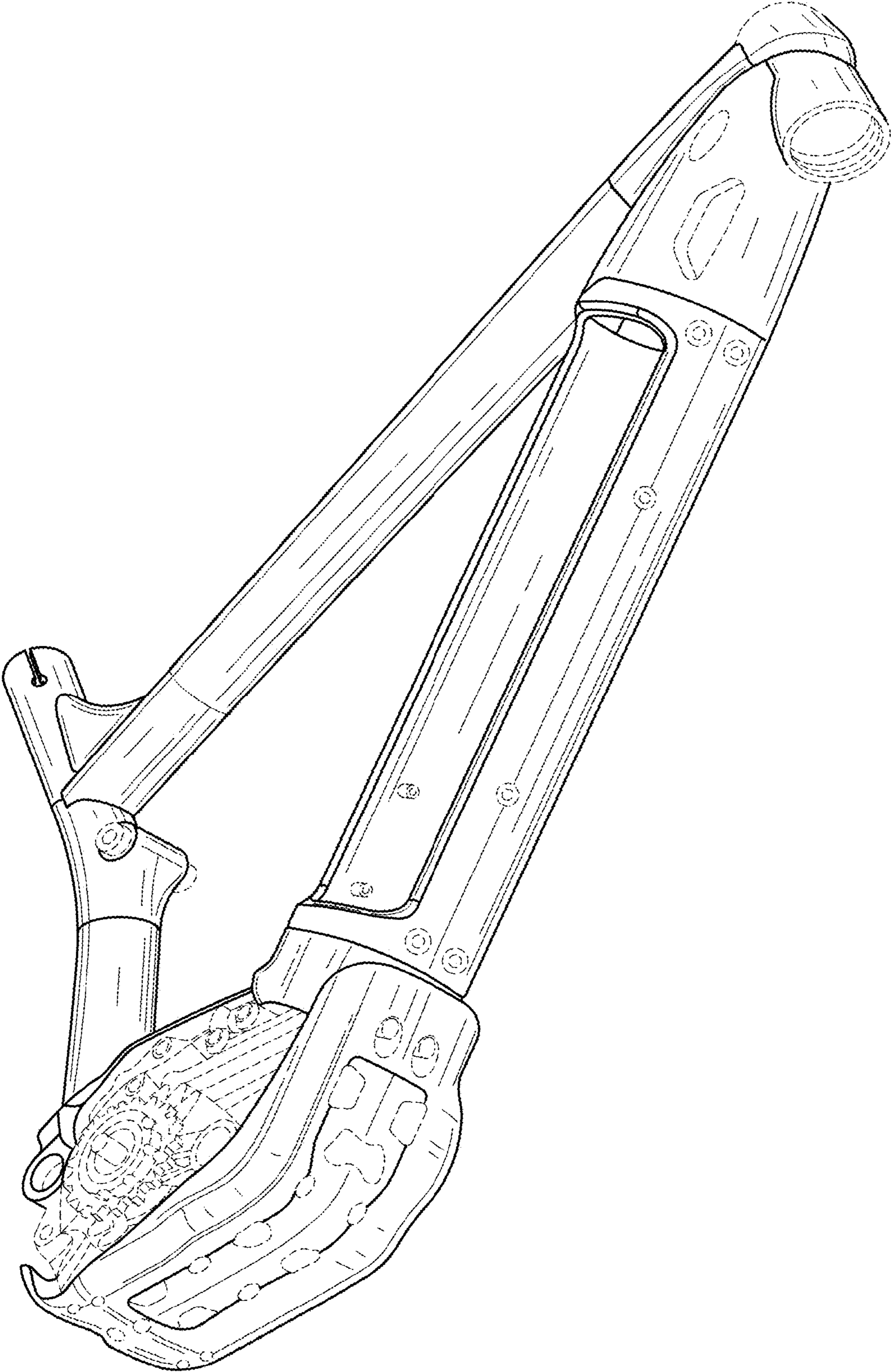

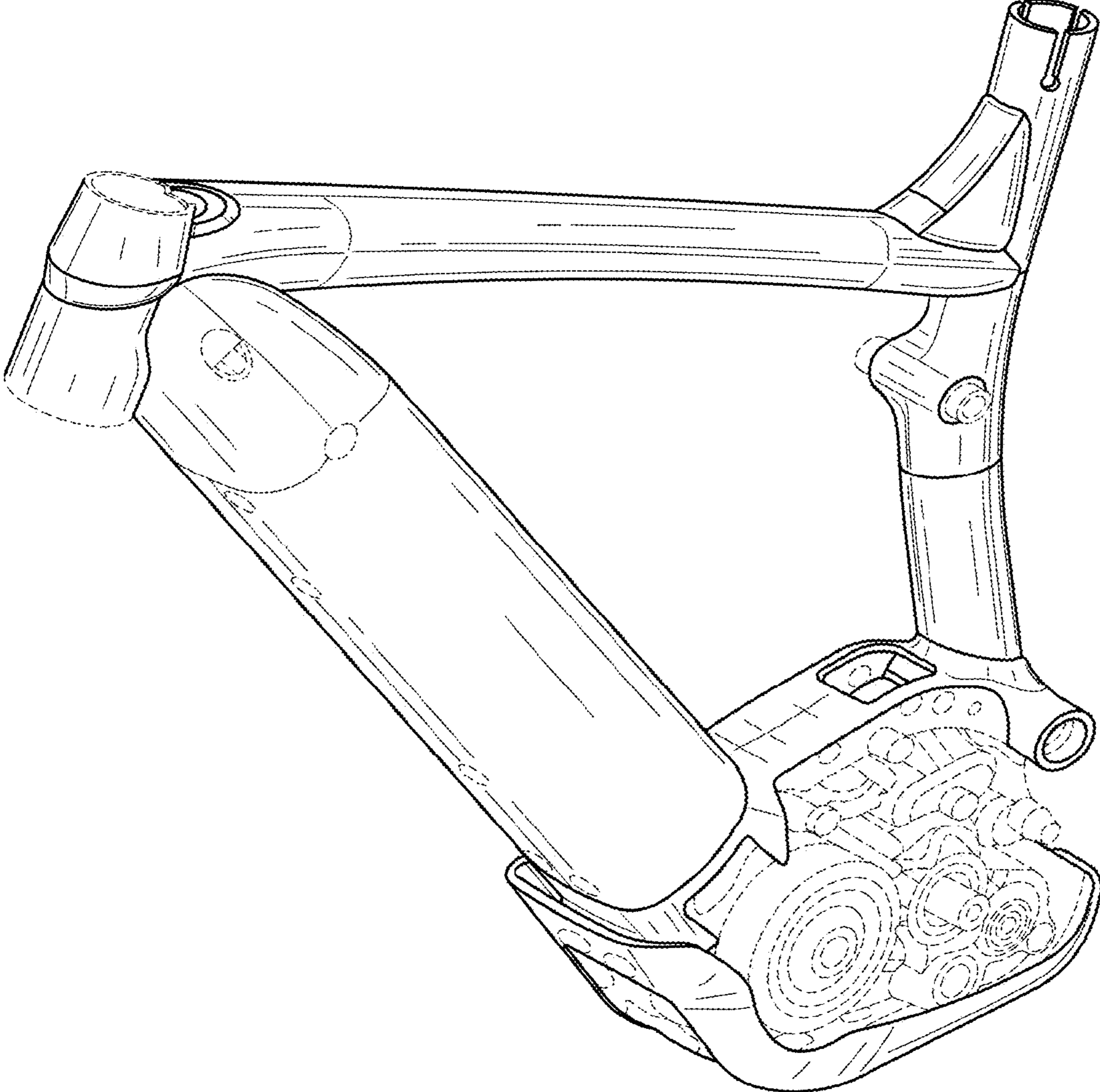

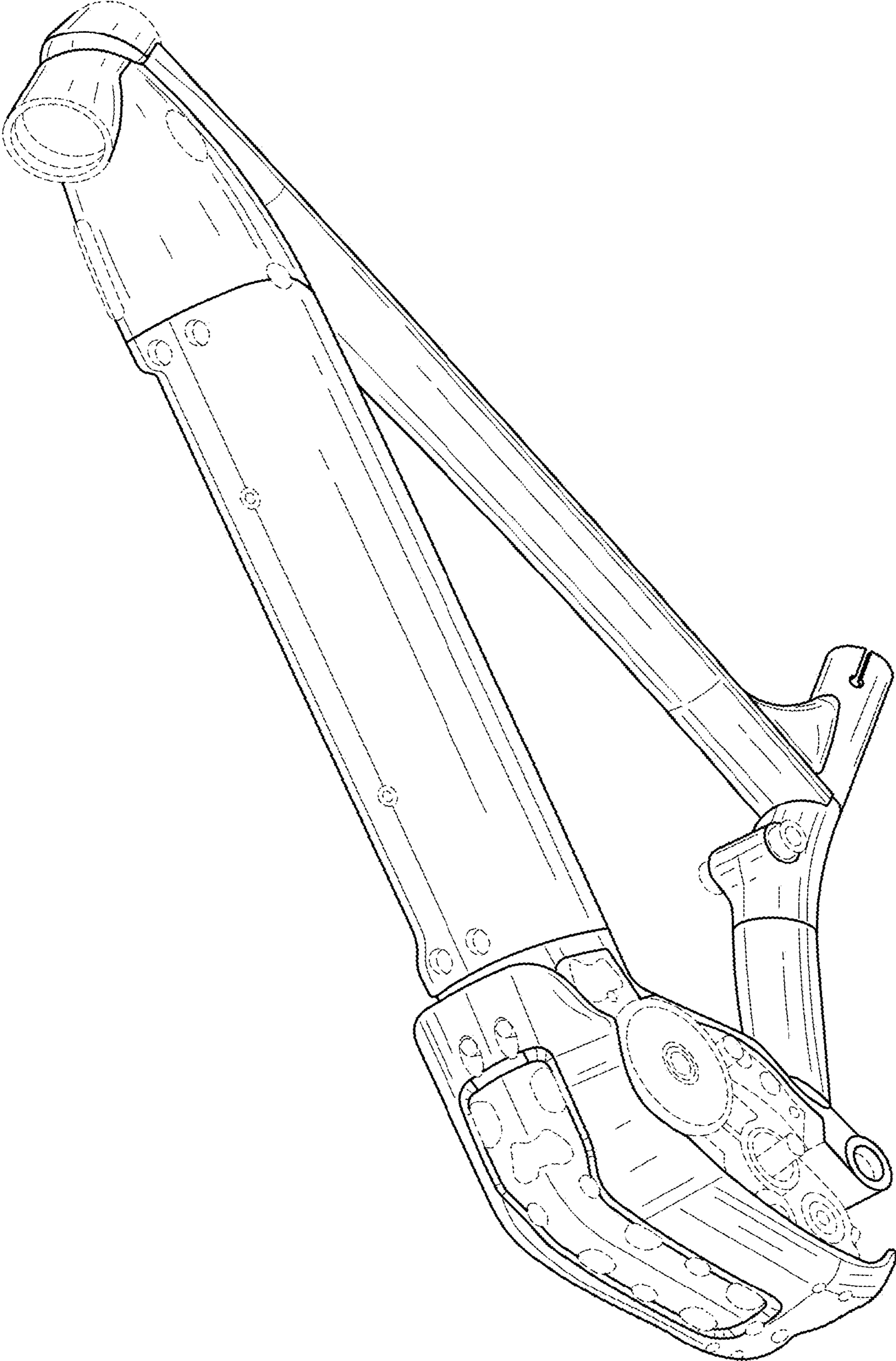

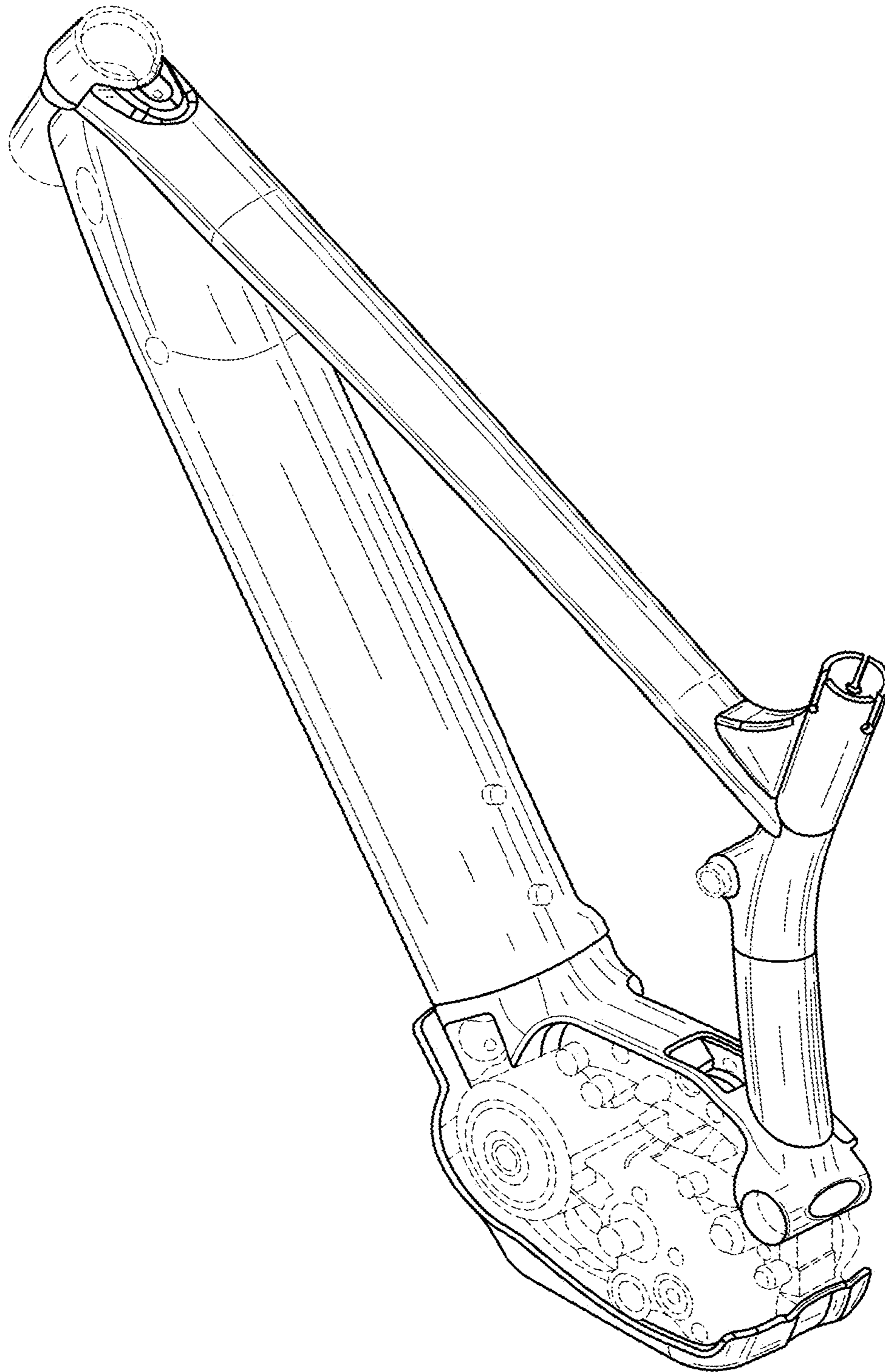

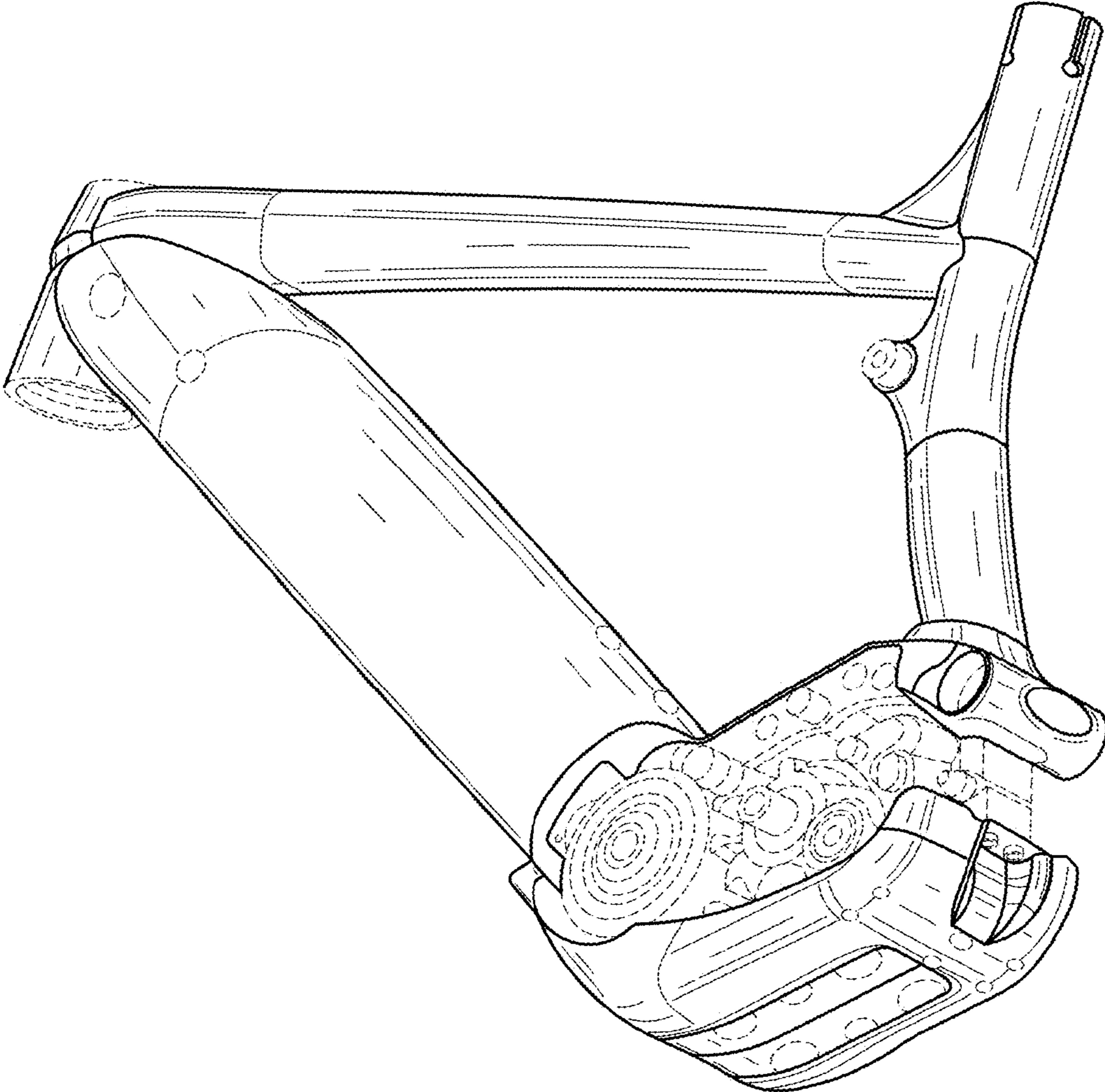
