FIG. 9 is a Top view of the tire as shown in FIG. 1.

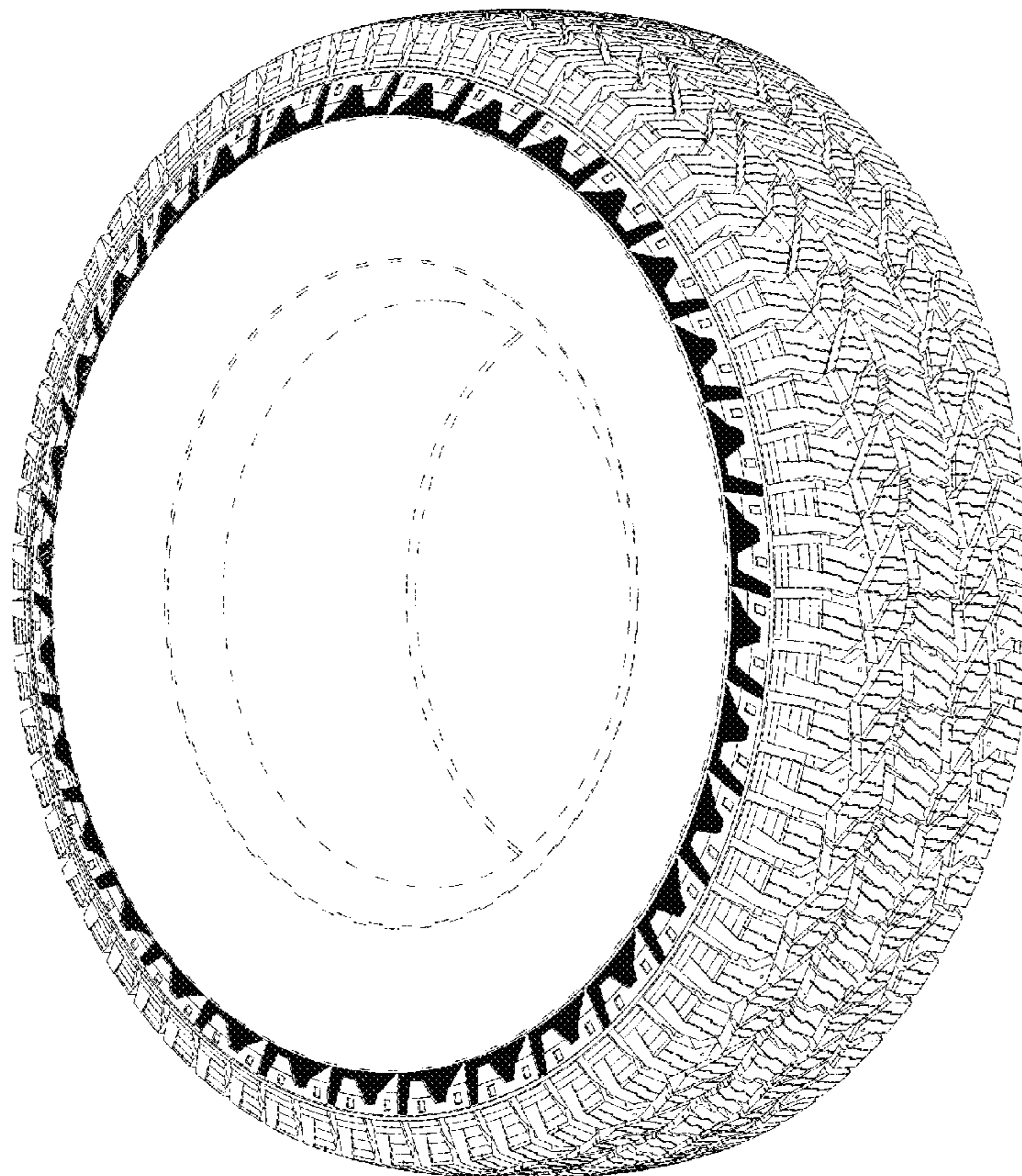

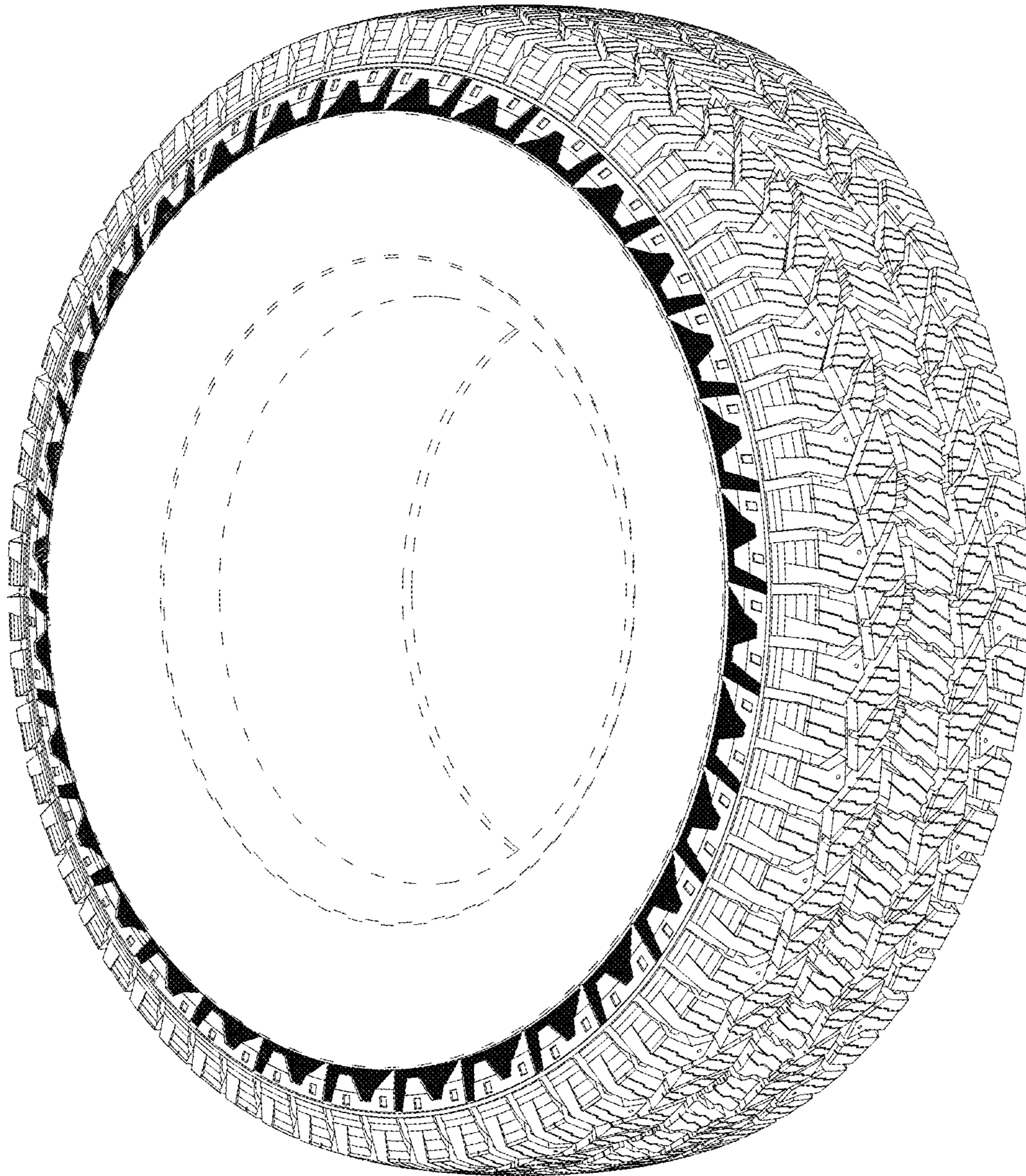

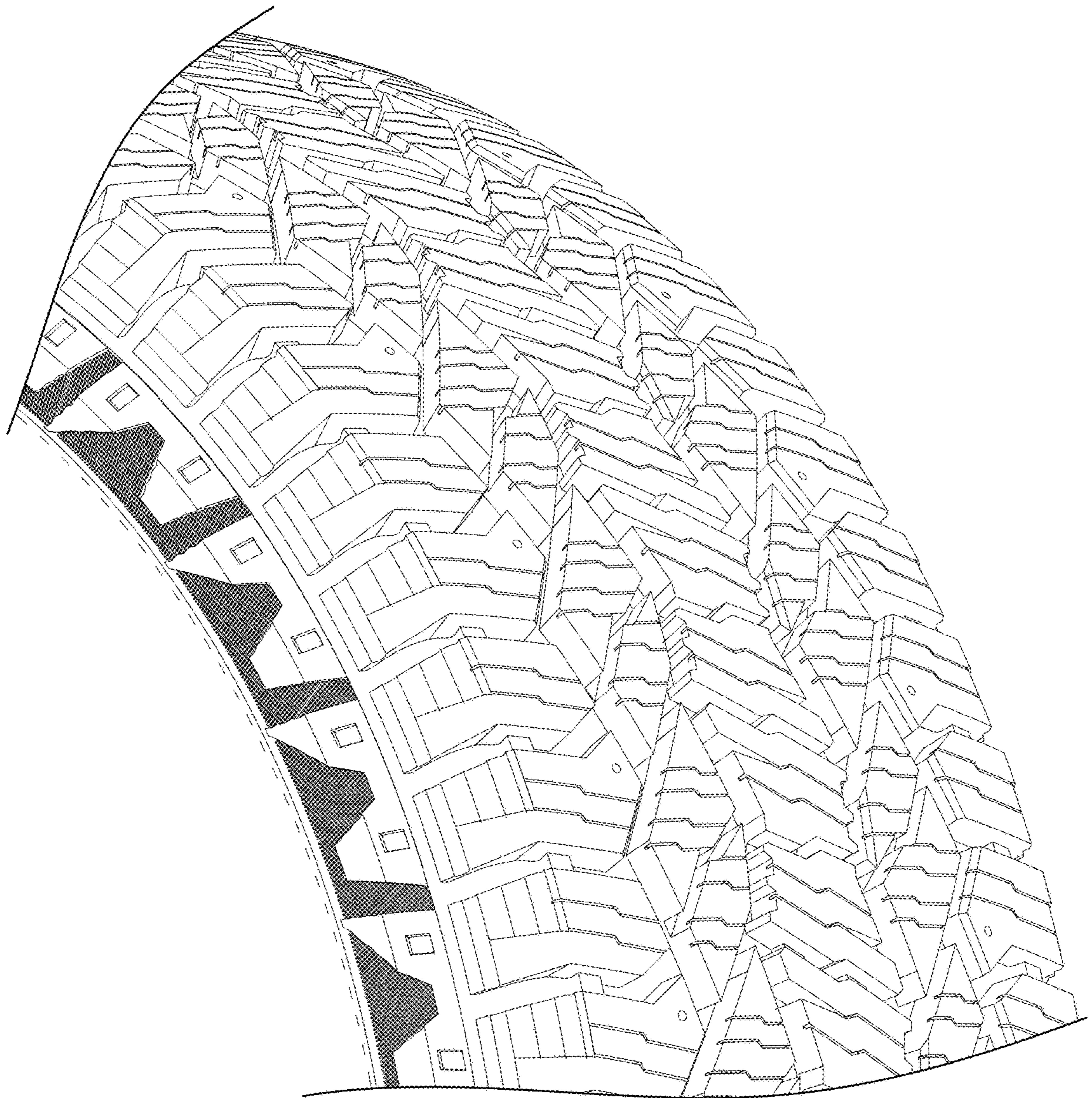

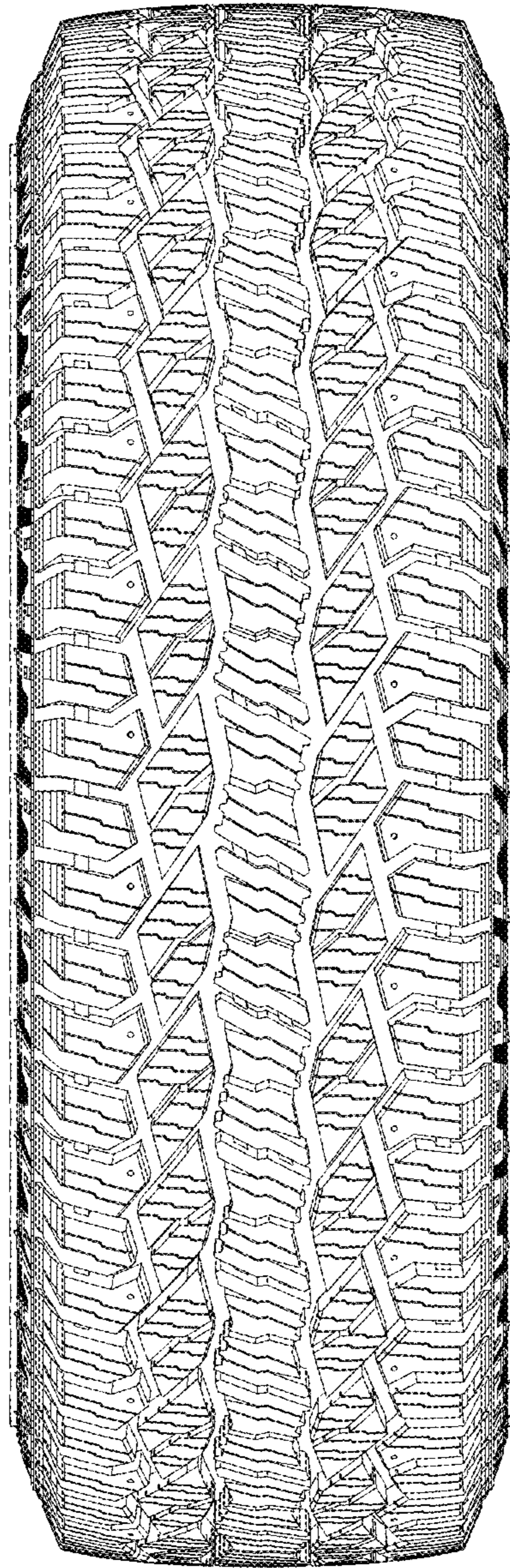

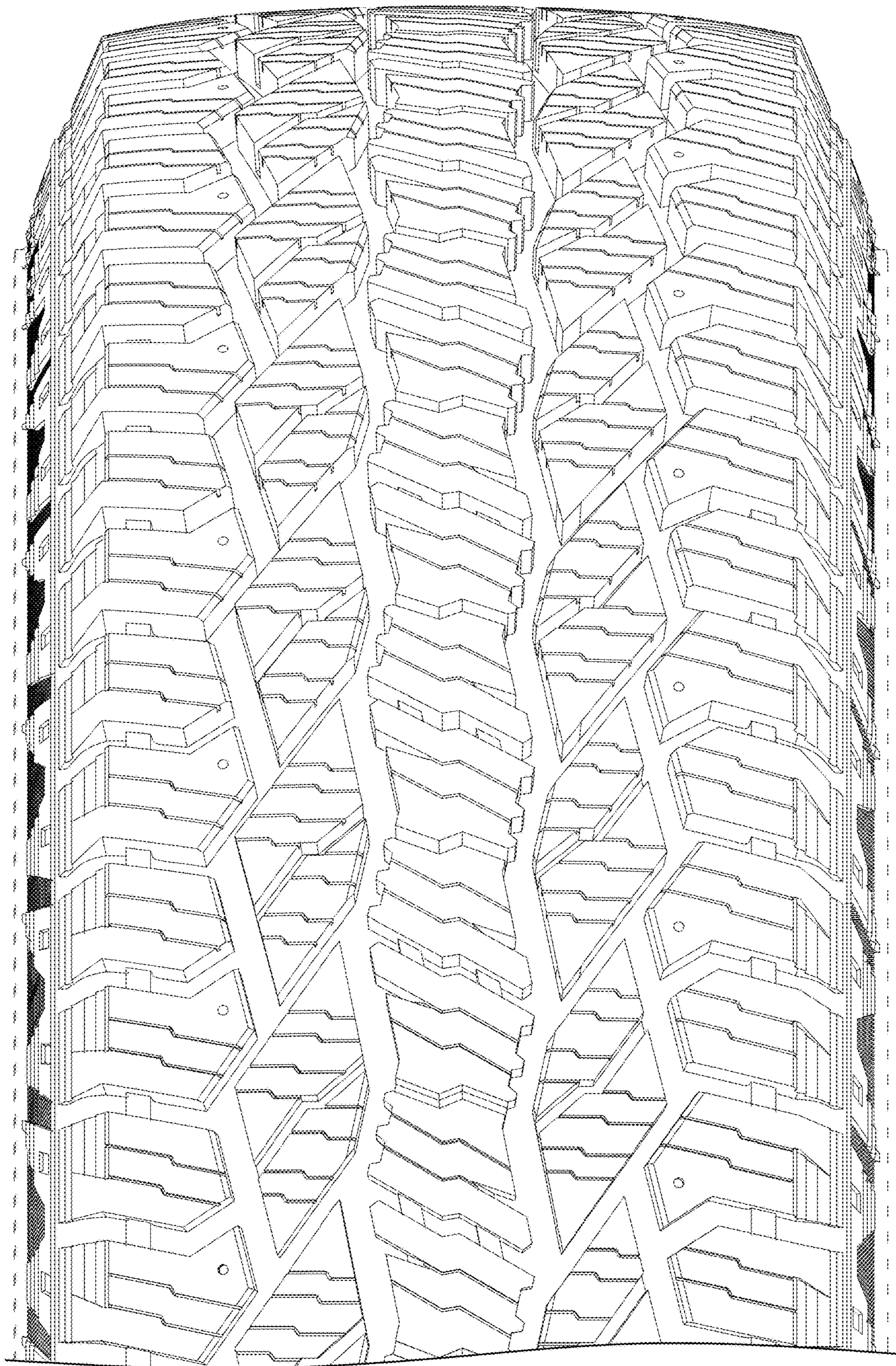

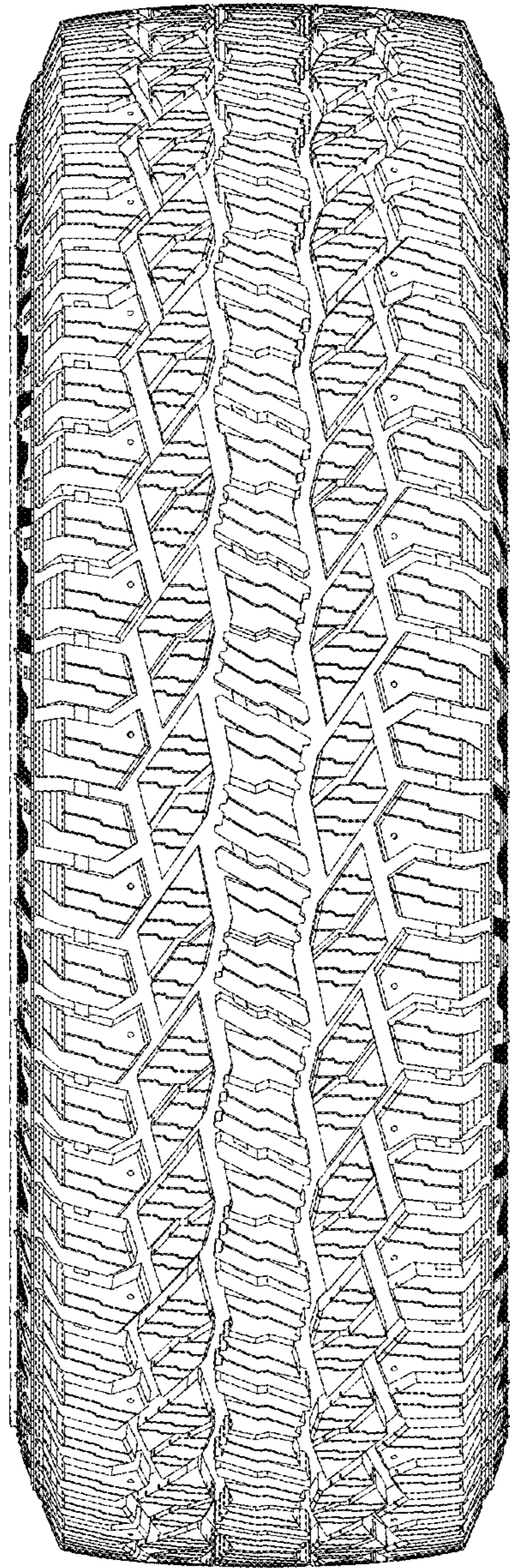

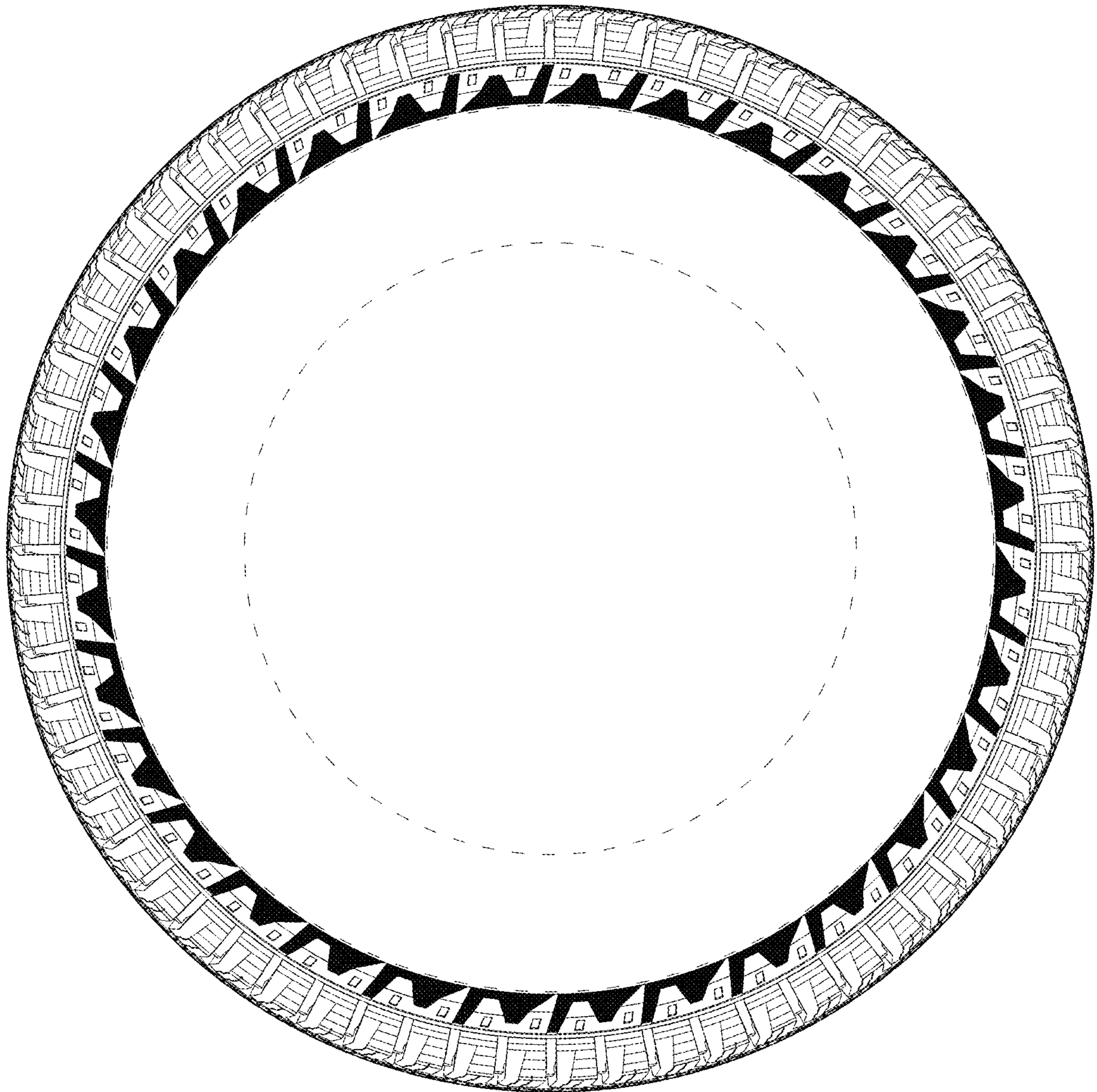

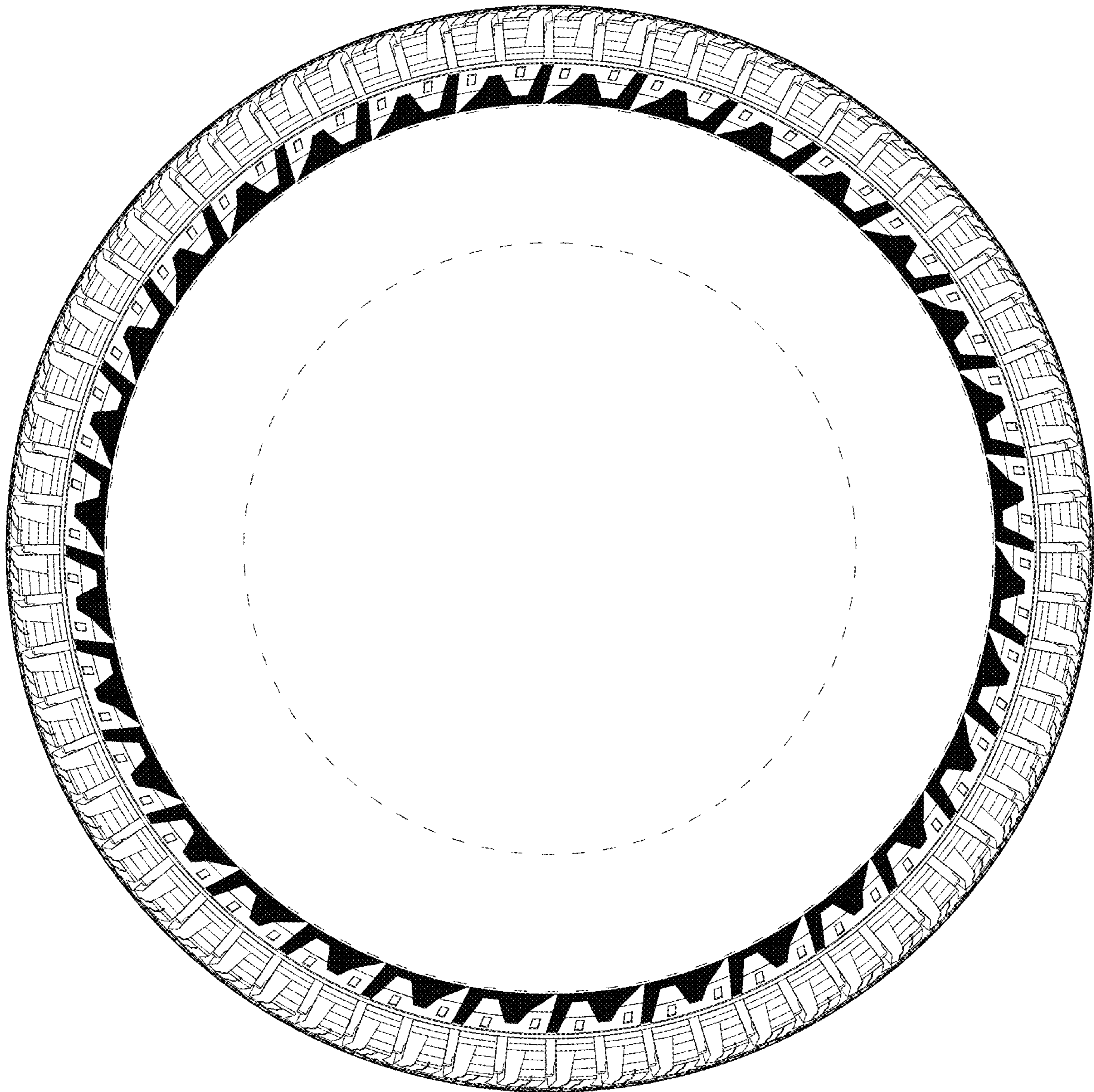

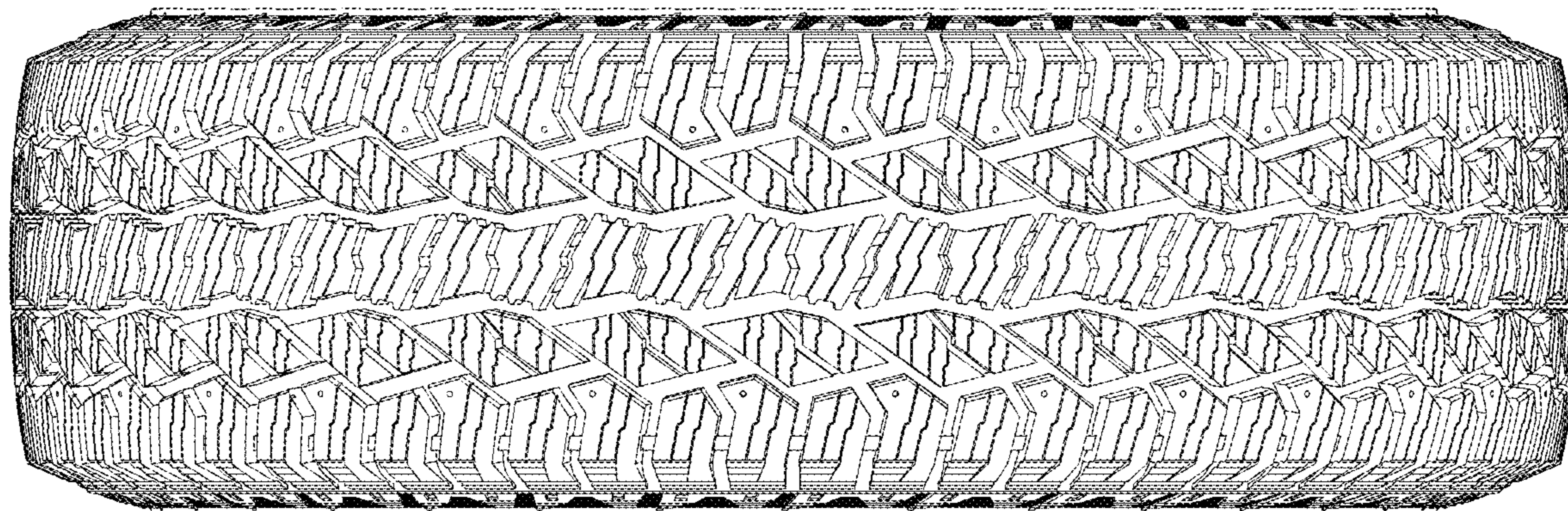

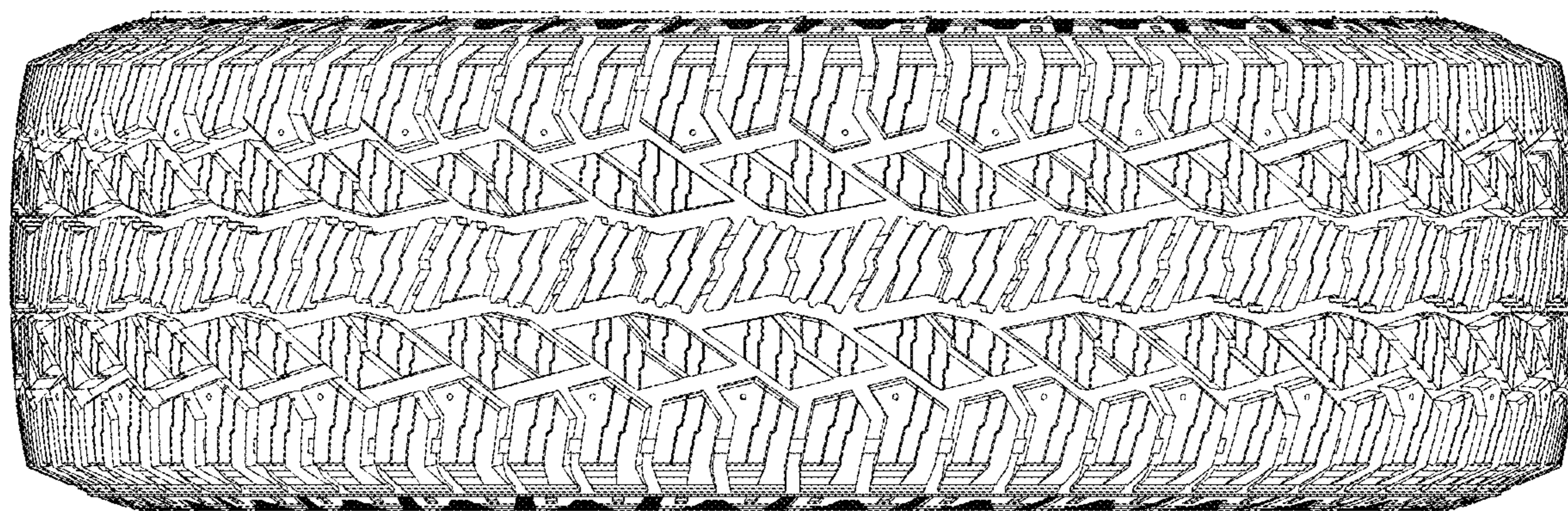
