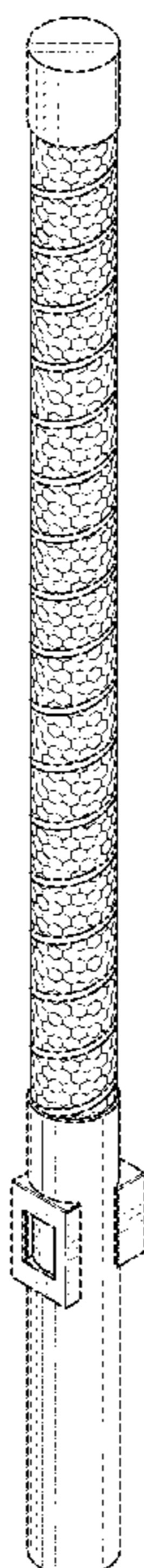
(57) **CLAIM**

as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of the electrical and cabling housing of the present invention;
 FIG. 2 is a front view thereof;
 FIG. 3 is a rear view thereof;
 FIG. 4 is a side view thereof, as seen from the left side of FIG. 2;
 FIG. 5 is a side view thereof, as seen from the right side of FIG. 2;

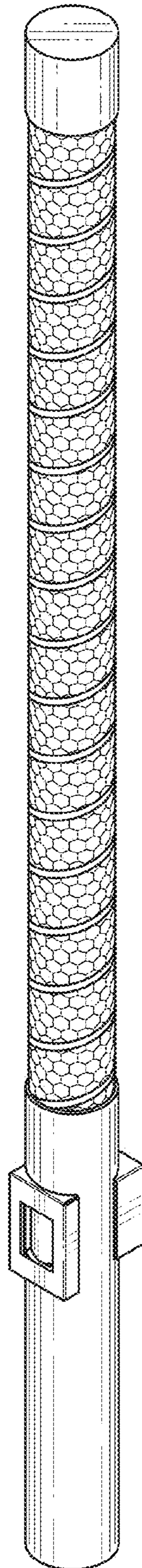

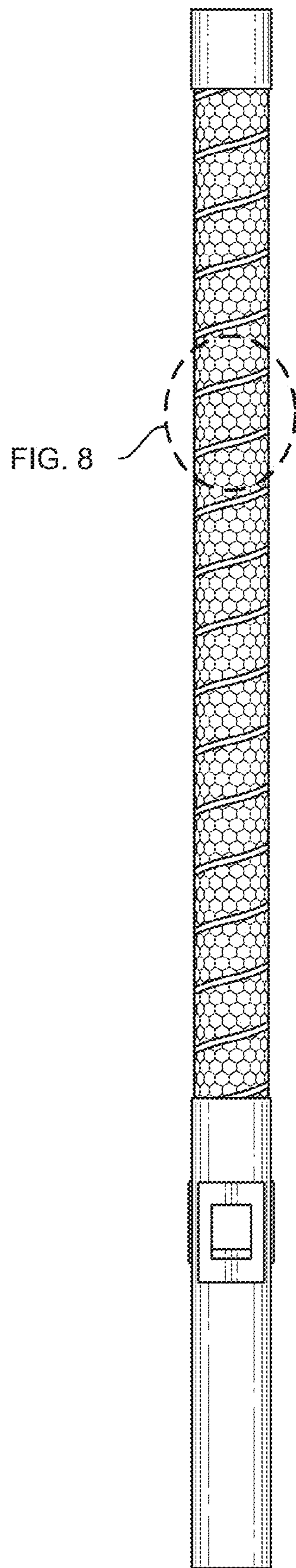

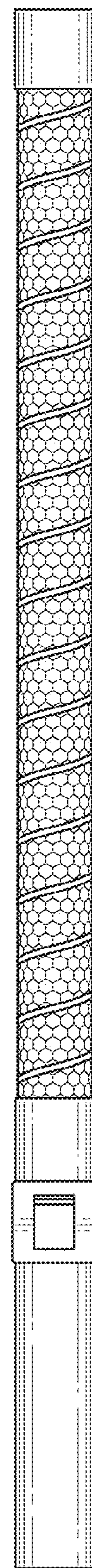

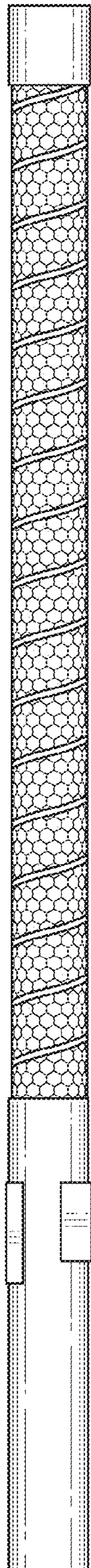

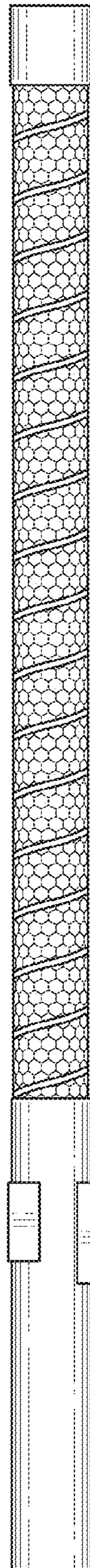

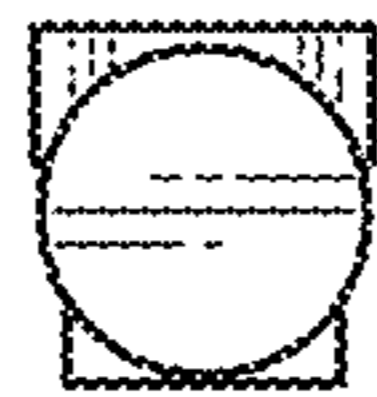

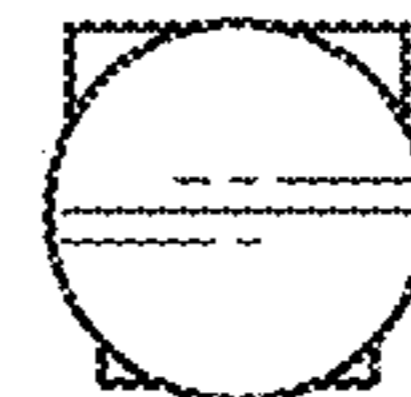

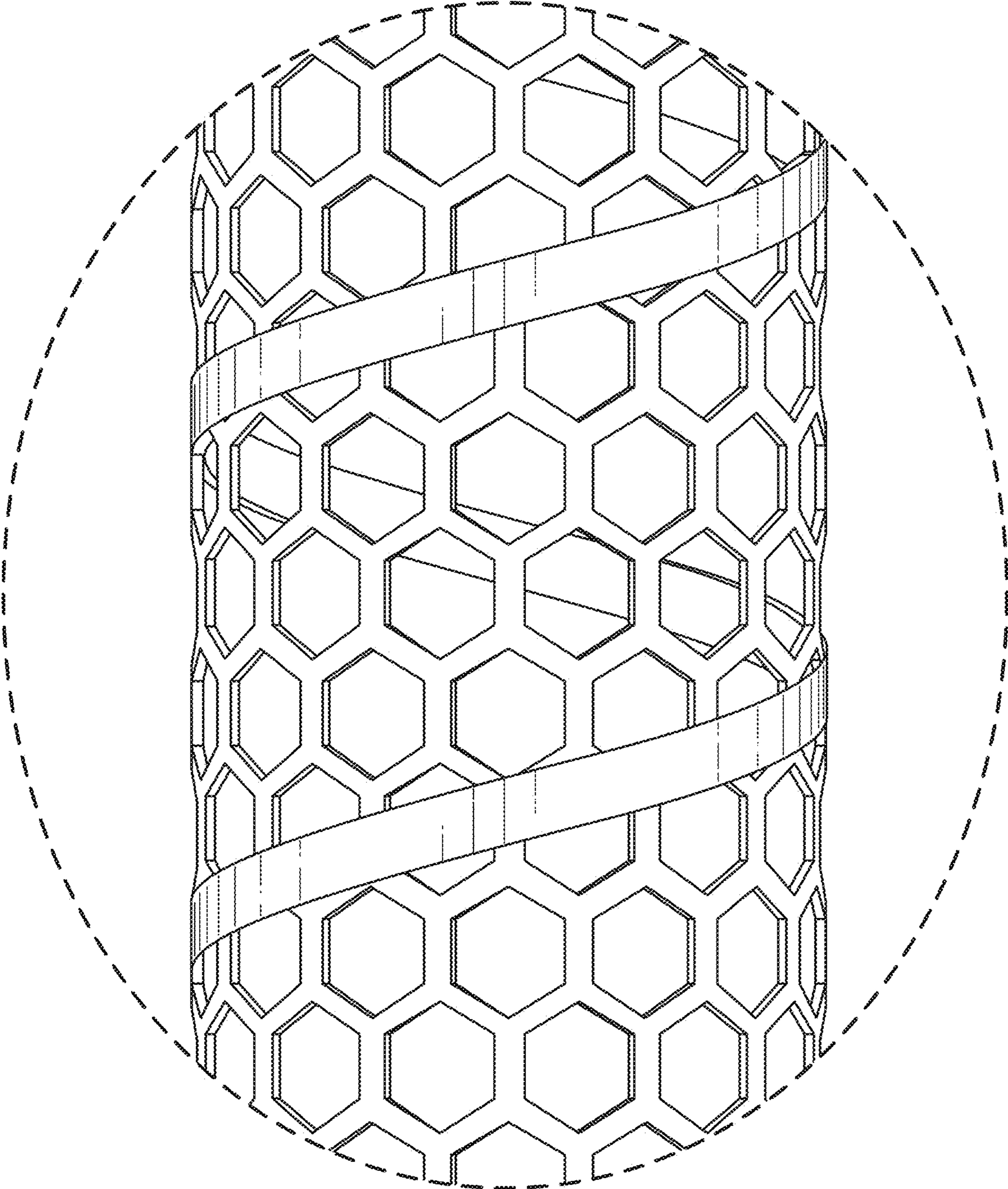
