FIG. 5 is a left side view of the user interface.

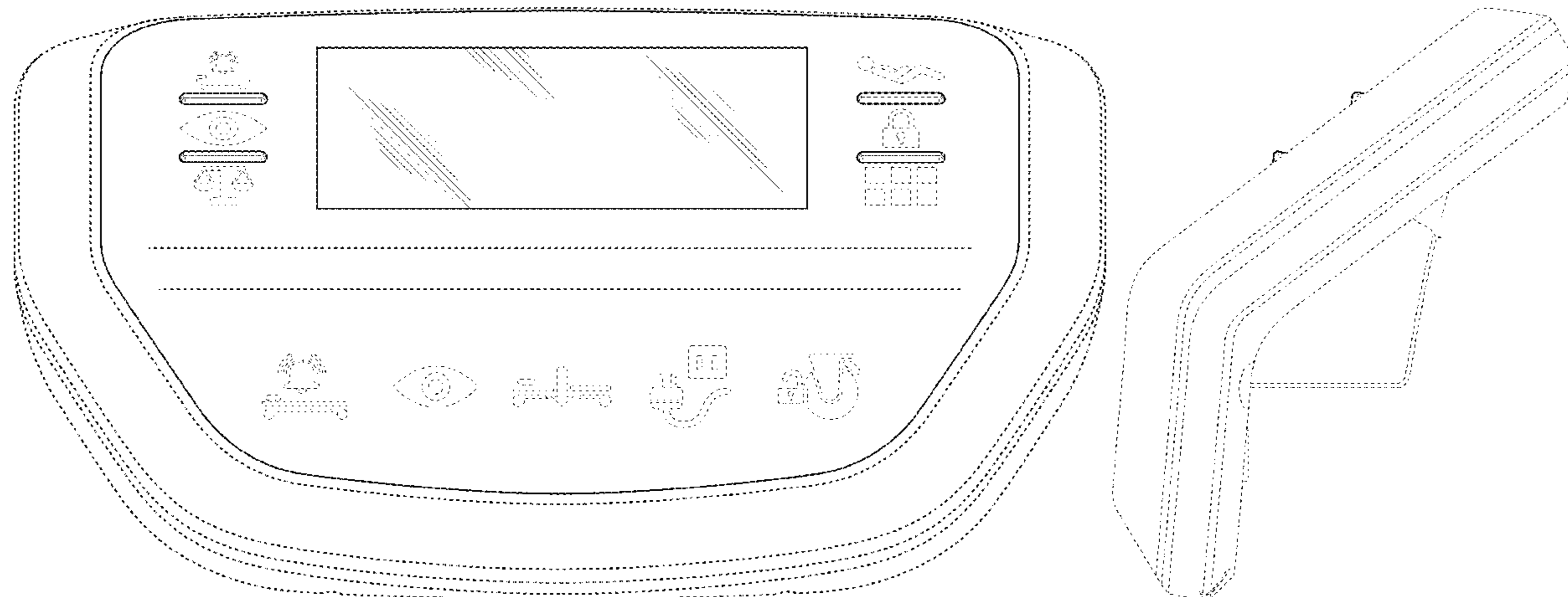
FIG. 6 is a top back perspective view of the user interface.

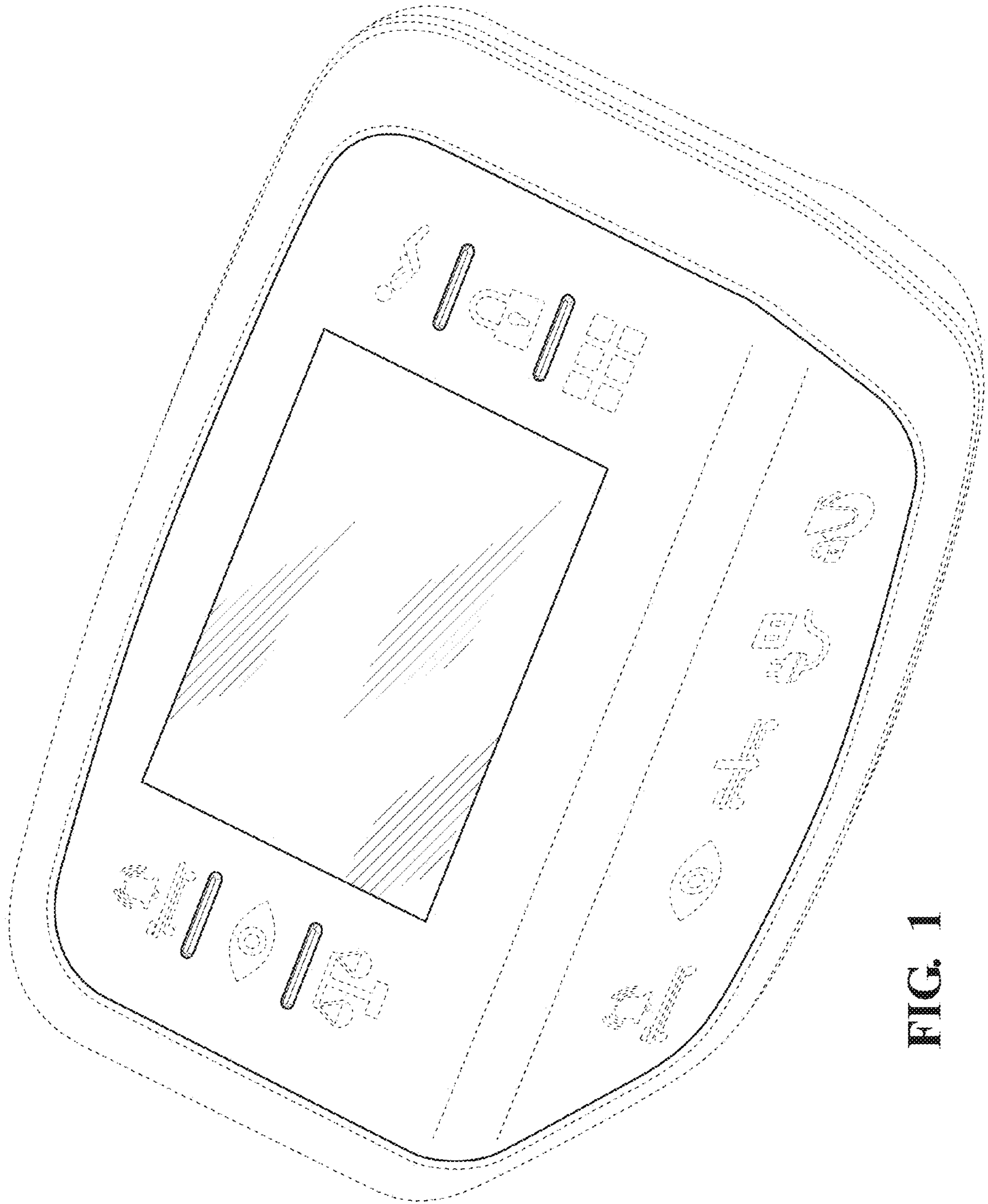

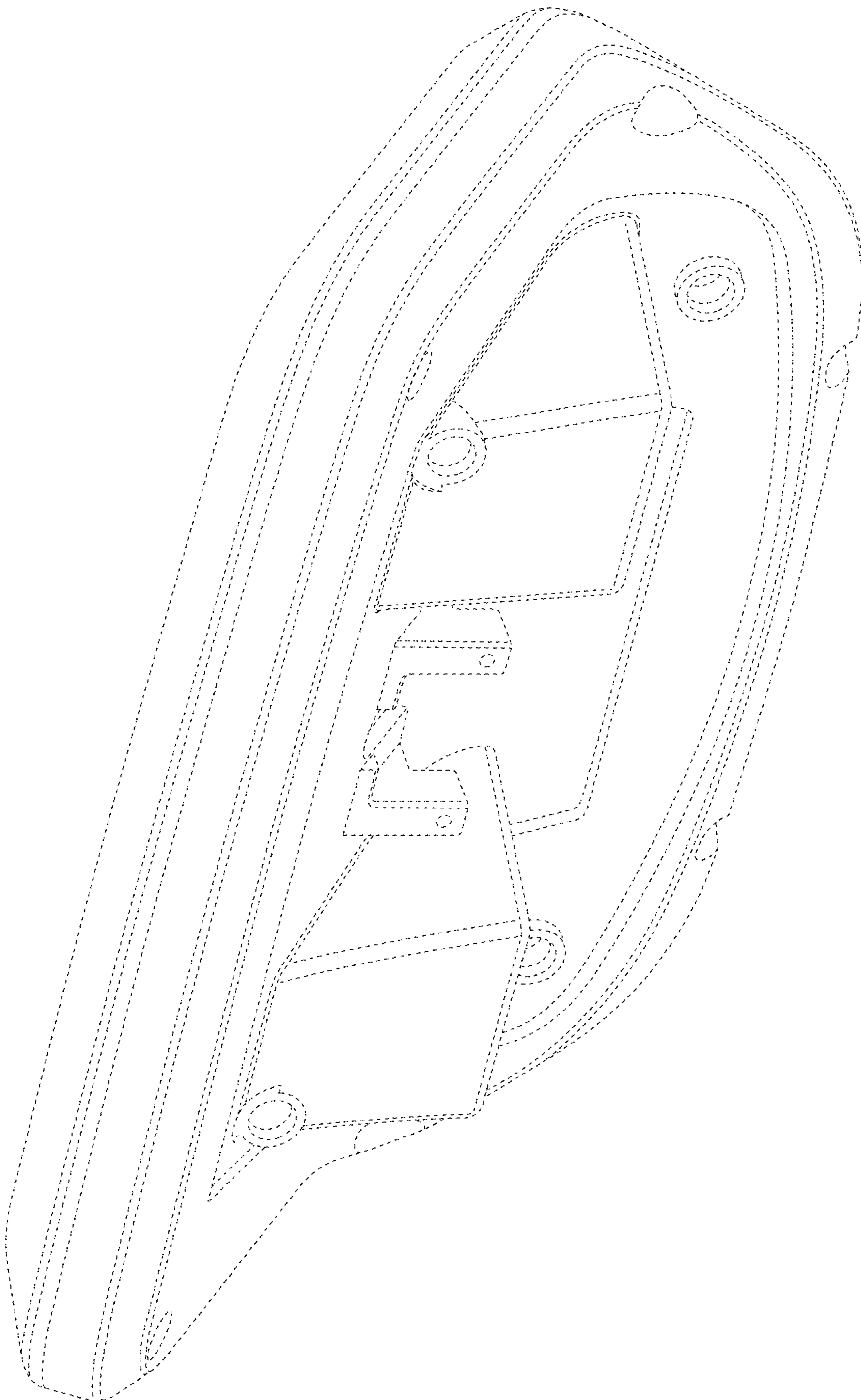

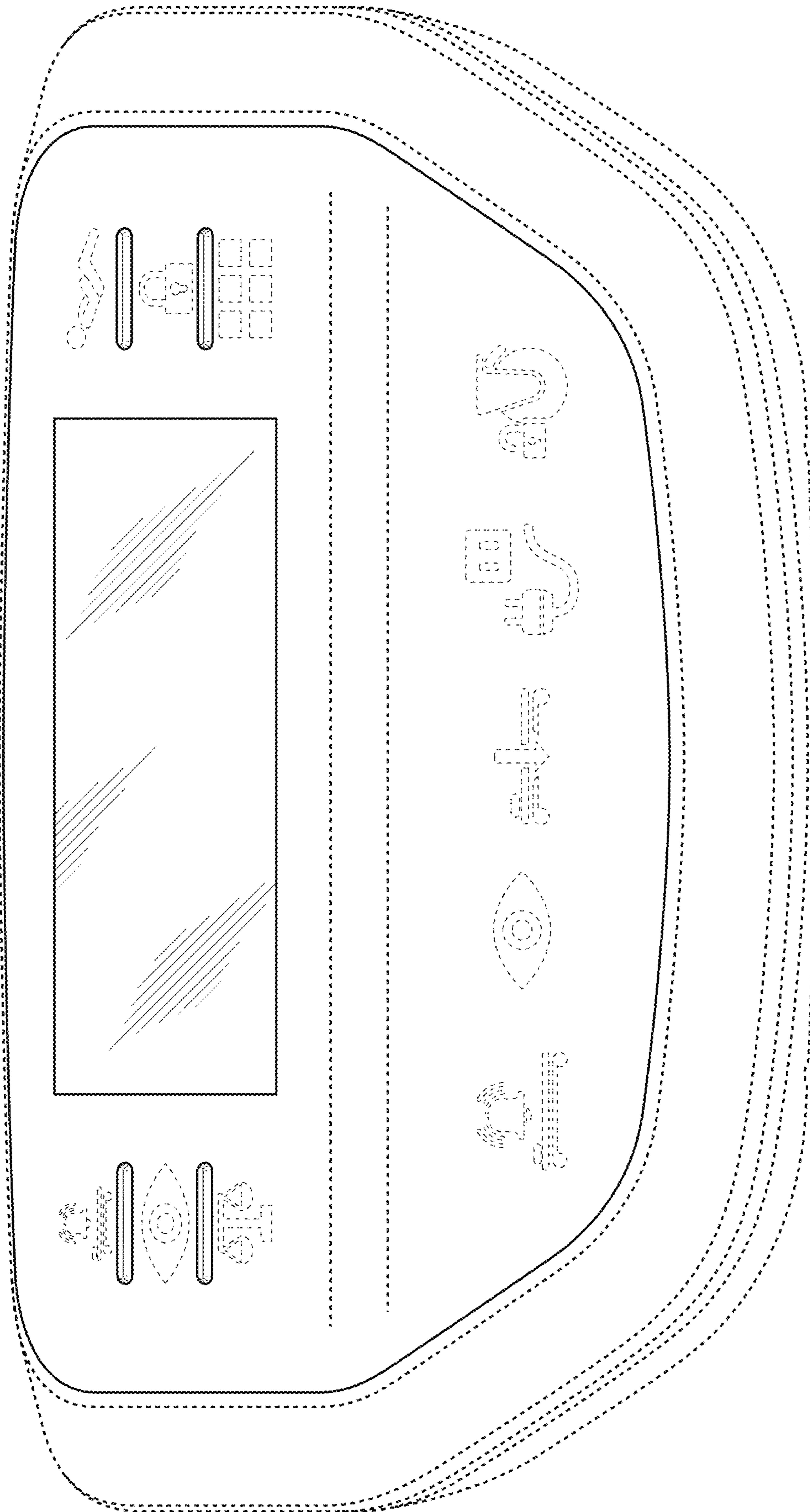

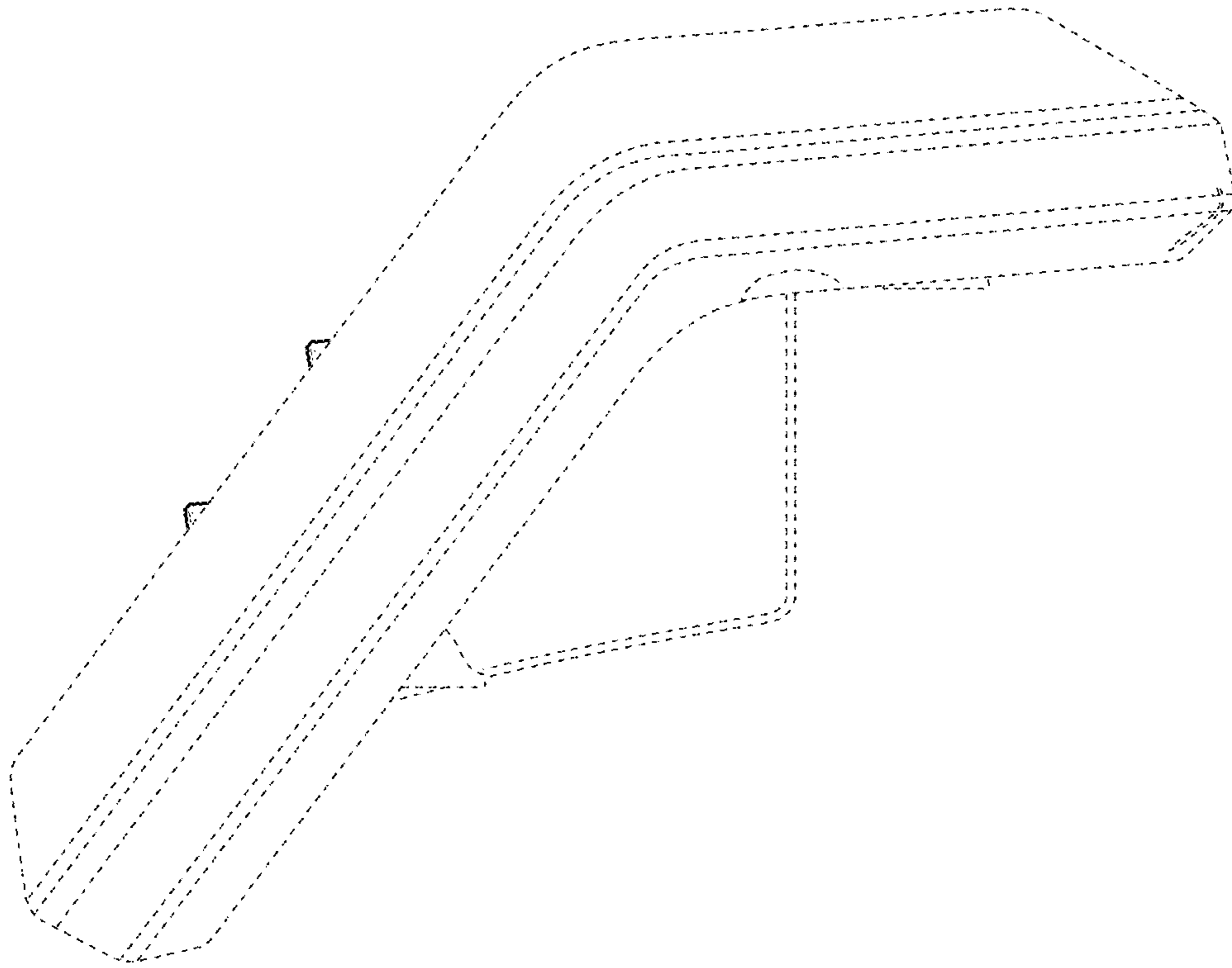

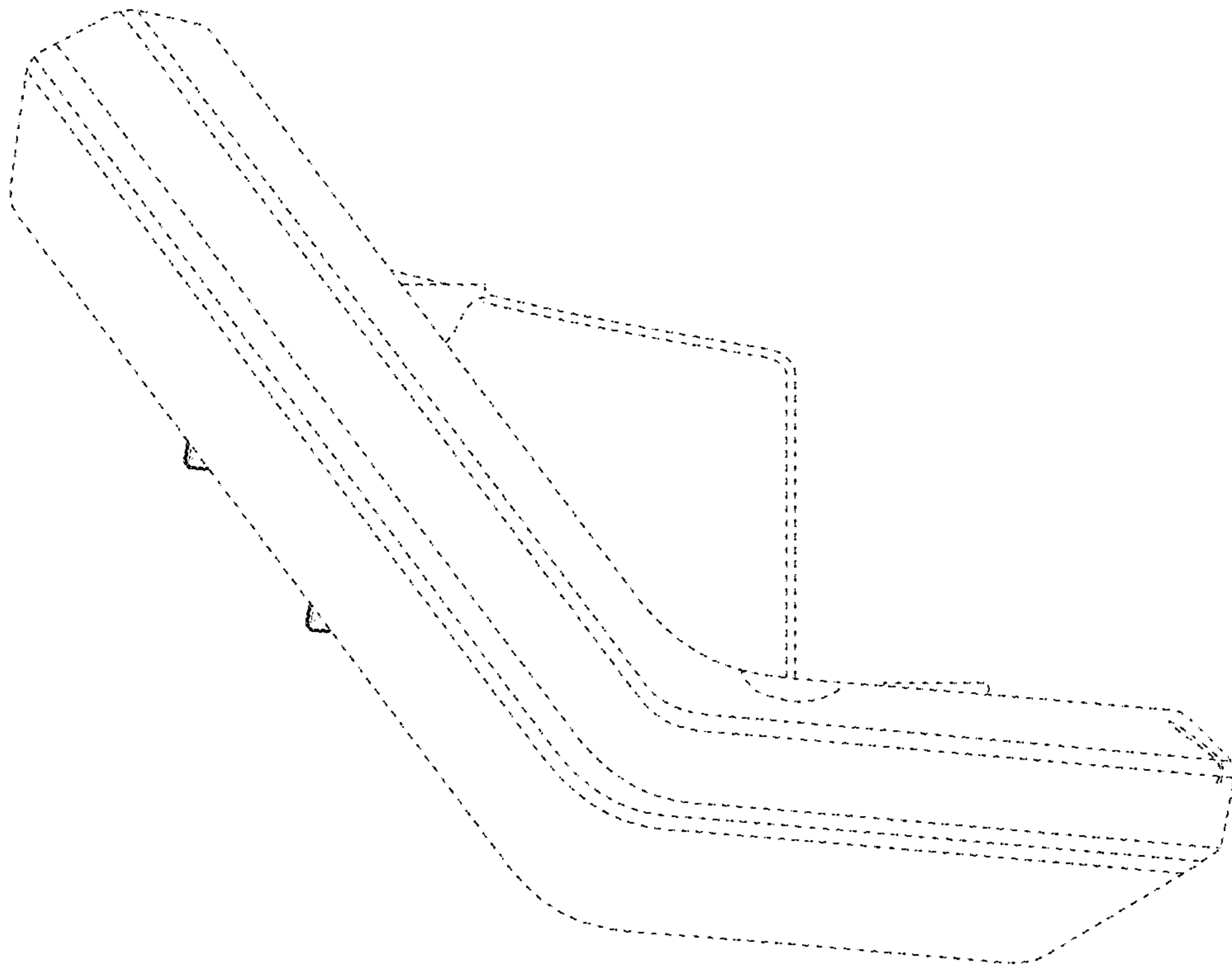

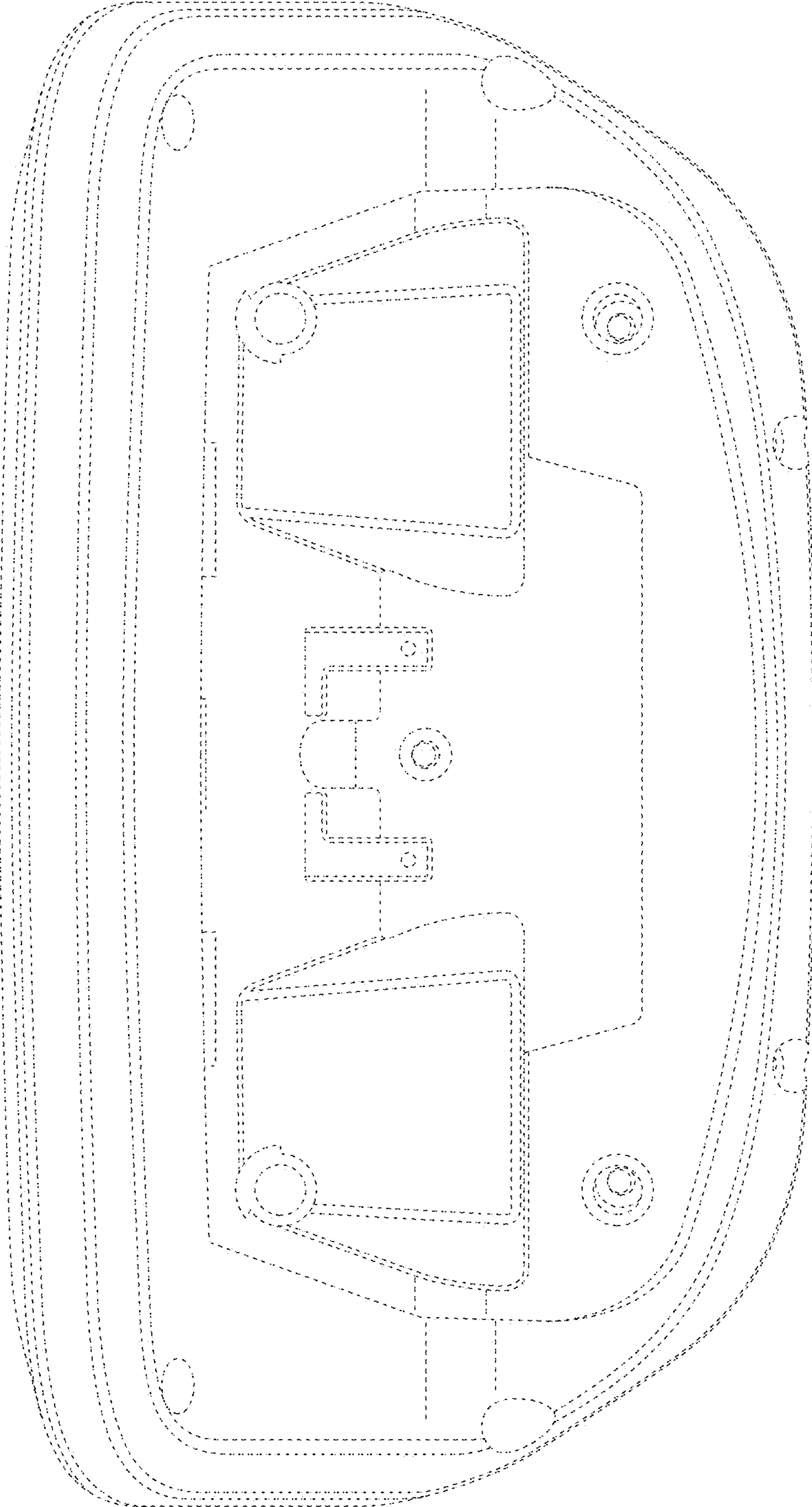

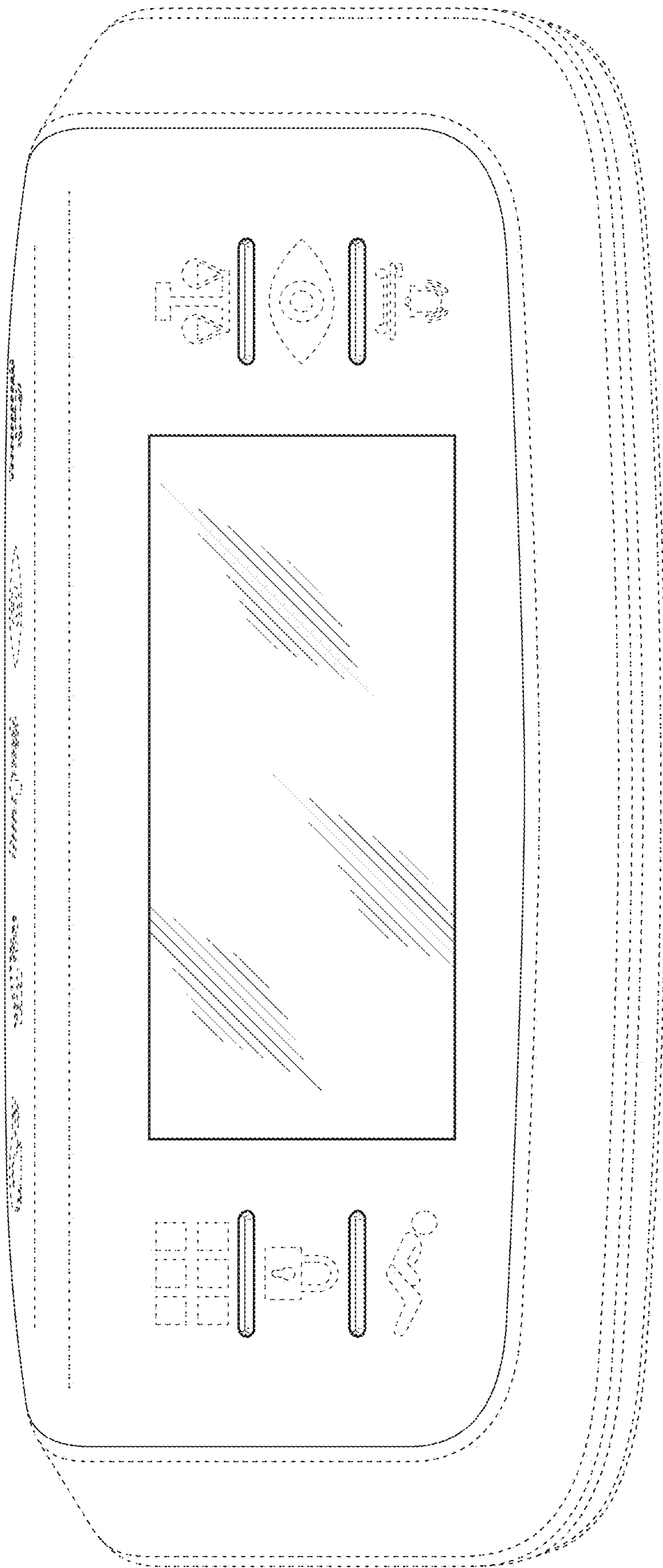

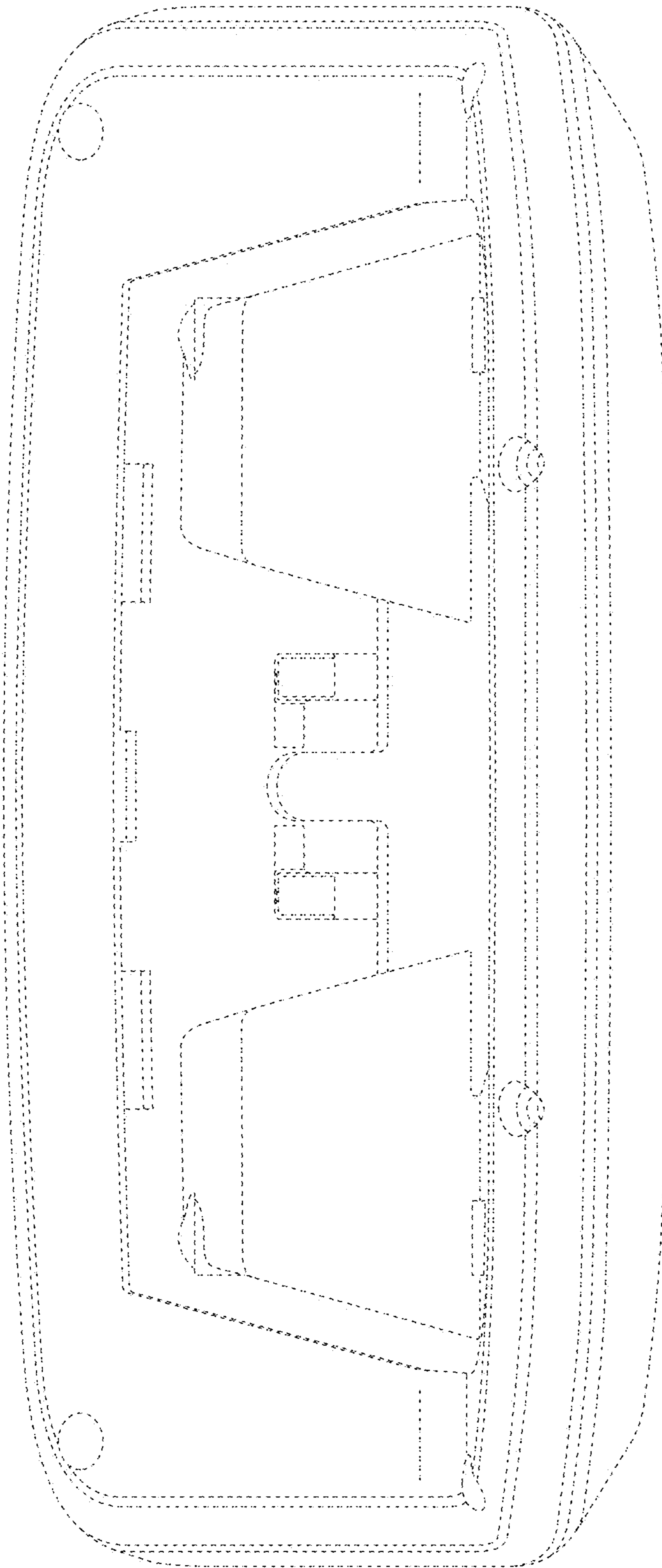
