(57) **CLAIM**

The ornamental design for an earbud headset, as shown and described.

**DESCRIPTION**

FIG. 1 is a back right perspective view of an earbud headset (including a left earbud shown on the left and a right earbud shown on the right) showing a first embodiment of our new design;

FIG. 2 is a back left perspective view of the earbud headset shown in FIG. 1 (with the left earbud shown on the left and the right earbud shown on the right);

FIG. 3 is a front view of the earbud headset shown in FIG. 1 (with the left earbud shown on the right and the right earbud shown on the left);

FIG. 4 is a back view of the earbud headset shown in FIG. 1 (with the right earbud shown on the right and the left earbud shown on the left);

FIG. 5 is a left side view of the earbud headset shown in FIG. 1 (with the right earbud shown on the left and the left earbud shown on the right);

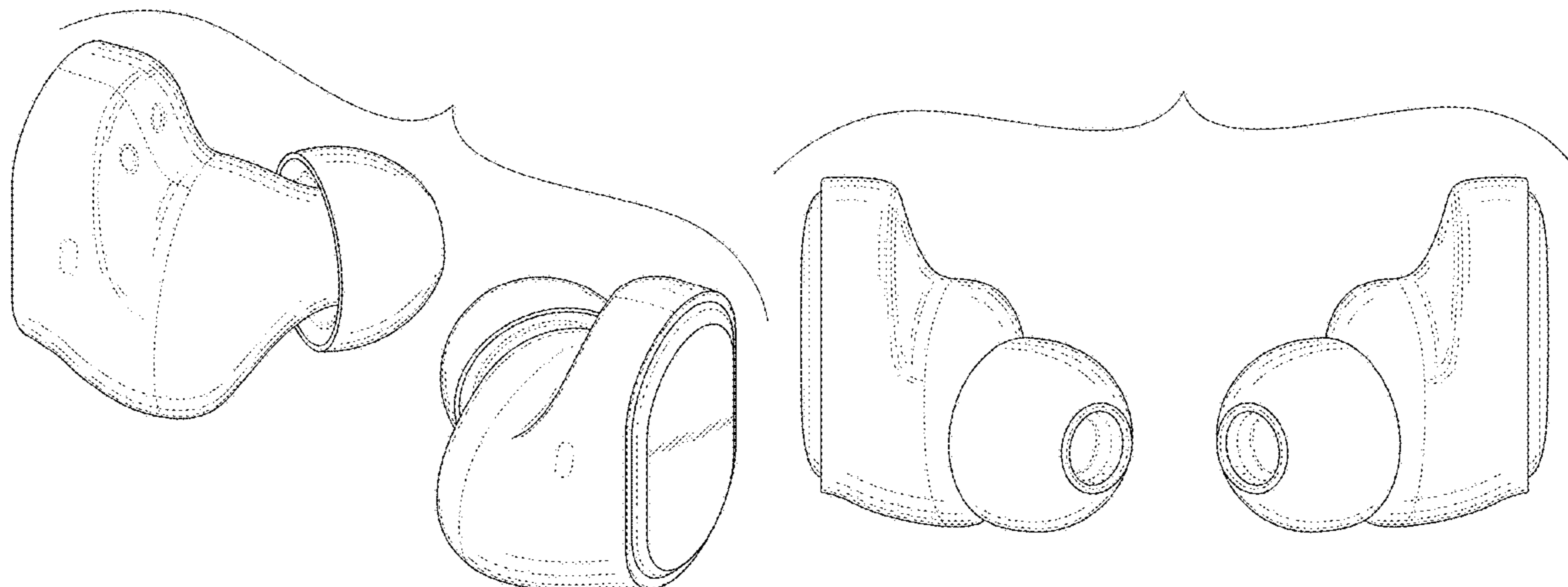
FIG. 6 is a right side view of the earbud headset shown in FIG. 1 (with the right earbud shown on the left and the left earbud shown on the right);

FIG. 7 is a top view of the earbud headset shown in FIG. 1 (with the right earbud shown on the left and the left earbud shown on the right); and,

FIG. 8 is a bottom view of the earbud headset shown in FIG. 1 (with the right earbud shown on the left and the left earbud shown on the right).

The broken lines immediately adjacent the shaded areas represent the bounds of the claimed design while all other broken lines are directed to environment; the broken lines form no part of the claimed design.

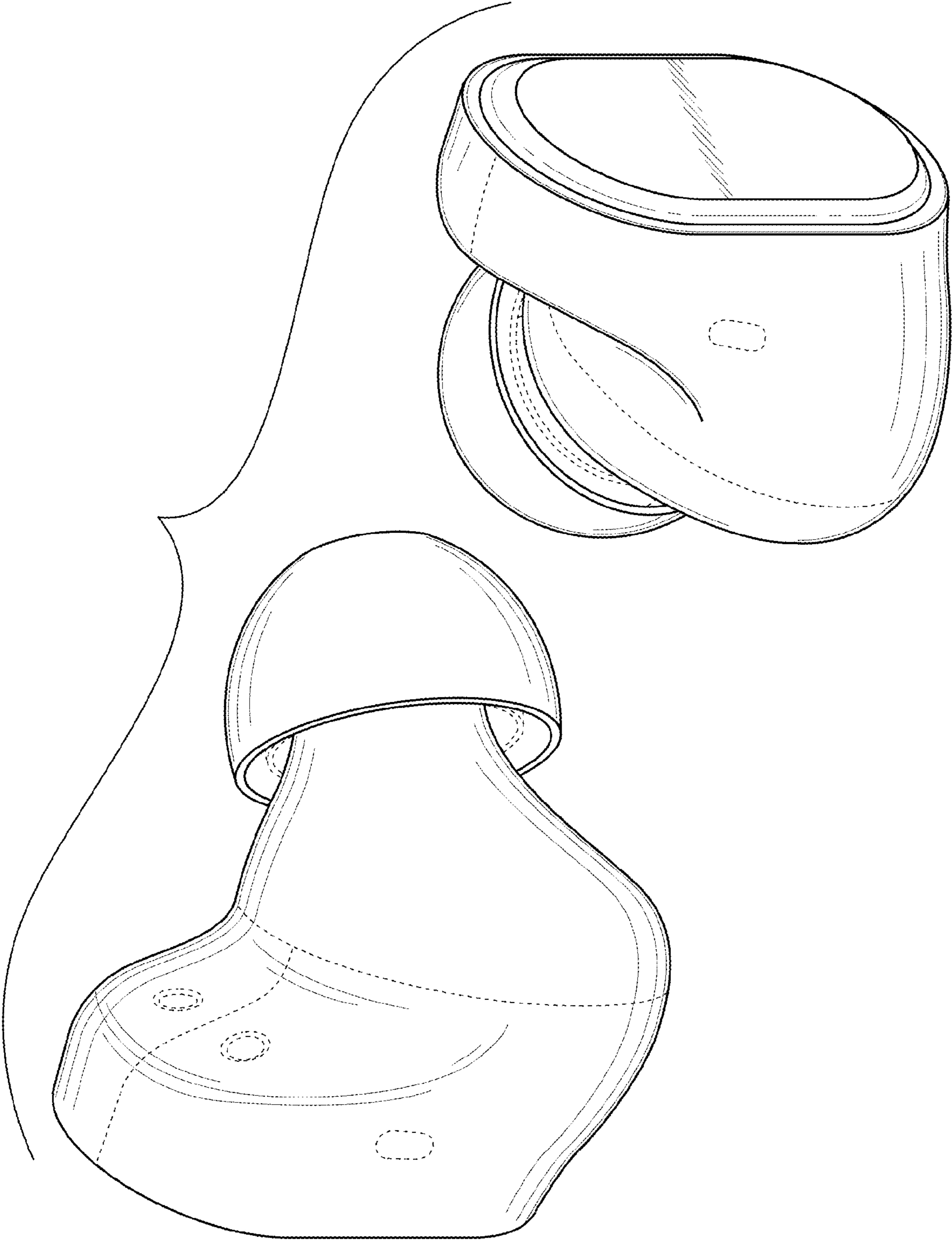

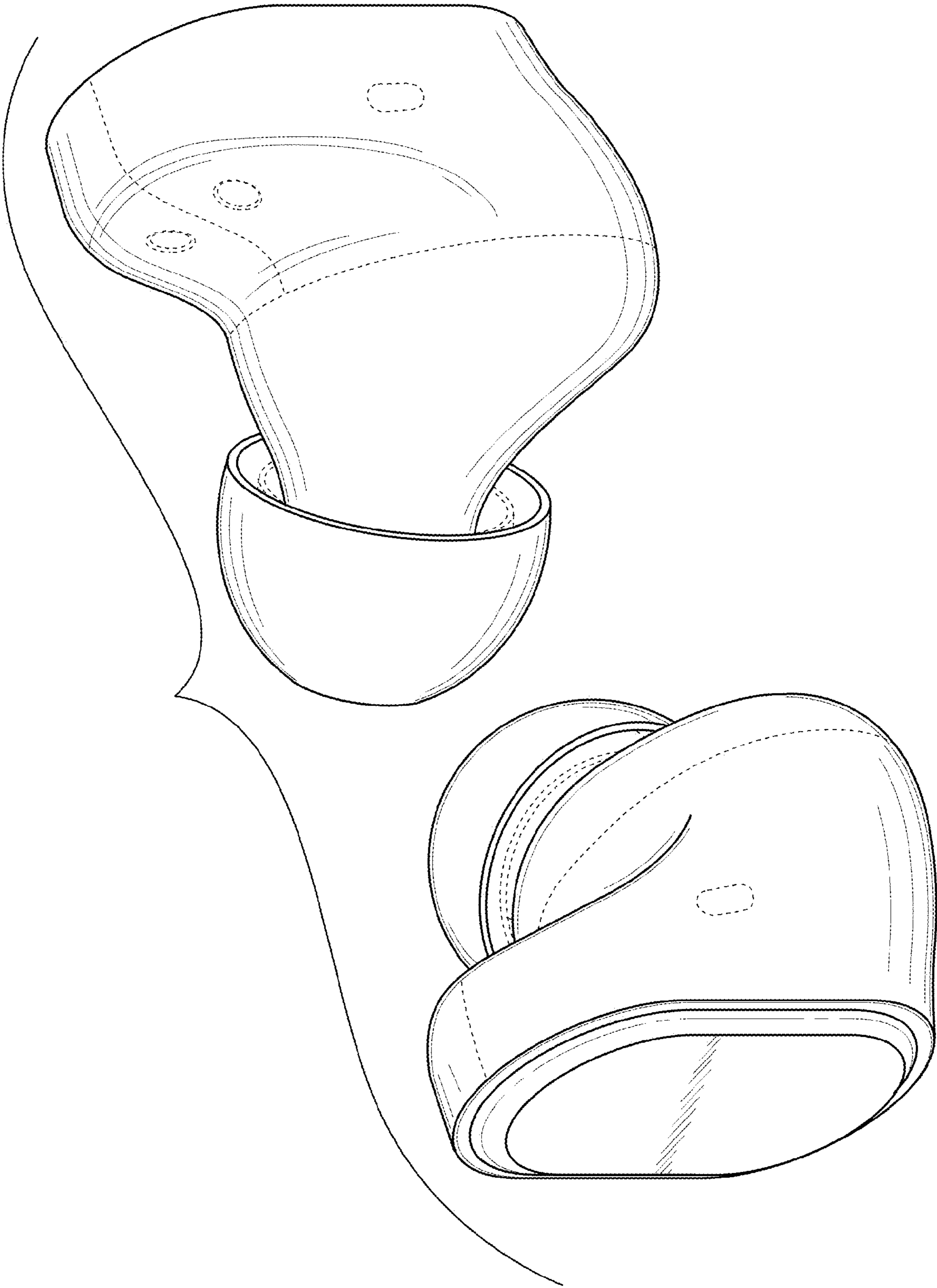

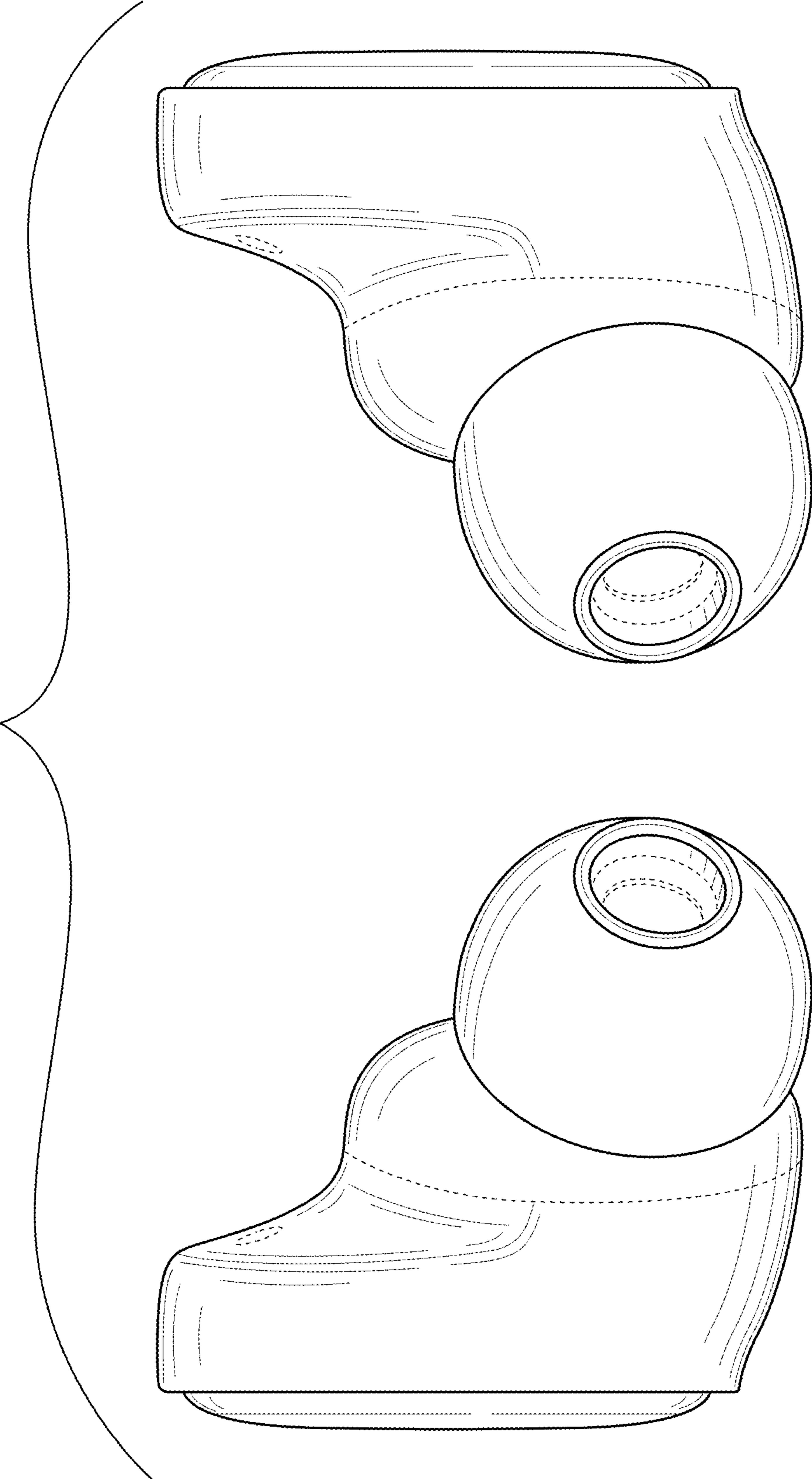

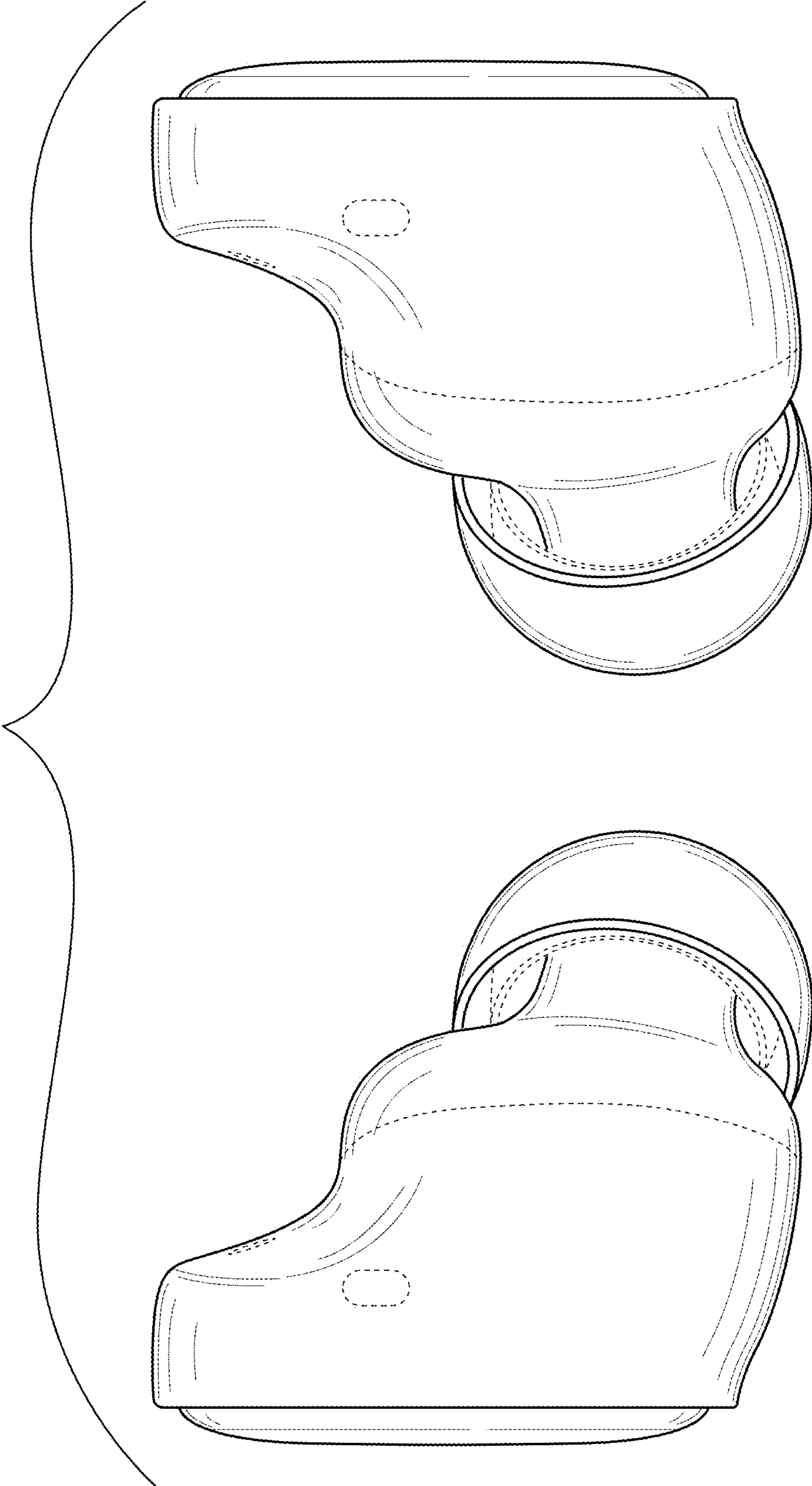

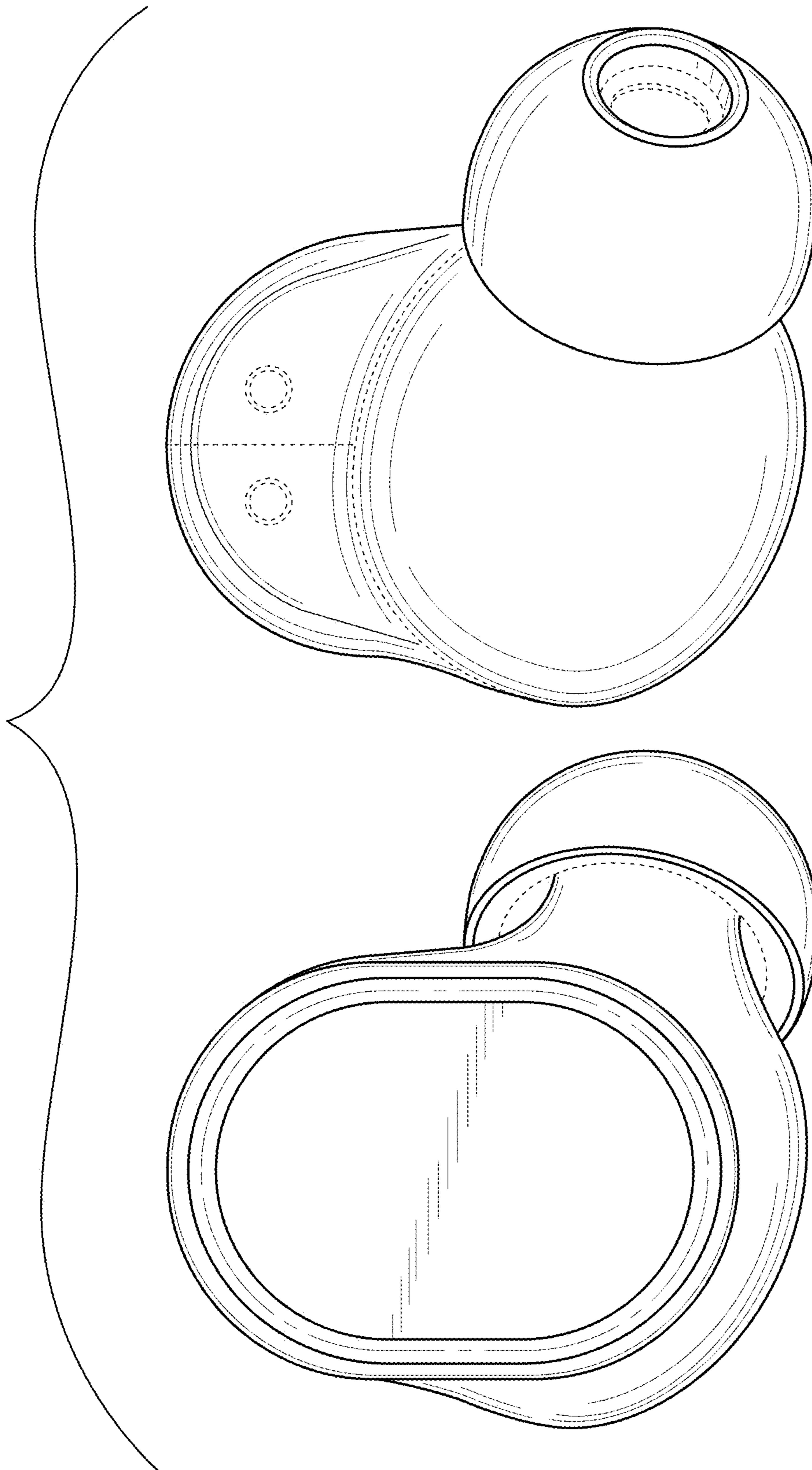

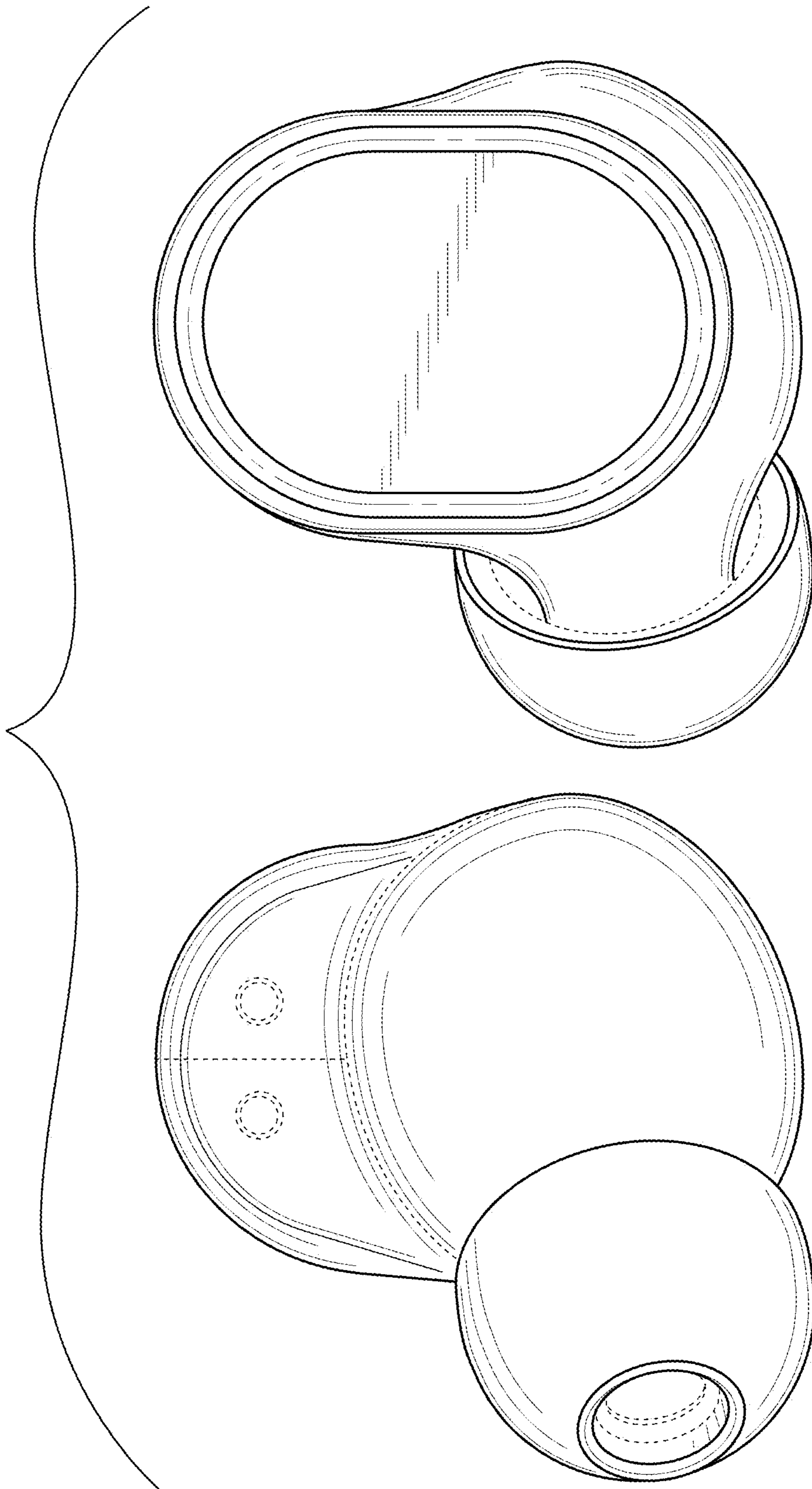

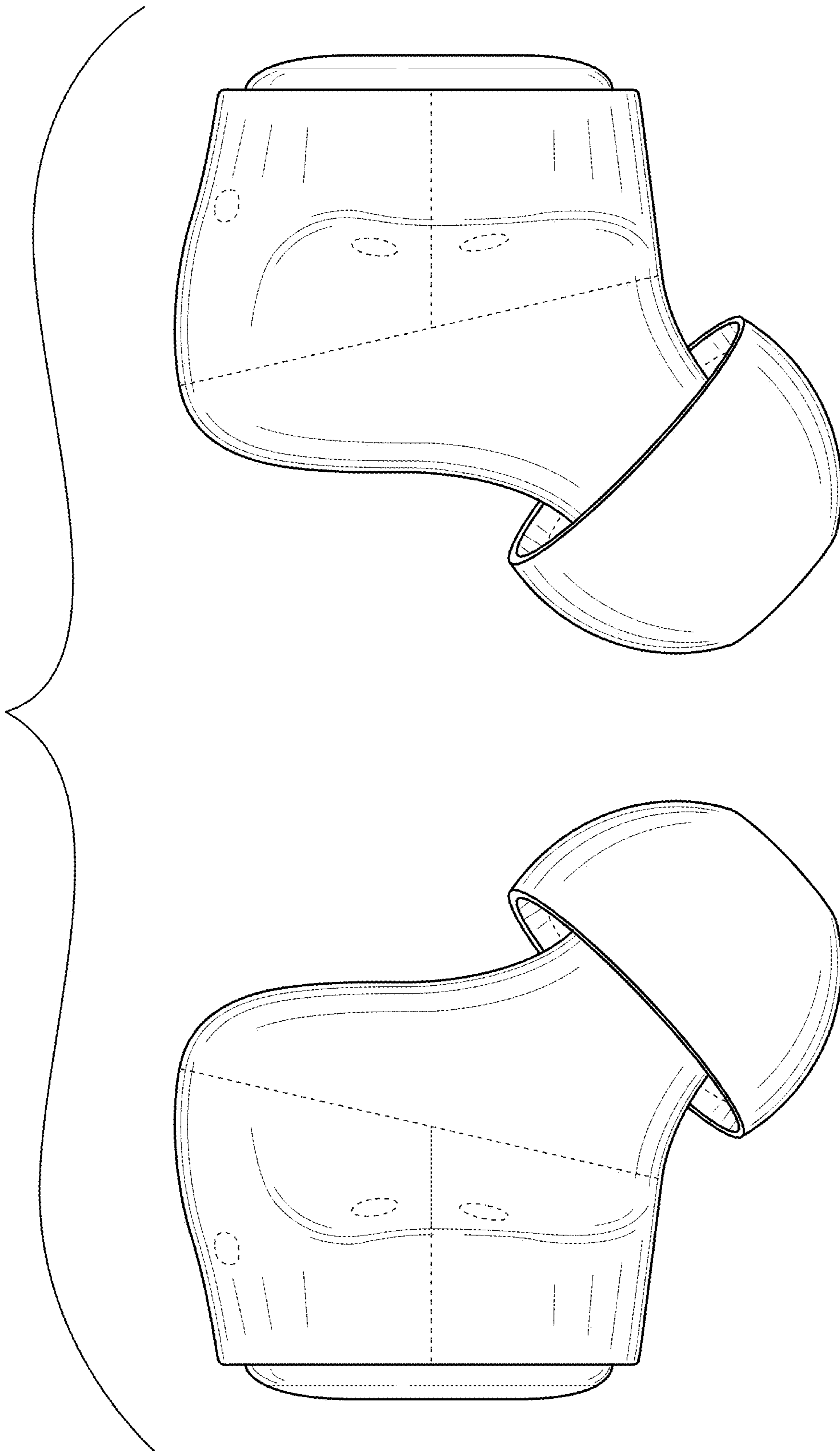

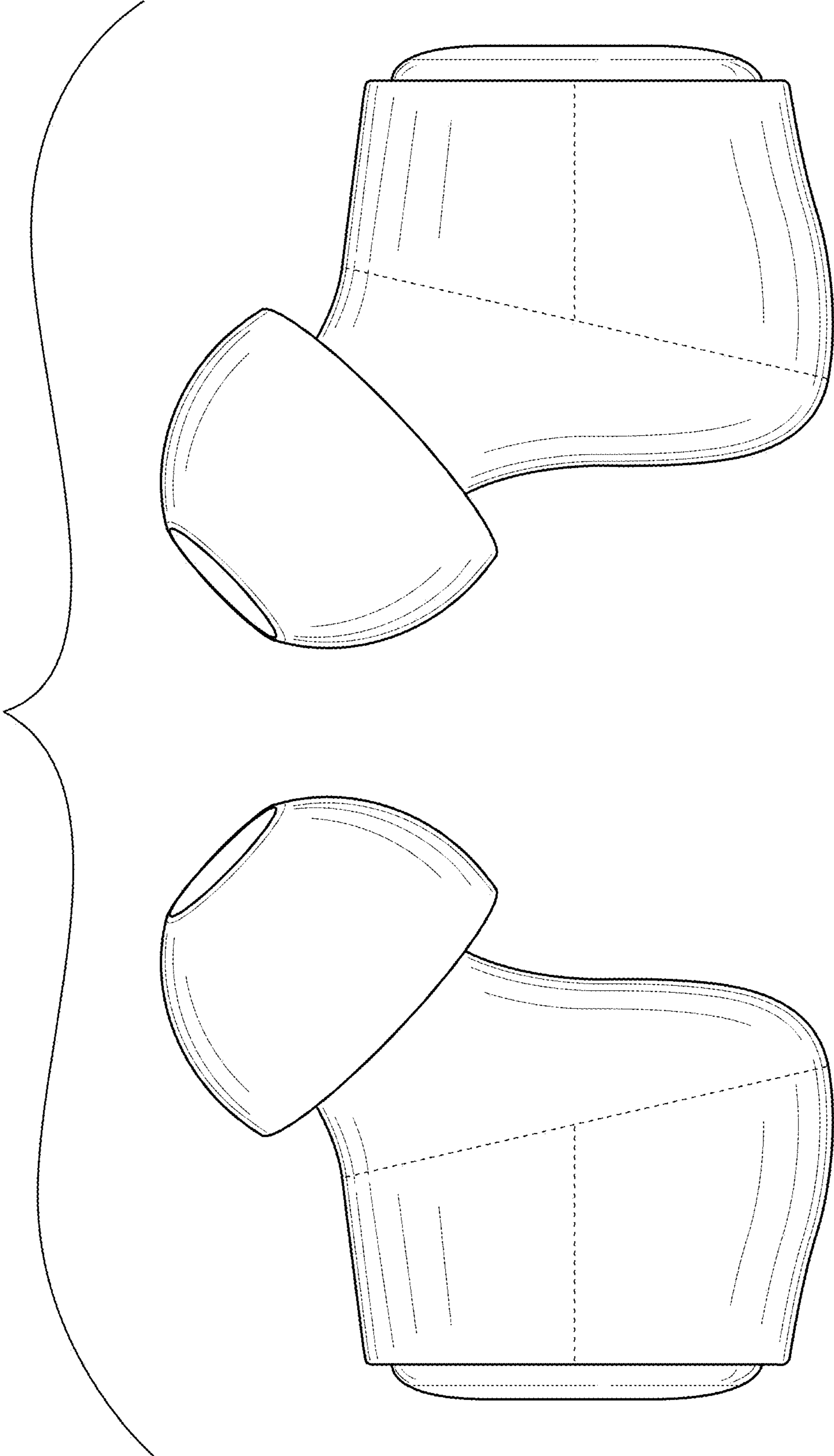
