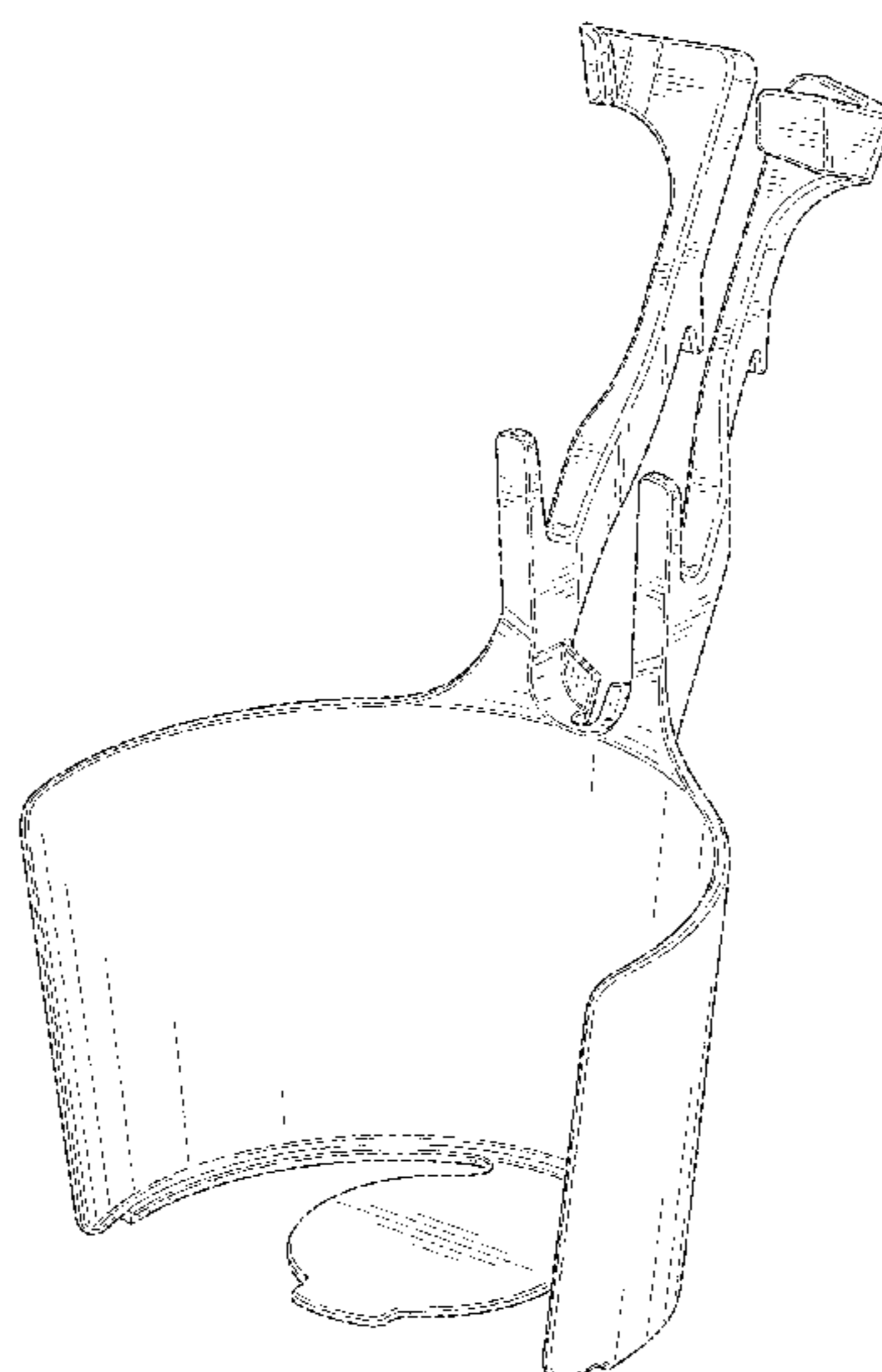
The ornamental design for a mobile device holder with cup

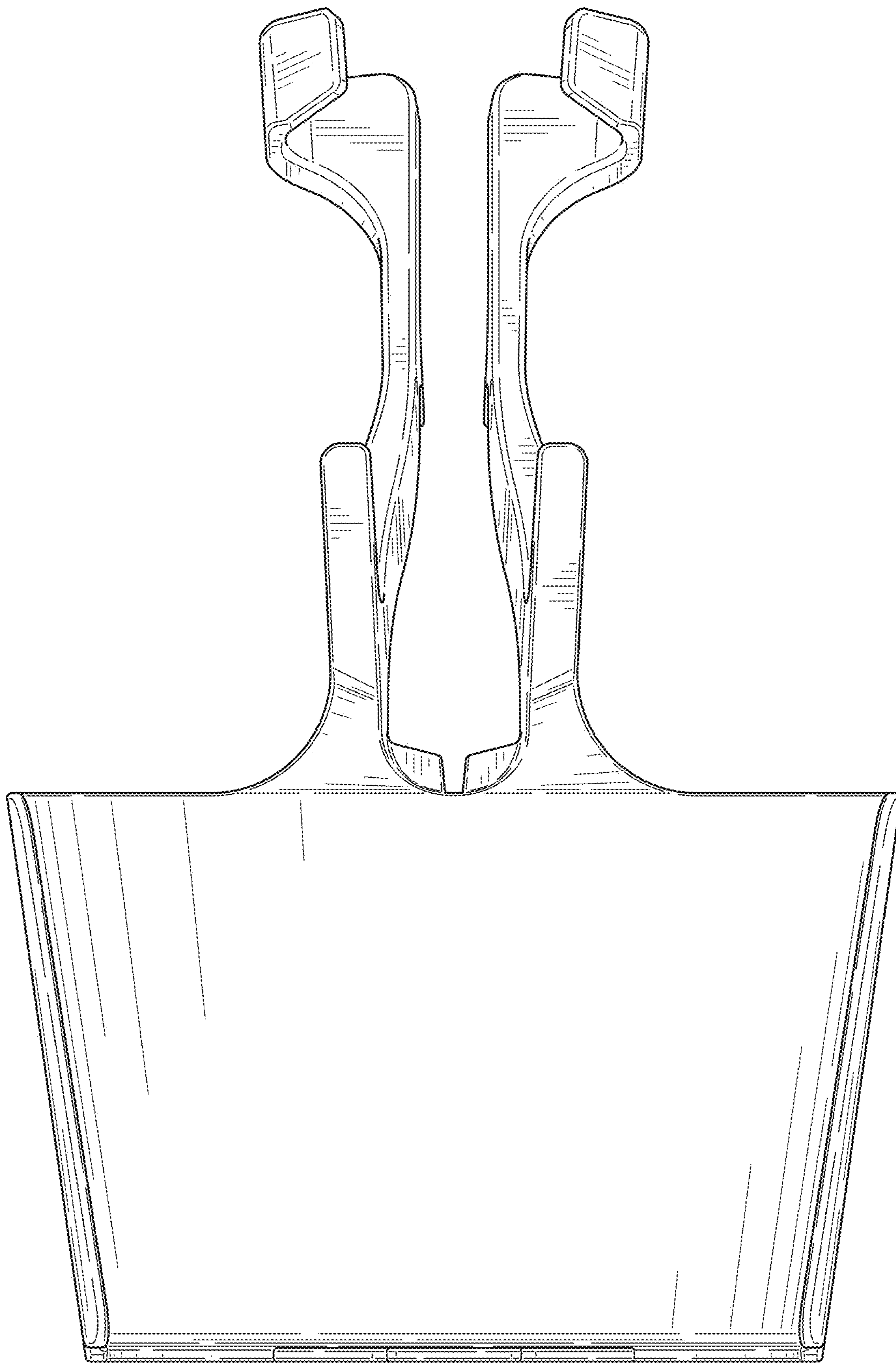

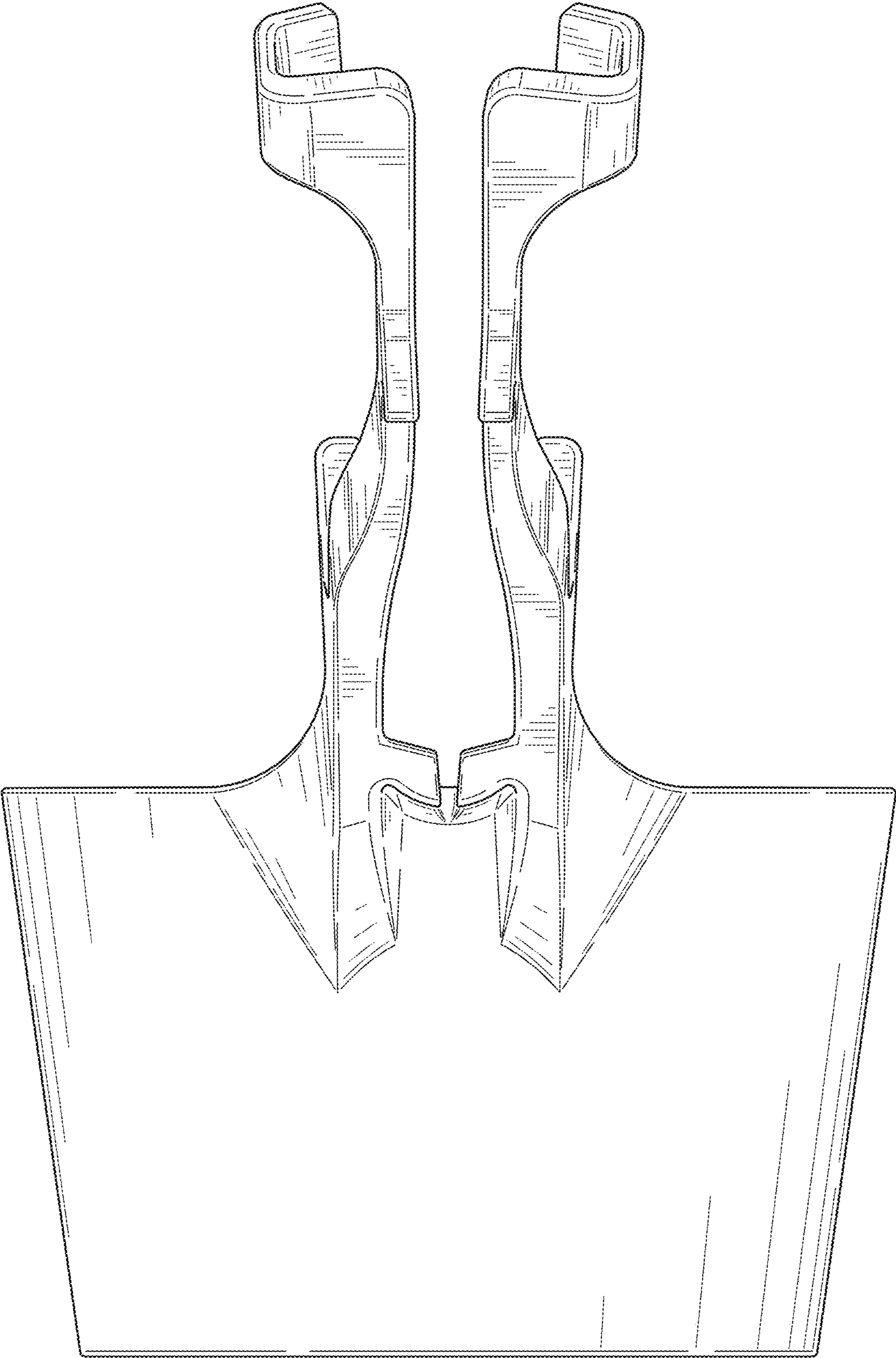

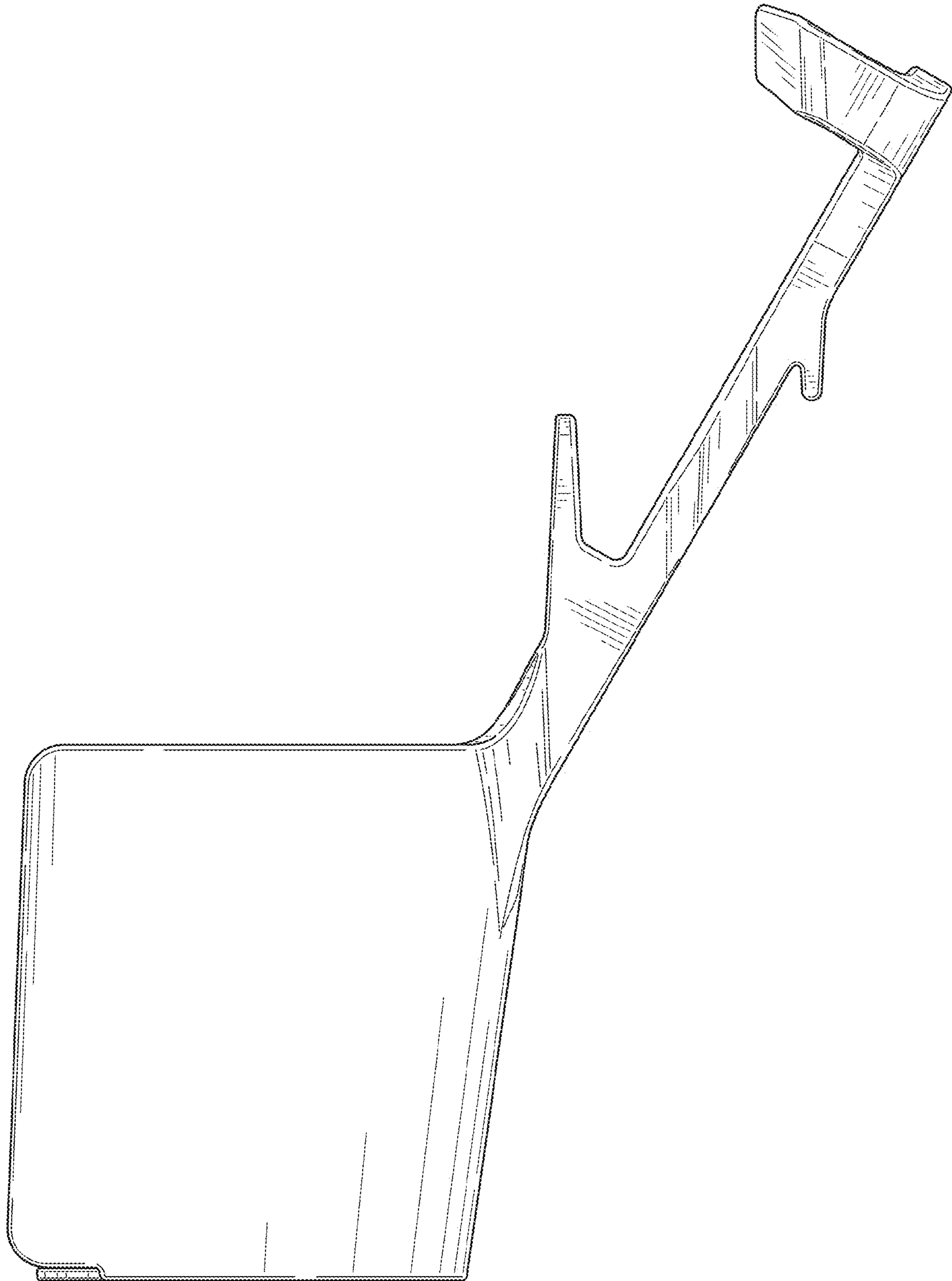

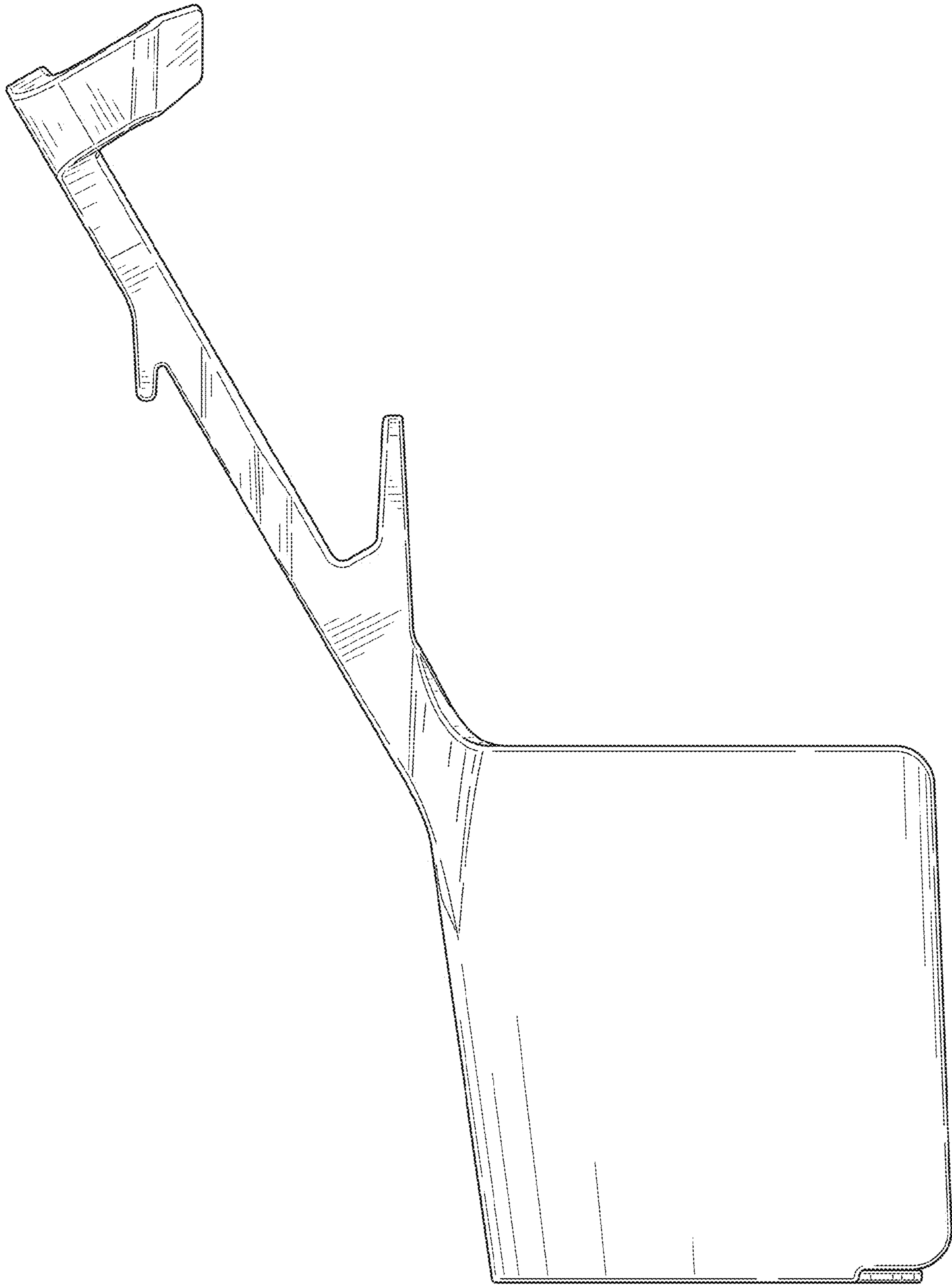

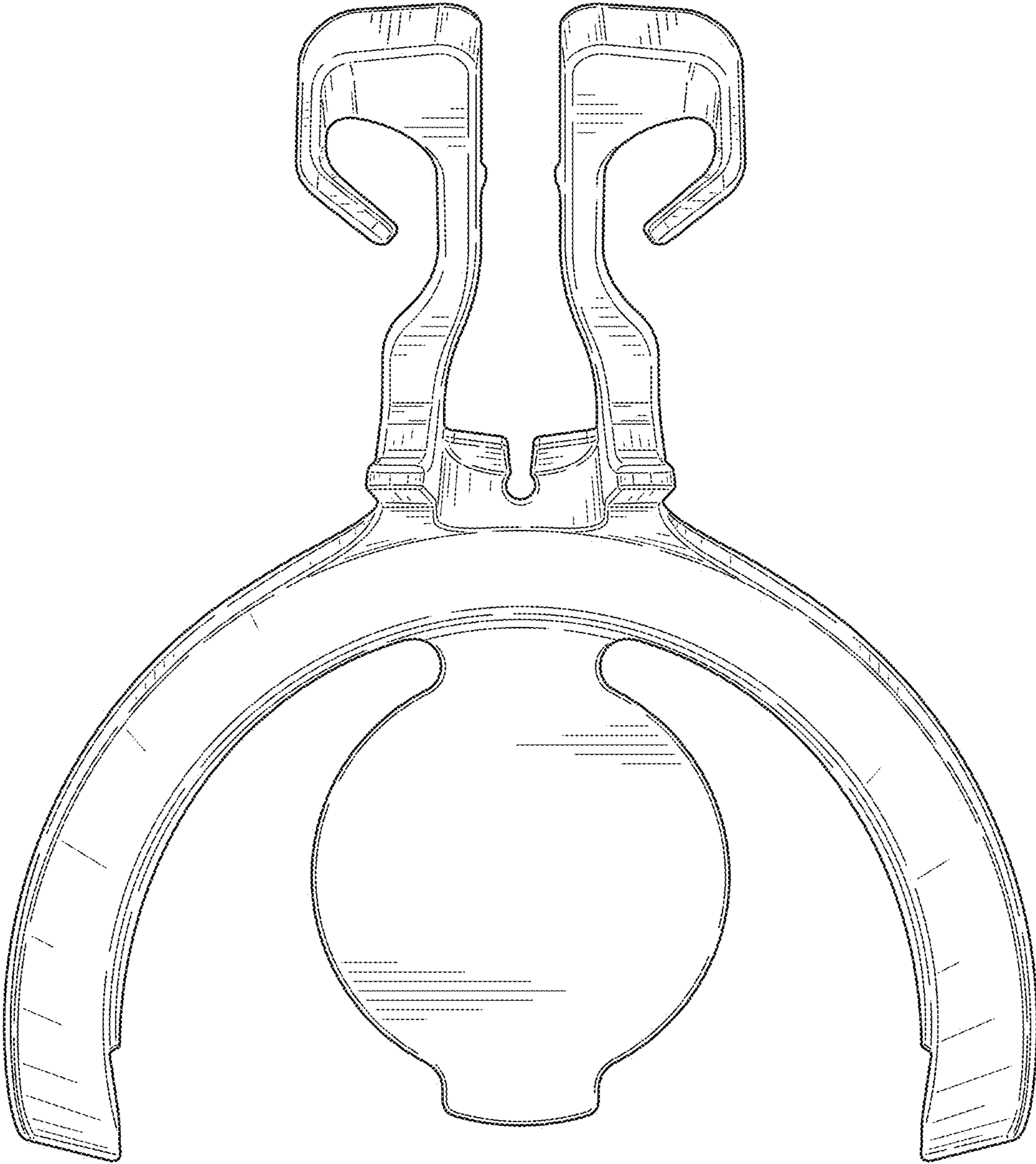

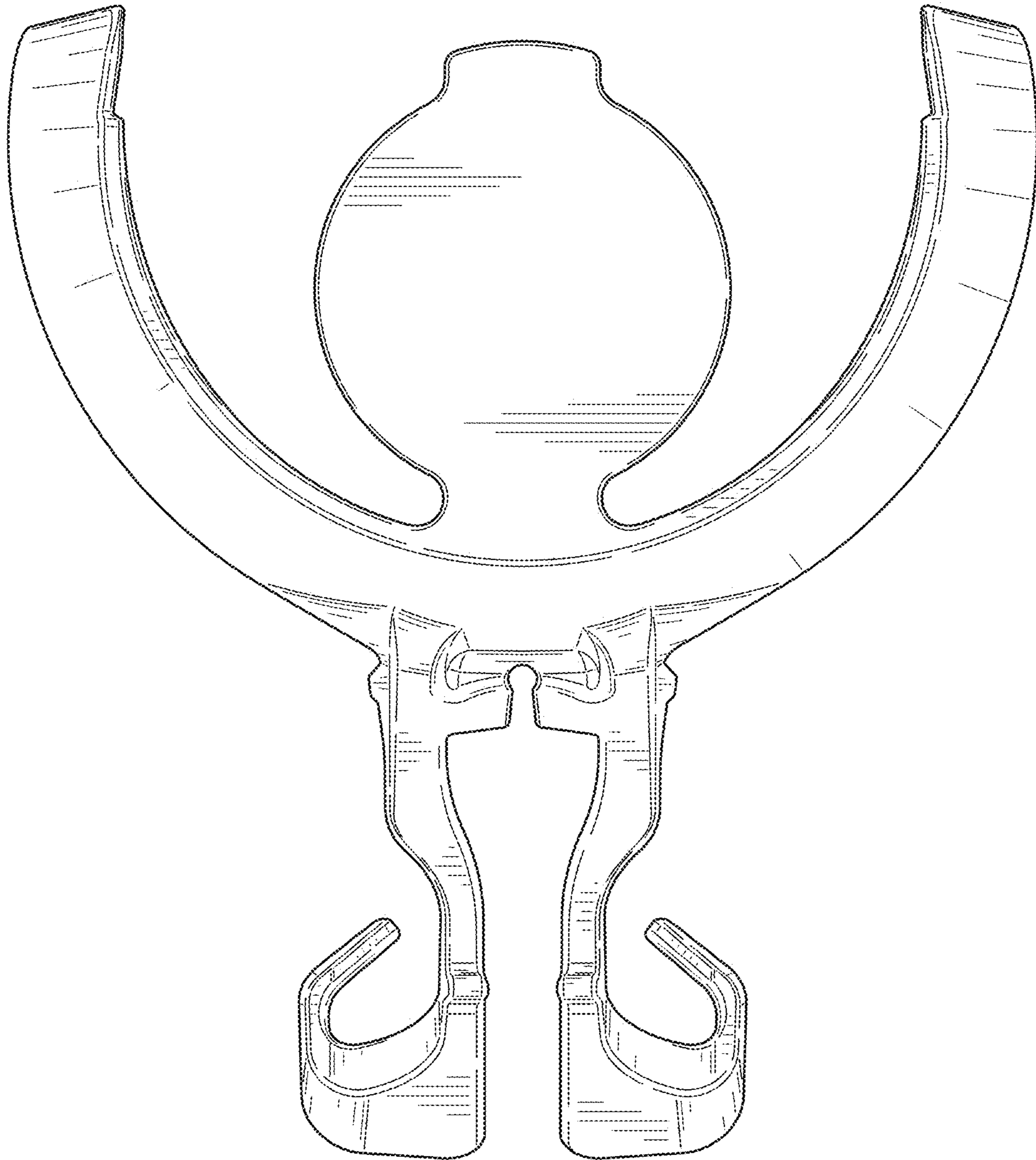
