(57) **CLAIM**

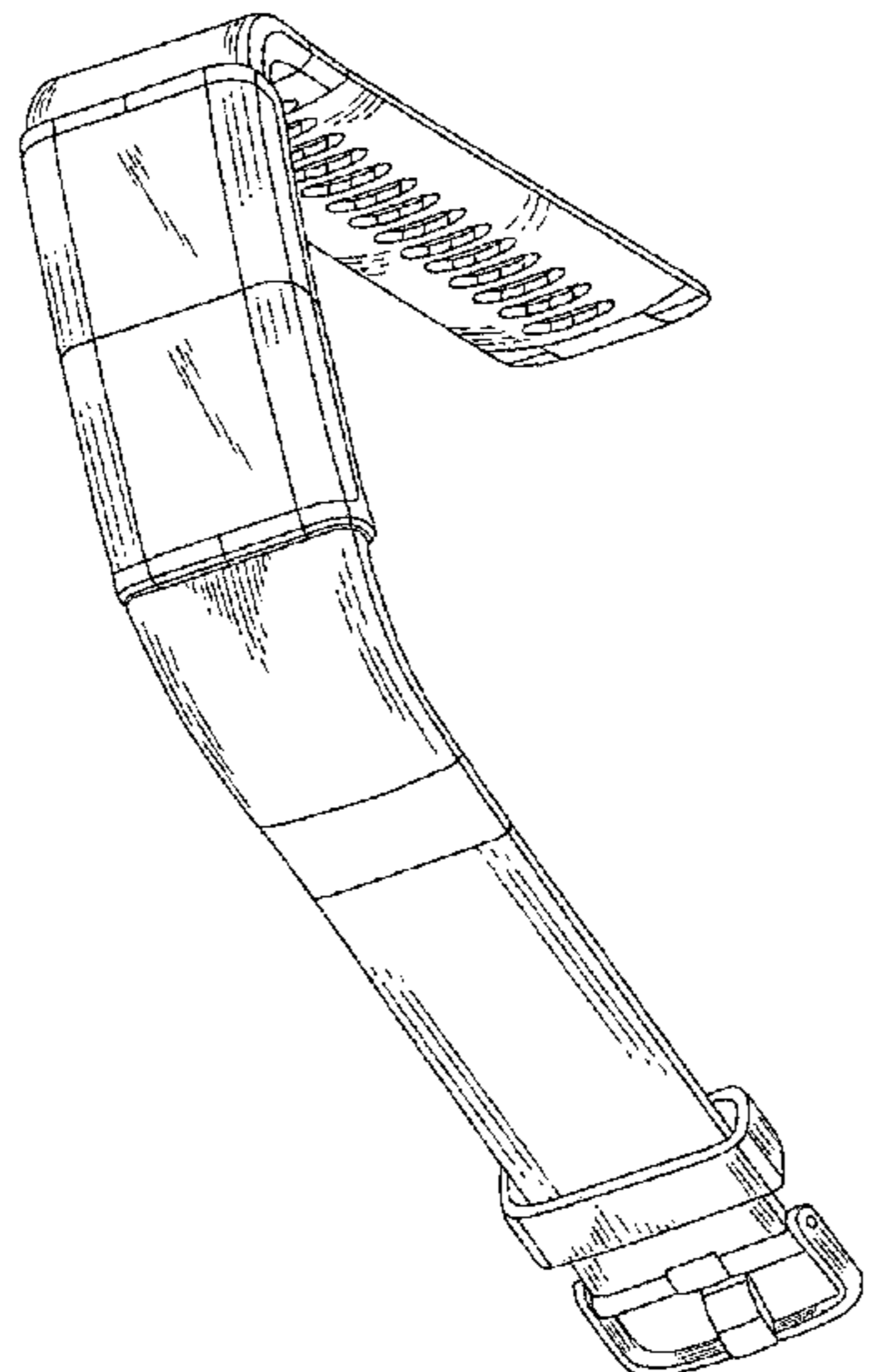
The ornamental design for a smartwatch, as shown and described.

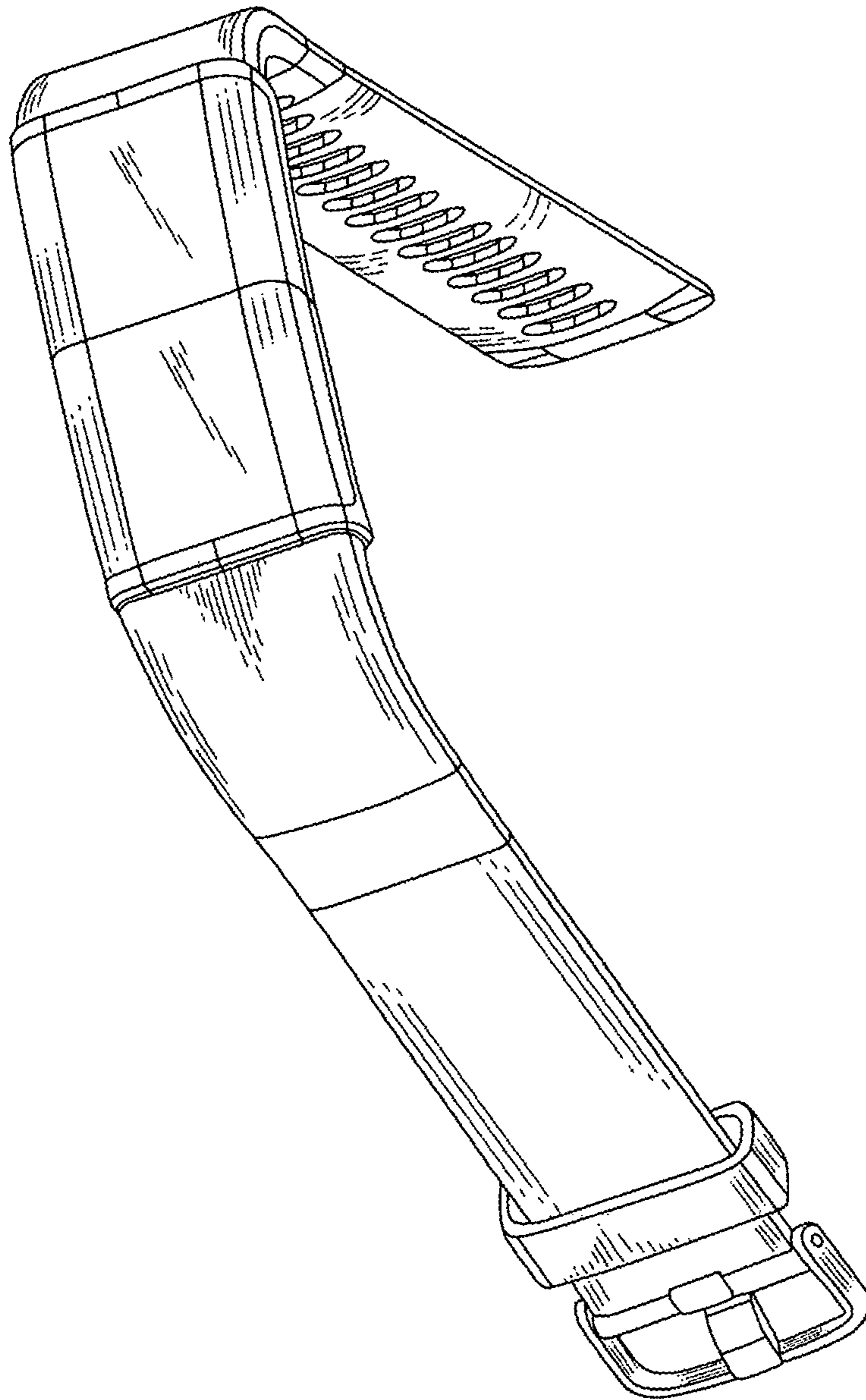

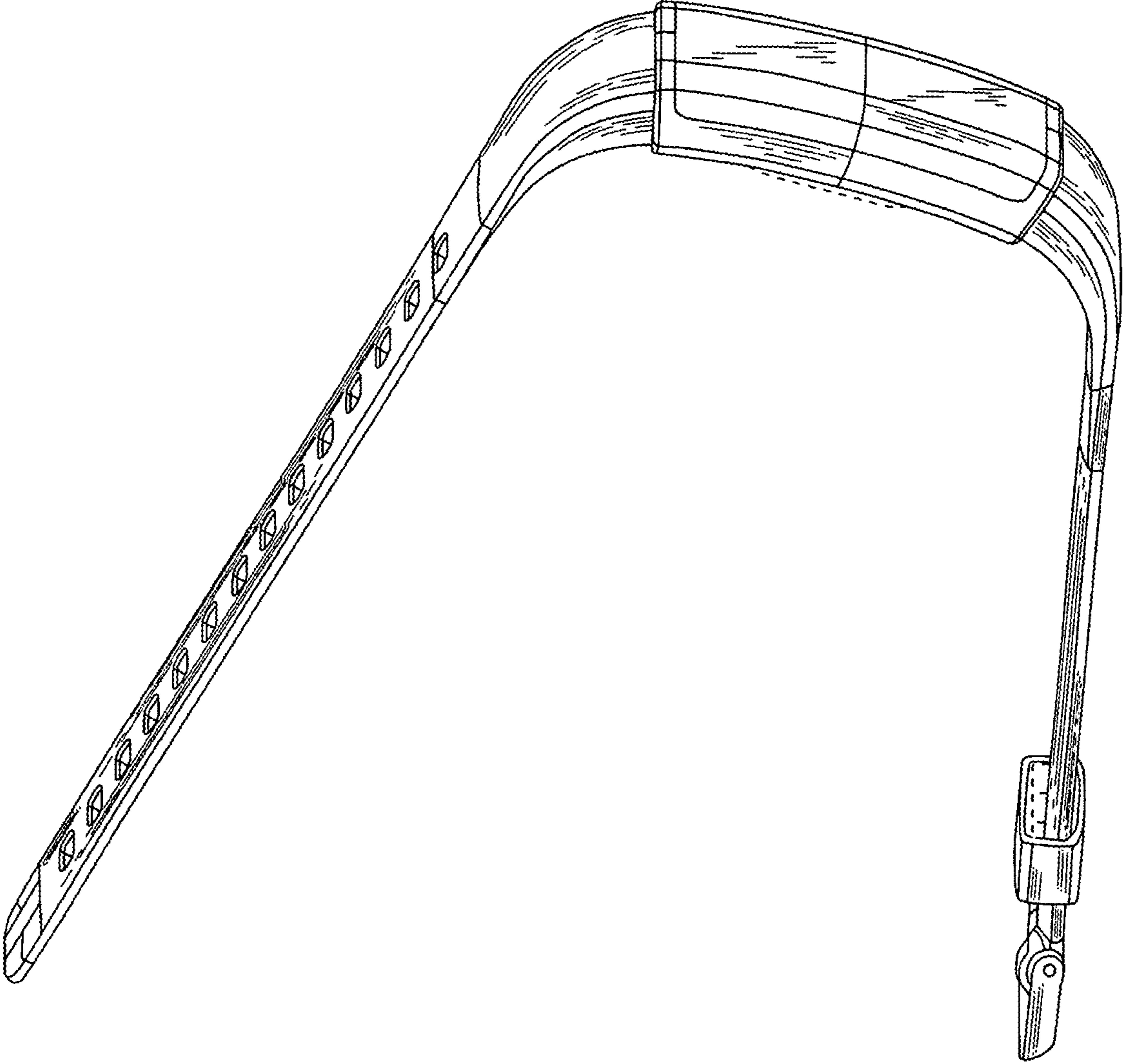

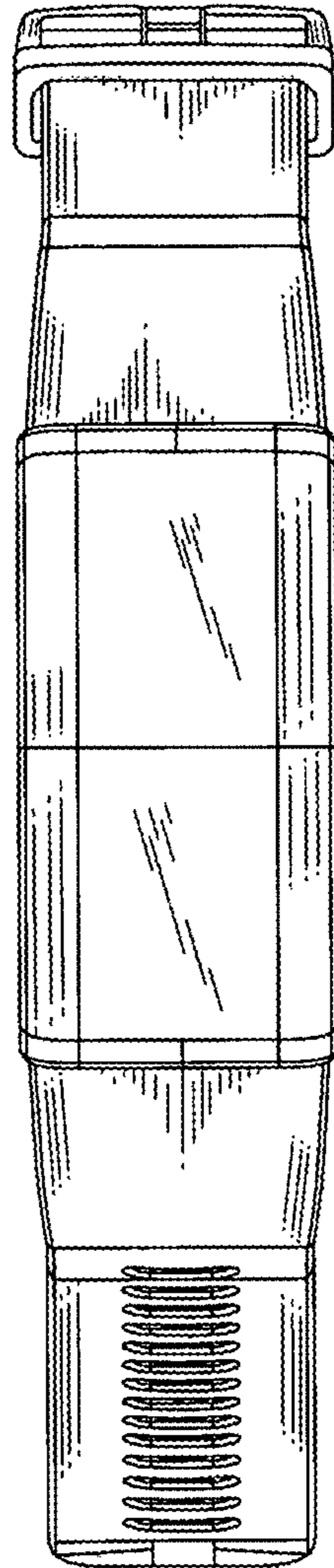

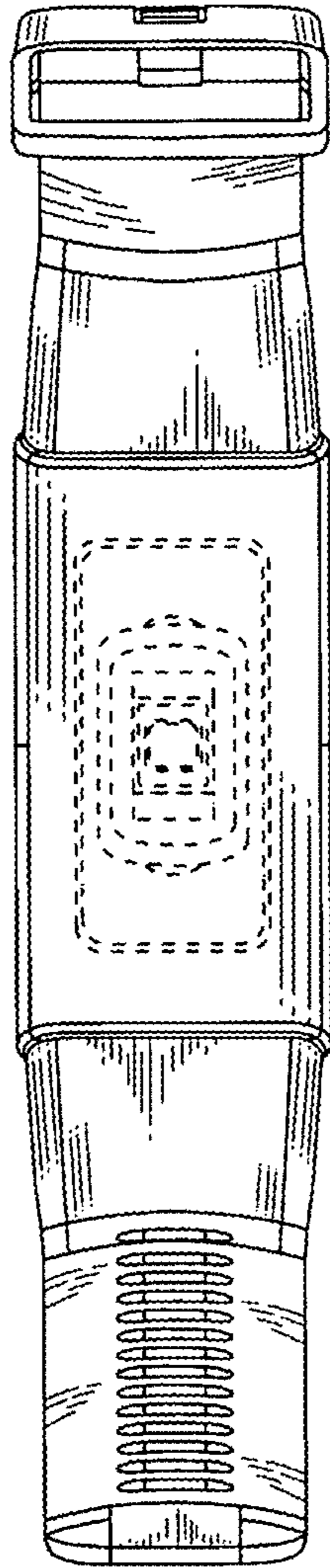

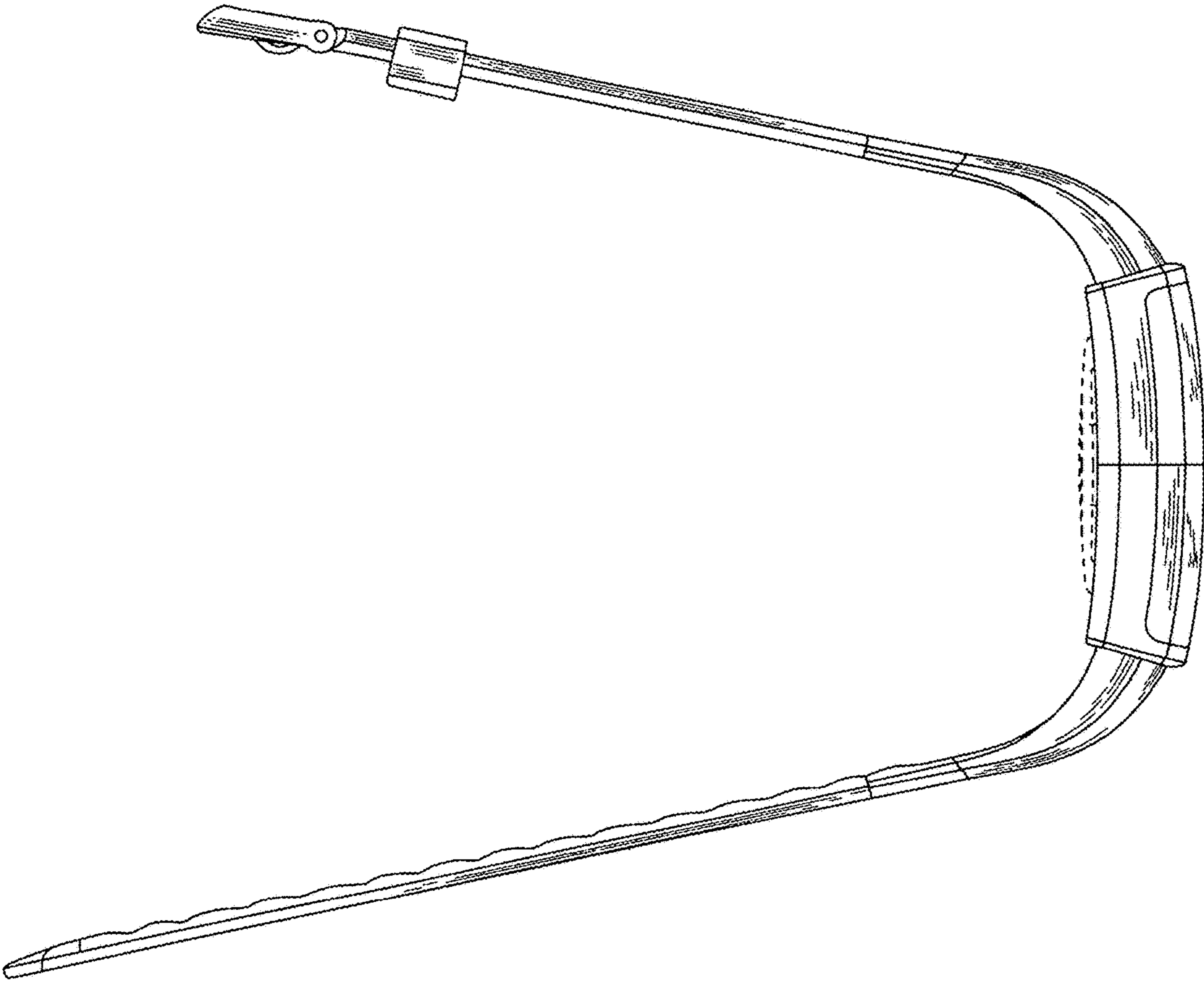

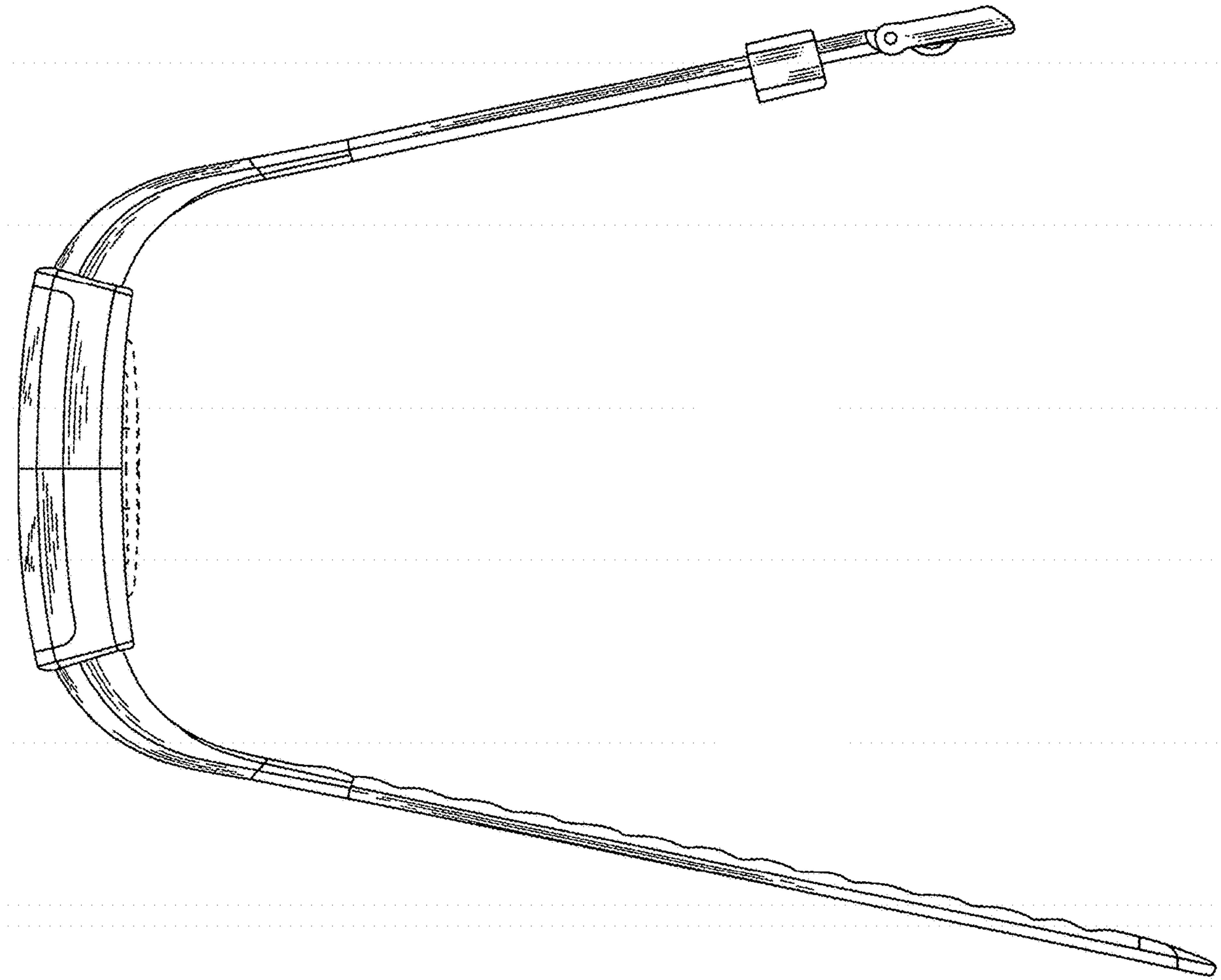

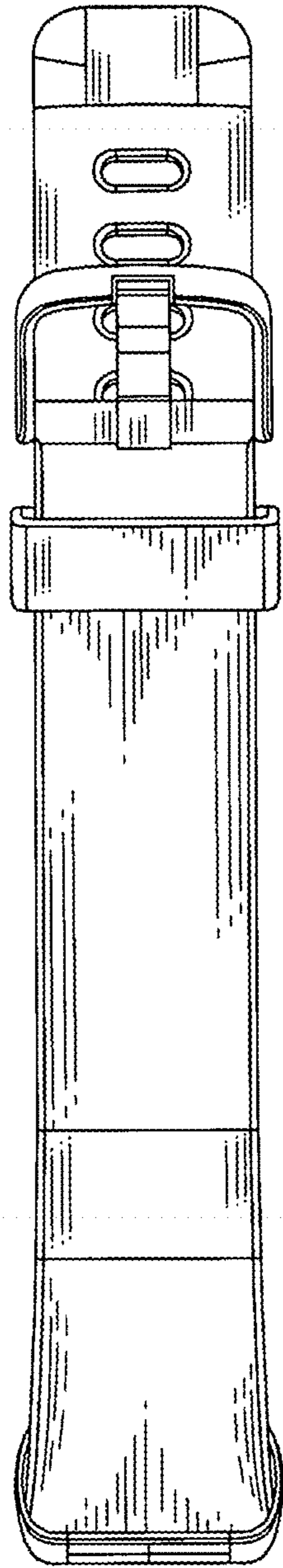

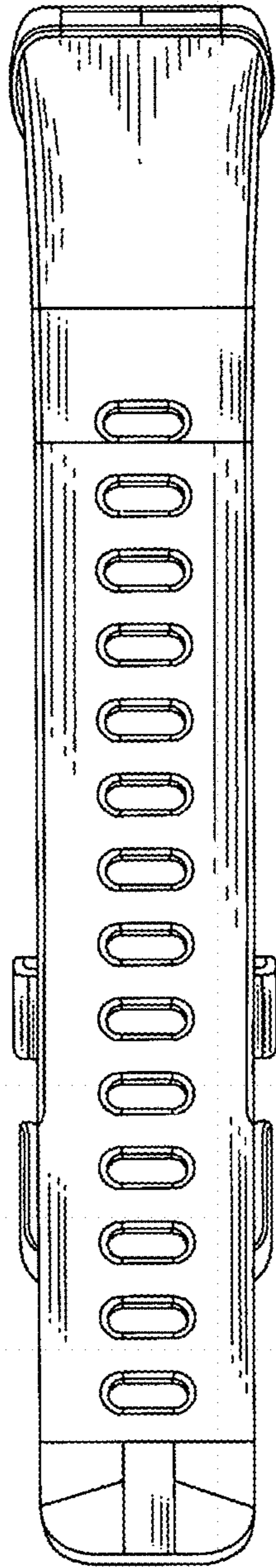
