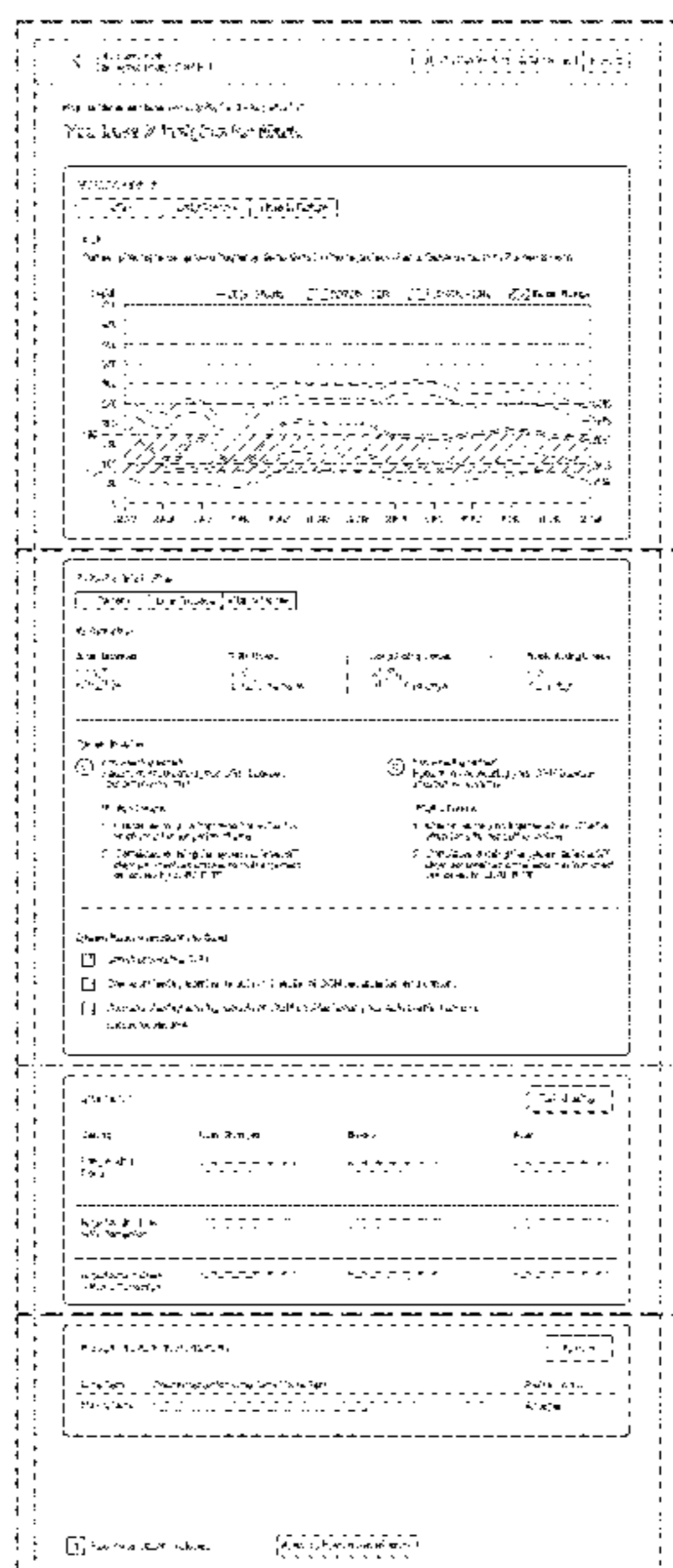

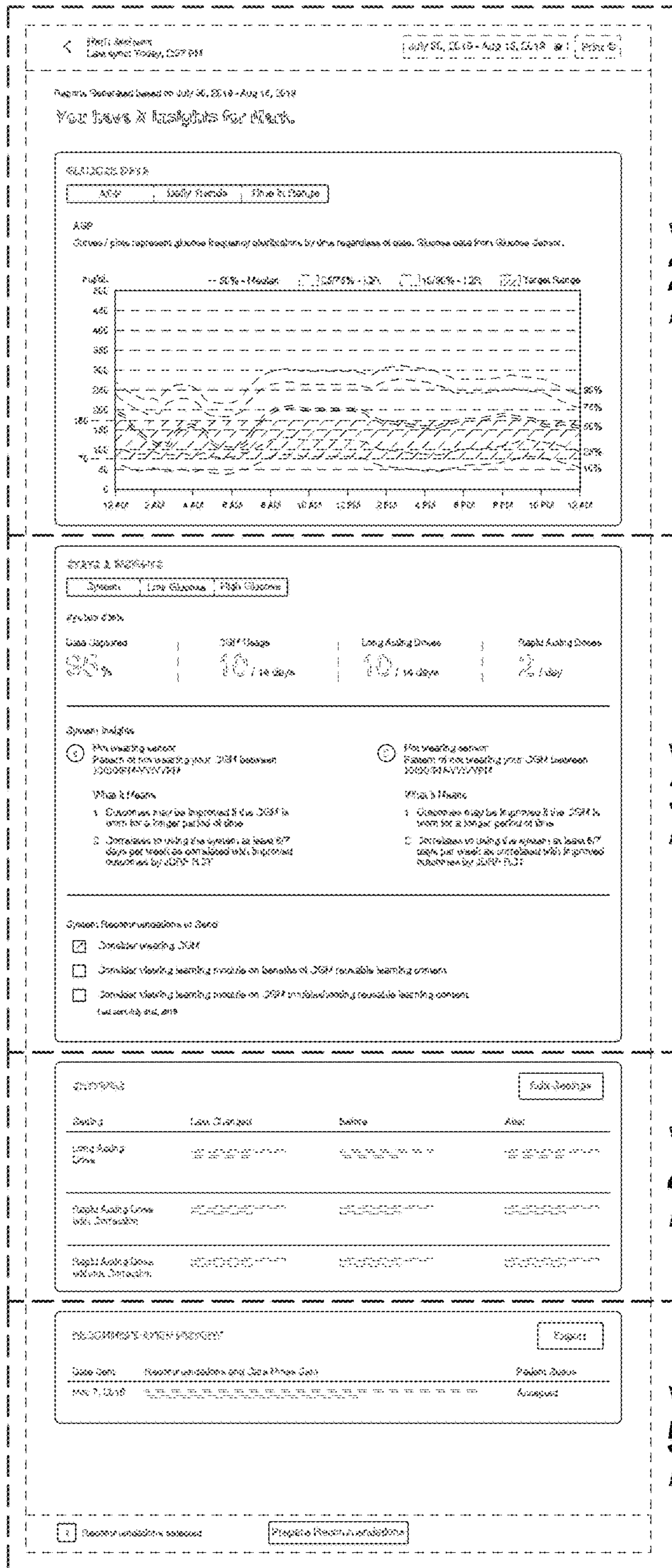

Yield Trends & Impedance for Moisture

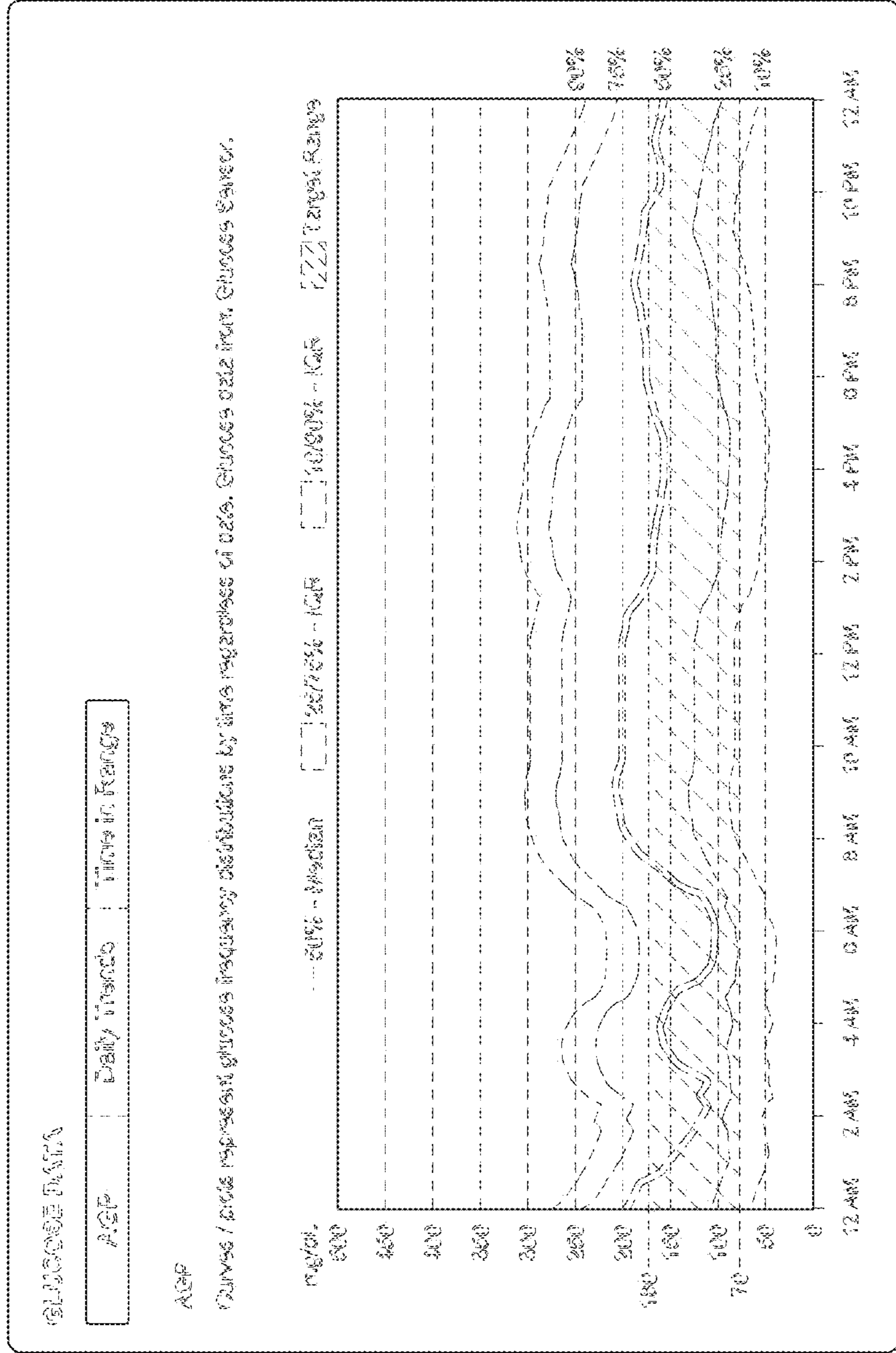

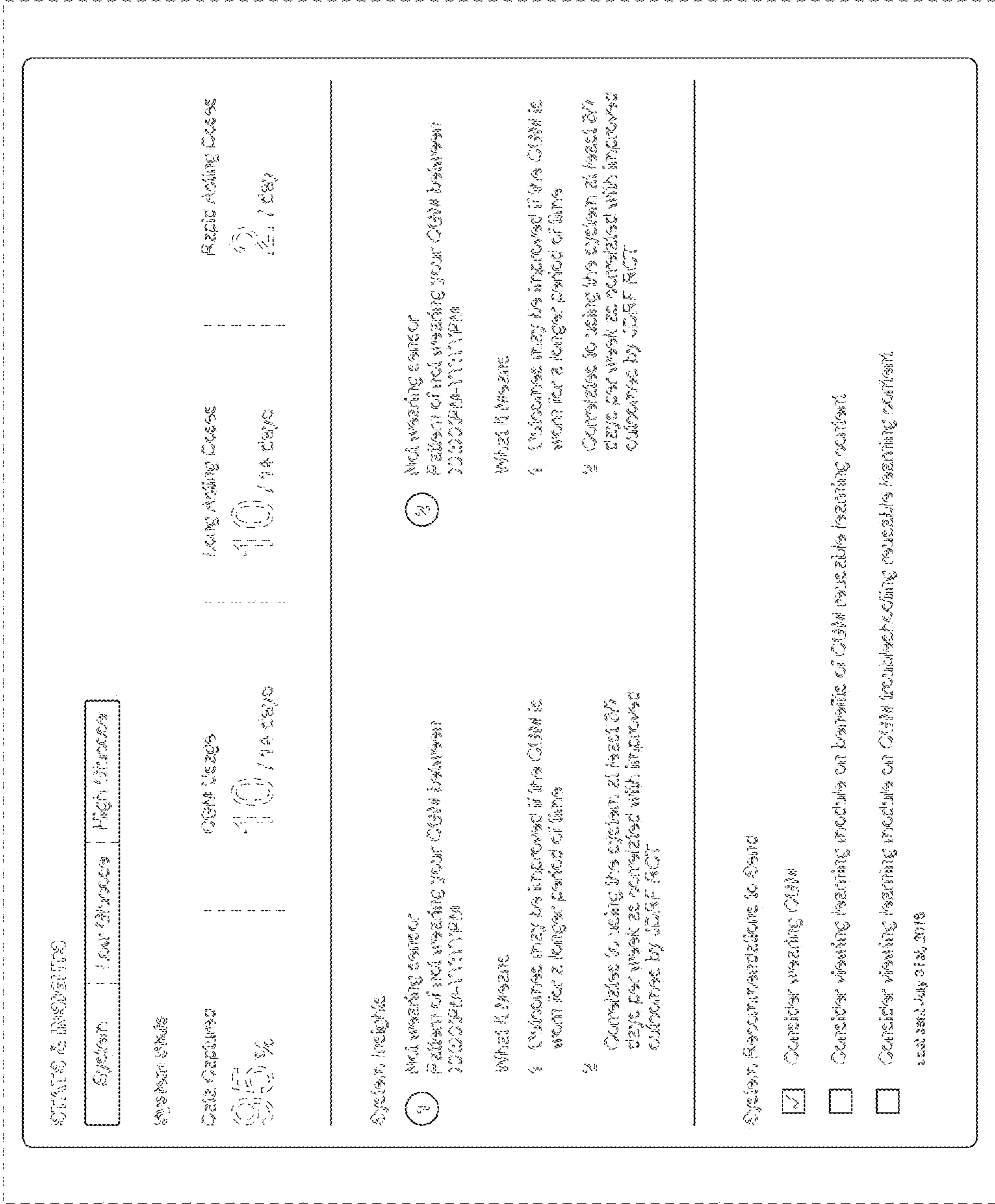

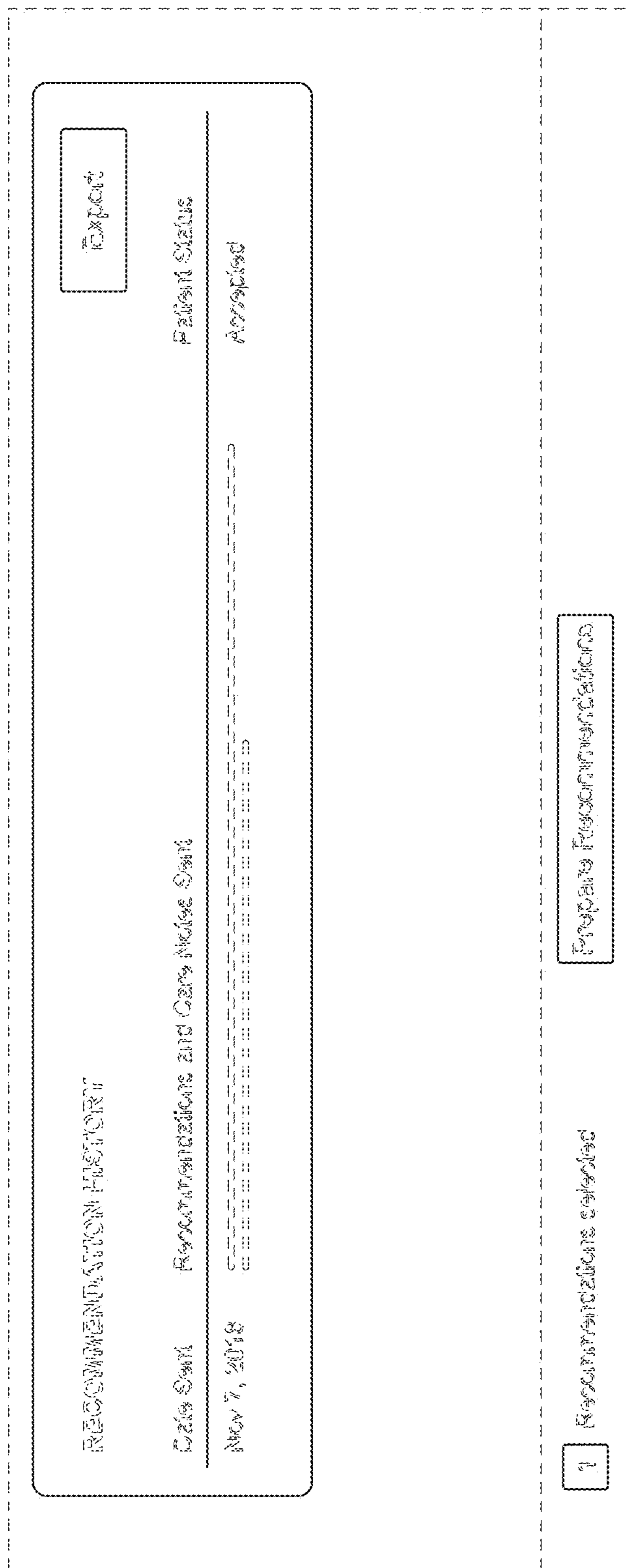

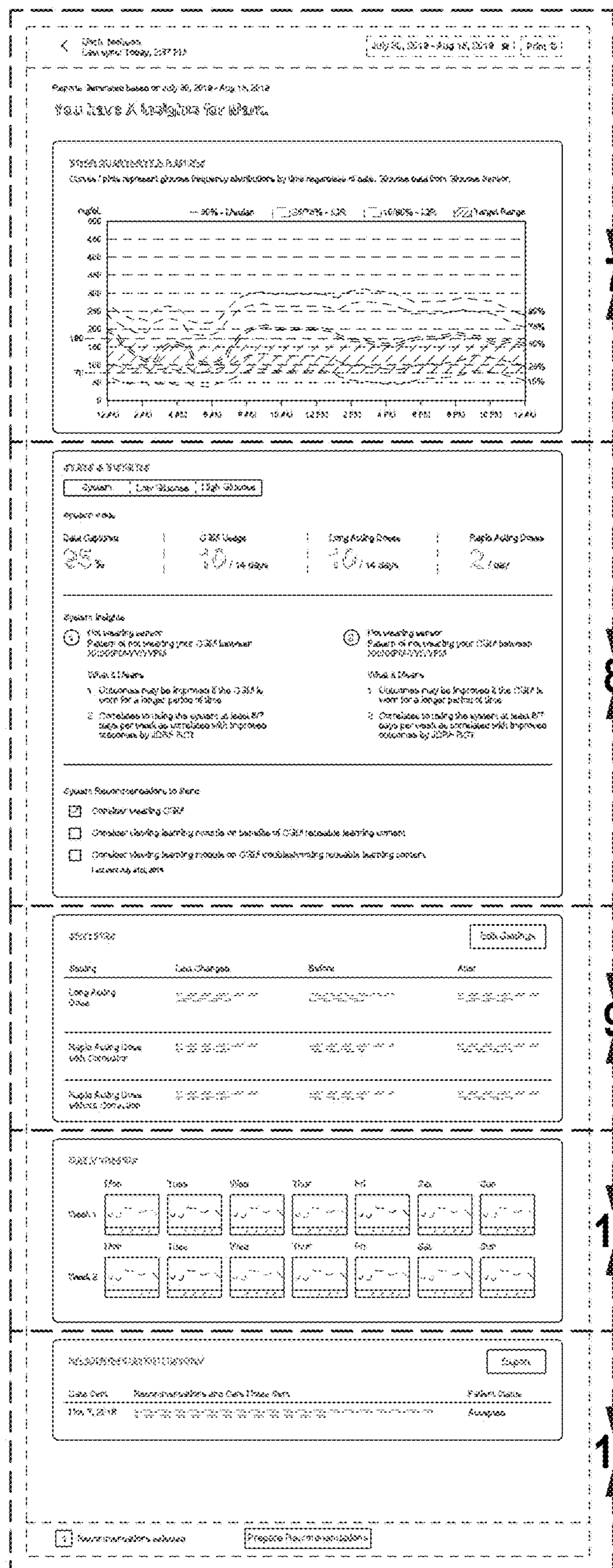

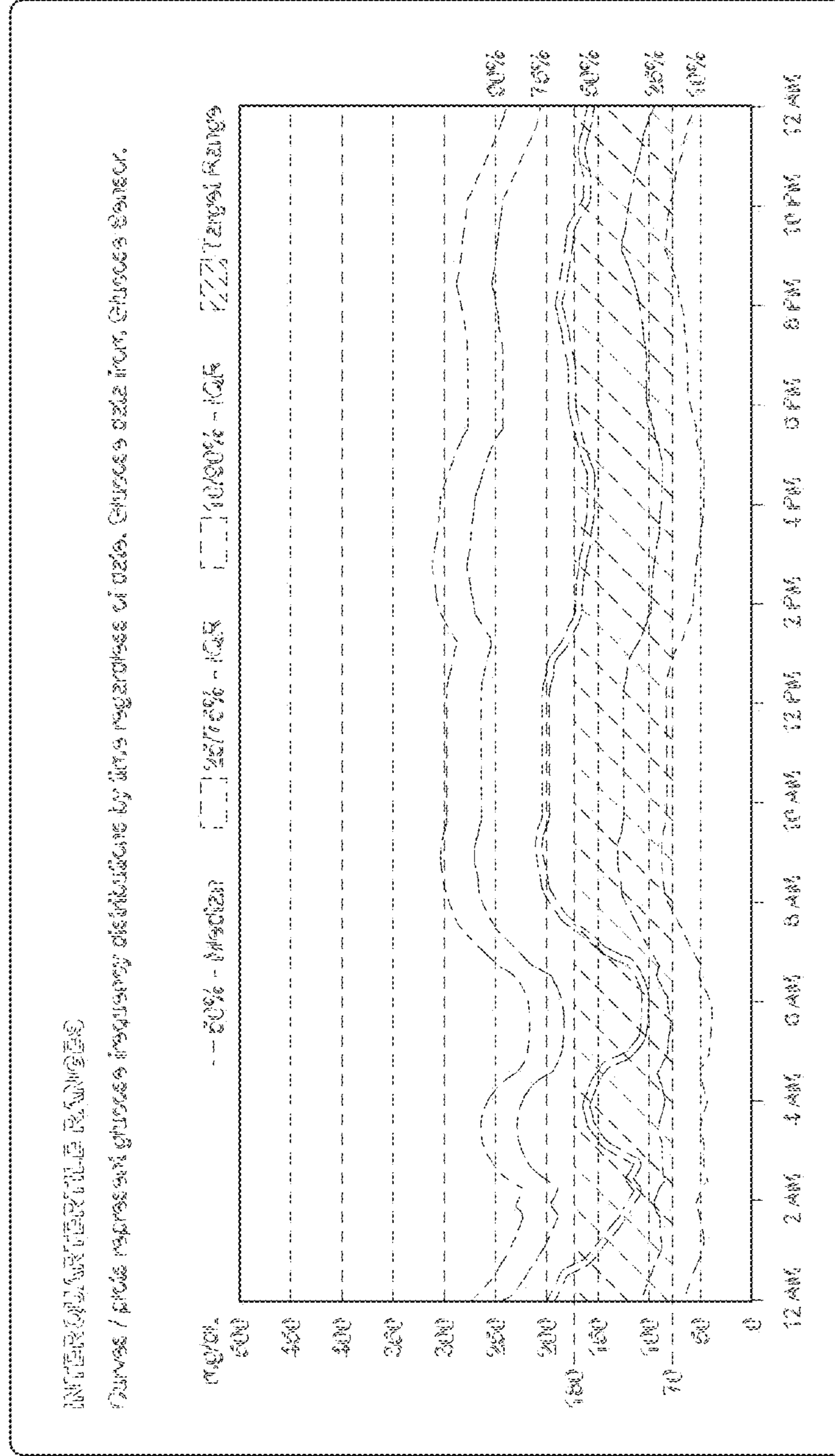

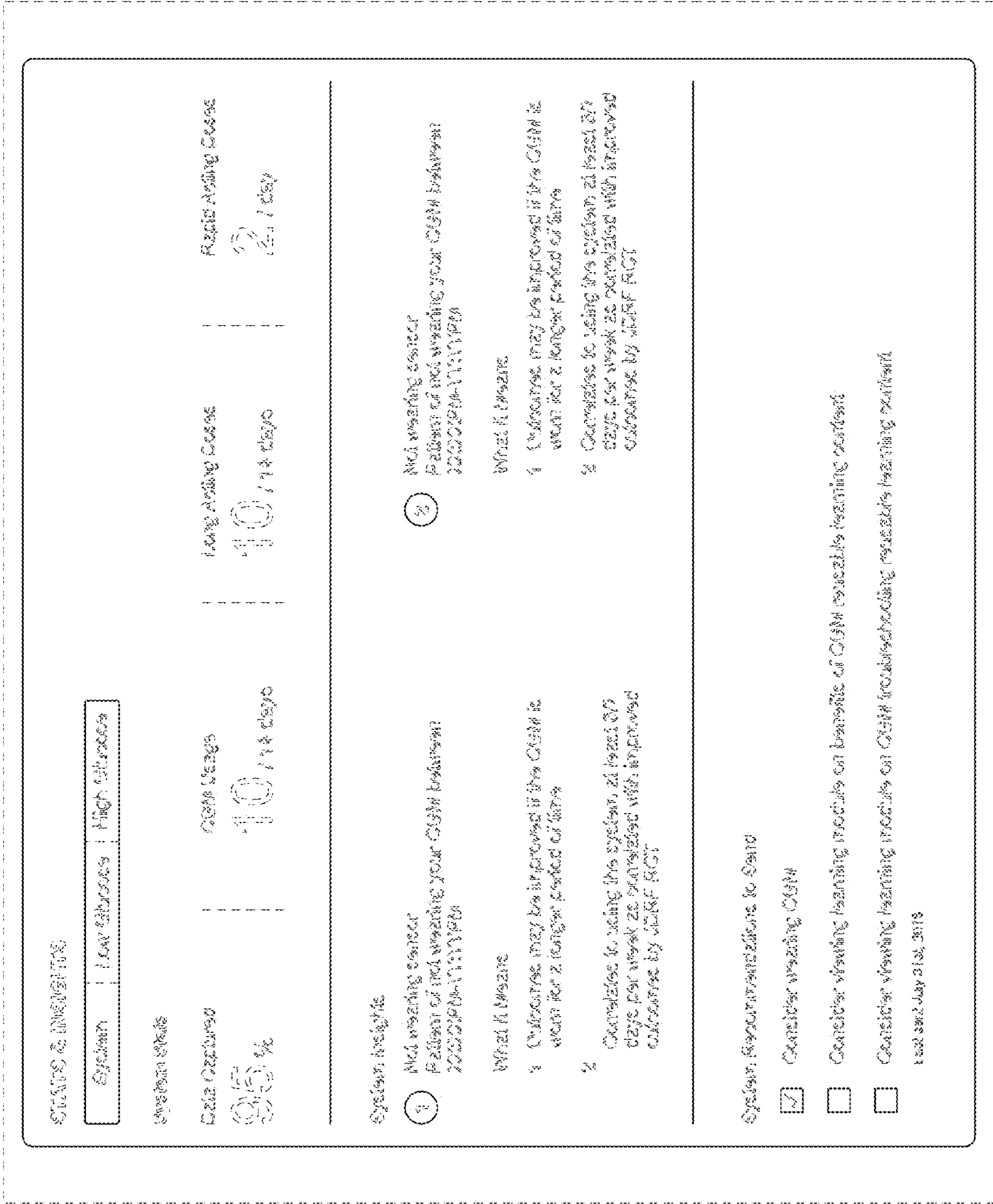

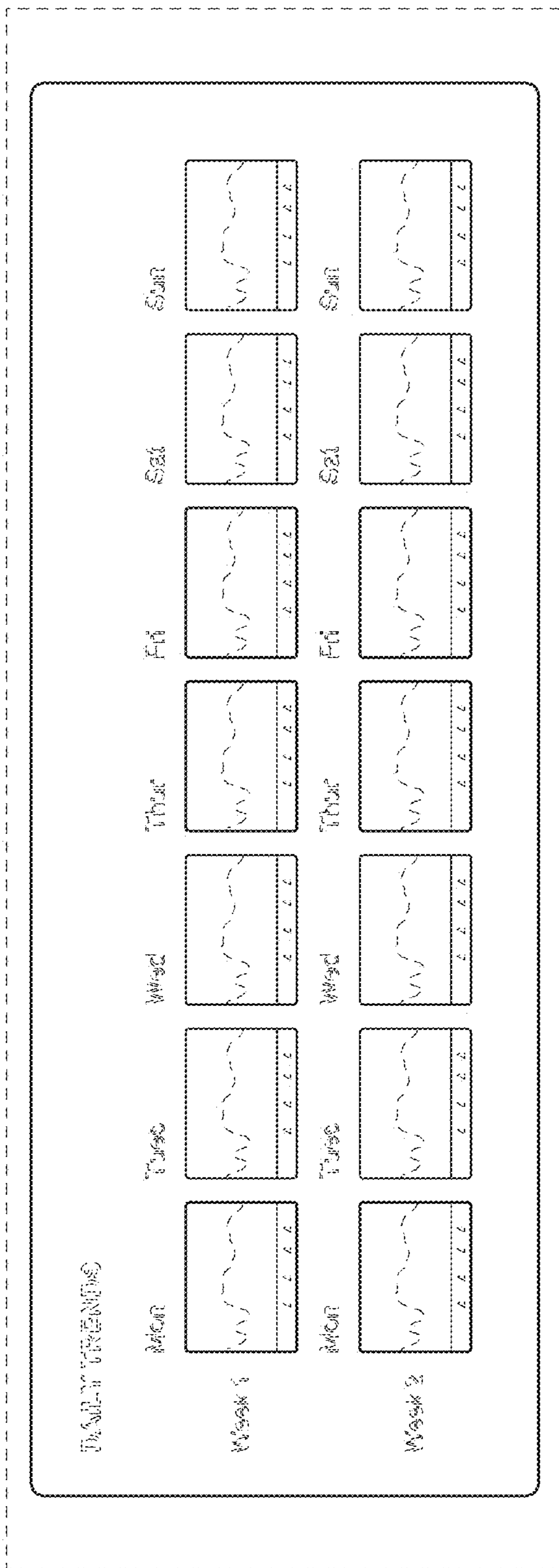

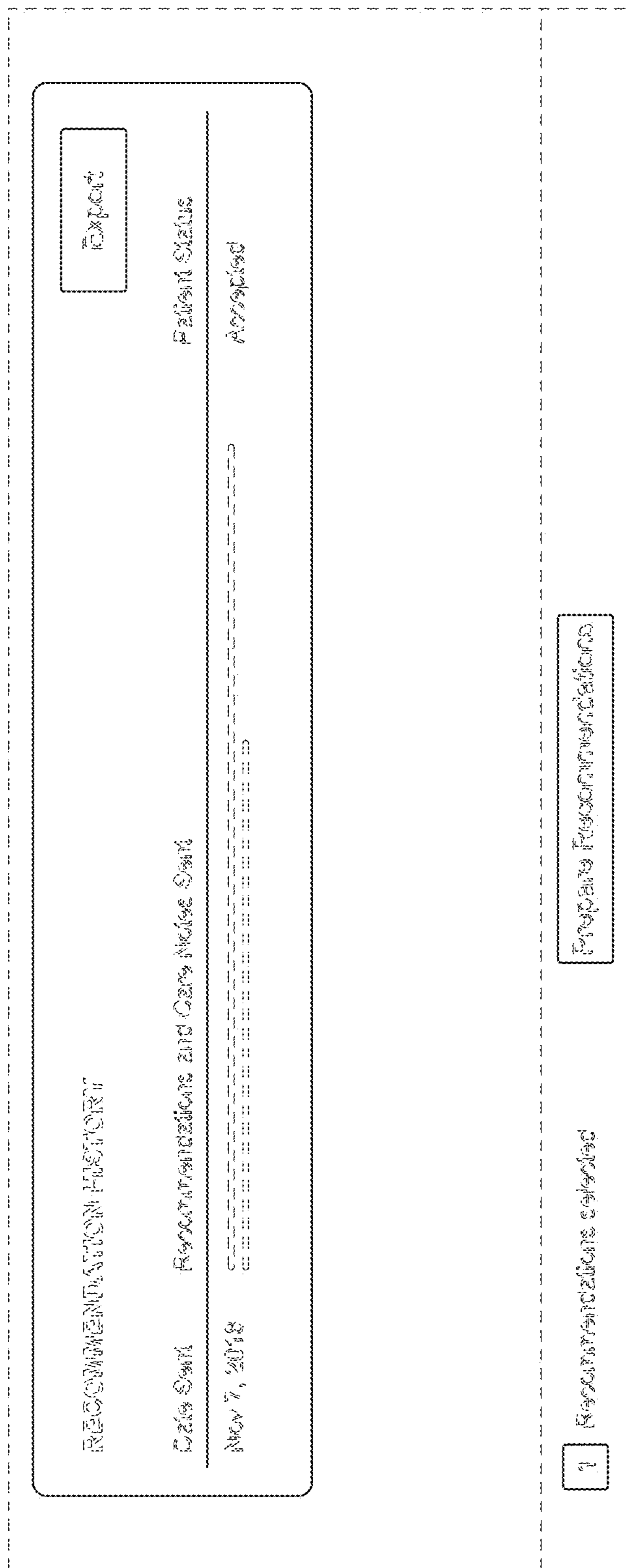
