The ornamental design for a display screen with animated icon, as shown and described.

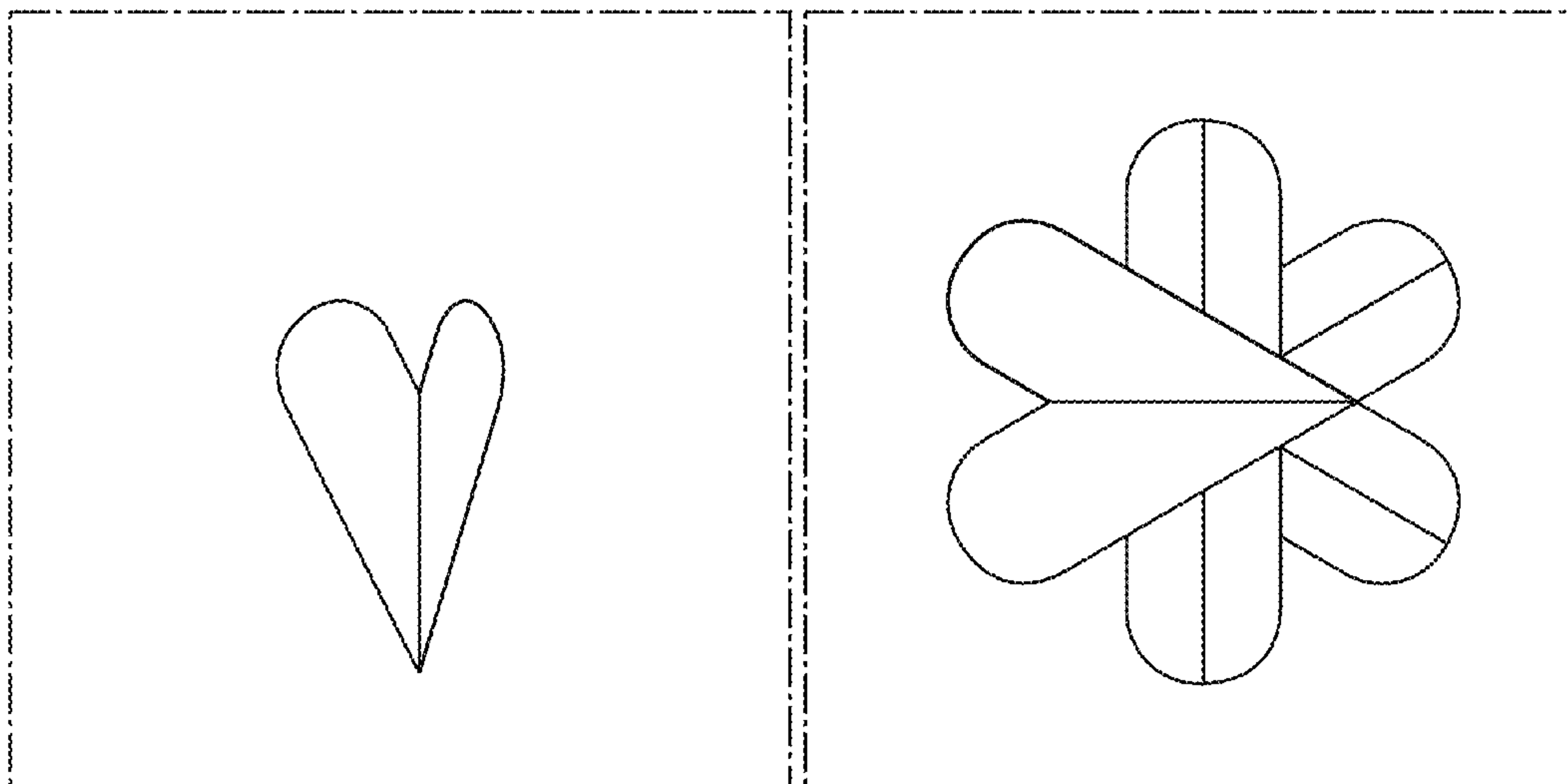
DESCRIPTION

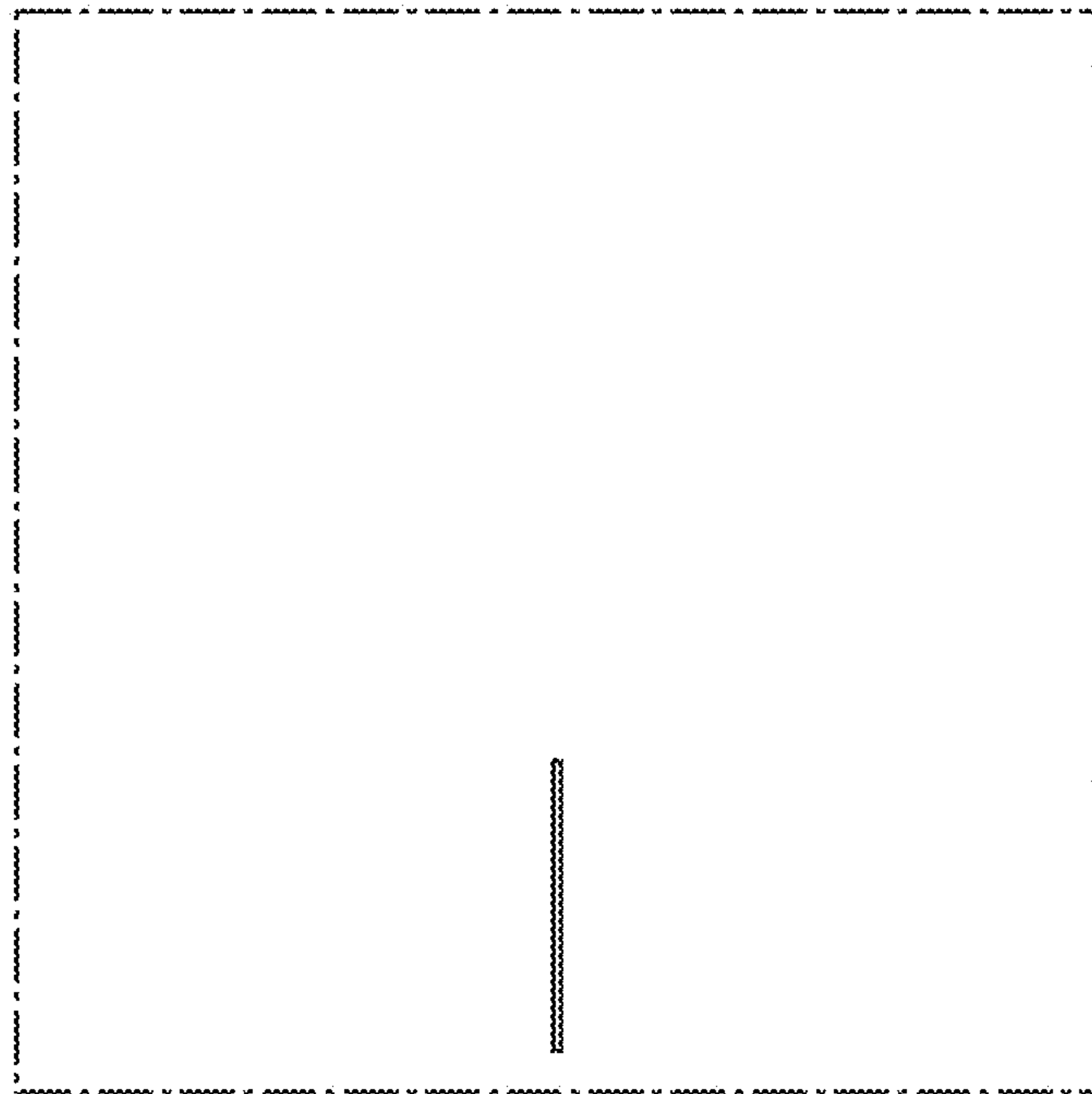

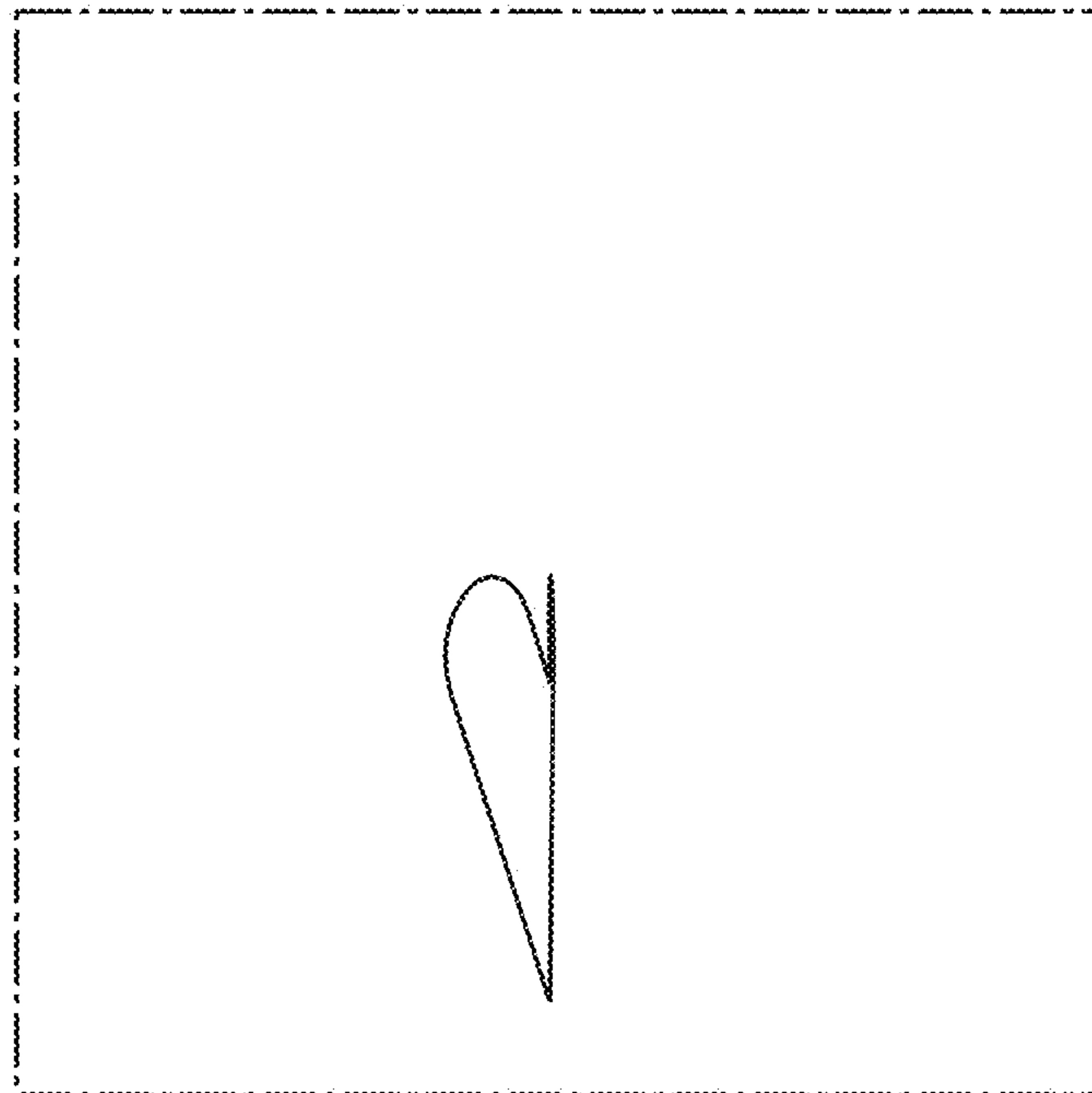

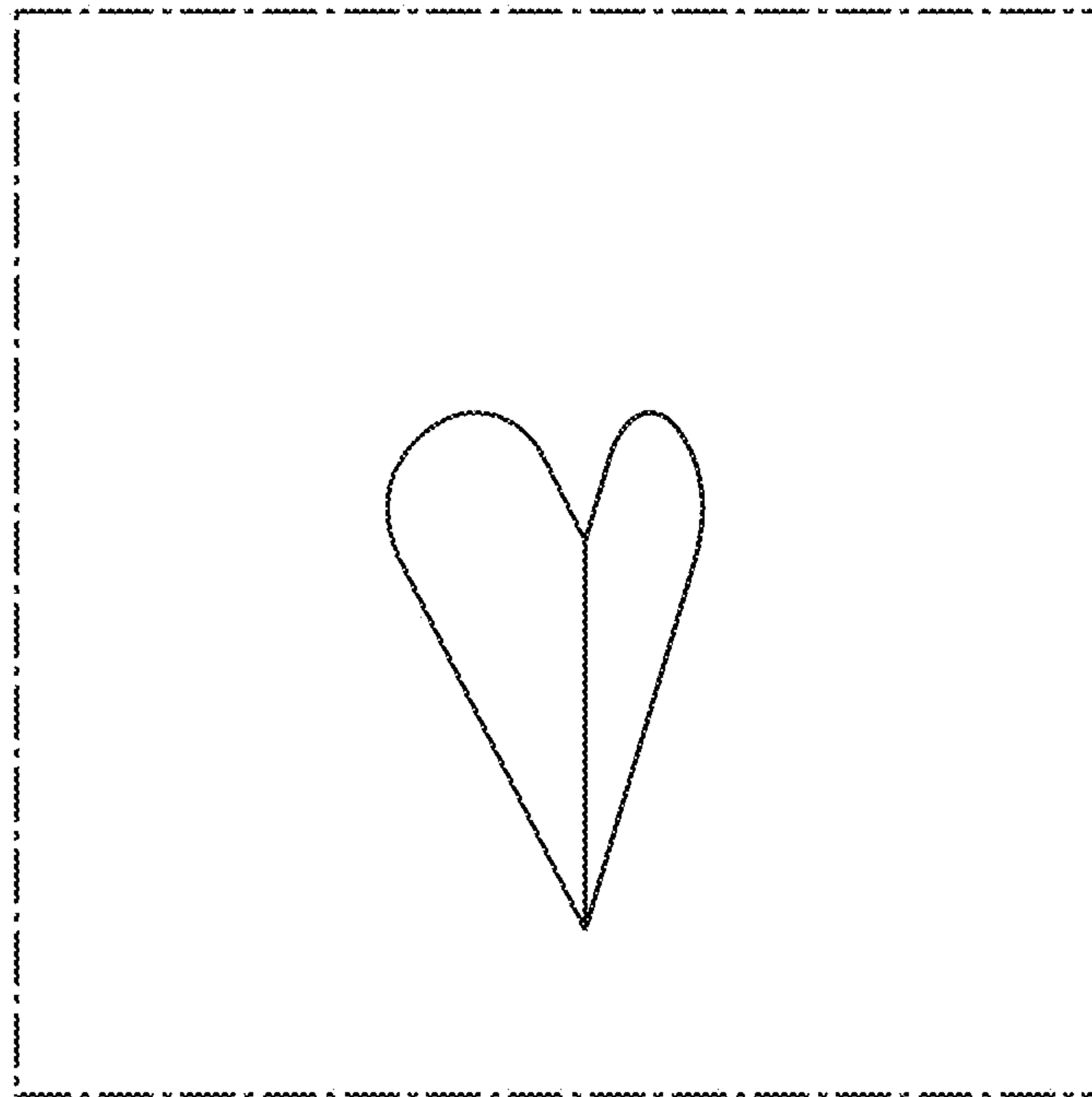

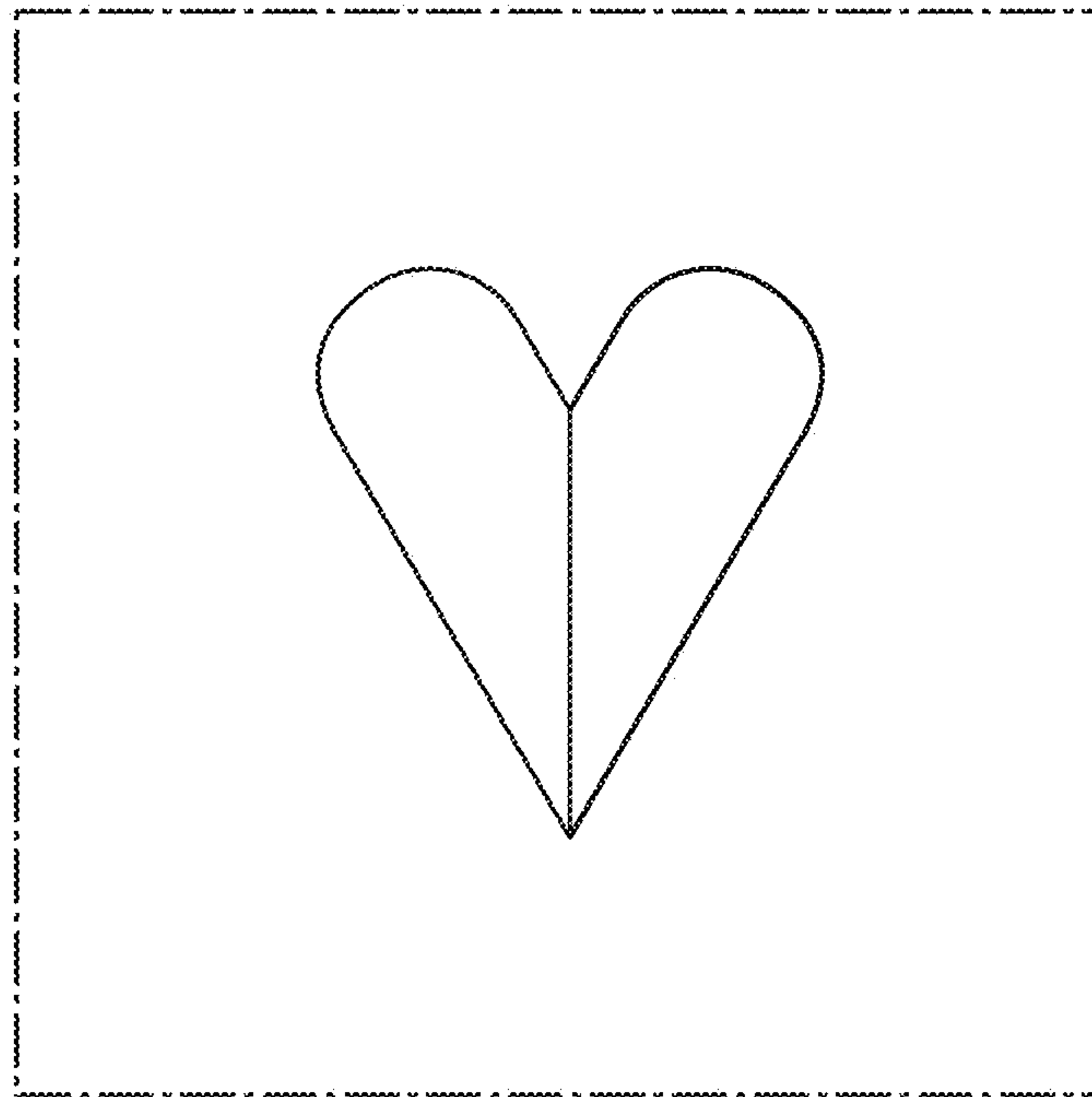

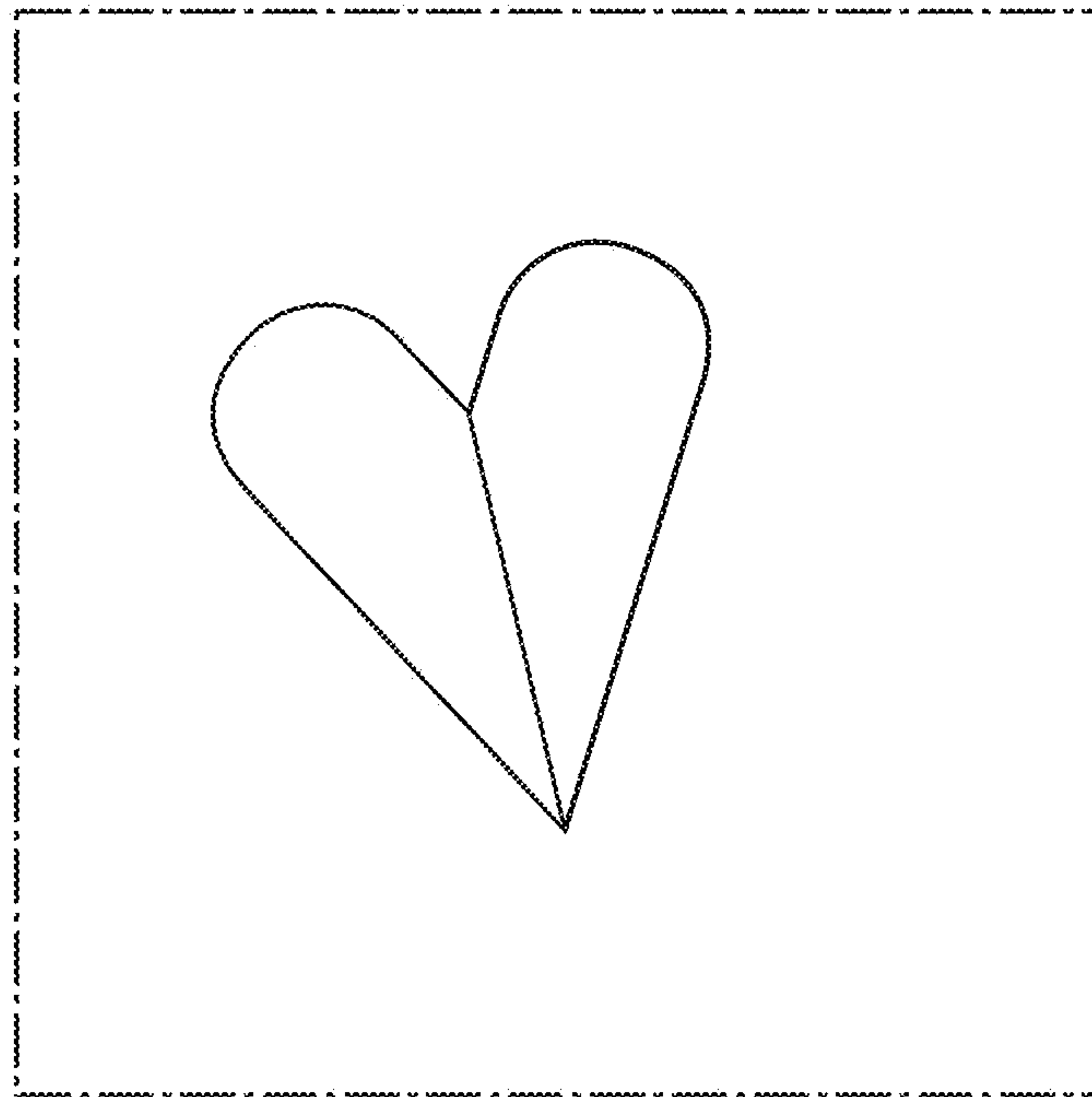

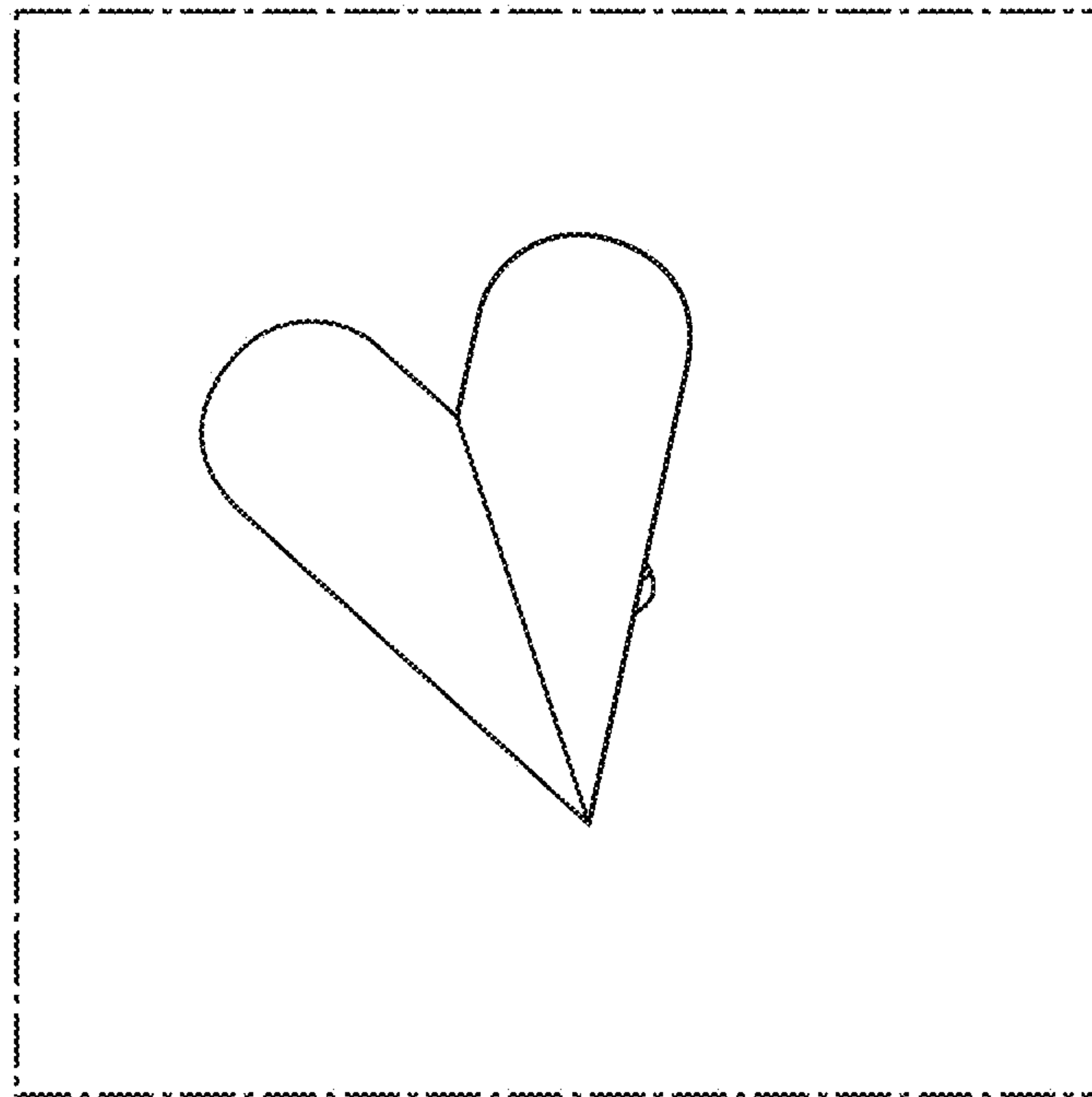

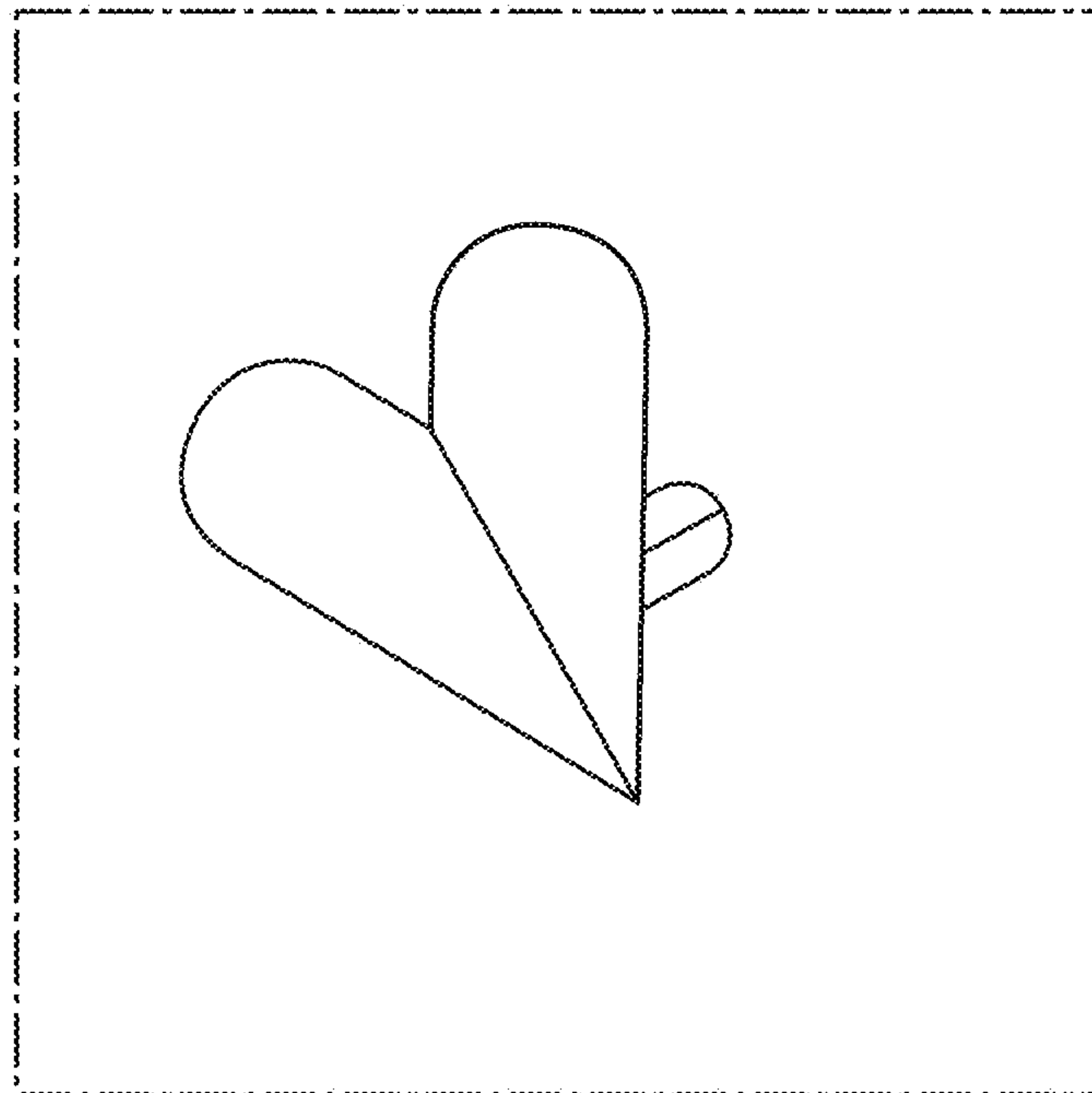

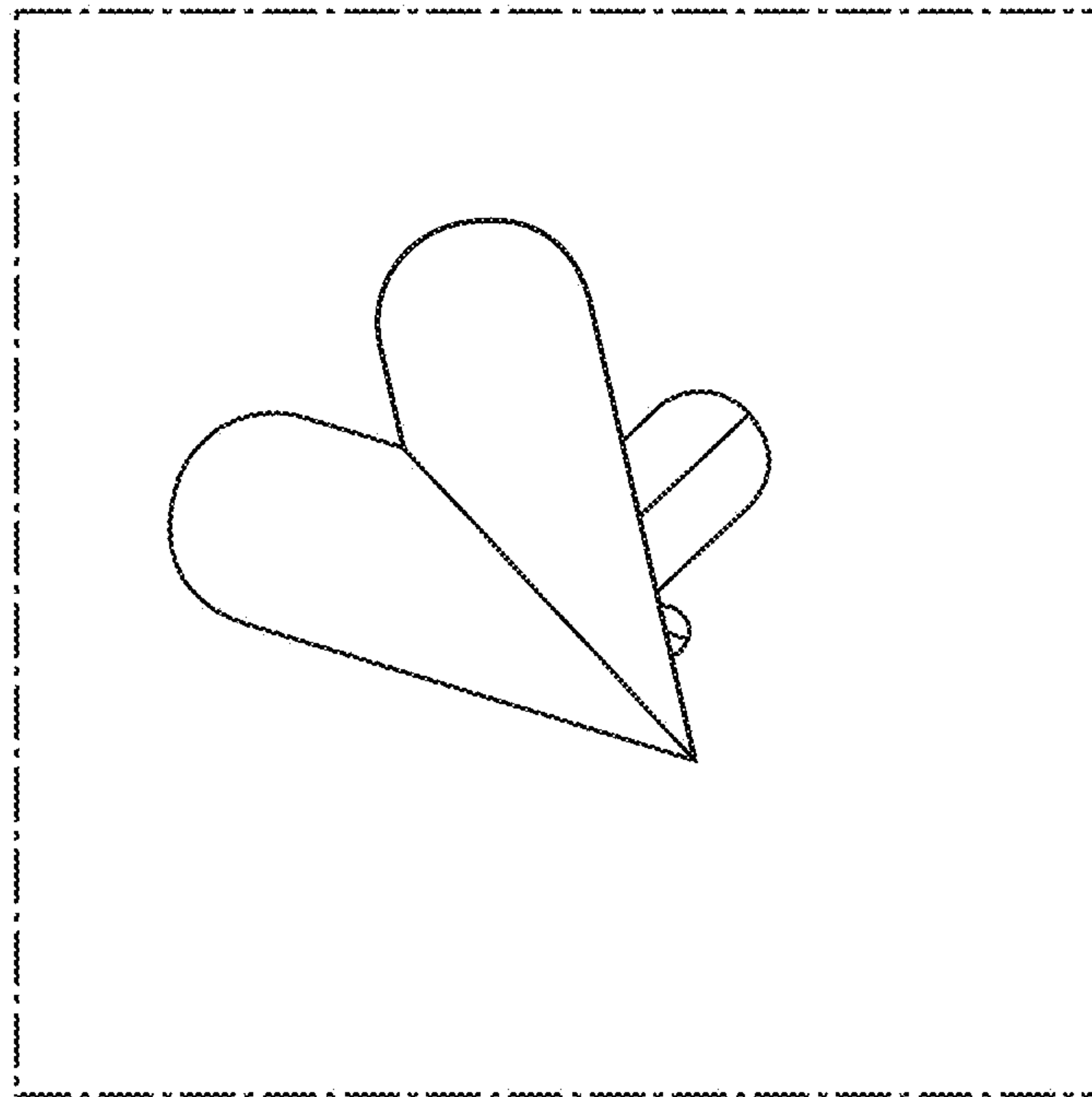

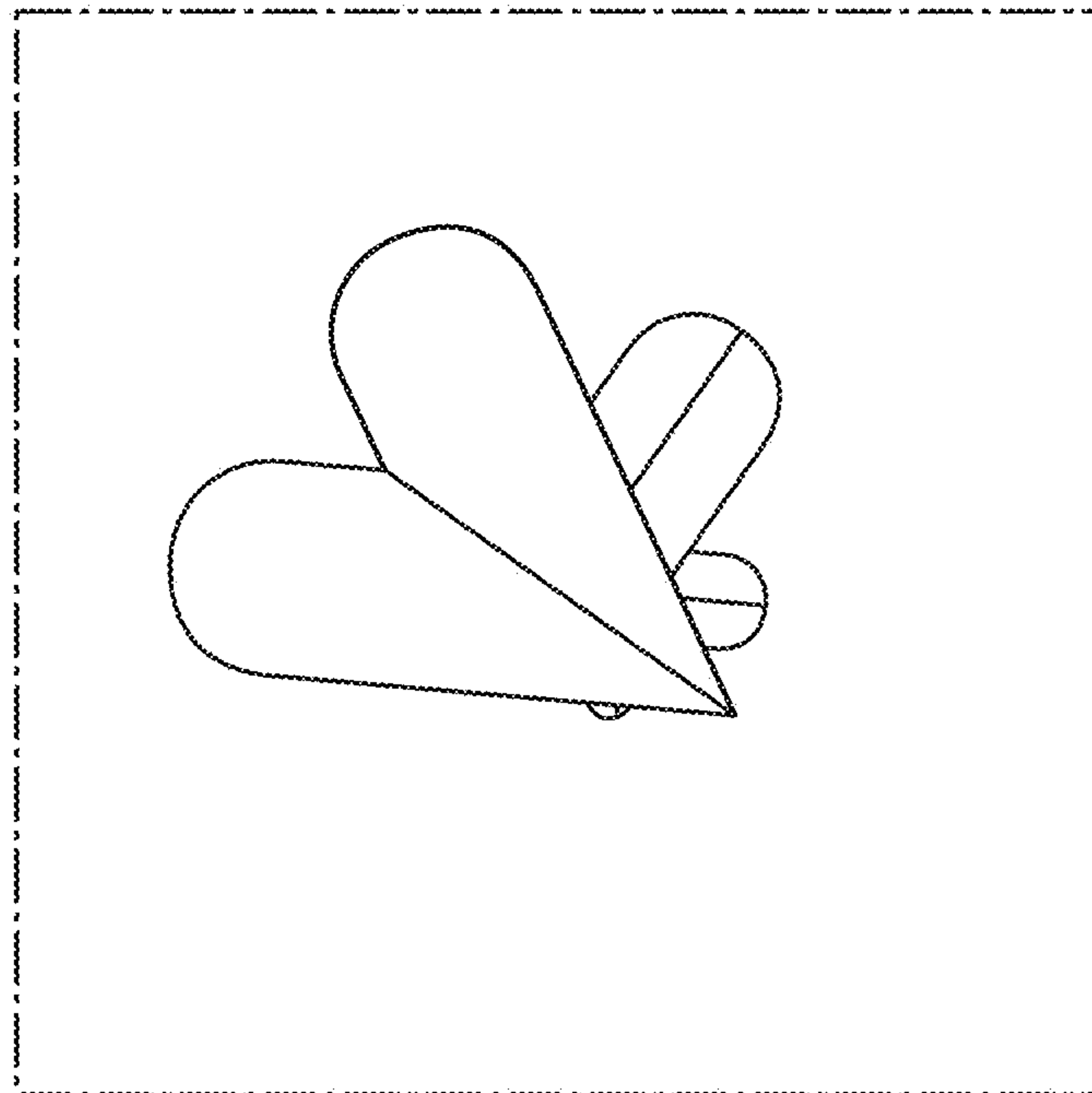

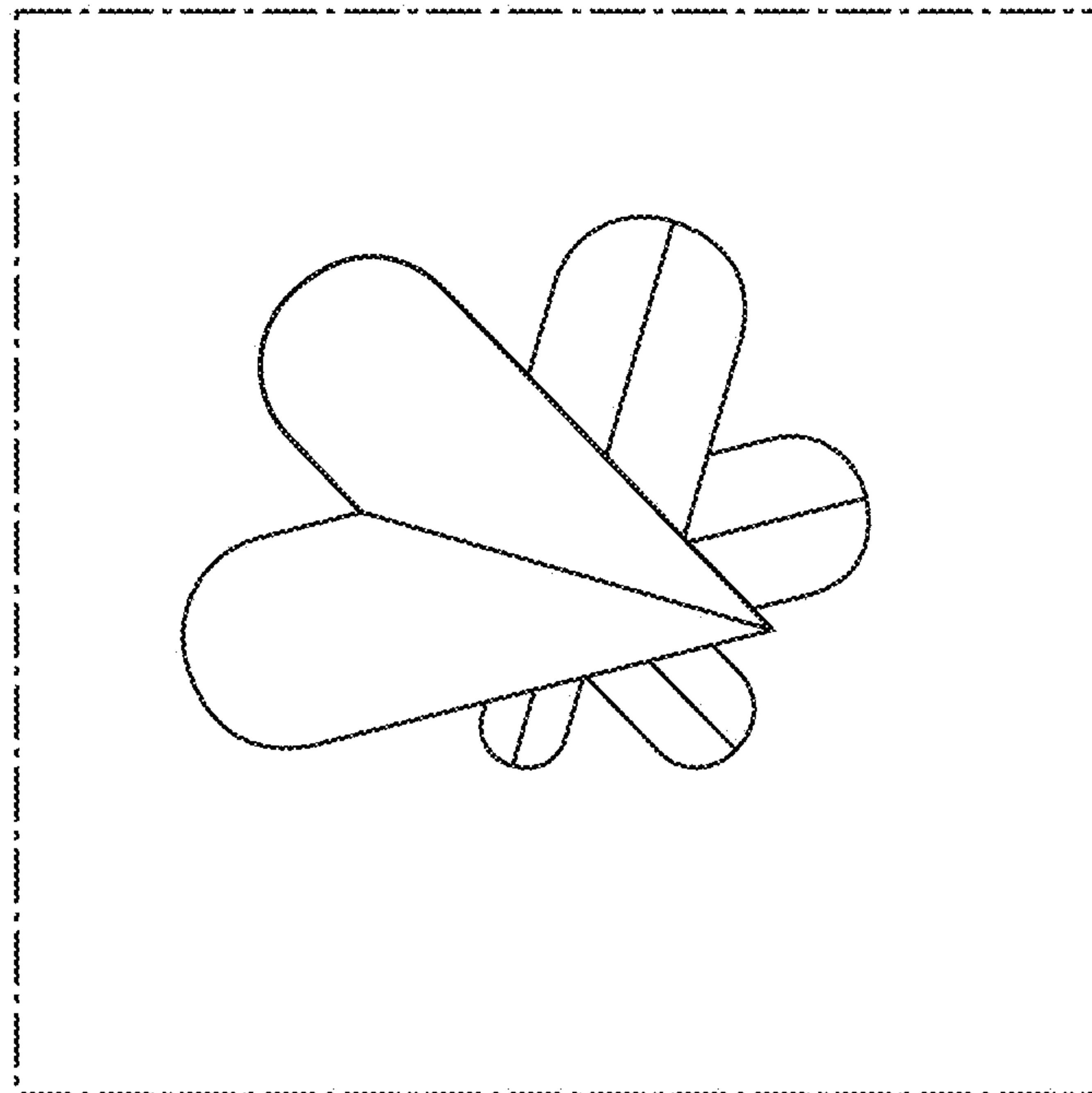

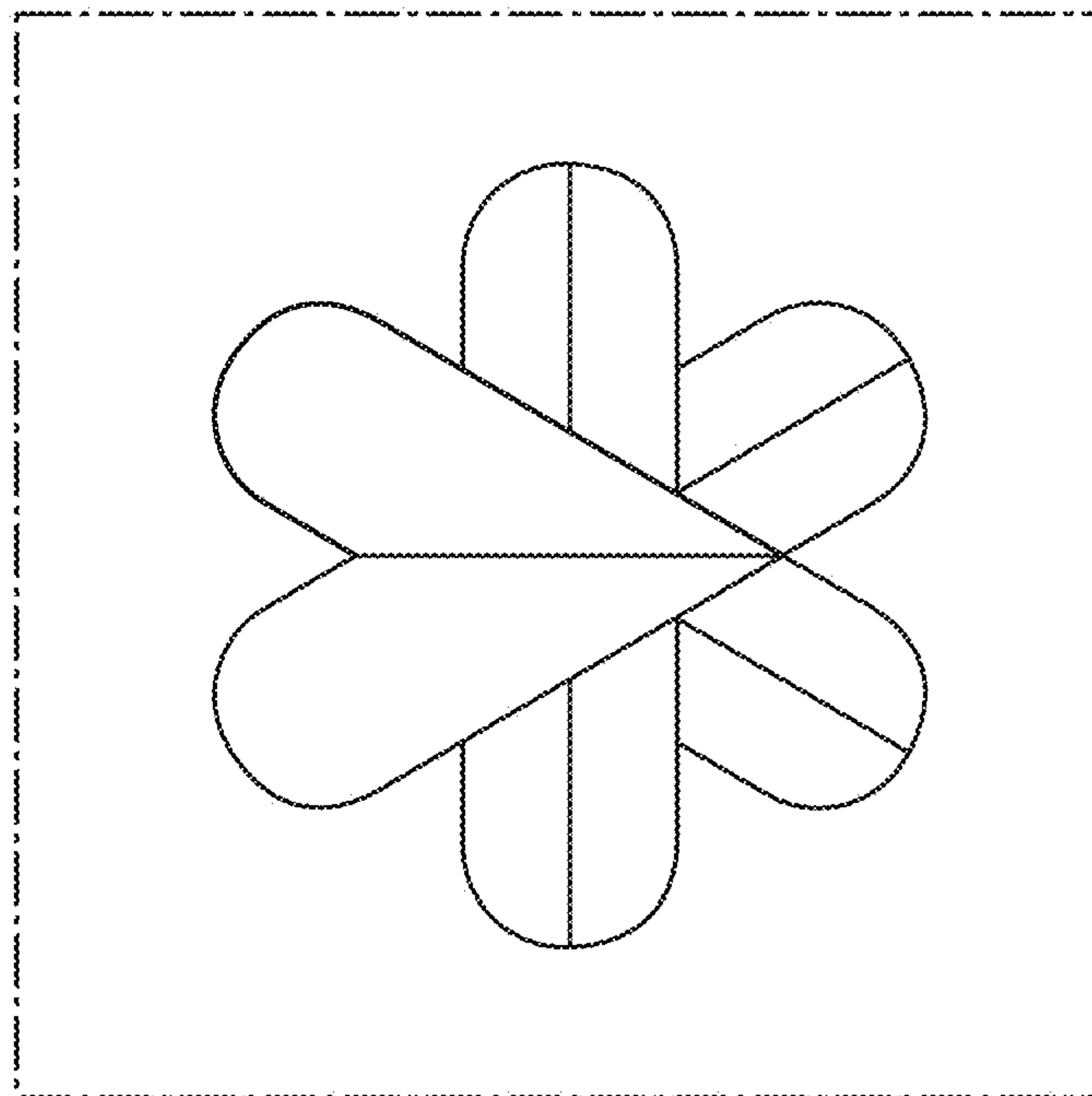
