DESCRIPTION

FIG. 12 is a top view thereof;

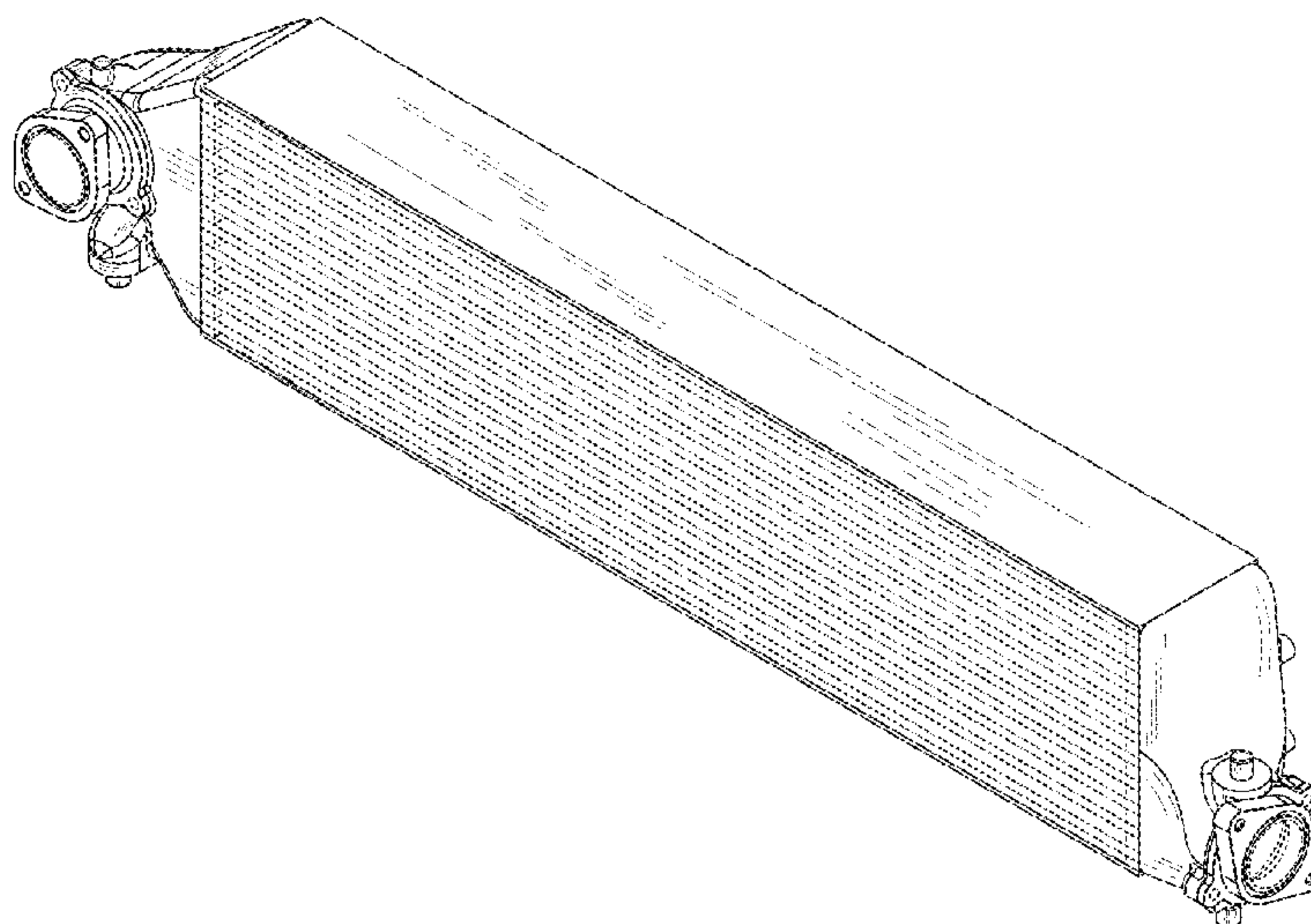
FIG. 13 is bottom view thereof; and,

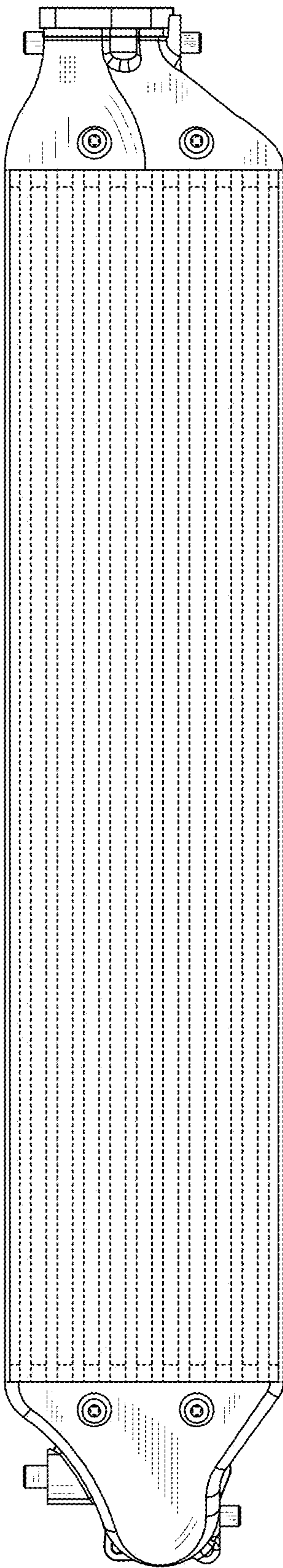

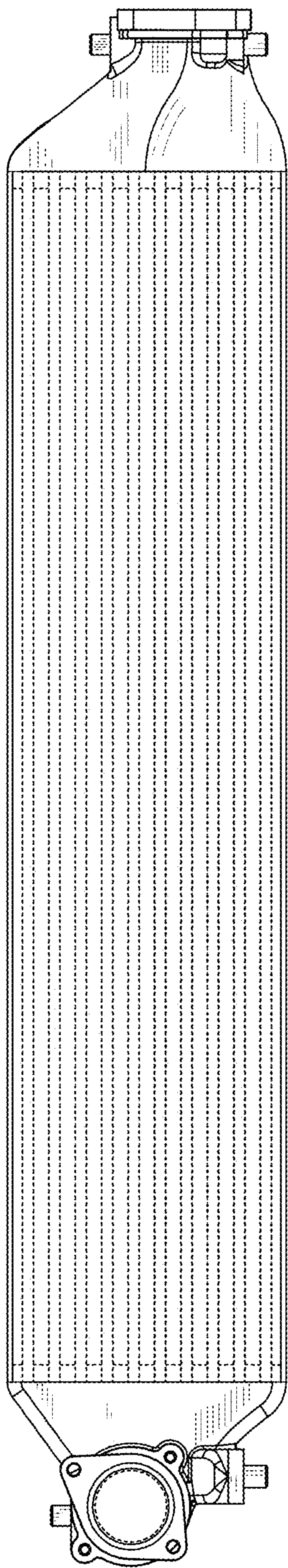

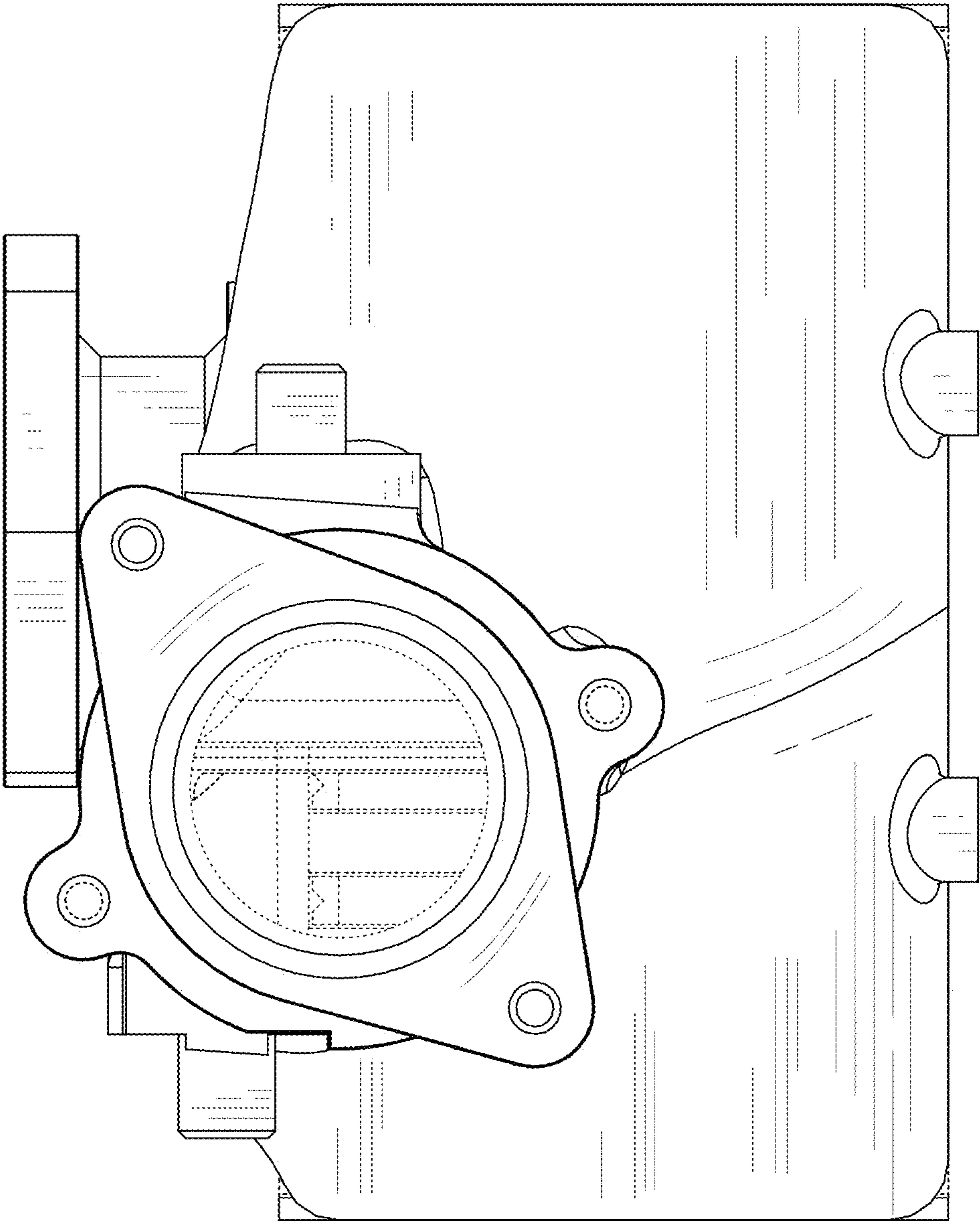

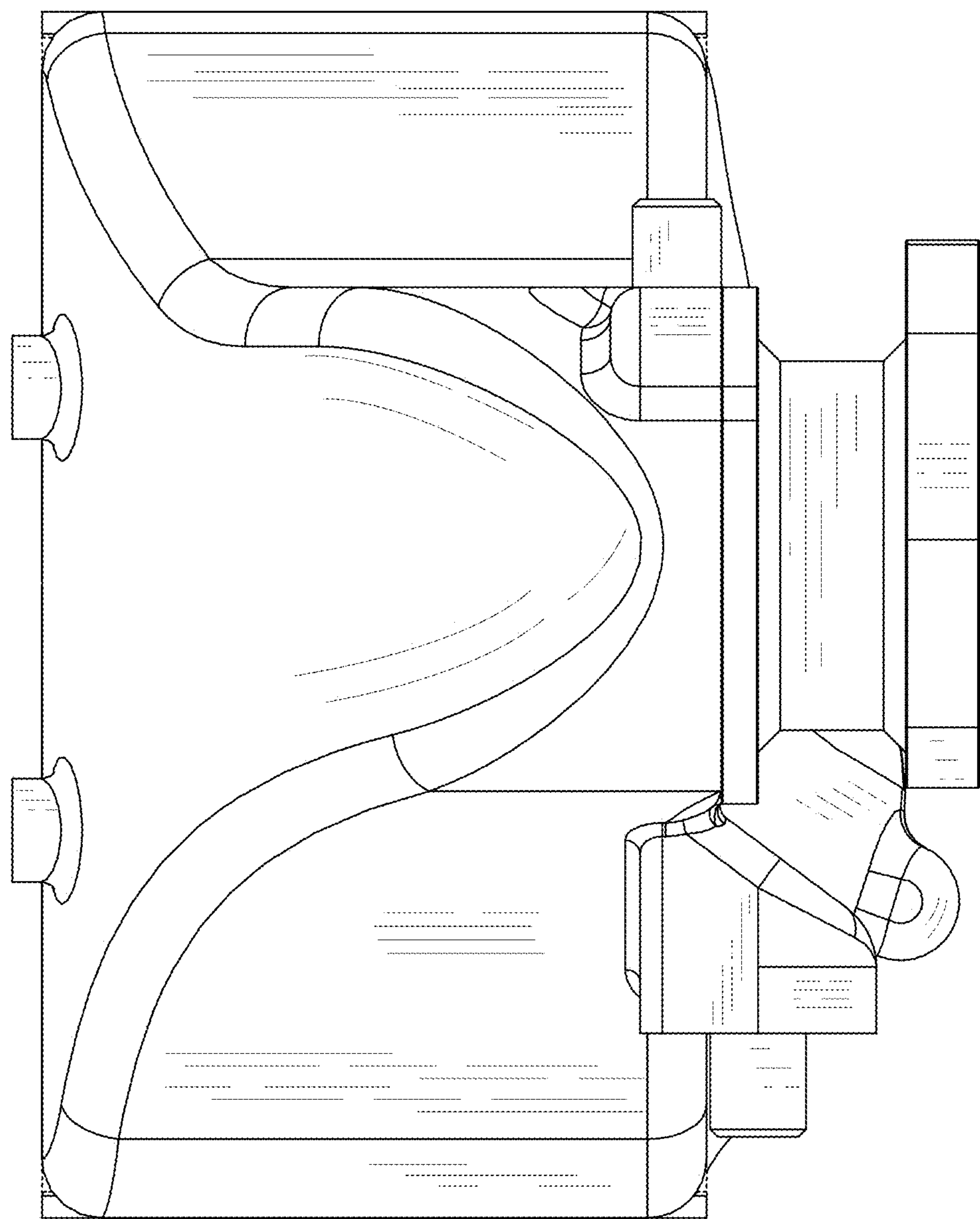

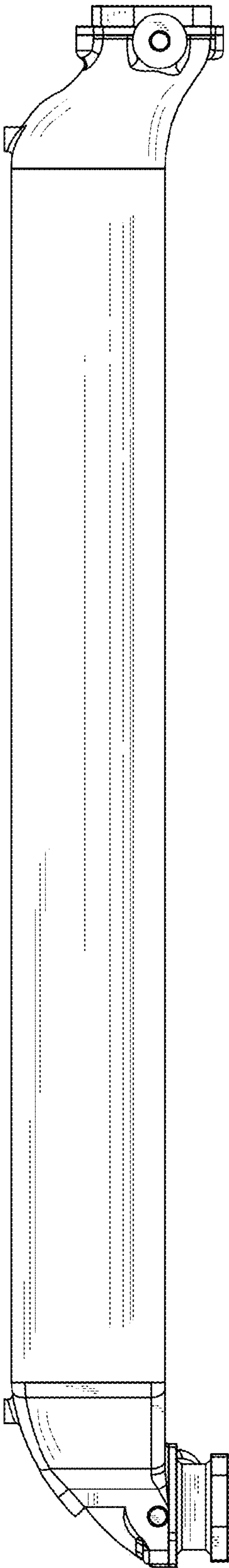

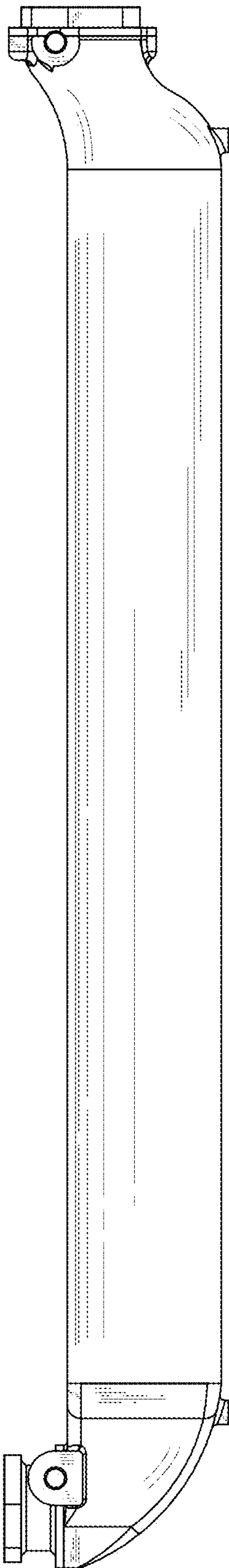

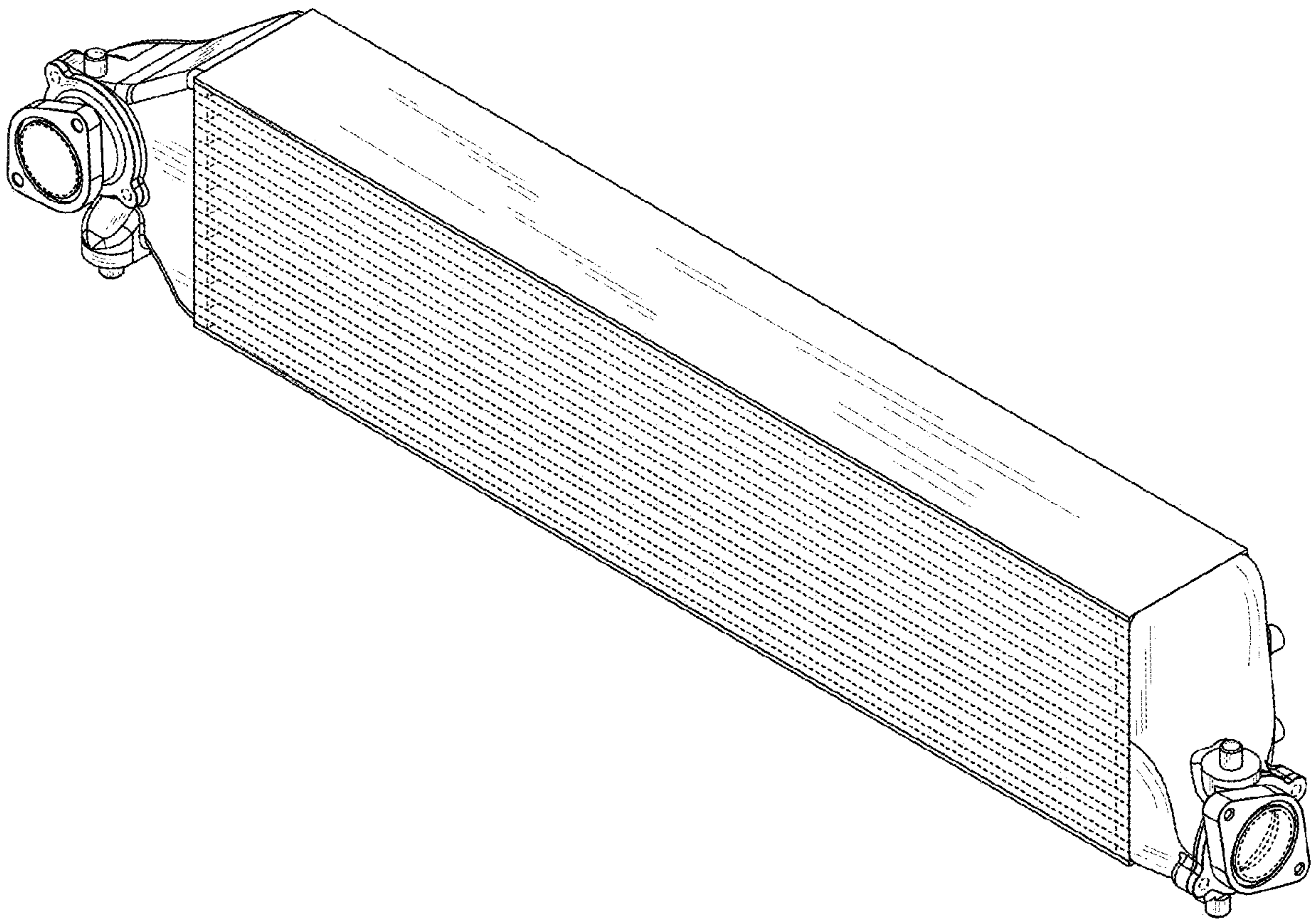

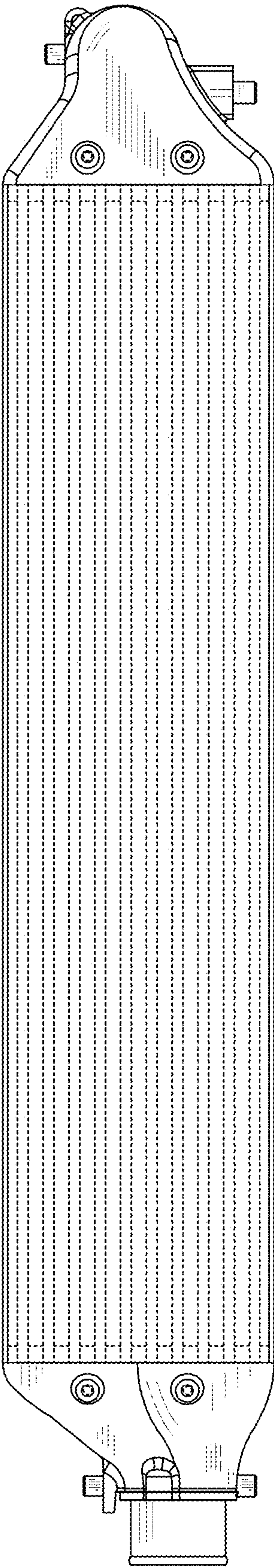

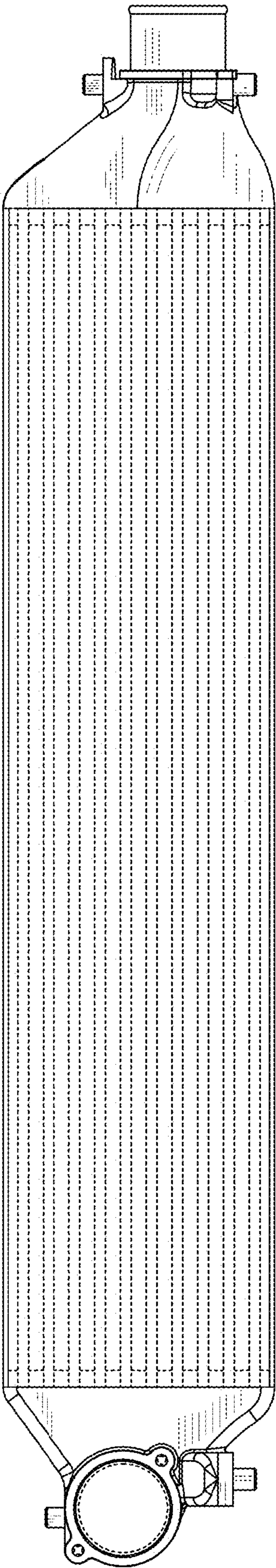

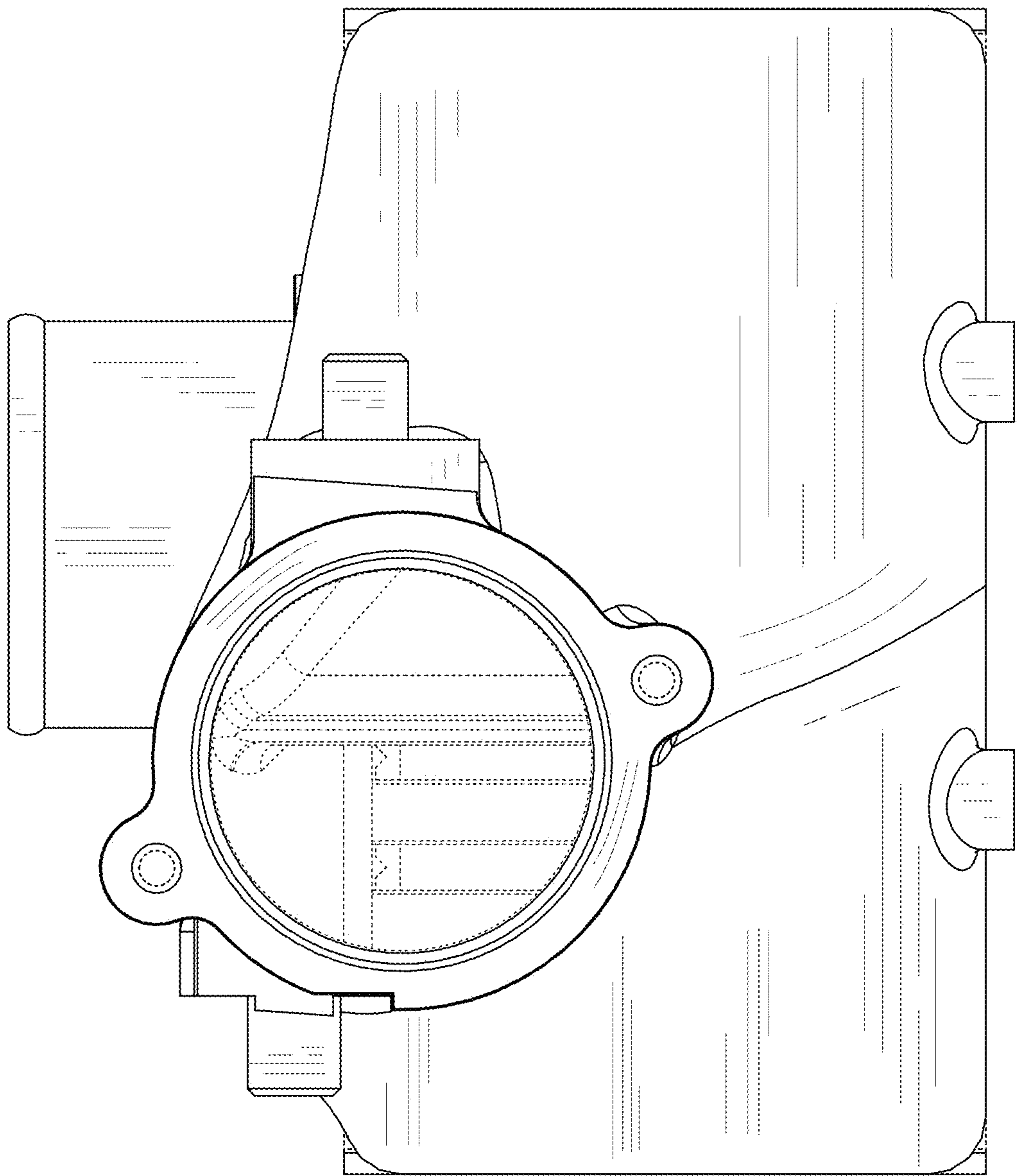

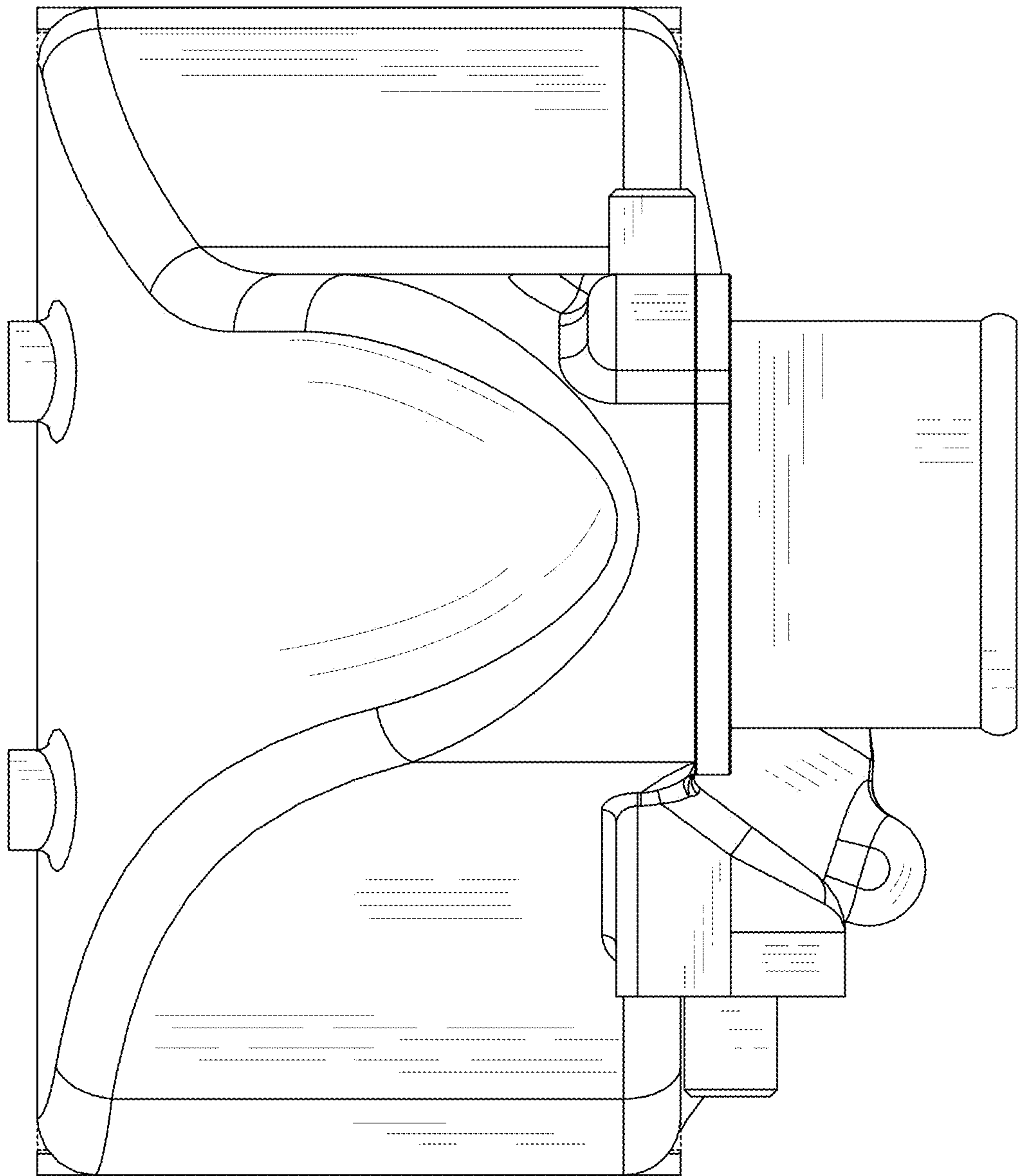

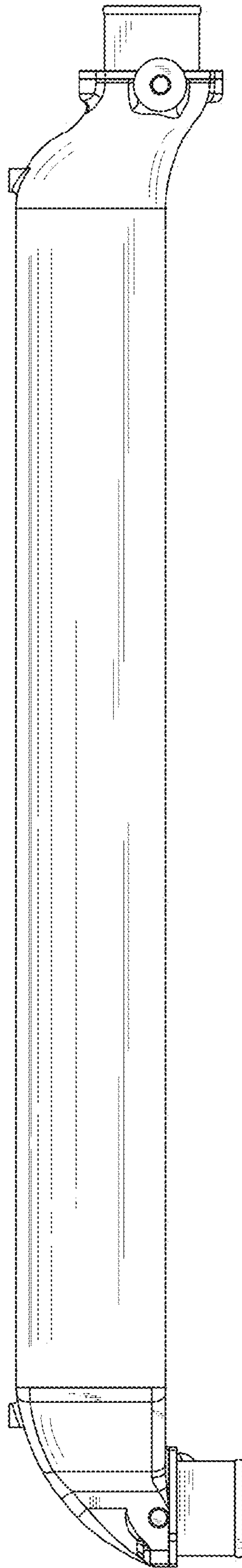

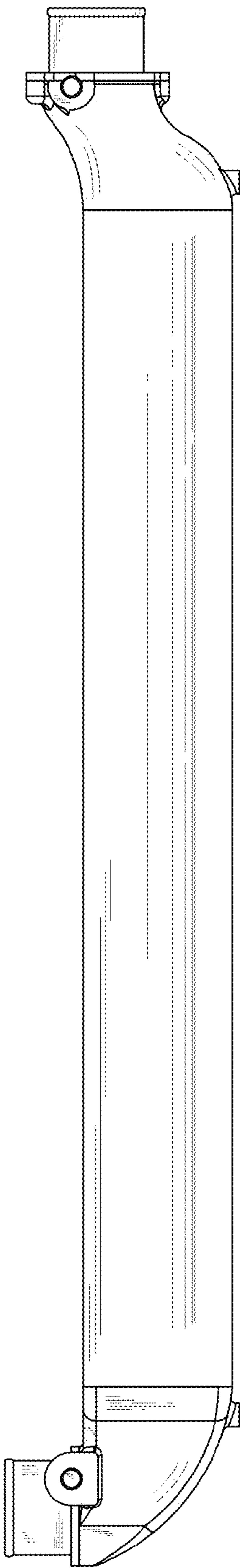

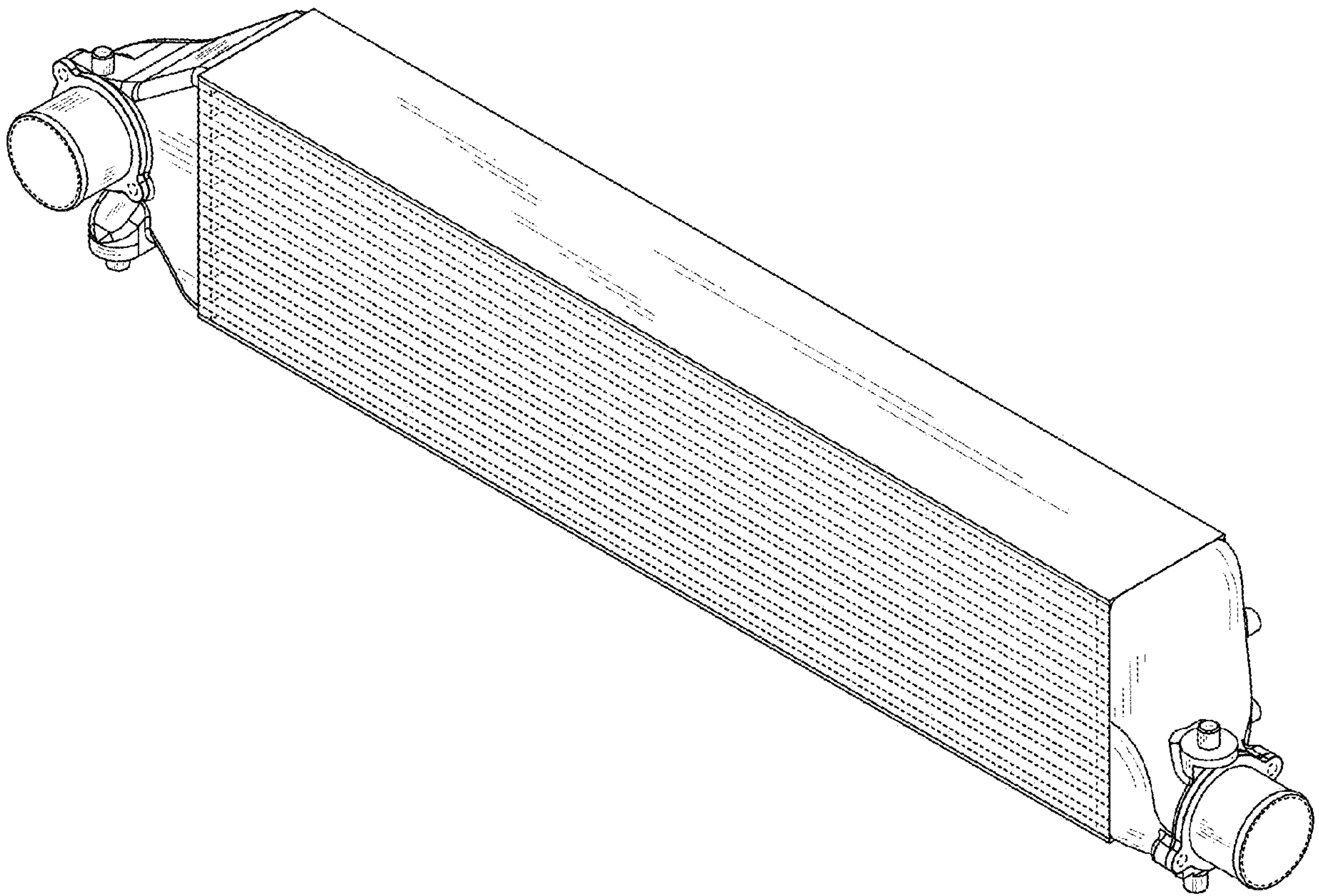
