The ornamental design for a tractor, as shown and described.

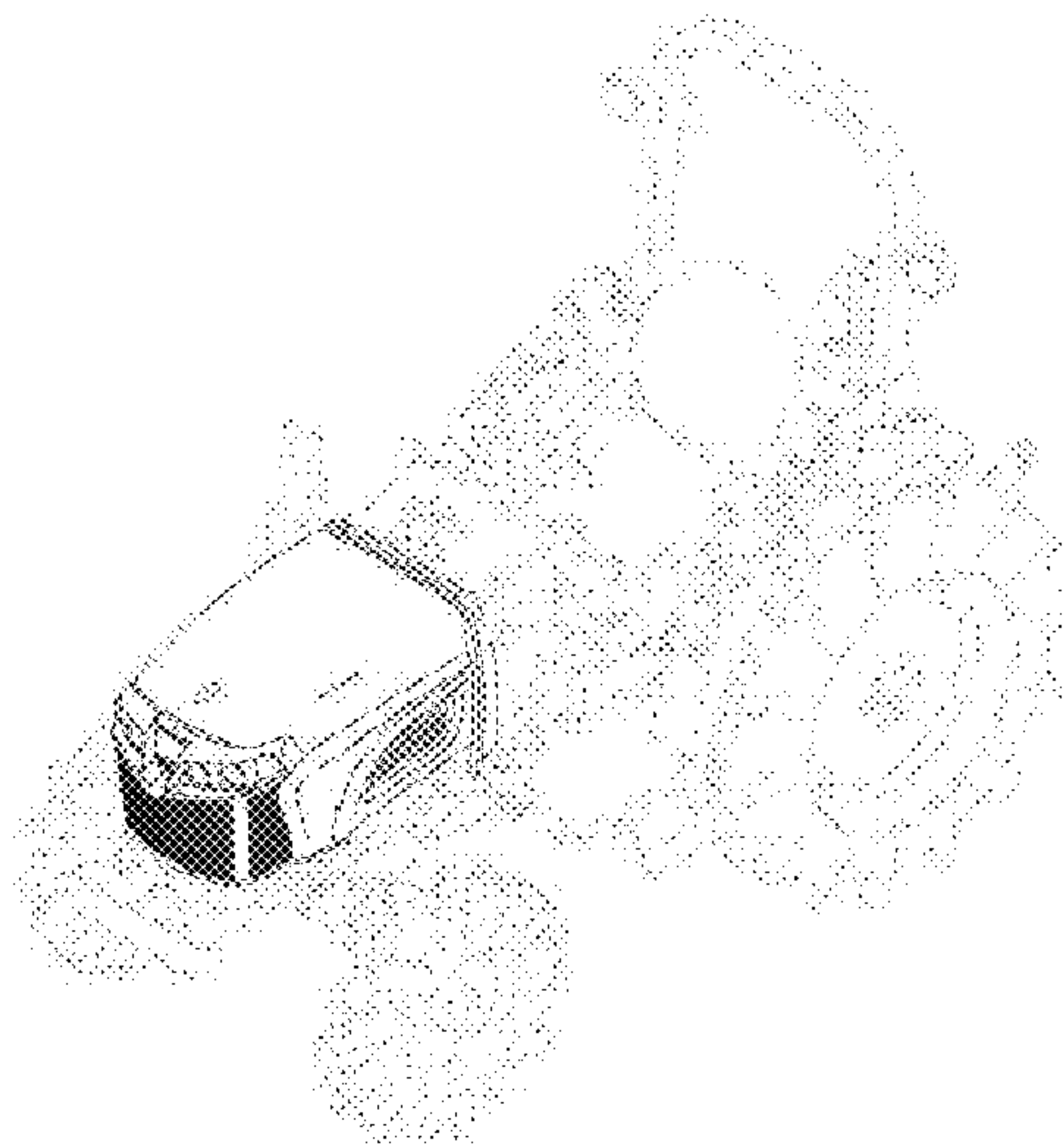
DESCRIPTION

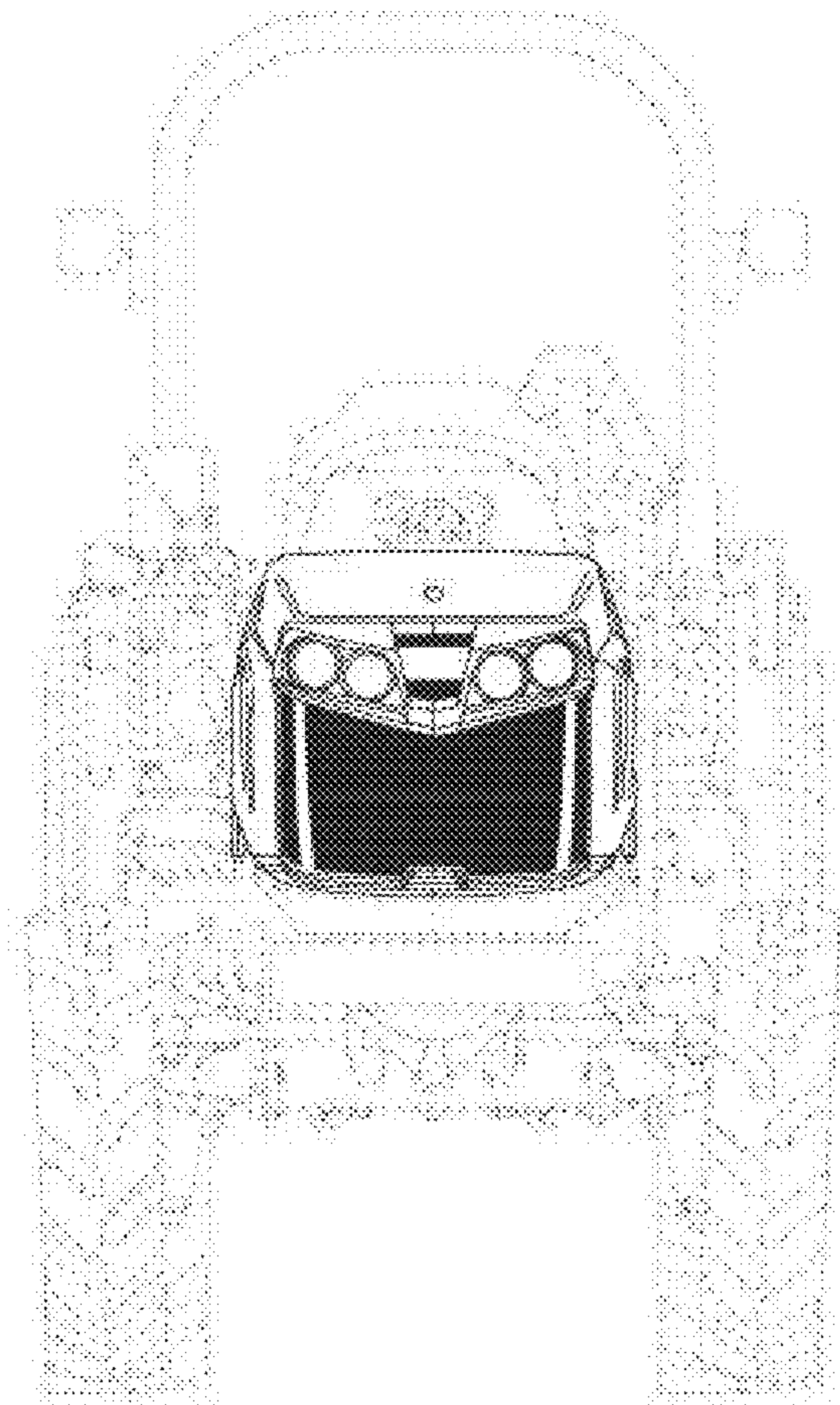

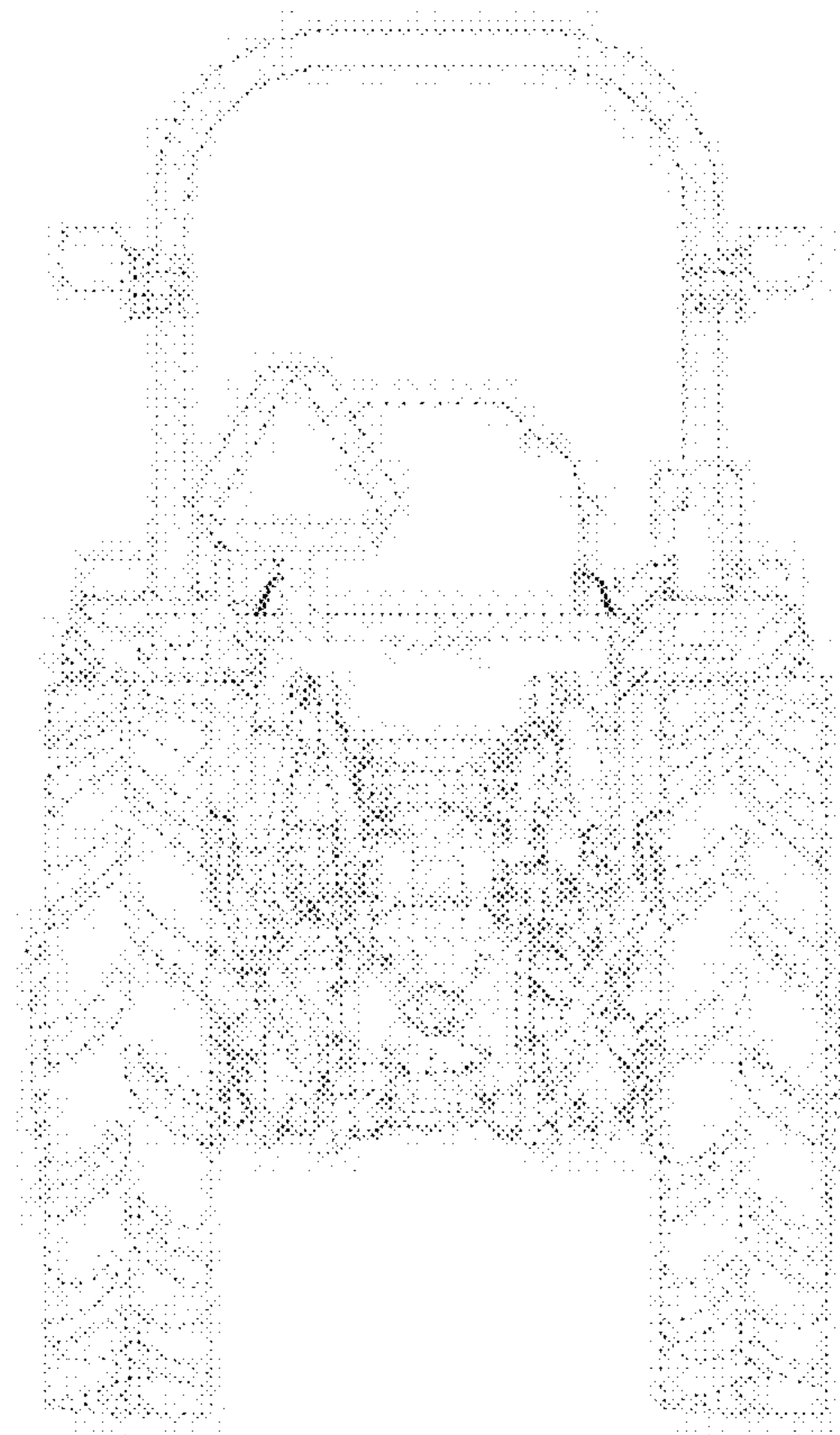

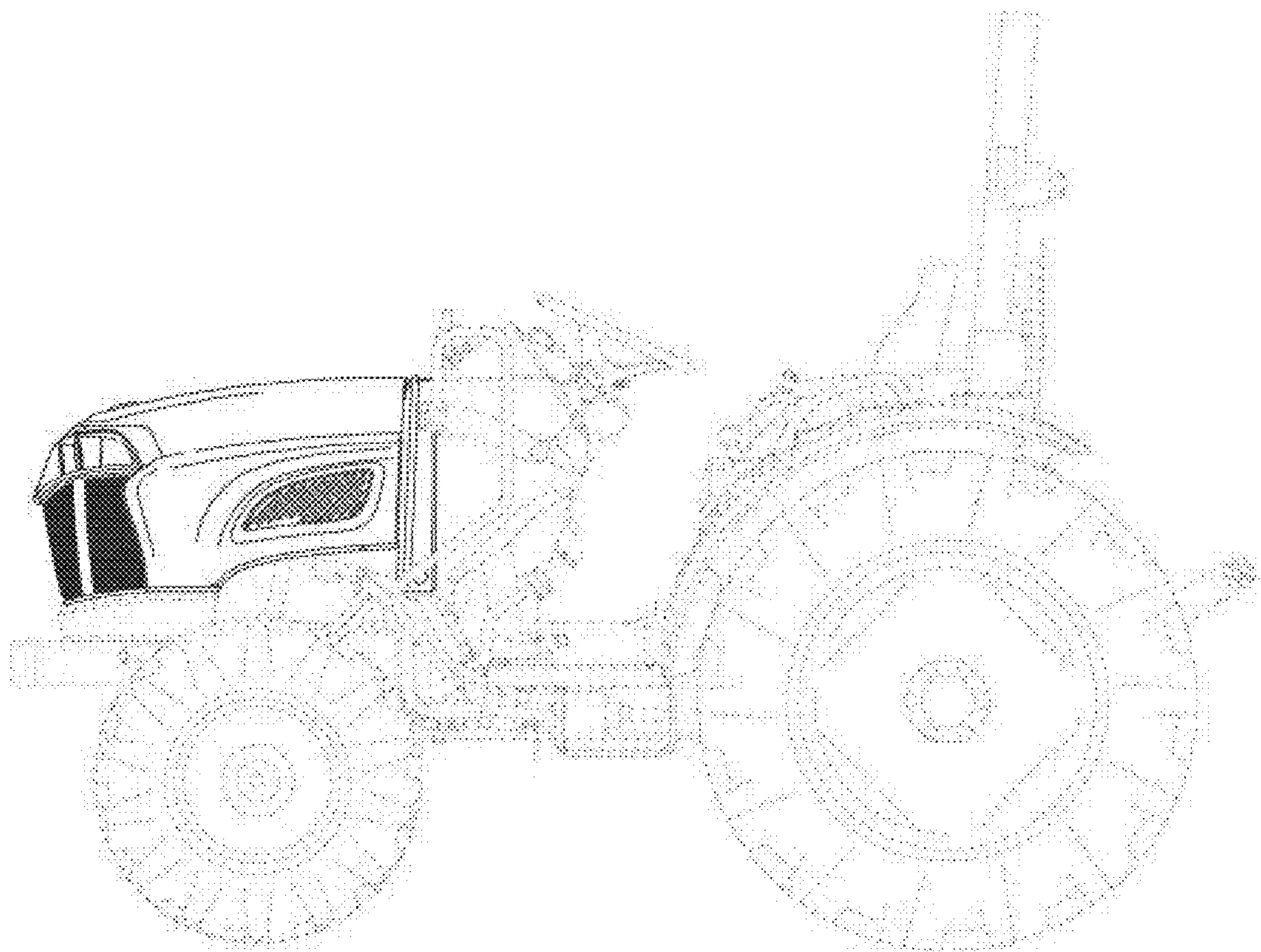

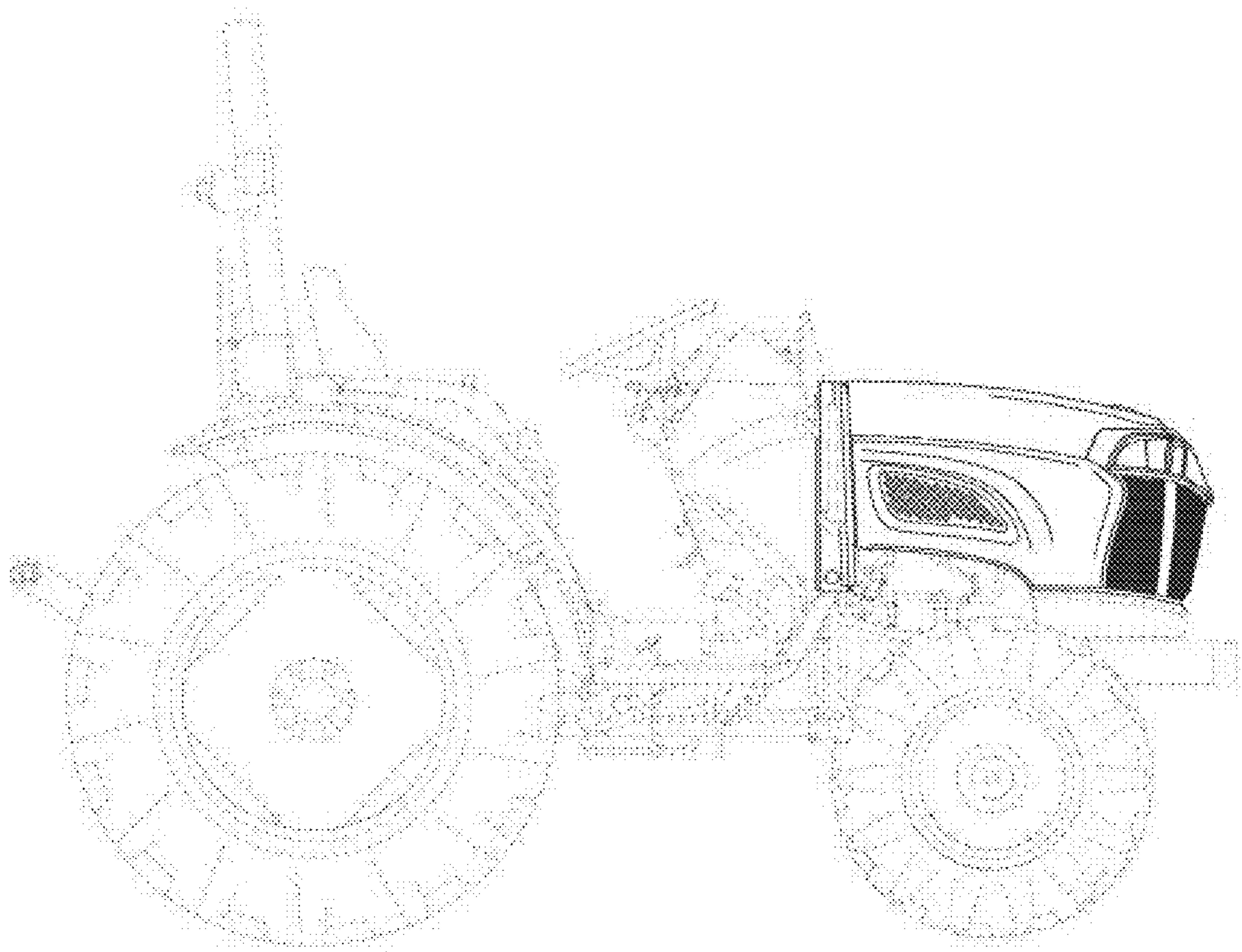

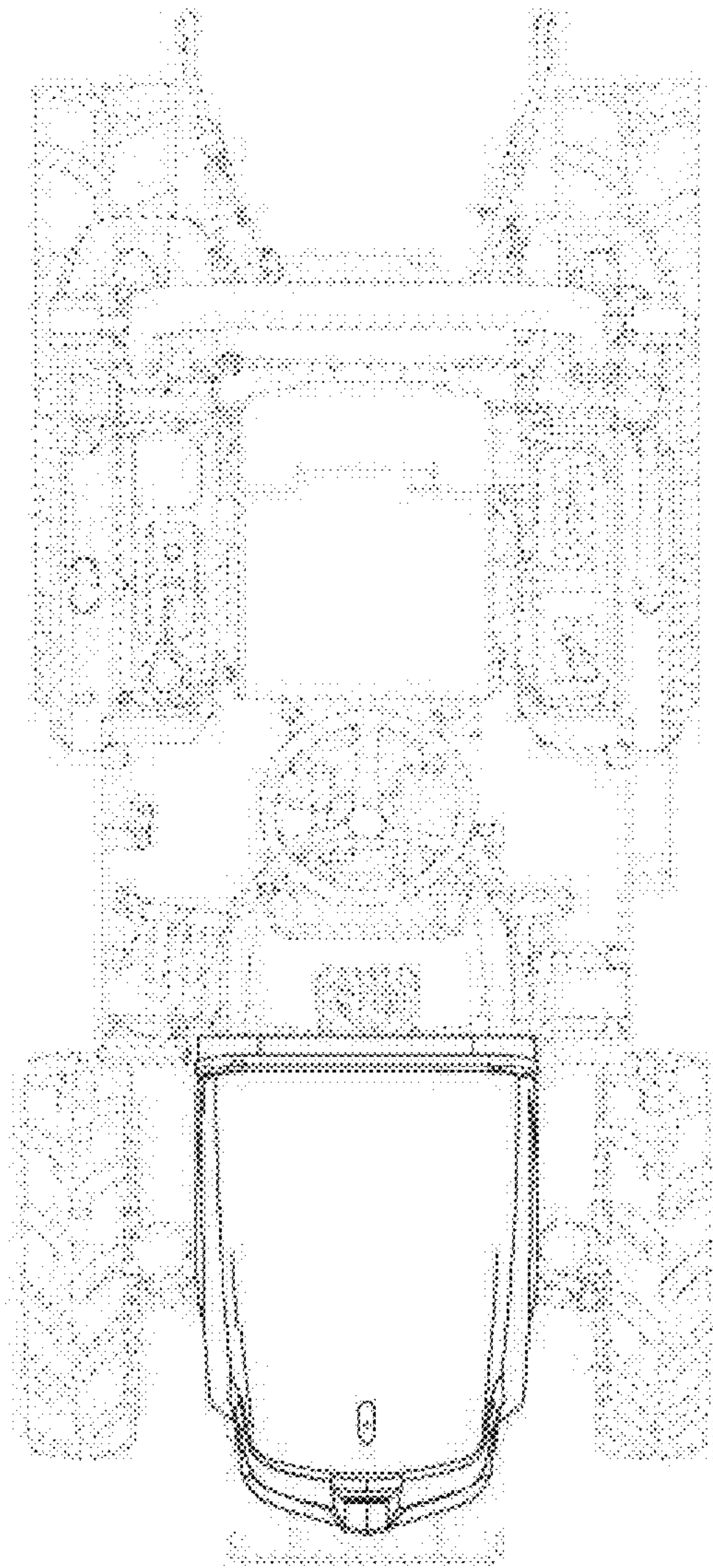
