(57) **CLAIM**

The ornamental design for a crane cab interior component, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a crane cab interior component showing our new design in an assembled condition;

FIG. 2 is a front perspective view of a crane cab interior component showing our new design in an unassembled condition set apart from the cab of FIG. 1 for ease of illustration;

FIG. 3 is a rear view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a front view thereof;

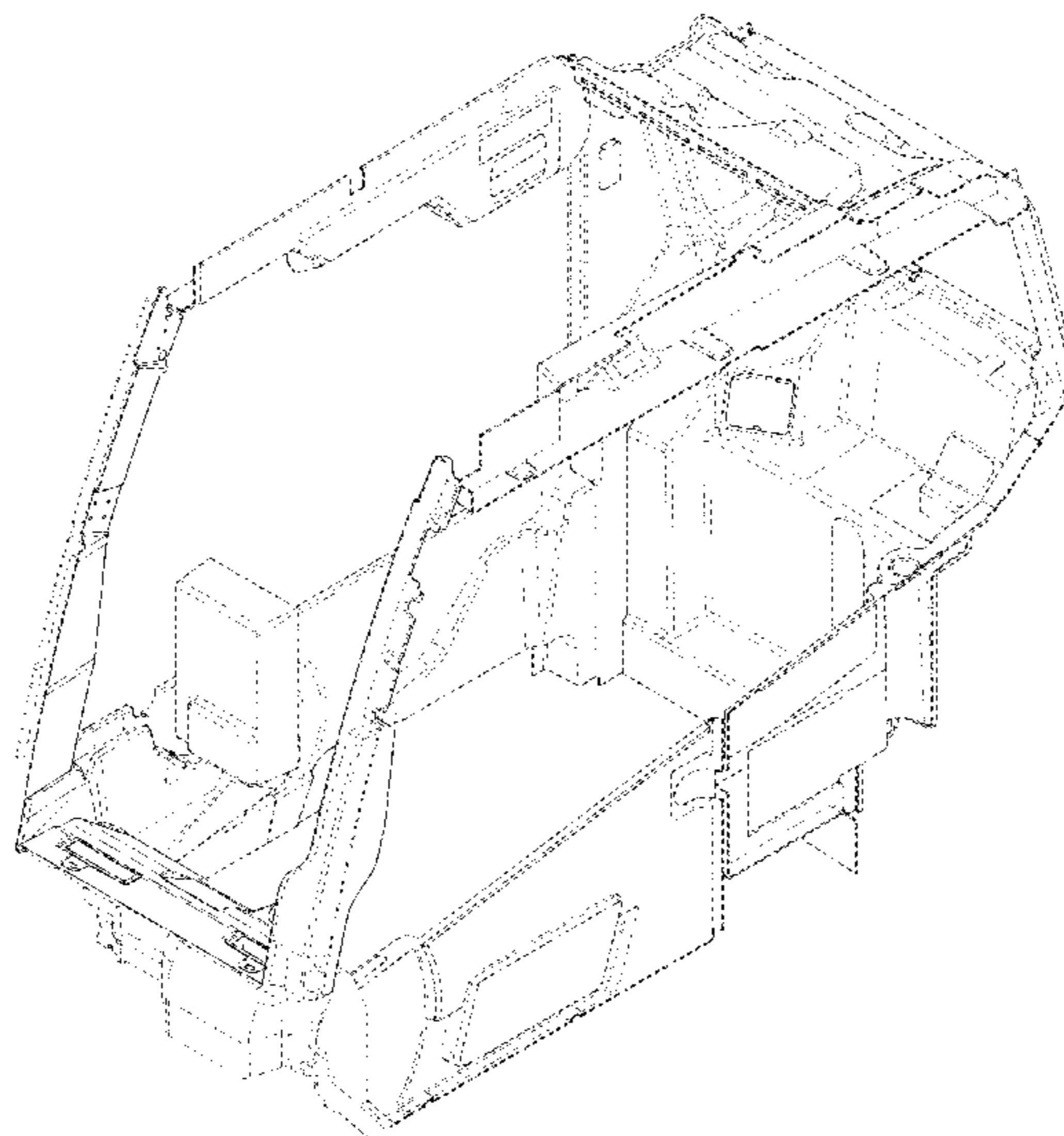
FIG. 6 is a left side view thereof;

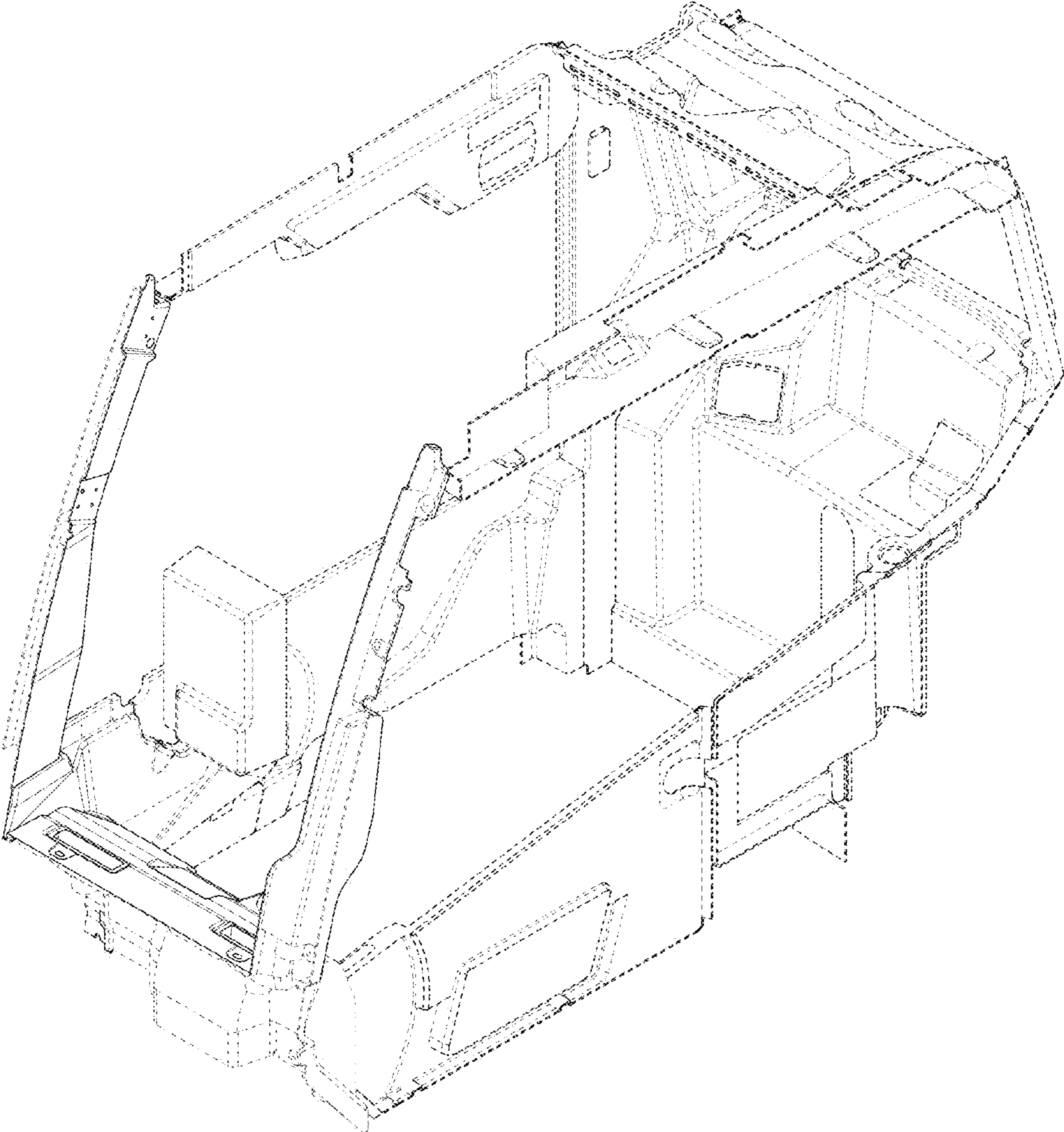

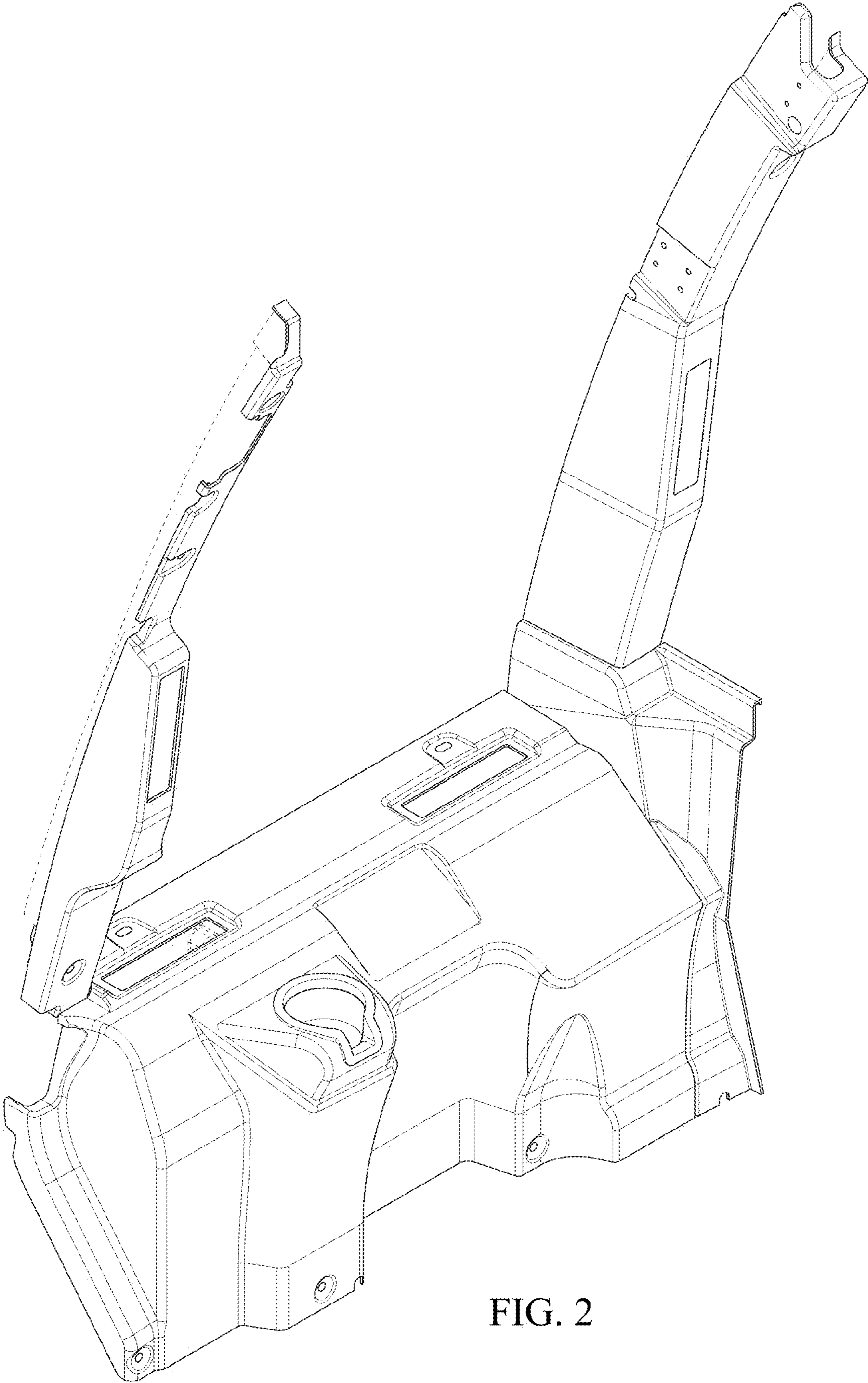

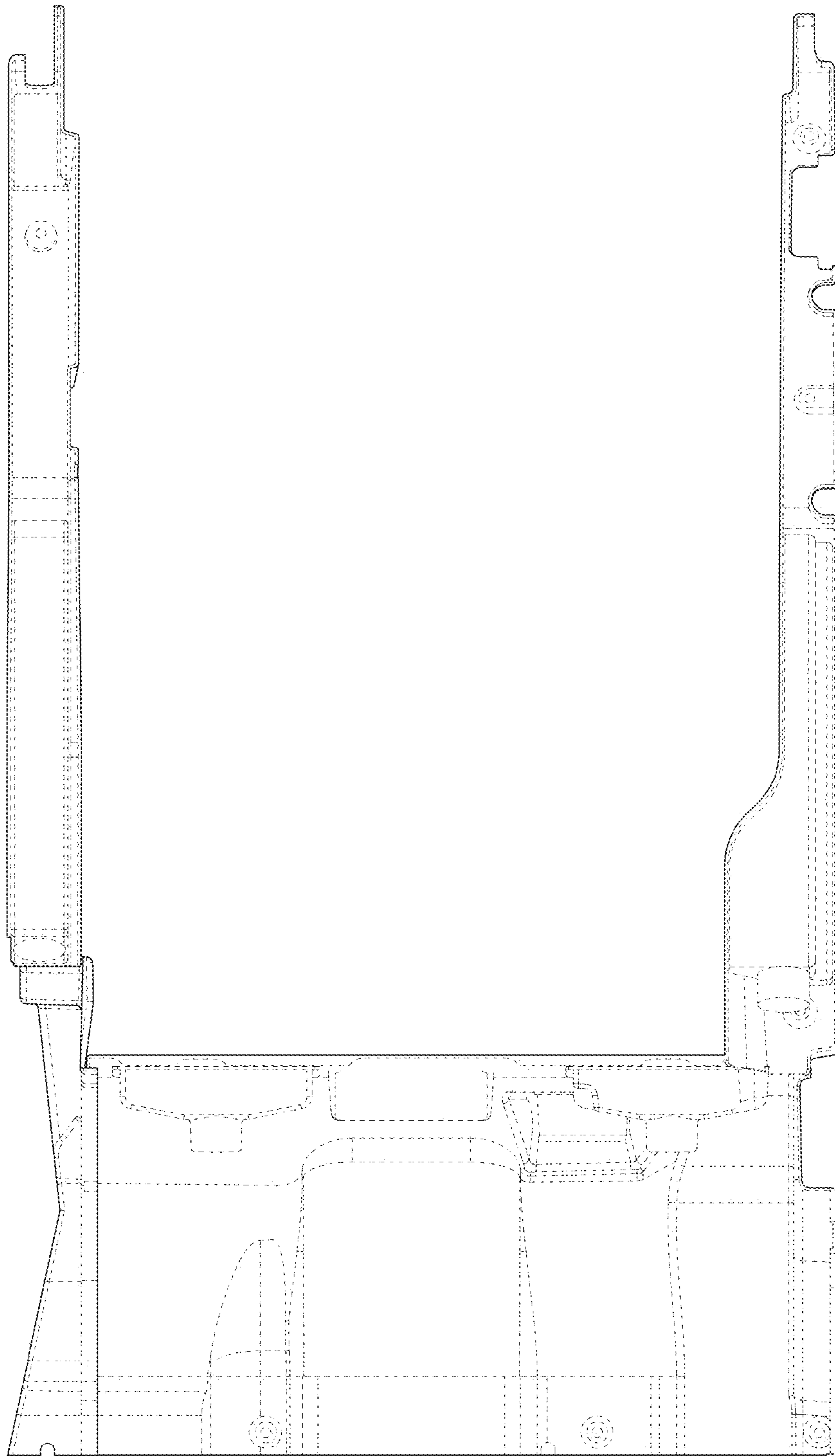

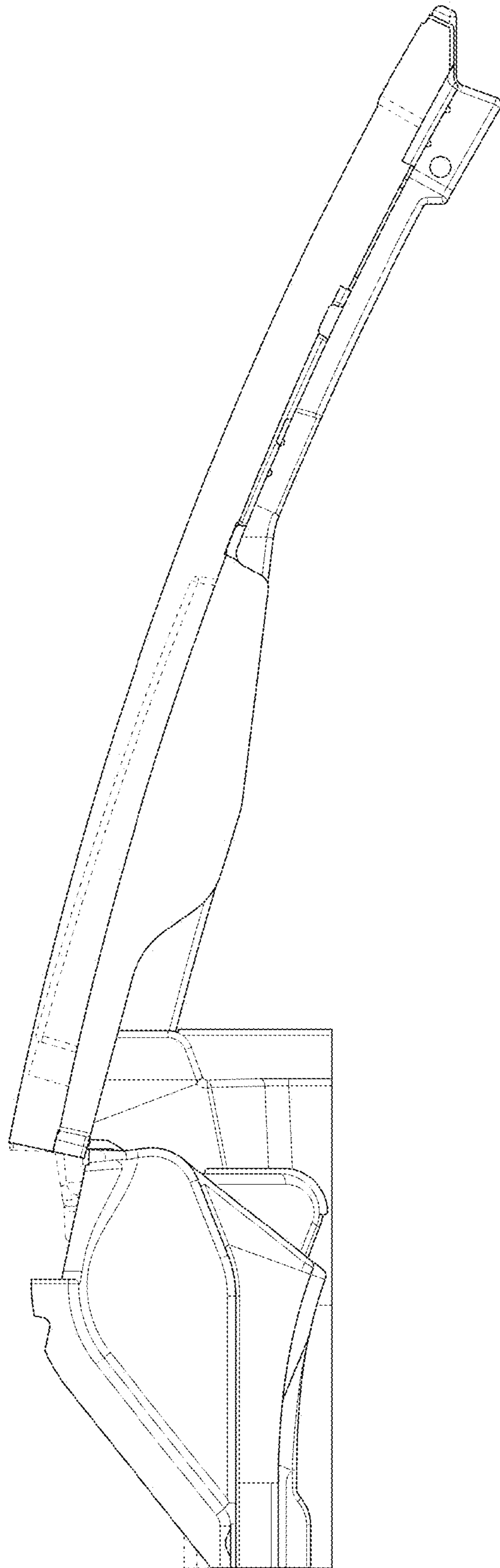

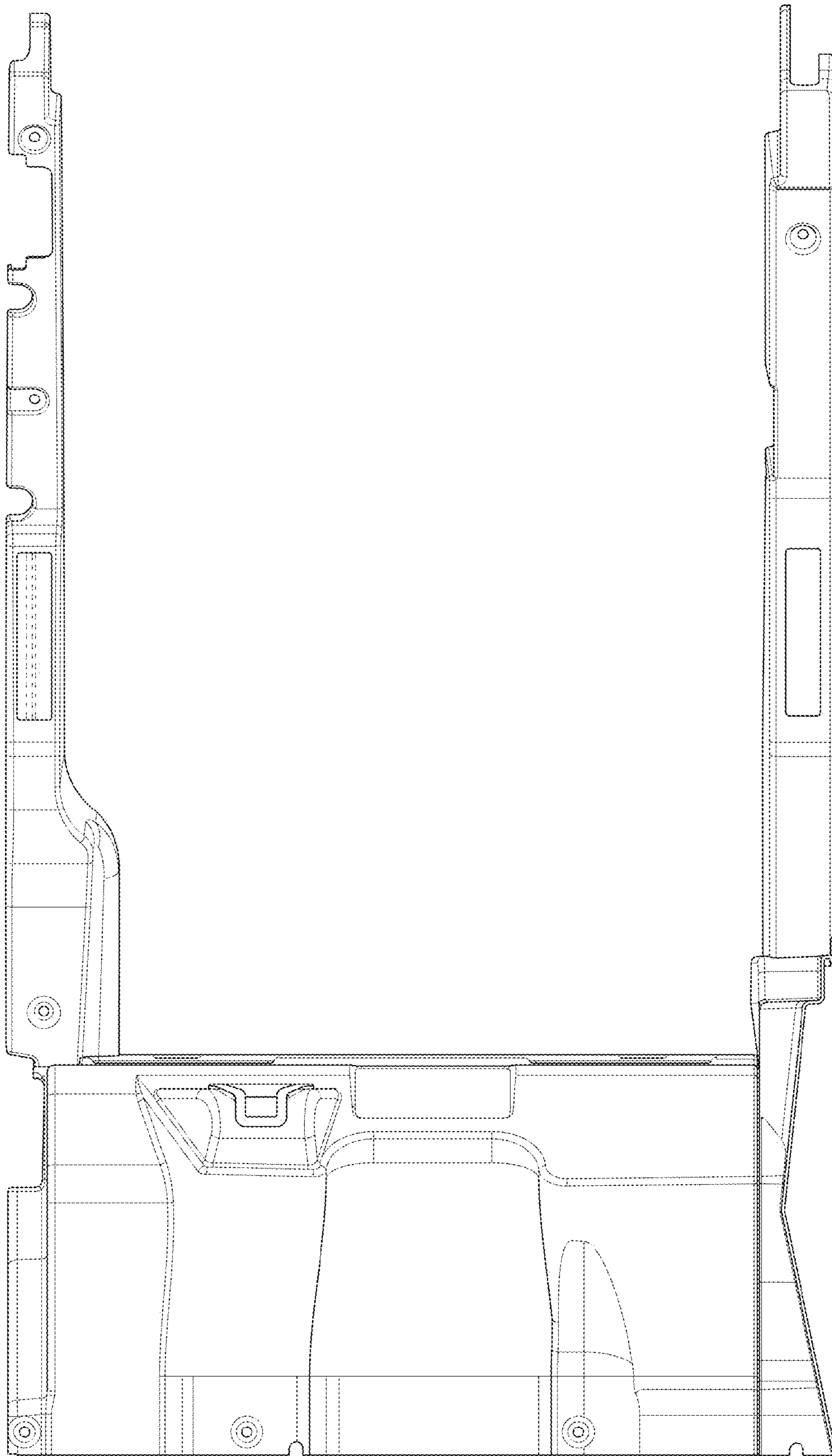

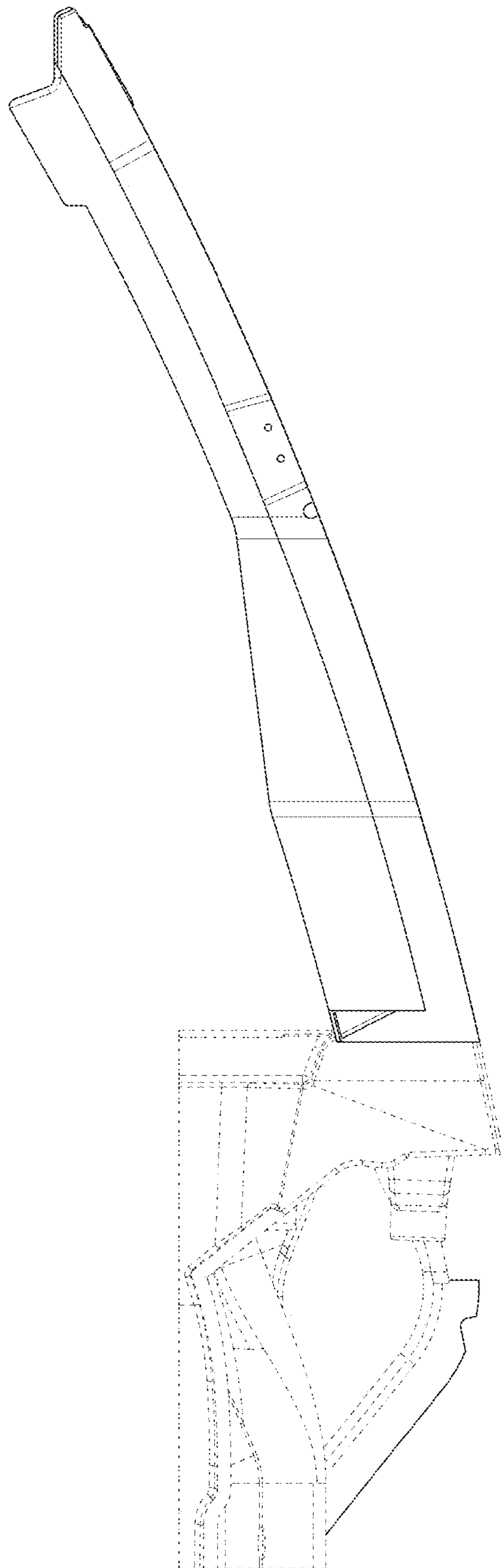

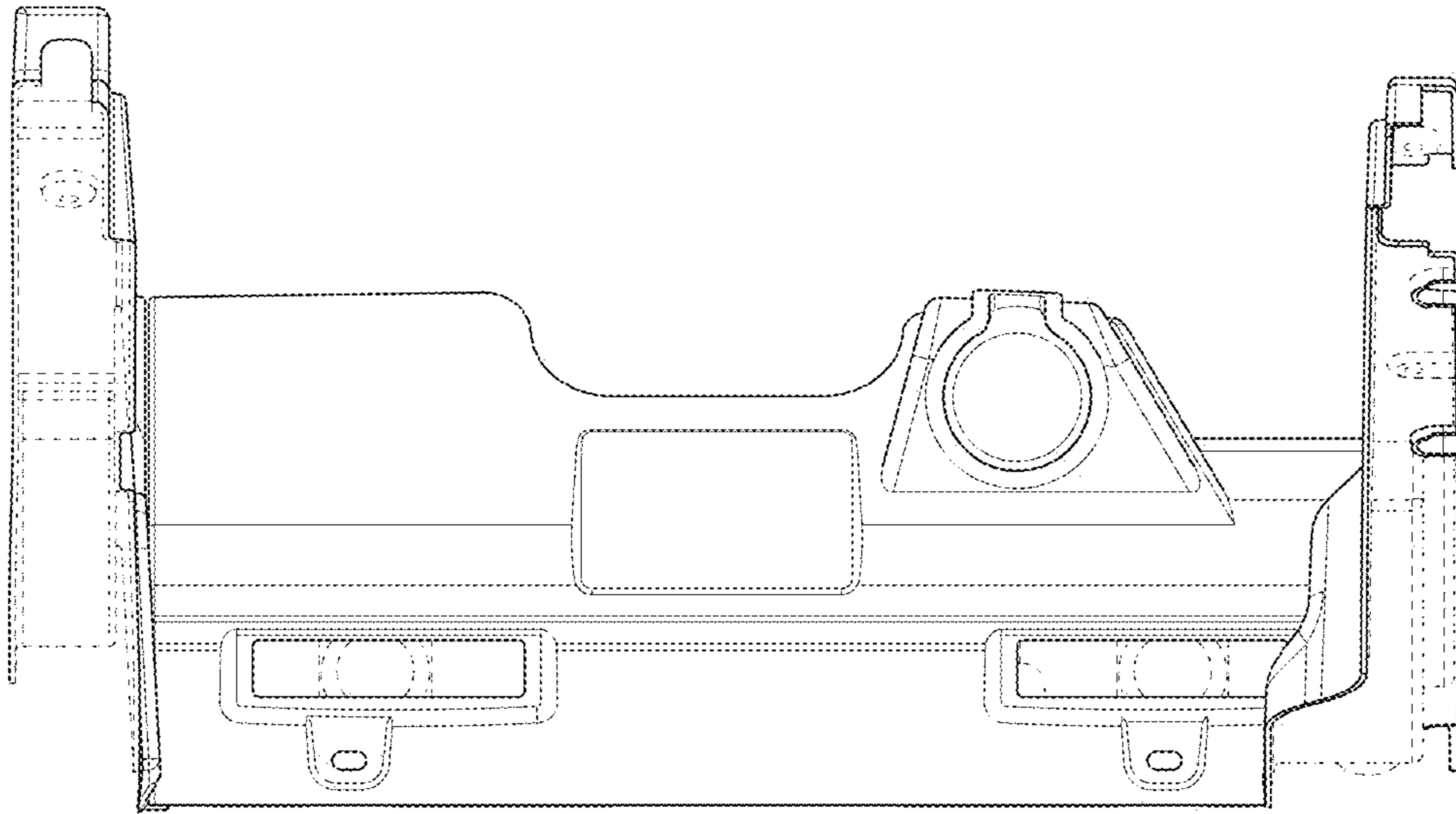

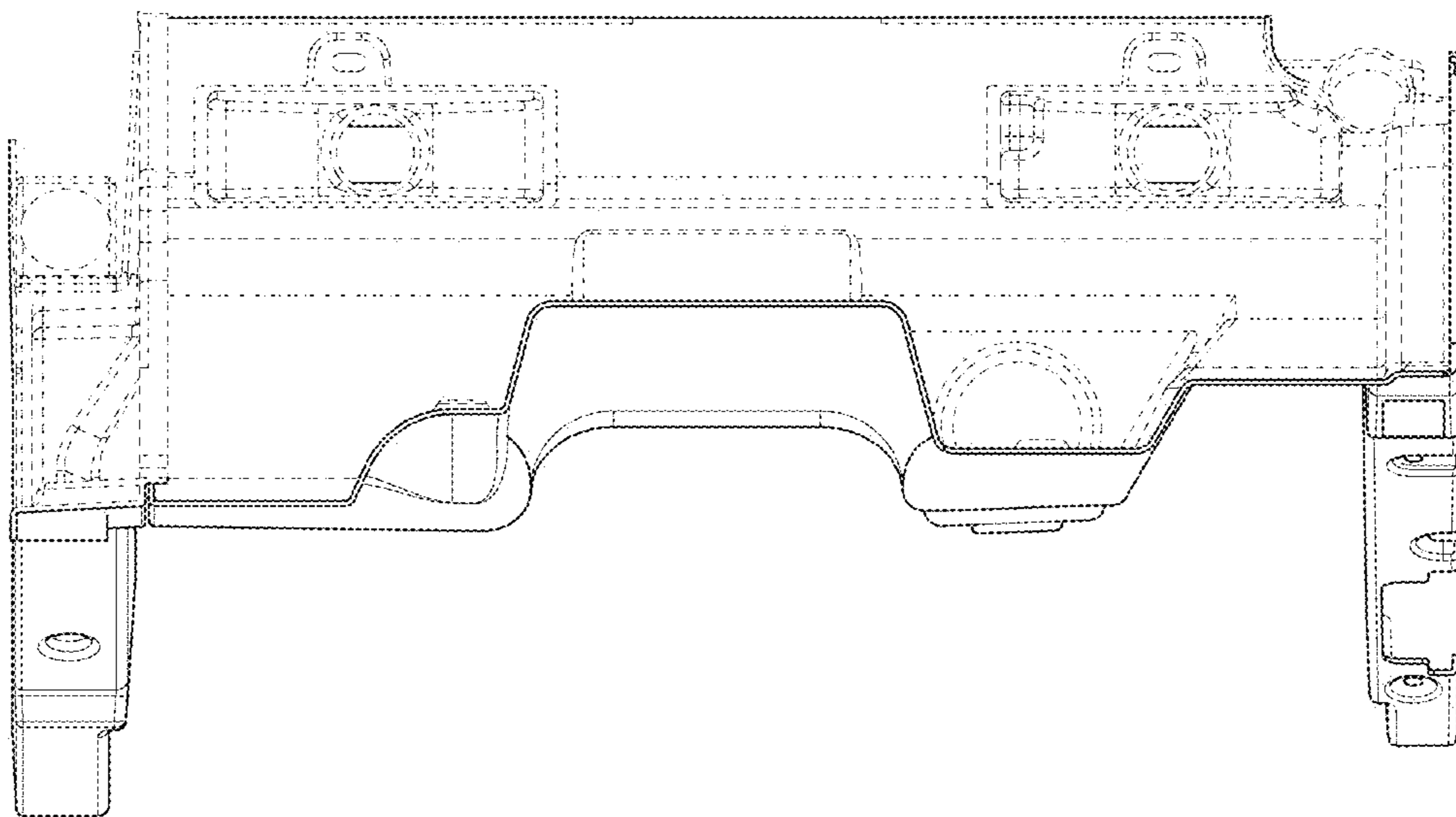
