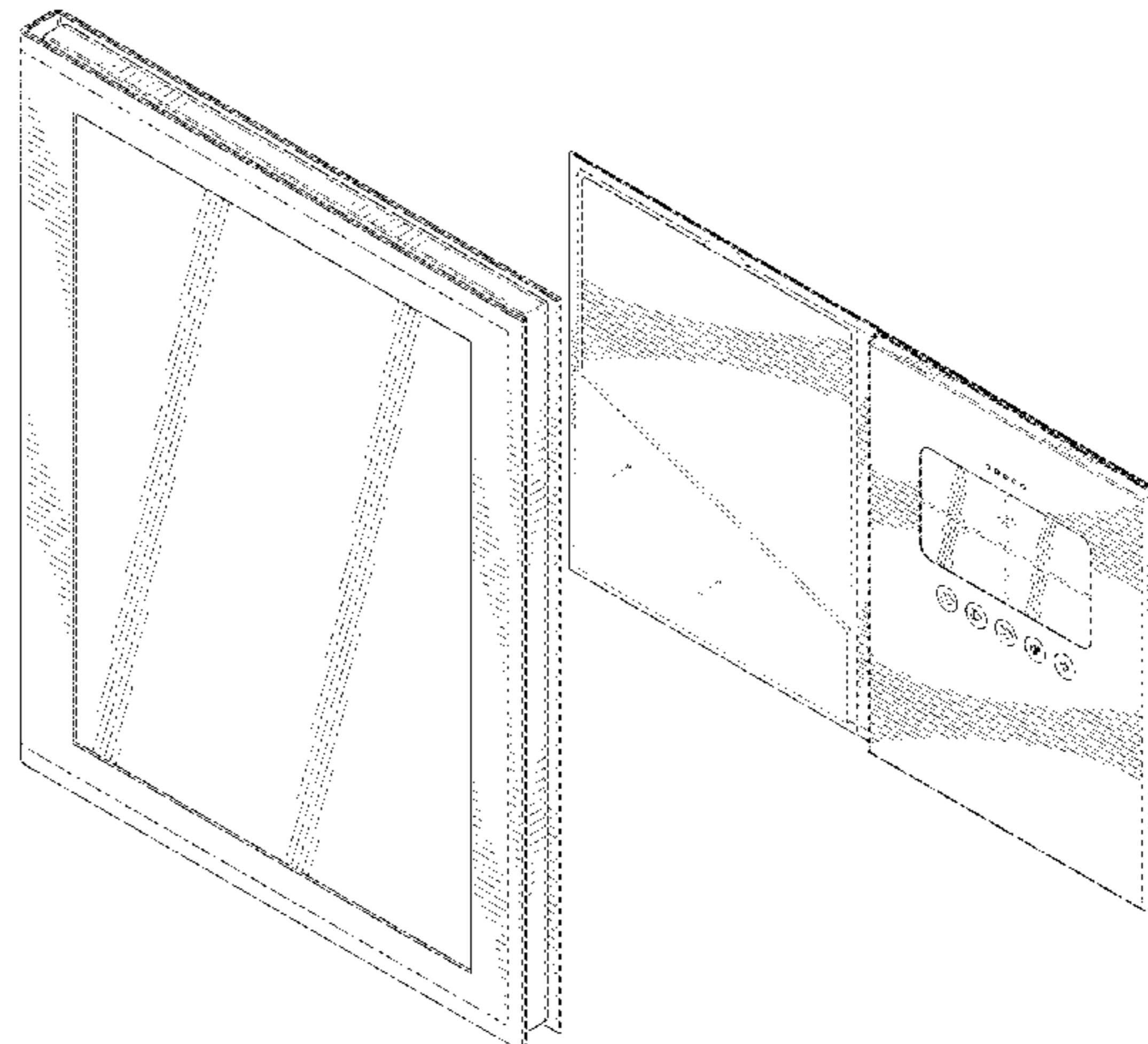

(57) **CLAIM**

The ornamental design for a folio video book with cover insert, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a folio video book with cover insert showing my new design in a closed configuration; FIG. 2 is a front elevation view thereof in the closed configuration; FIG. 3 is a rear elevation view thereof in the closed configuration; FIG. 4 is a right side elevational view thereof in the closed configuration; FIG. 5 is a left side elevational view thereof in the closed configuration; FIG. 6 is a bottom plan view thereof in the closed configuration; FIG. 7 is a top plan view thereof in the closed configuration; FIG. 8 is an inside perspective view thereof in an open configuration; FIG. 9 is an inside front elevation view thereof in the open configuration; FIG. 10 is a rear elevation view thereof in the open configuration; FIG. 11 is a right side elevational view thereof in the open configuration; FIG. 12 is a left side elevational view thereof in the open configuration; FIG. 13 is a bottom plan view thereof in the open configuration; FIG. 14 is a top plan view thereof in the open configuration;

FIG. 15 is an inside perspective view of a second embodiment of my claimed design in the open configuration the difference consisting of disclaiming the video controls and speaker holes;

FIG. 16 is an inside front elevation view thereof in the open configuration;

FIG. 17 is a rear elevation view thereof in the open configuration;

FIG. 18 is a right side elevational view thereof in the open configuration;

FIG. 19 is a left side elevational view thereof in the open configuration;

FIG. 20 is a bottom plan view thereof in the open configuration; and,

FIG. 21 is a top plan view thereof in the open configuration. The folio video book with cover insert shows a rounded corner rectangular interior display with symbolic breaks in its height and width. The appearance of any portion of the article in between these broken lines, including the broken lines themselves, forms no part of the claimed design. All other broken lines depict portions of the folio video book with cover insert that form no part of the claimed design.

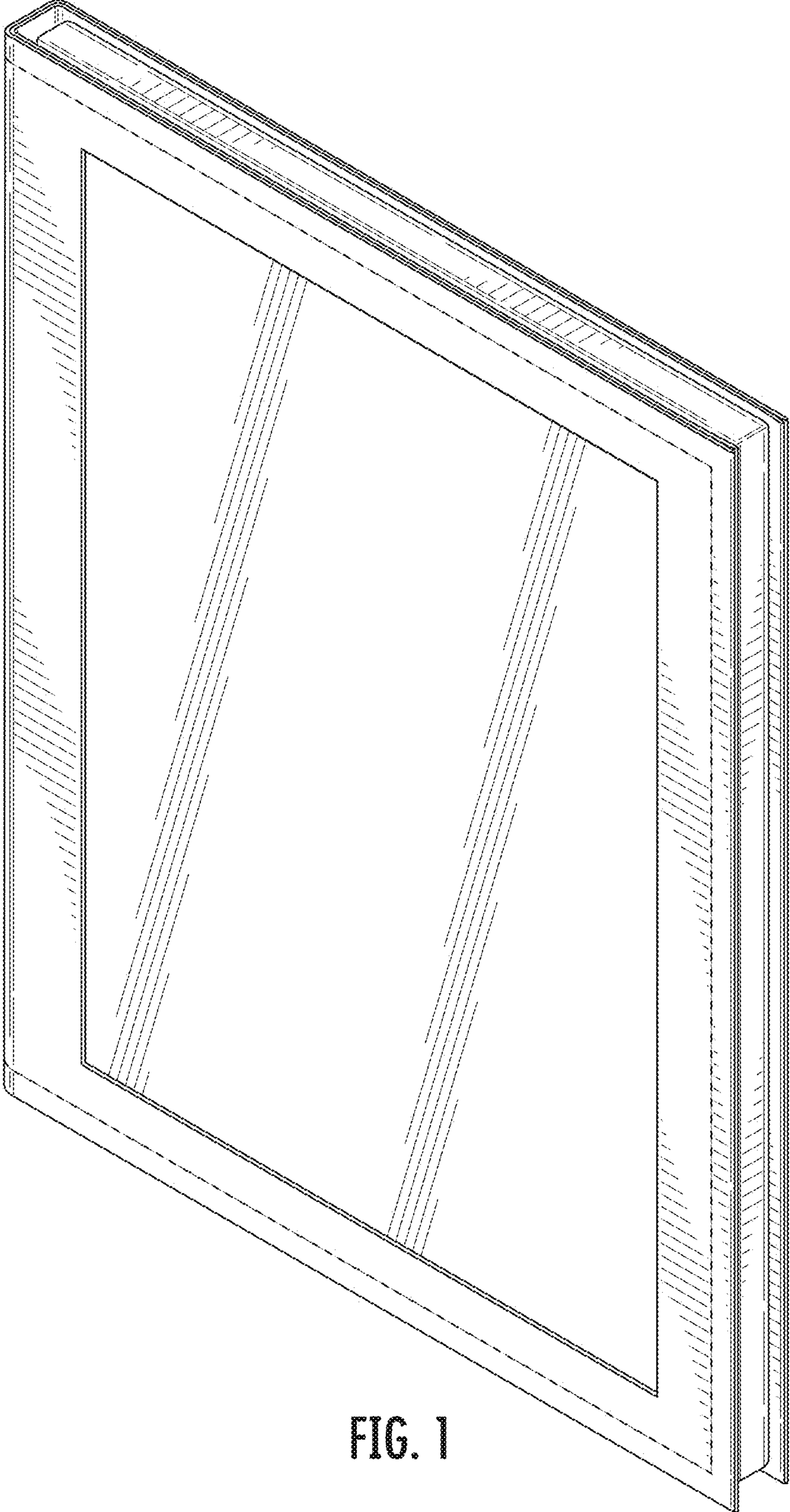

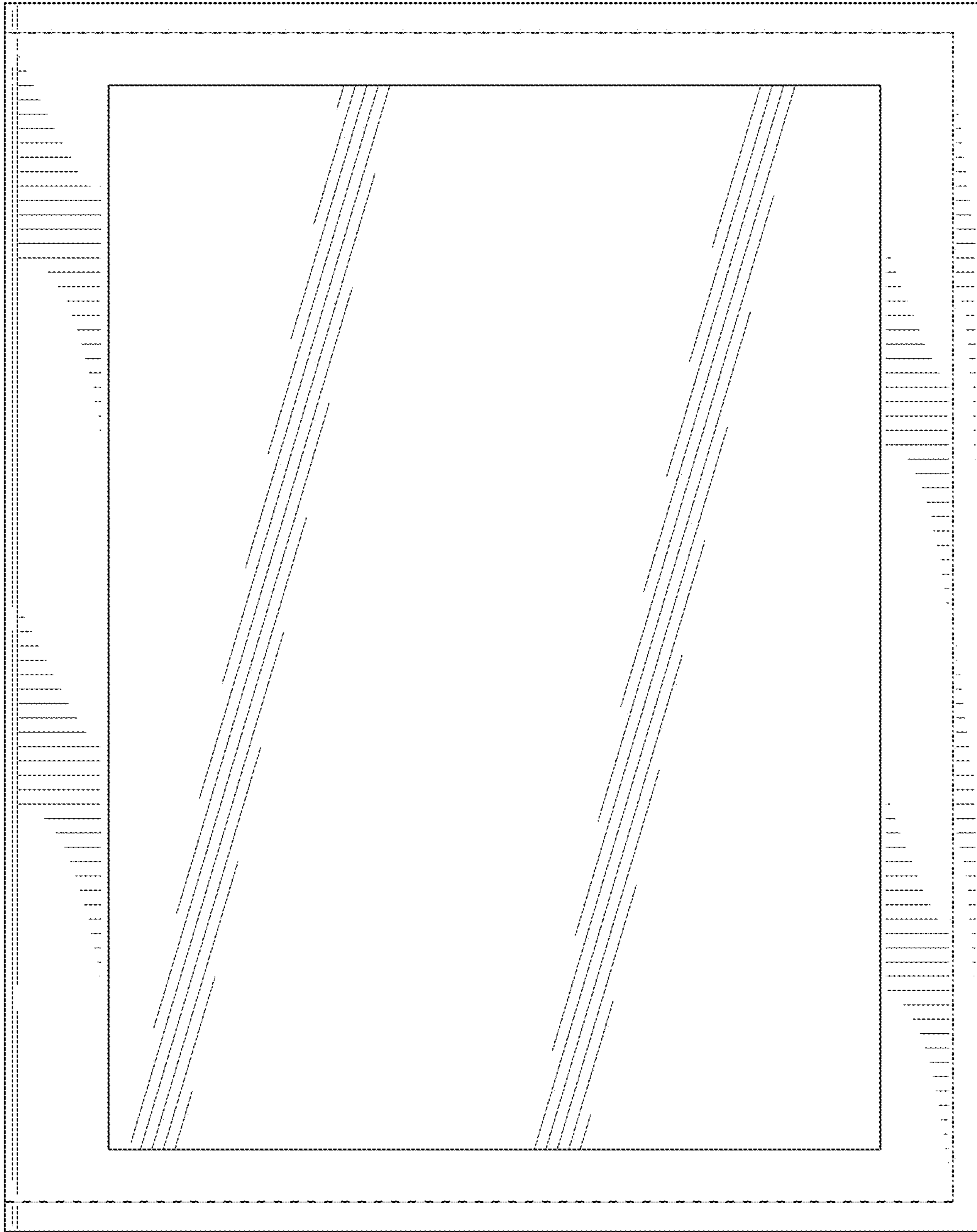

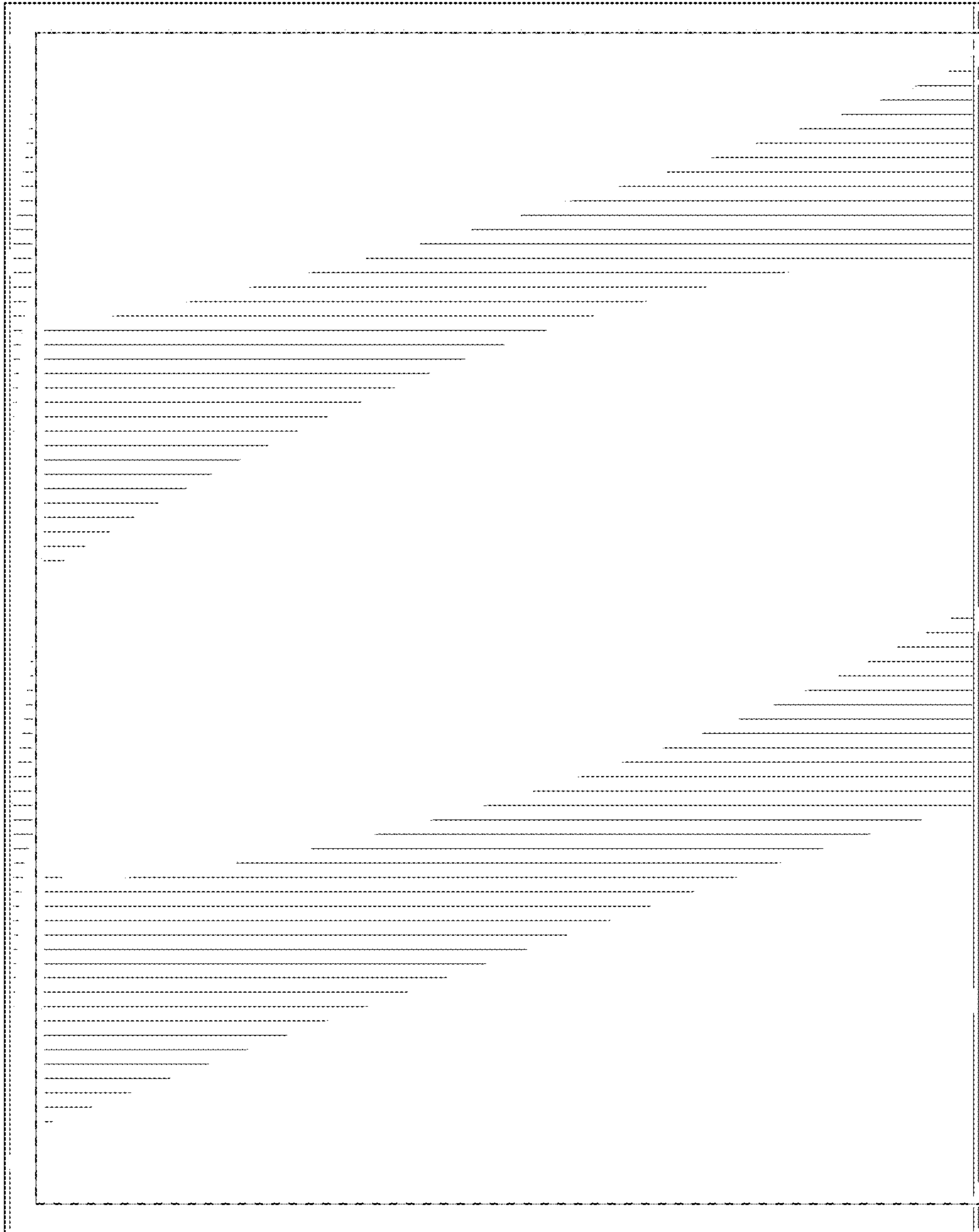

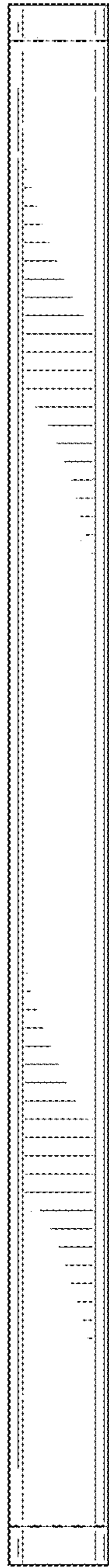

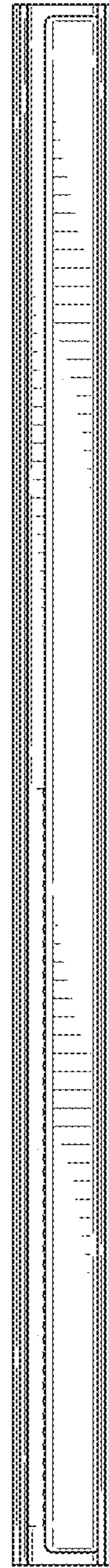

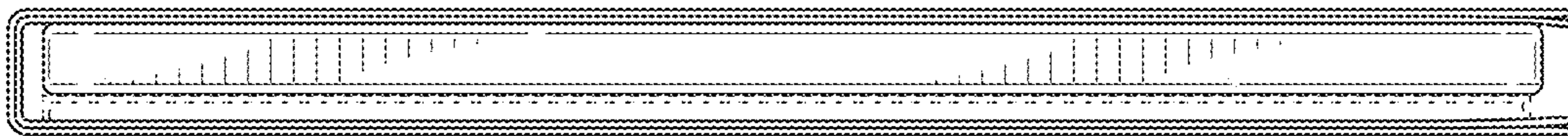

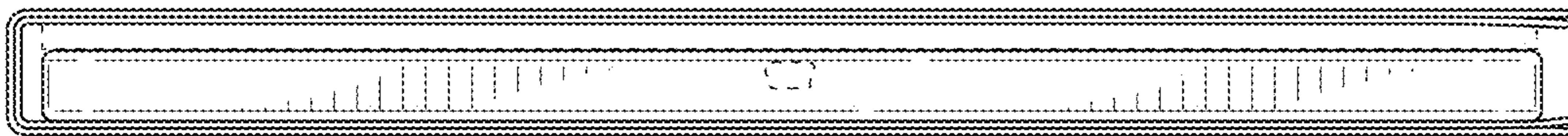

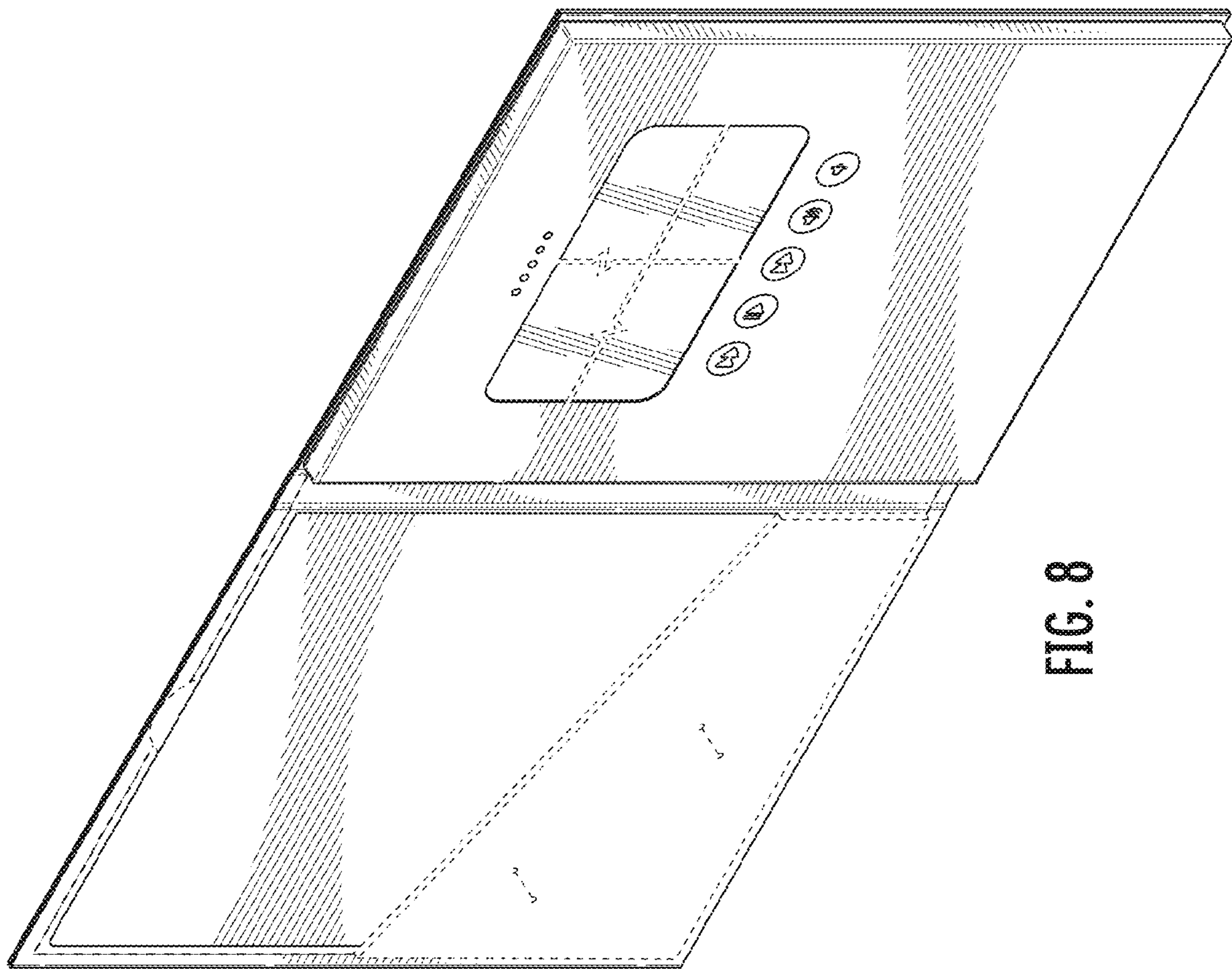

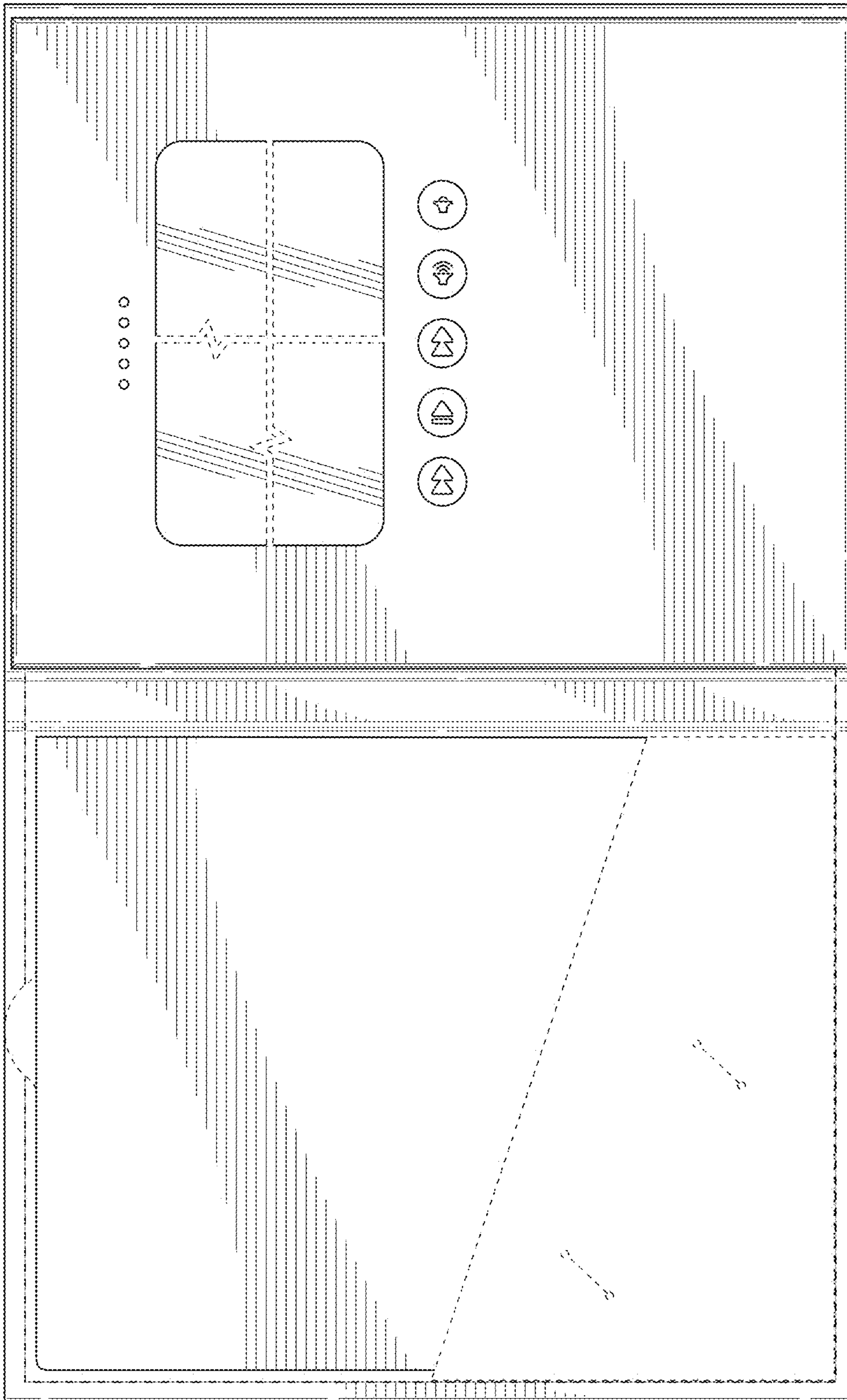

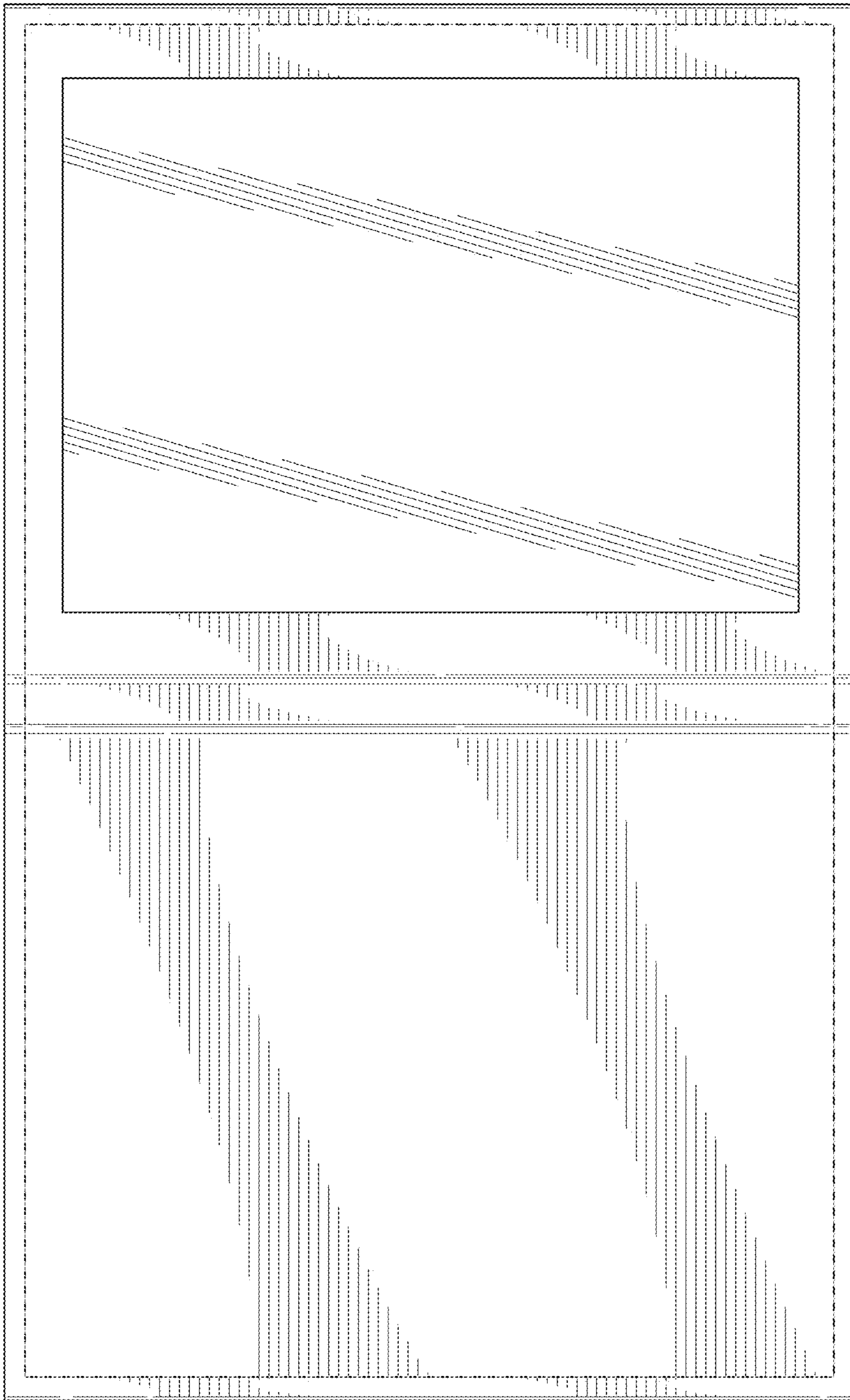

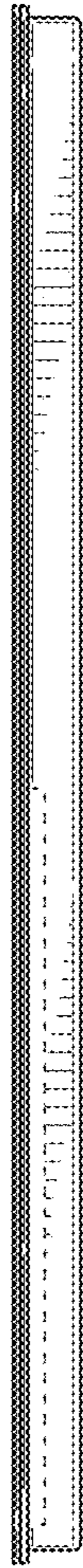

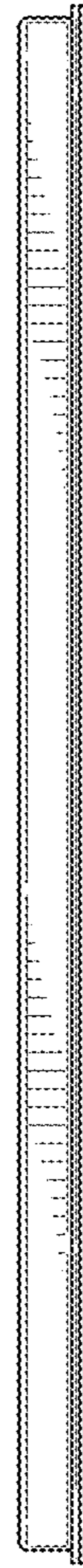

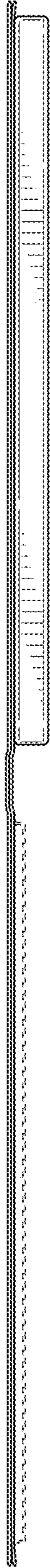

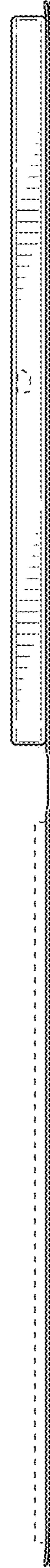

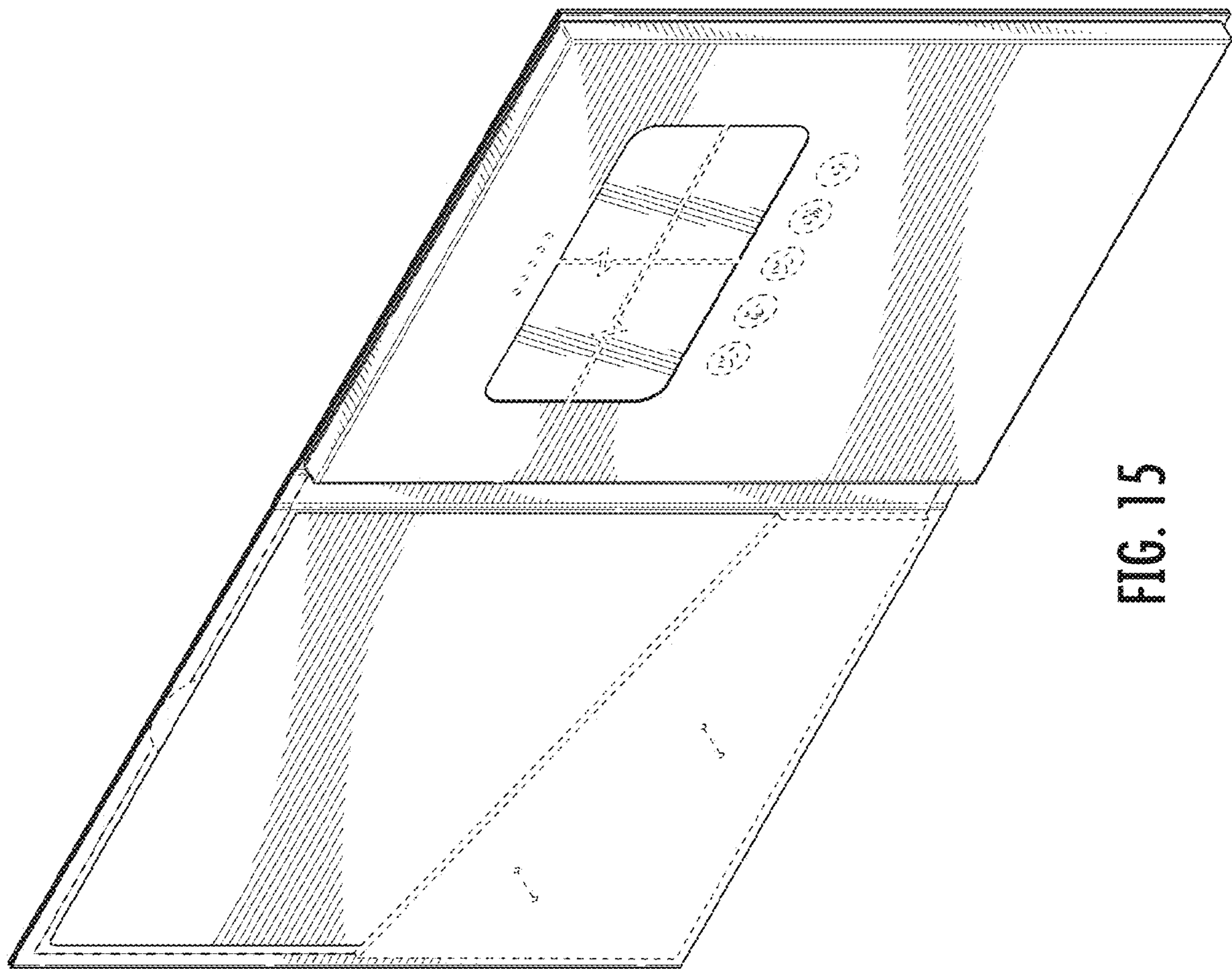

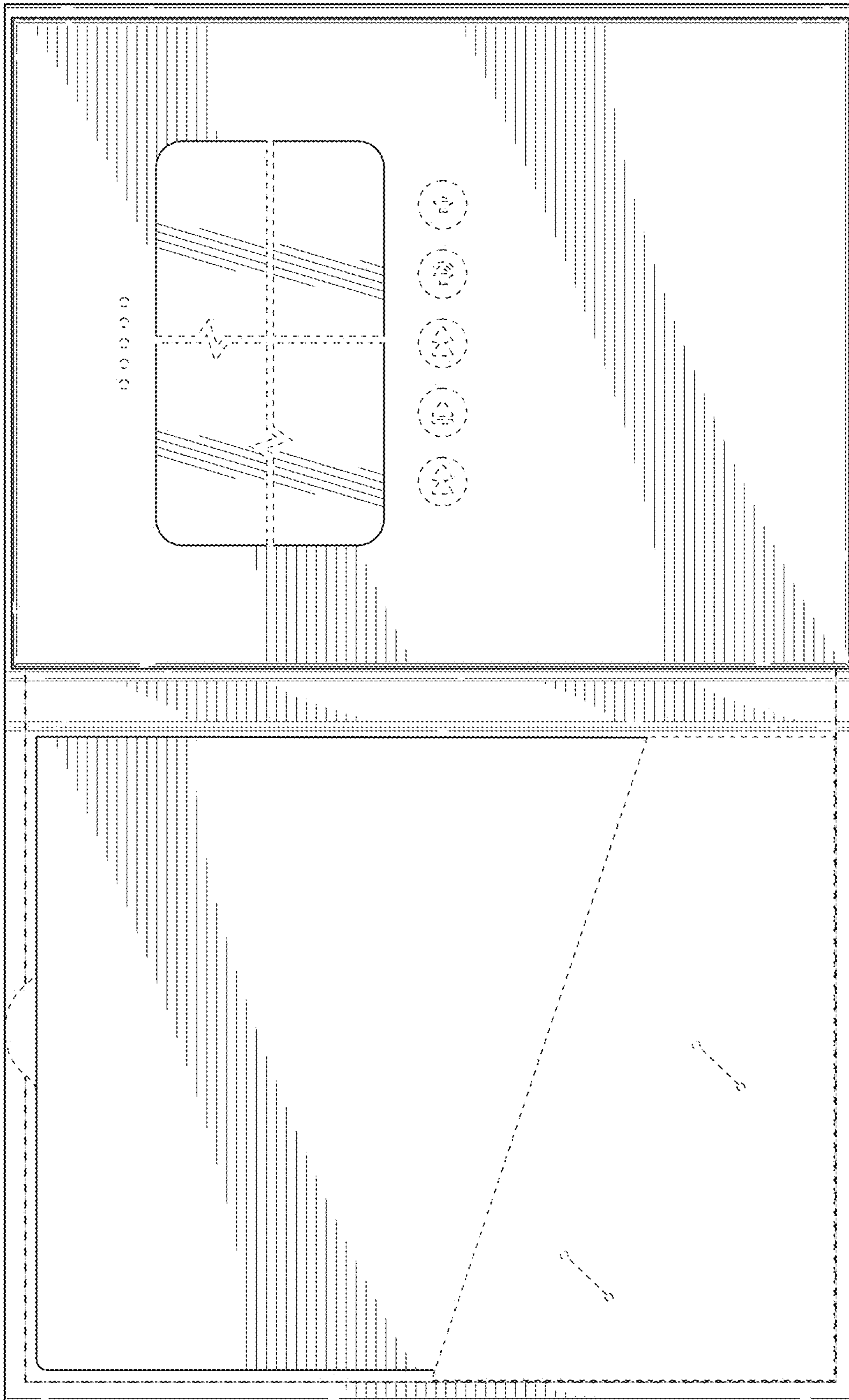

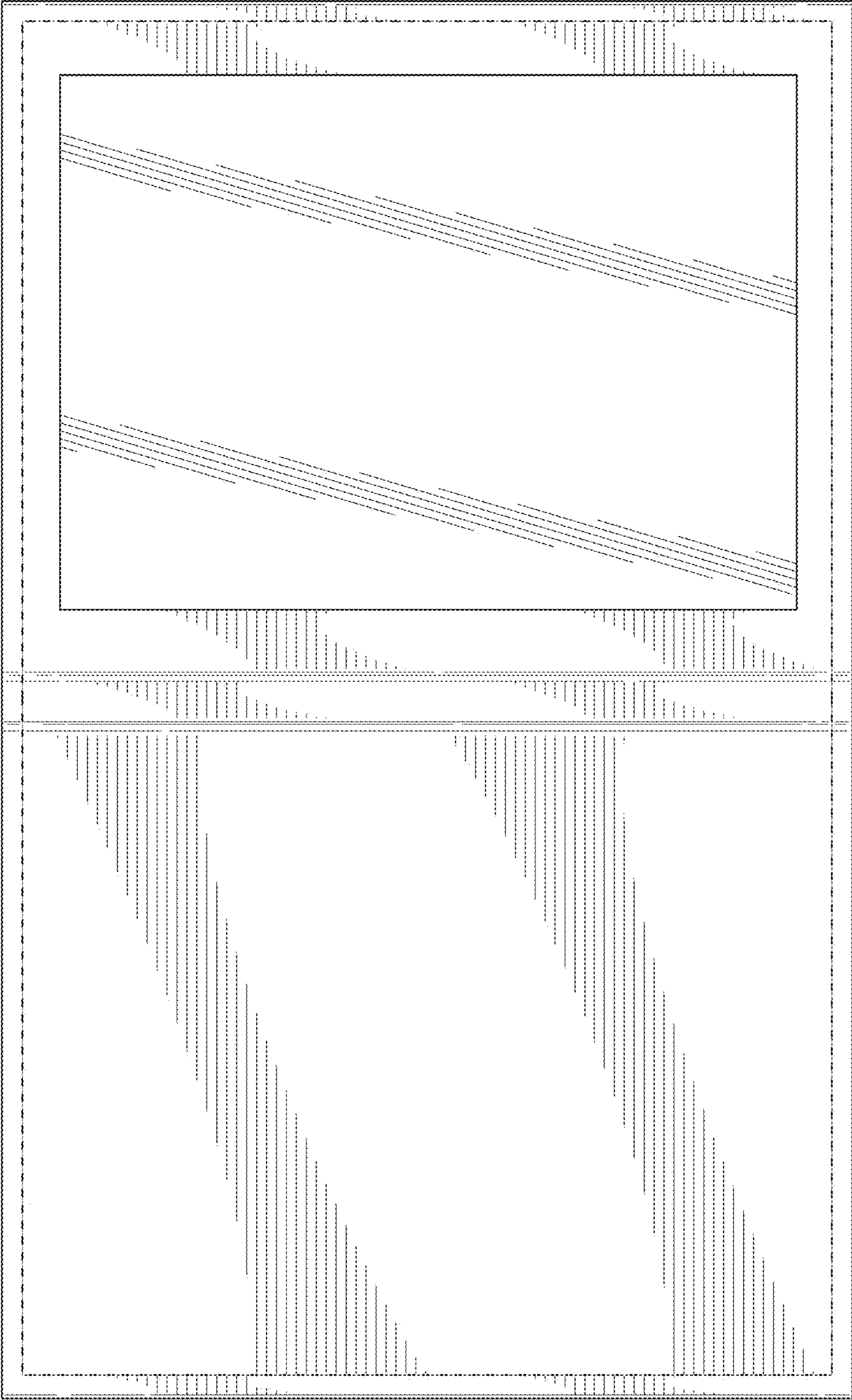

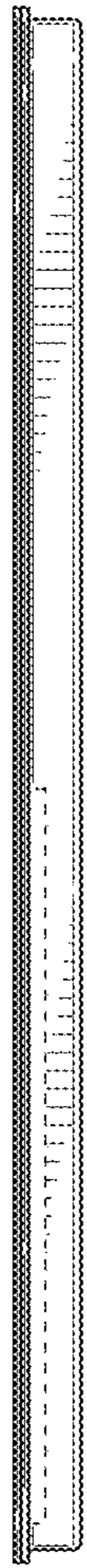

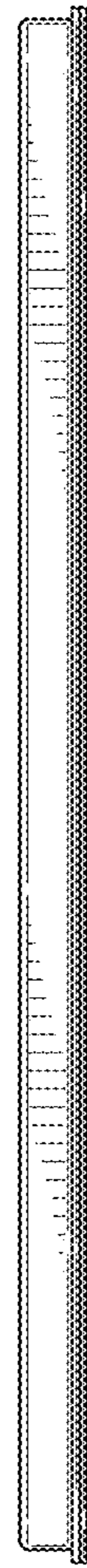

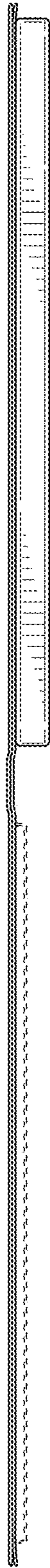
