The ornamental design for armor, as shown and described.

DESCRIPTION

FIG. 1 is a front right side perspective view of armor showing our new design in an open configuration;

FIG. 2 is a front left side perspective view thereof;

FIG. 3 is a rear left side perspective view thereof, the rear right side perspective being a mirror image thereof;

FIG. 4 is a front left side perspective view of the armor of FIGS. 1-3 showing our new design in a closed configuration, the front right side perspective being a mirror image thereof;

FIG. 5 is a top right side perspective view thereof, the top left side perspective being a mirror image thereof;

FIG. 6 is a right side view thereof, the left side being a mirror image thereof;

FIG. 7 is a front right side perspective view of the armor of FIGS. 1-3, shown in color;

FIG. 8 is a front left side perspective view thereof;

FIG. 9 is a rear left side perspective view thereof, the rear right side perspective being a mirror image thereof;

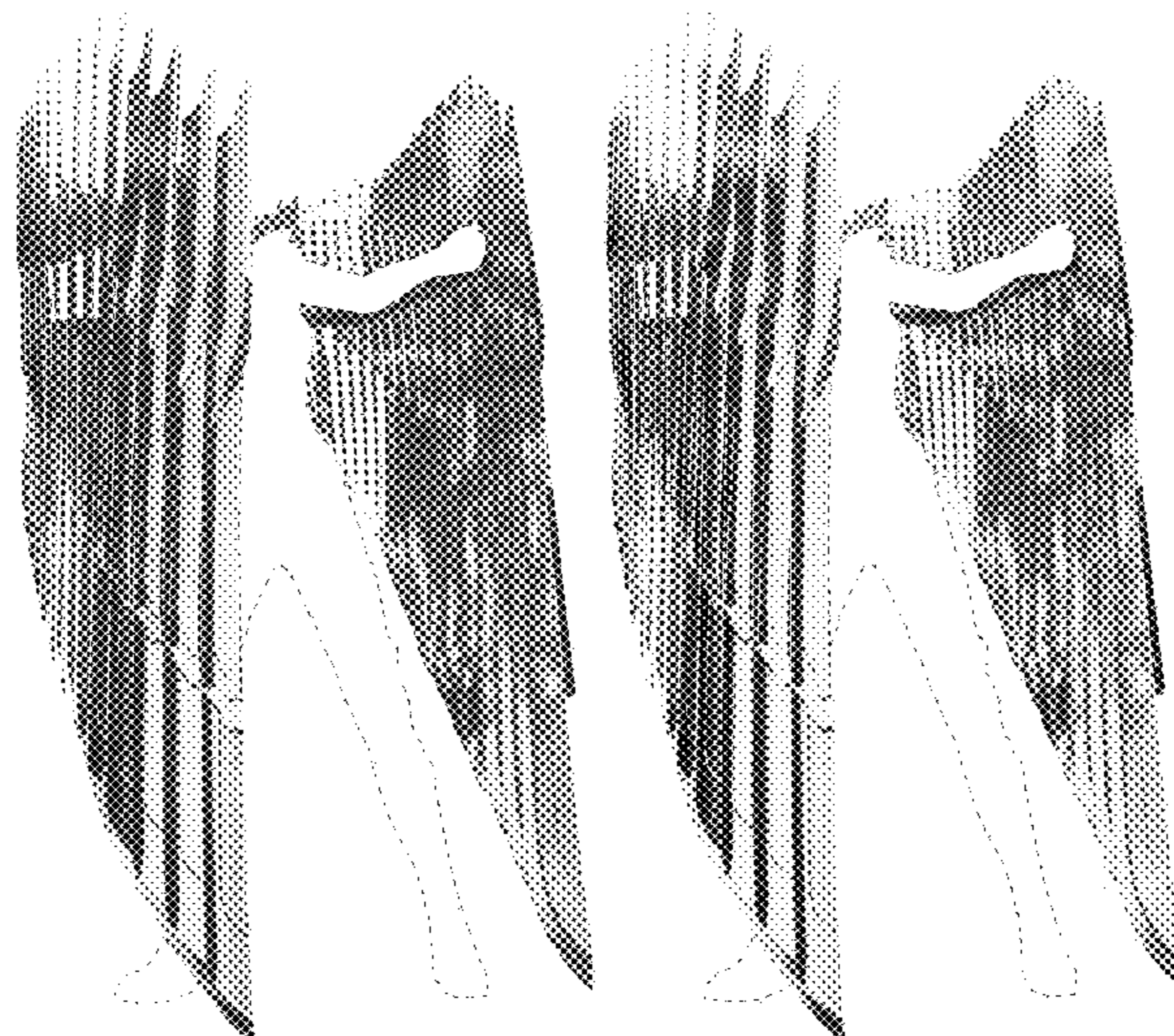
FIG. 10 is a front left side perspective view of the armor of FIGS. 4-6, the front right side perspective being a mirror image thereof, shown in color;

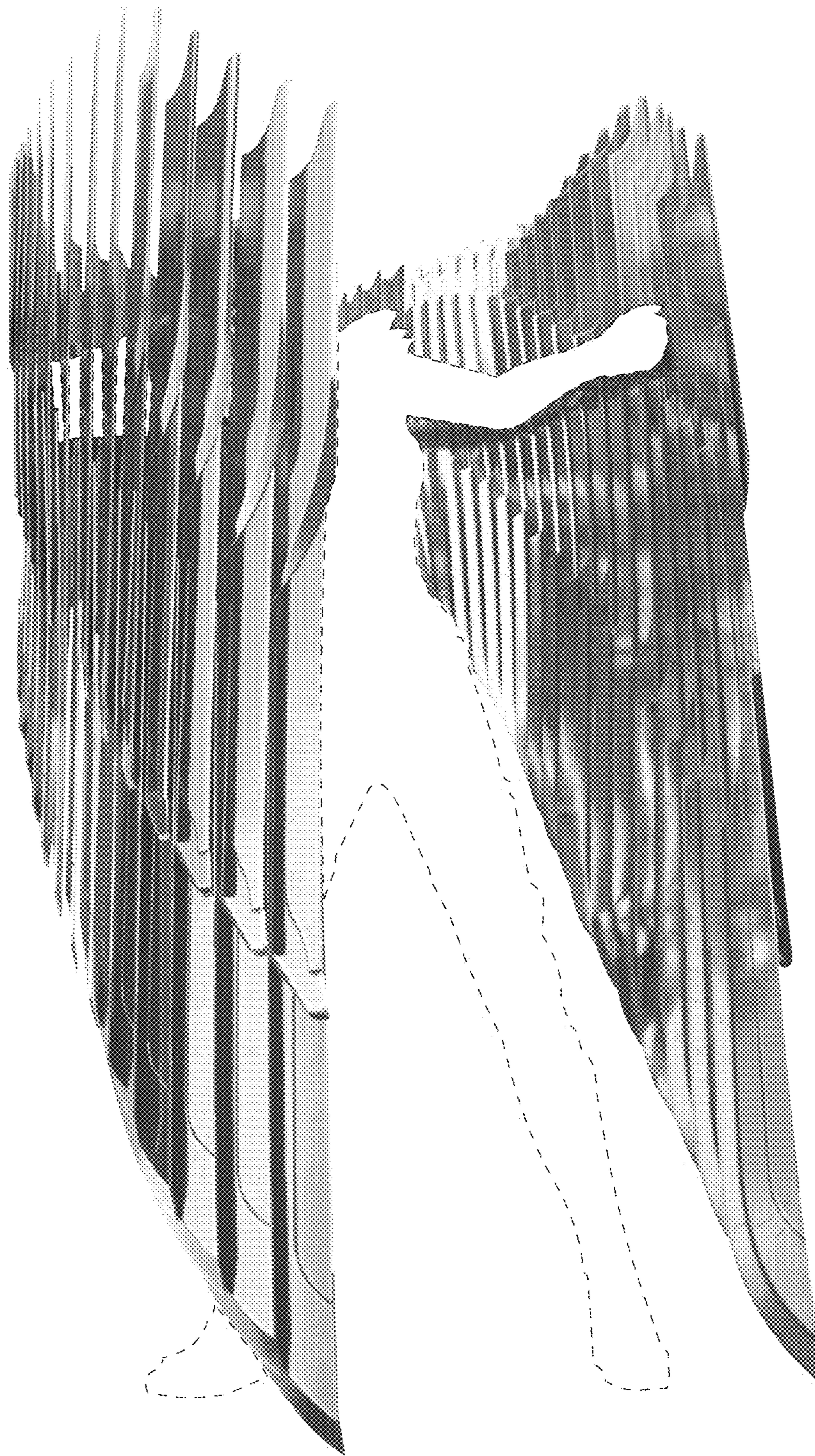

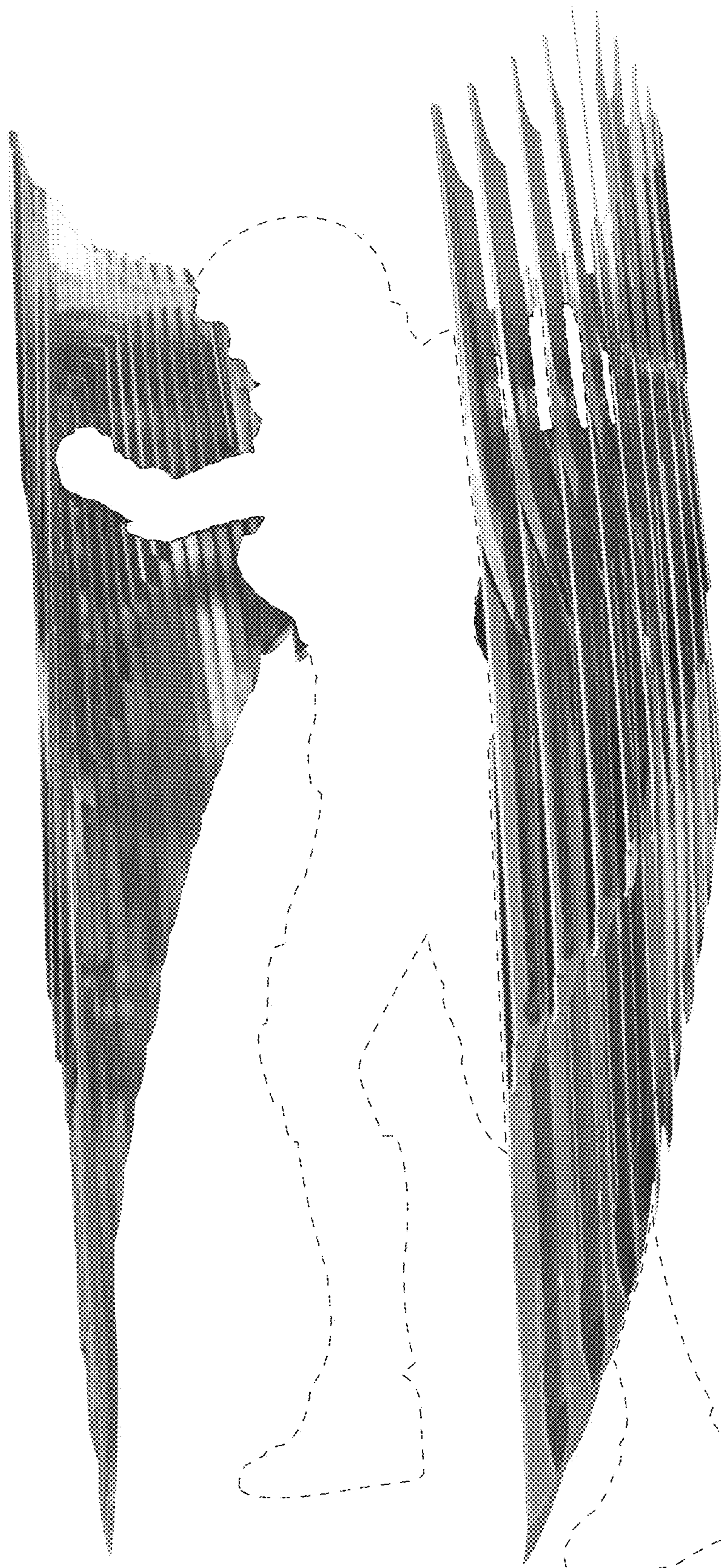

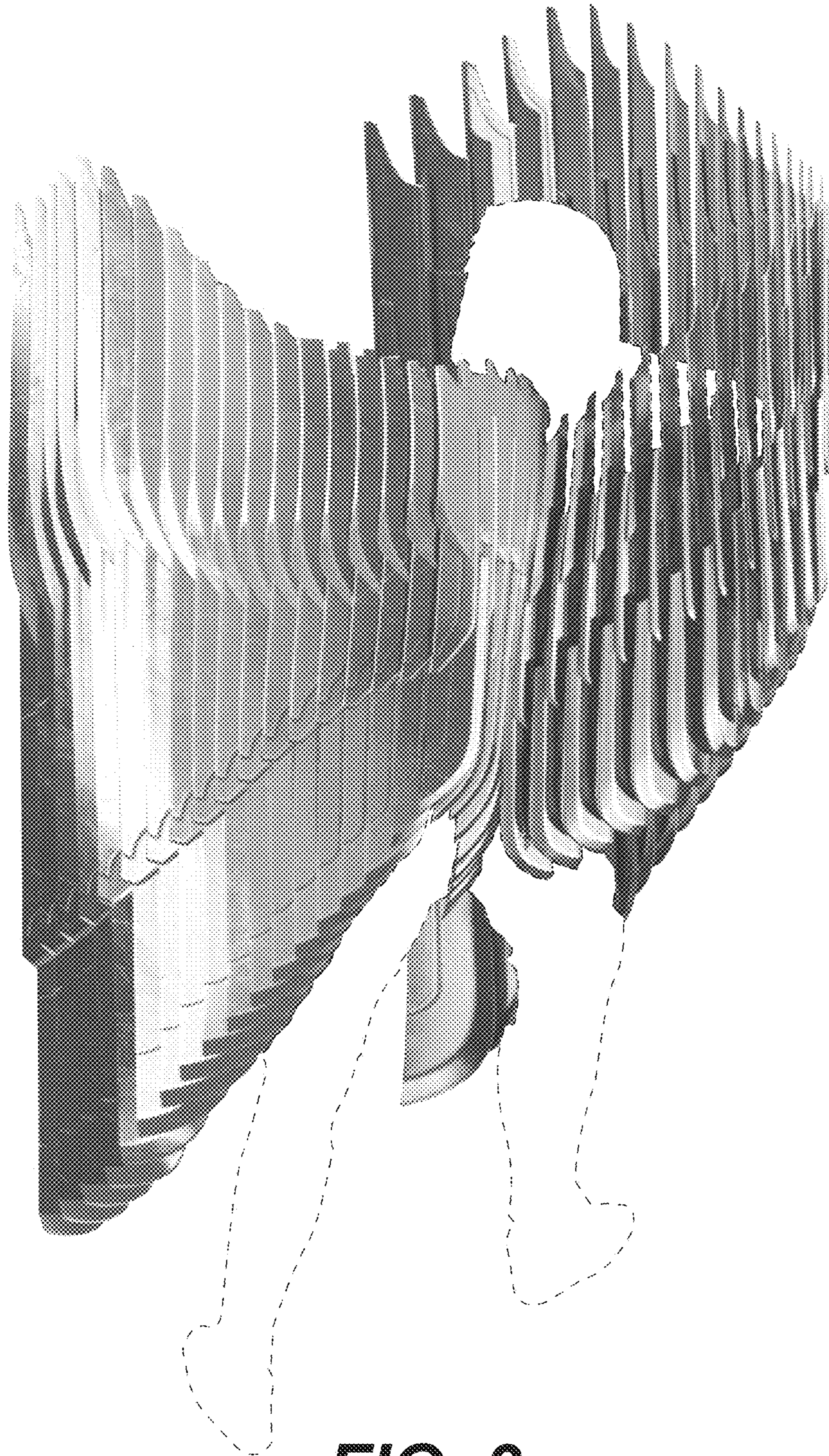

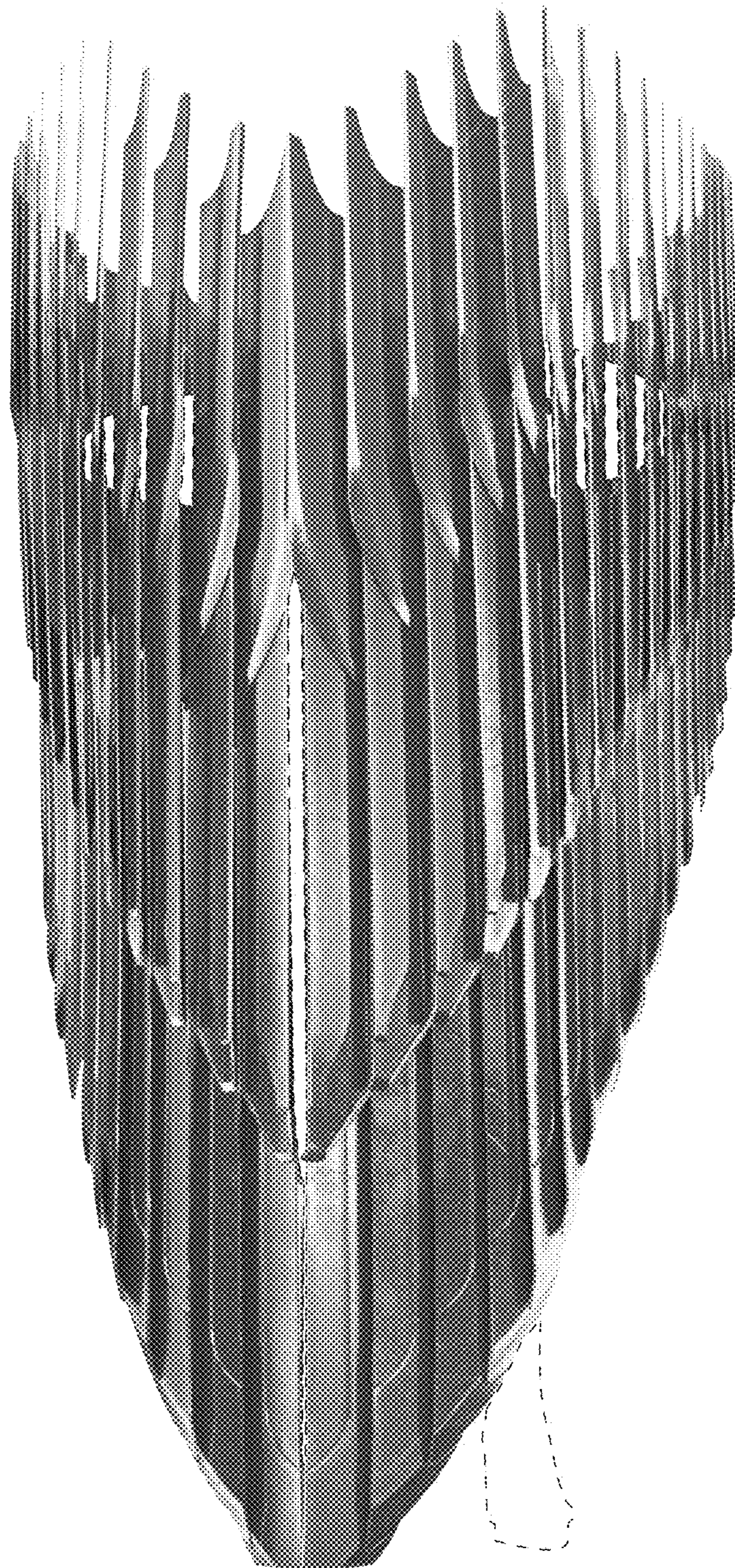

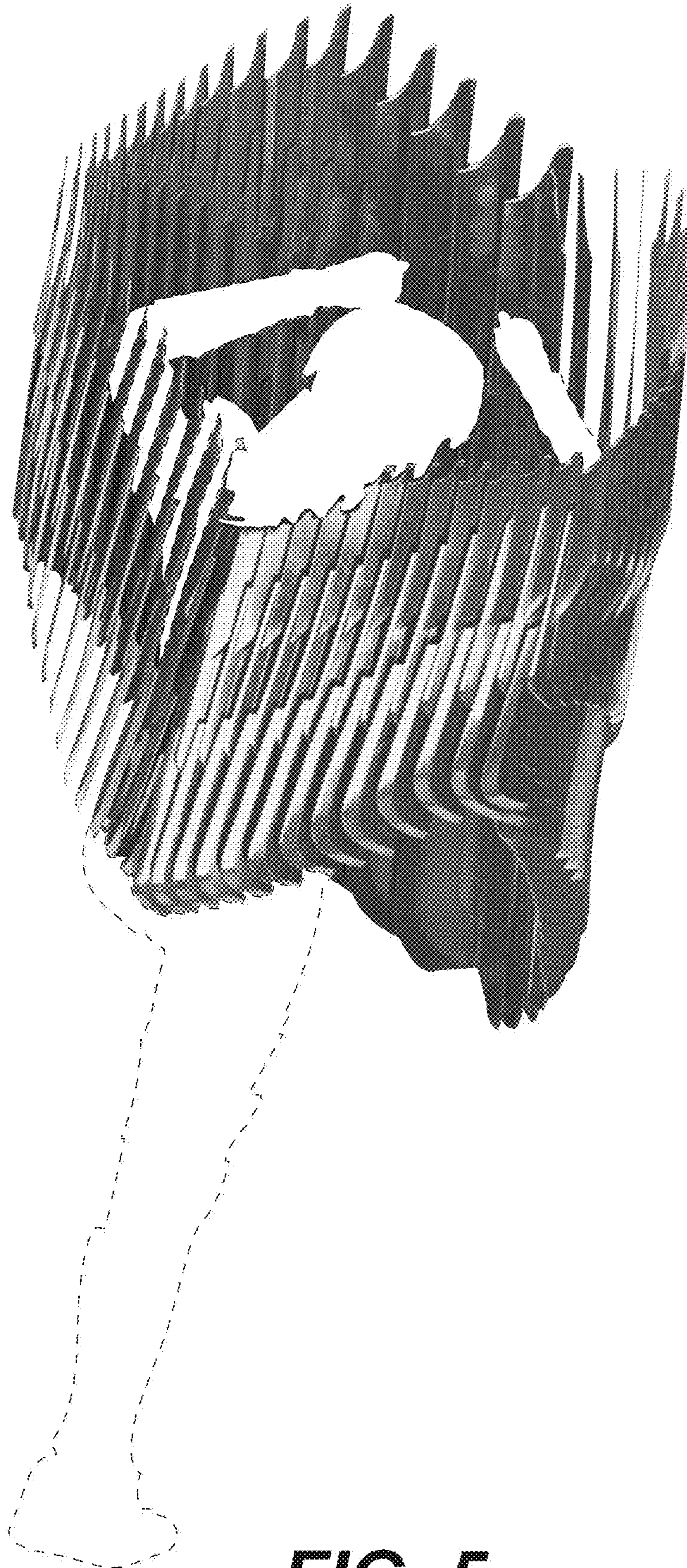

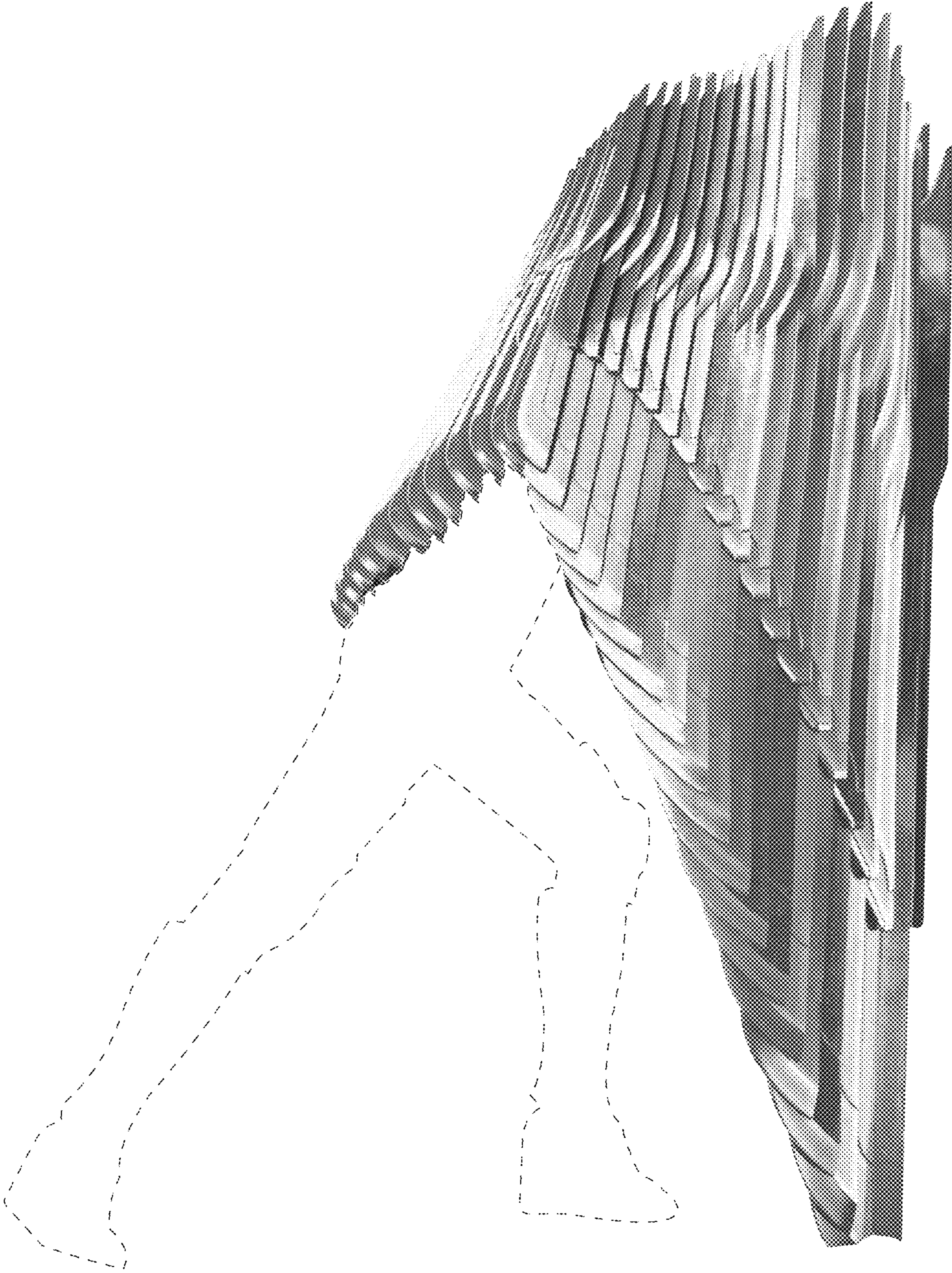

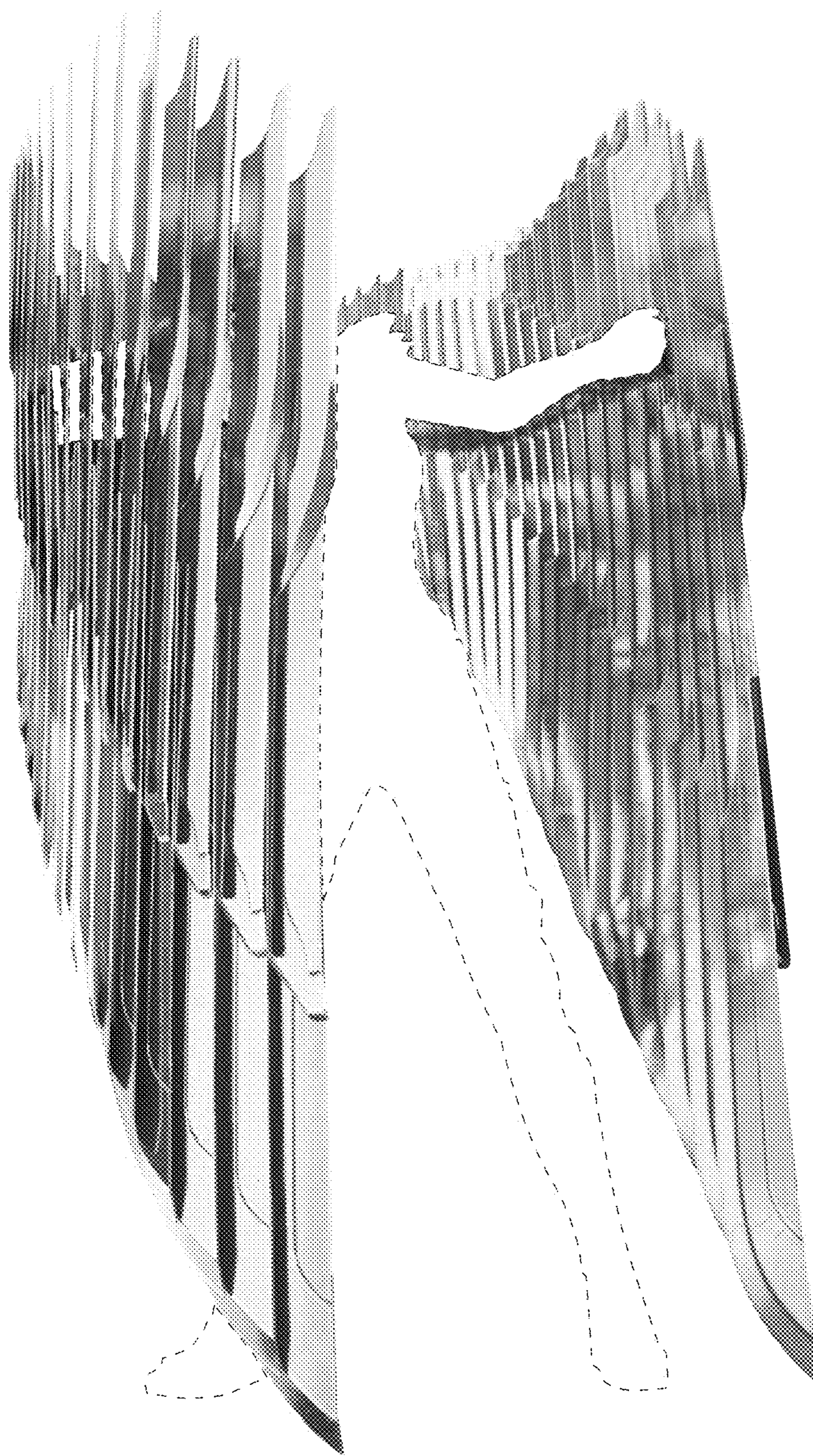

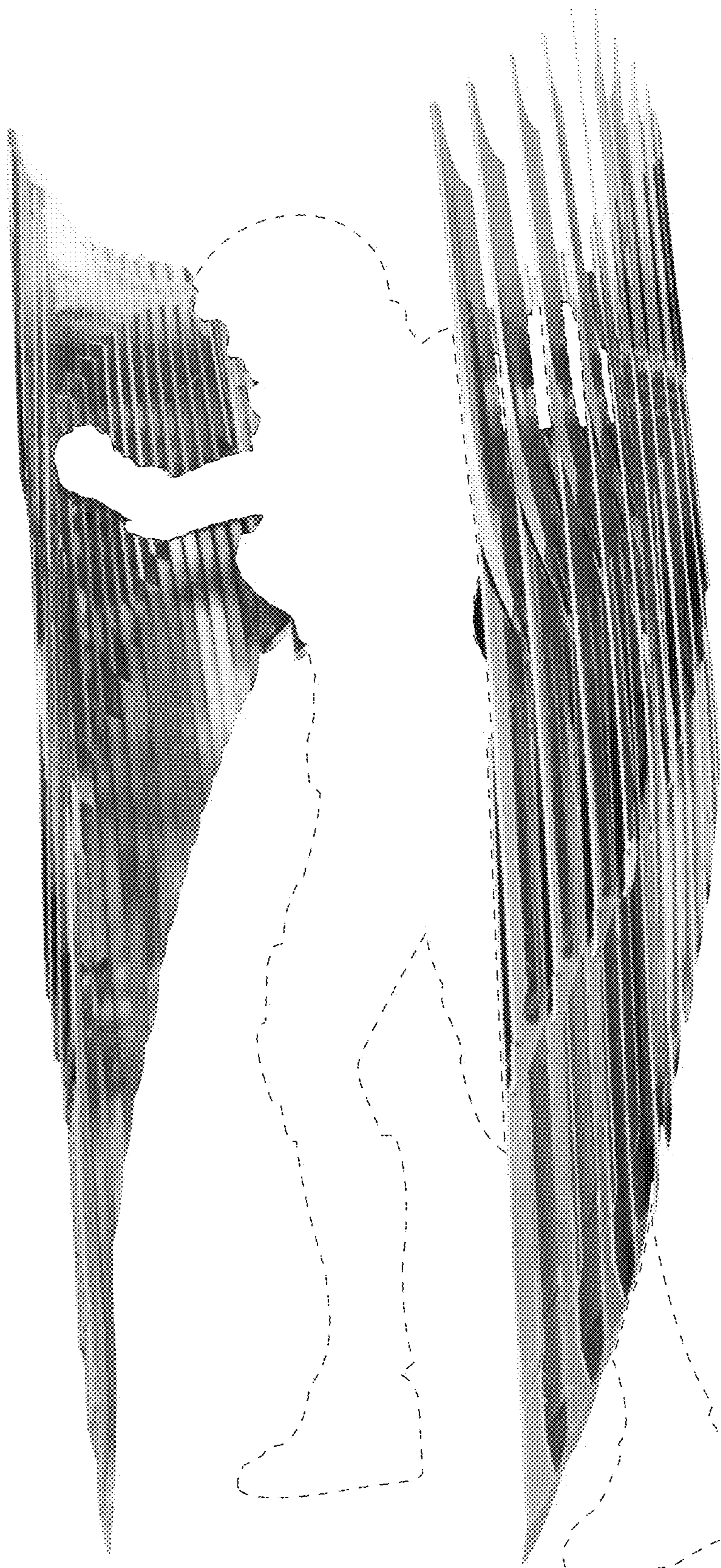

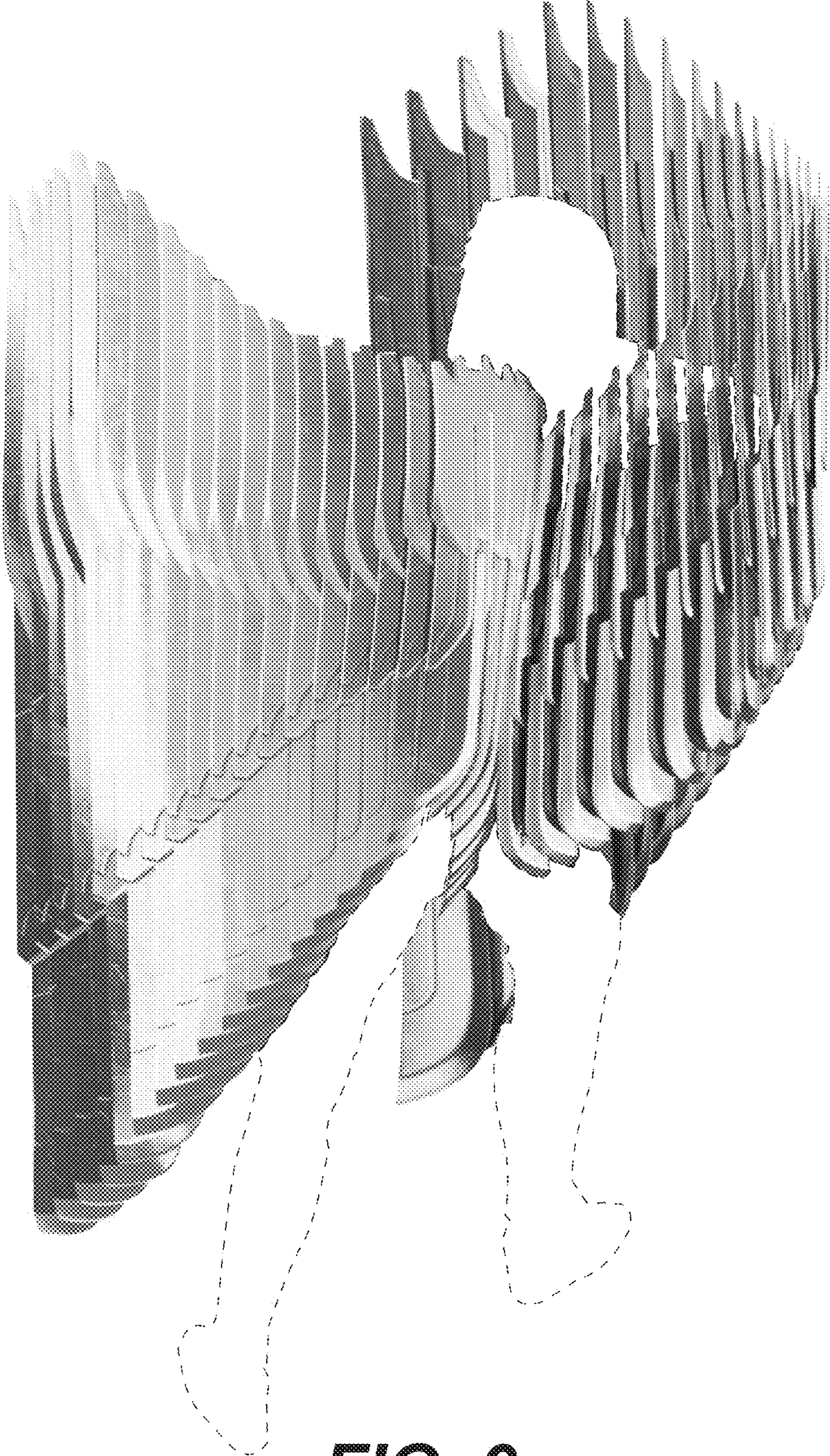

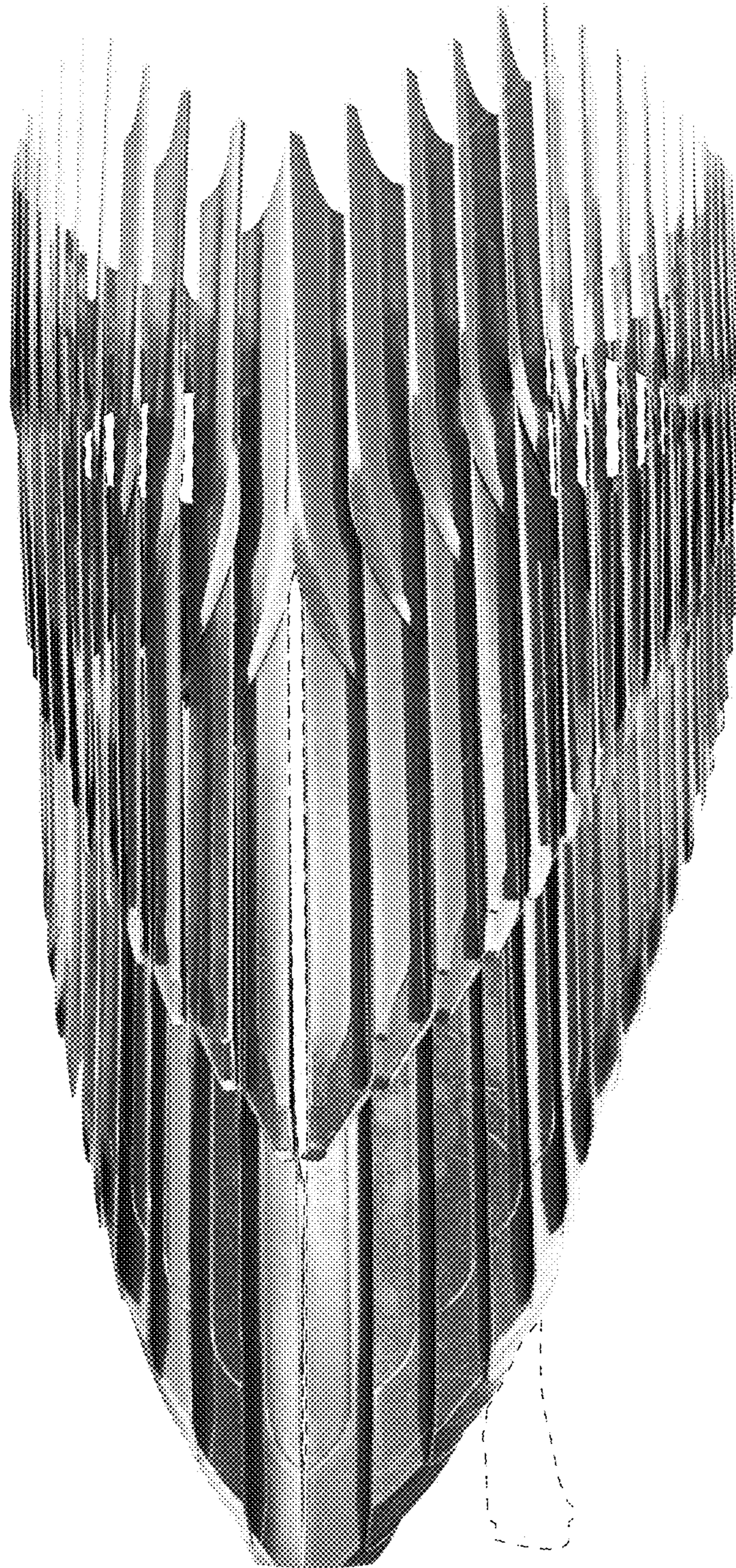

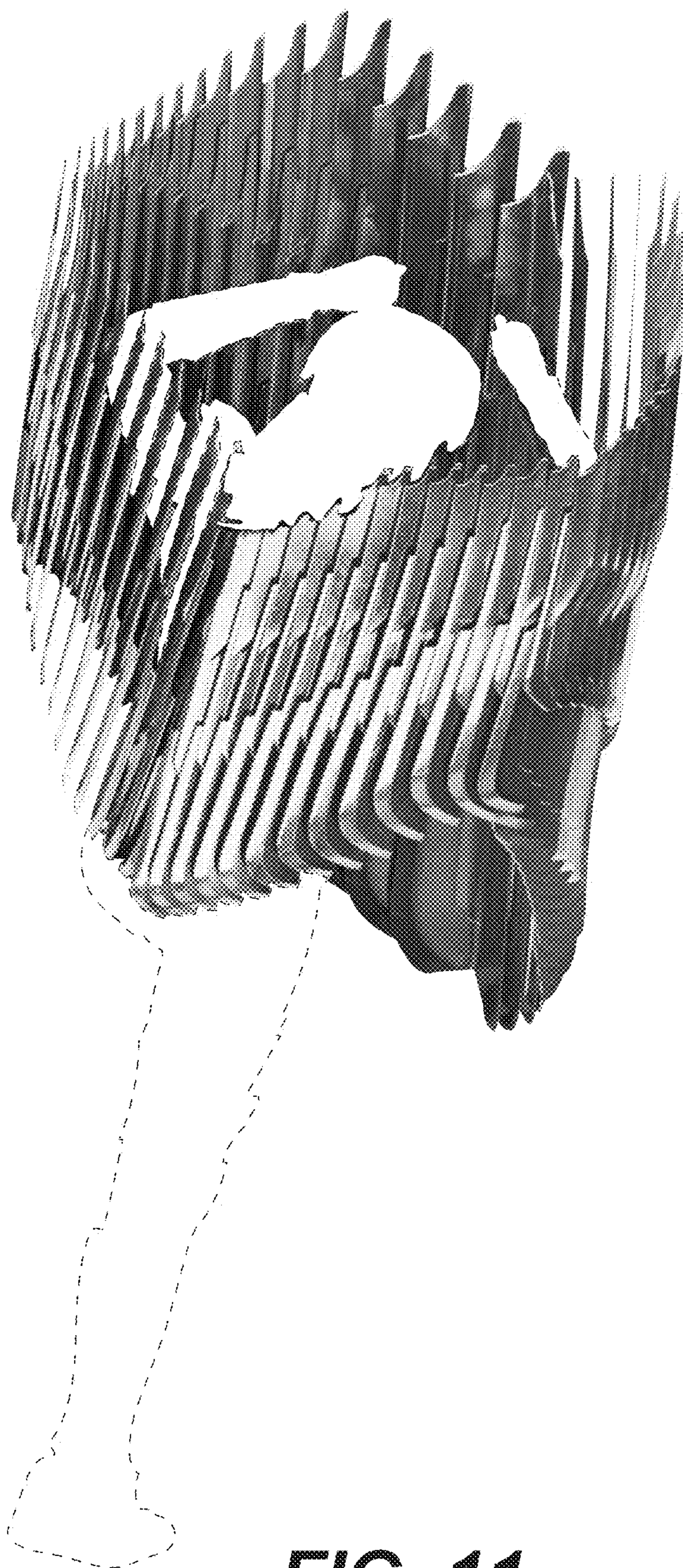

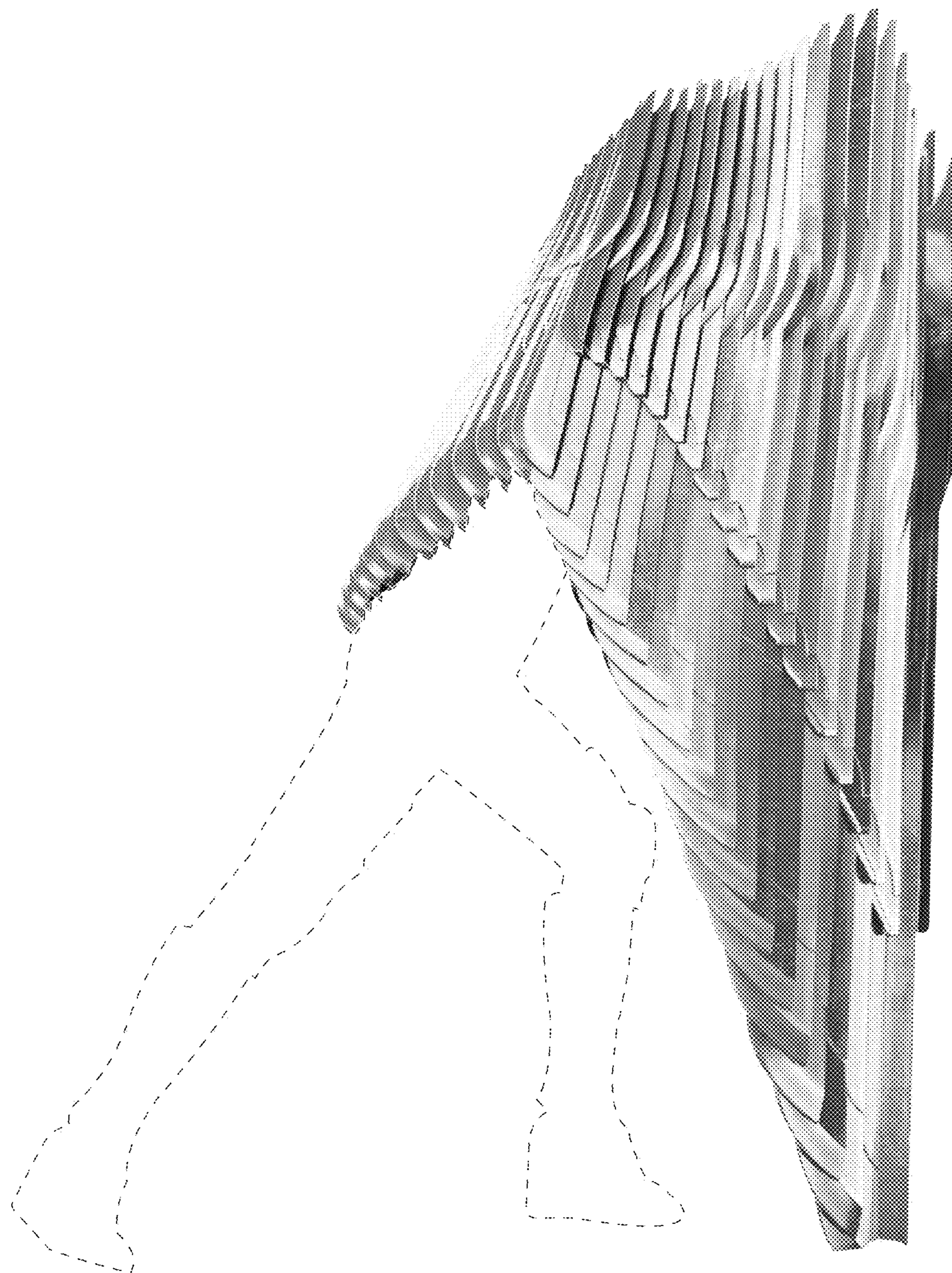
