The ornamental design for a helmet, as shown and described.

DESCRIPTION

FIG. 1 is a front left side perspective view of a helmet showing our new design, the front right side perspective being a mirror image thereof;

FIG. 2 is an enlarged front right side perspective view thereof, the enlarged front left side perspective being a mirror image thereof;

FIG. 3 is an enlarged left side view thereof, the enlarged right side being a mirror image thereof;

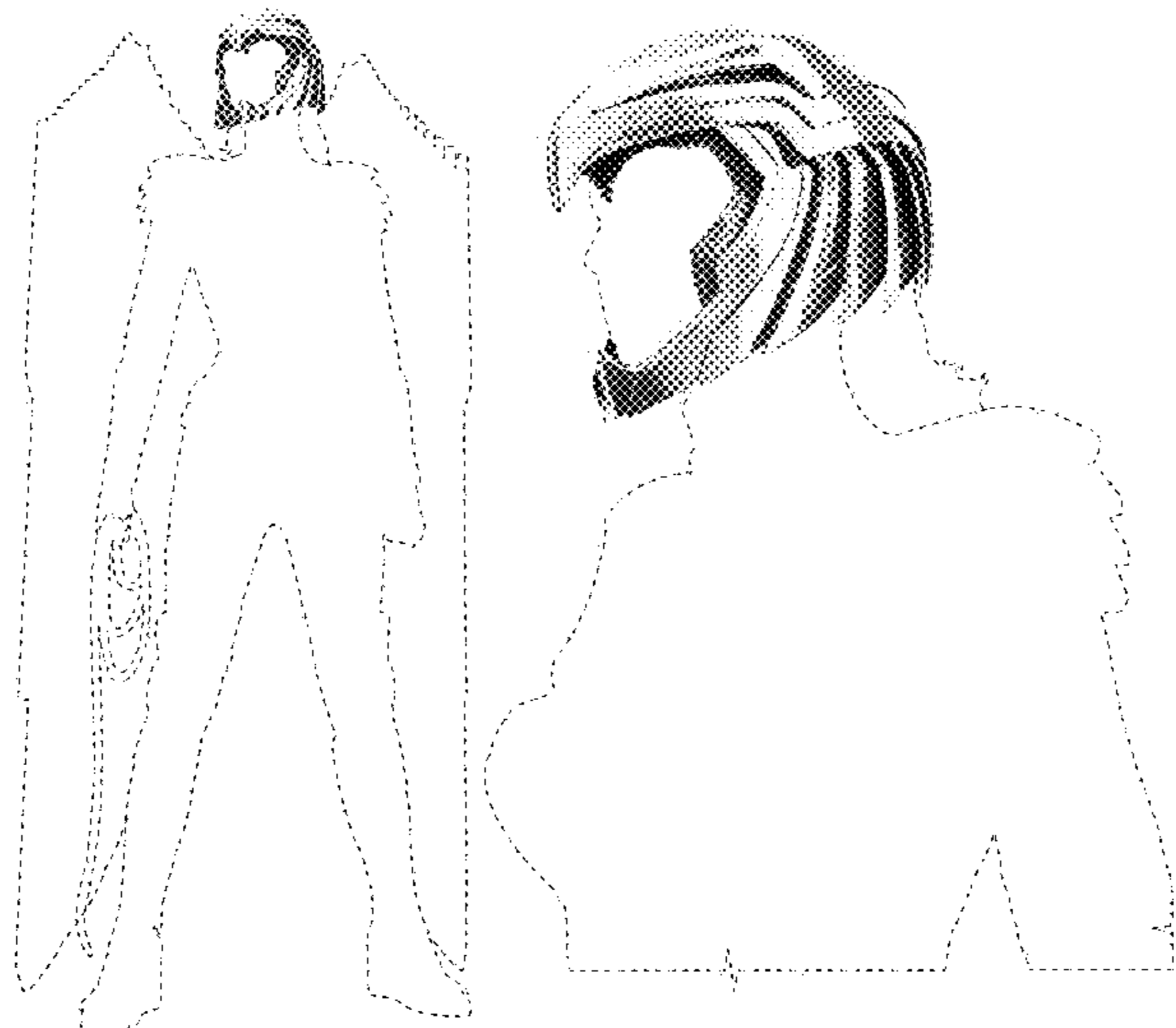
FIG. 4 is a front left side perspective view of a helmet showing our new design, shown in color, the front right side perspective being a mirror image thereof;

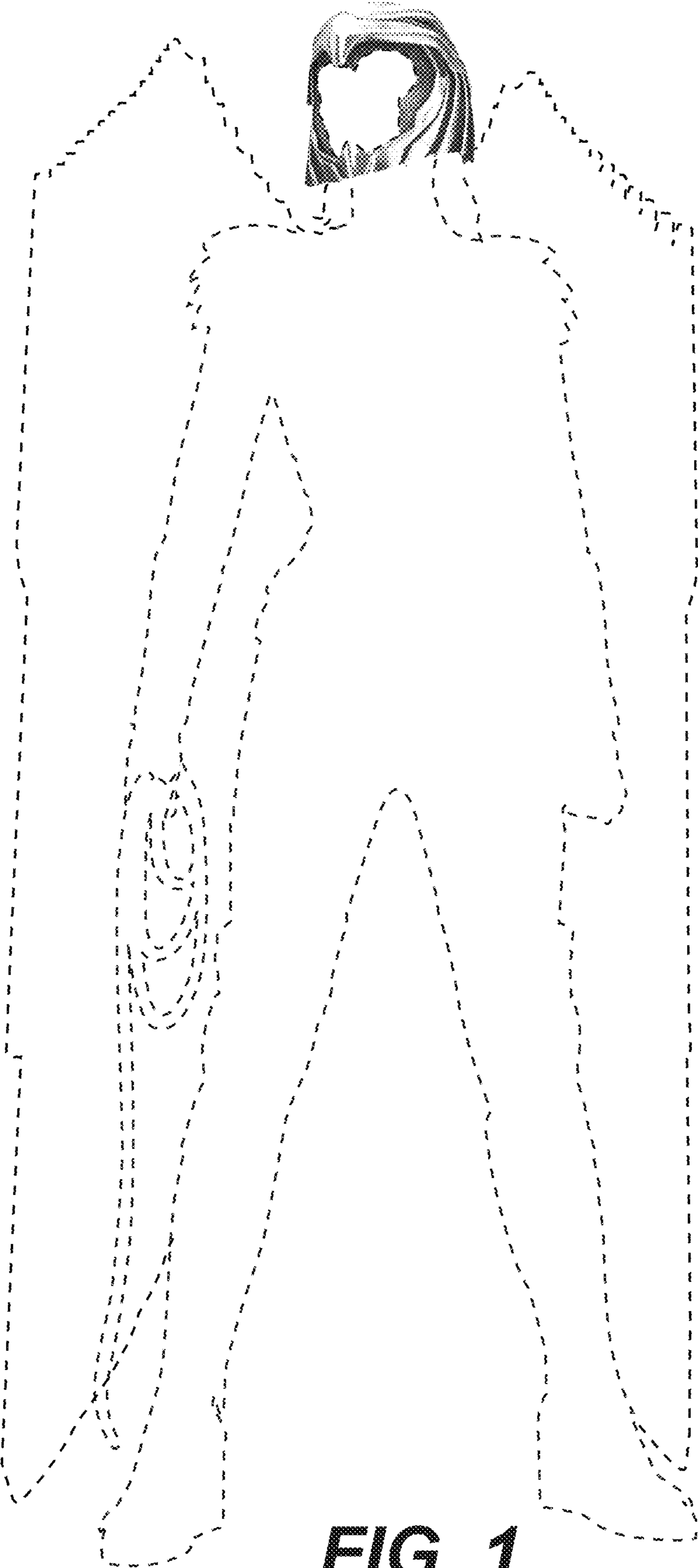

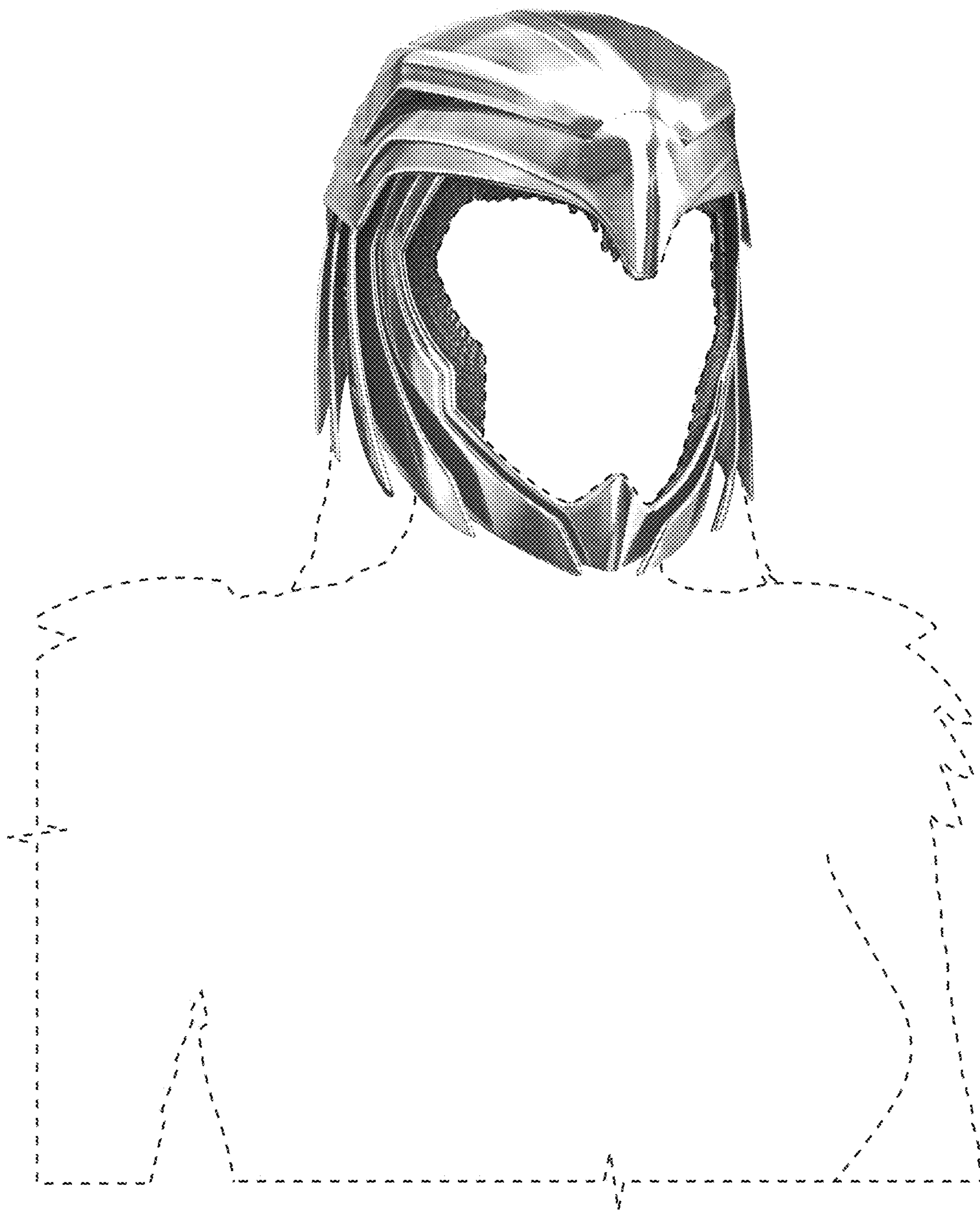

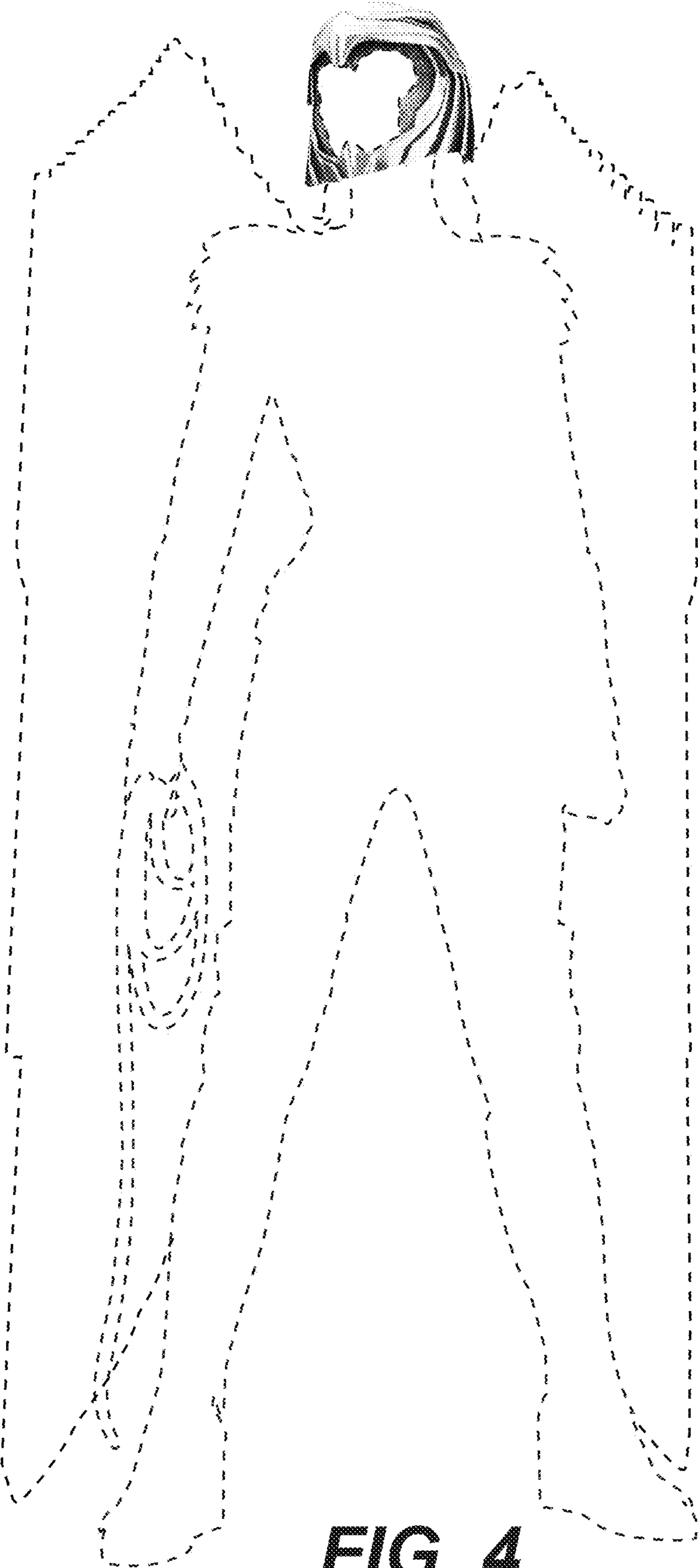

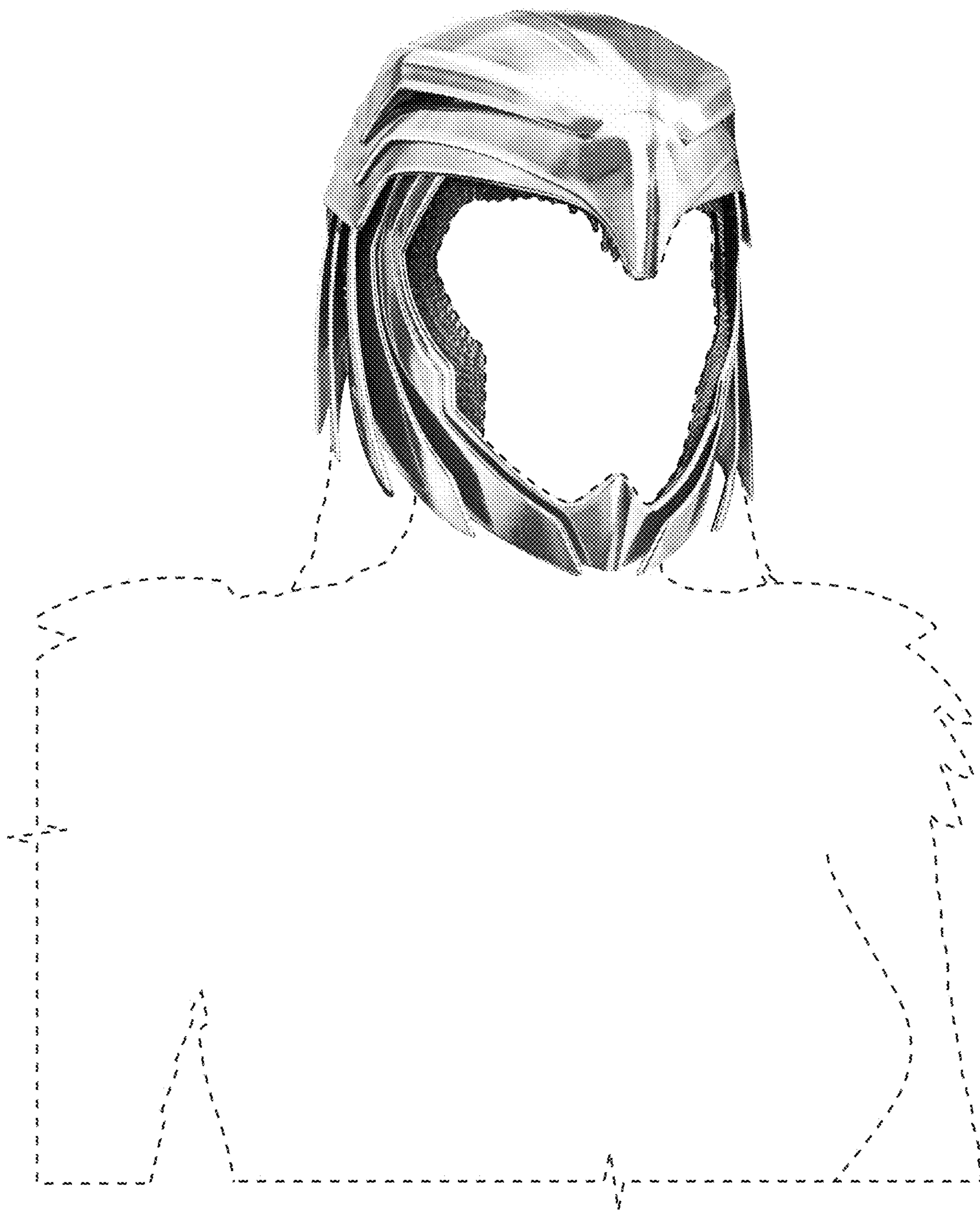
