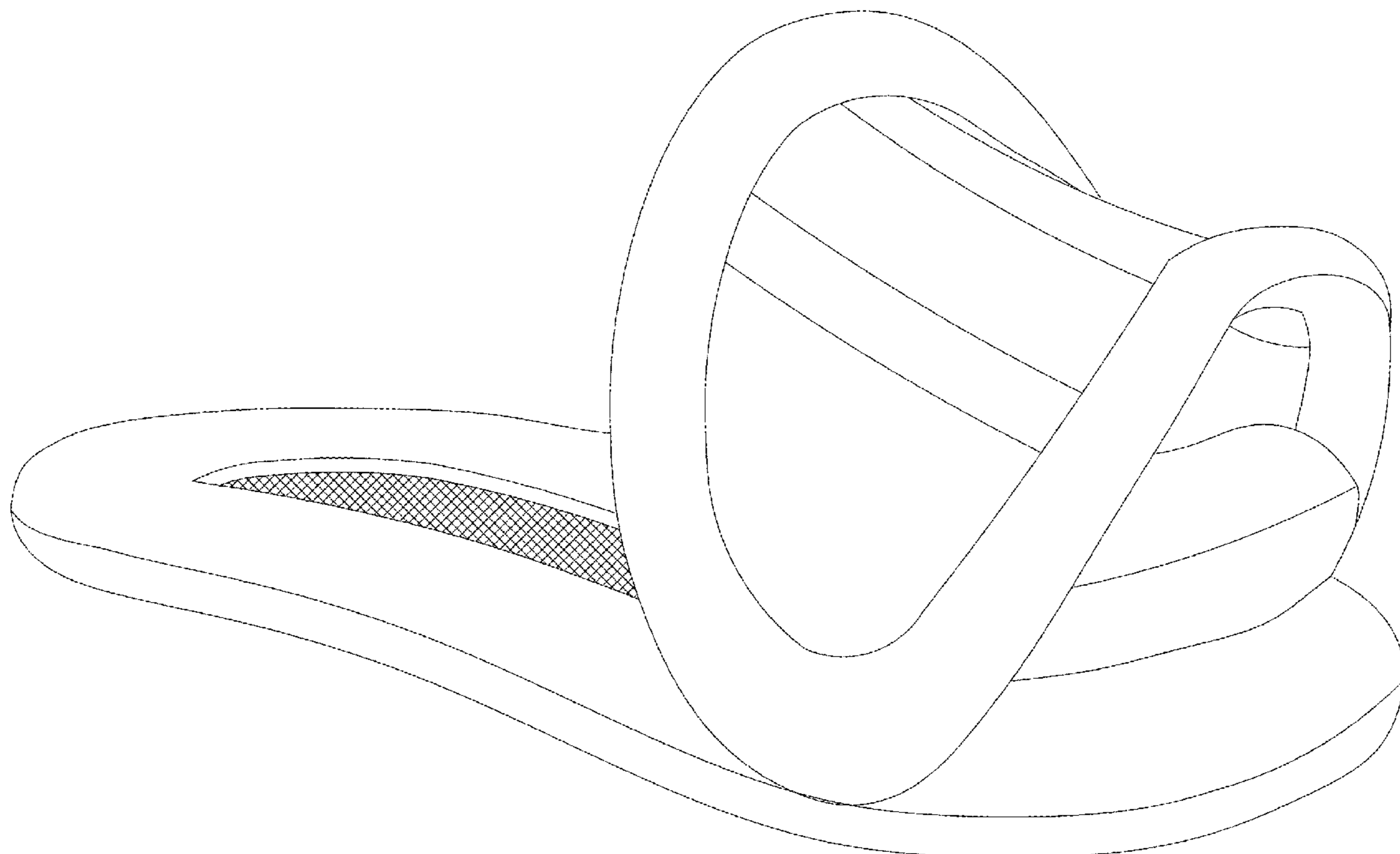
(57) **CLAIM**

The ornamental design for a pool float with arch canopy, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a pool float with arch canopy showing my new design;
 FIG. 2 is a bottom, rear, left side perspective view thereof;
 FIG. 3 is an enlarged front elevation view thereof;
 FIG. 4 is an enlarged rear elevation view thereof;
 FIG. 5 is a left side elevation view thereof;
 FIG. 6 is a right side elevation view thereof;
 FIG. 7 is a top plan view thereof; and,
 FIG. 8 is a bottom plan view thereof.
 The broken lines in the drawings illustrate portions of the pool float with arch canopy that form no part of the claimed design.

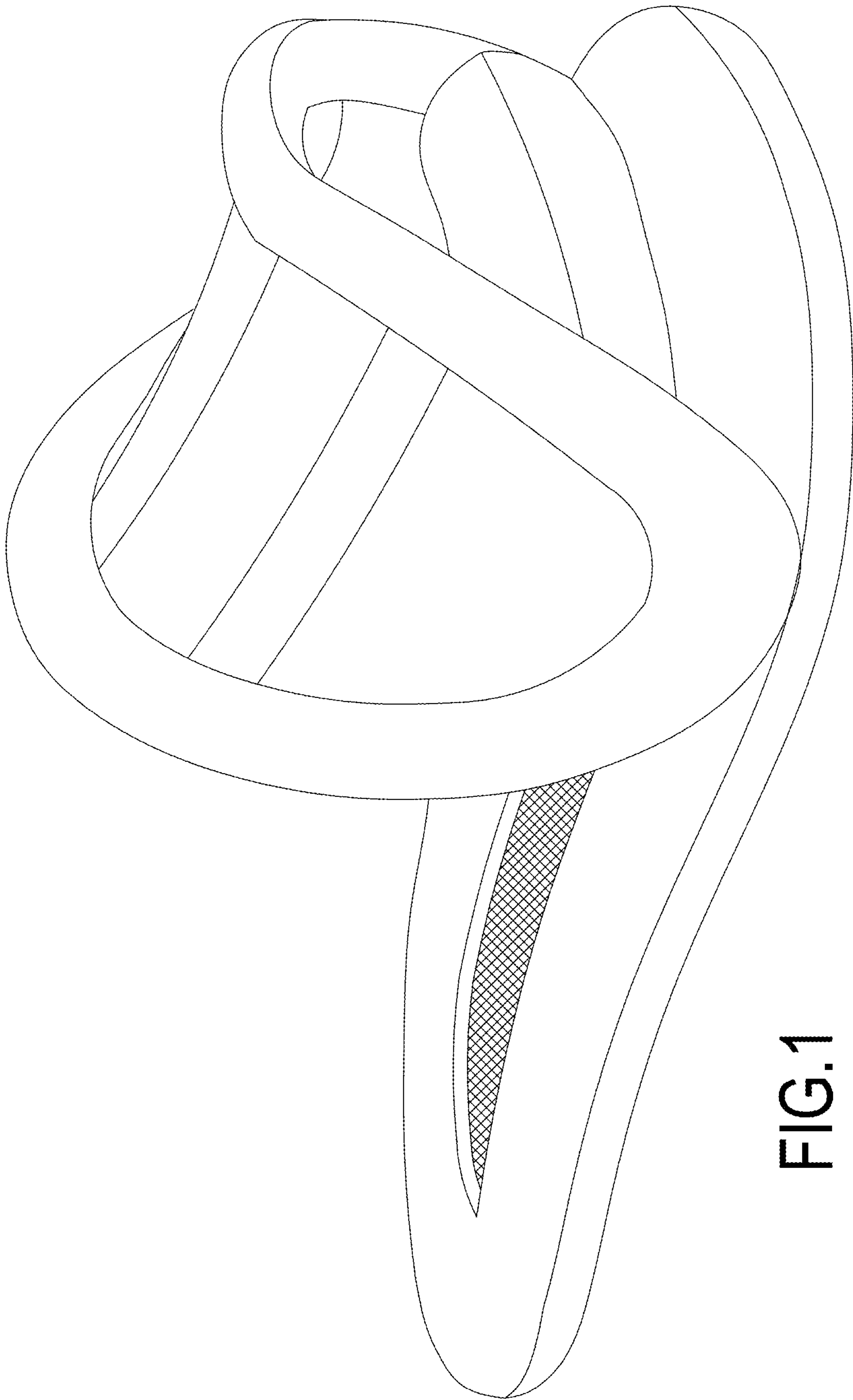

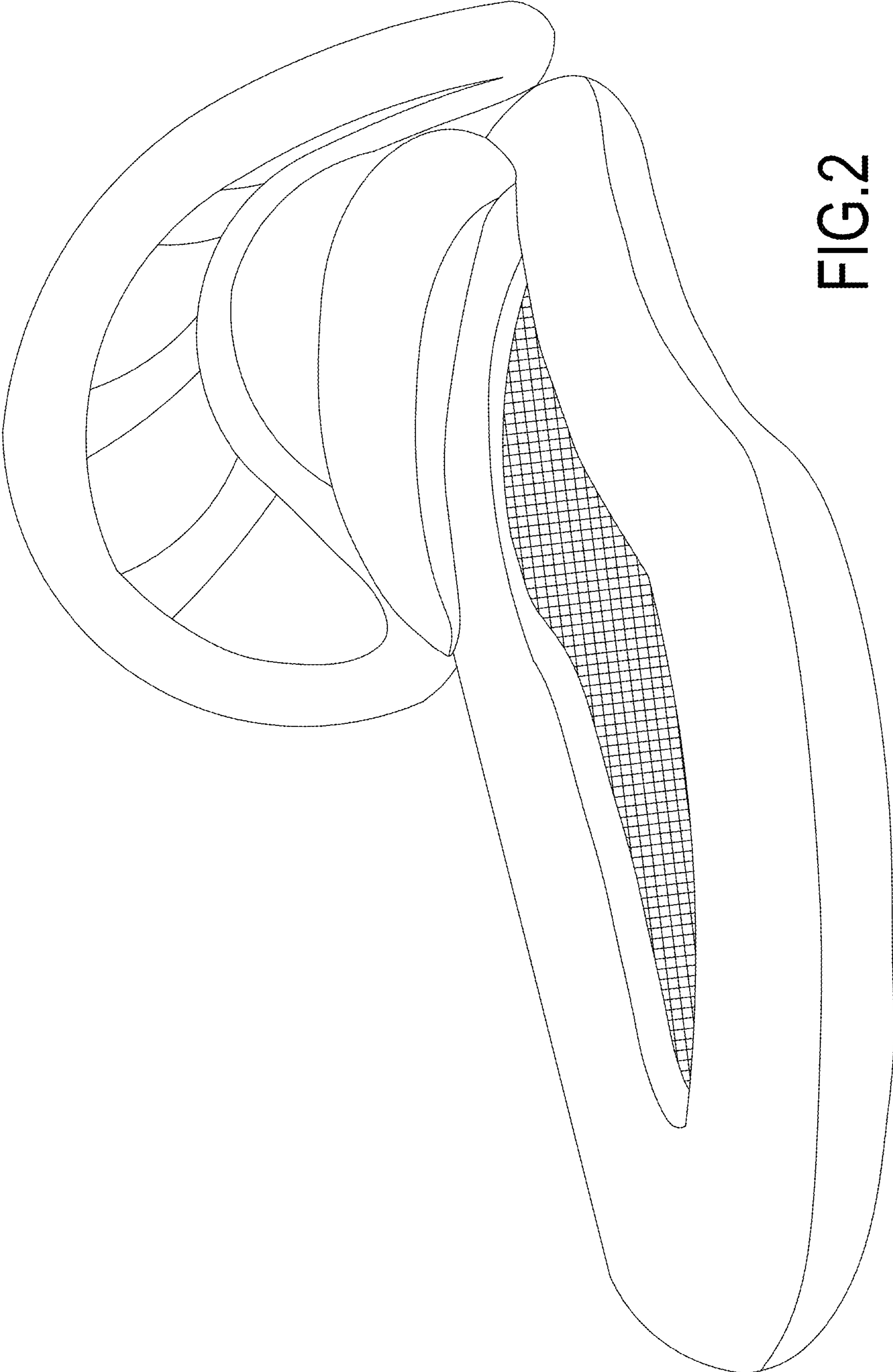

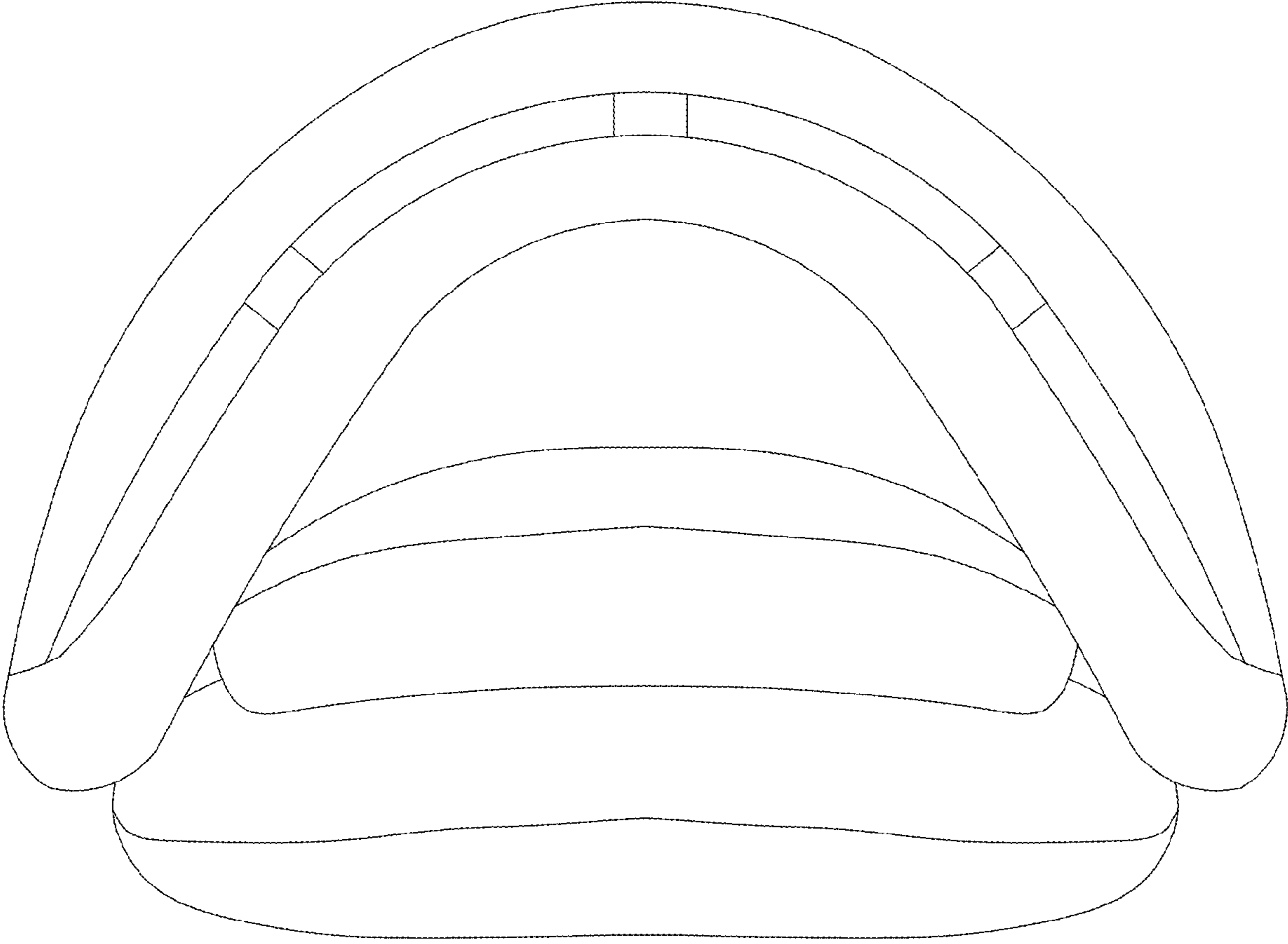

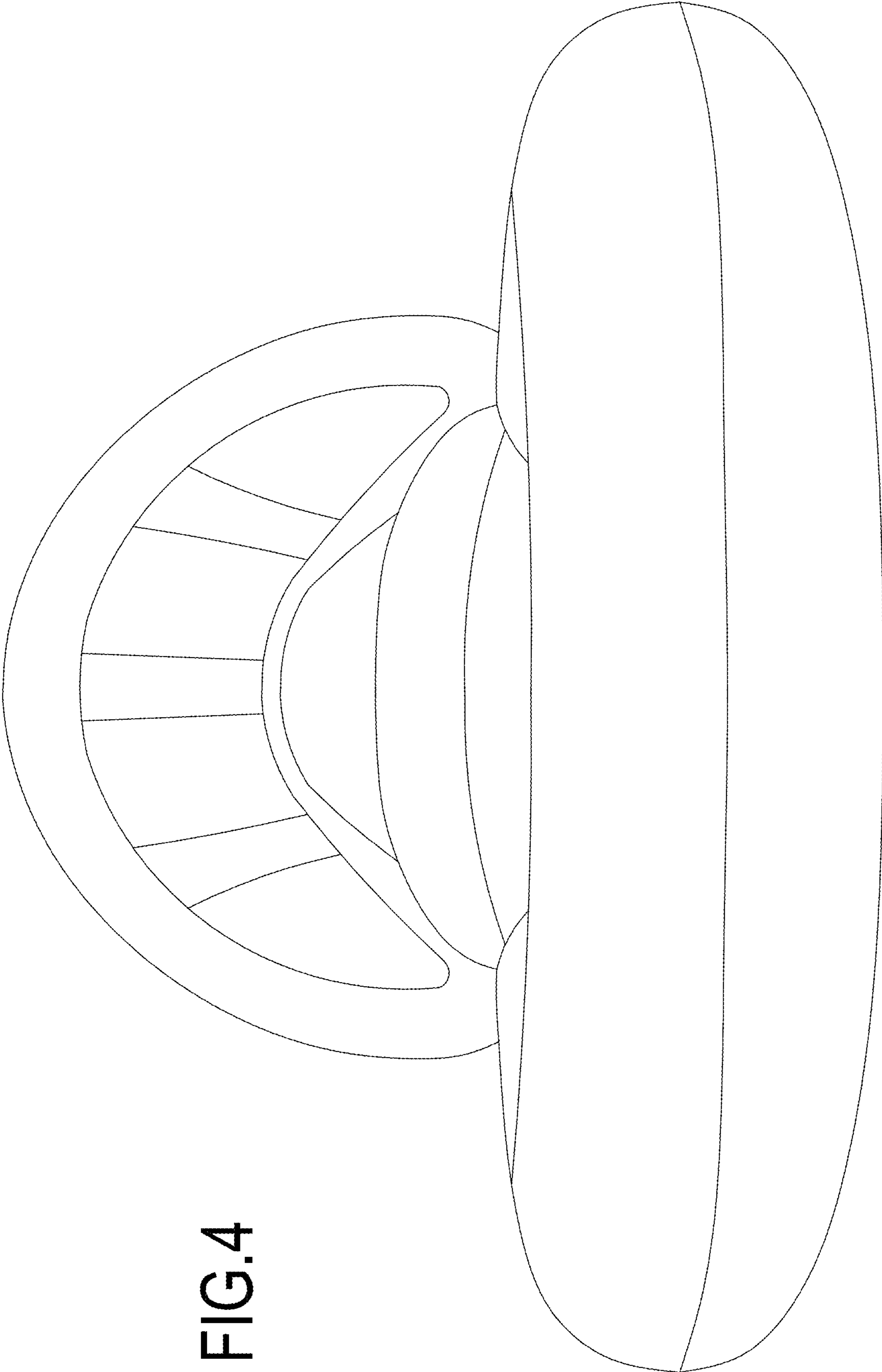

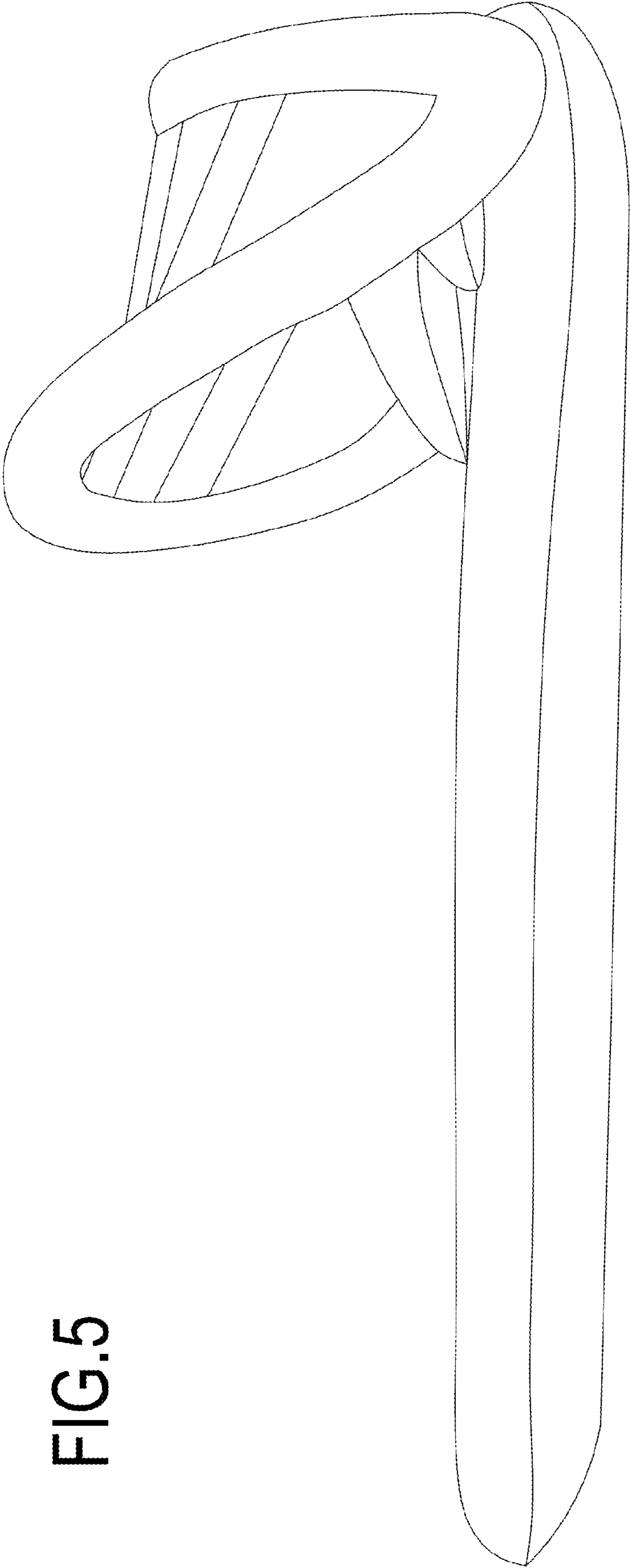
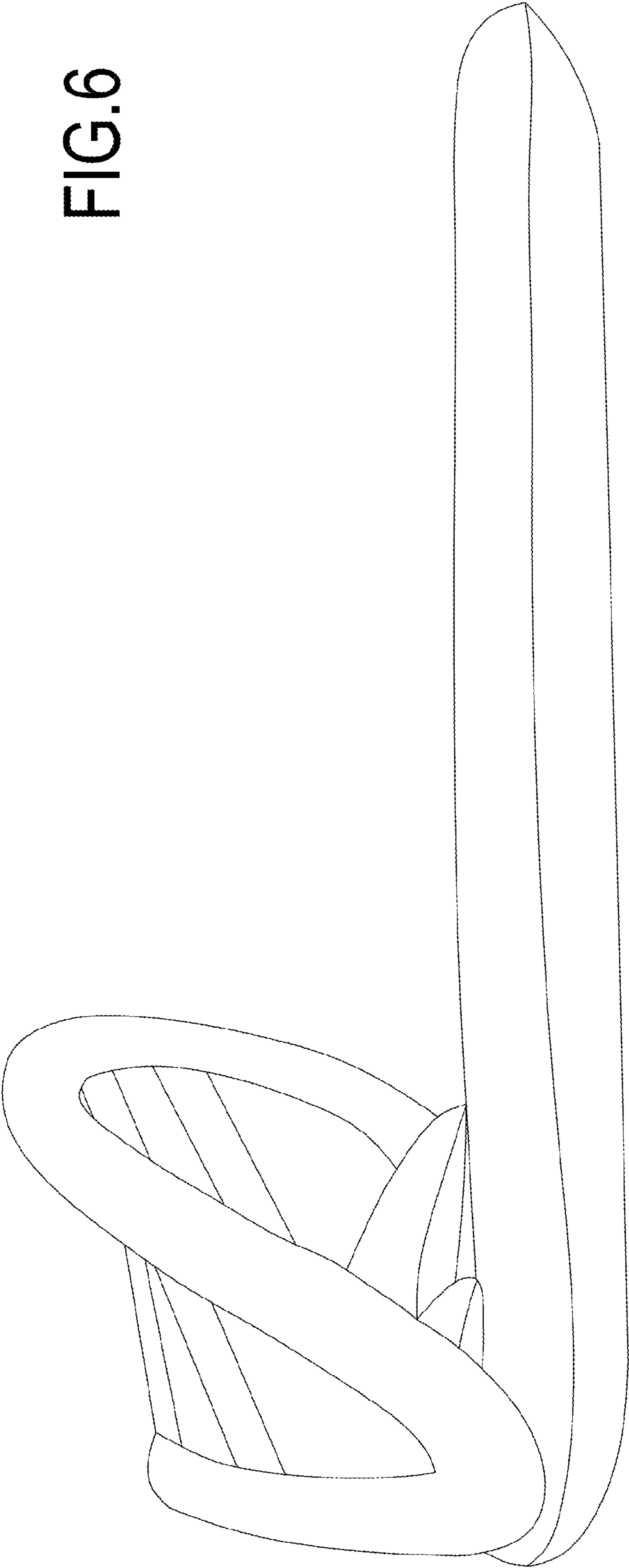

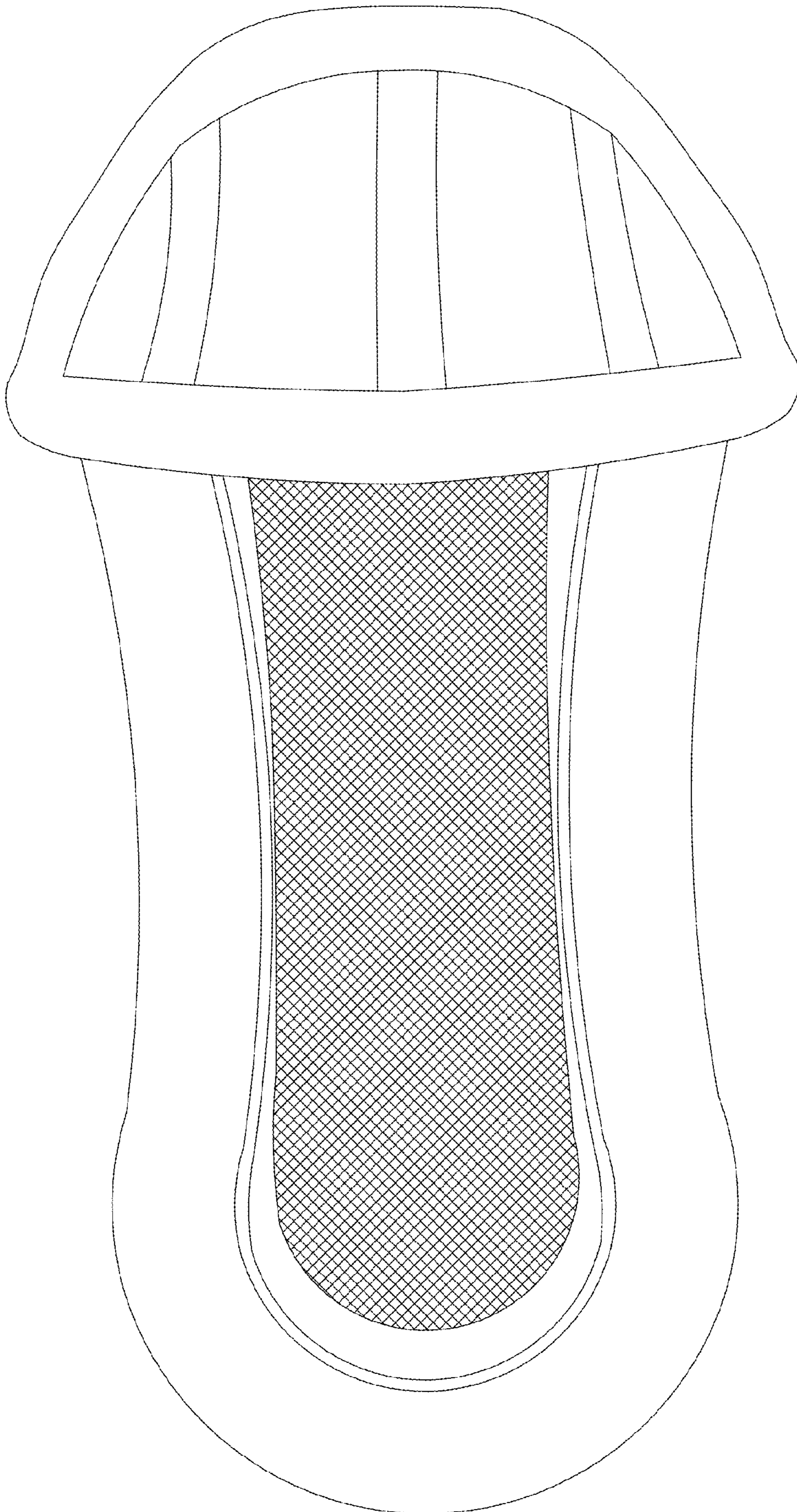

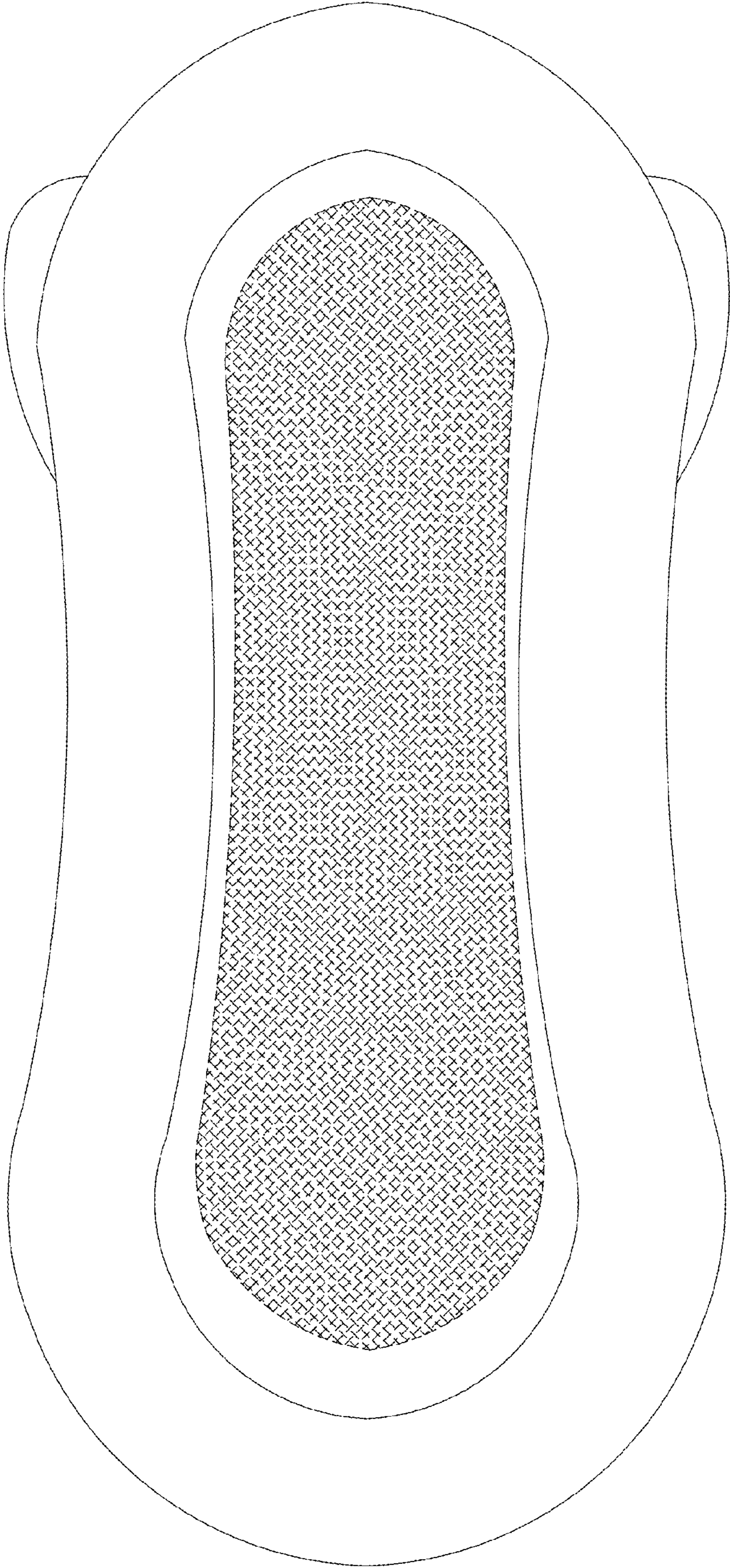
