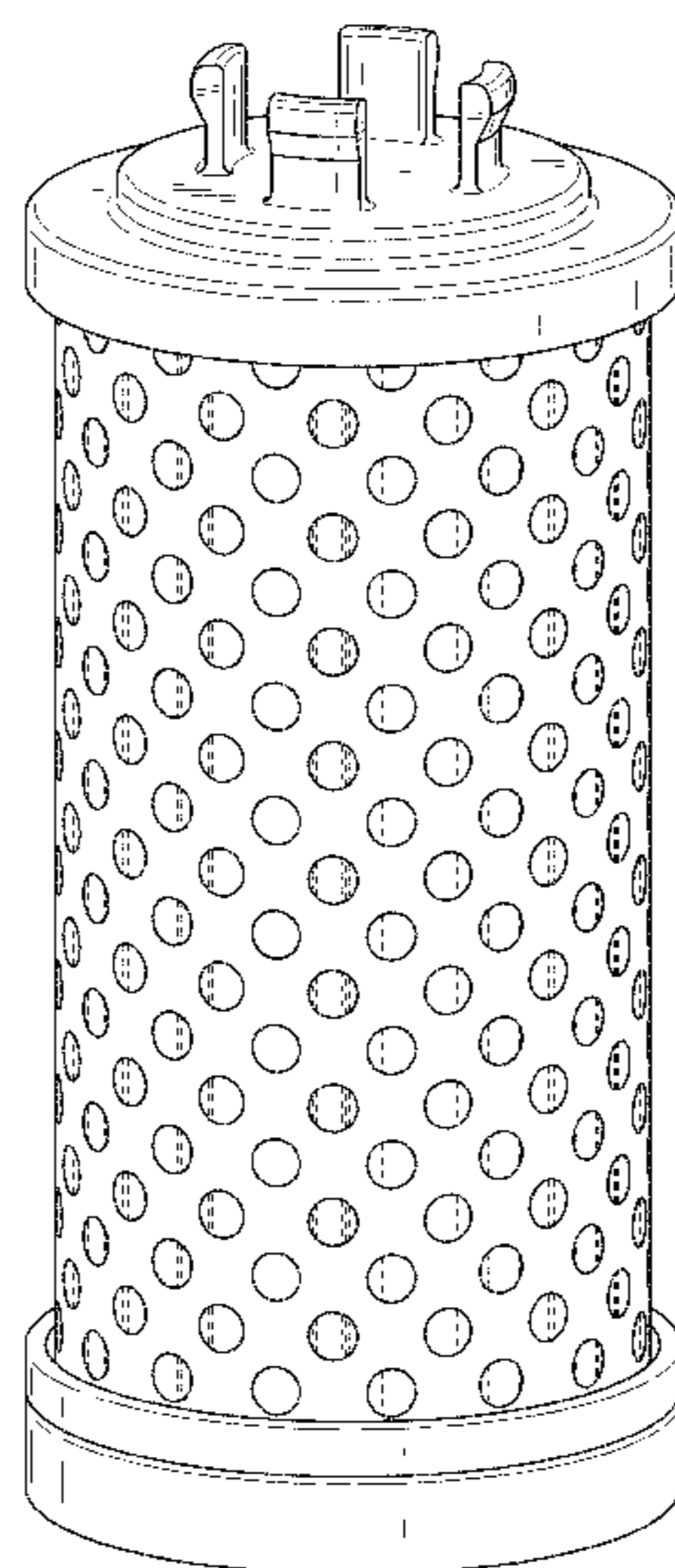
(57) **CLAIM**

We claim the ornamental design for an oil filter, as shown and described.

**DESCRIPTION**

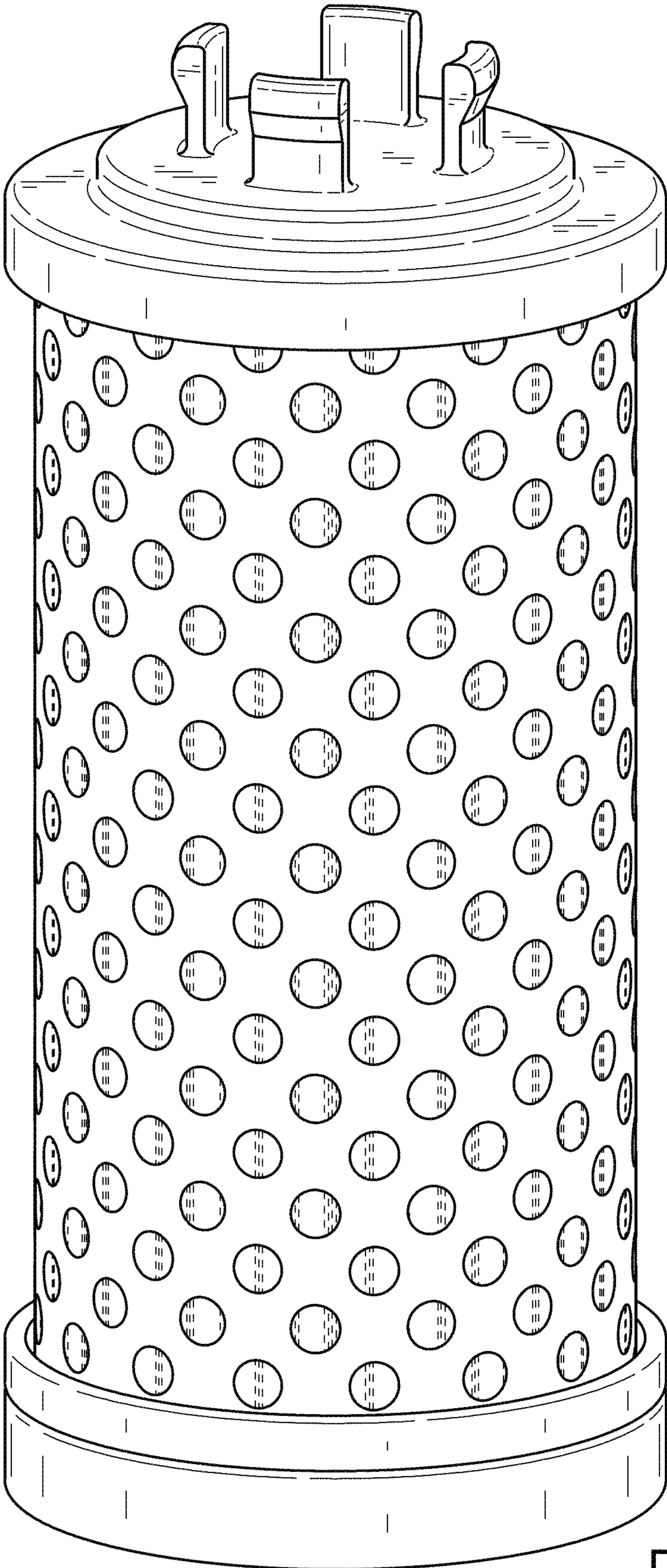

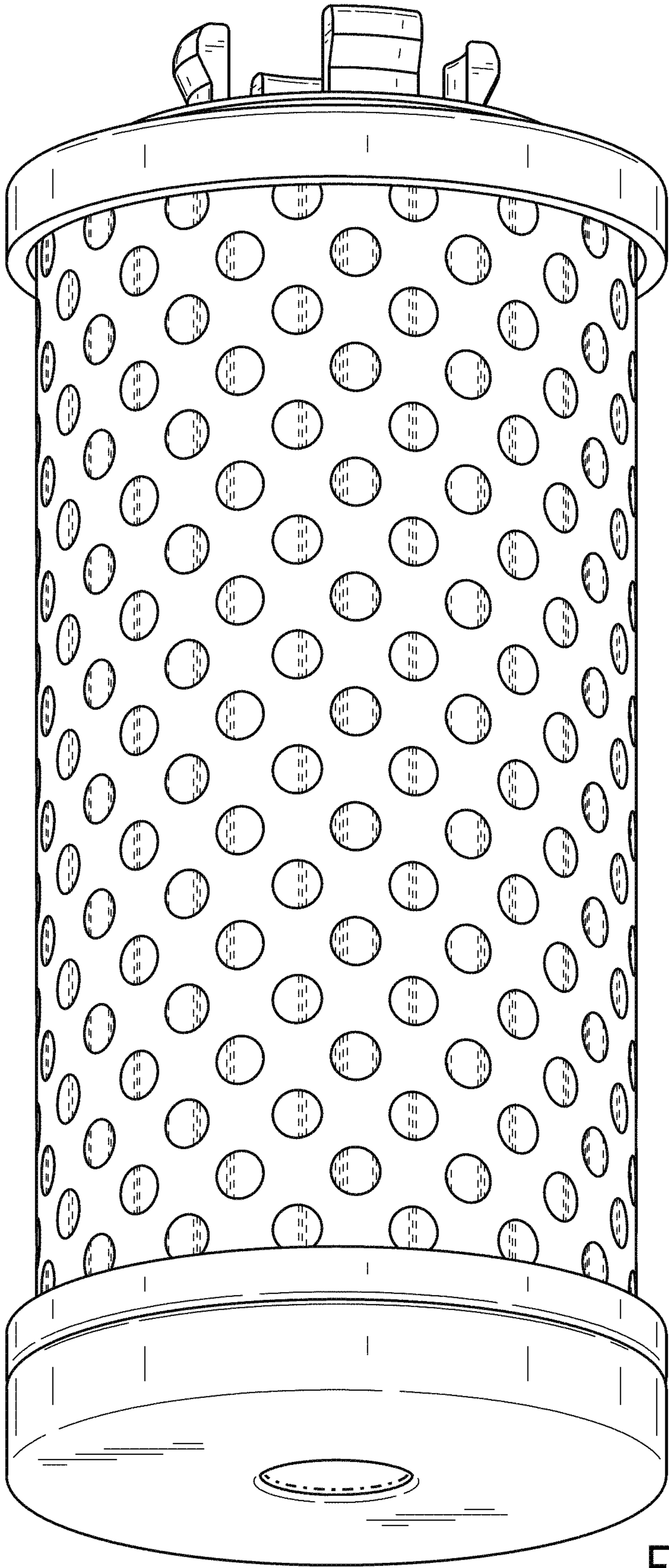

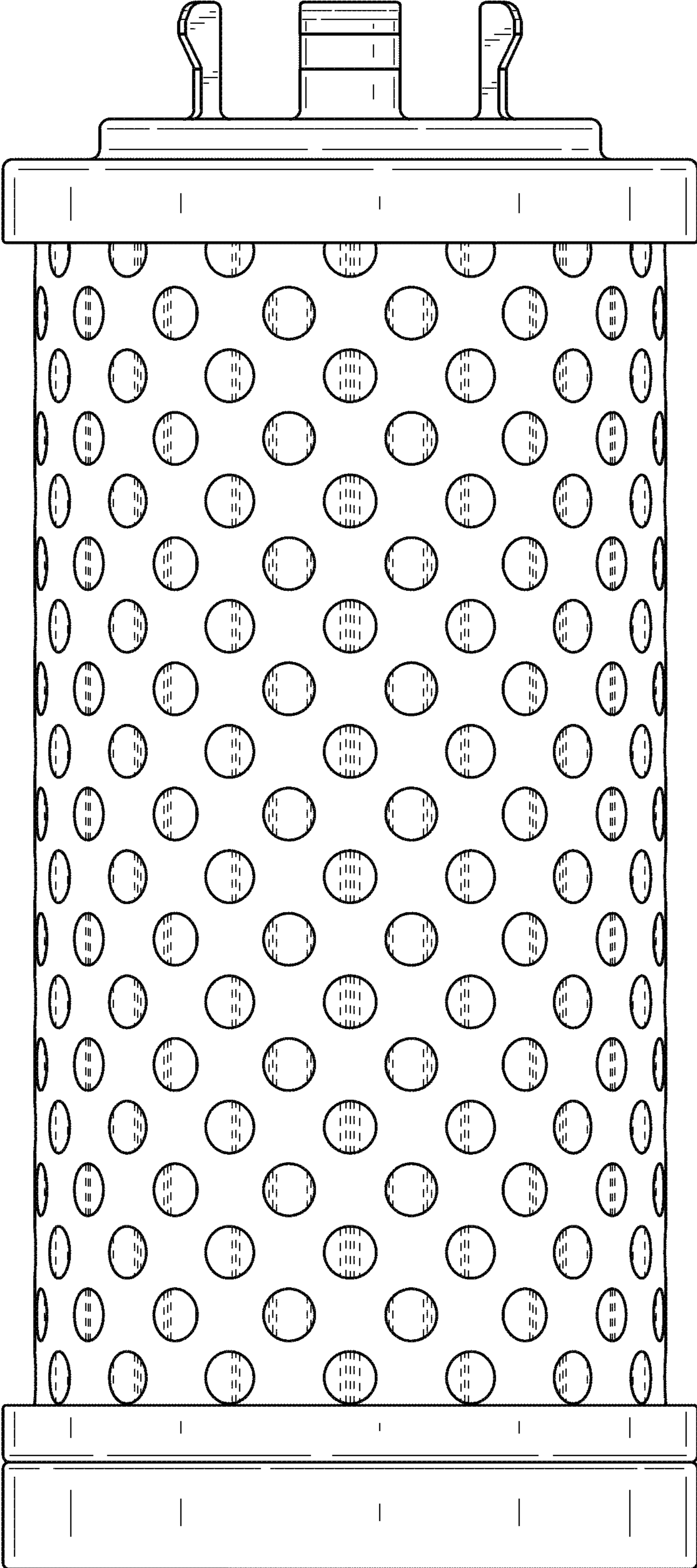

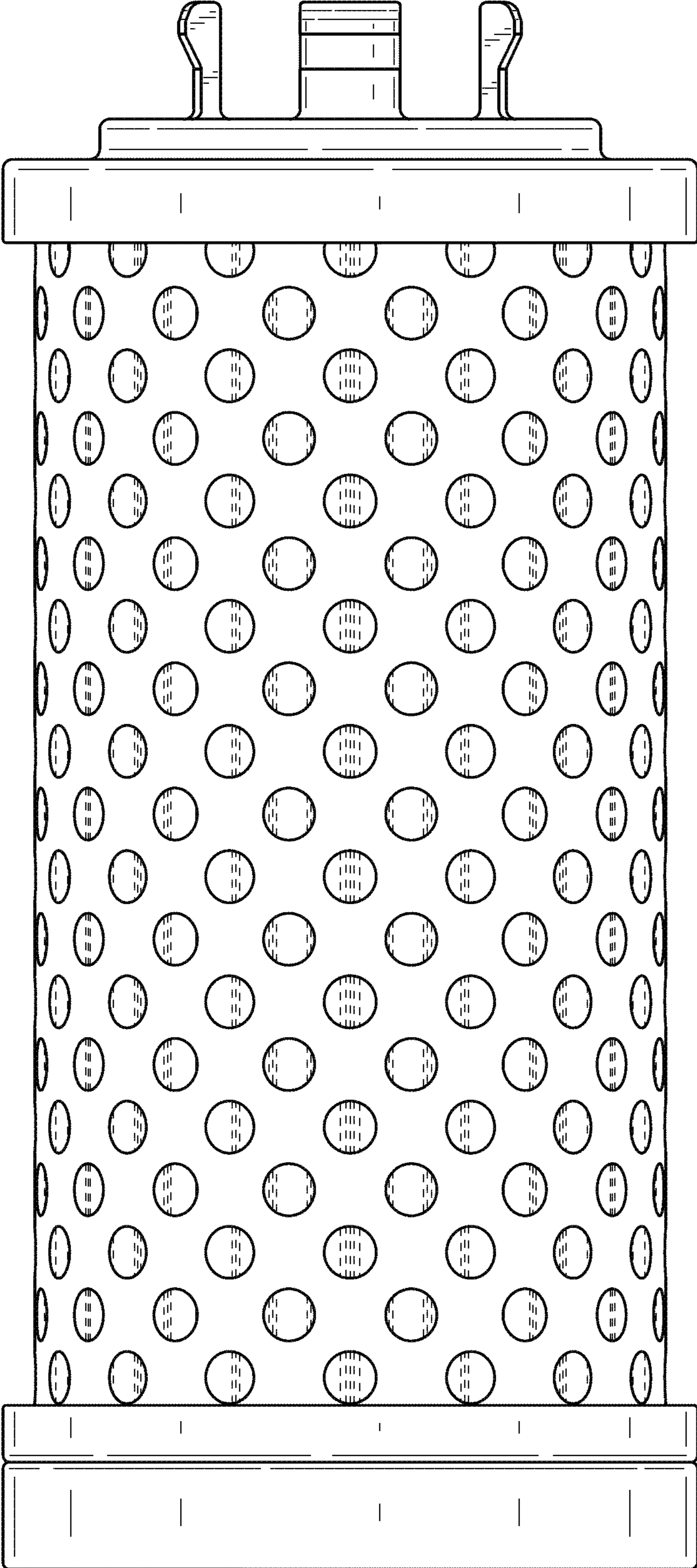

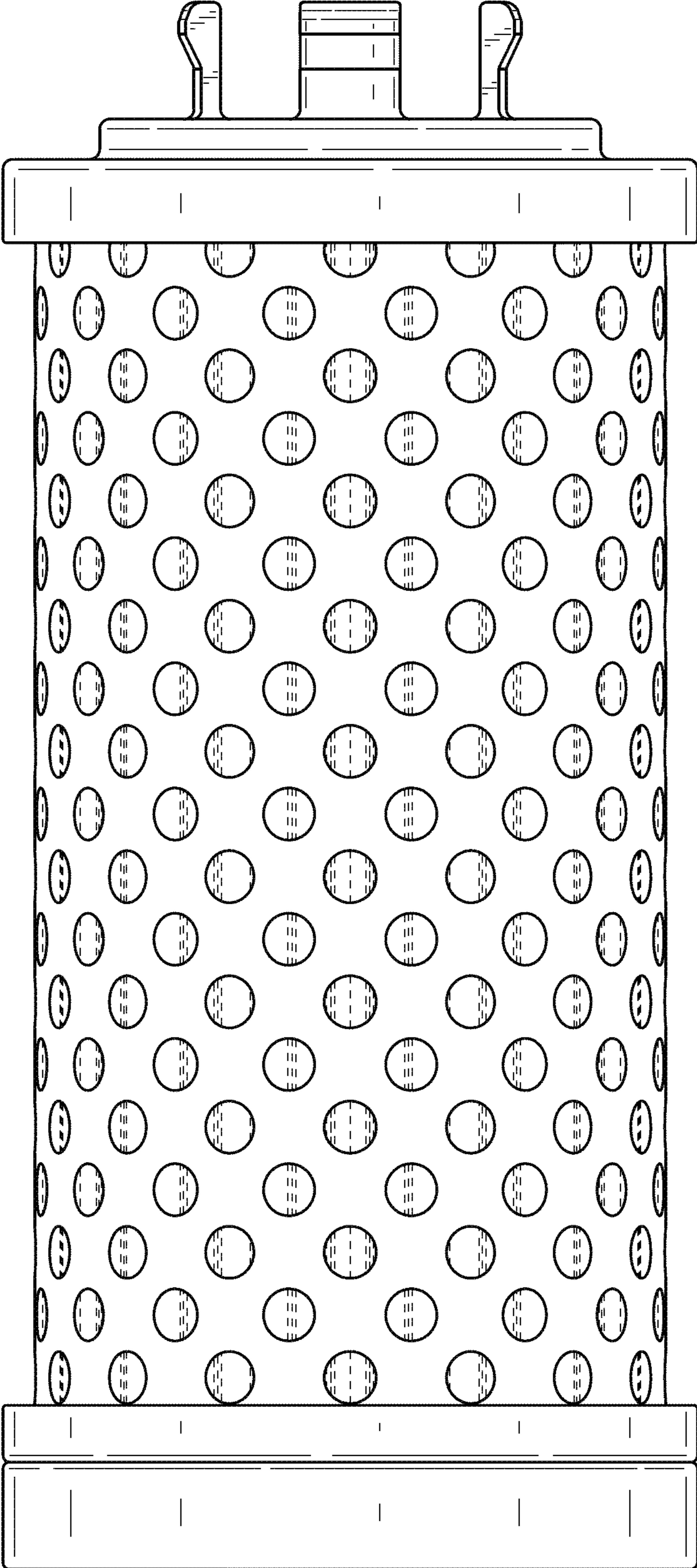

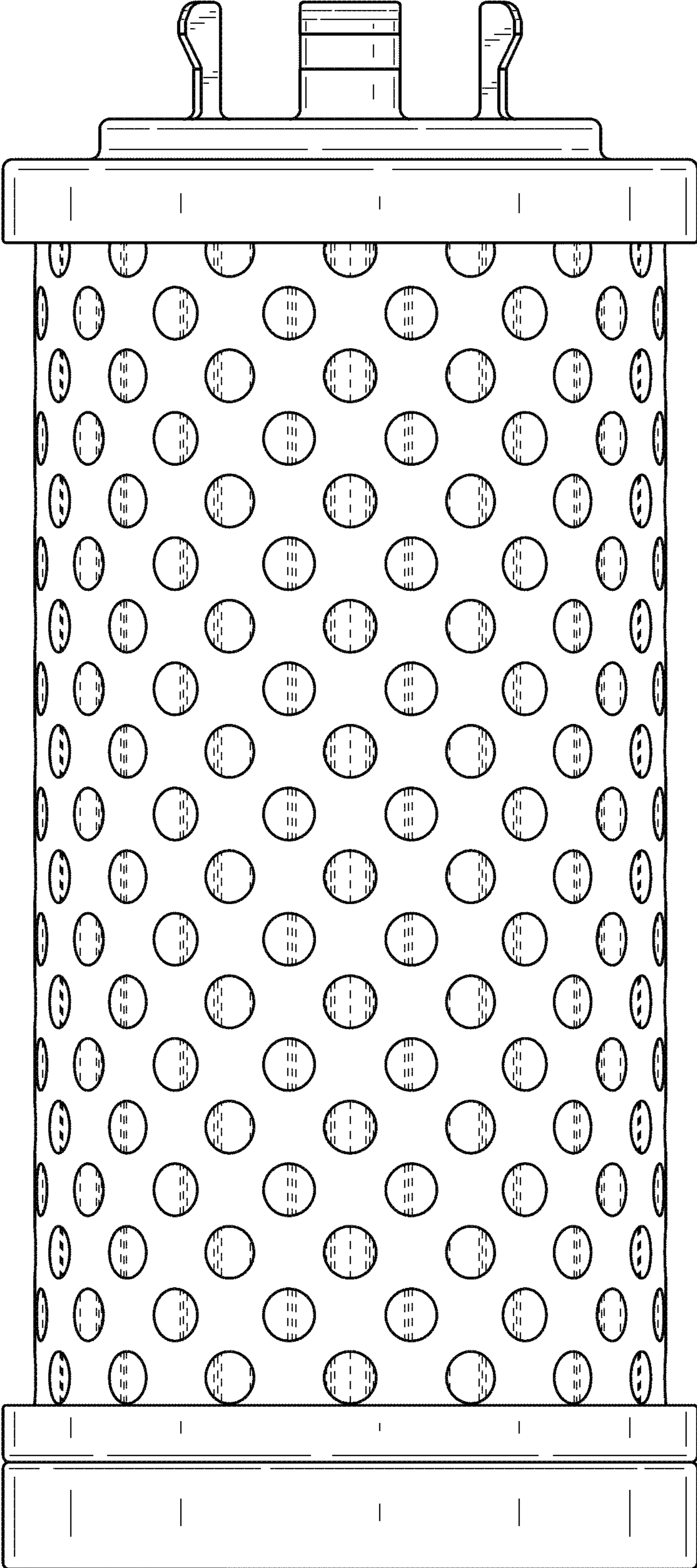

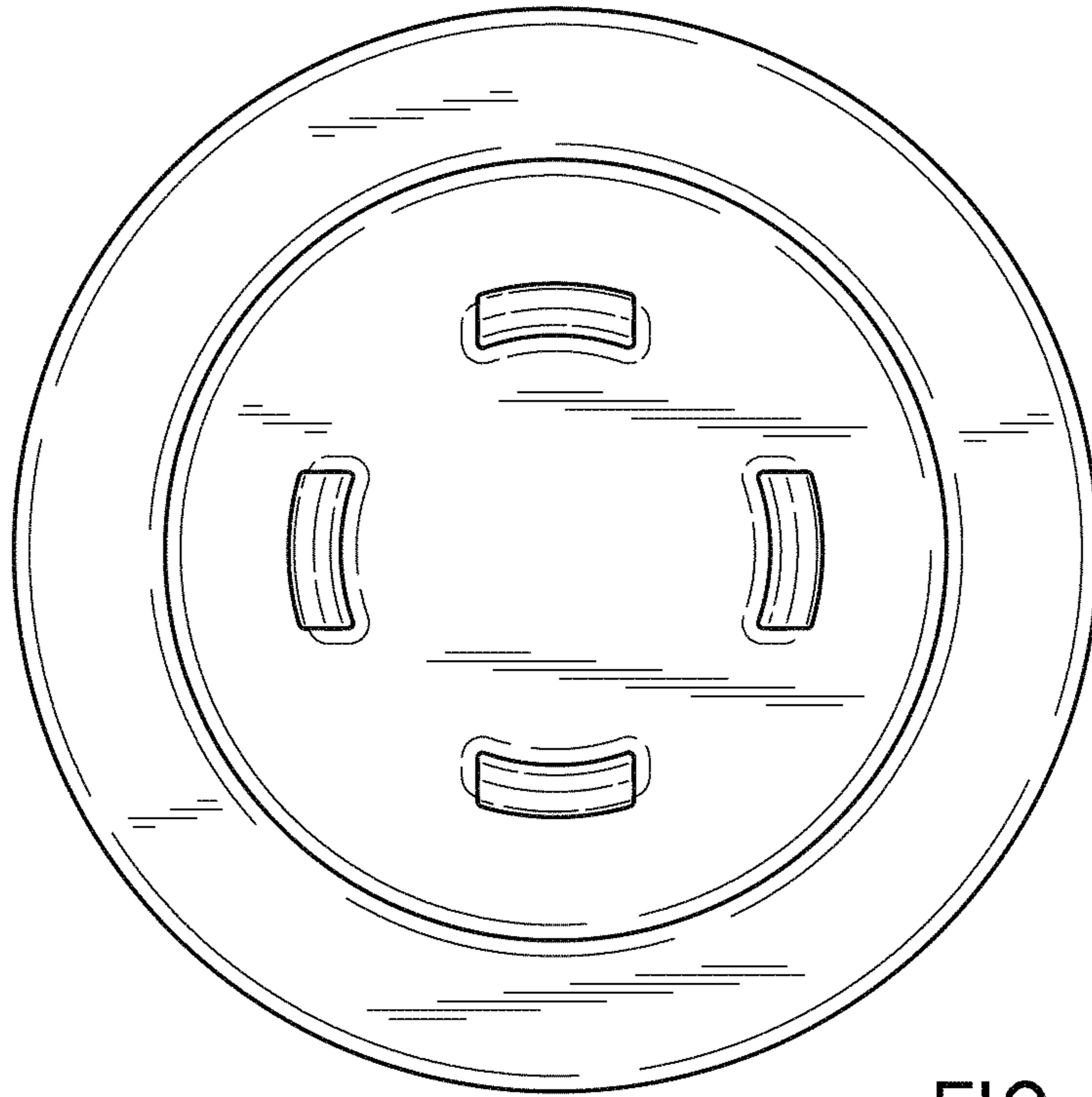

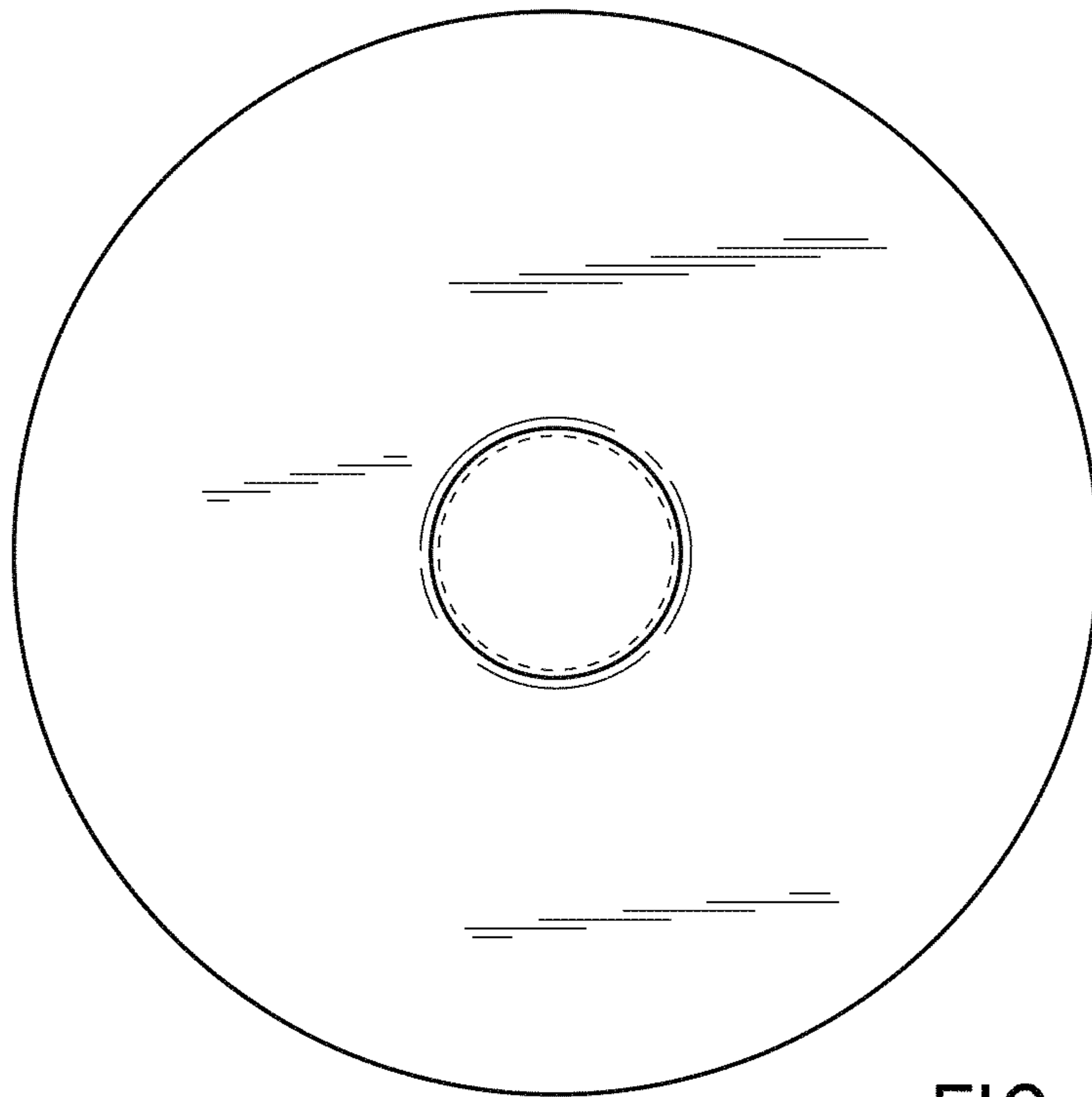
