**DESCRIPTION**

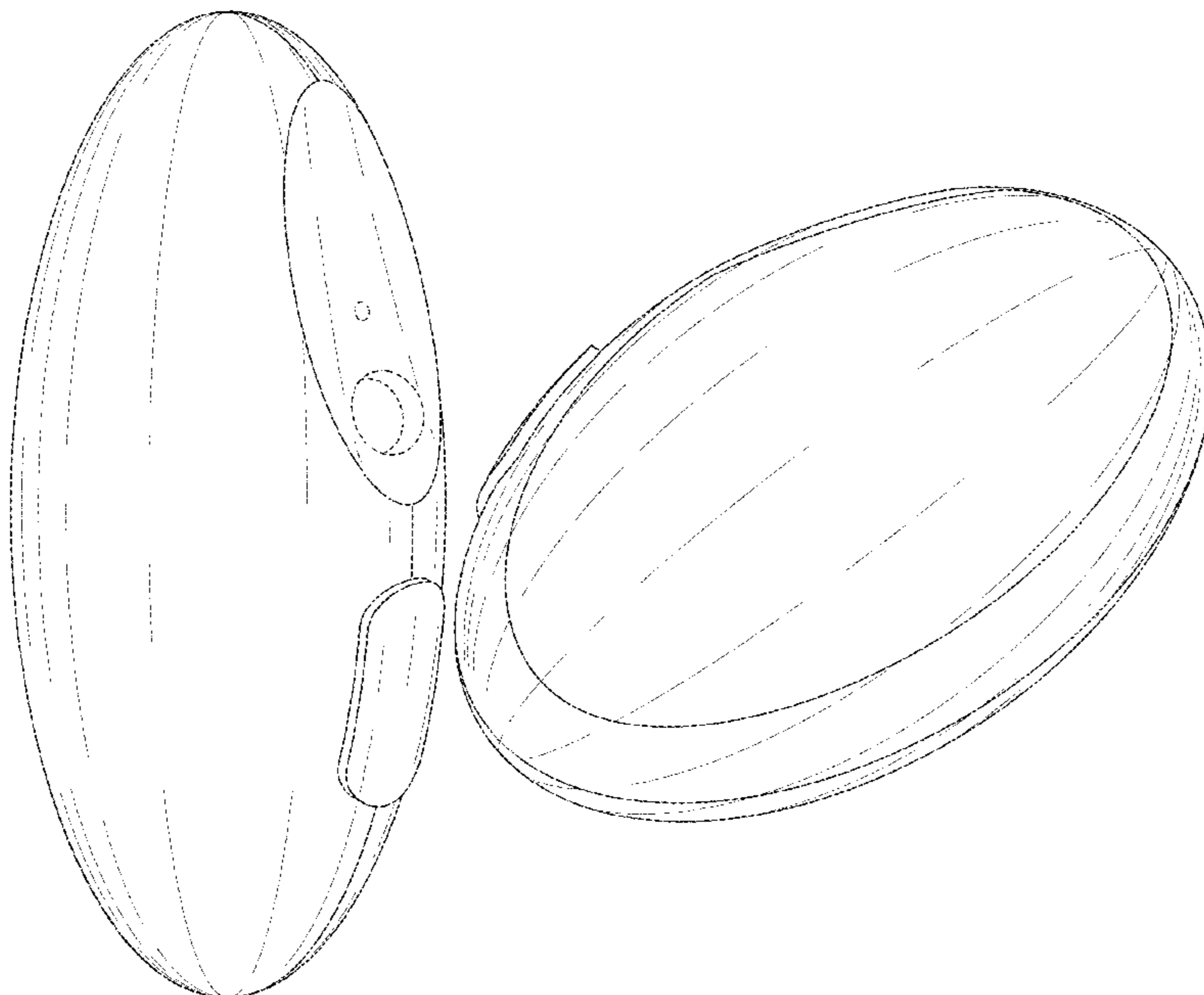
FIG. 1 is a front elevational view of an aroma diffuser showing my new design;

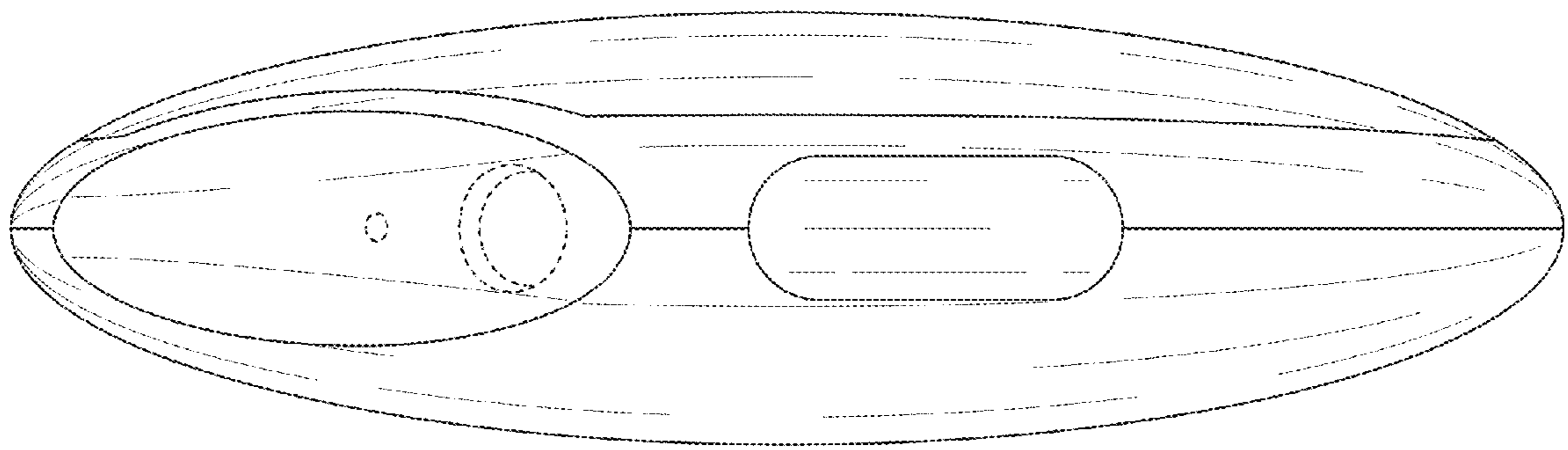

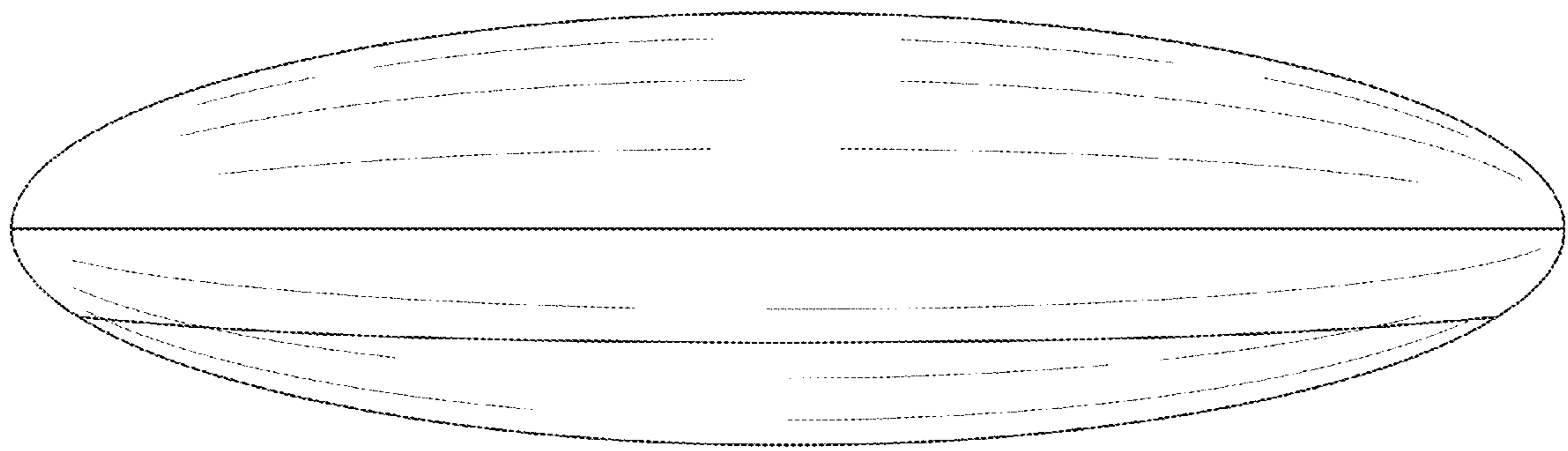

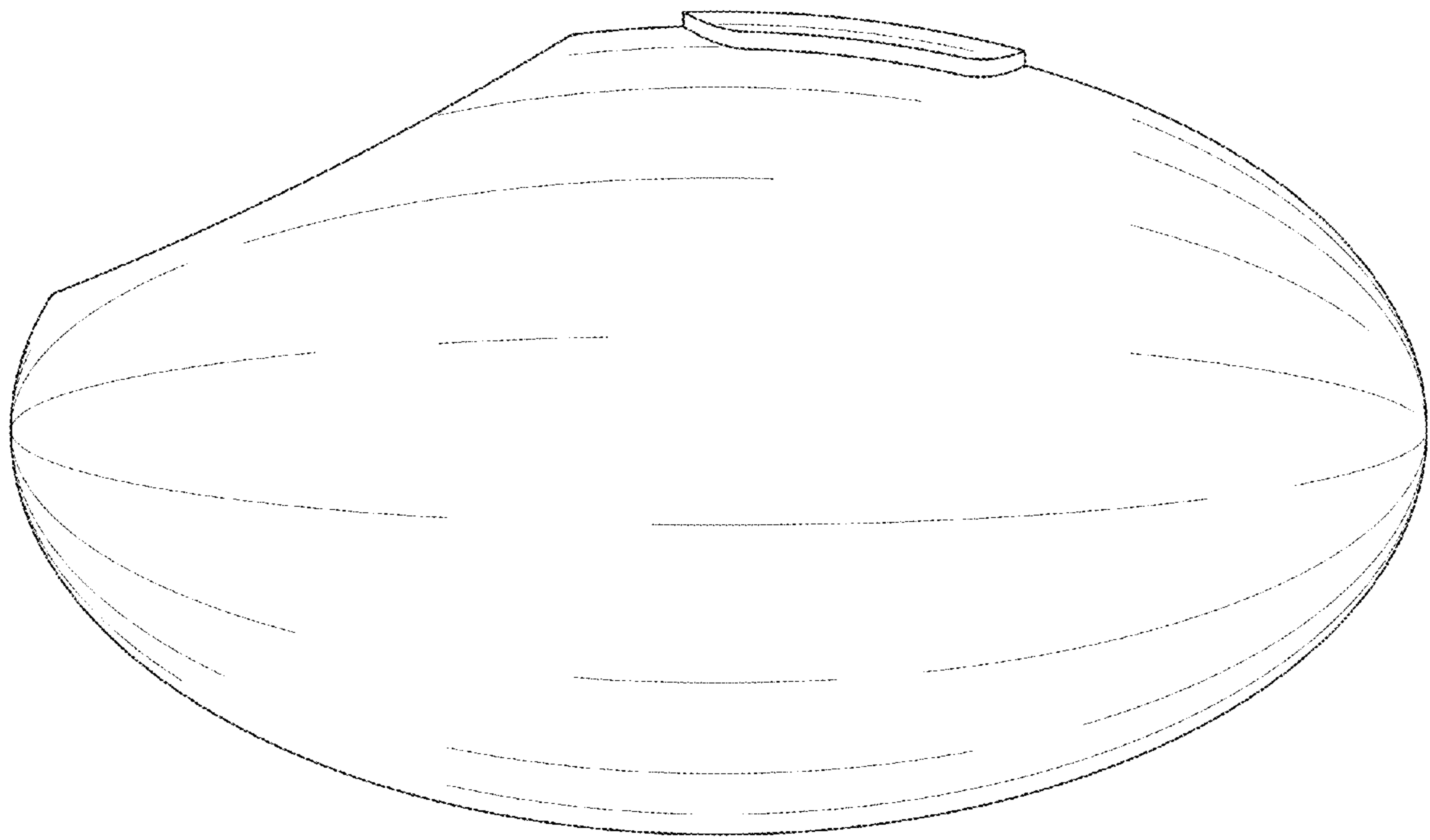

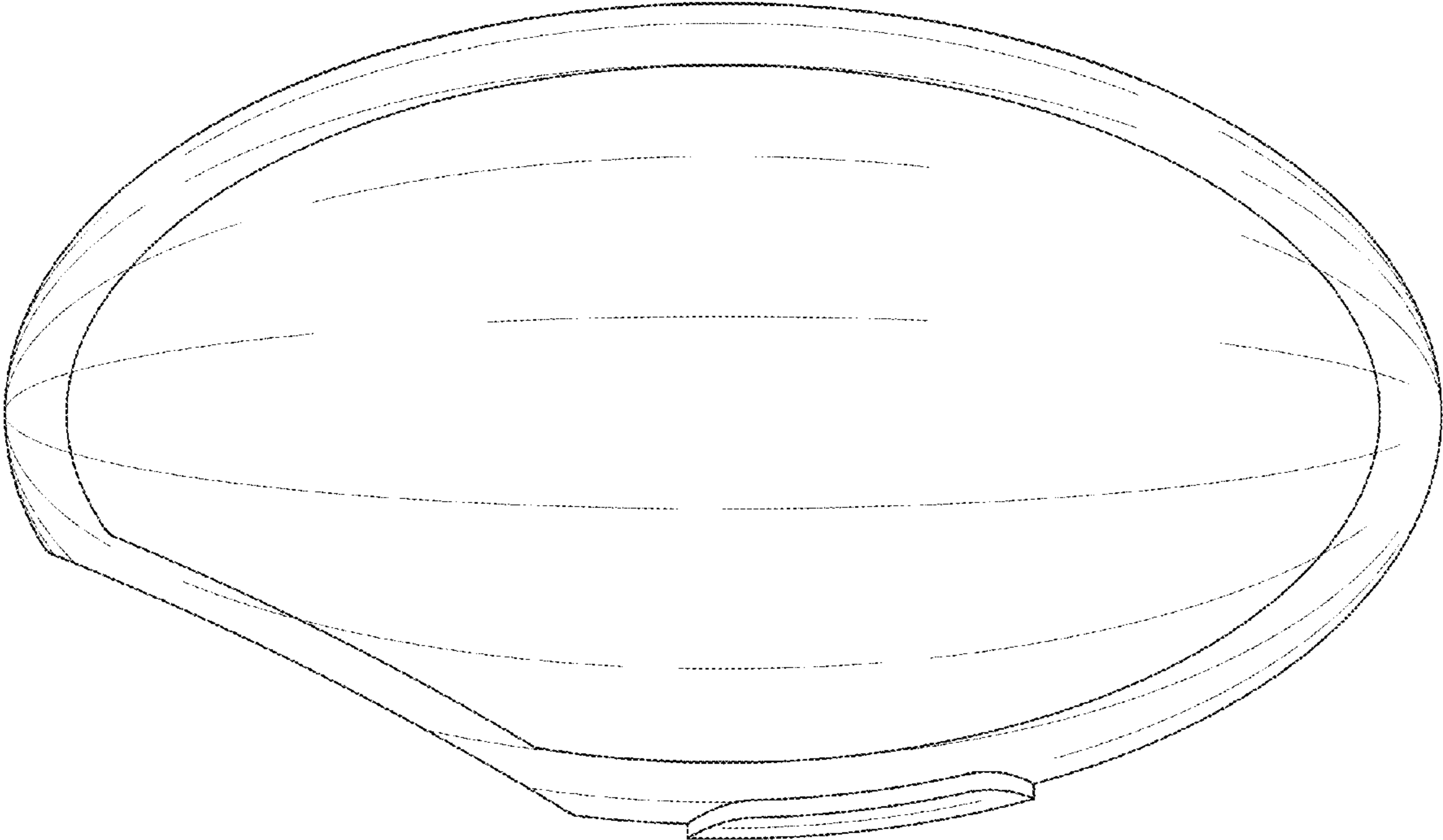

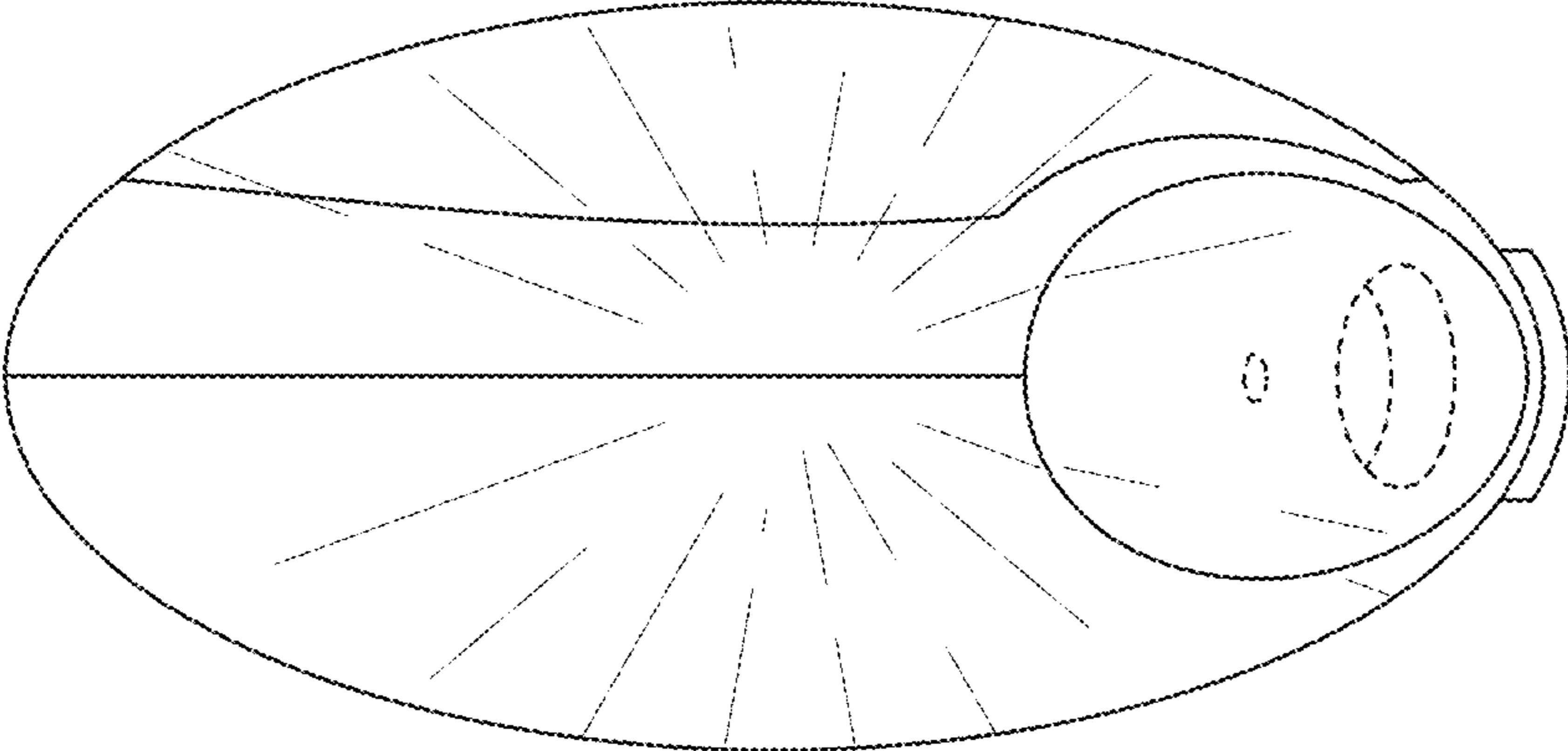

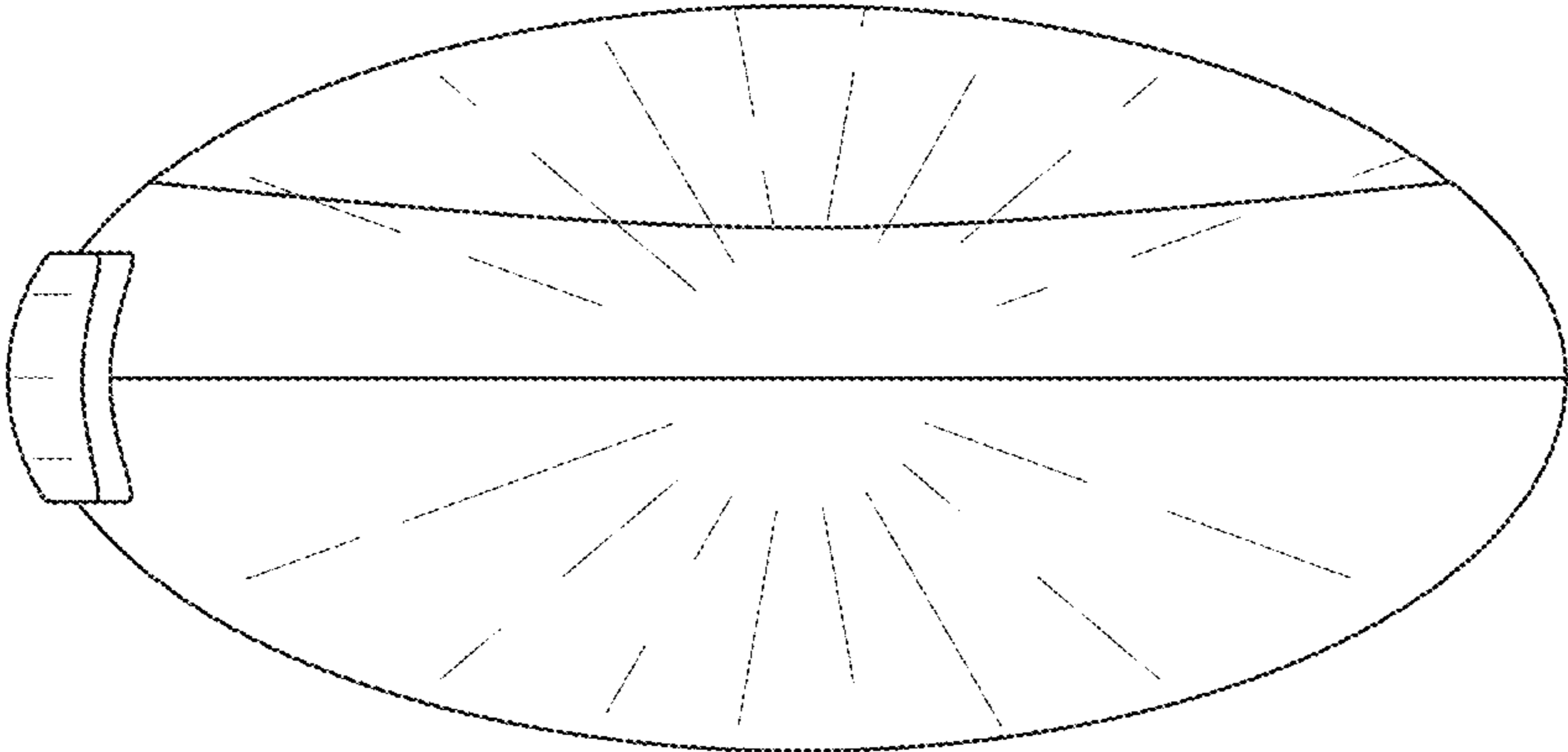

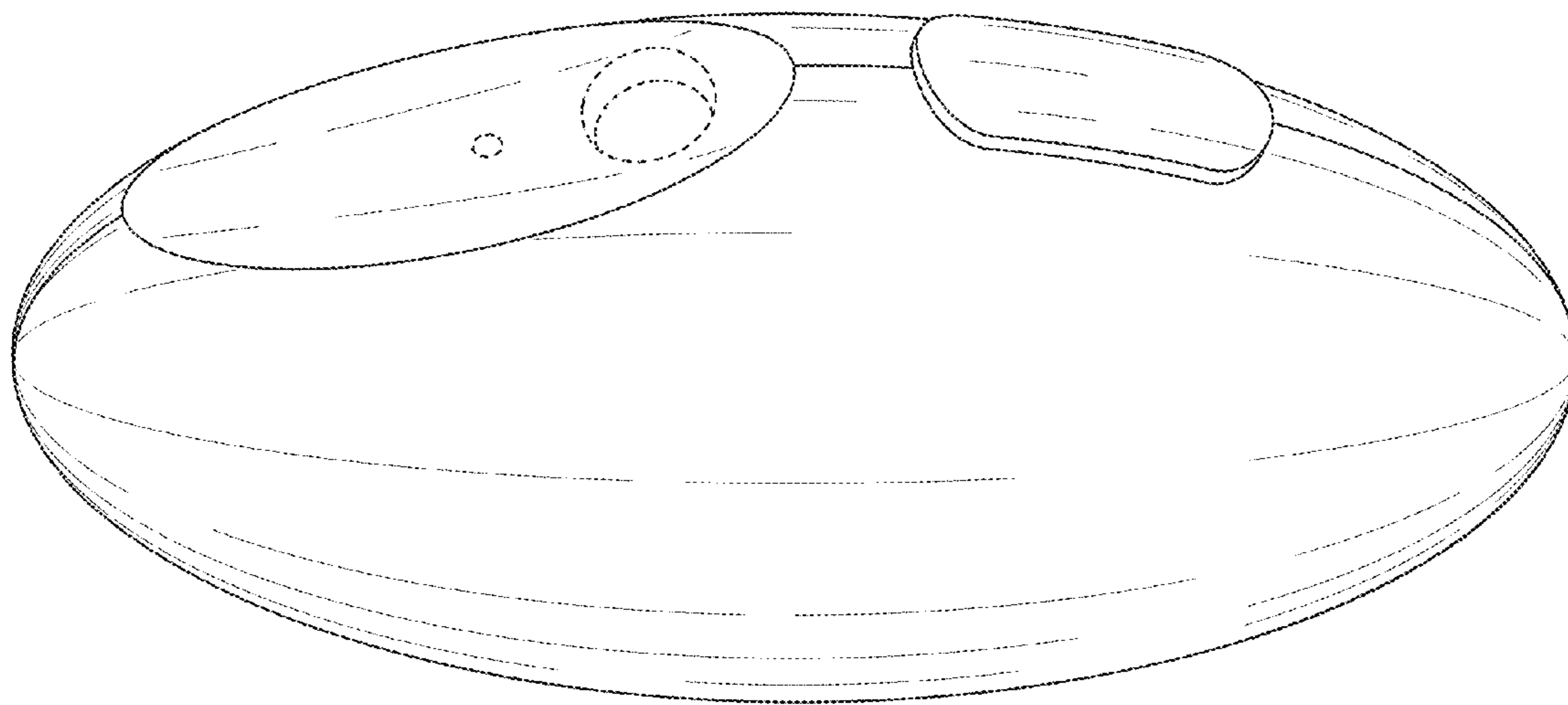

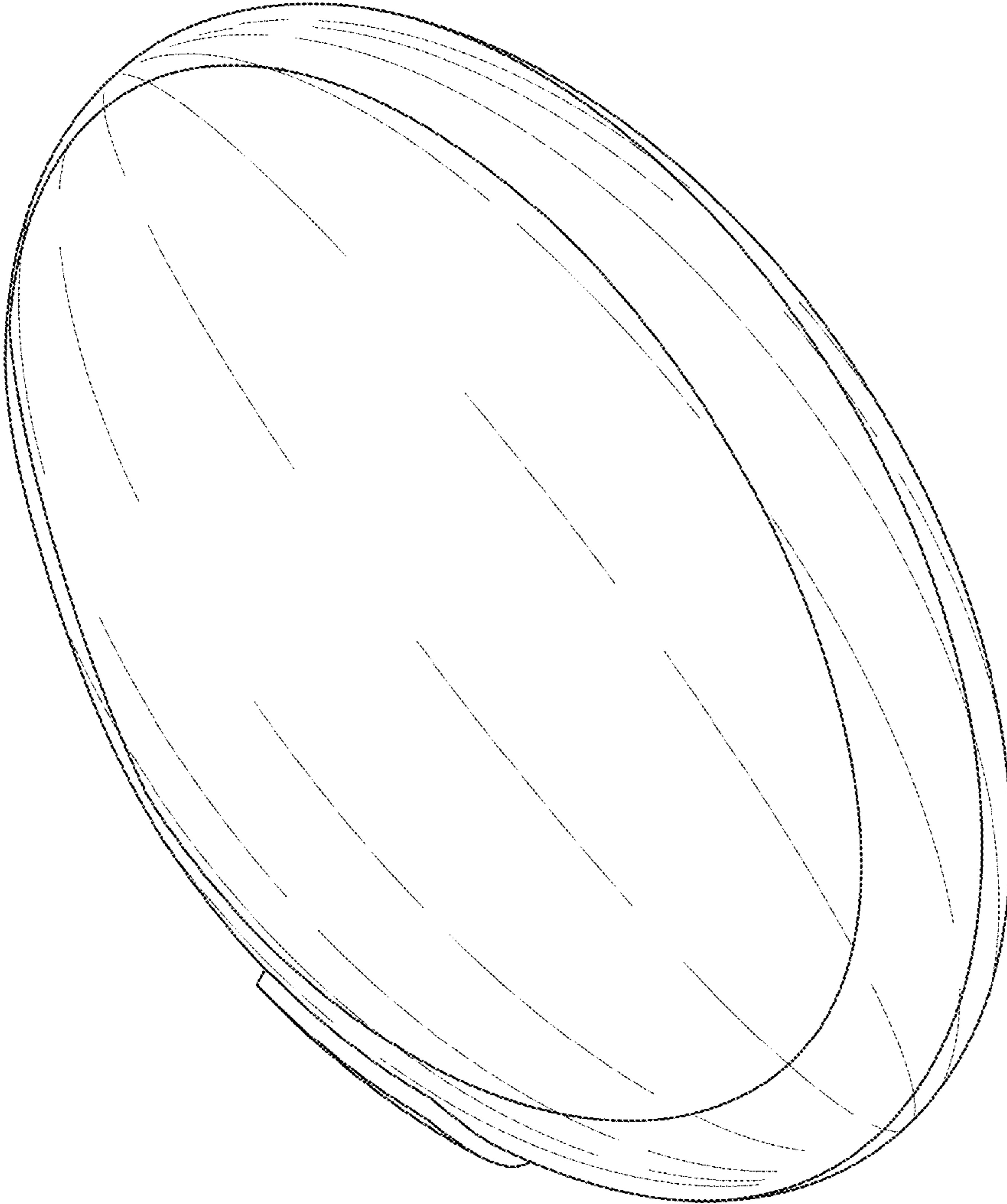
