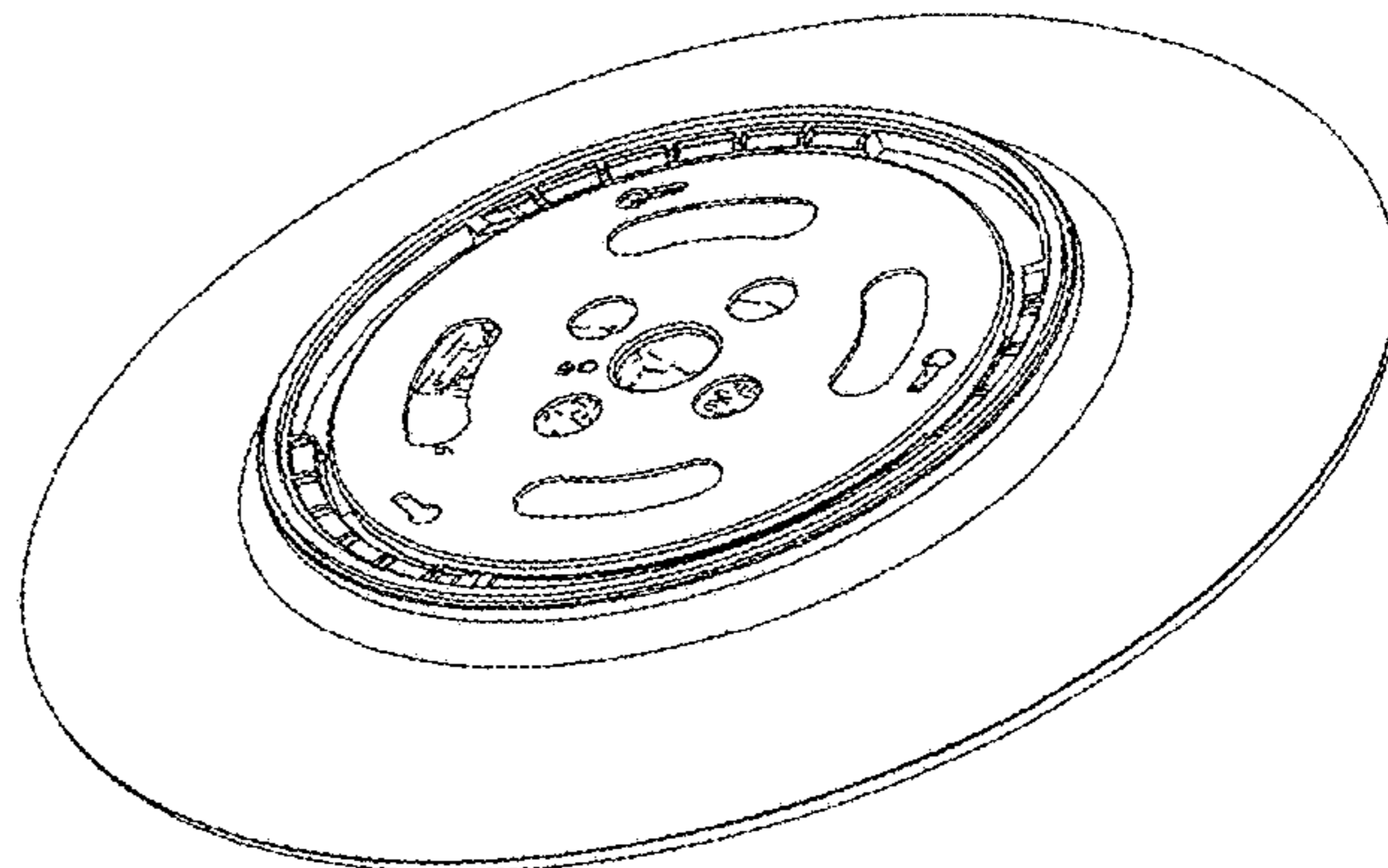
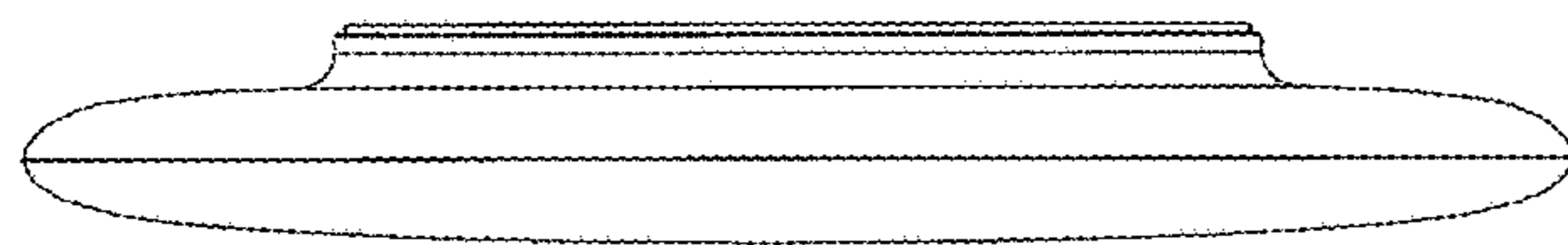
The ornamental design for an LED ceiling light, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the LED ceiling light; FIG. 2 is a rear elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a perspective view projecting toward the rear thereof.

The broken lines illustrate portions of the LED ceiling light that form no part of the claimed design.

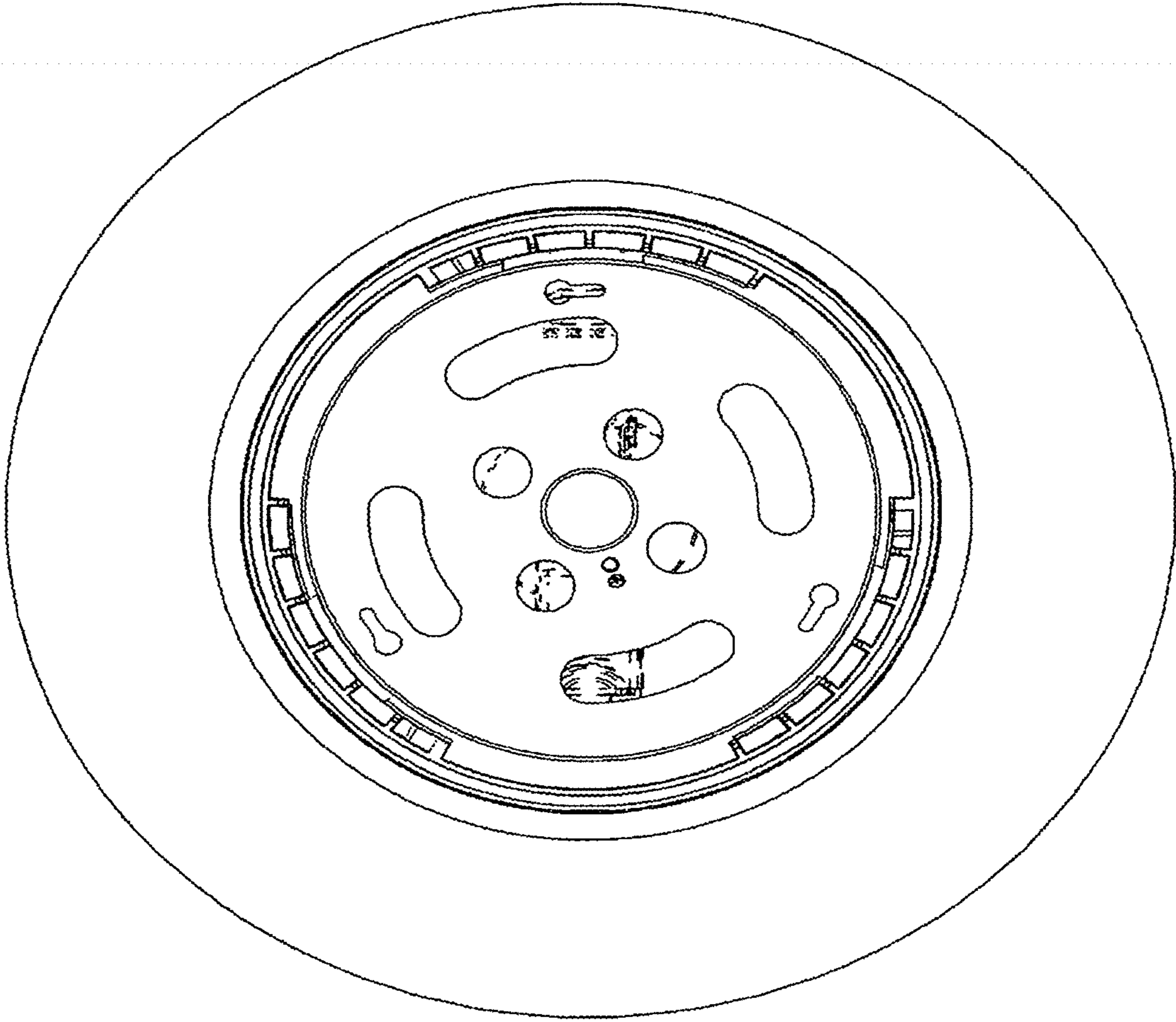

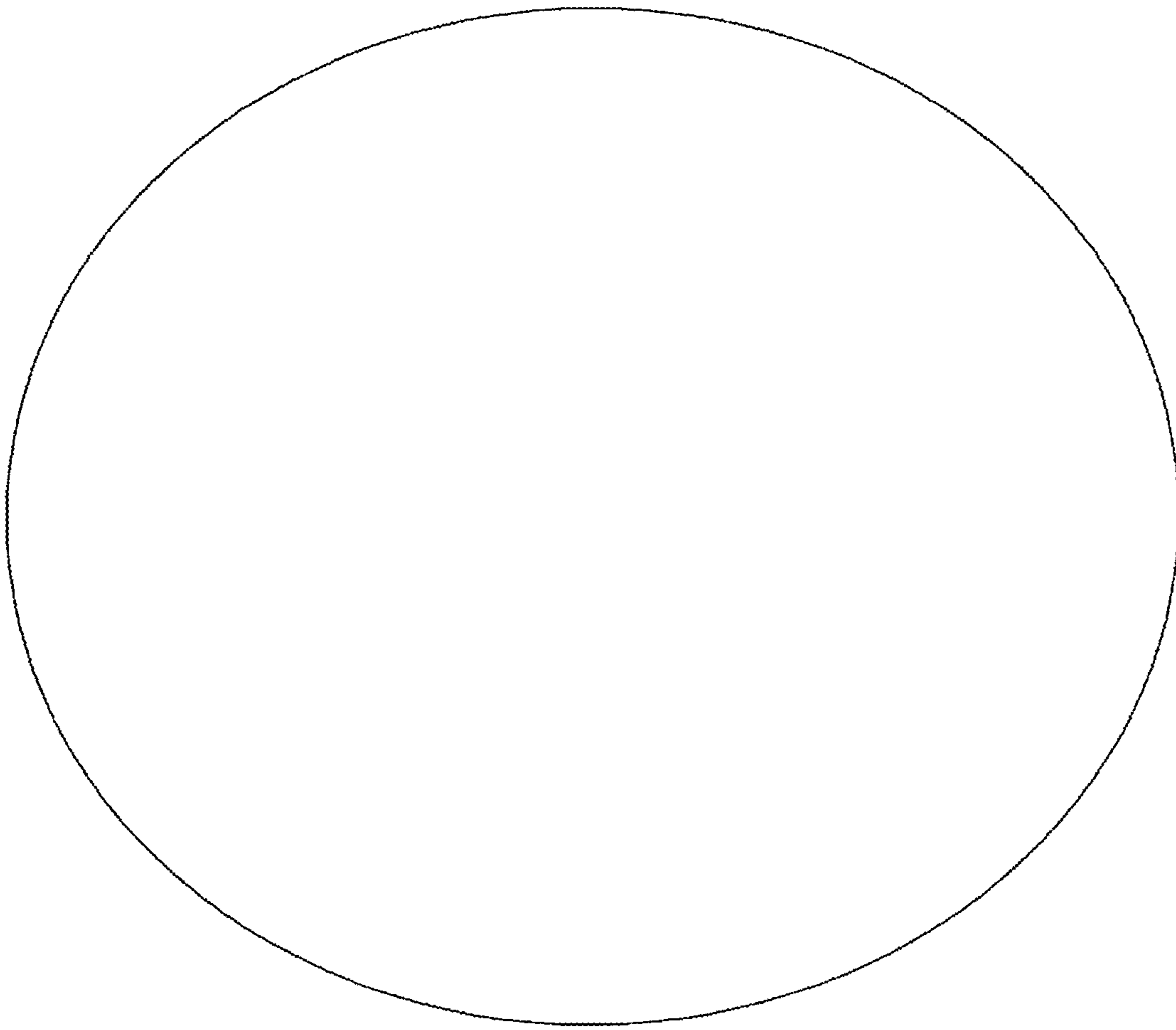

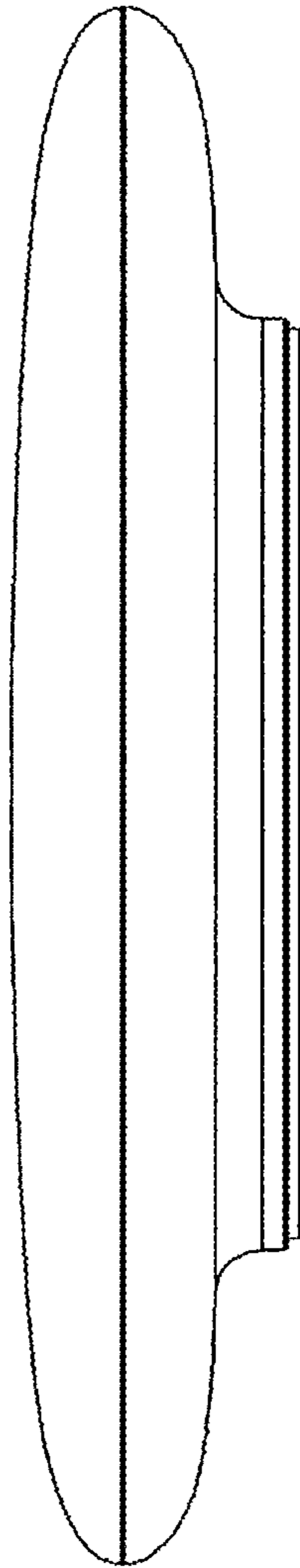

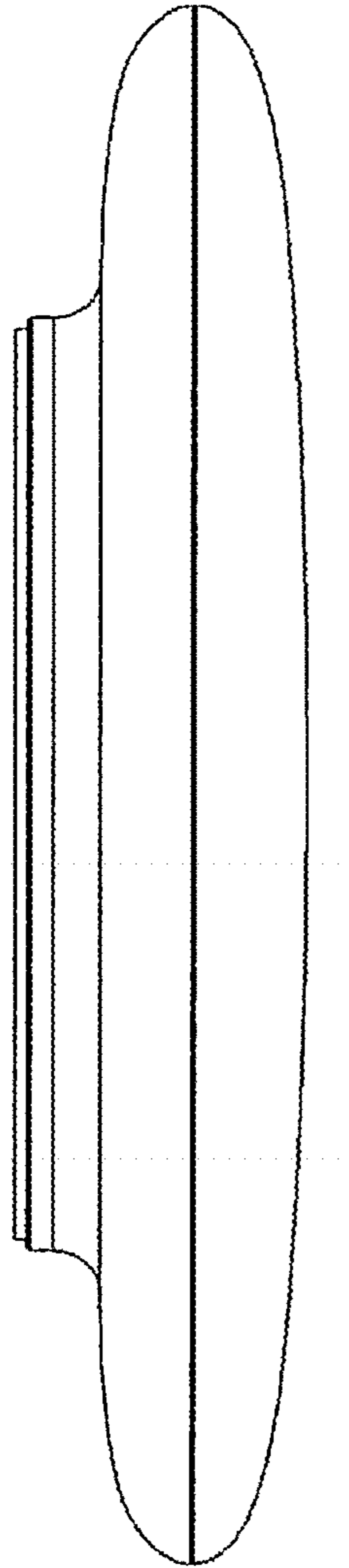

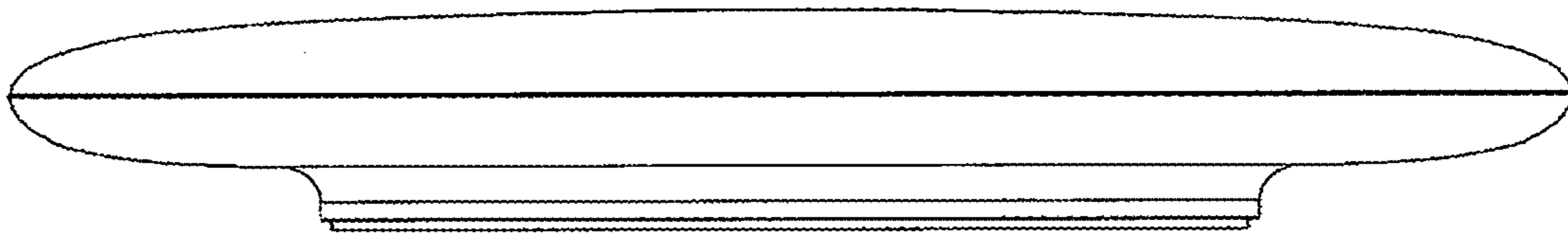

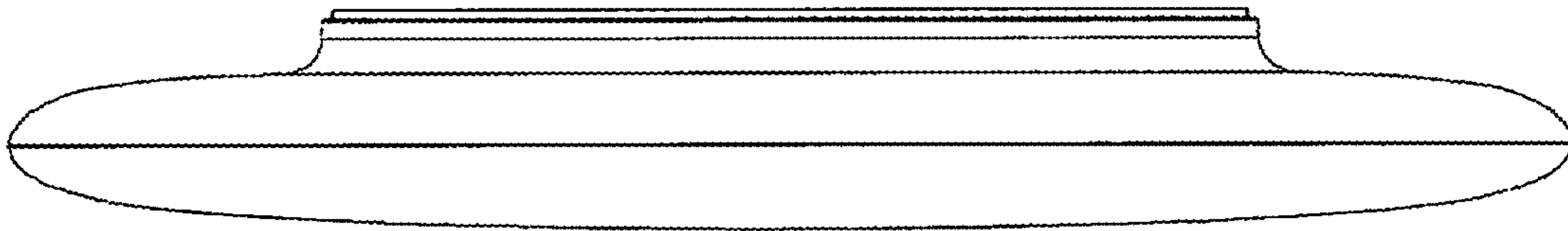

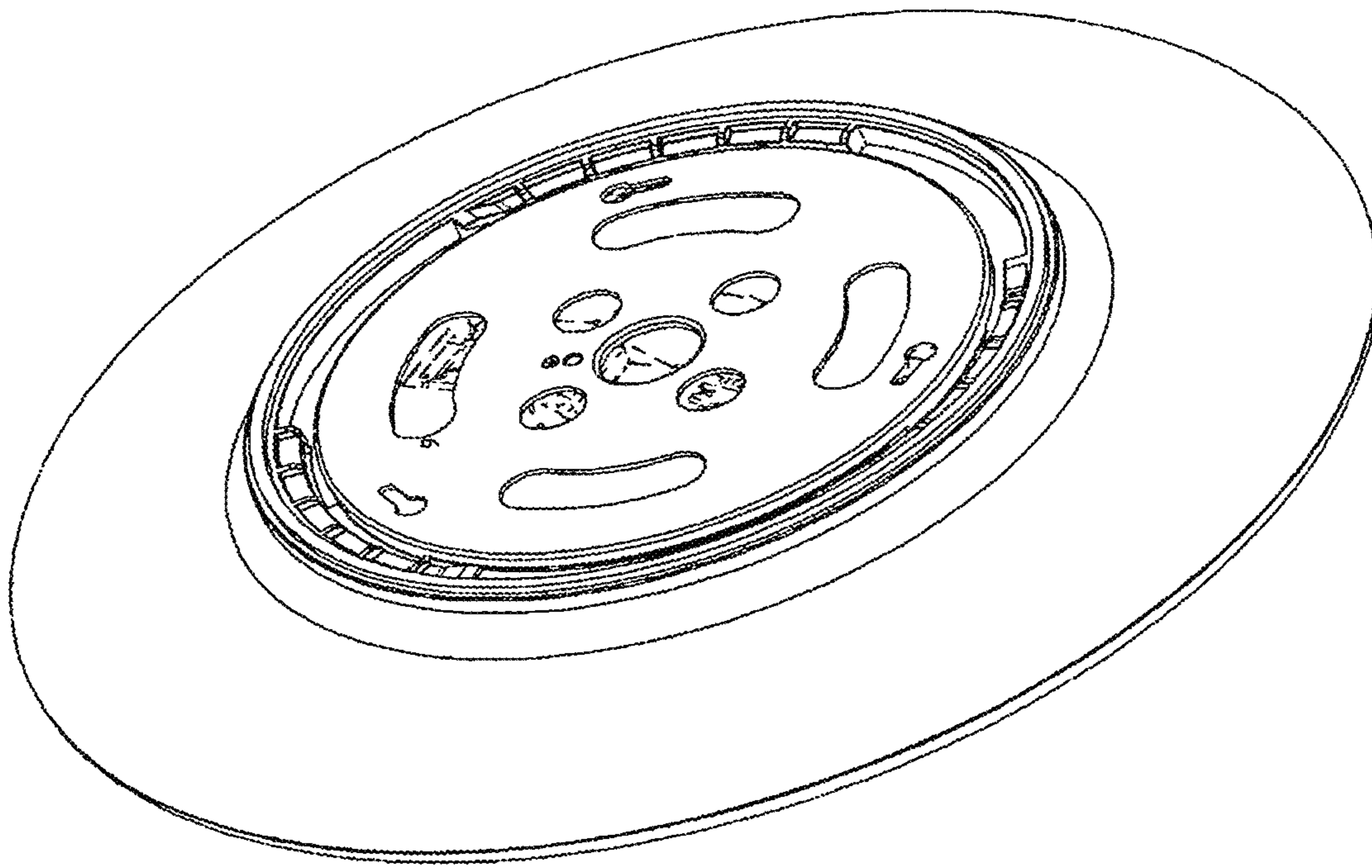
