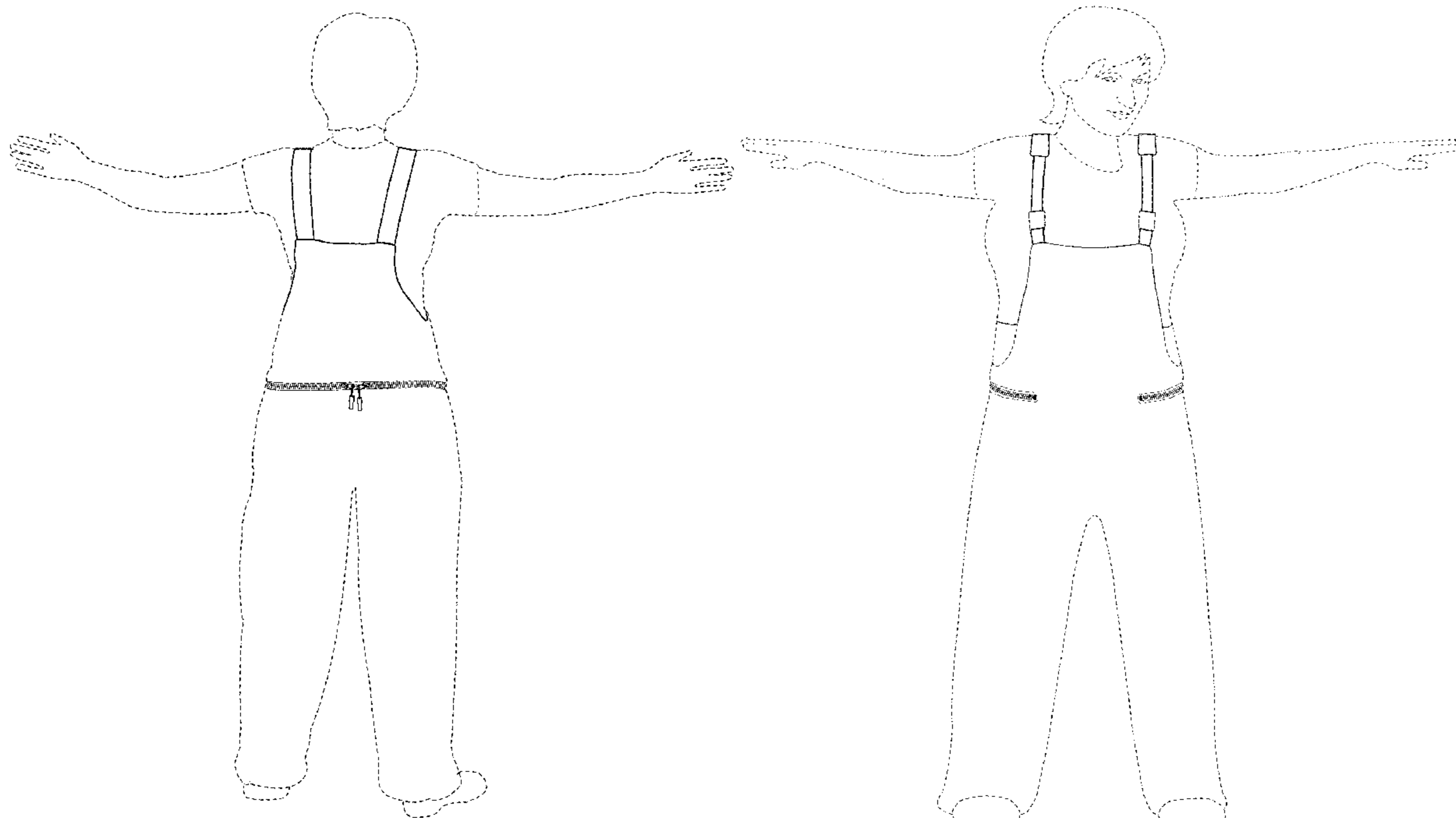
(57) **CLAIM**

I claim the ornamental design for a back accessible garment, as shown and described.

DESCRIPTION

FIG. 1 is a back perspective view of a back accessible garment, with the back access in the closed position.
 FIG. 2 is a right side elevation view thereof.
 FIG. 3 is a back side elevation view thereof.
 FIG. 4 is a front side elevation view thereof.
 FIG. 5 is a back side elevation view thereof, in a partially open configuration.
 FIG. 6 is a close-up view of the material encircled in FIG. 5, after the zipper is in a fully open configuration.
 FIG. 7 is a front side elevation view, in a fully open configuration.
 FIG. 8 is a right side elevation view thereof; and,
 FIG. 9 is a right side elevation view, in a squatting configuration.
 The broken lines form no part of the claimed design. The human arms, feet, head and undershirt depict environment and form no part of the claimed design.

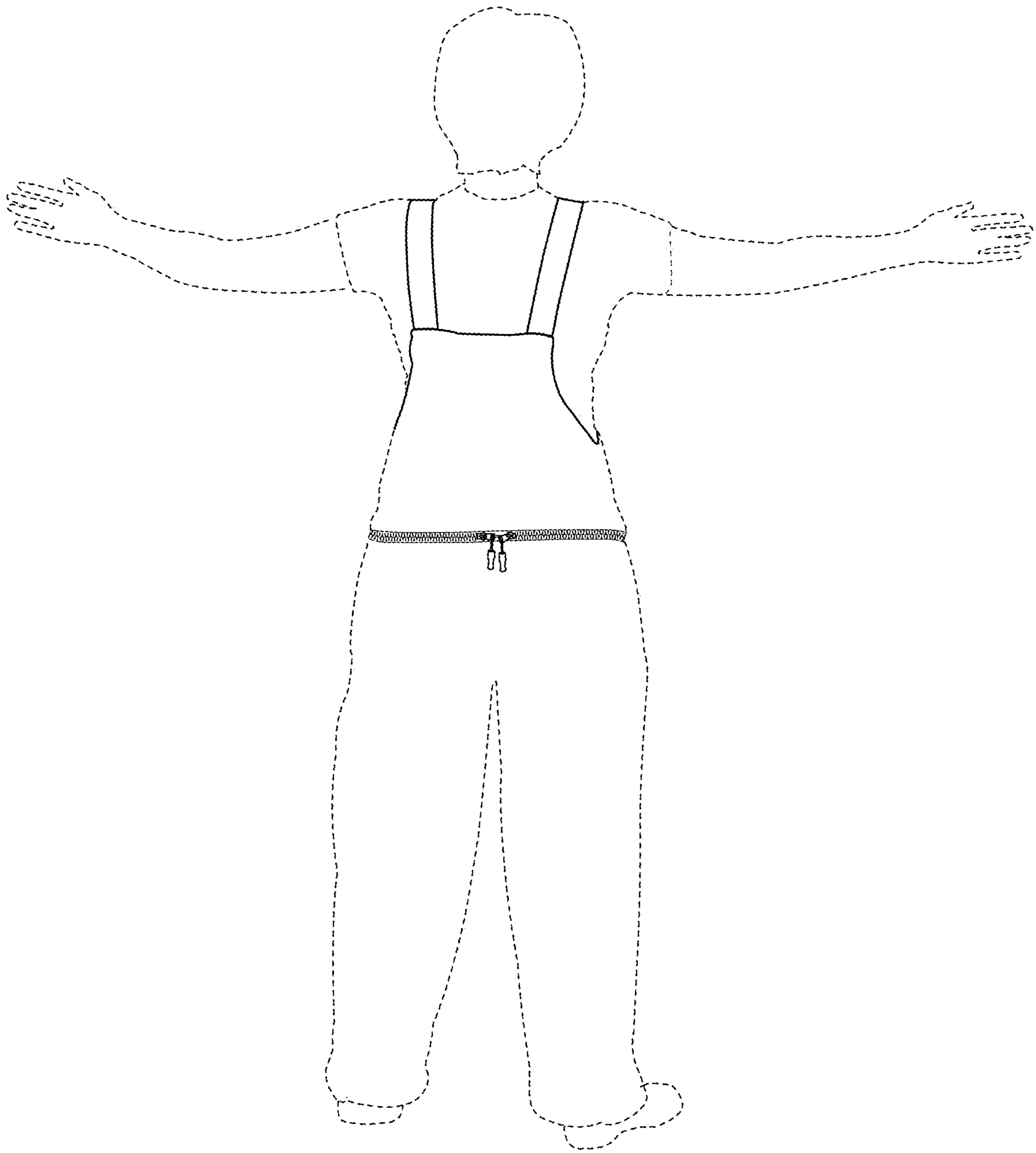

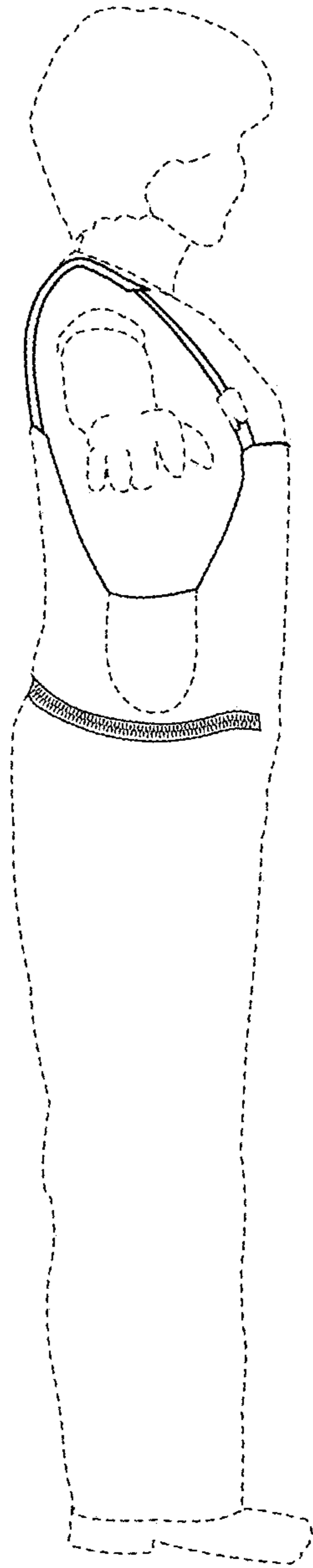

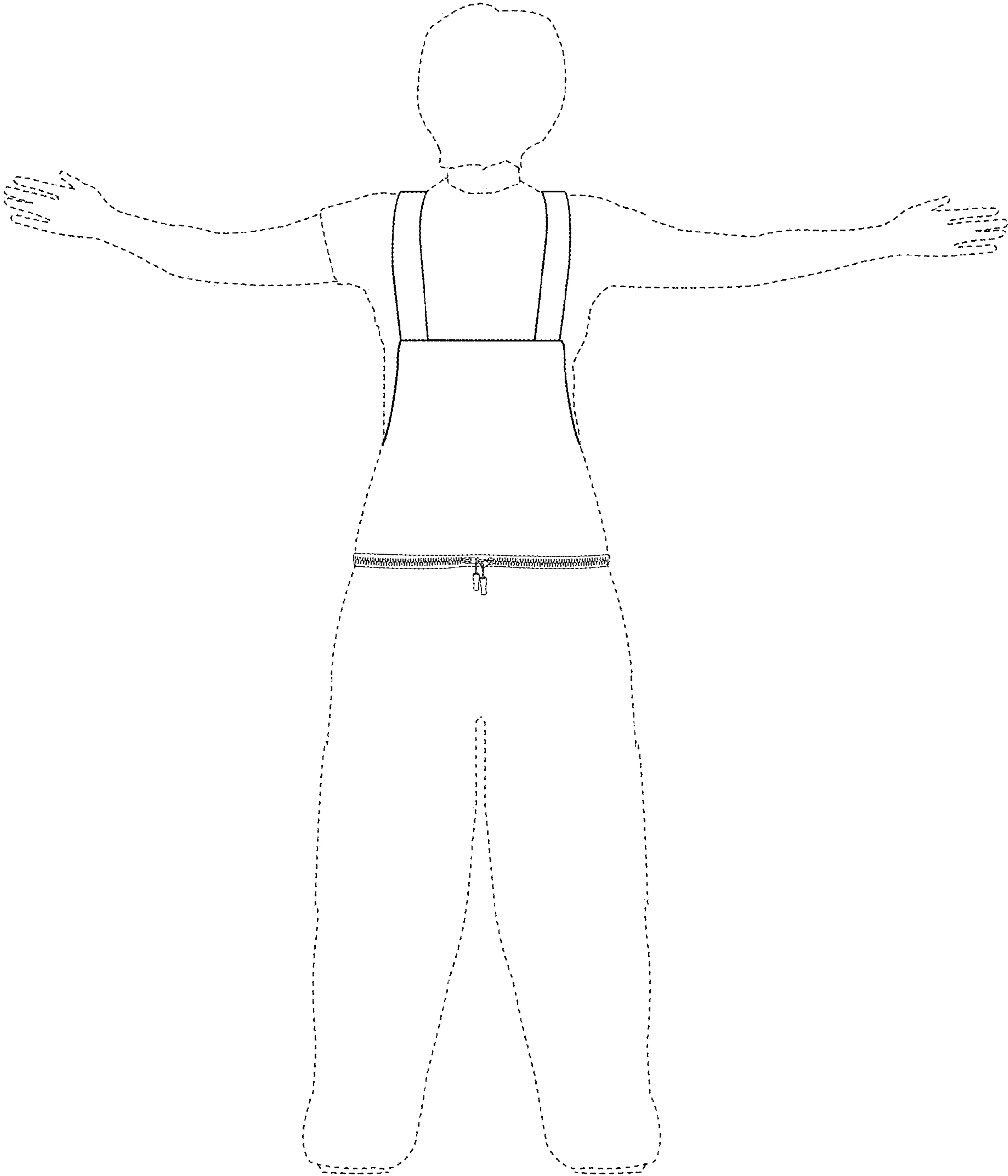

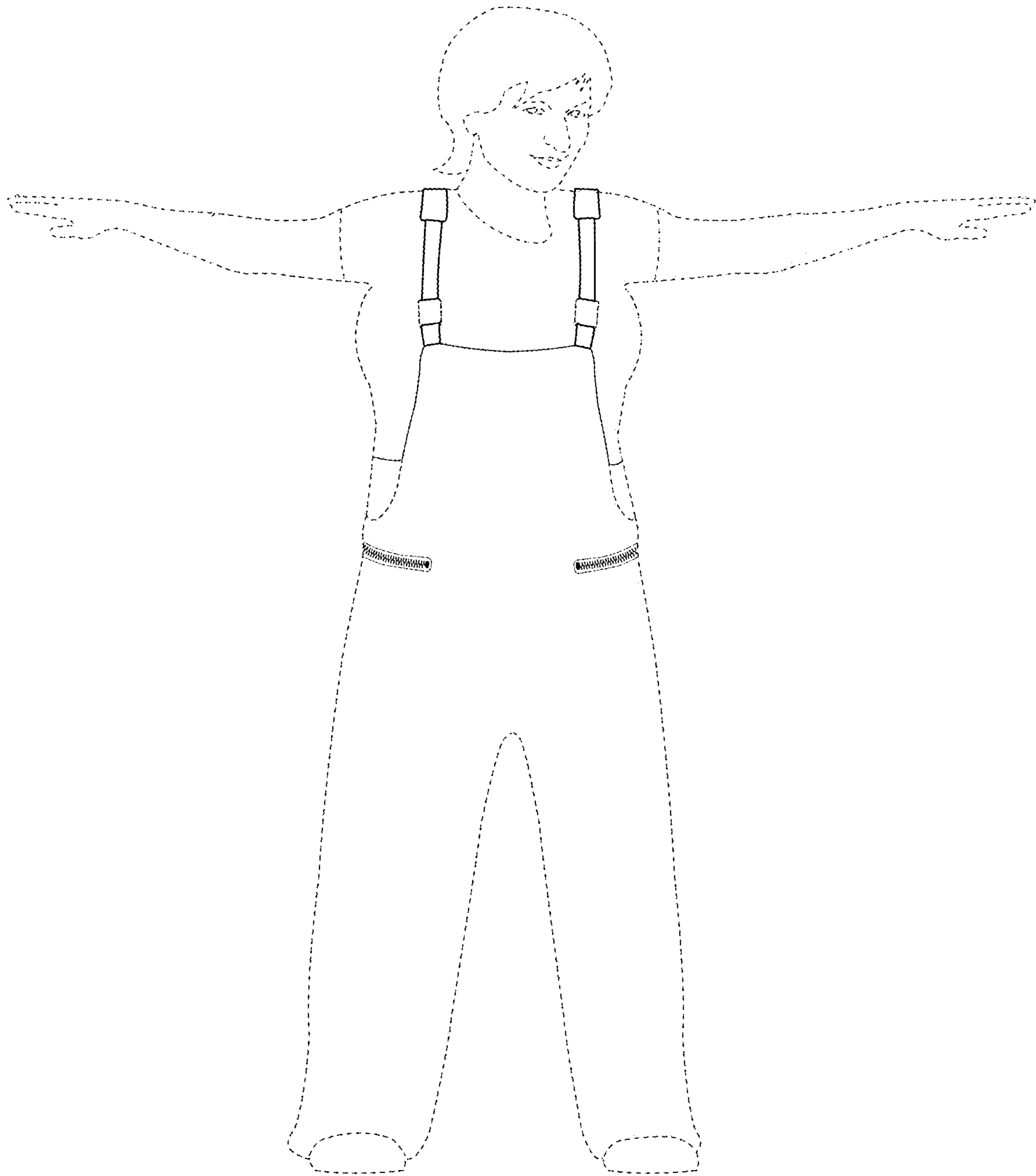

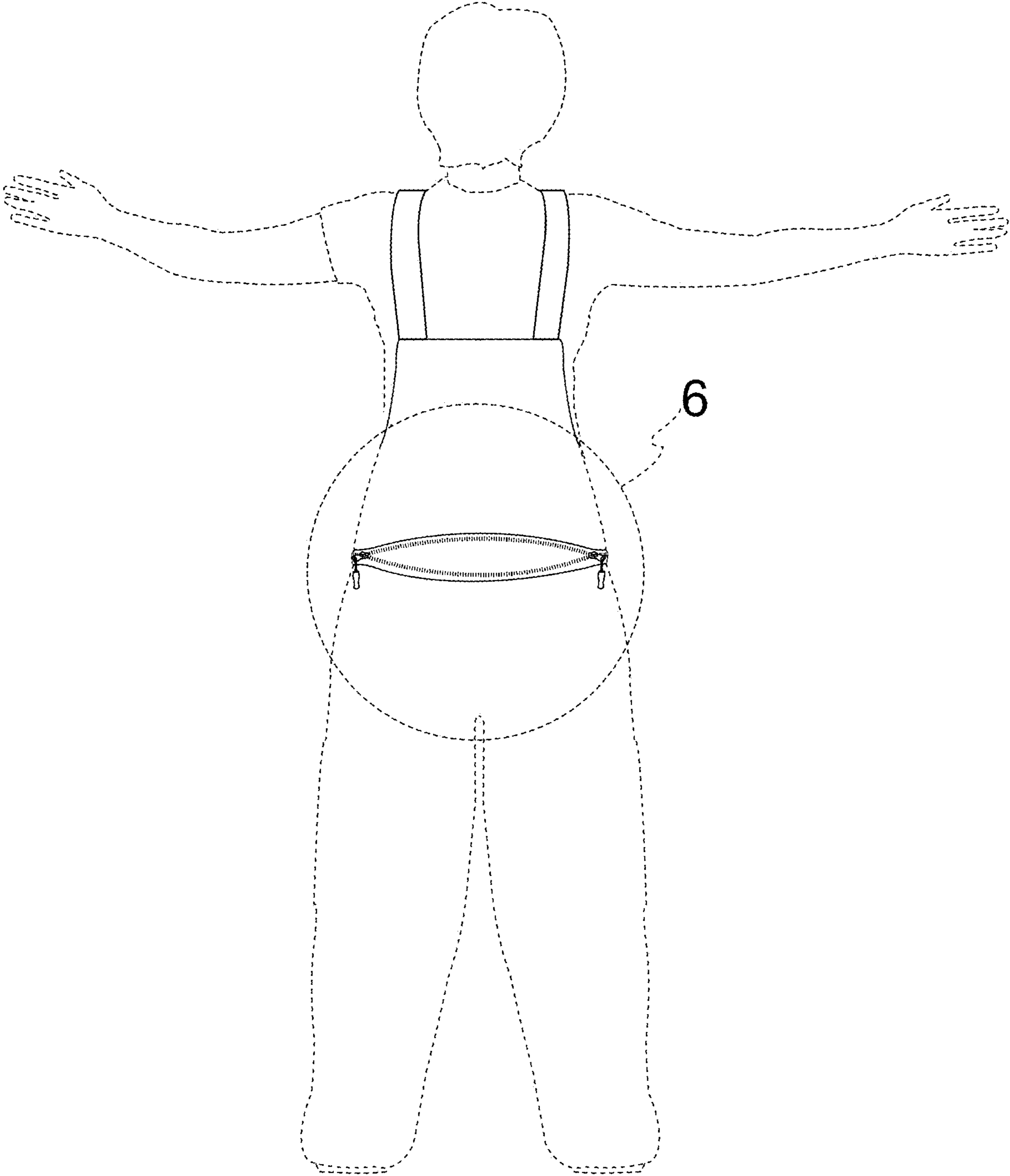

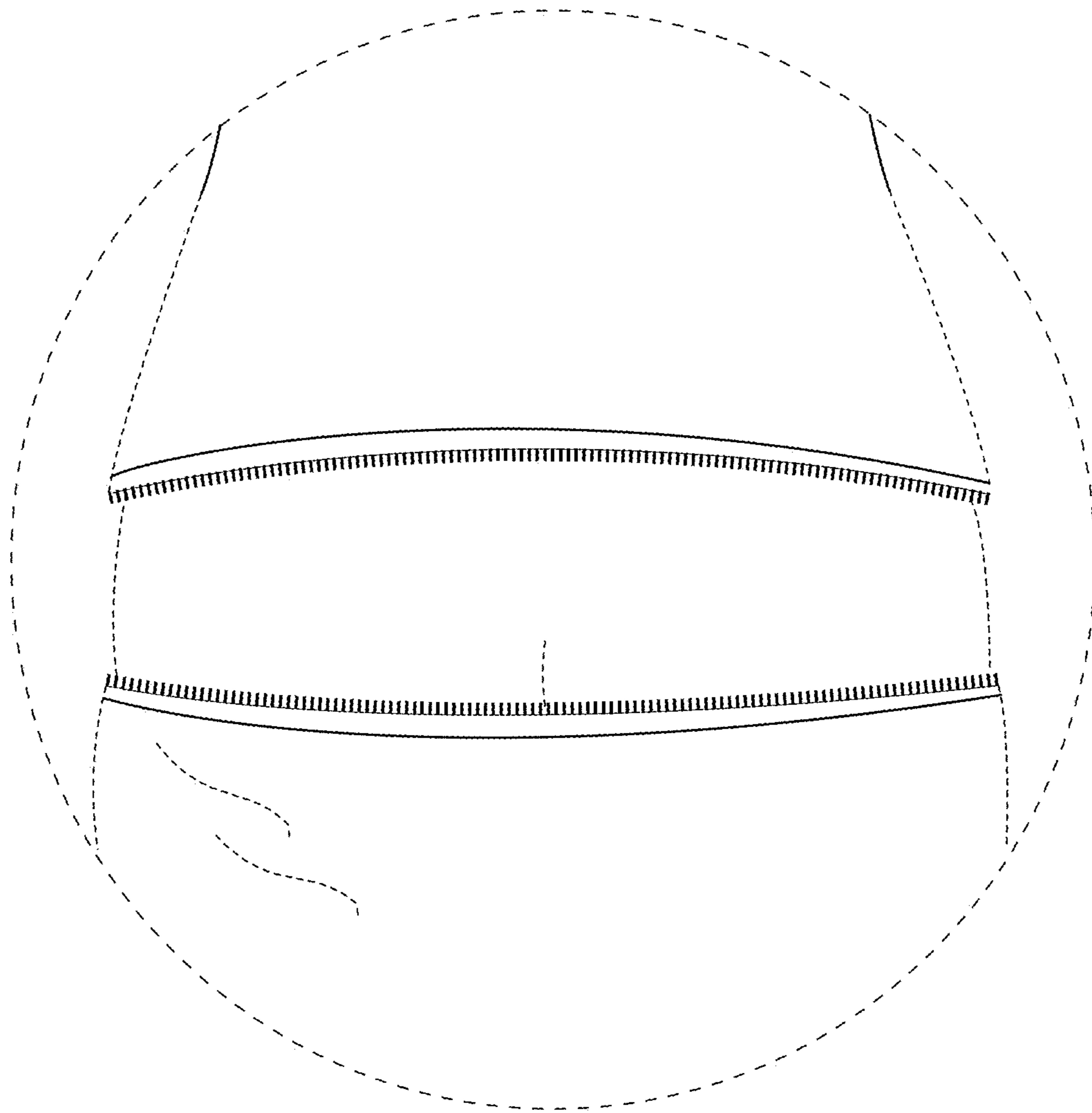

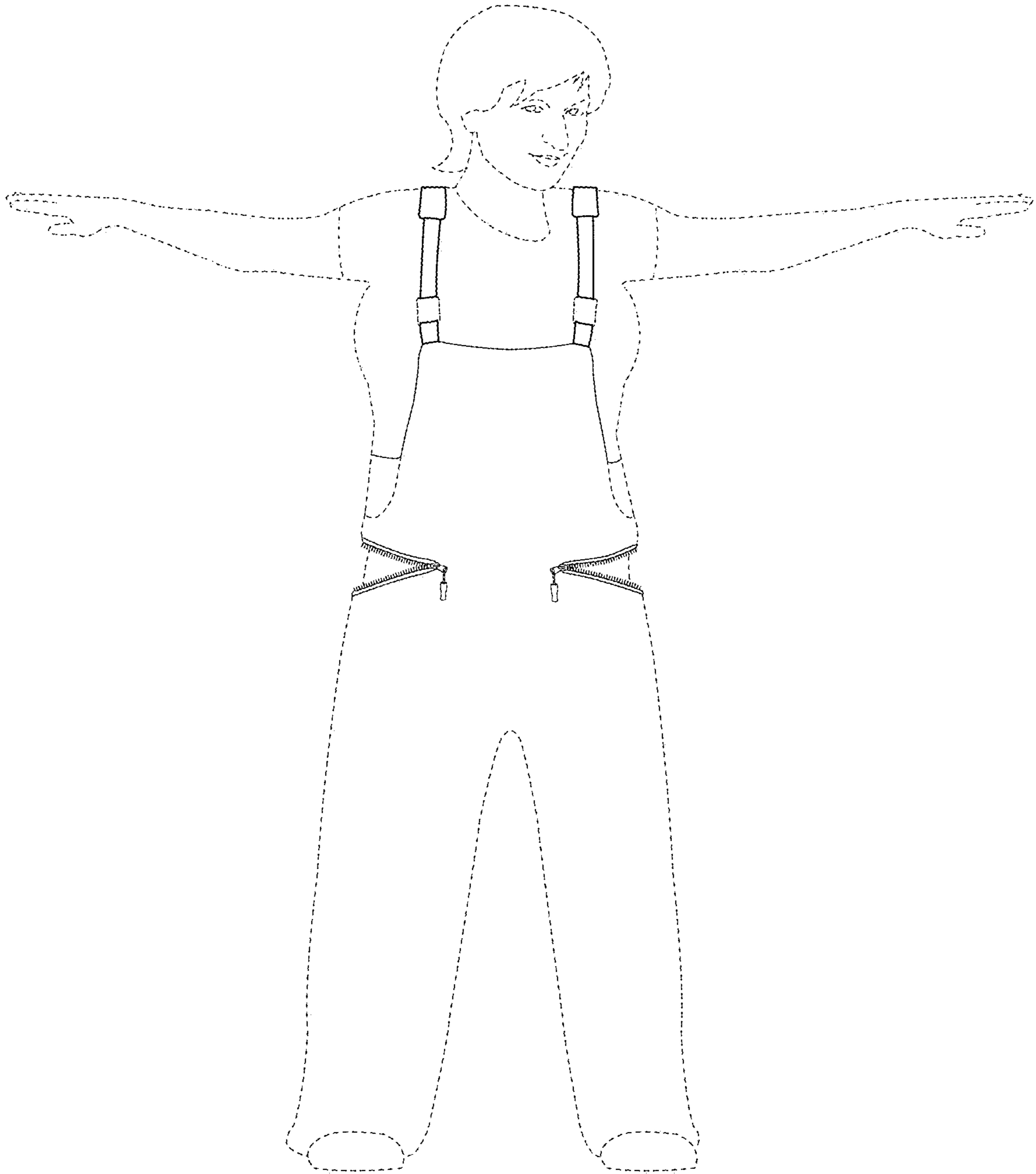

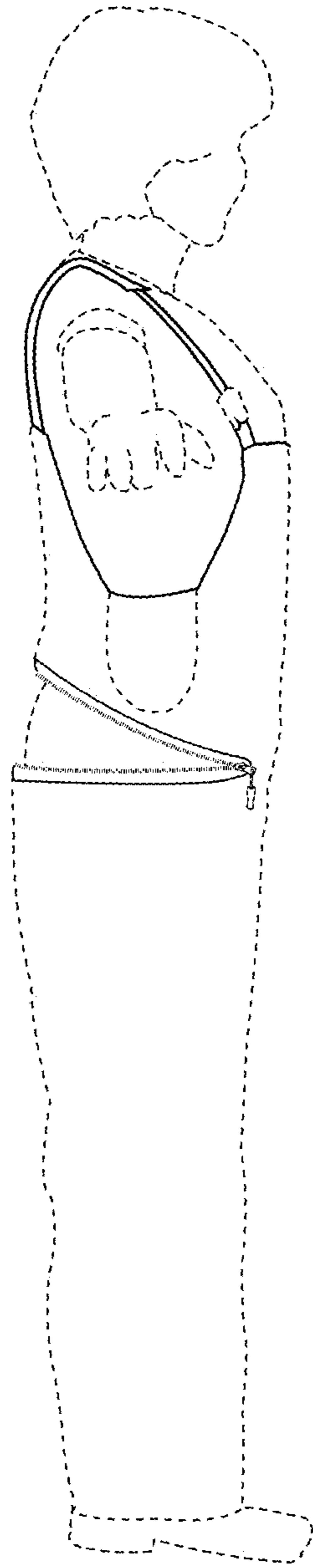

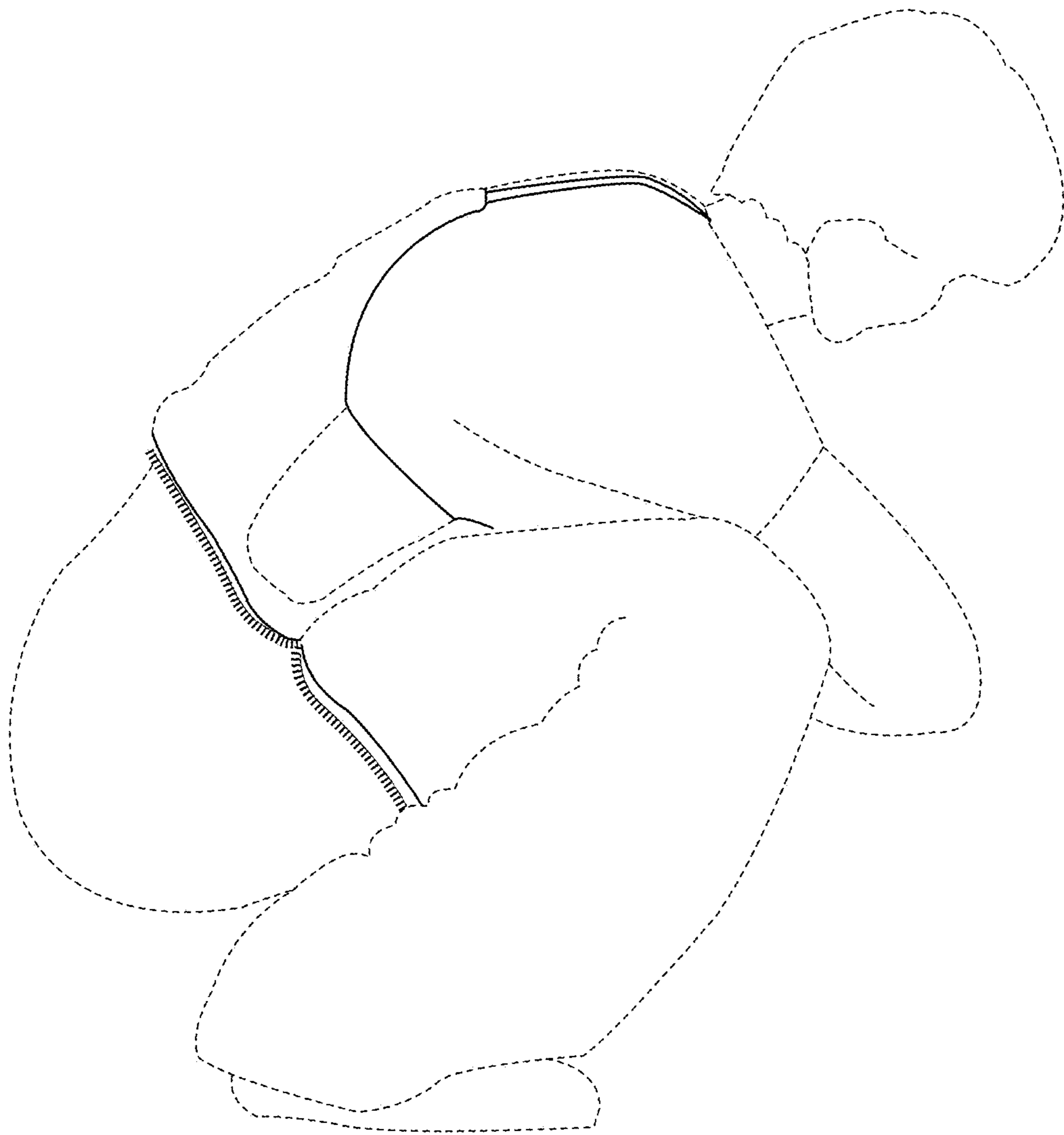
