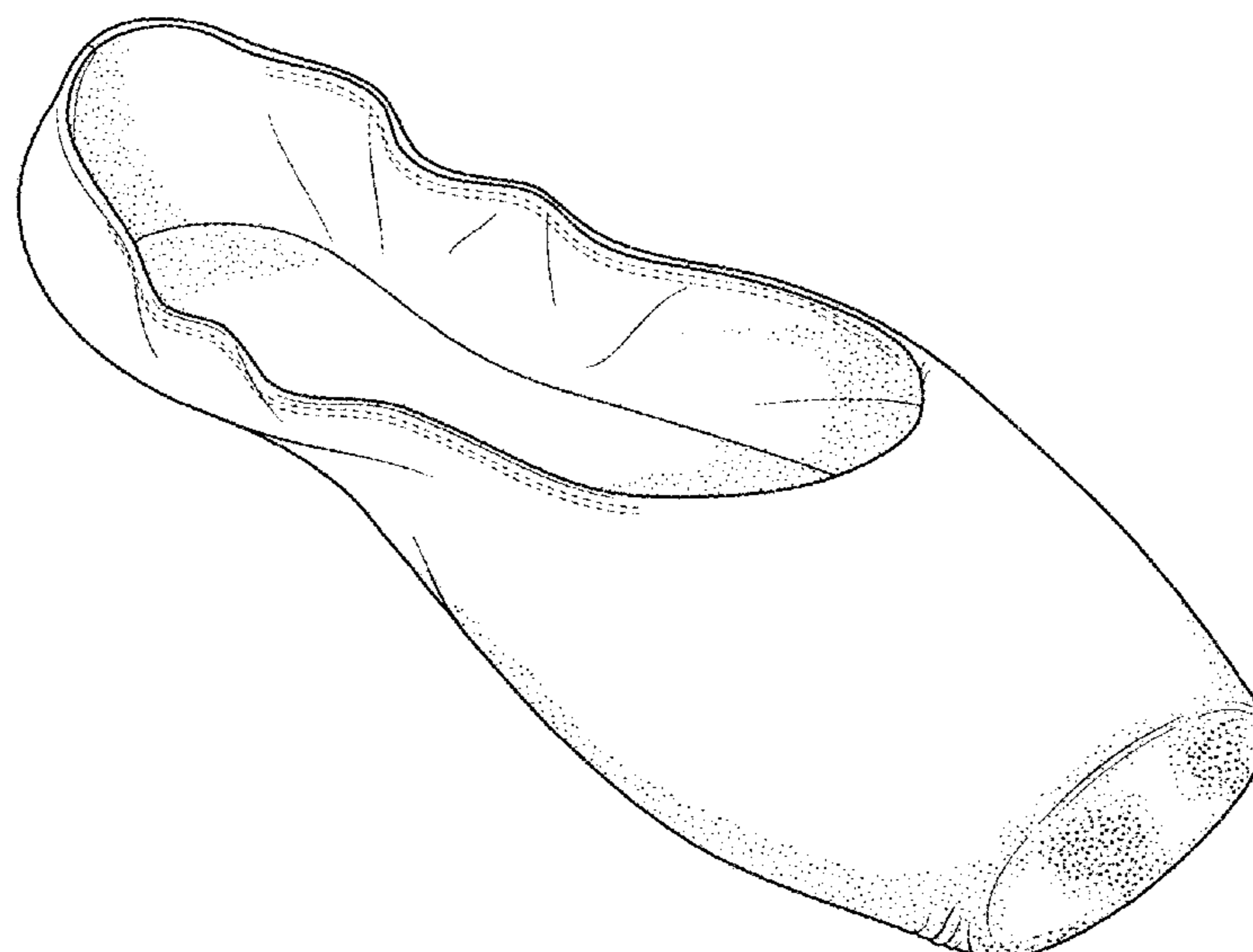
(57) **CLAIM**

The ornamental design for a ballet pointe shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front-right perspective view of a ballet pointe shoe showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a front-right perspective view of the ballet pointe shoe shown in a condition of use;
FIG. 9 is a front elevation view thereof shown in a condition of use;
FIG. 10 is a rear elevation view thereof shown in a condition of use;
FIG. 11 is a right side elevation view thereof shown in a condition of use;
FIG. 12 is a left side elevation view thereof shown in a condition of use;
FIG. 13 is a top plan view thereof shown in a condition of use; and,
FIG. 14 is a bottom plan view thereof shown in a condition of use.
The broken line of alternating long and short lines showing the foot is for the purpose of illustrating environment and forms no part of the claimed design. The dashed lines represent stitching which is part of the claimed design.

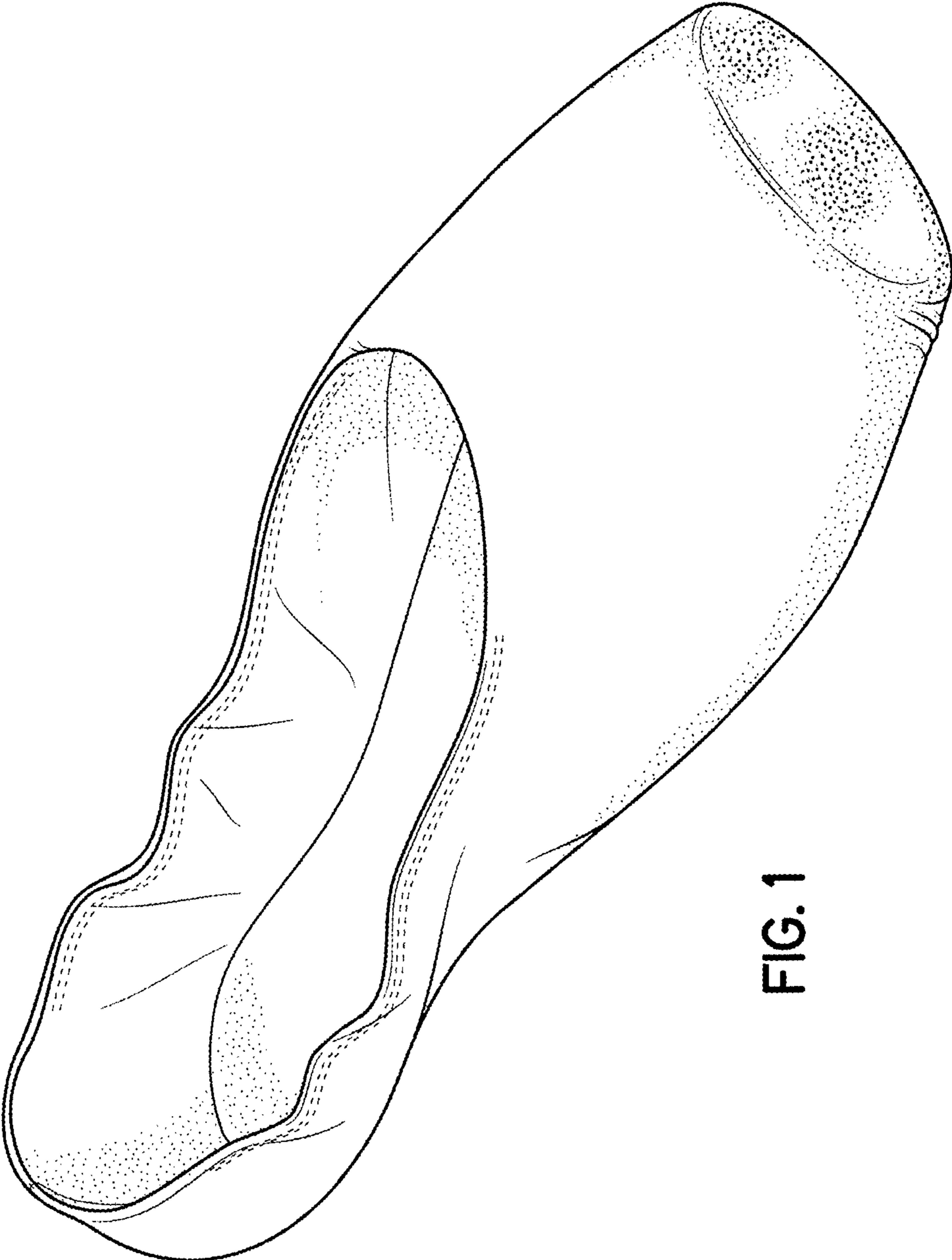

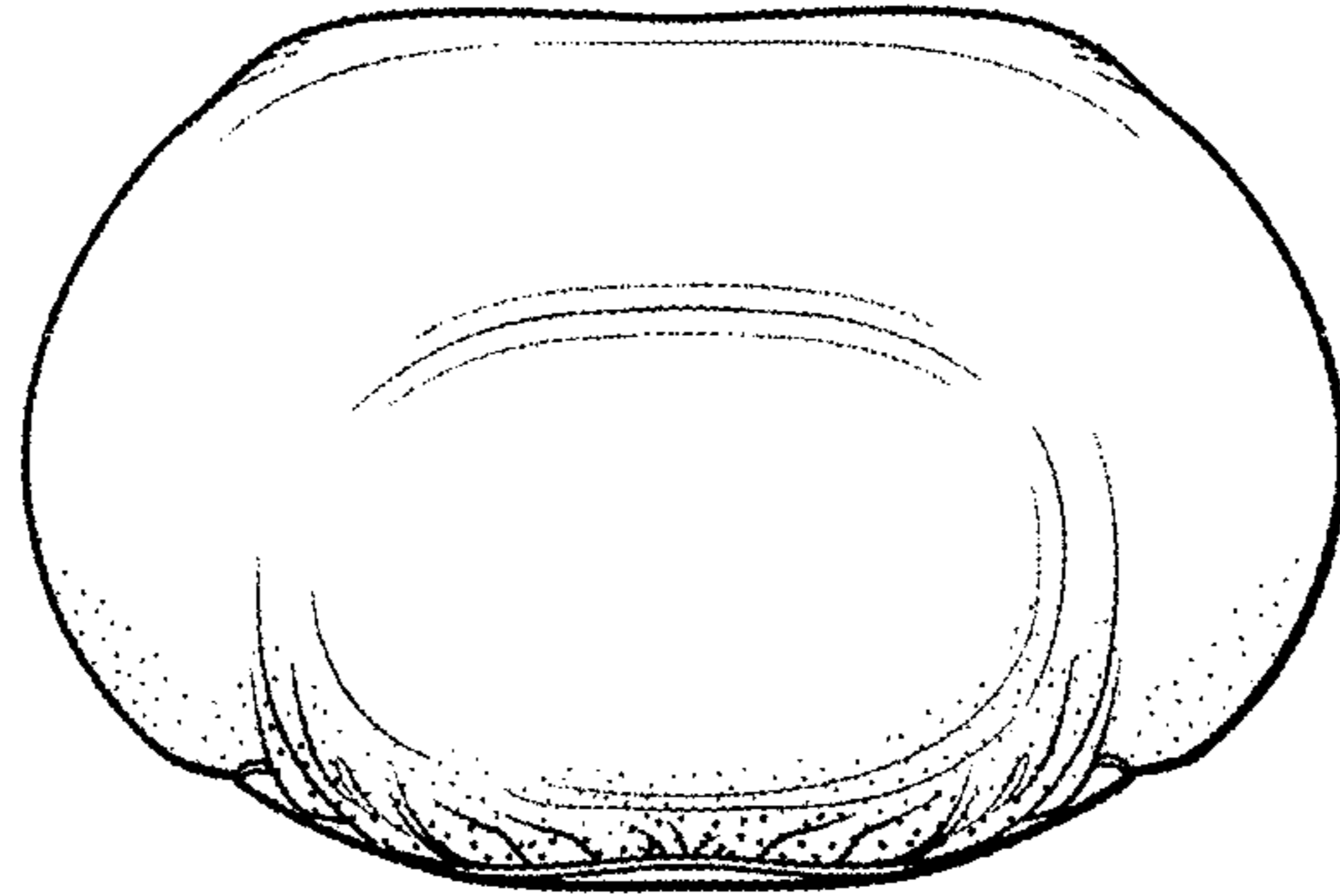

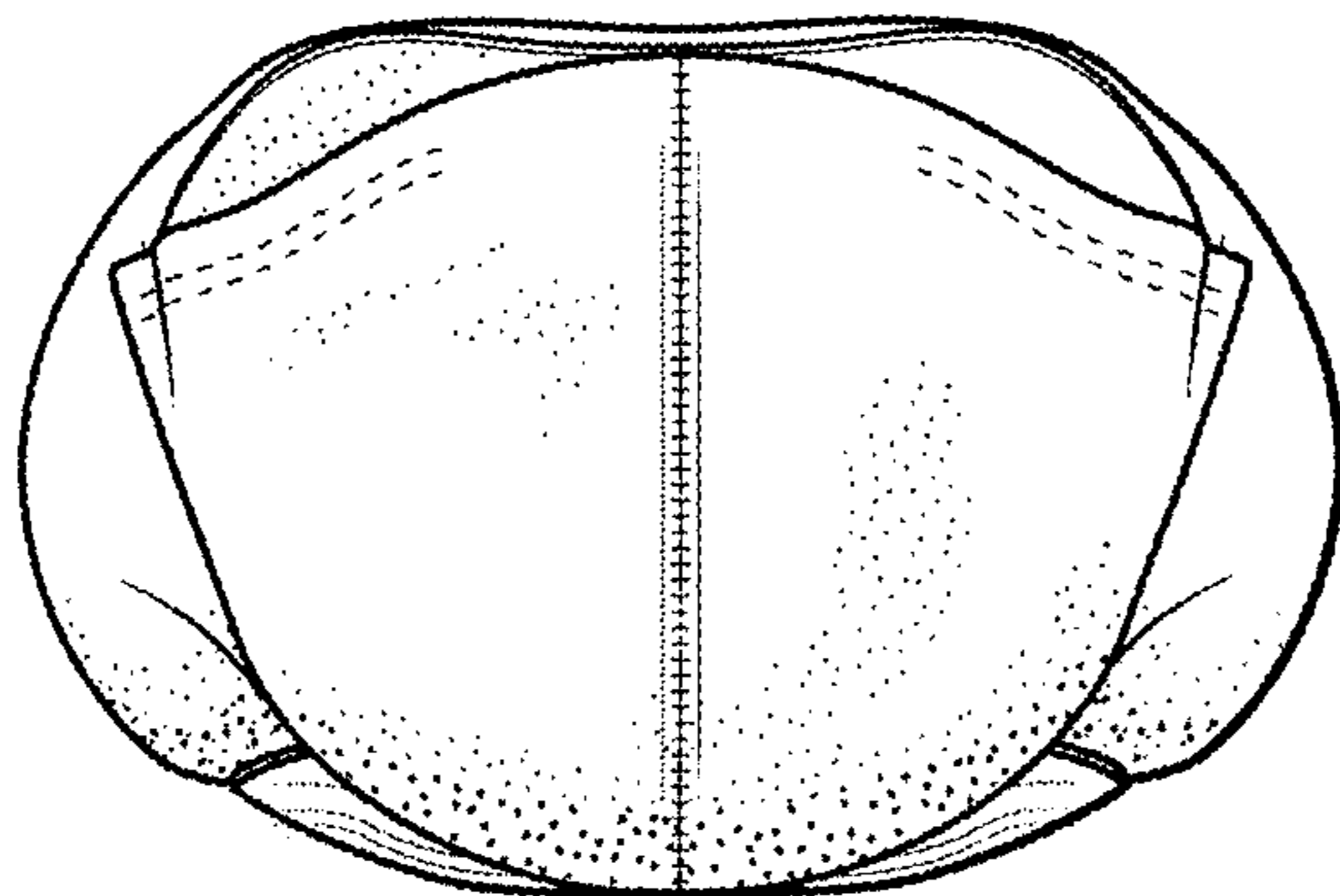

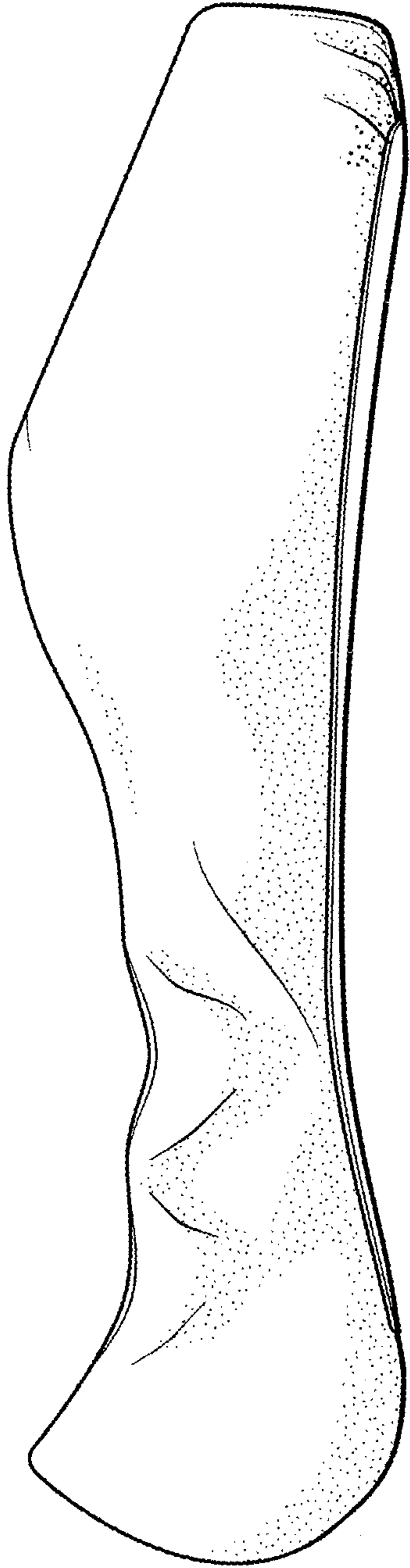

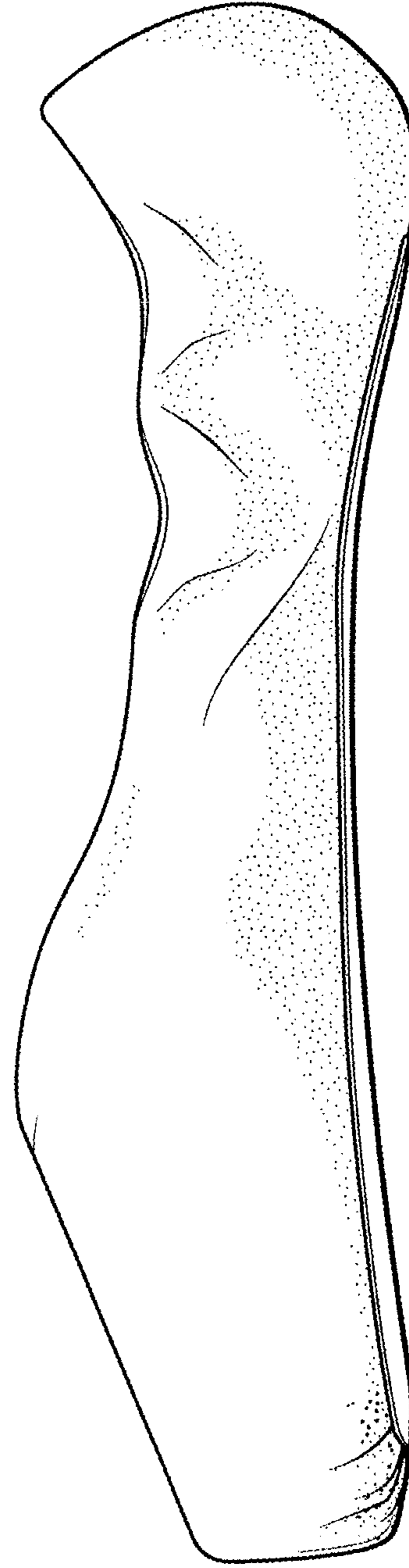

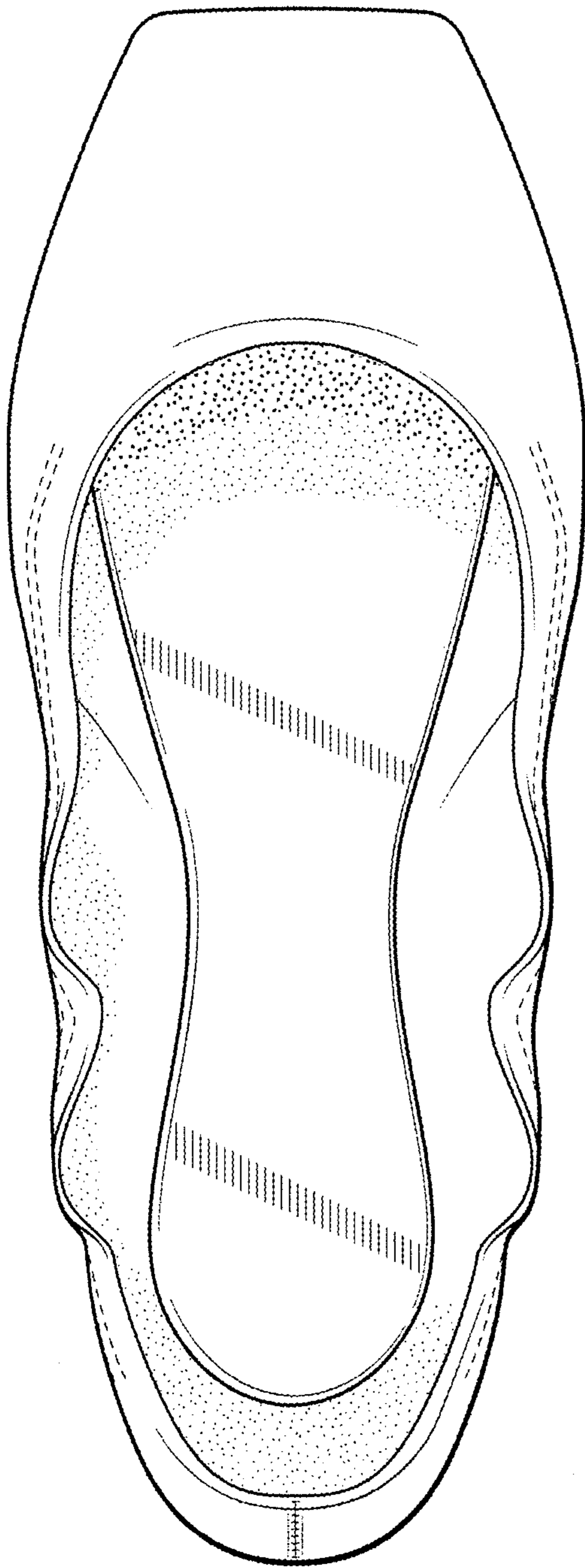

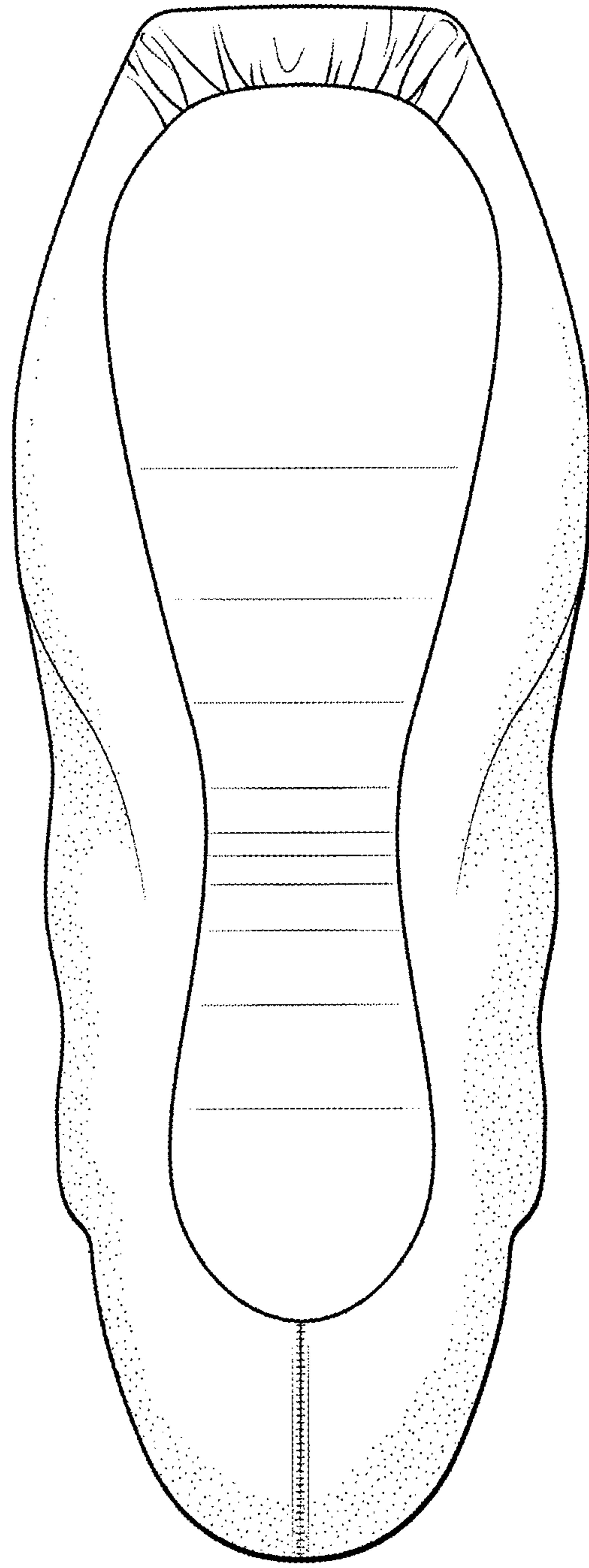

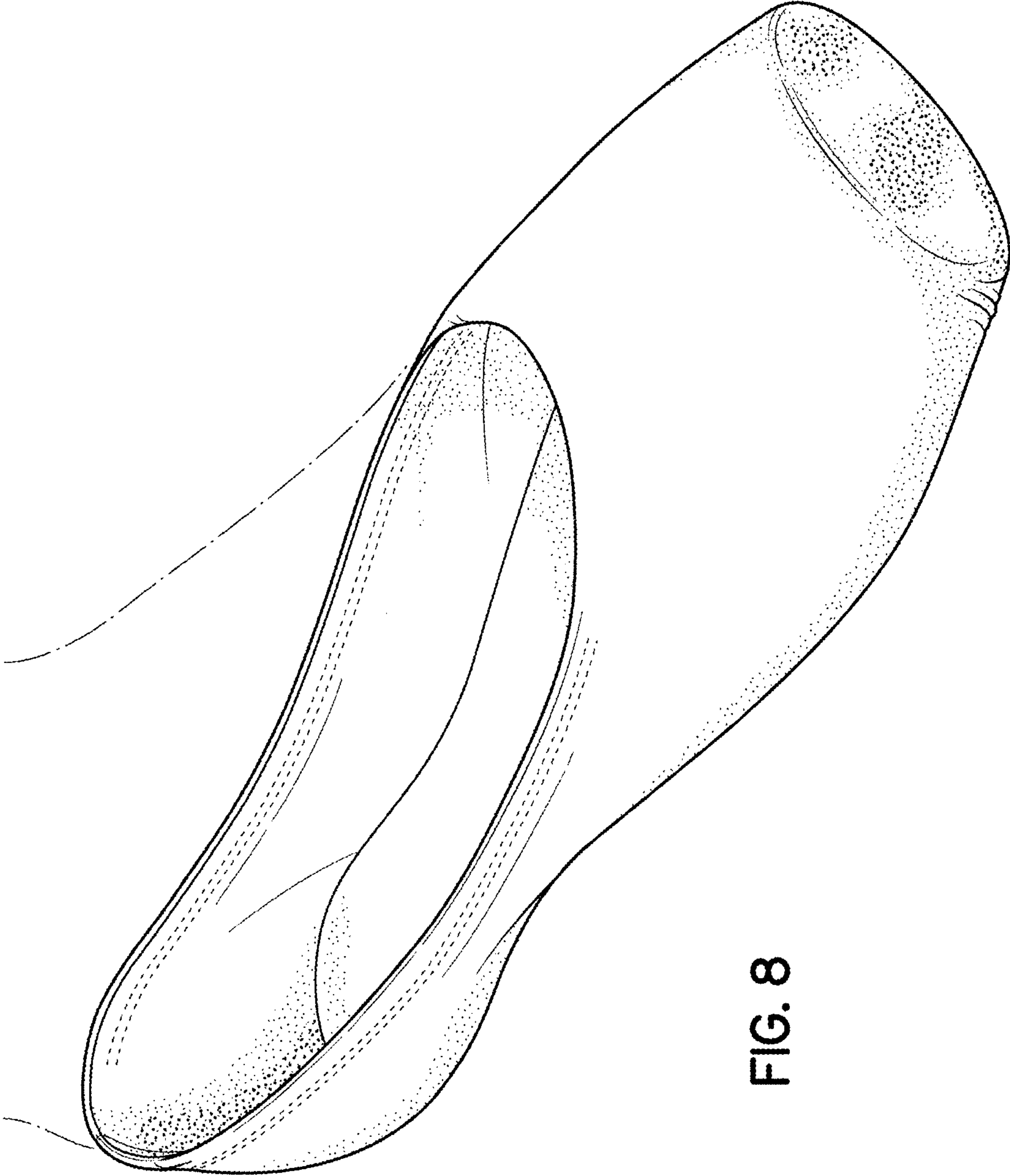

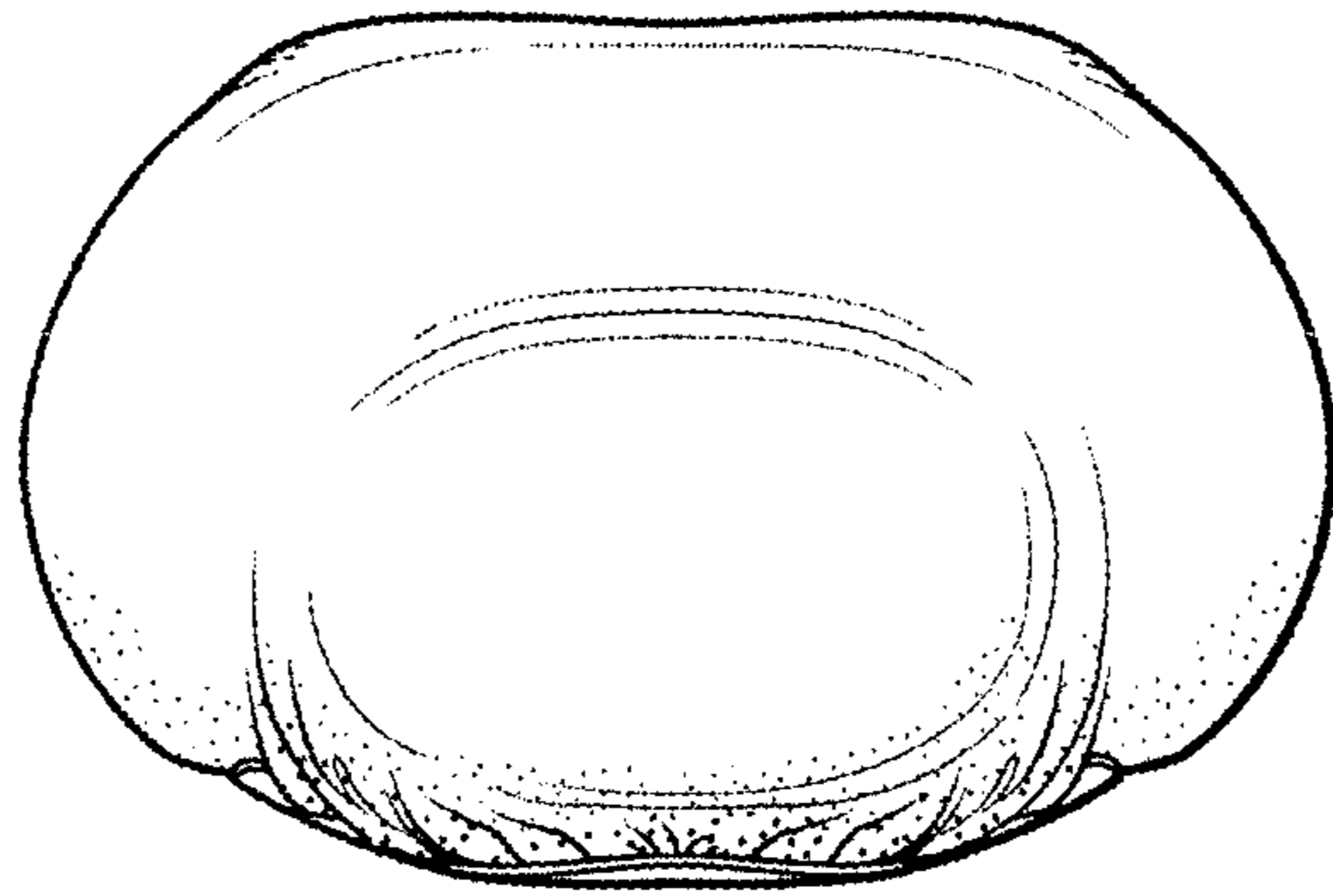

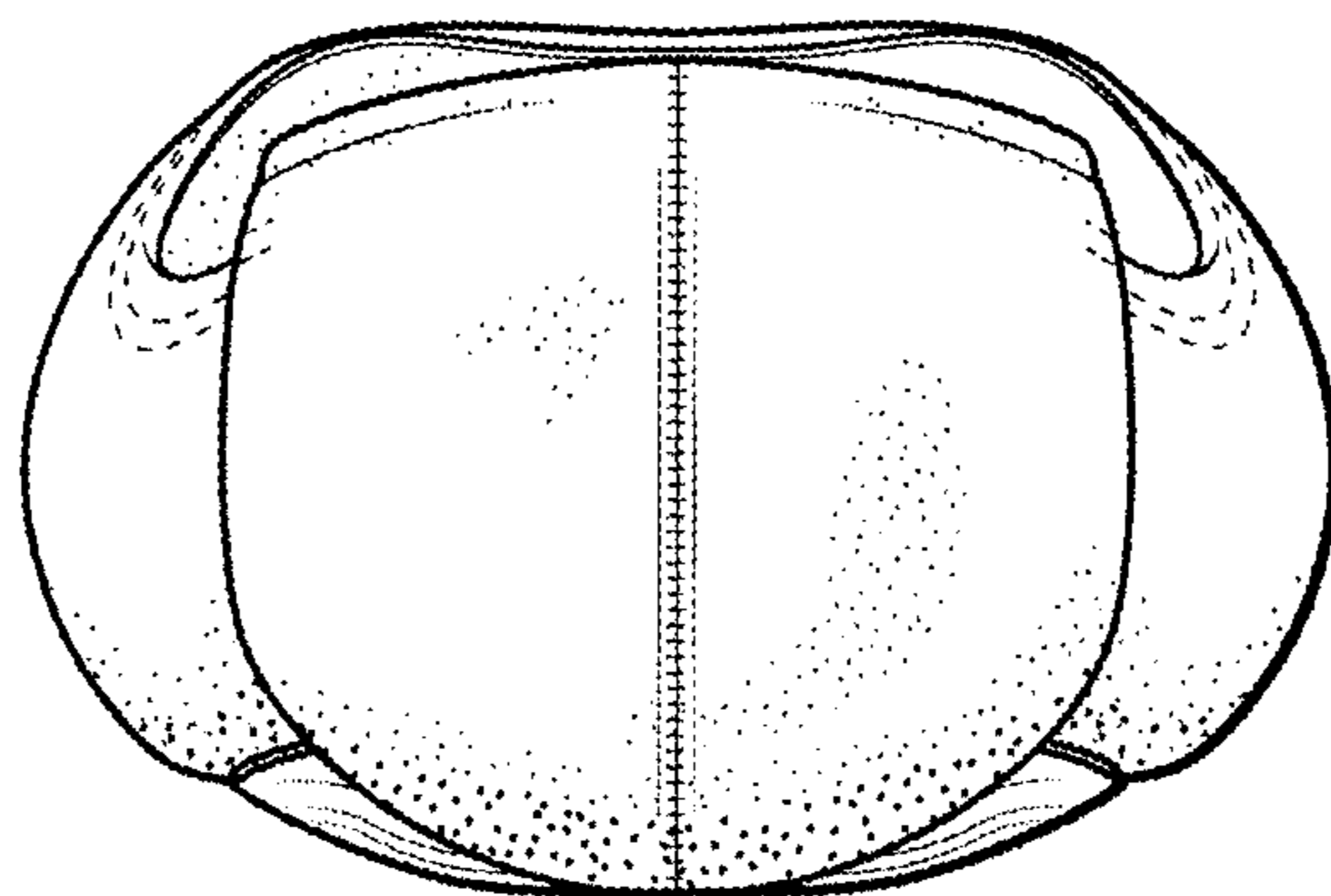

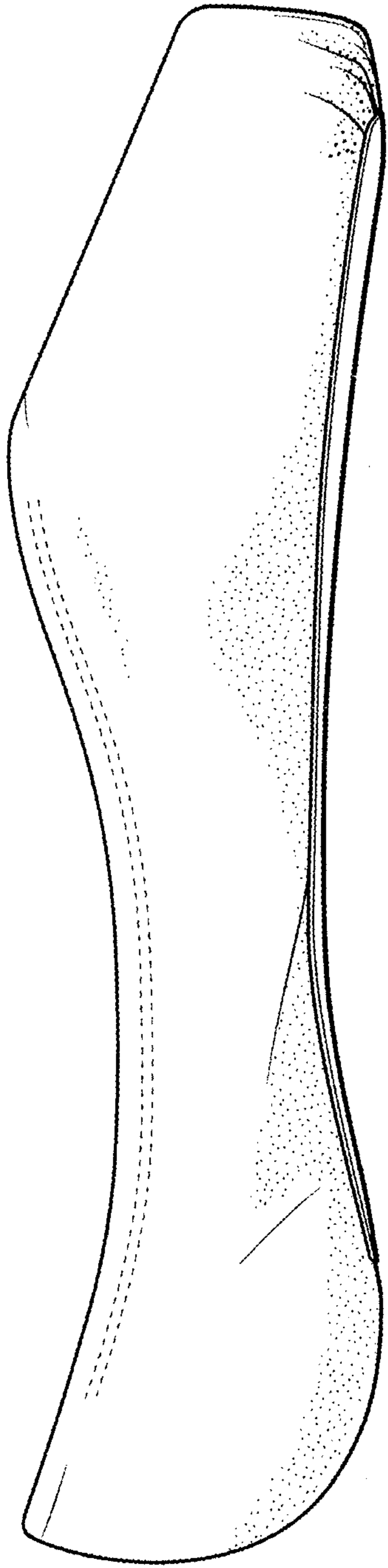

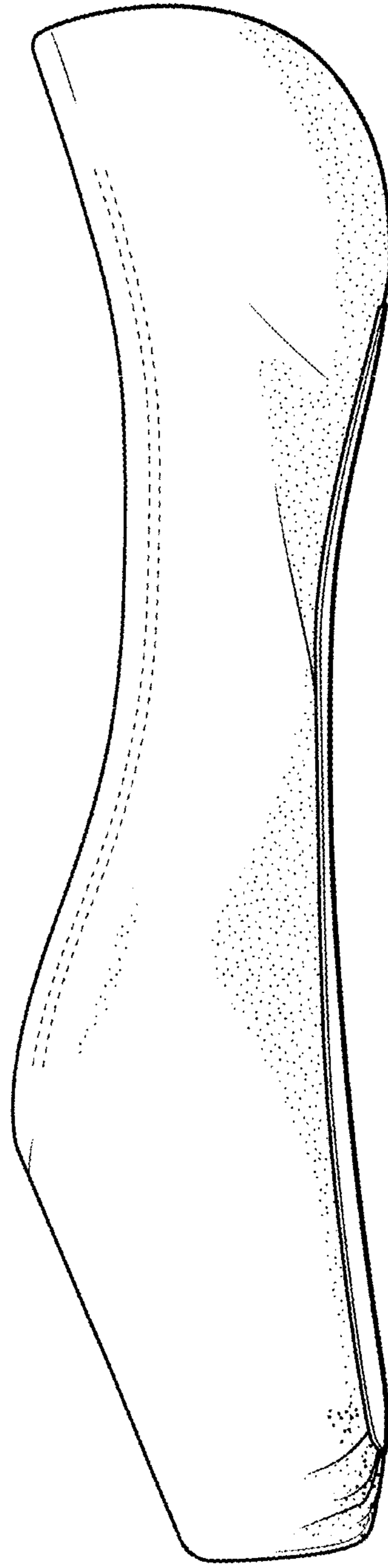

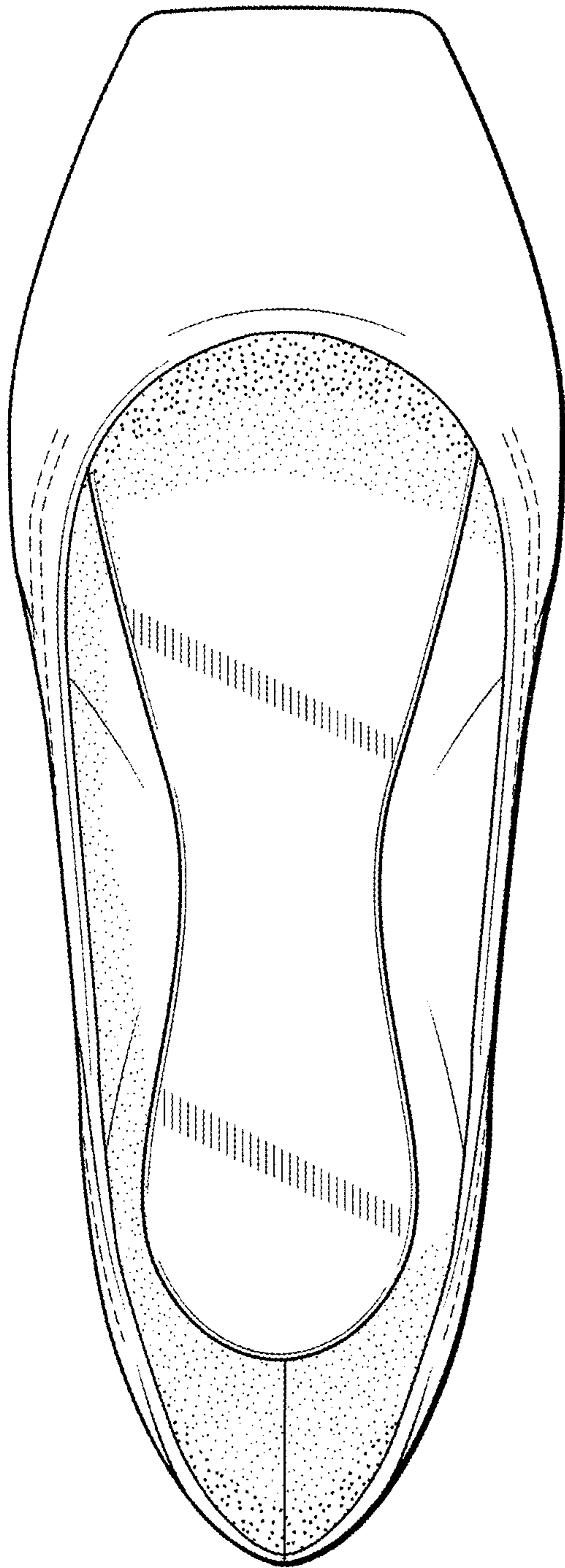

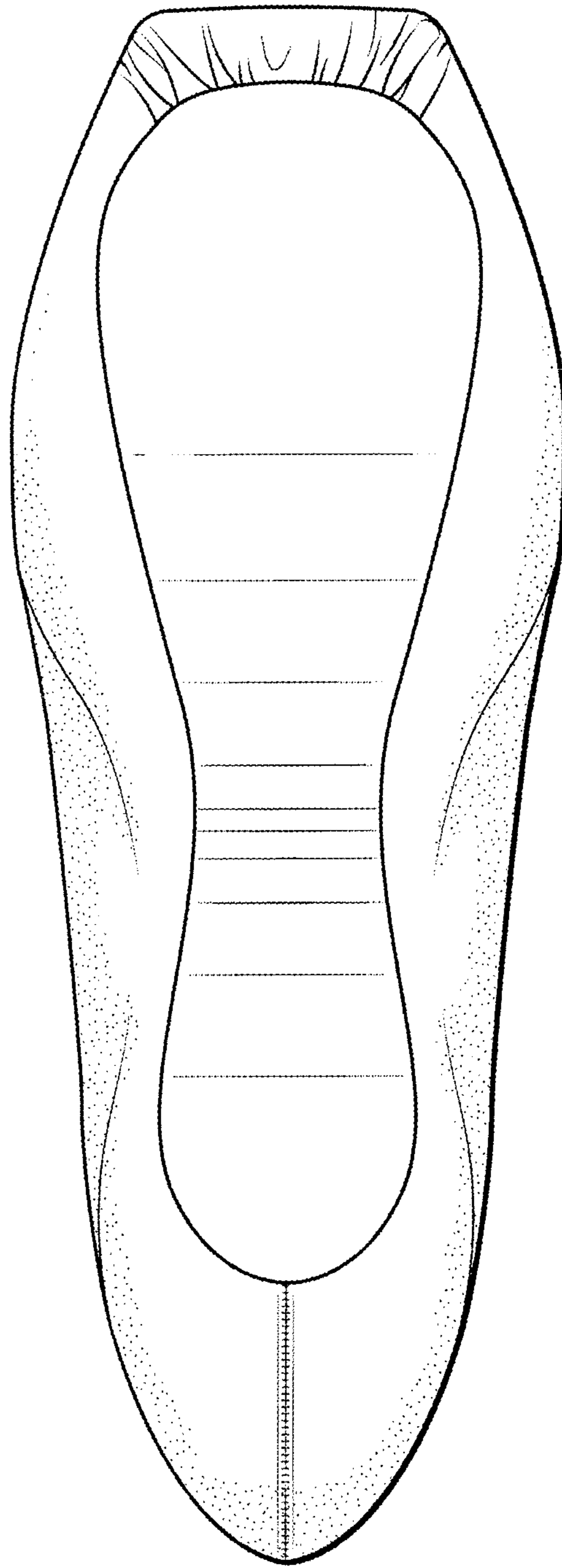
