(57) **CLAIM**

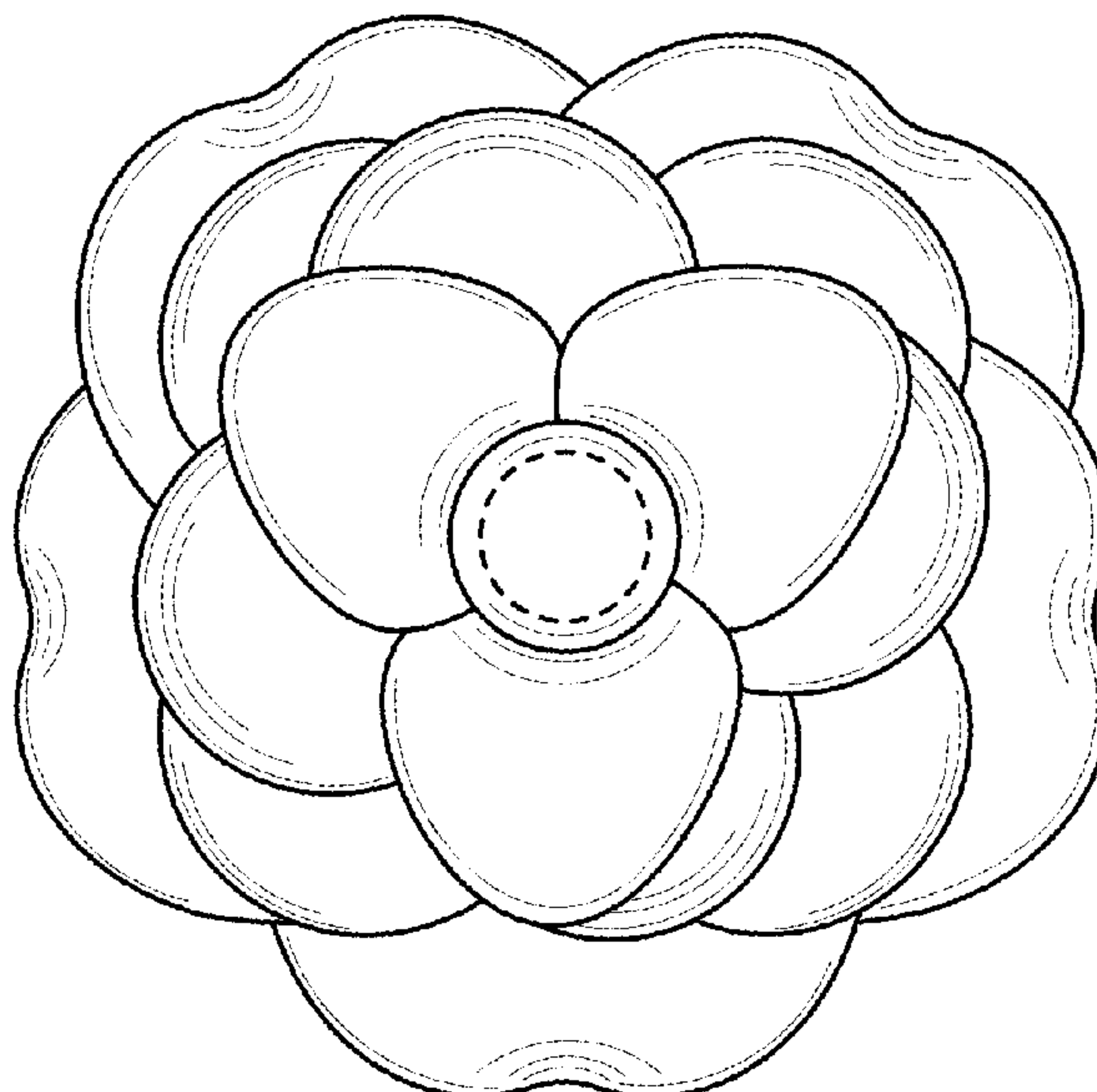
The ornamental design for a display for fragrance and cosmetic sampler, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the display for fragrance and cosmetic sampler showing our new design;

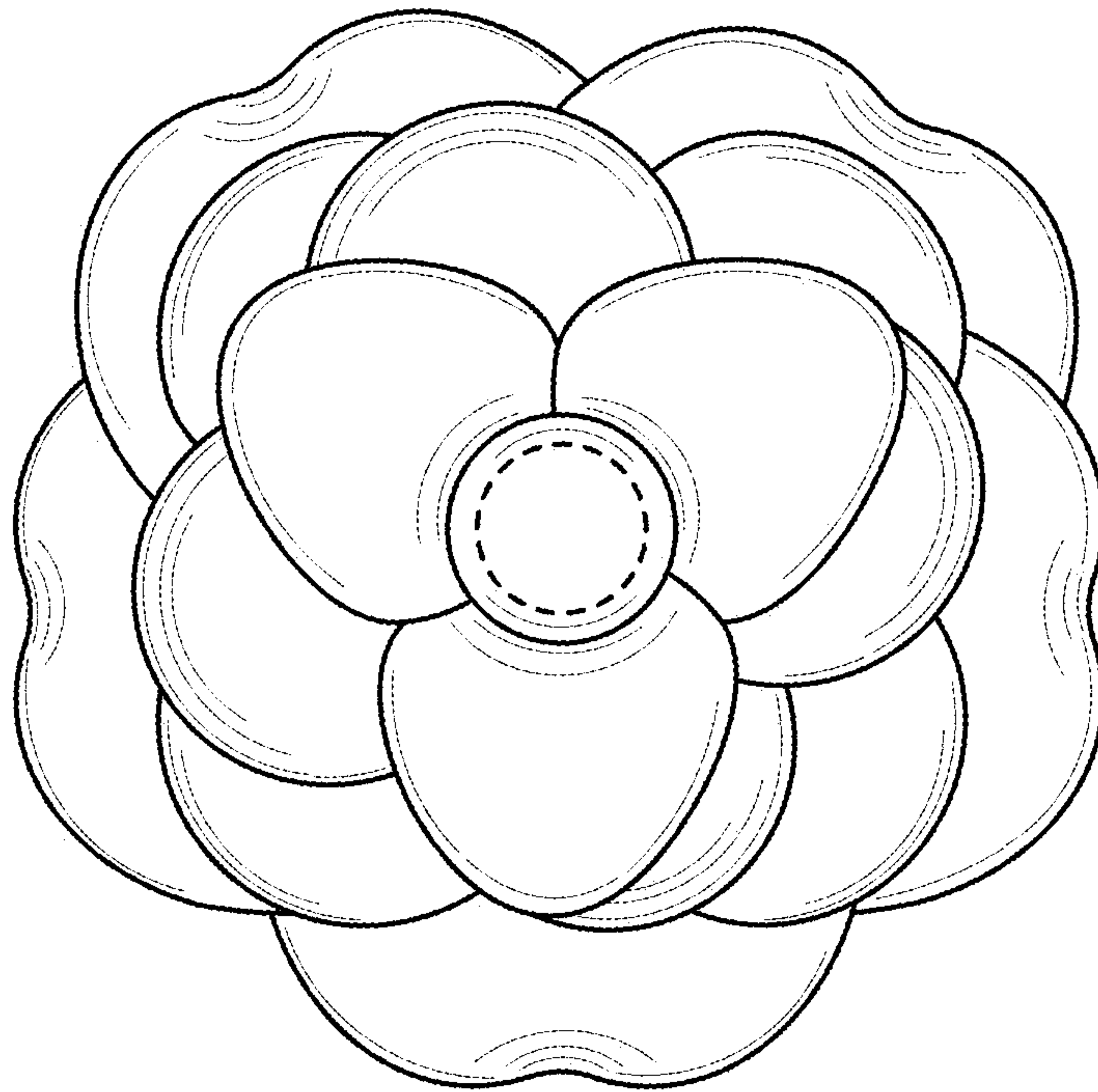

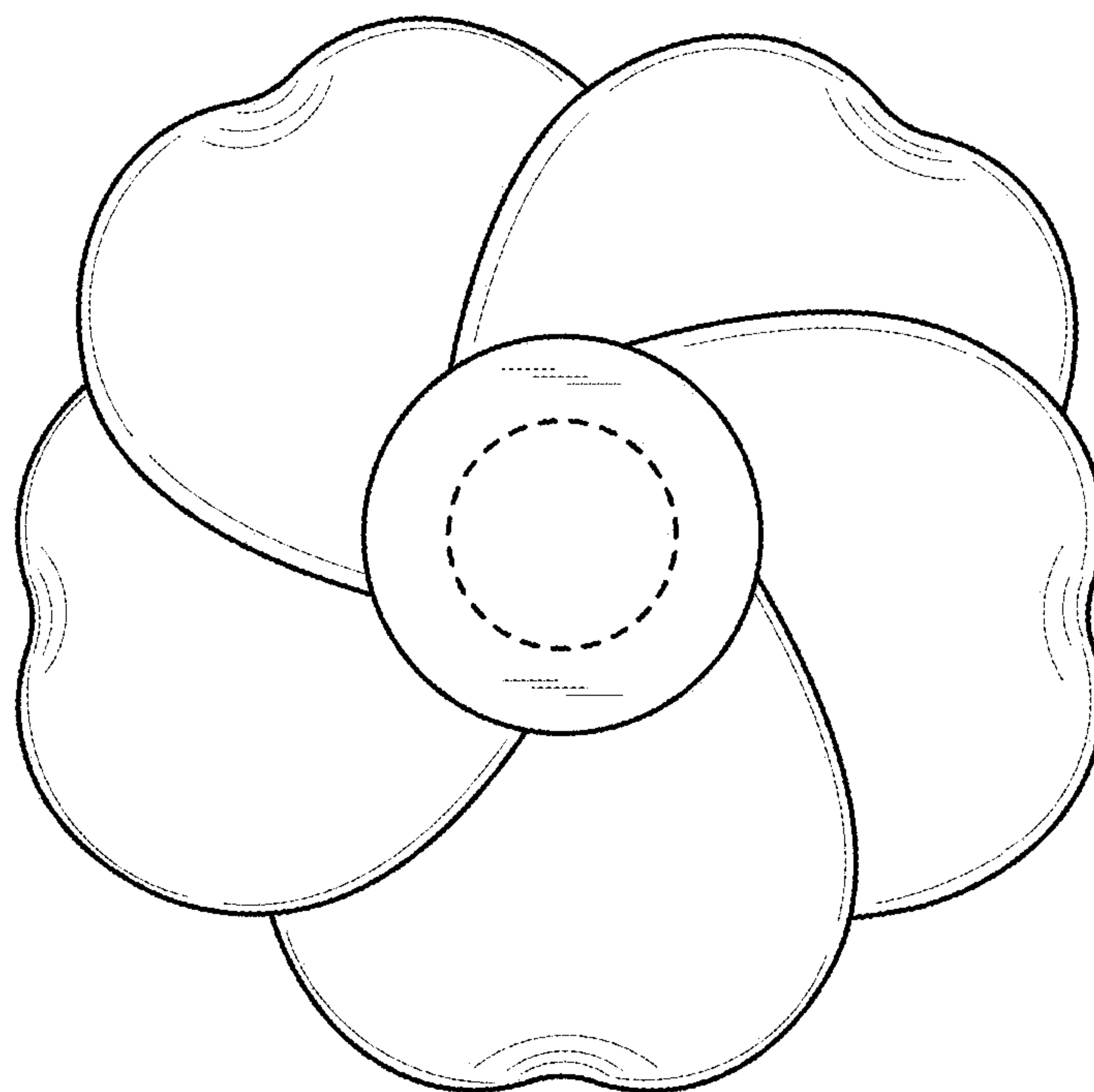

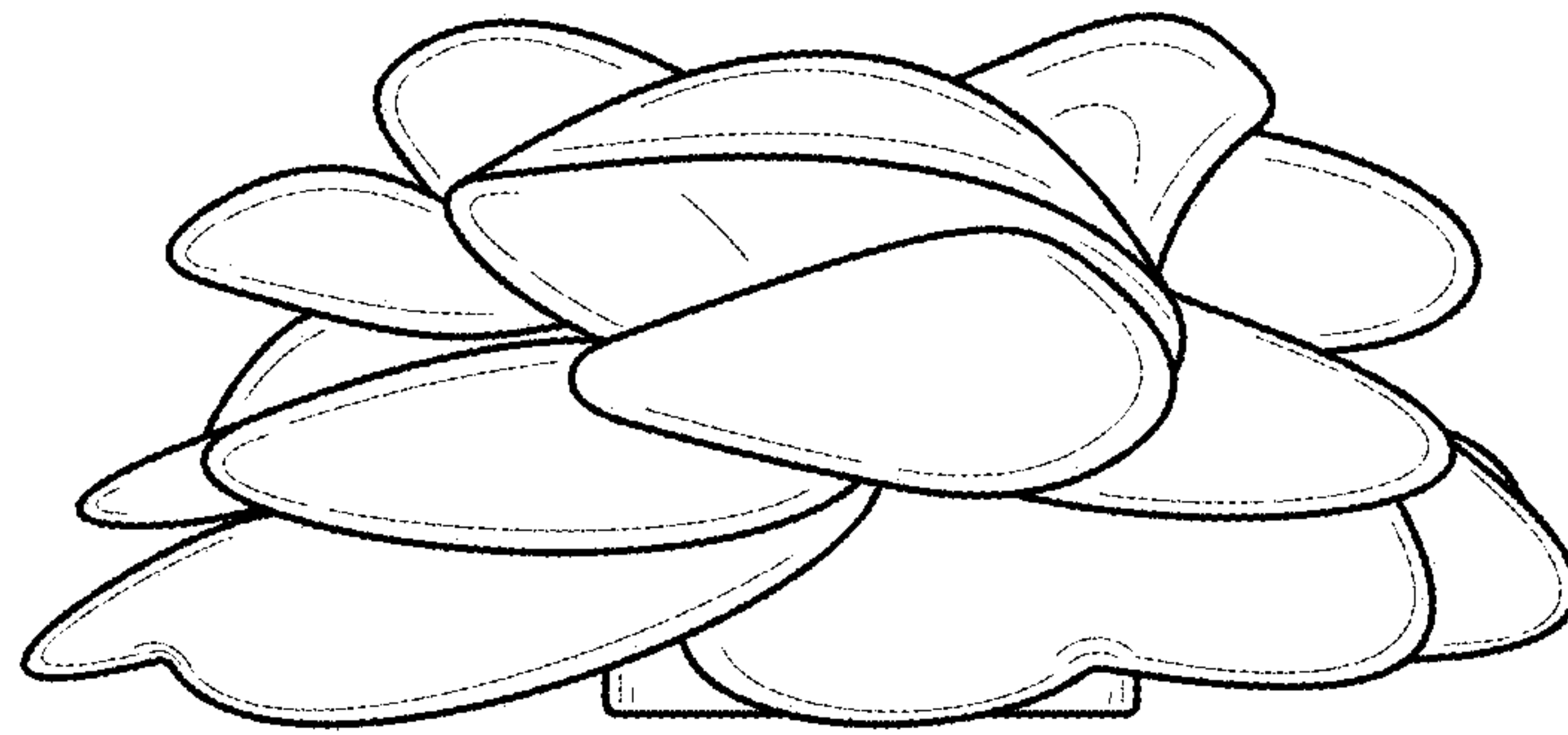

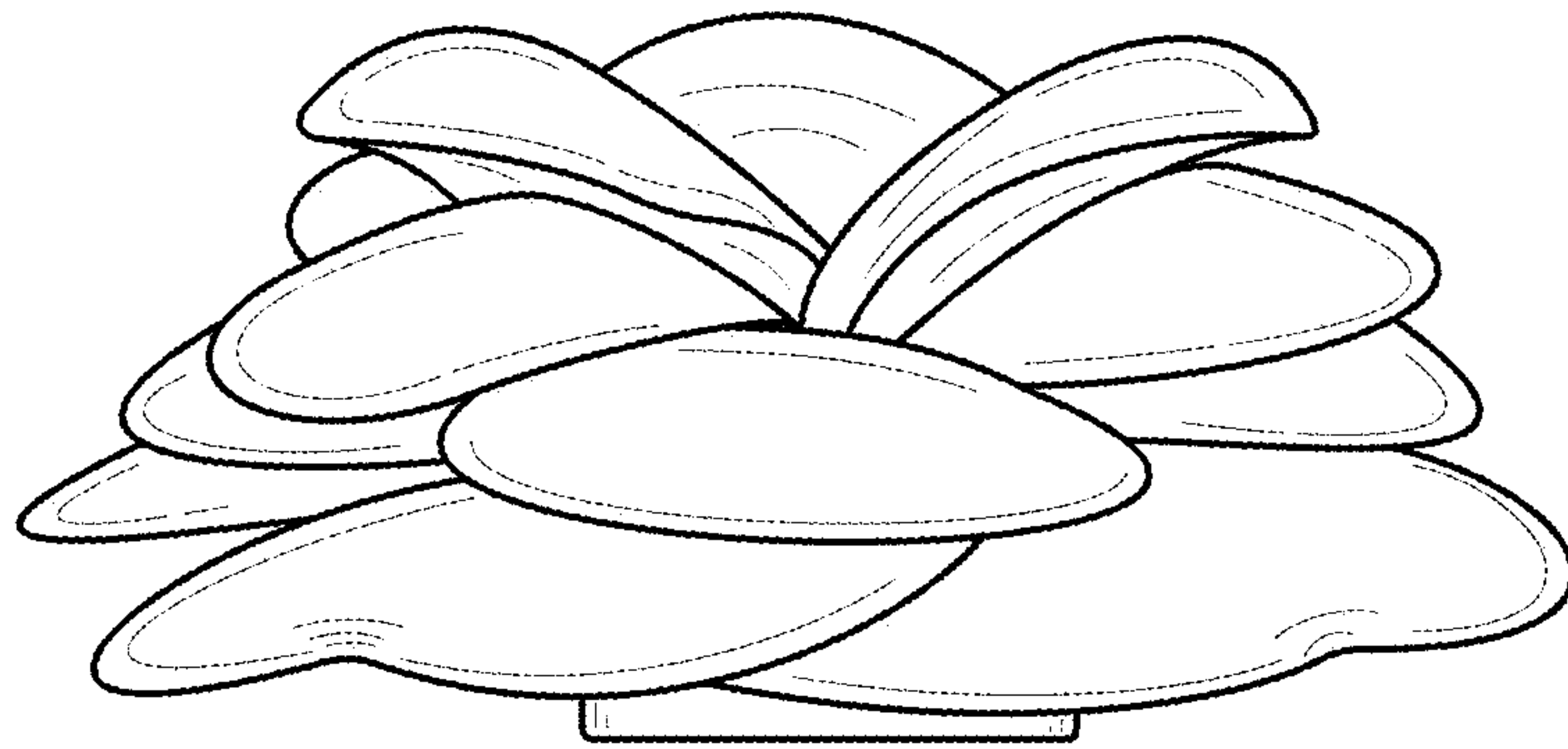

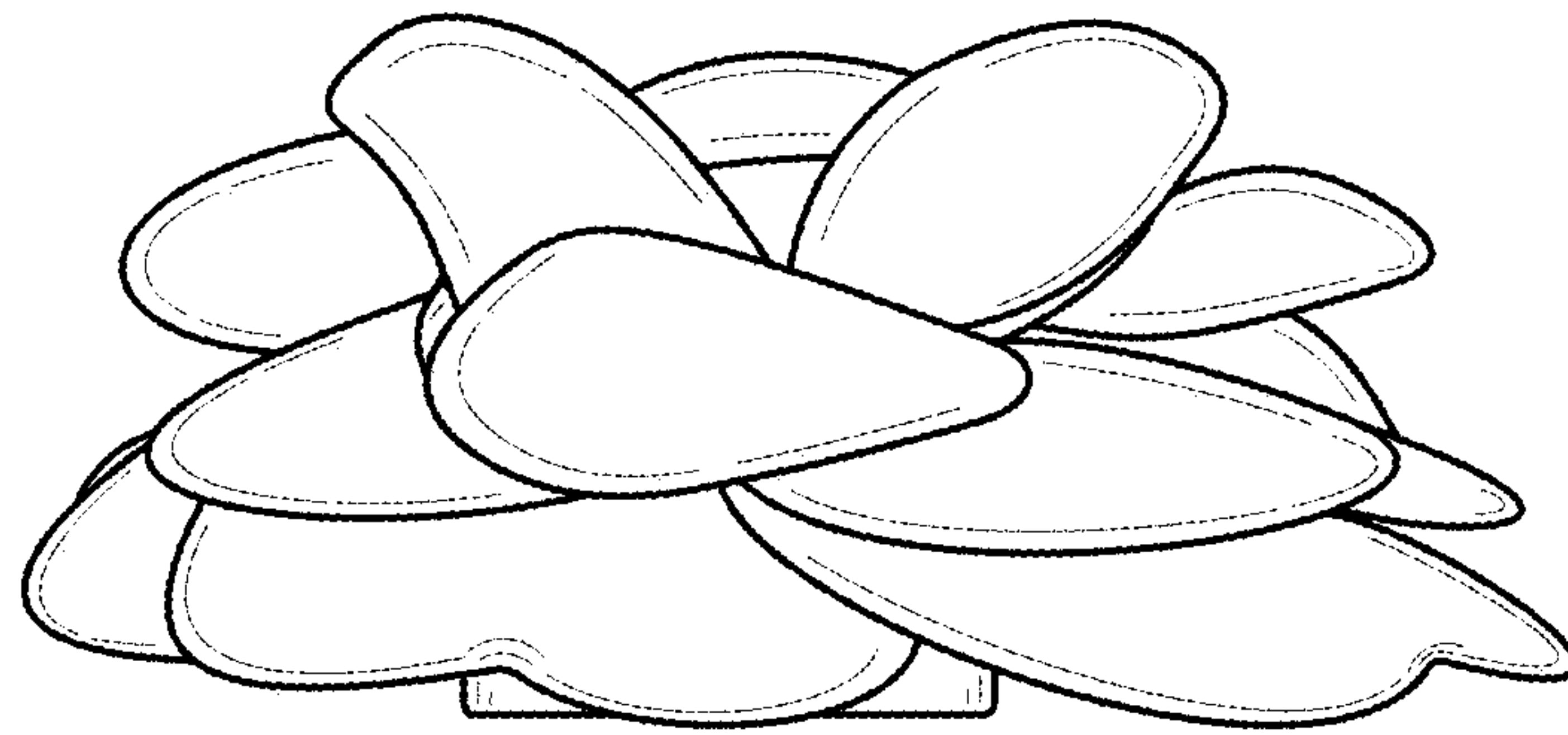

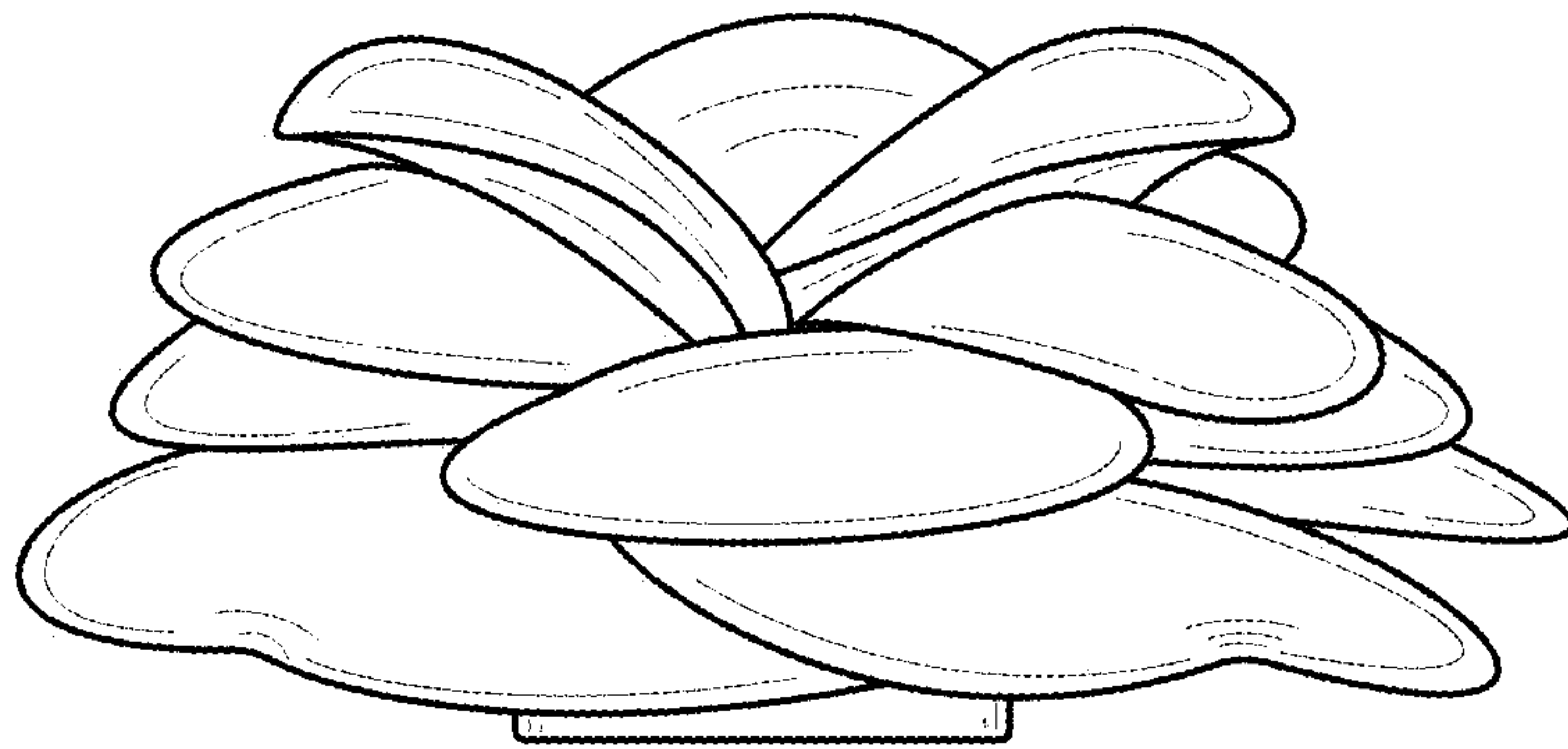

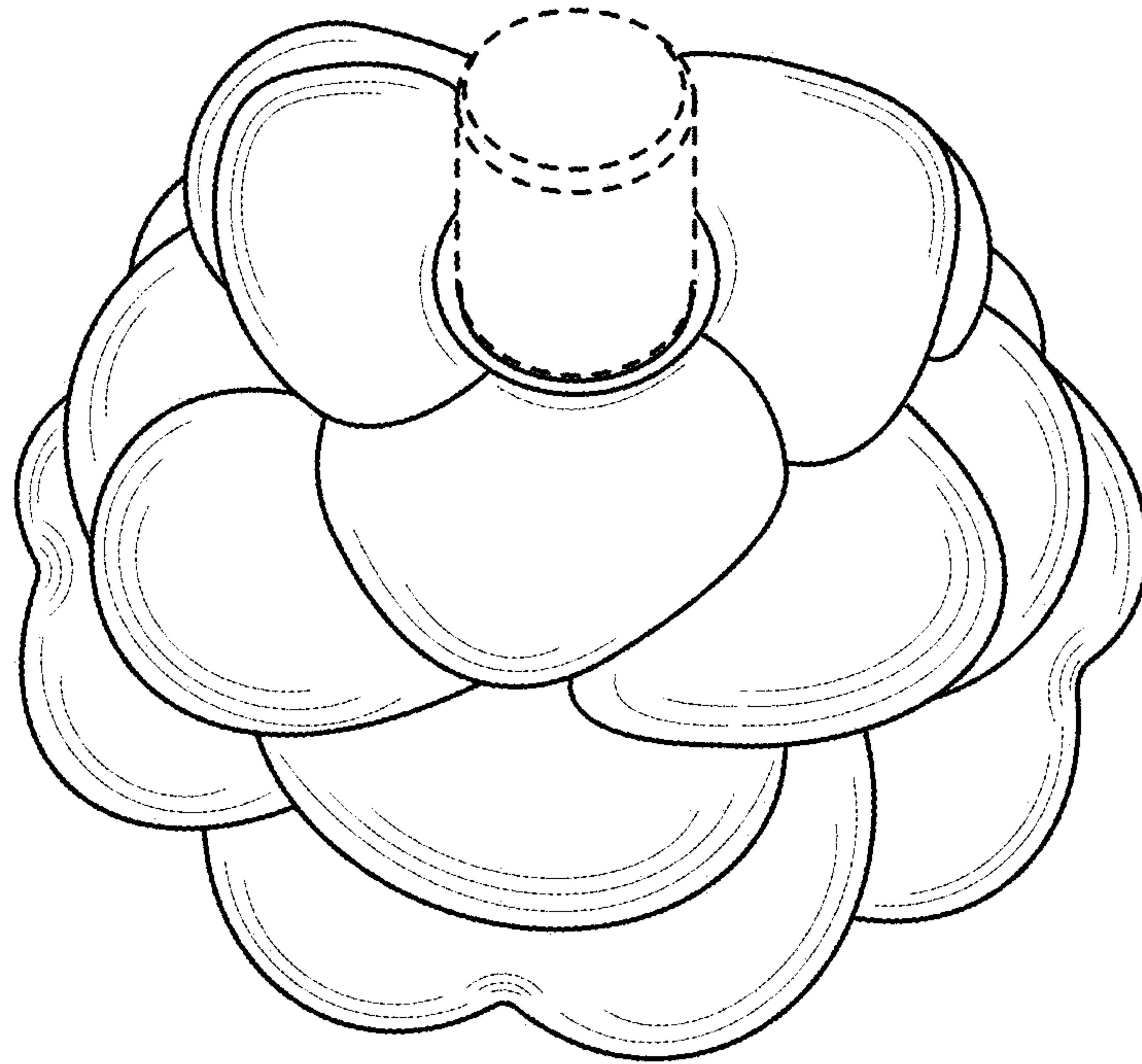

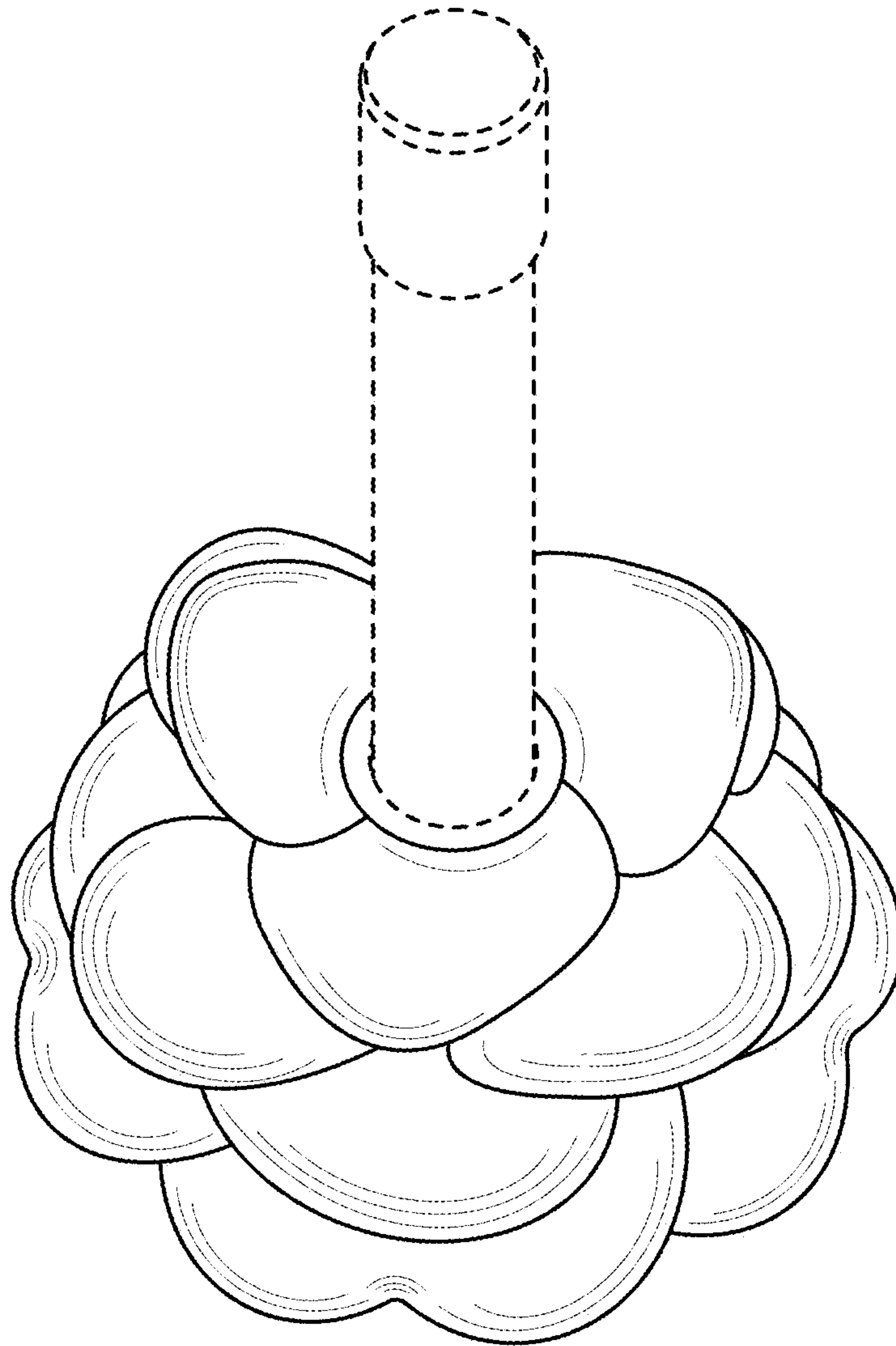
