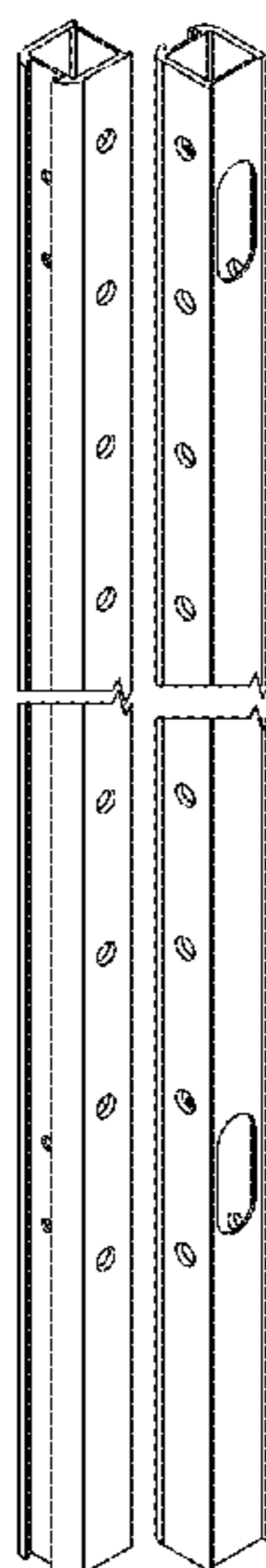
(57) **CLAIM**

The ornamental design of a post for a storage rack, as shown and described.

**DESCRIPTION**

FIG. 1 is a front isometric view of a post for a storage rack; FIG. 2 is a rear isometric view of view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a rear view thereof; and, FIG. 7 is a top view thereof.  
A bottom view is not shown but is a mirror image of the top view shown in FIG. 7.  
The broken away symbols in the drawing indicate the appearance of any portion of the post for a storage rack between the break lines forms no part or the claimed design.

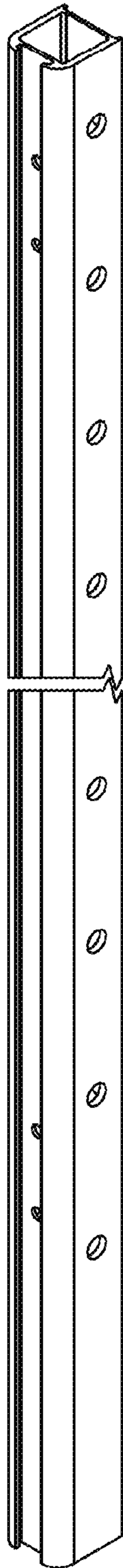

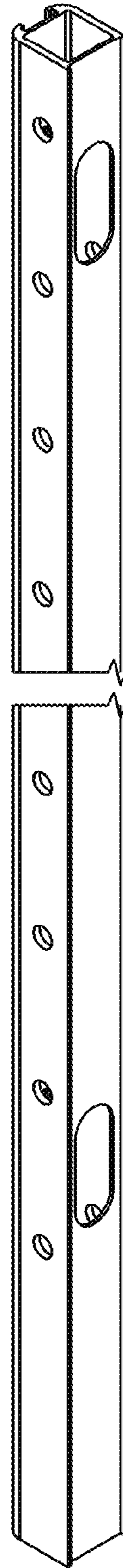

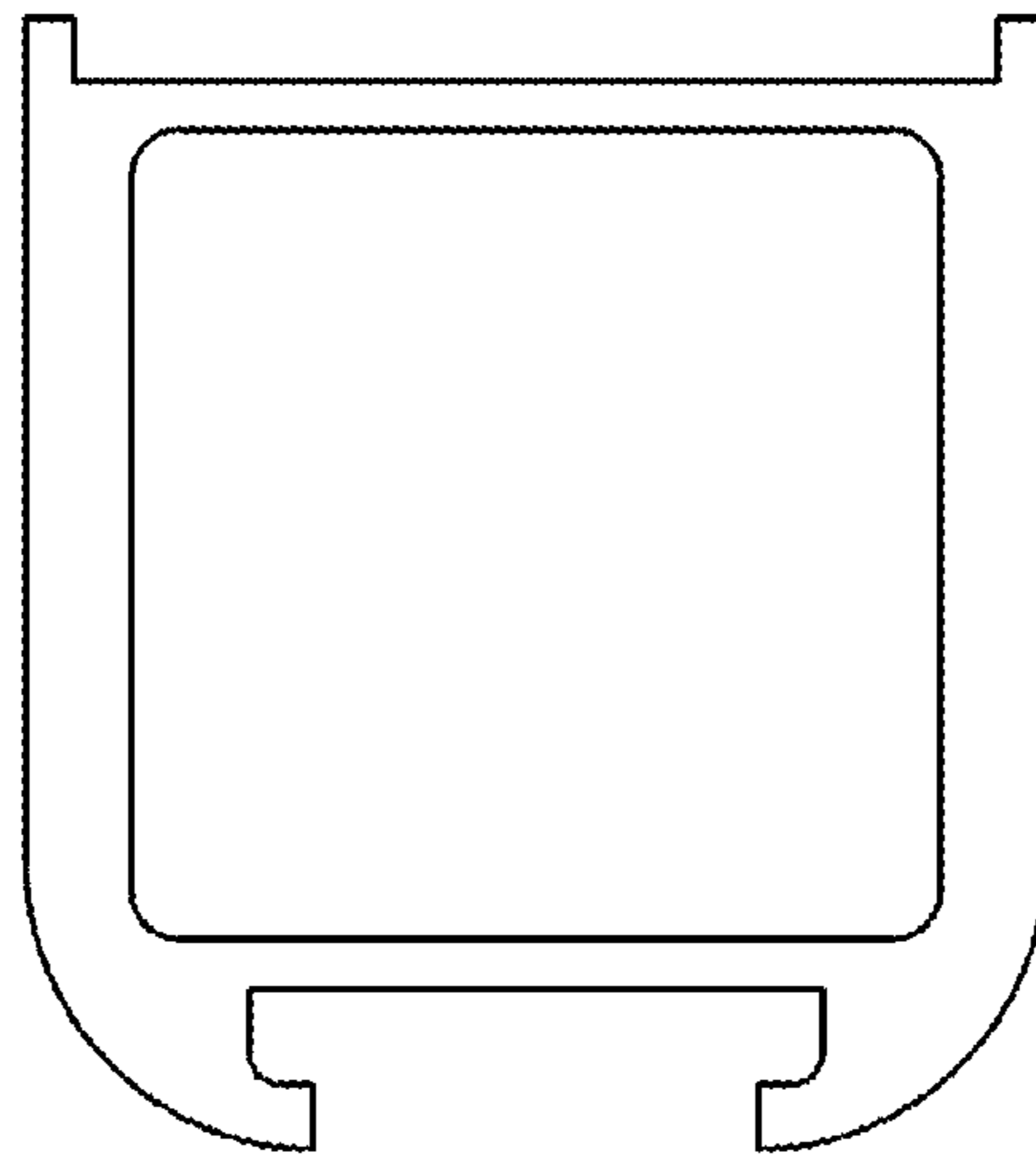
