The ornamental design for a box, substantially as shown and described.

DESCRIPTION

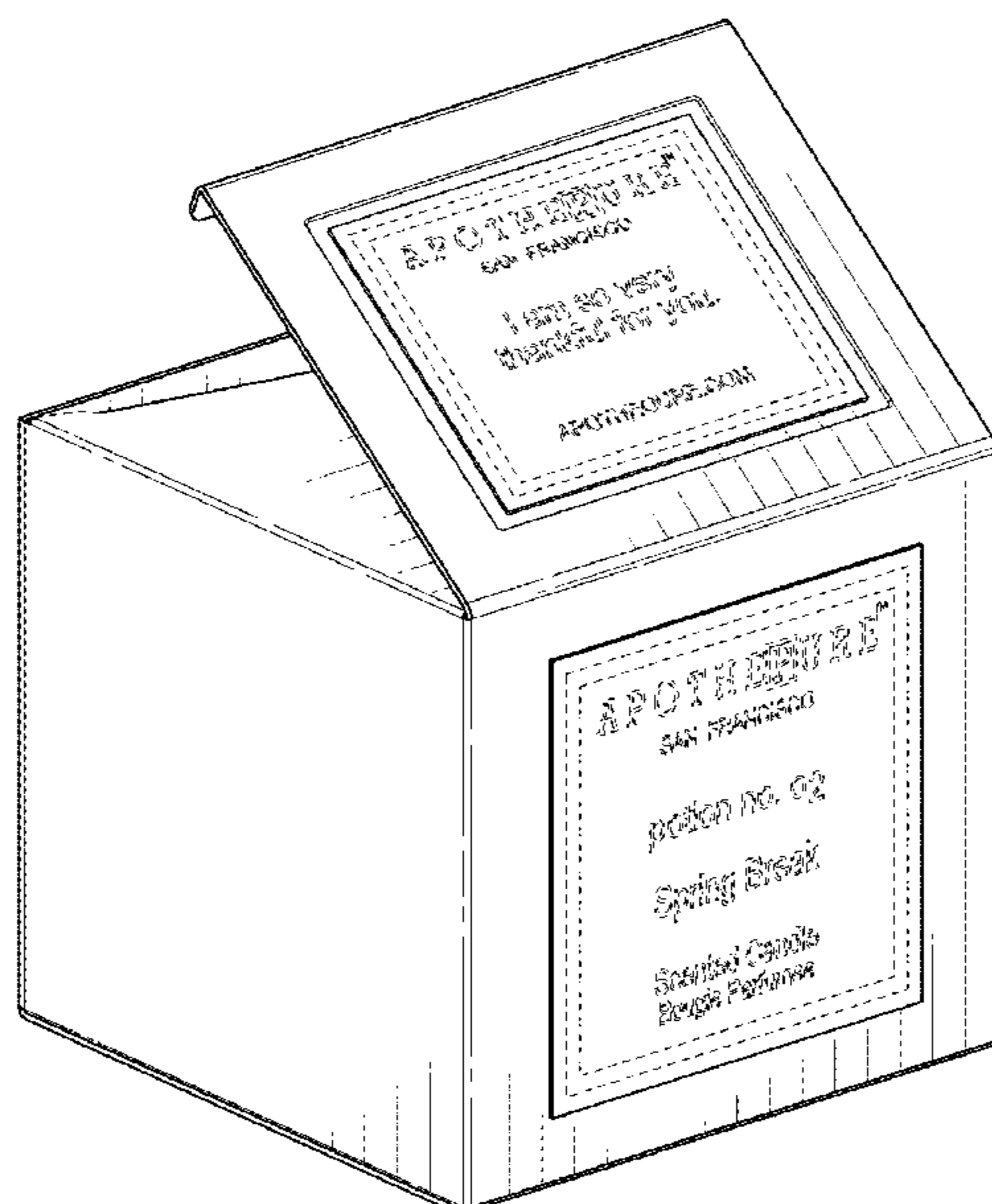
FIG. 1 is a perspective view of a box showing my new design, featuring a recessed square in the top of the box without a sticker to reveal aspects of the design not apparent in the other views.
FIG. 2 is a perspective view of the box of FIG. 1, with a sticker positioned in the recessed square.
FIG. 3 is a top view thereof.
FIG. 4 is a right side view thereof.
FIG. 5 is a left side view thereof.
FIG. 6 is a front view thereof.
FIG. 7 is a bottom view thereof; and,
FIG. 8 is a perspective view thereof, with the top slightly open.
The evenly dashed broken lines in the drawings depict environmental subject matter and form no part of the claimed design. The unevenly dashed broken lines in FIG. 7 depict the boundaries of the claim and the lines themselves form no part of the claimed design.

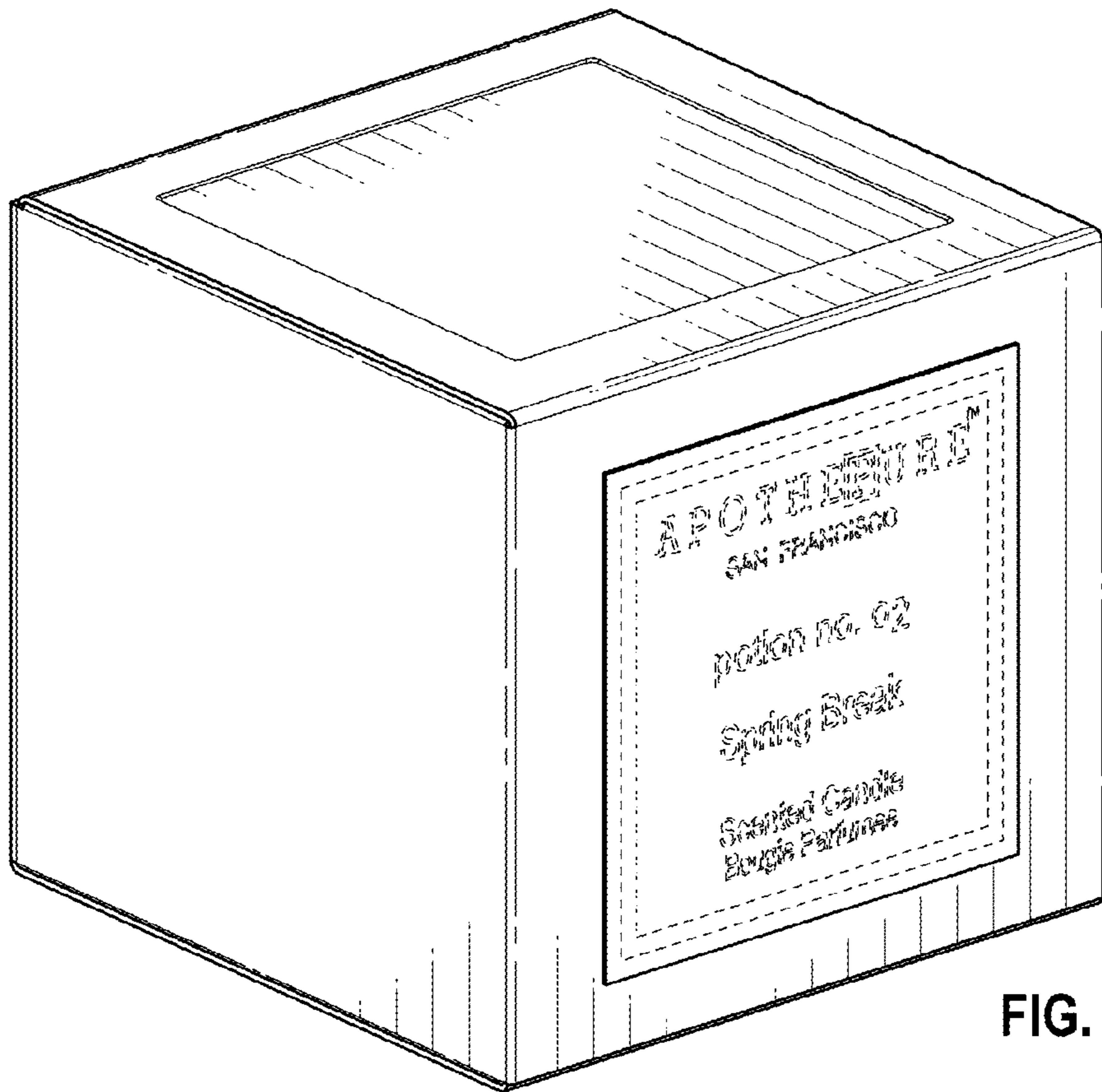

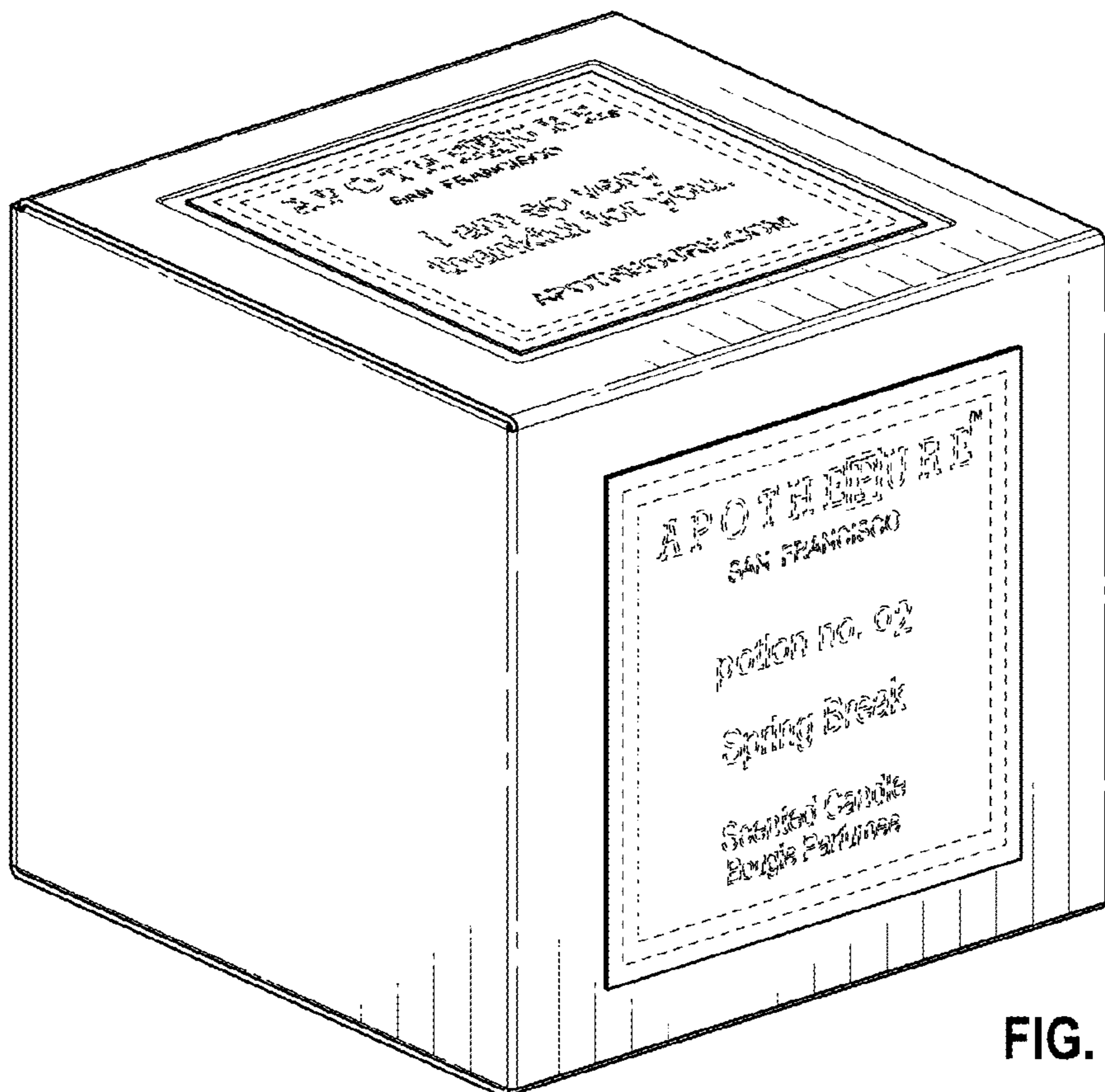

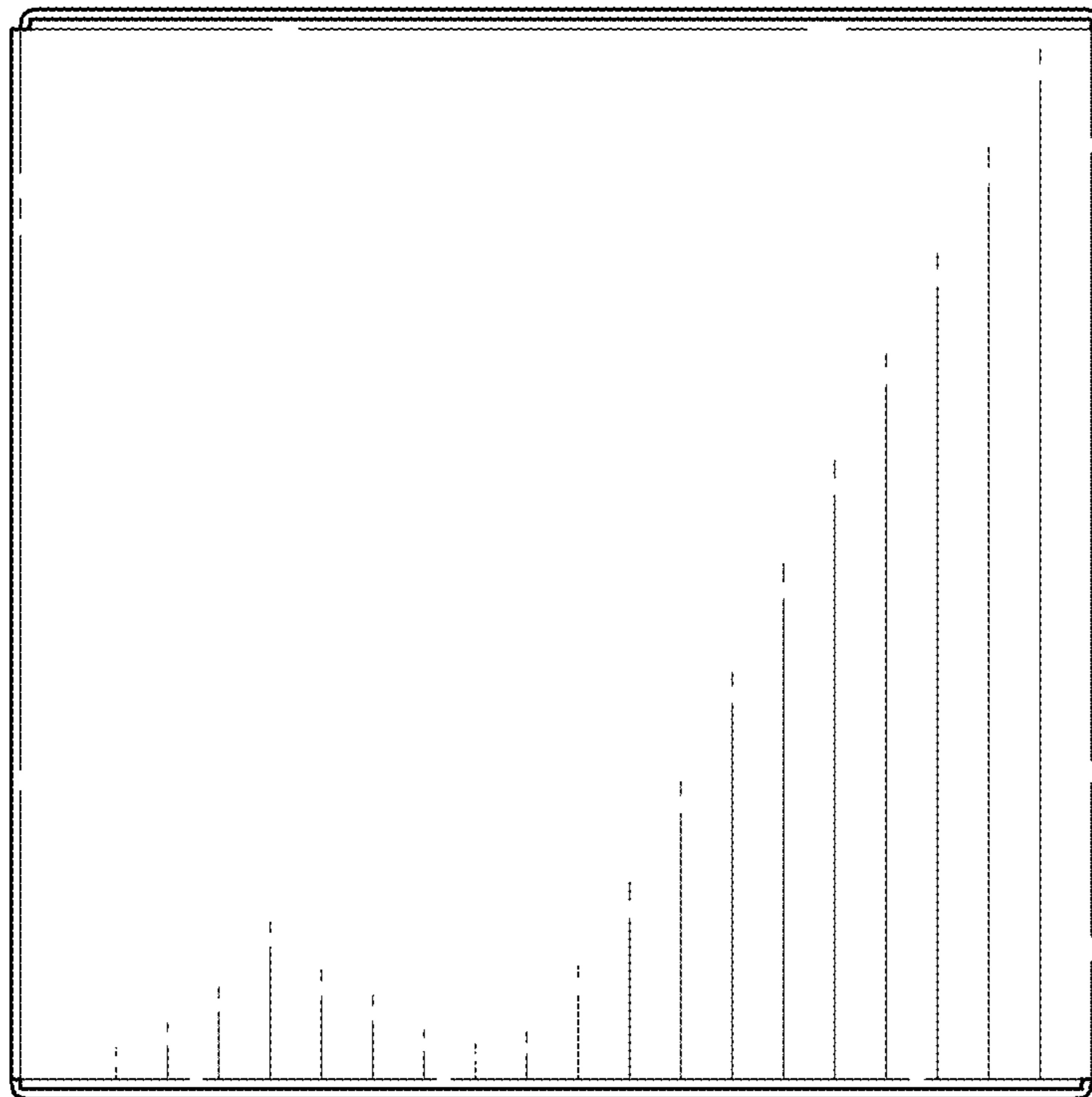

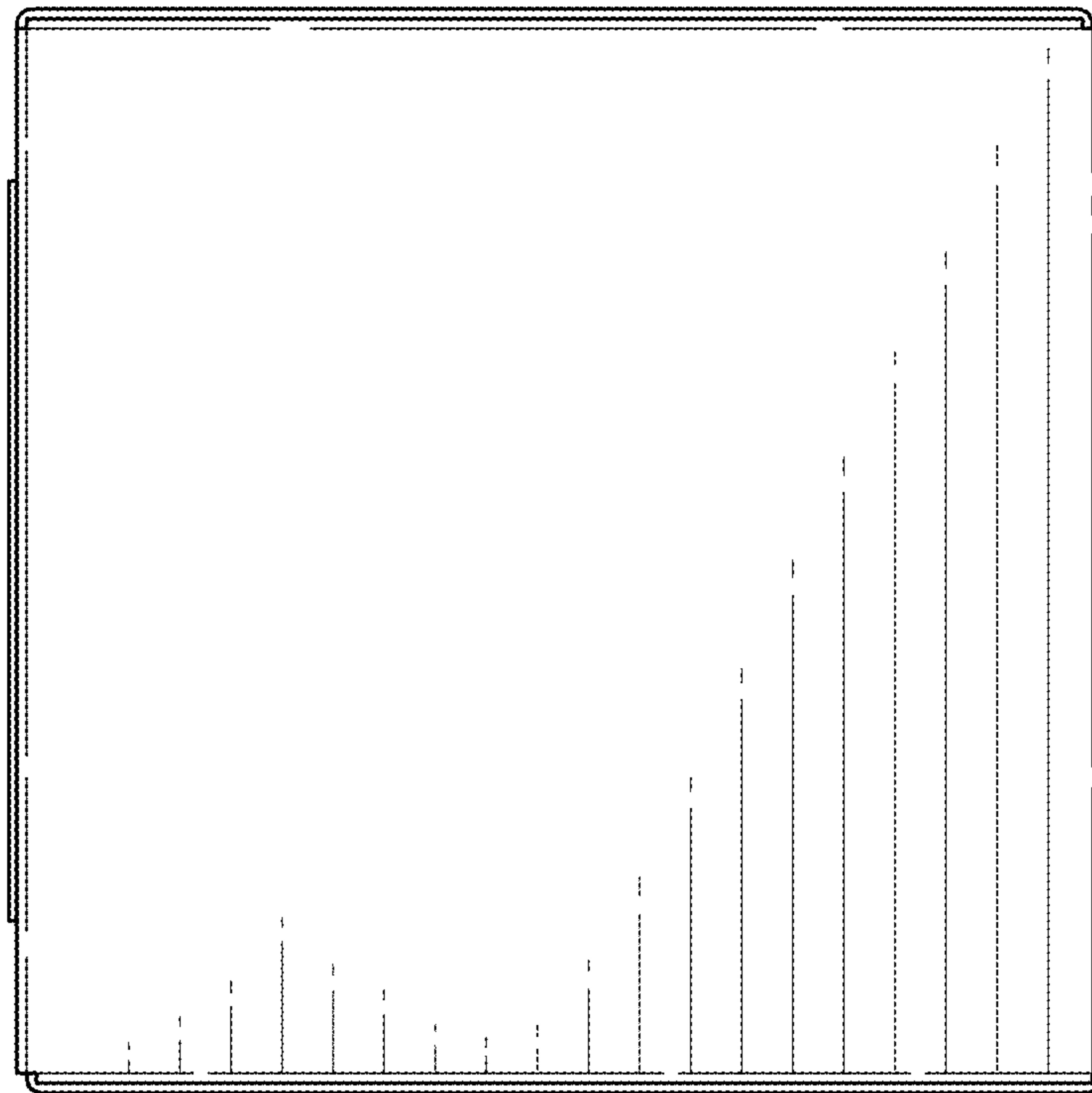

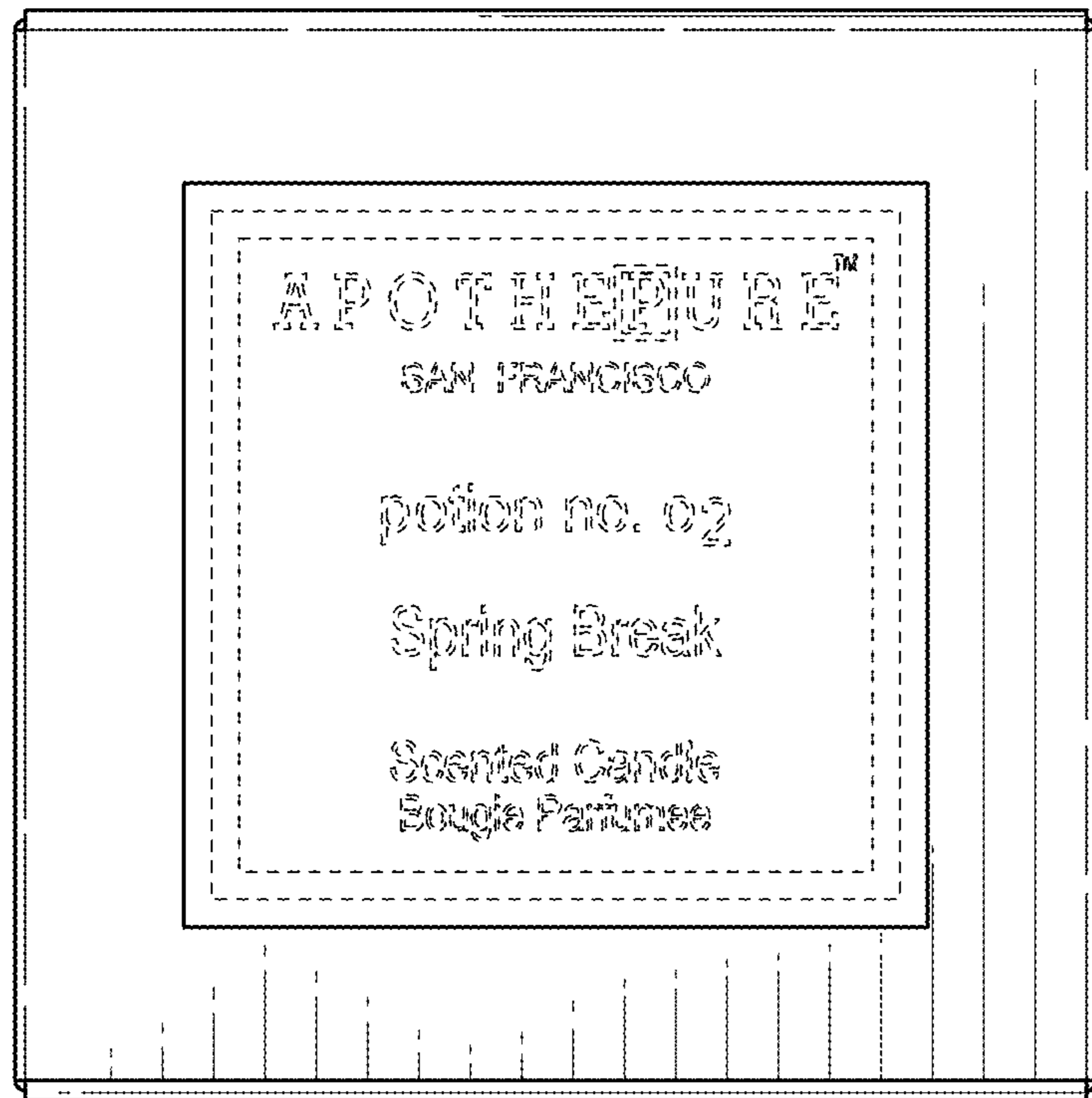

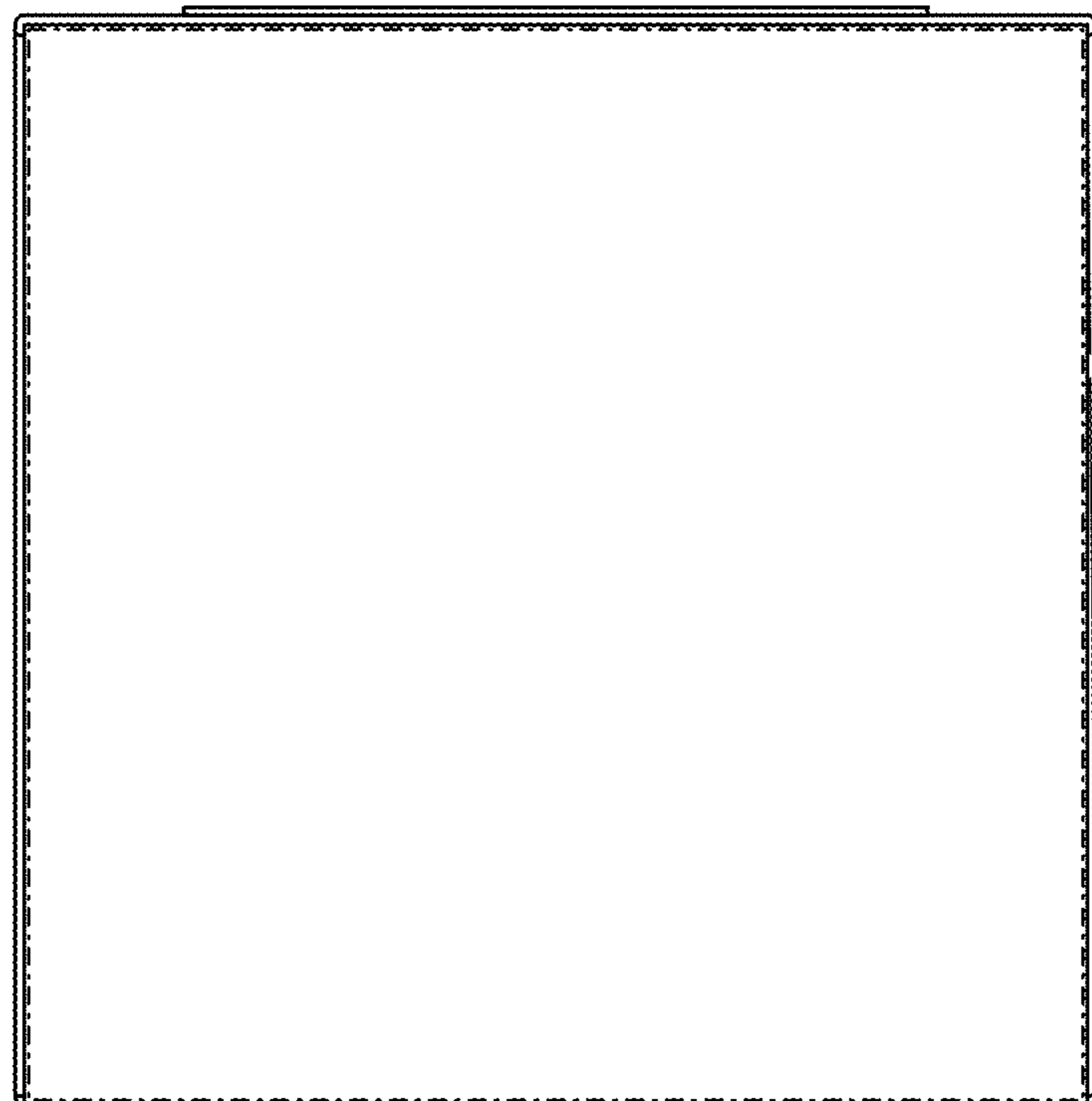

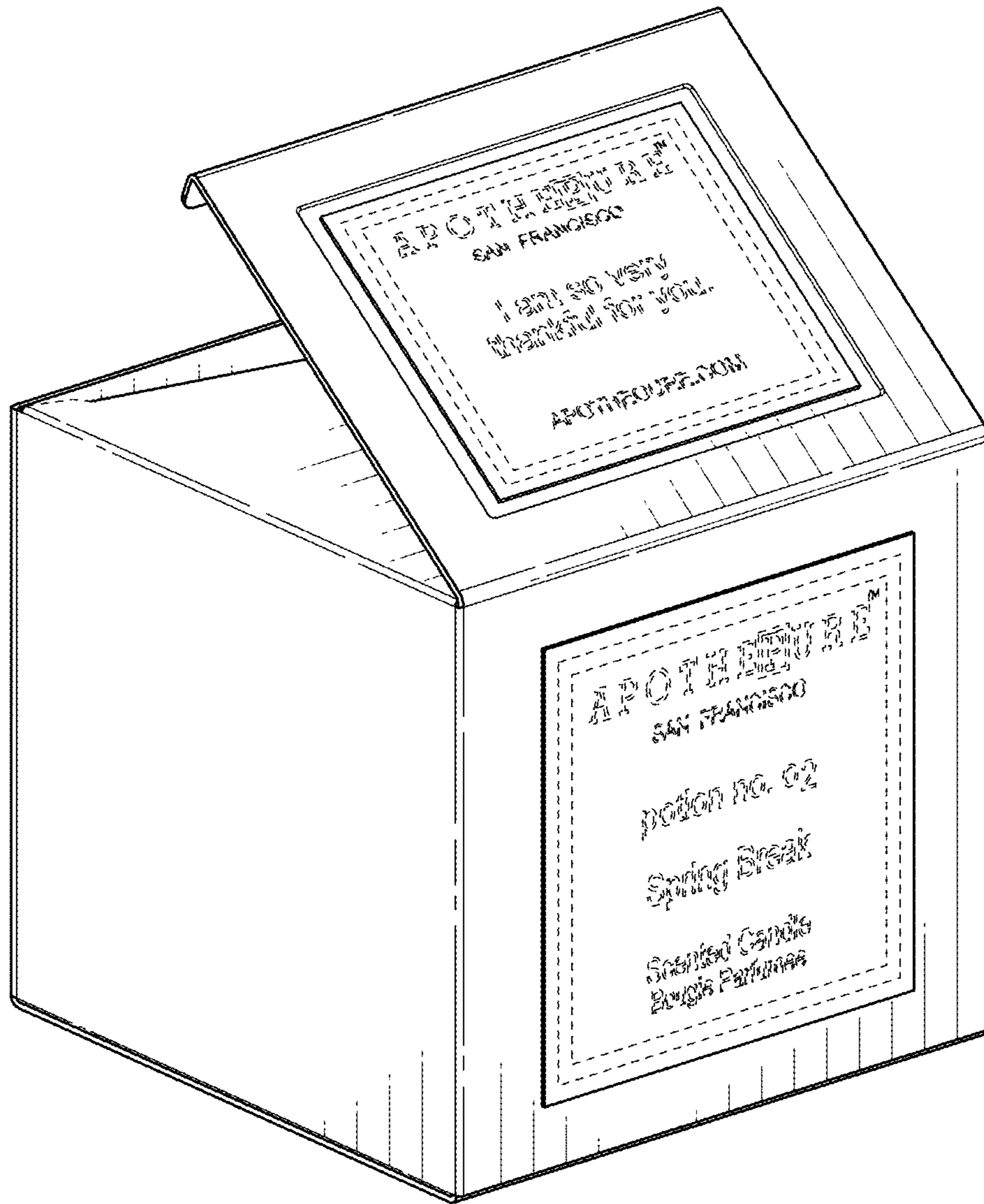
