DESCRIPTION

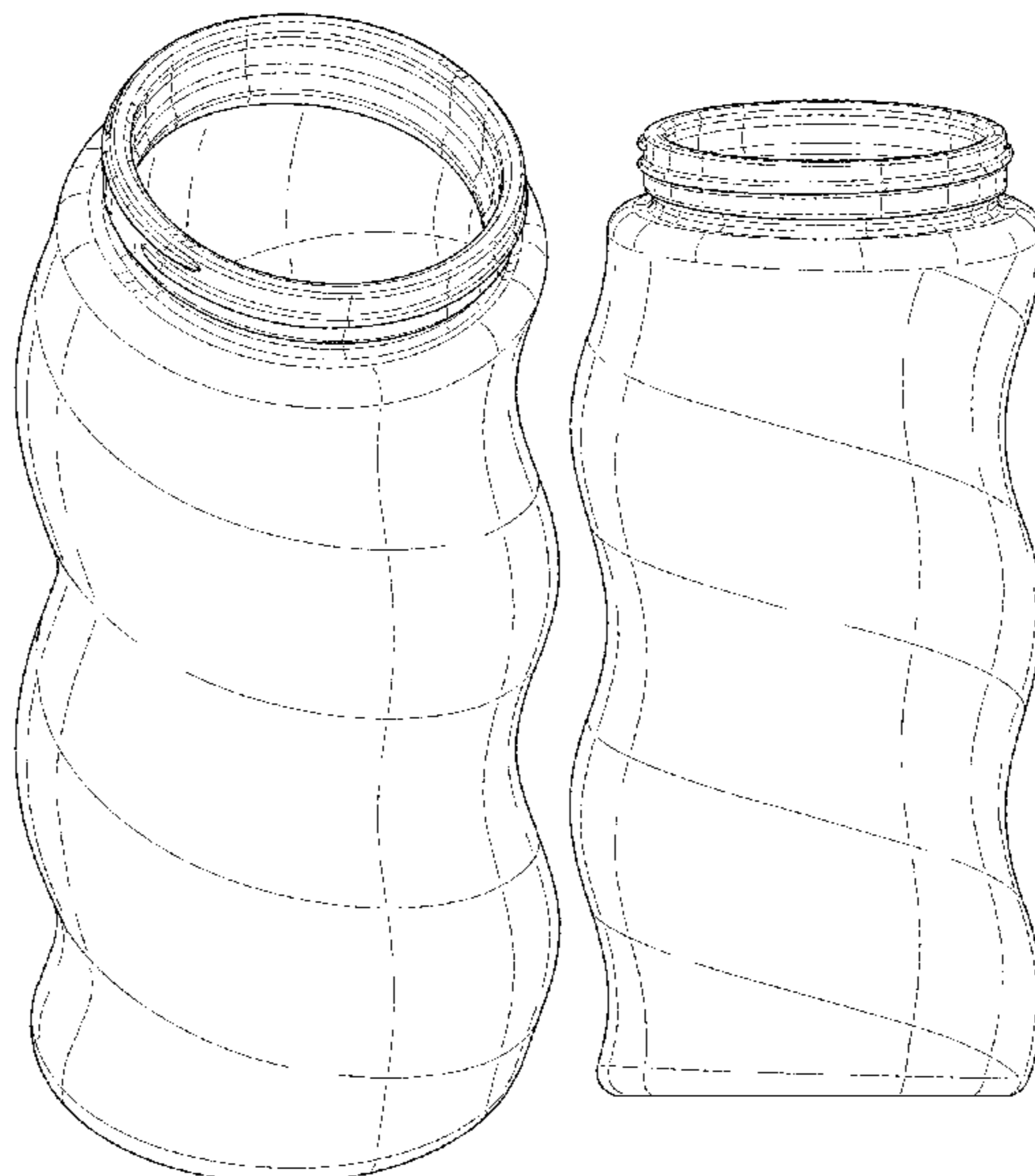
FIG. 1 is a perspective view of a storage container showing our new design;

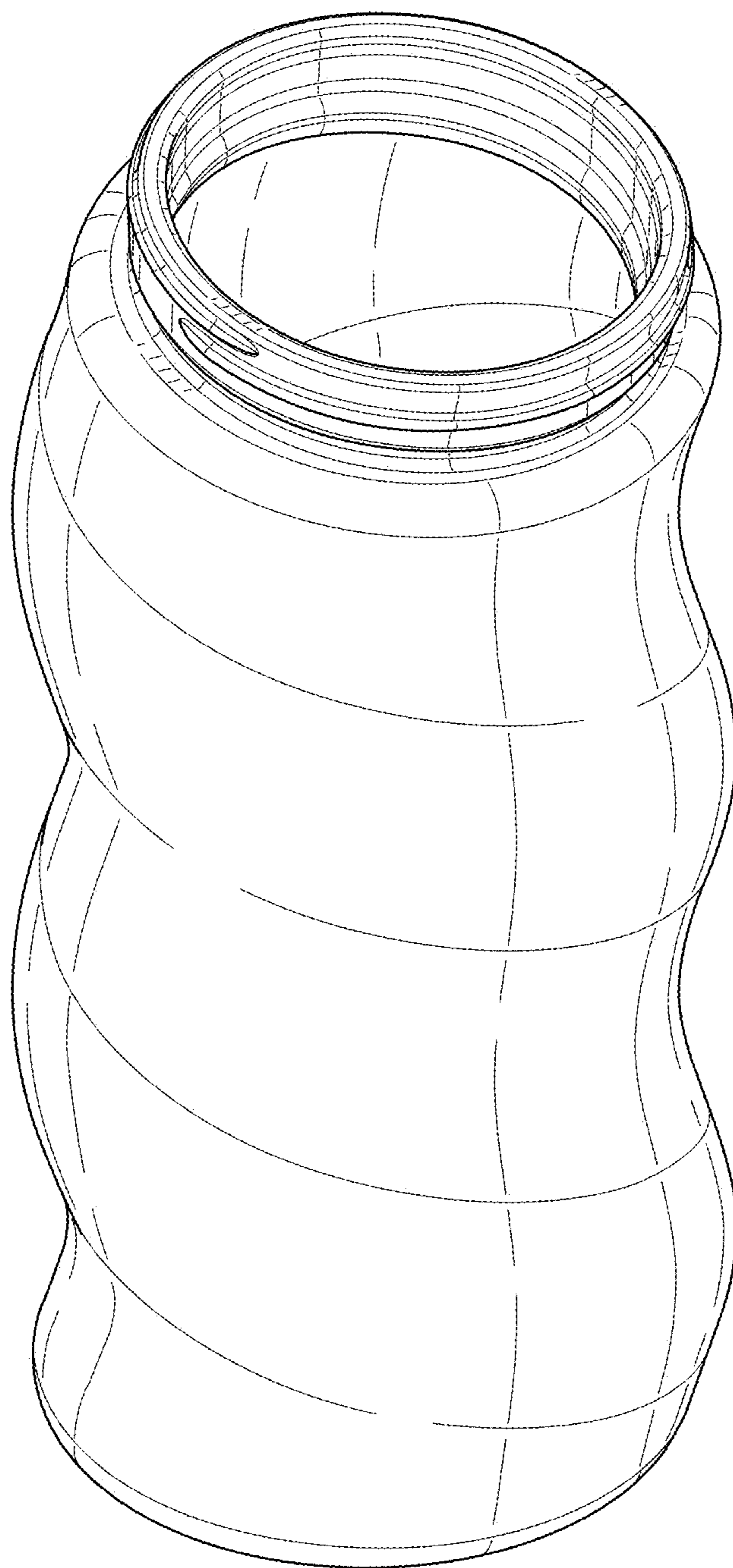

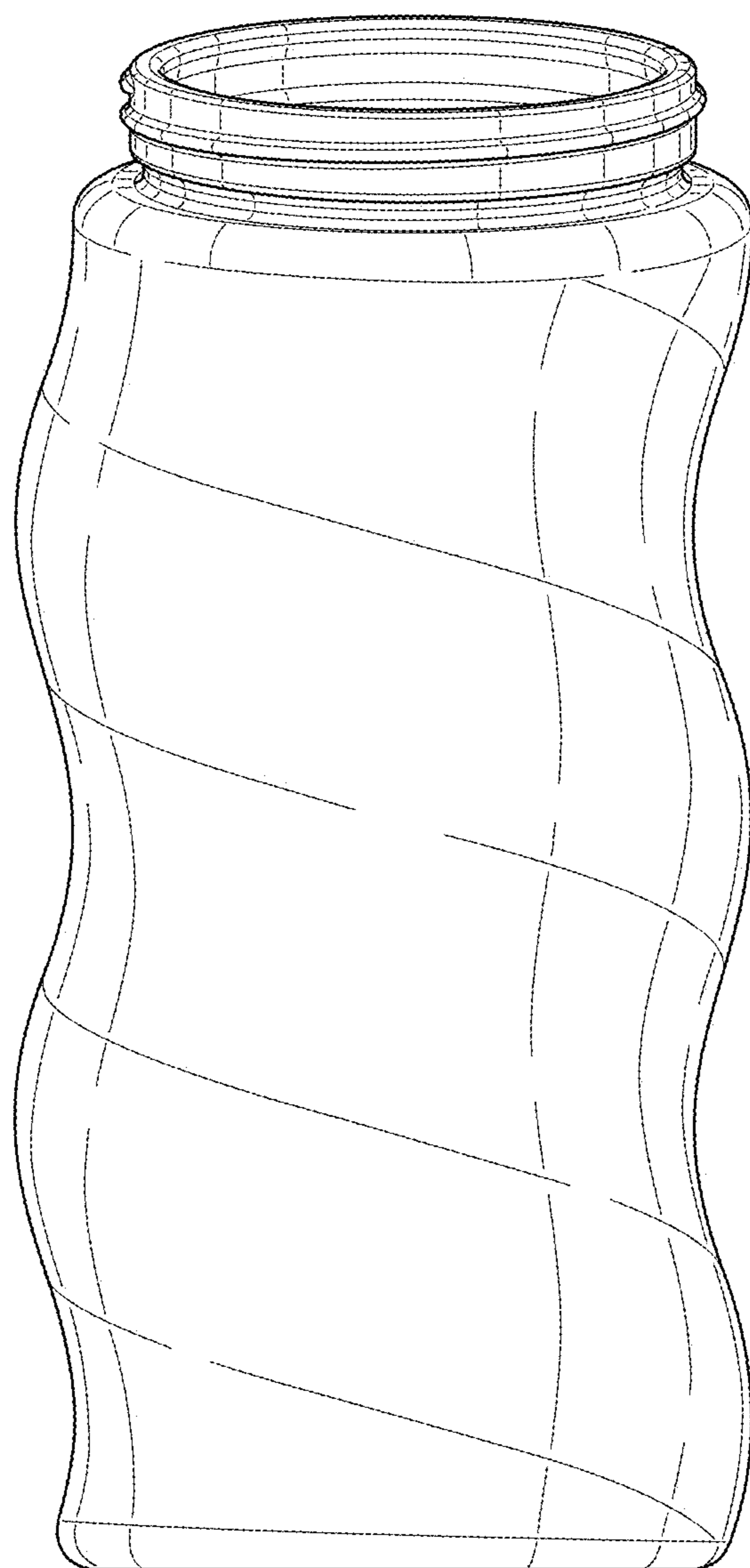

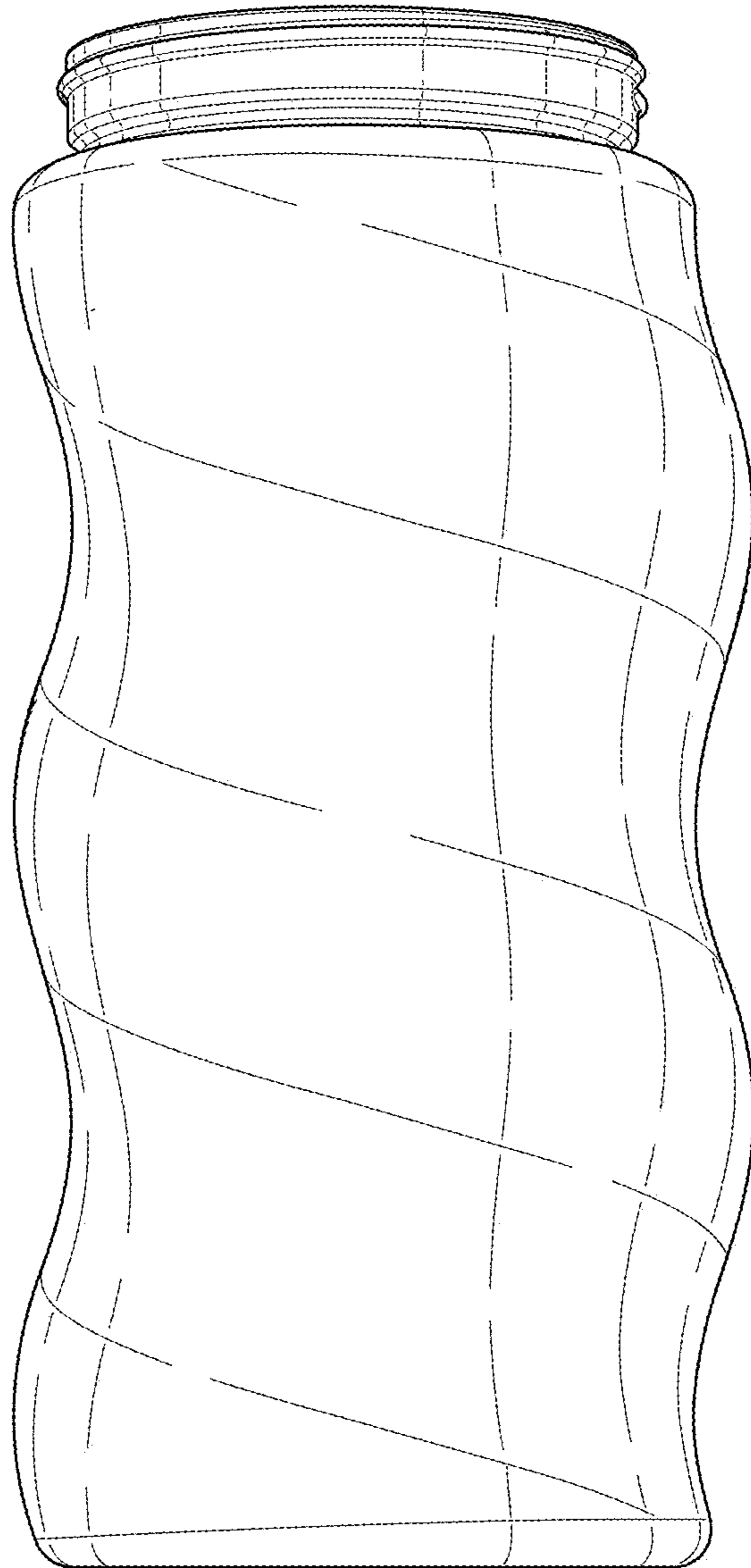

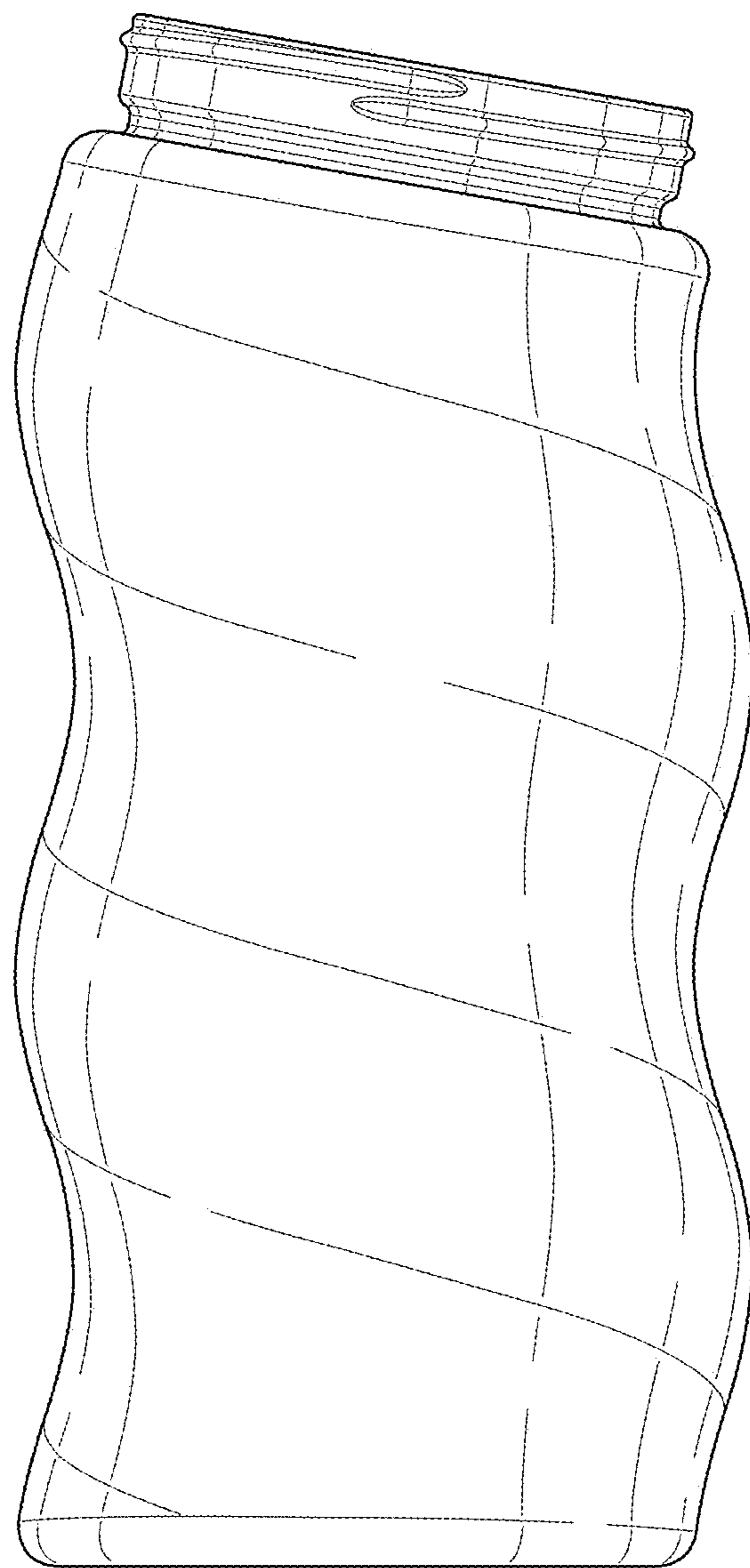

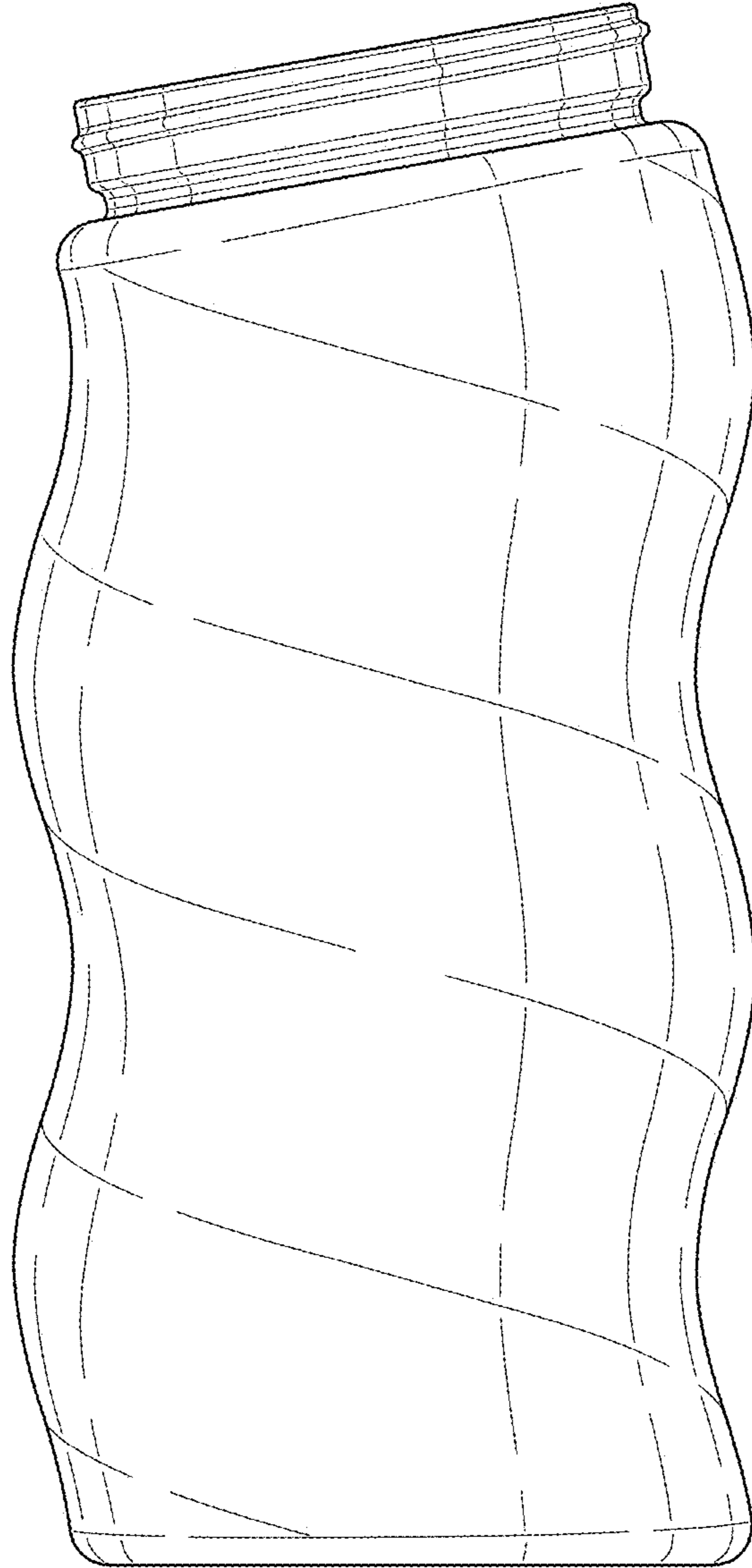

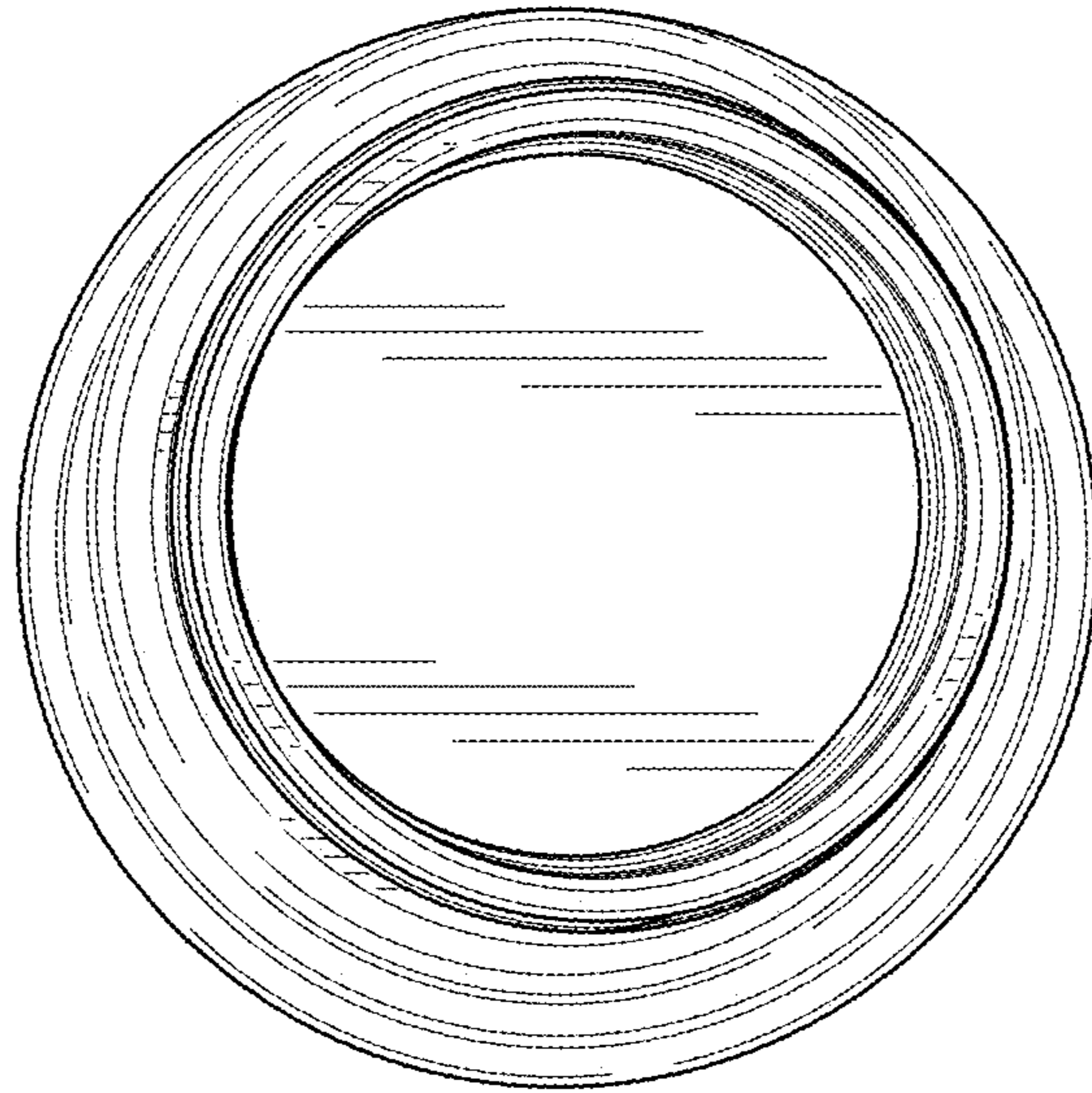

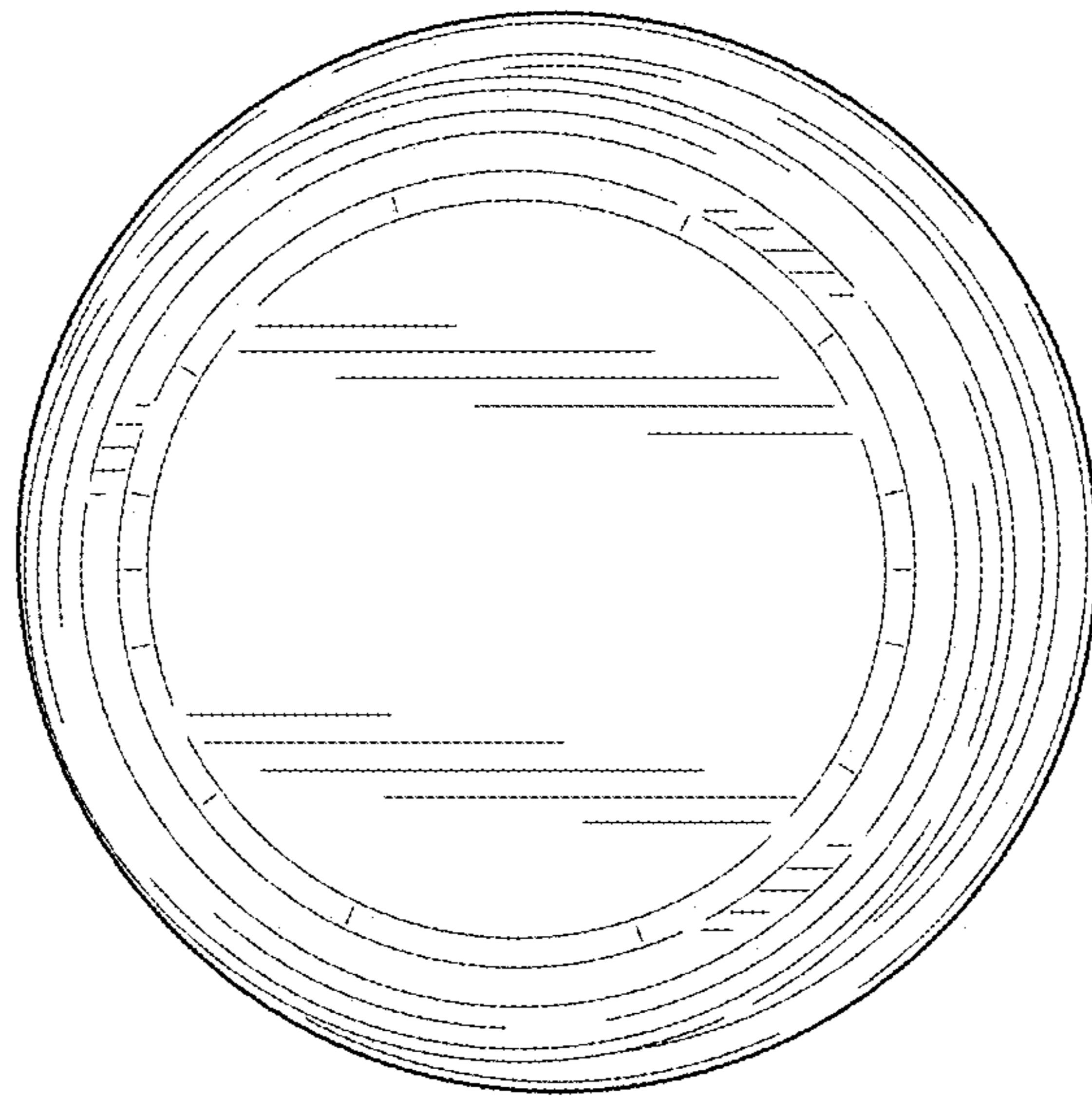
