FIG. 30 is an a front and left elevation view thereof;

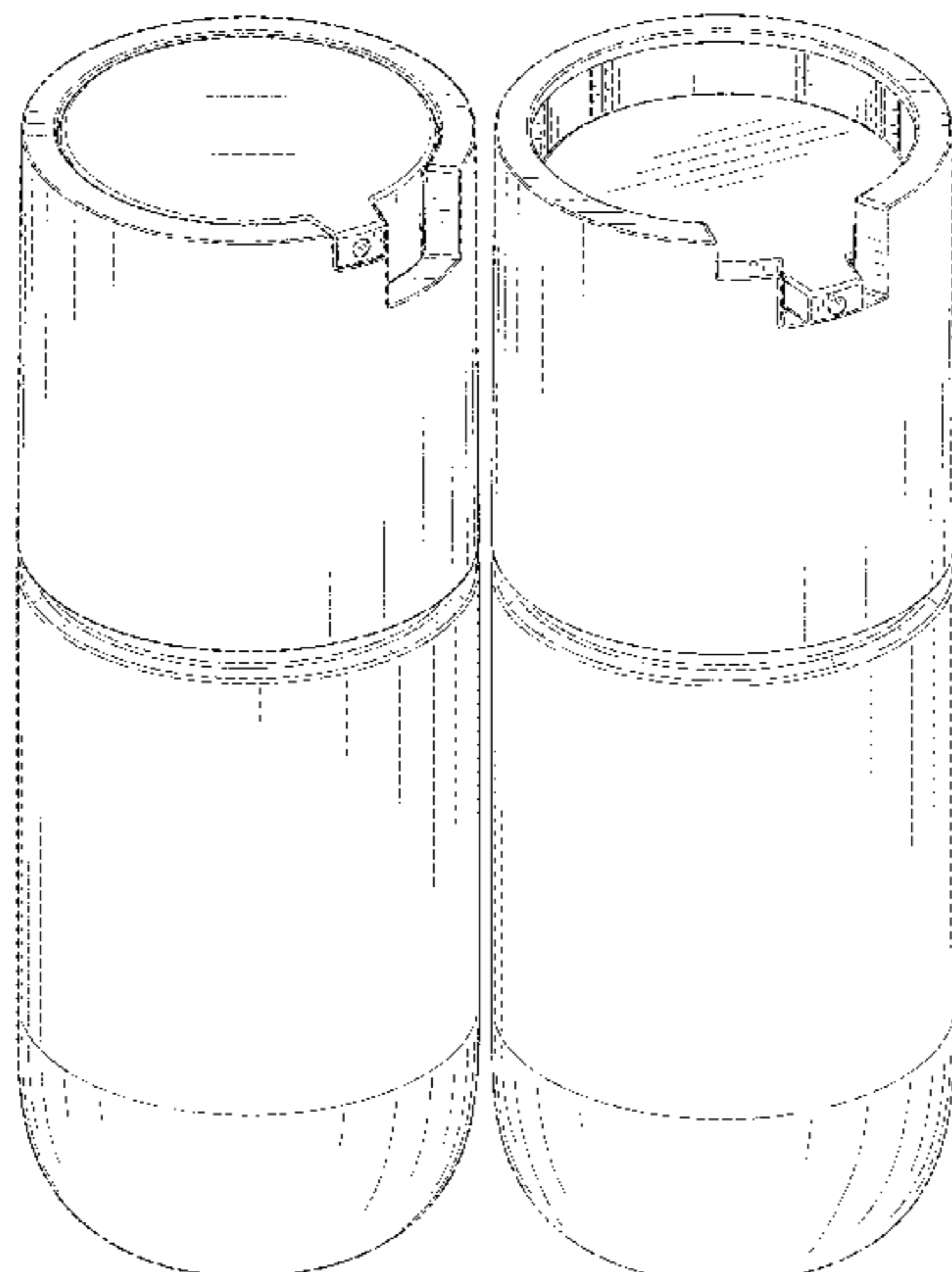
FIG. 31 is a right side view thereof;

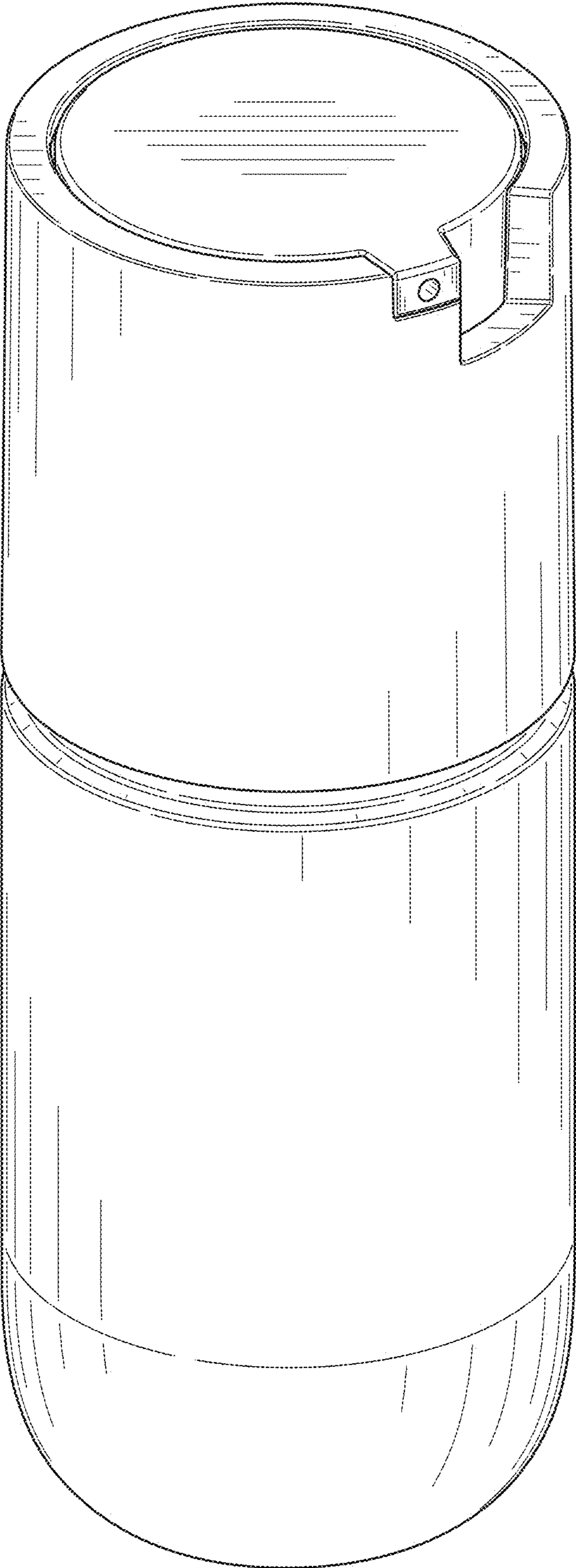

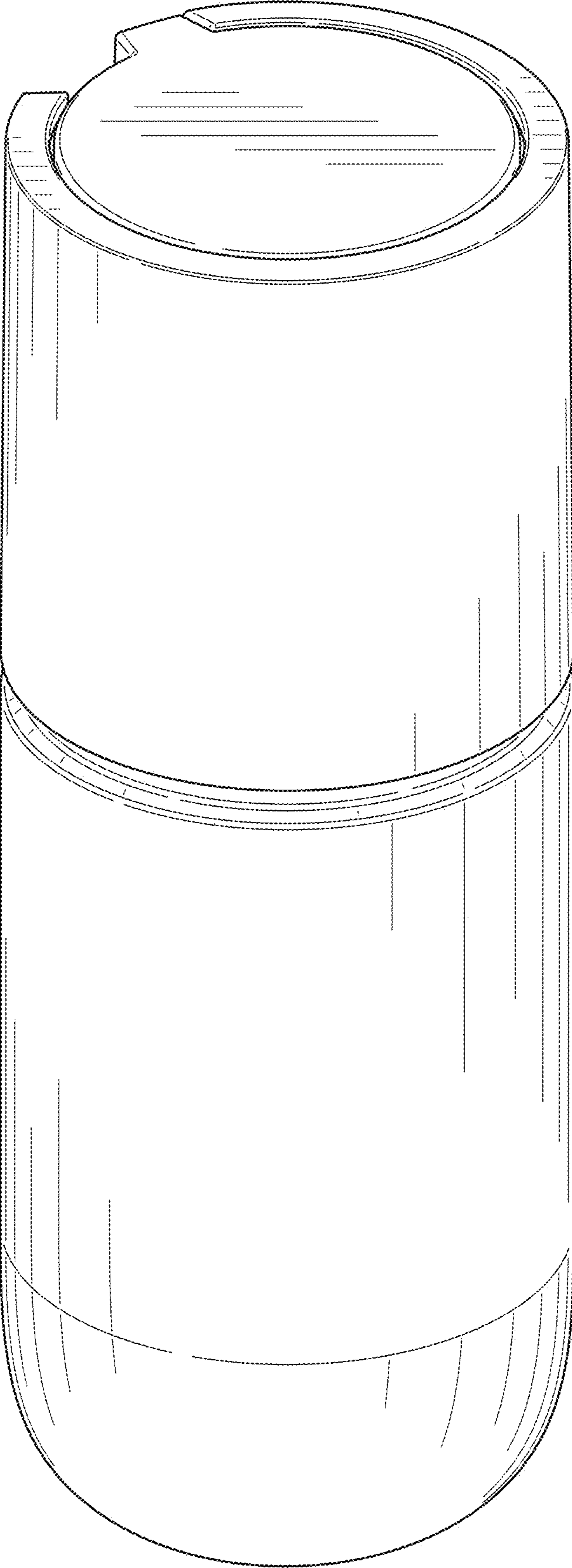

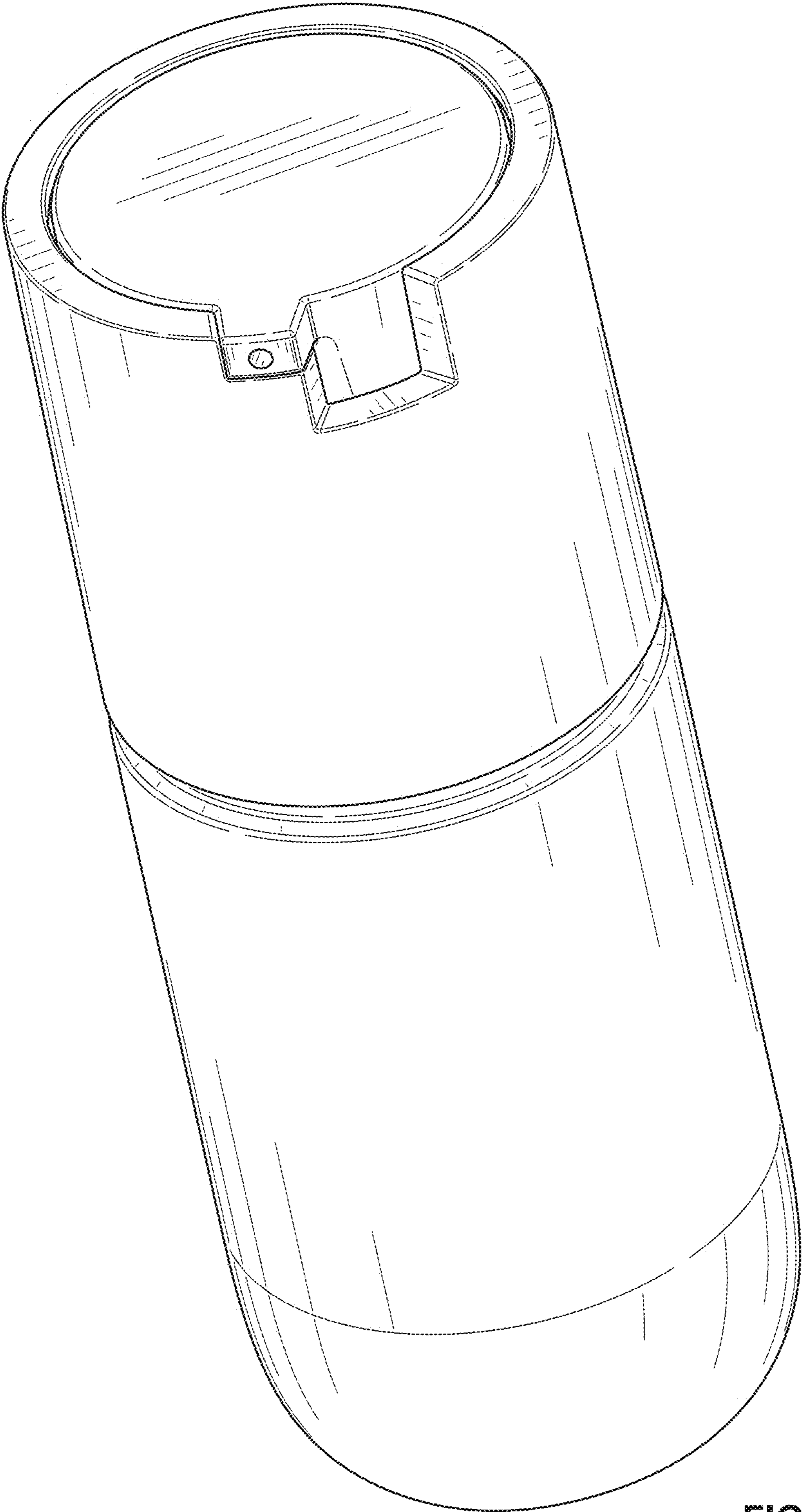

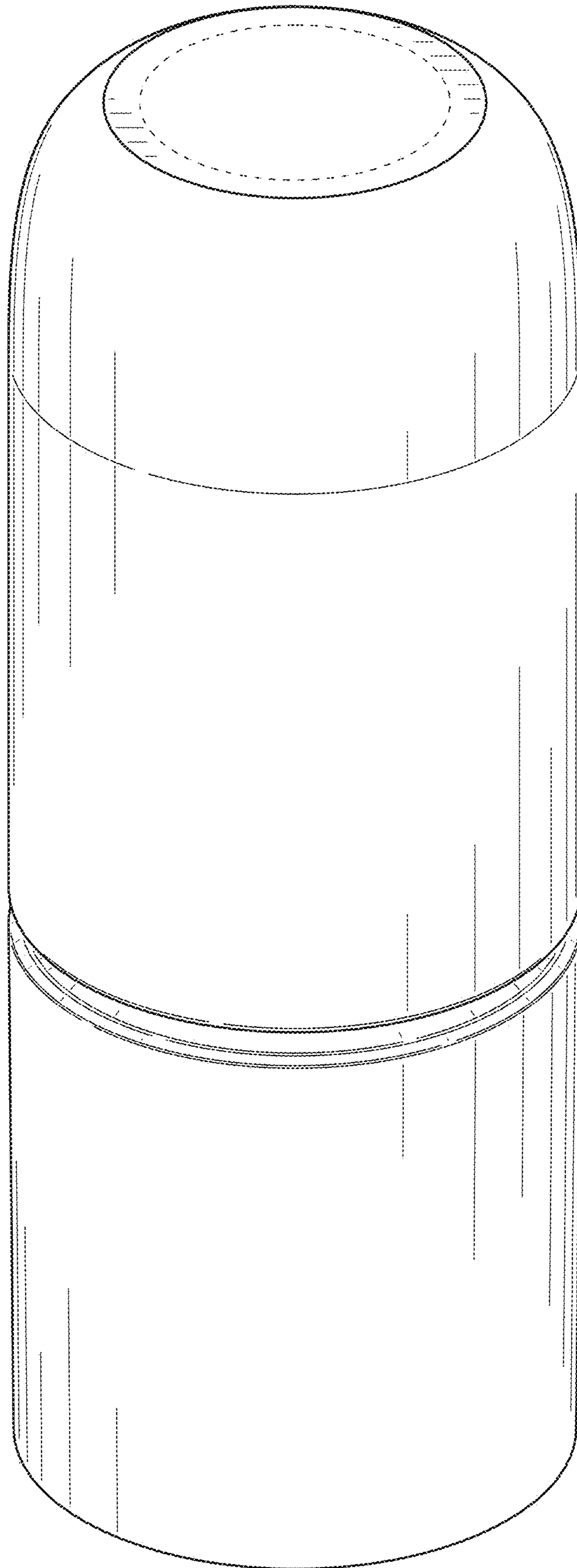

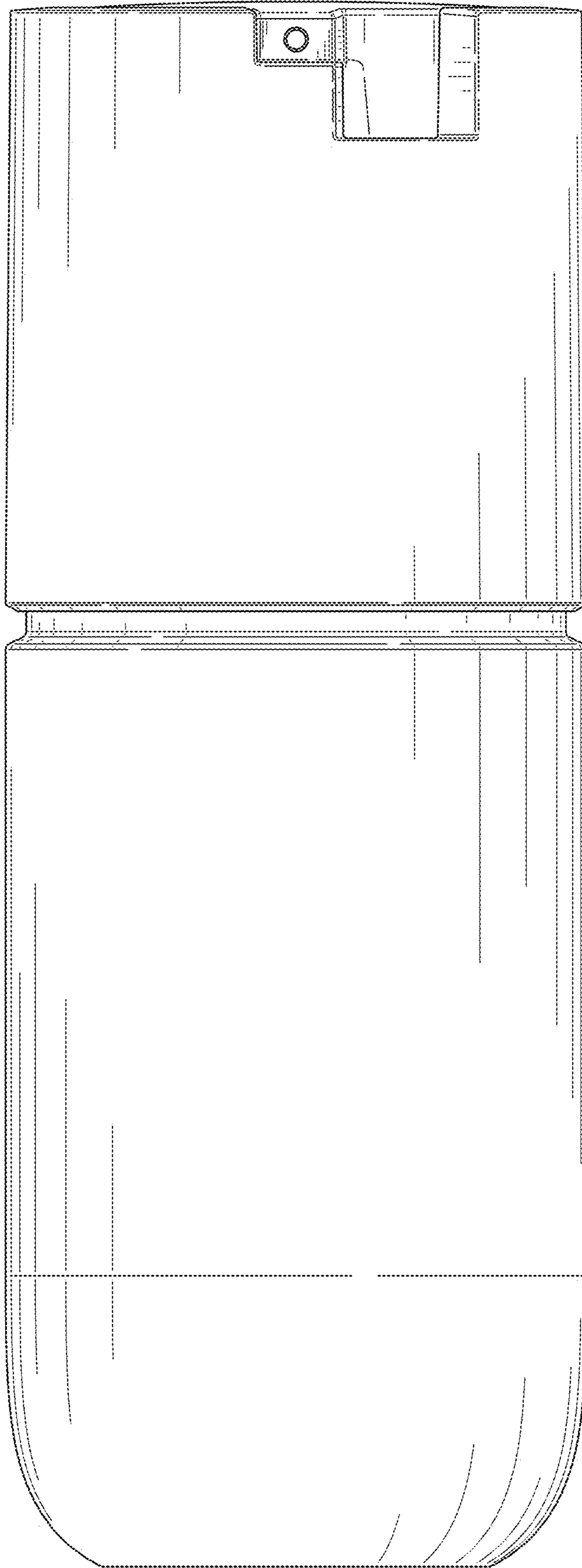

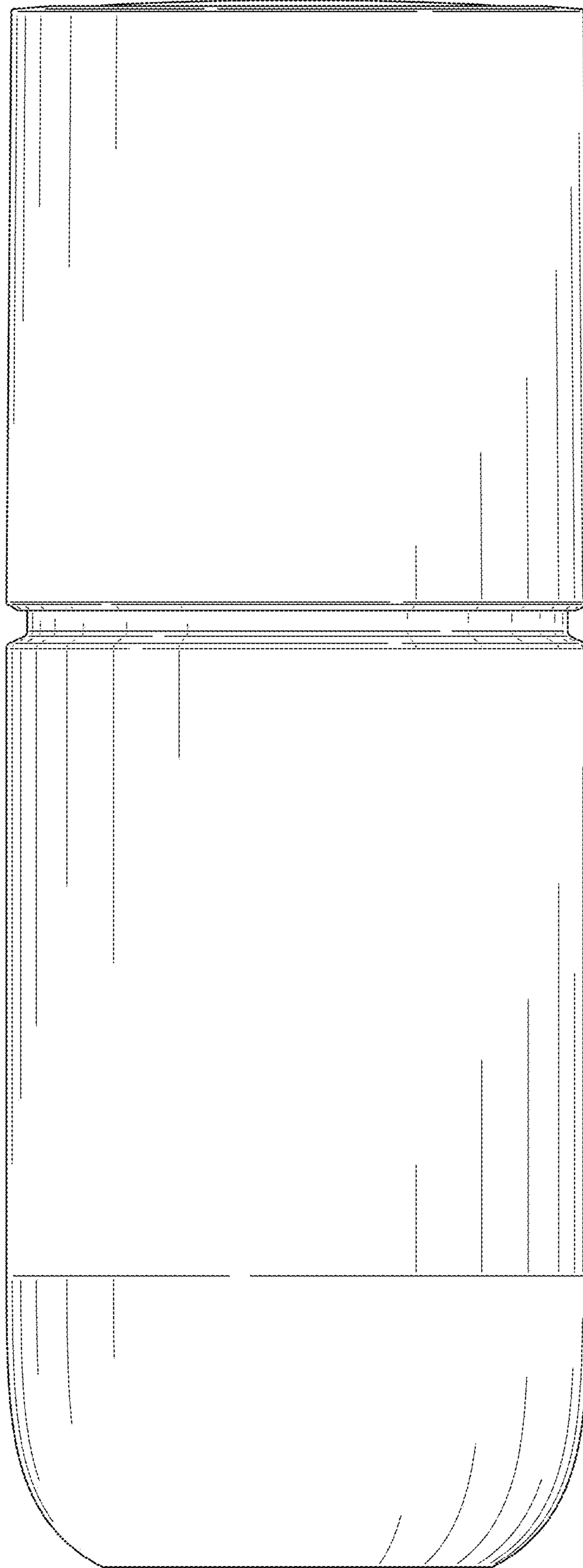

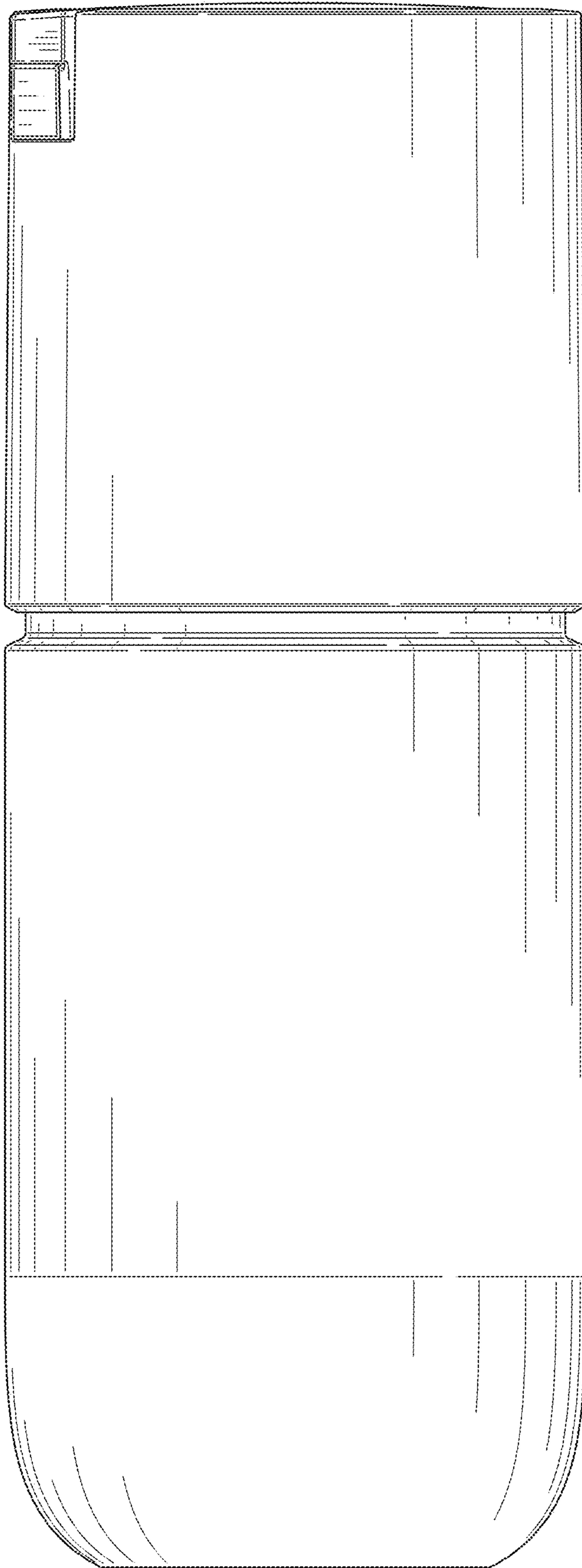

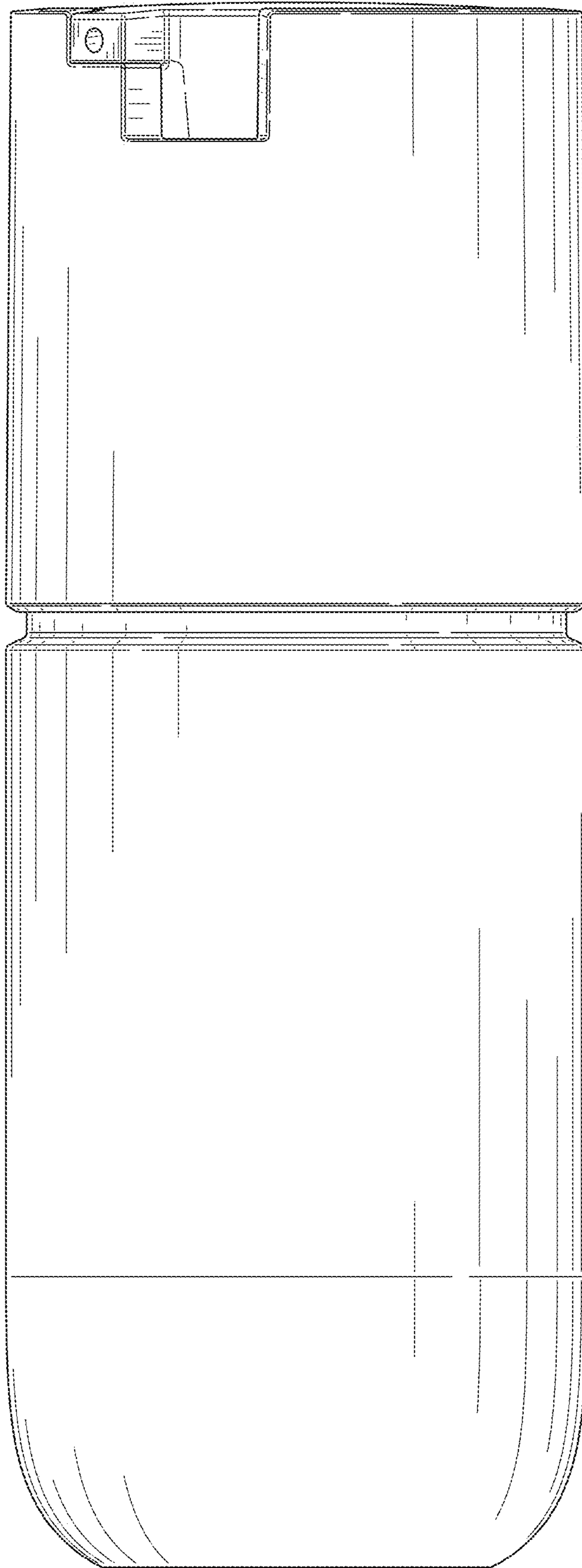

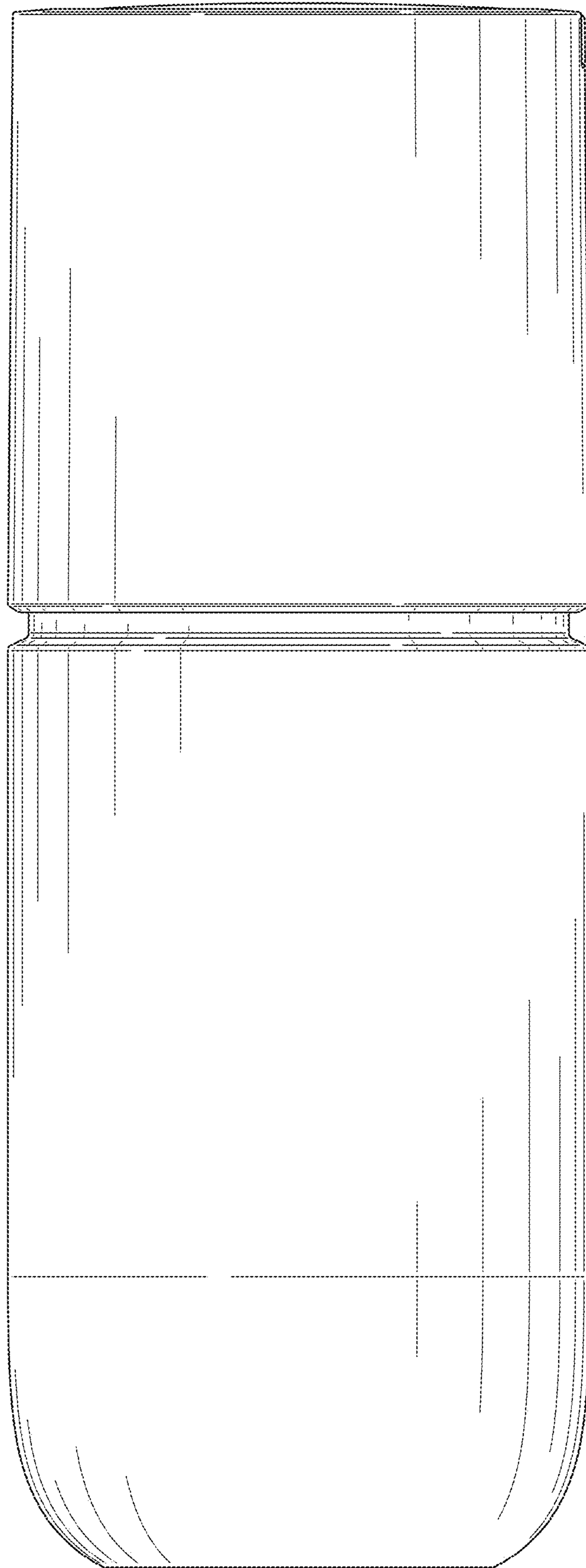

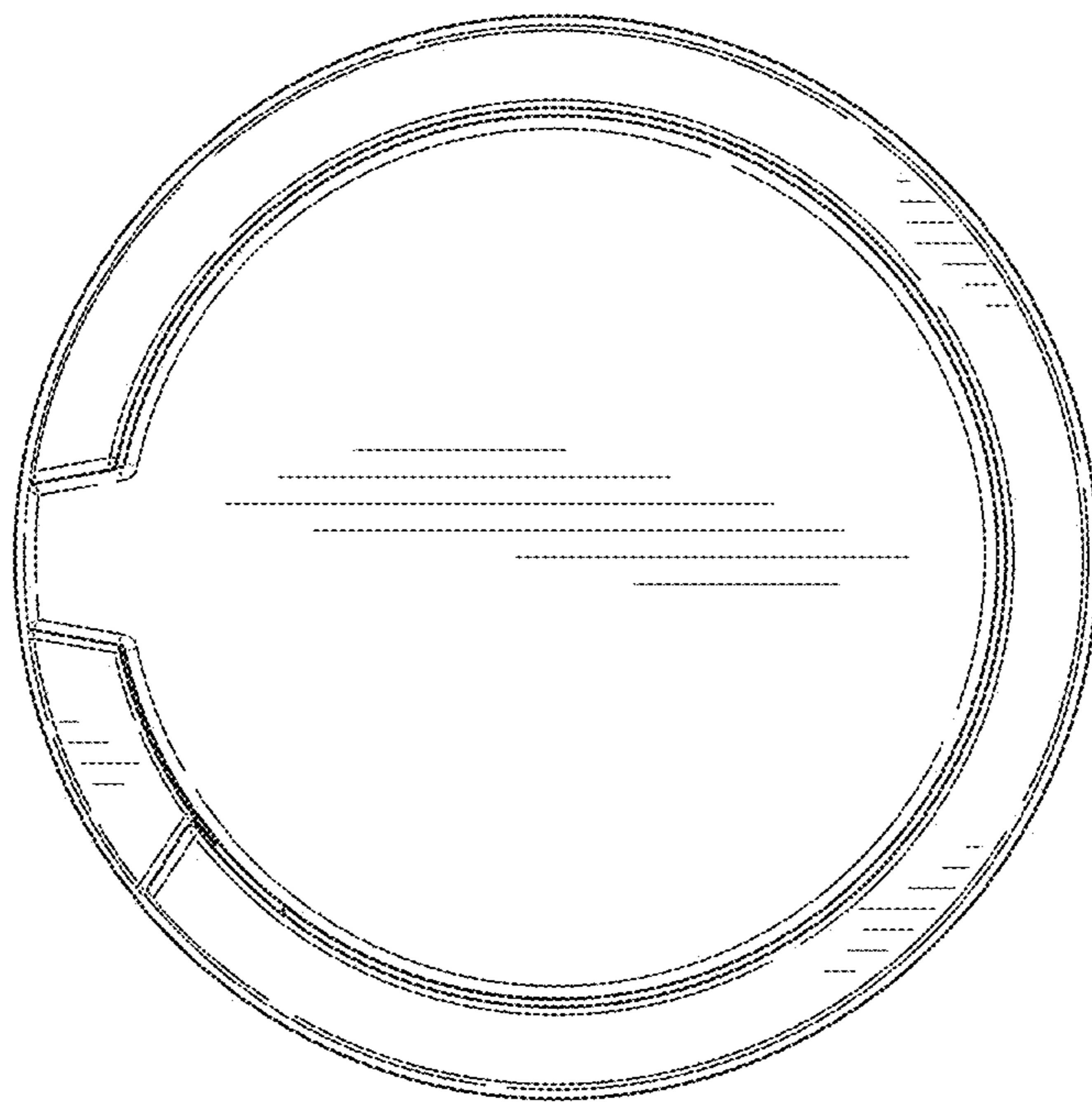

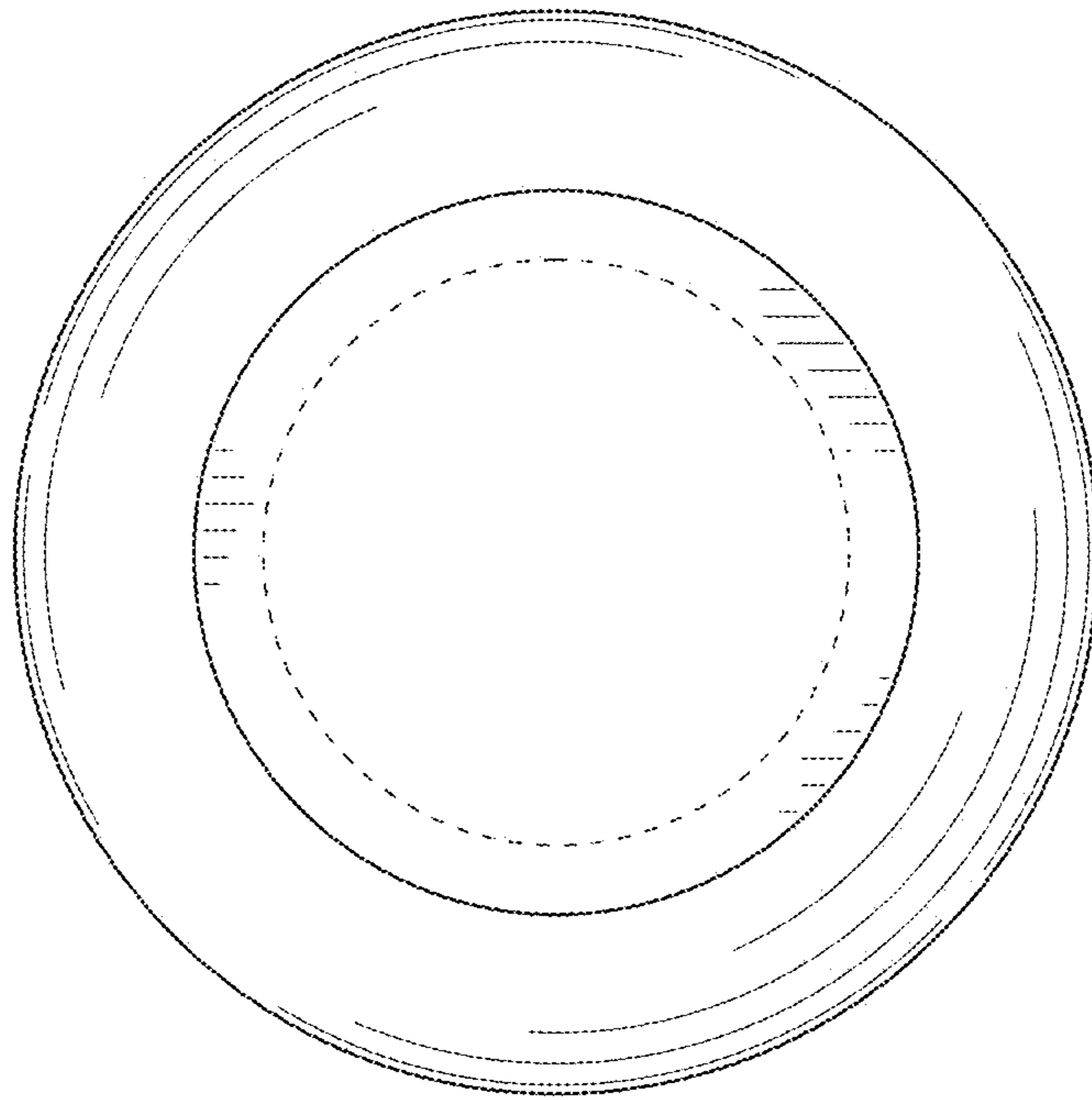

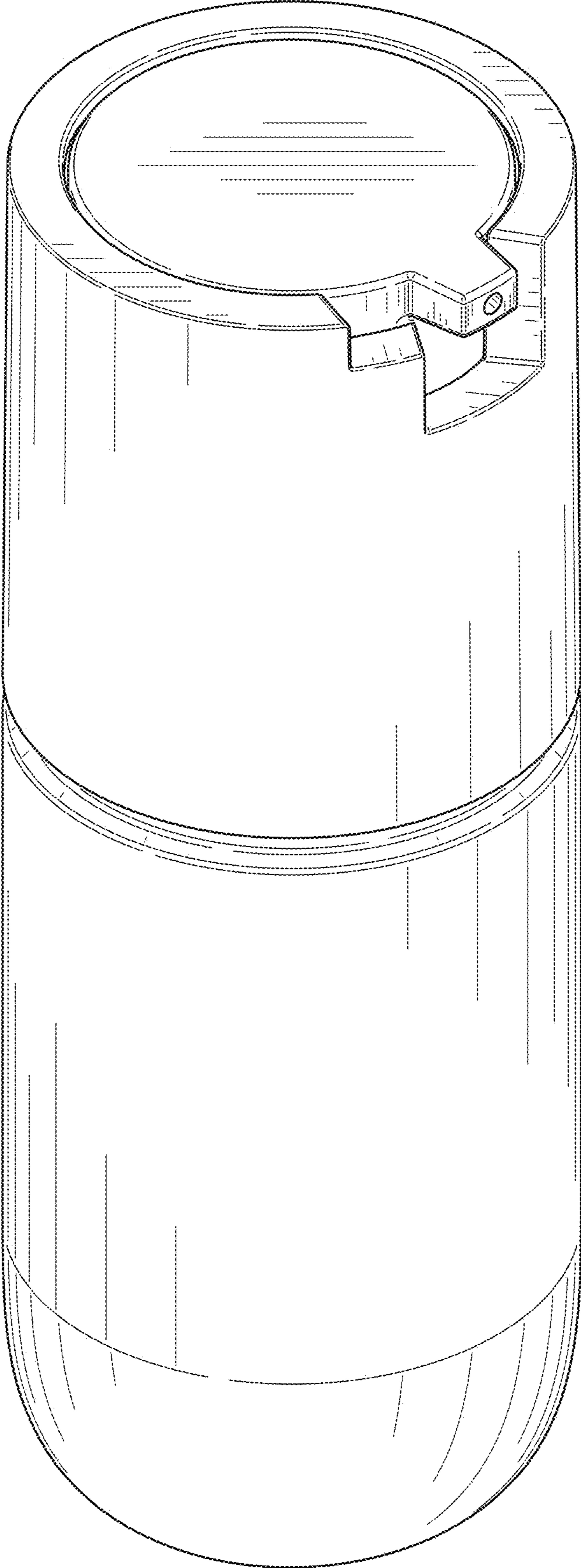

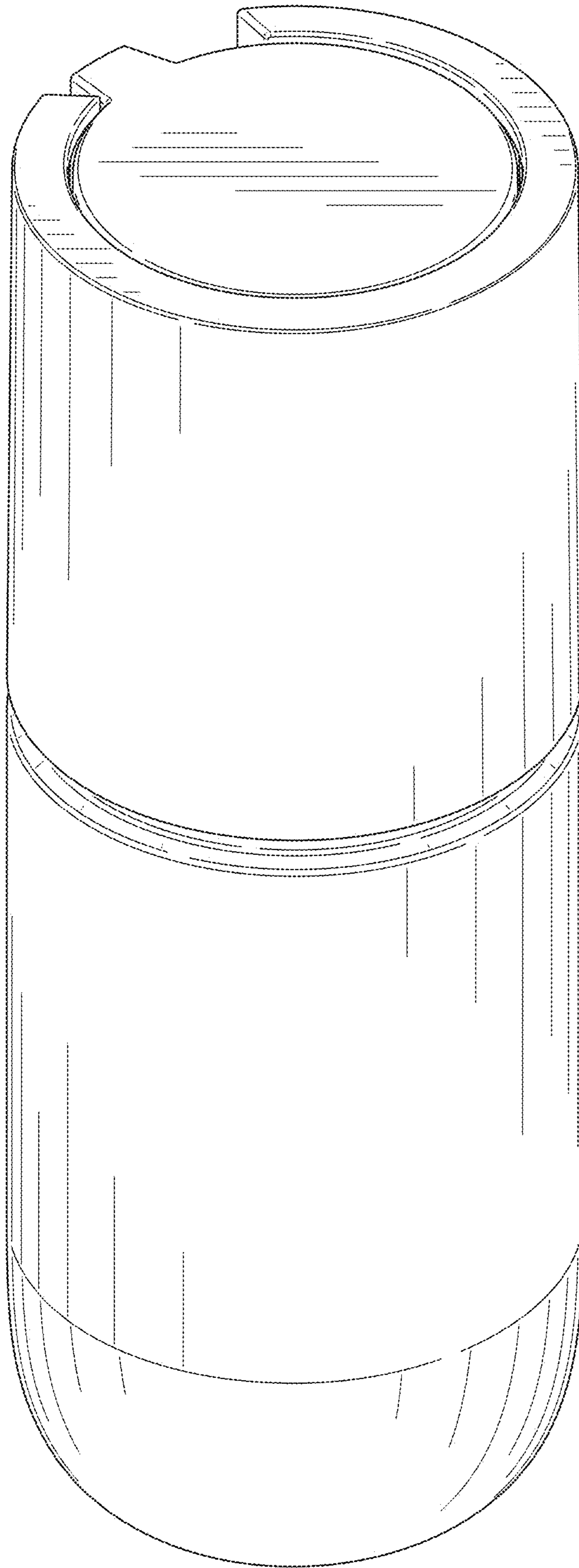

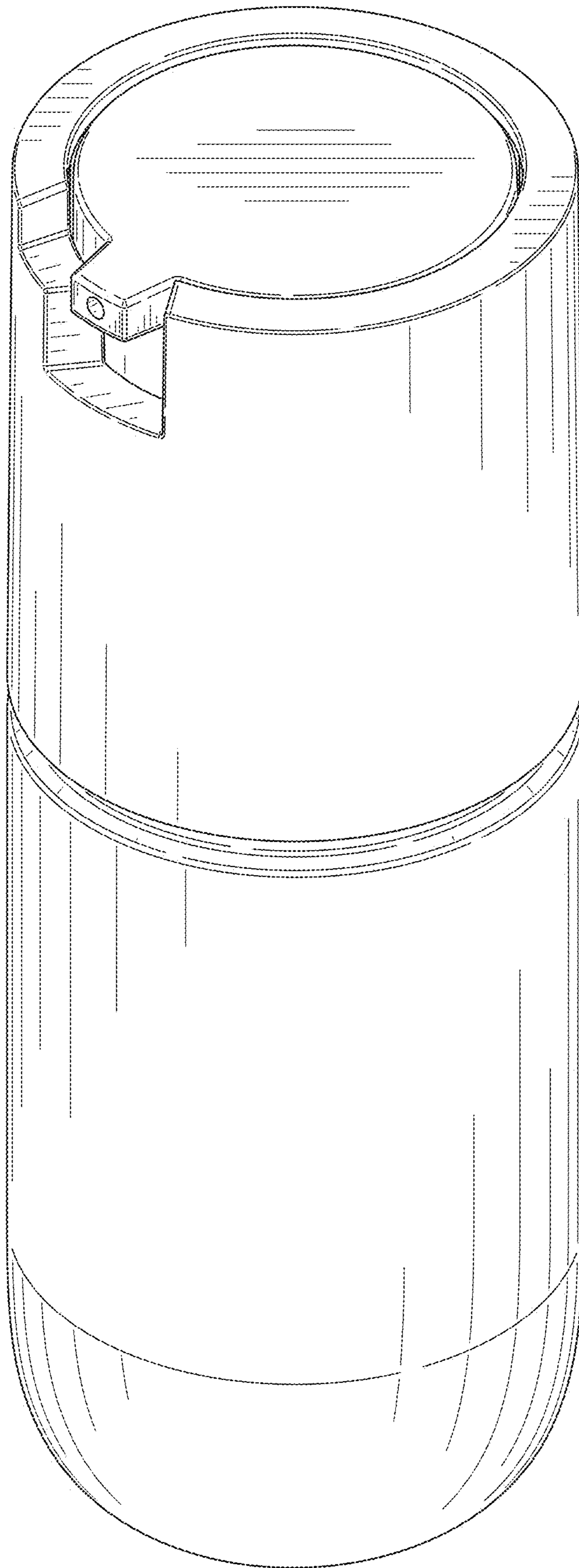

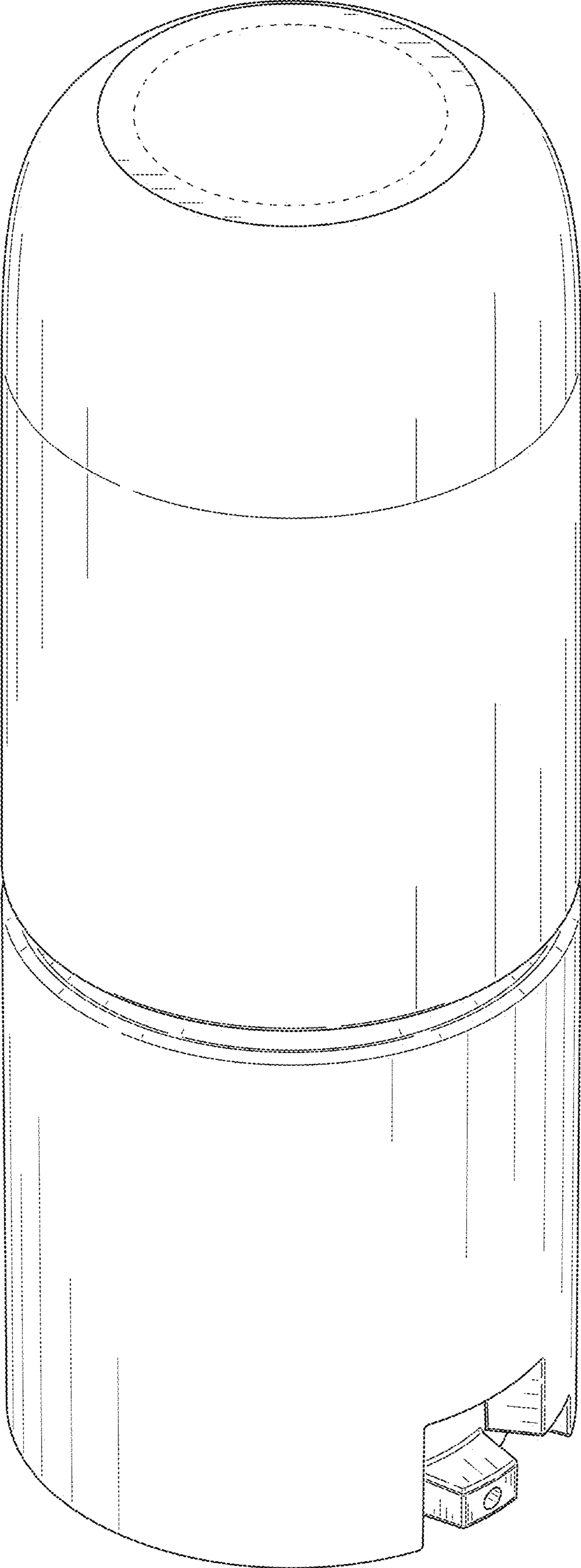

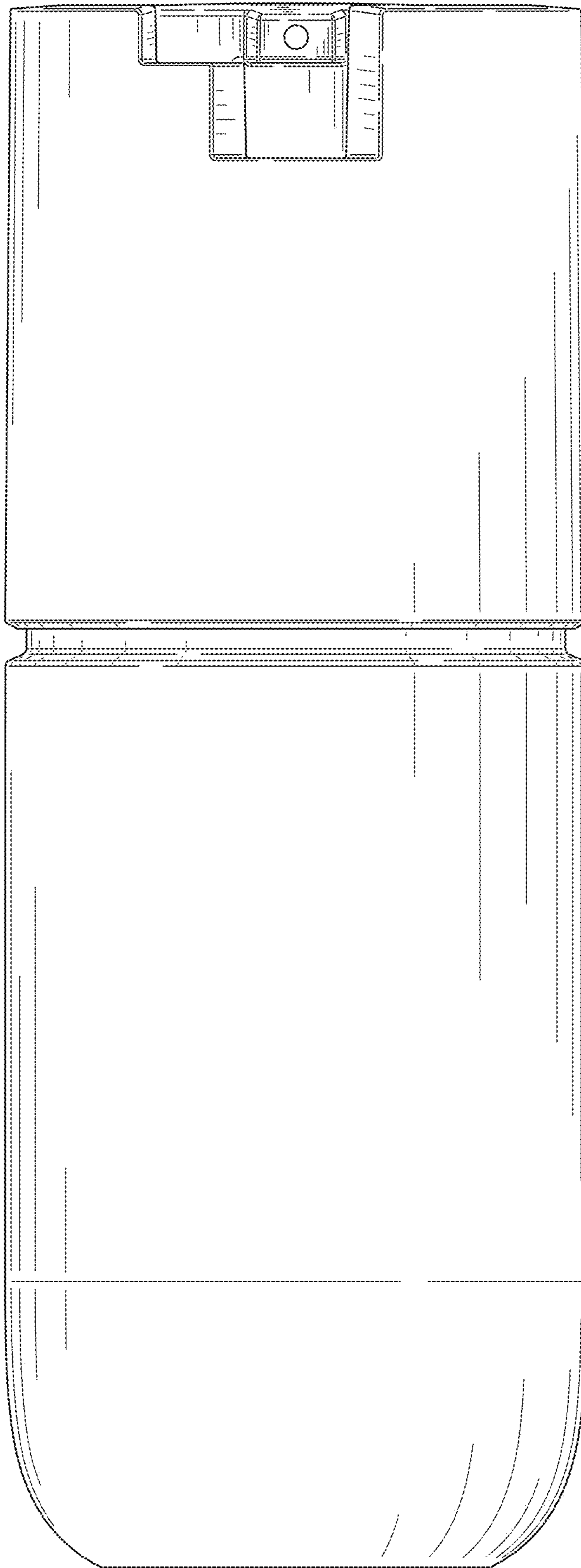

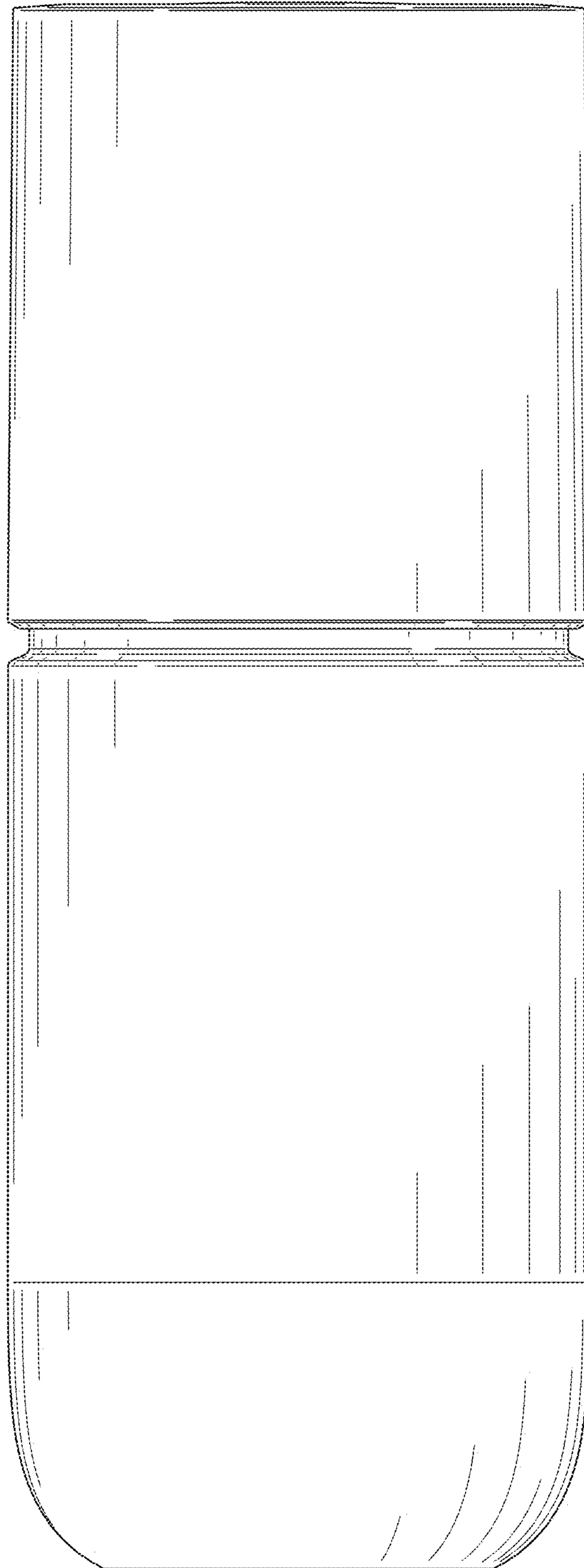

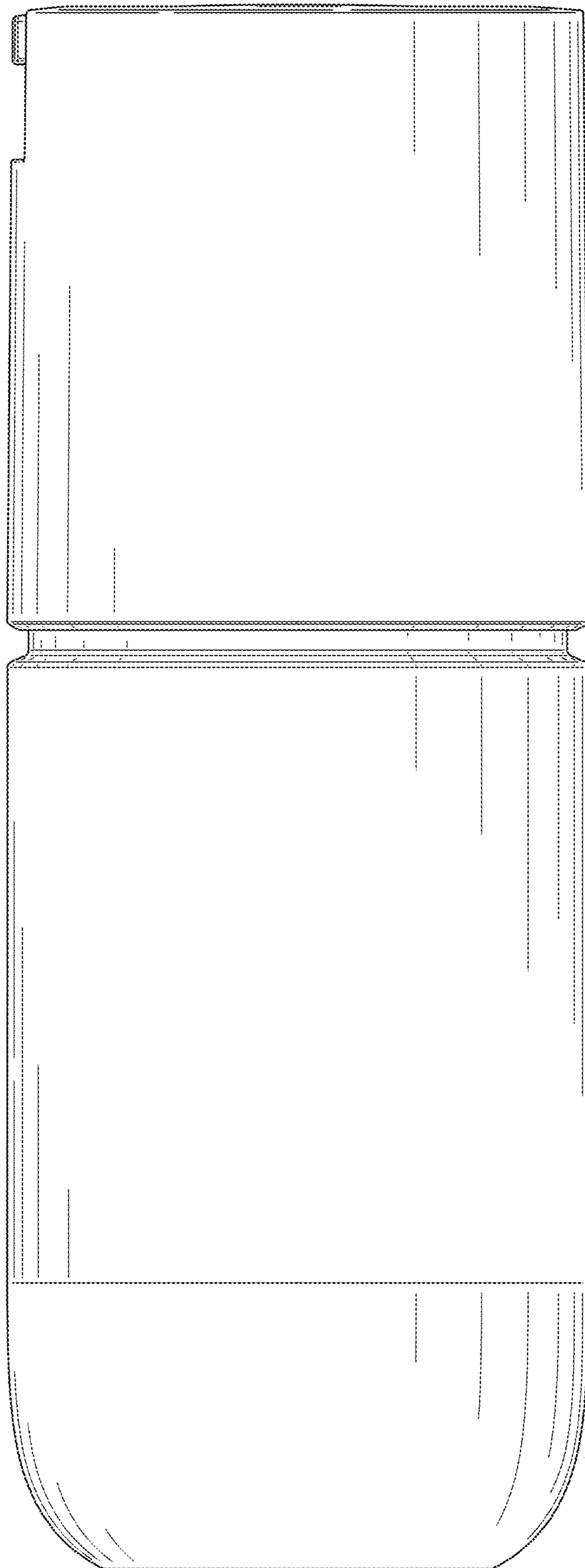

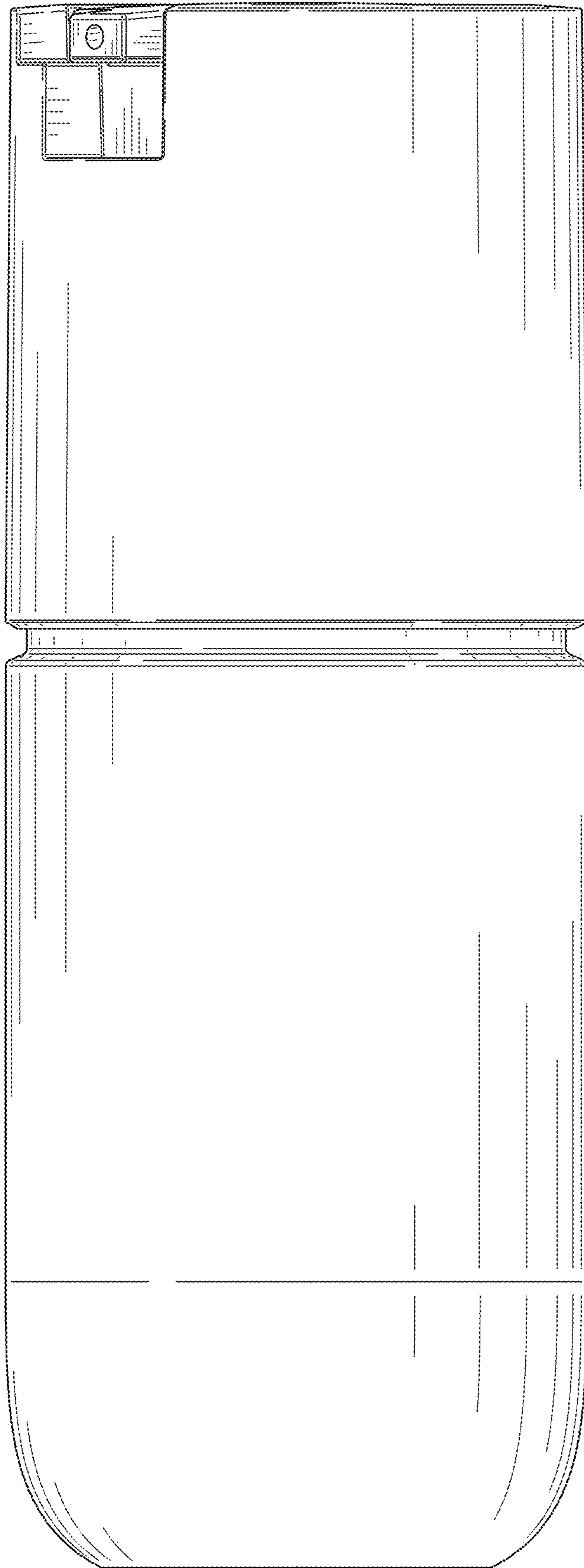

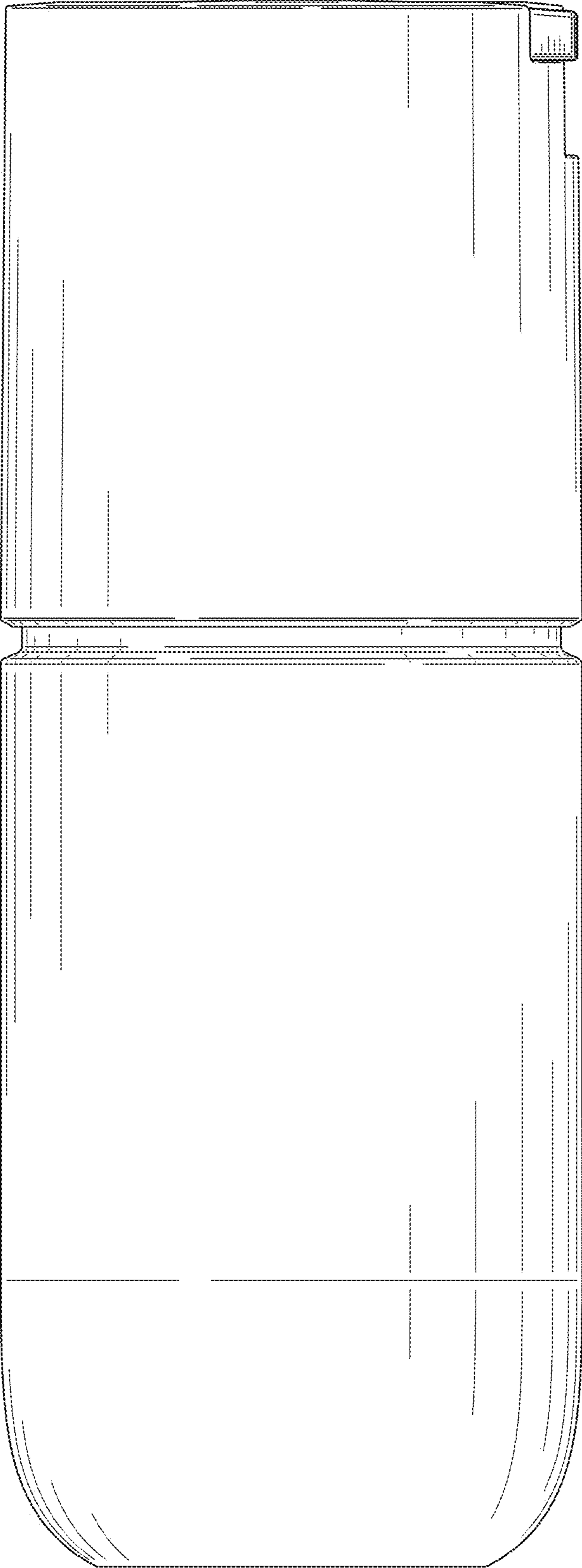

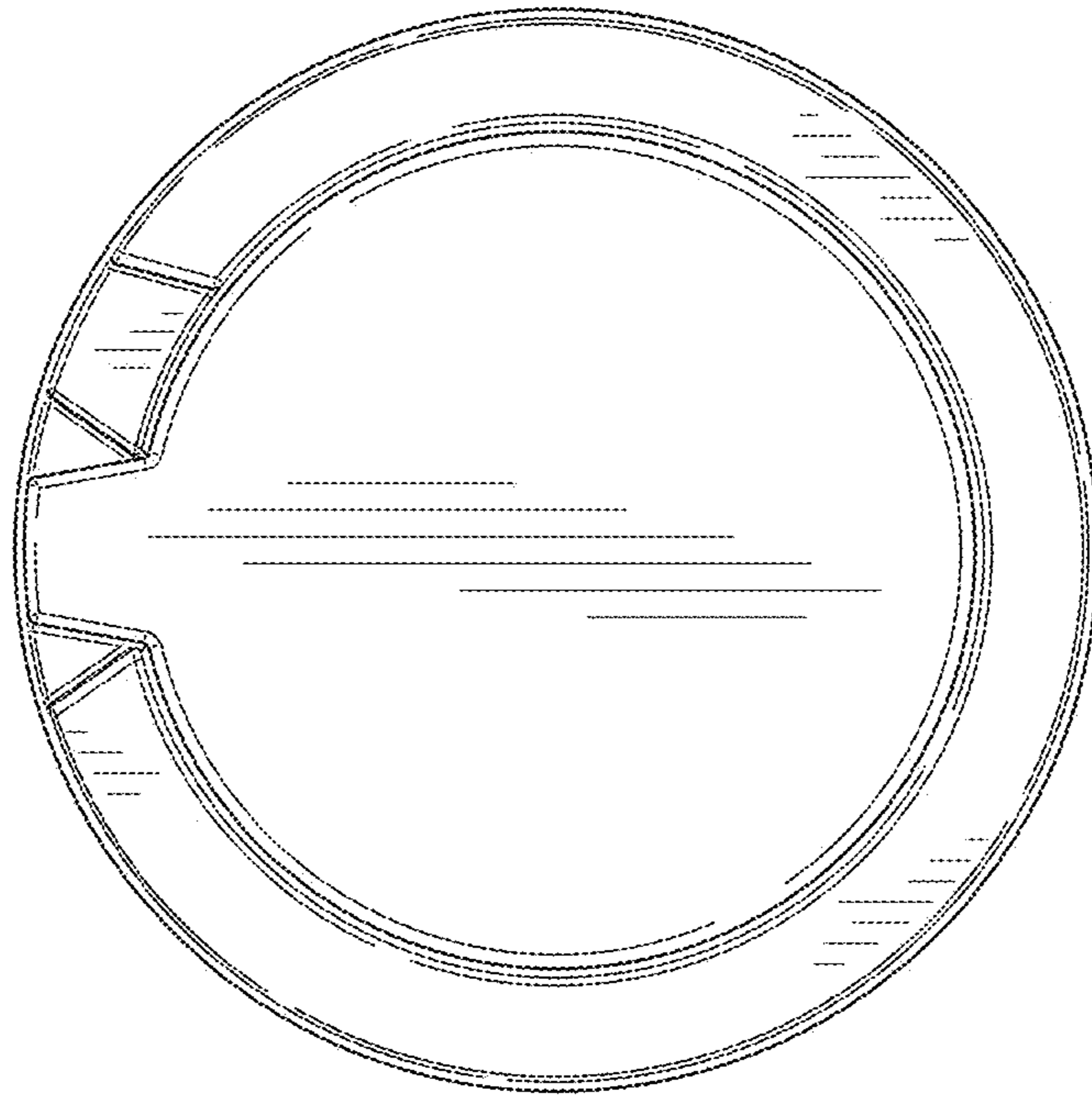

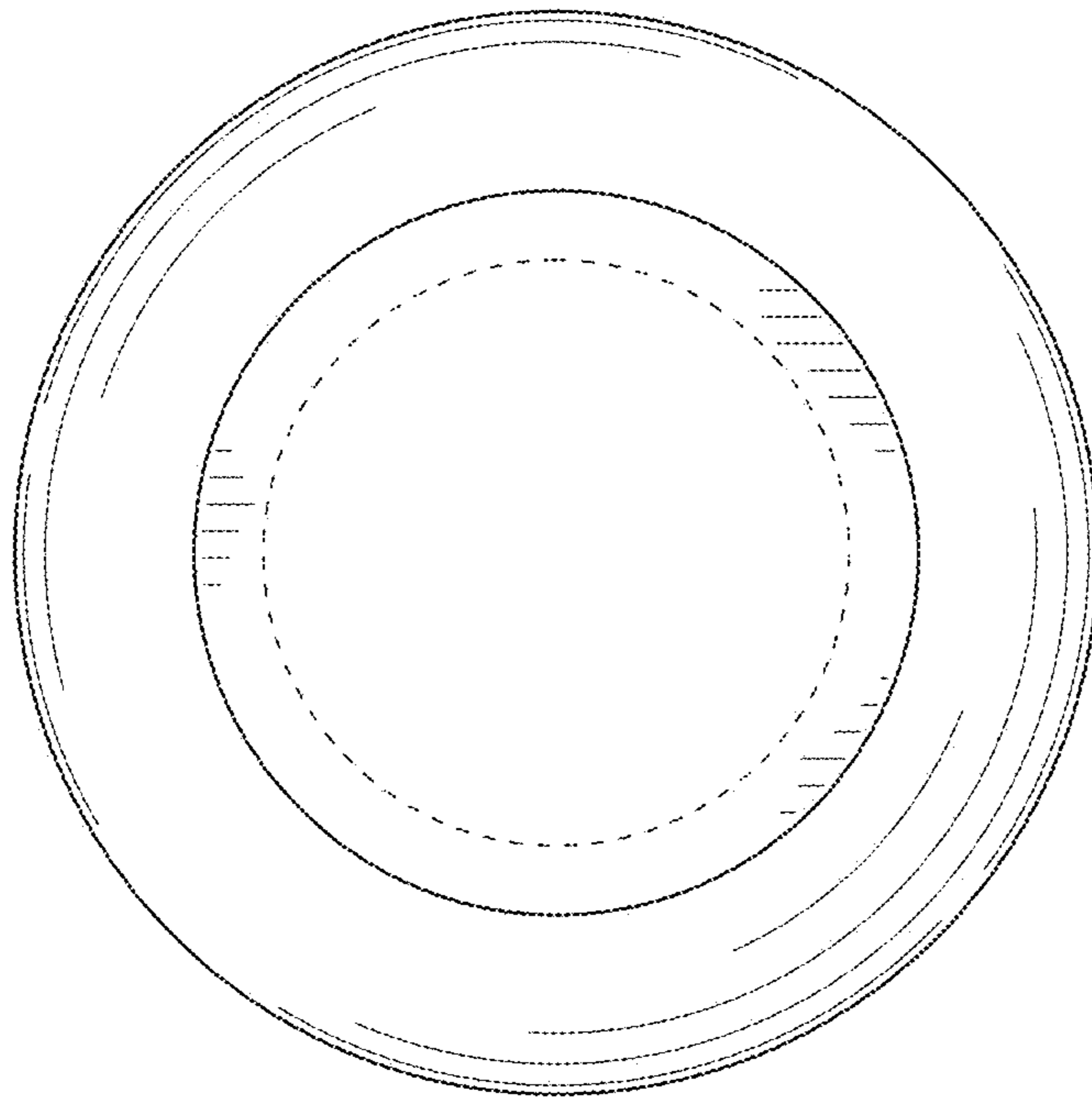

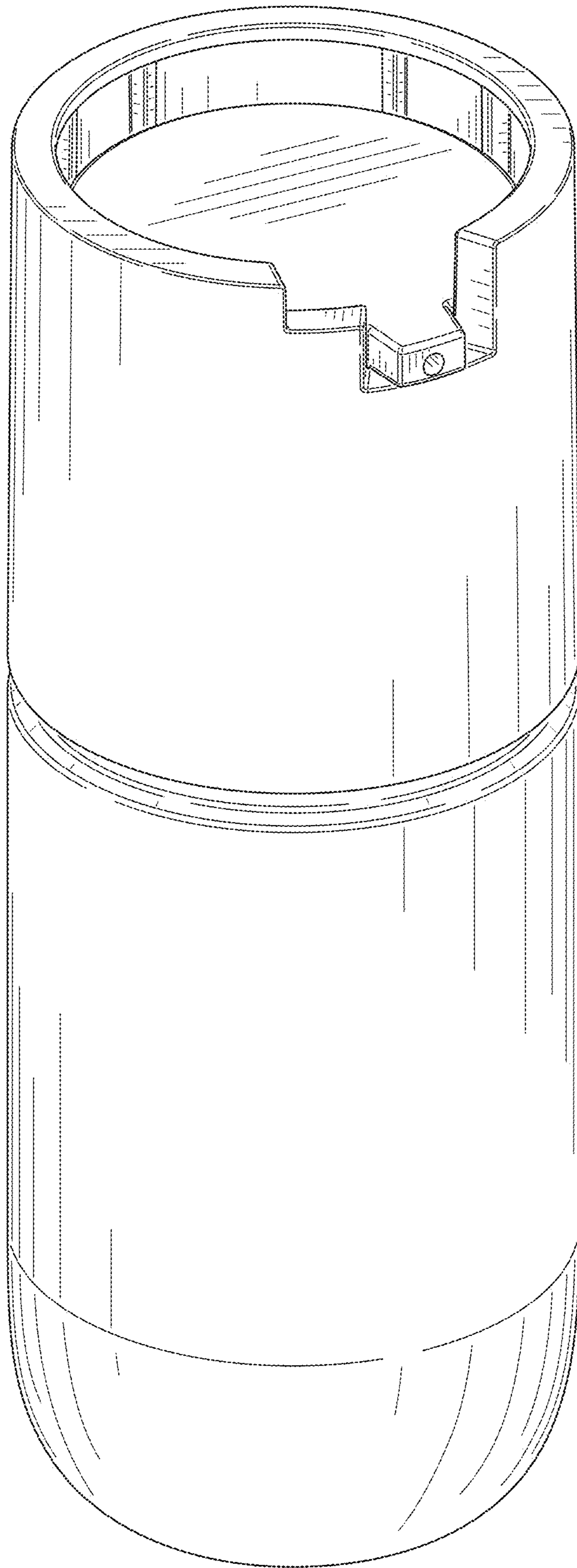

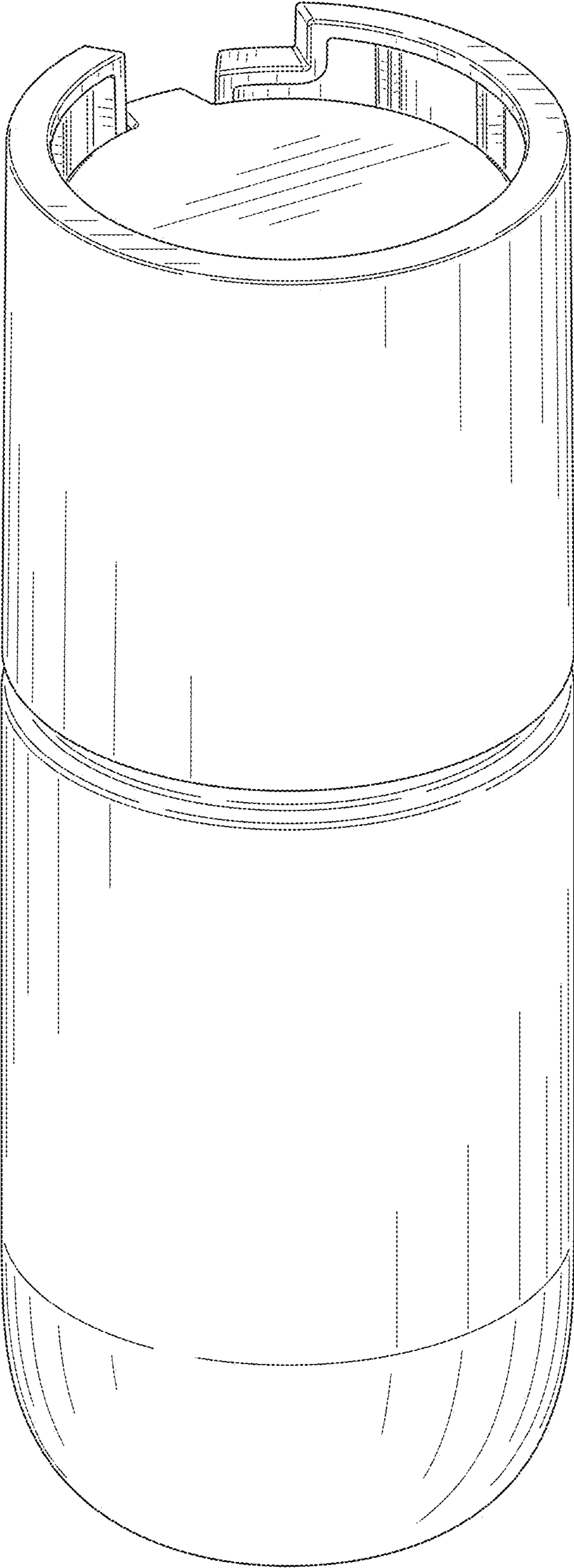

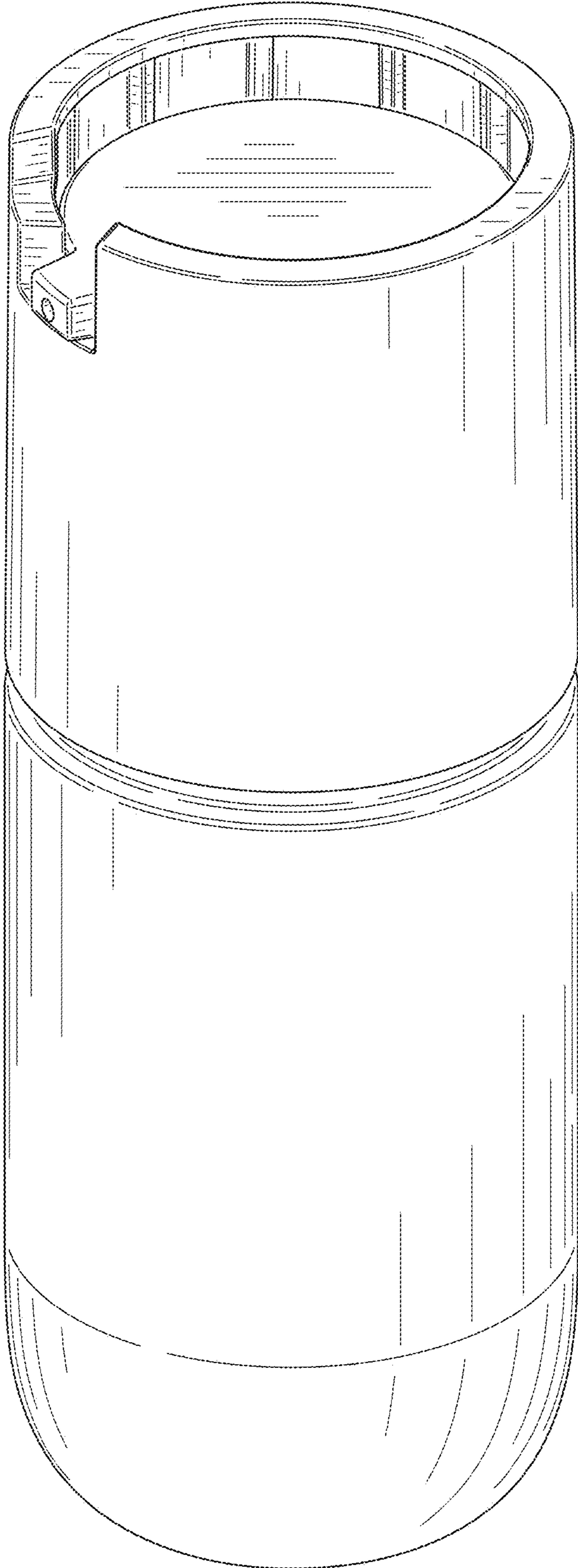

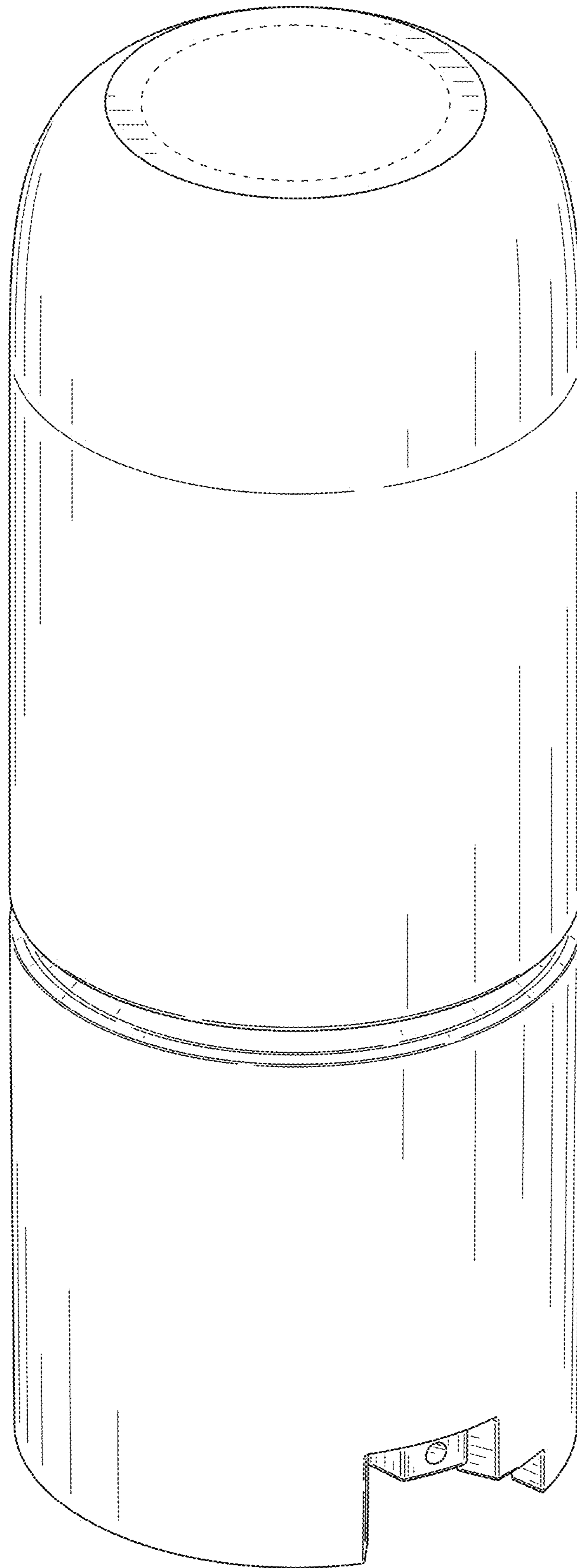

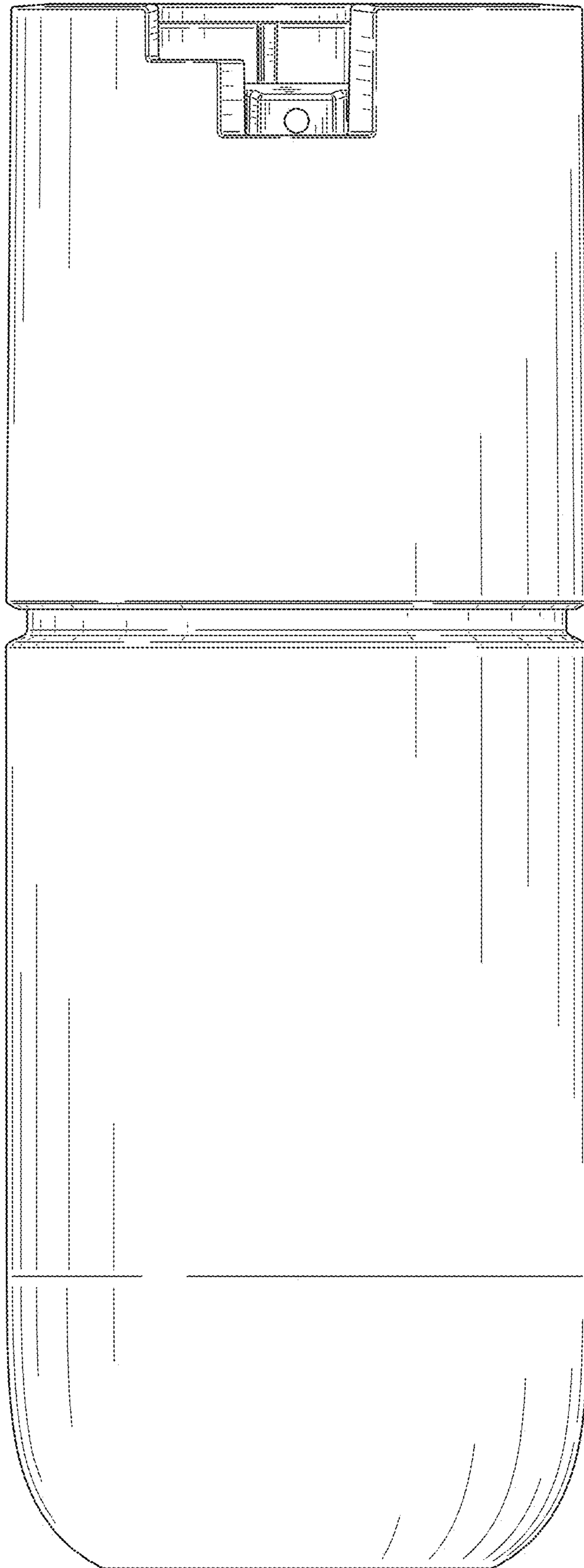

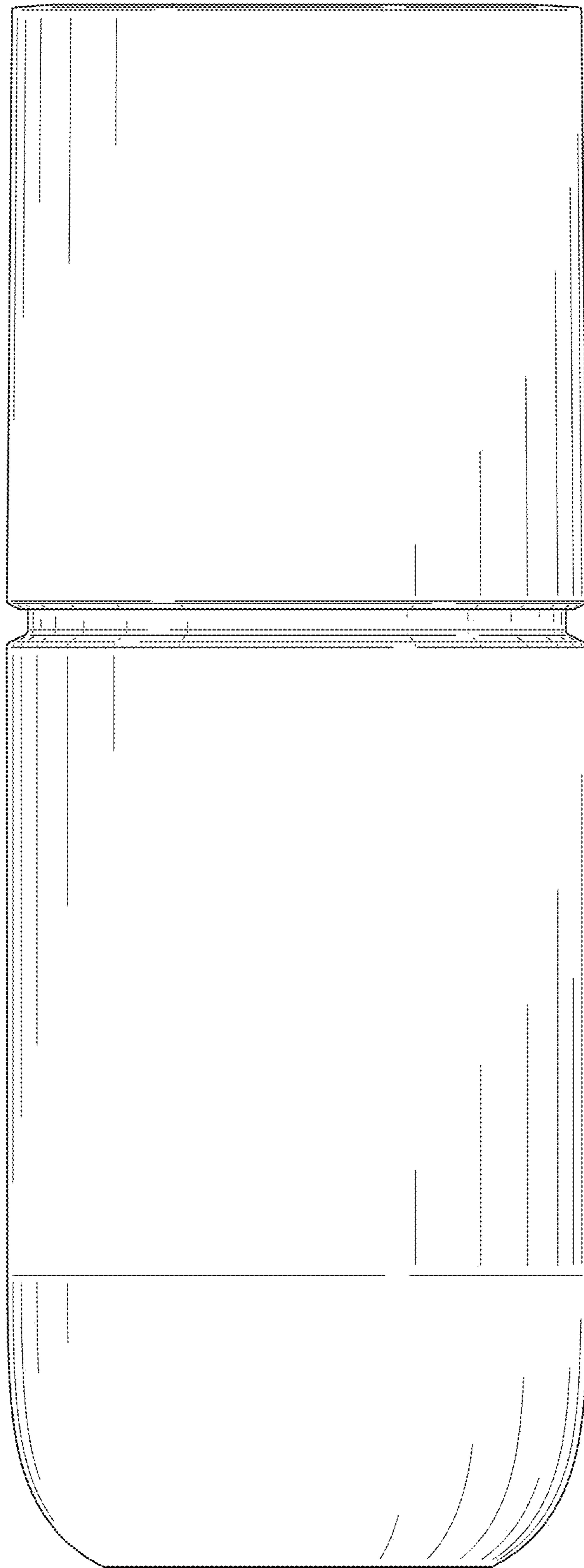

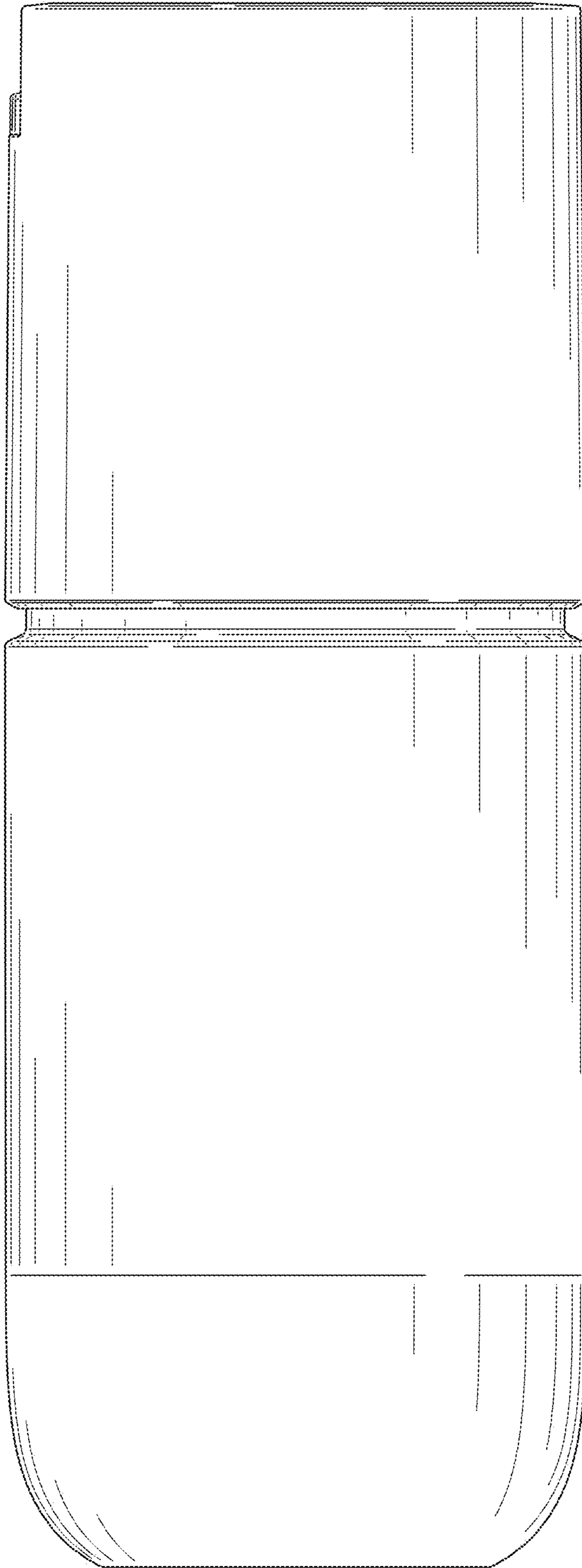

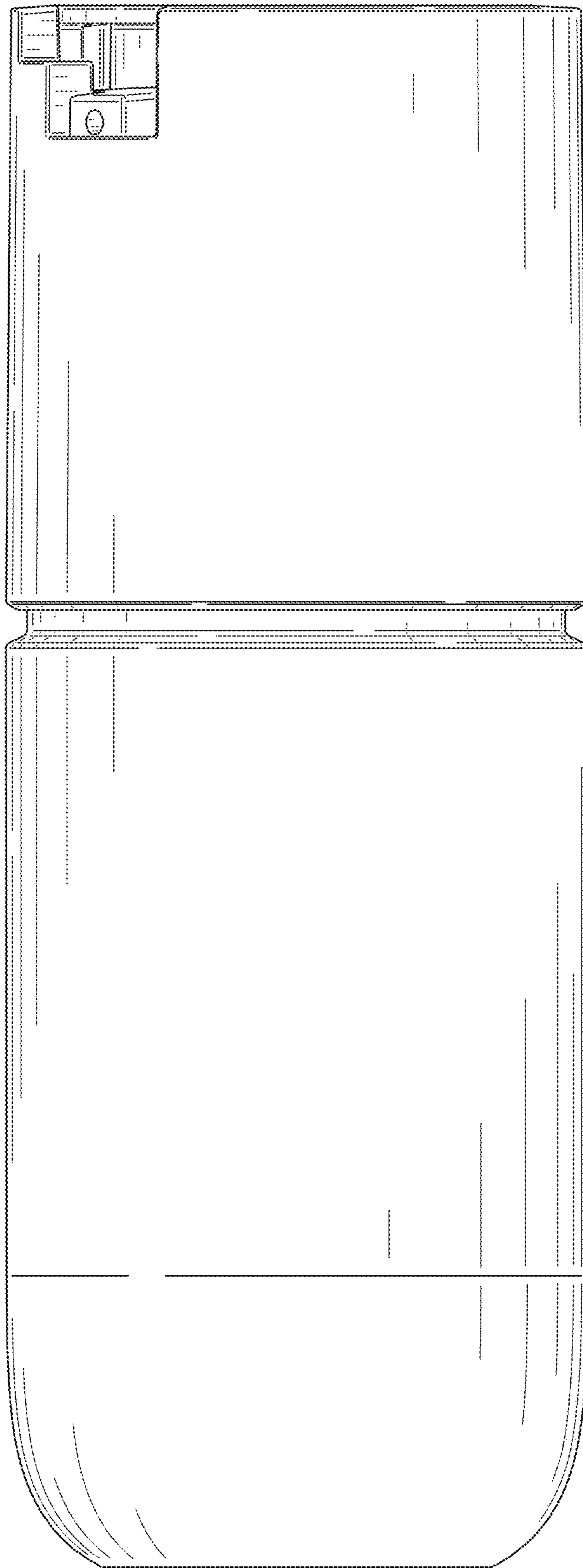

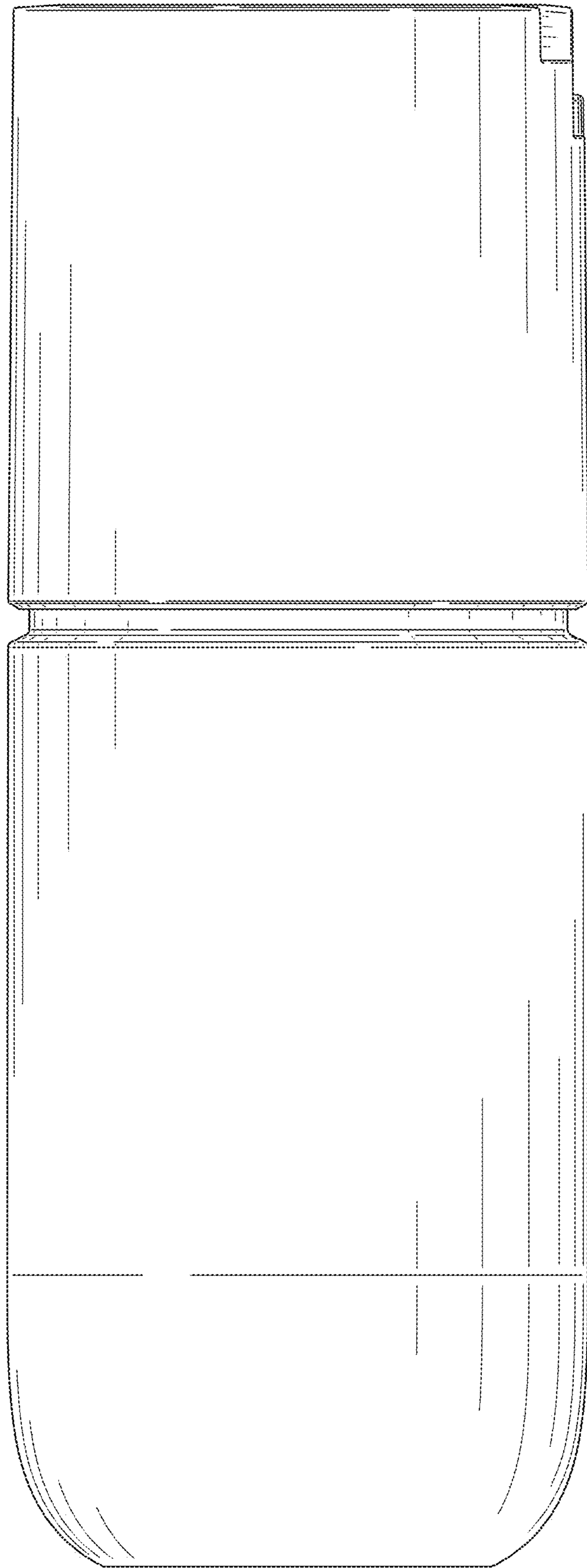

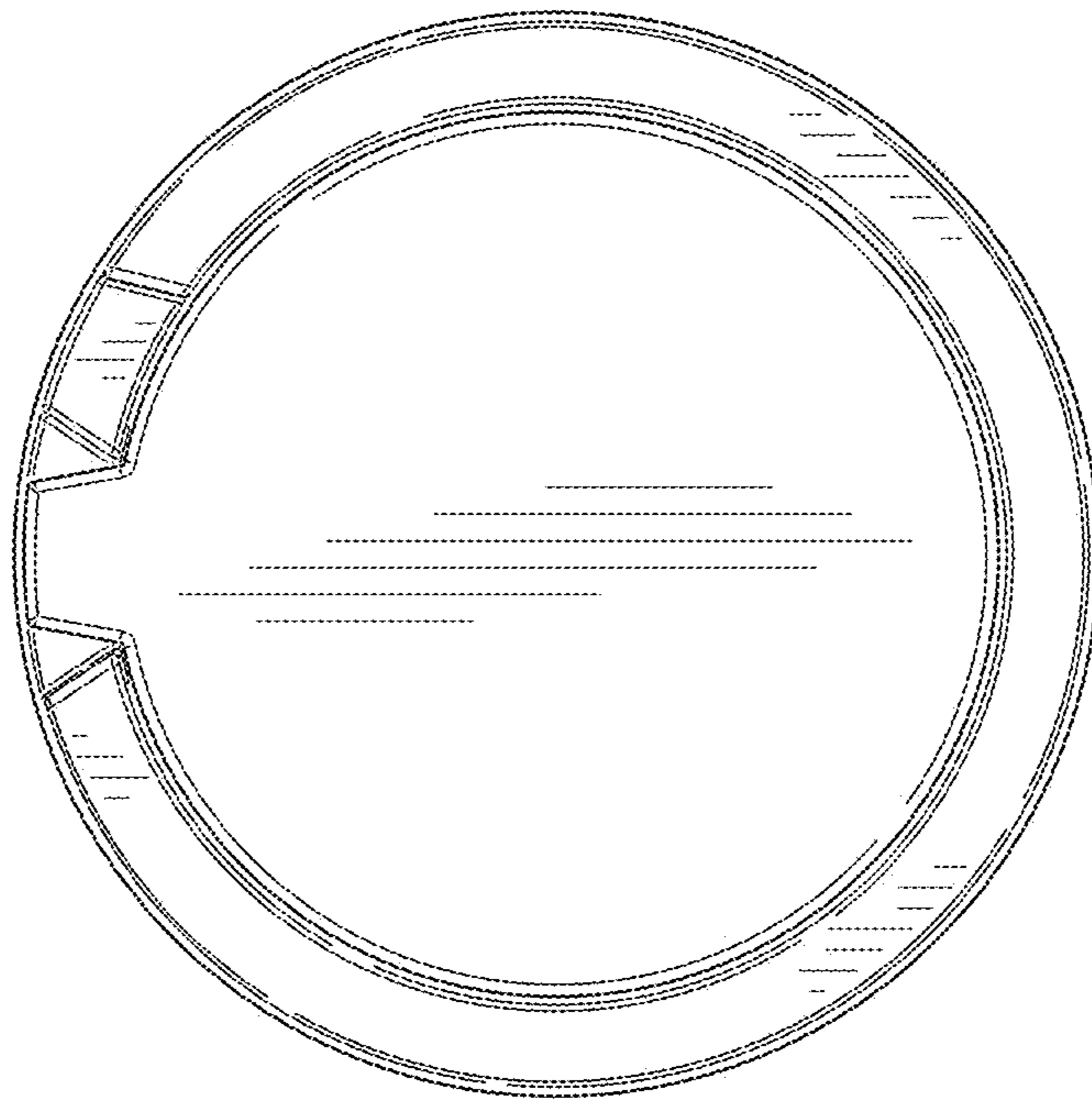

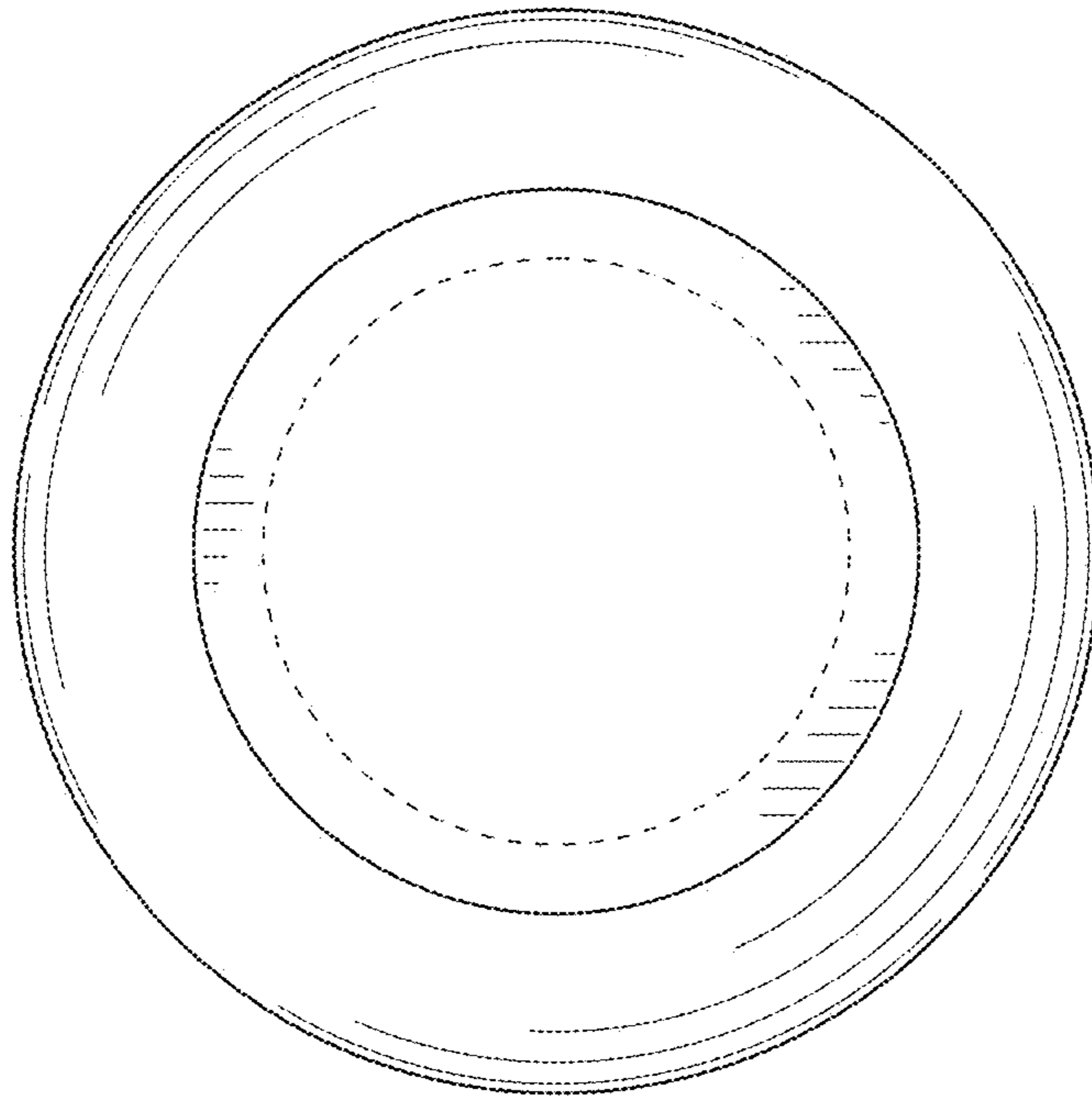
