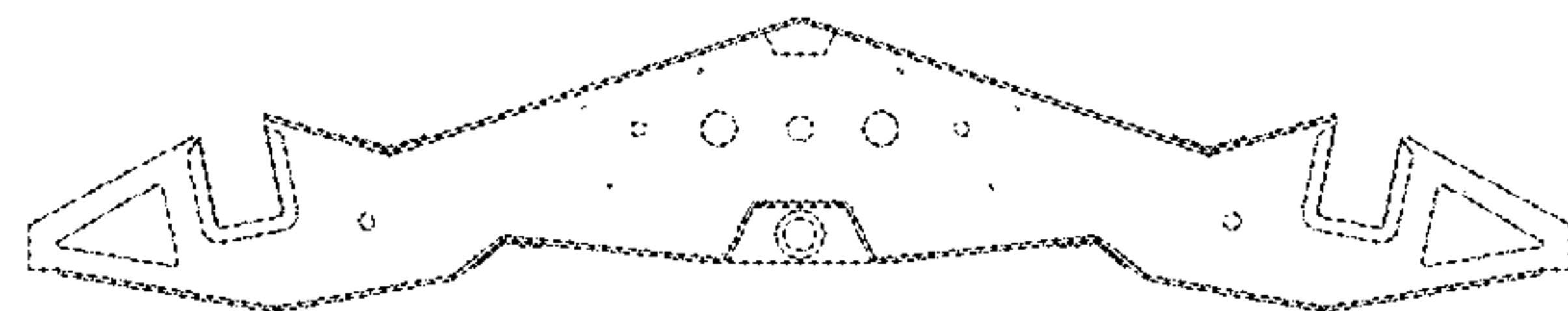
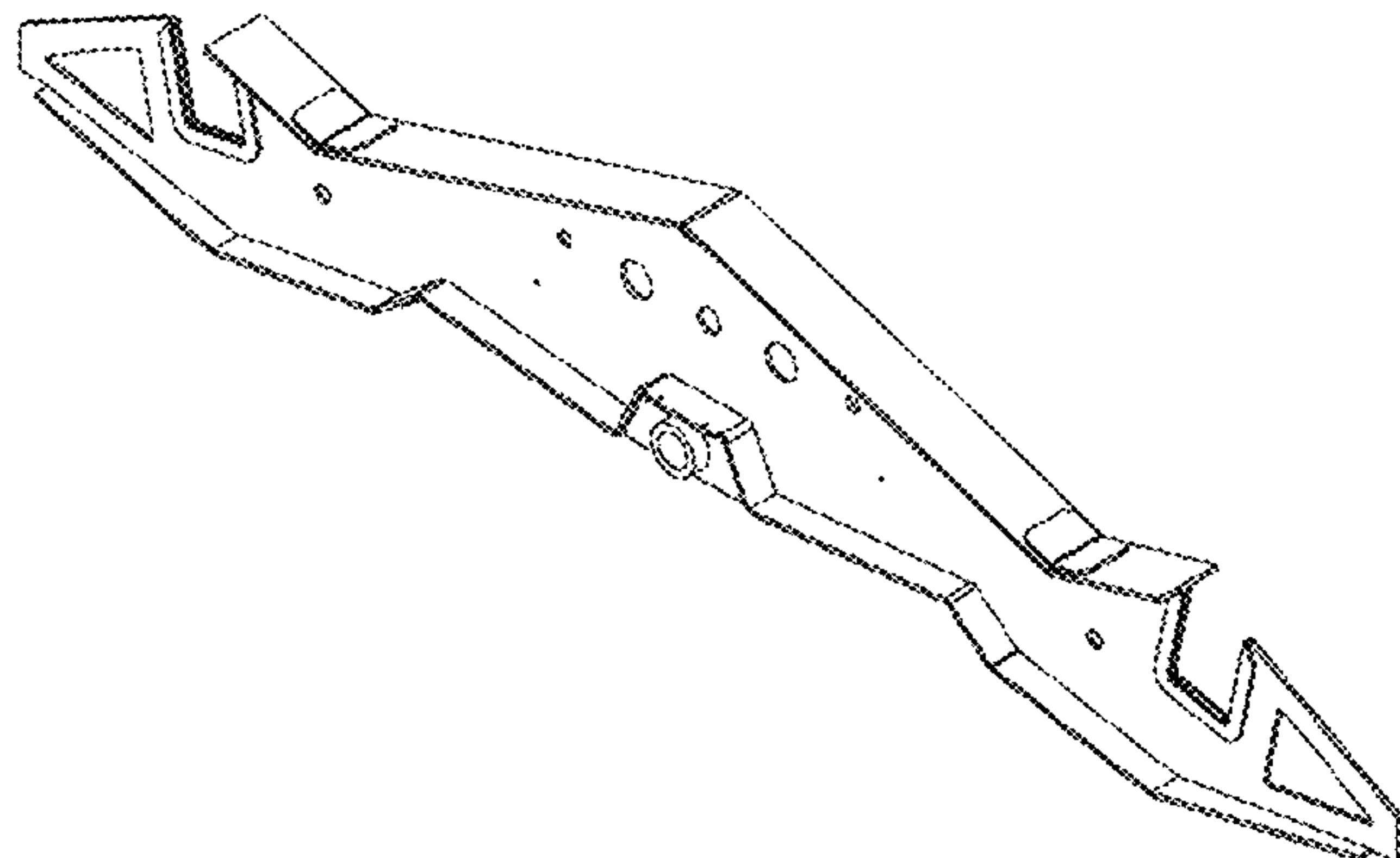
(57) **CLAIM**

The ornamental design for a lightweight bottom dump trailer beam, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a lightweight bottom dump trailer beam;

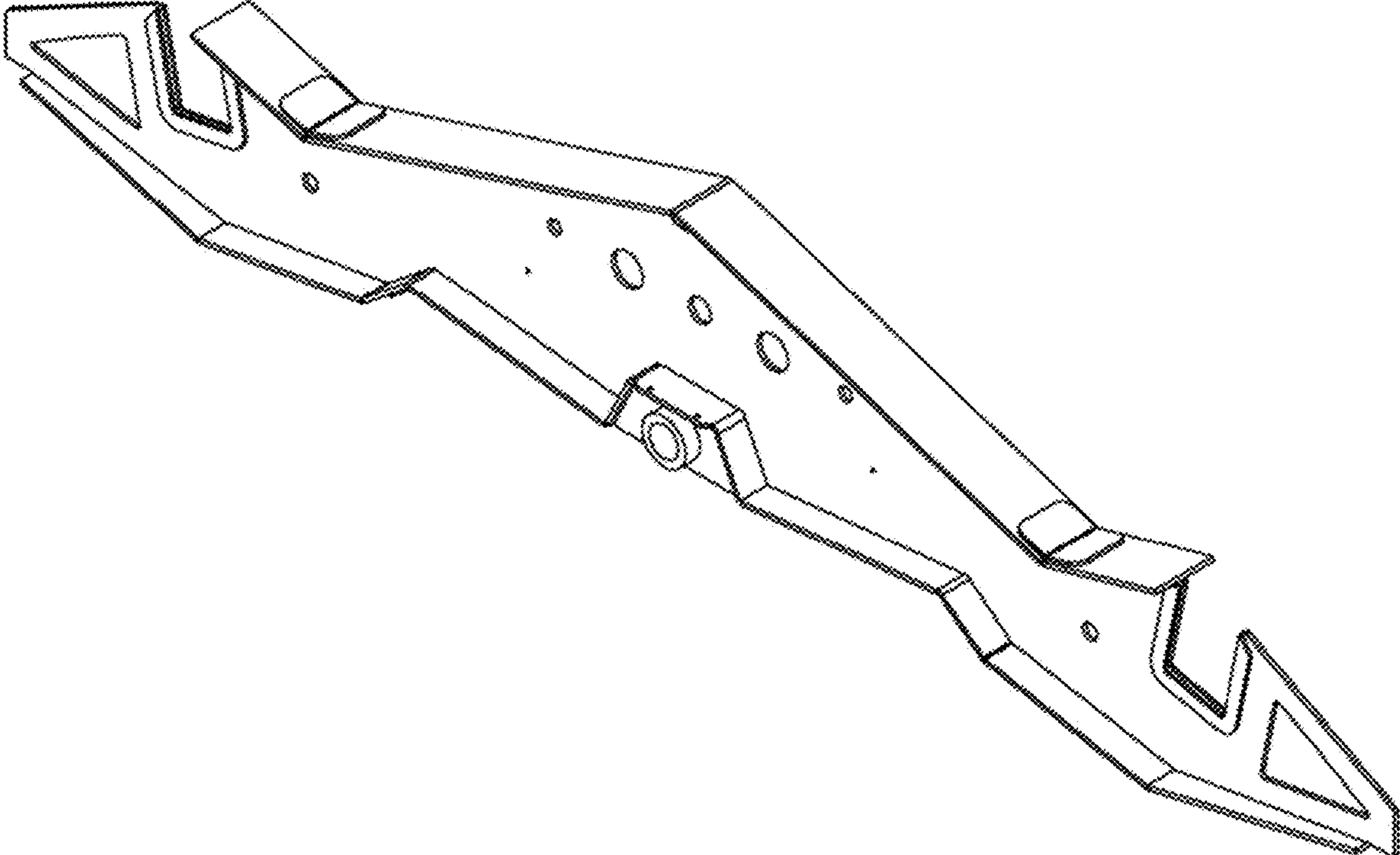

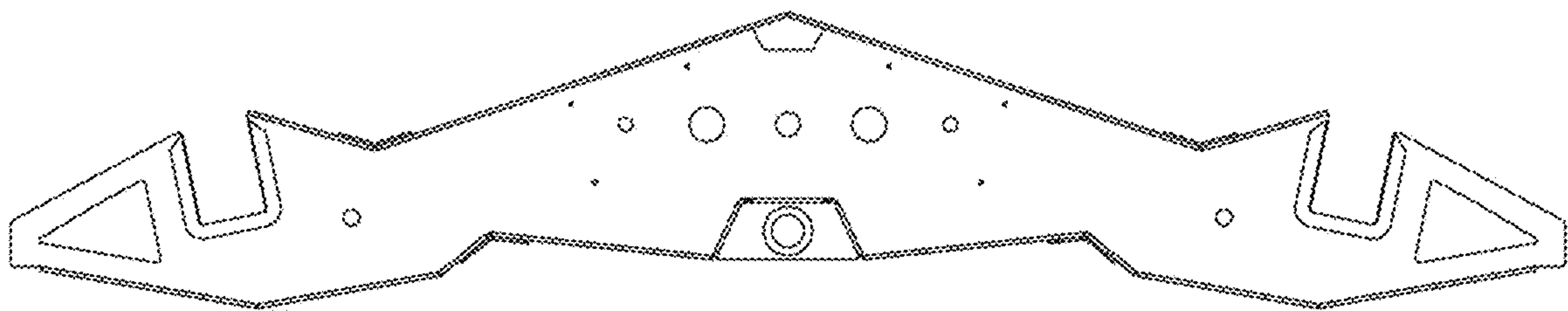

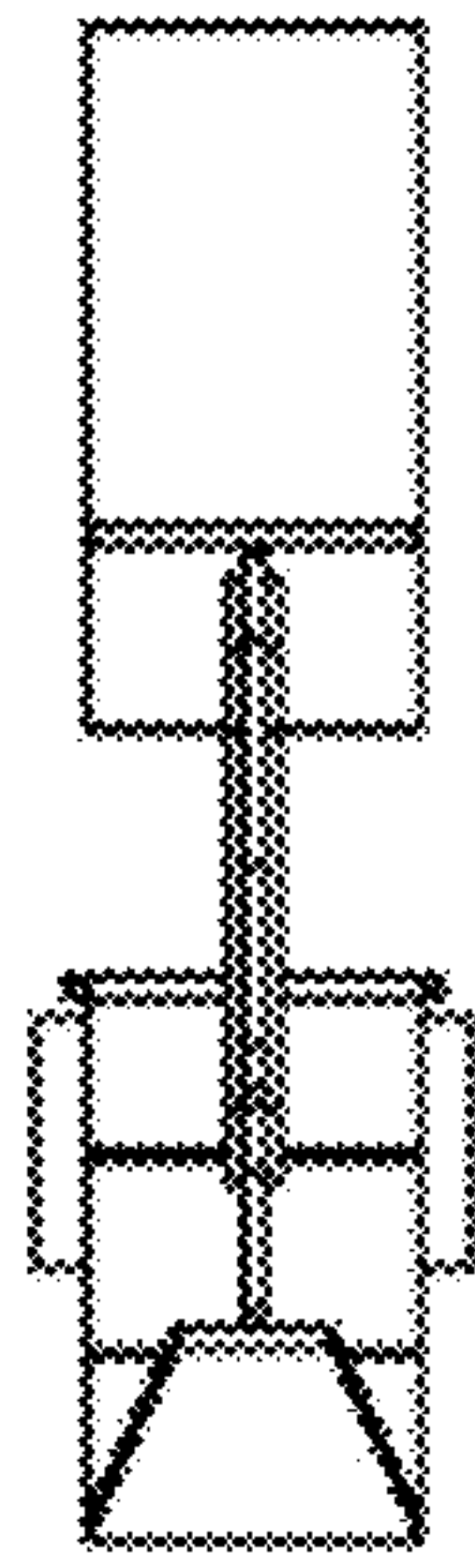

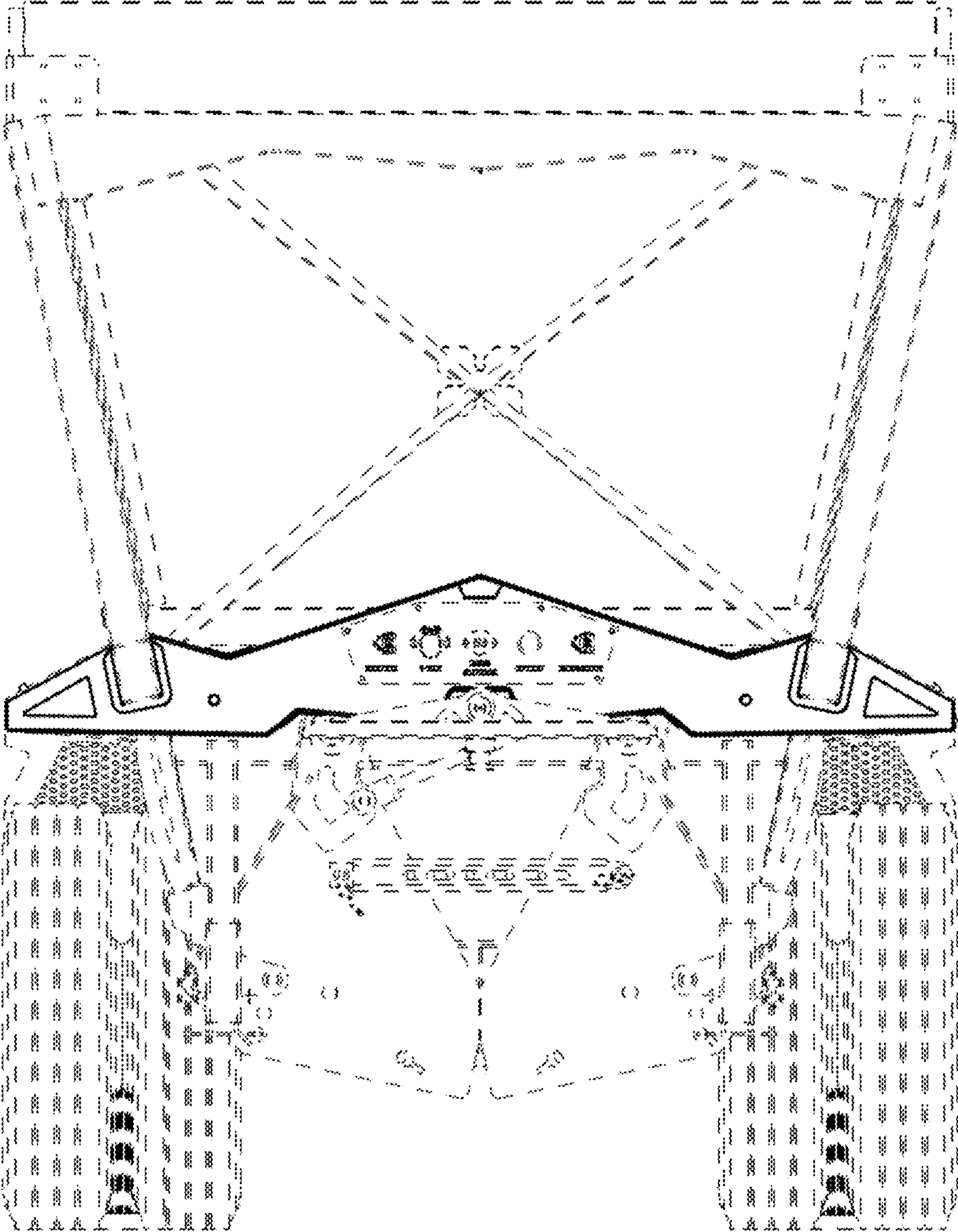
