FIG. 7 is a left side elevational view thereof.

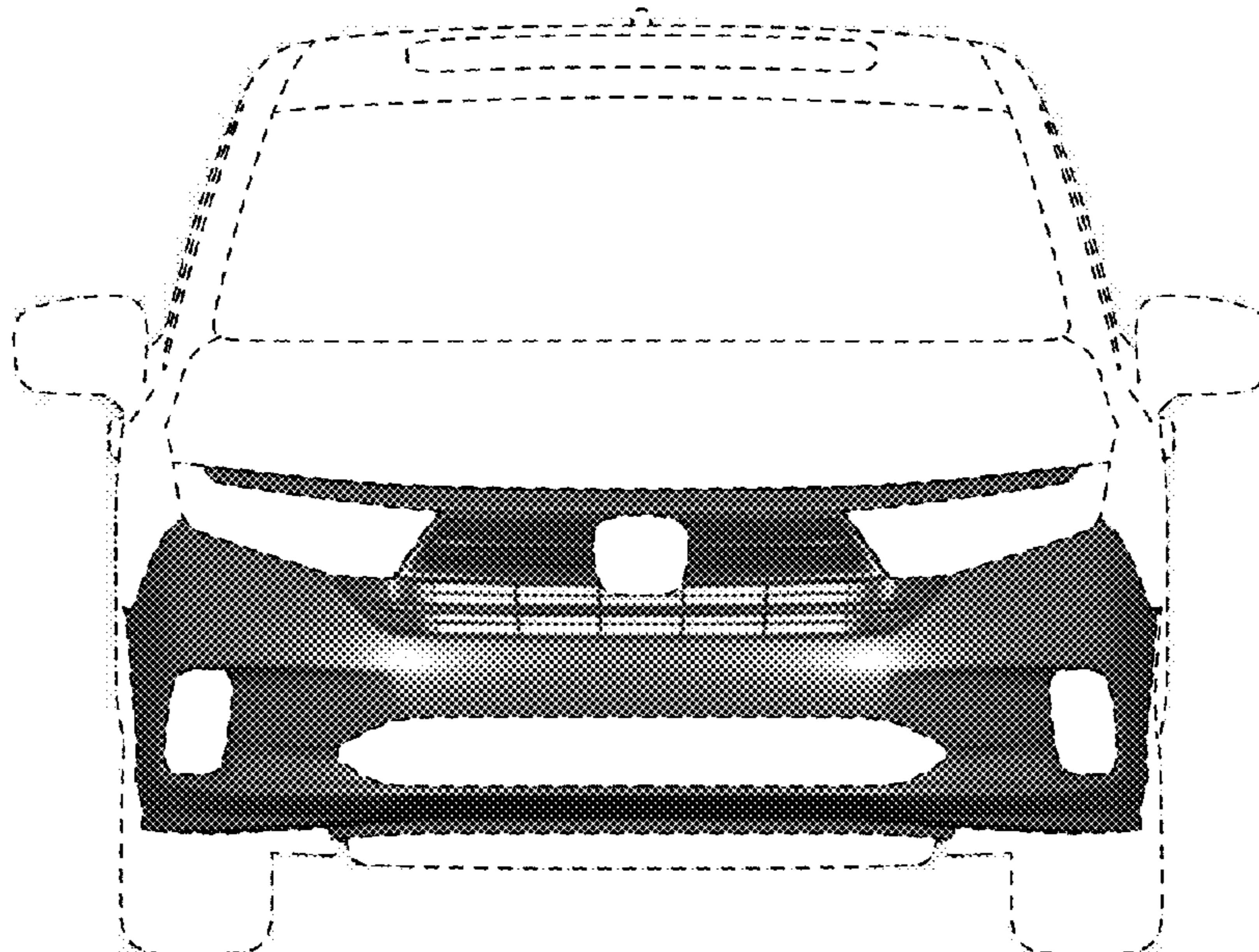
FIG. 8 is a right side elevational view thereof.

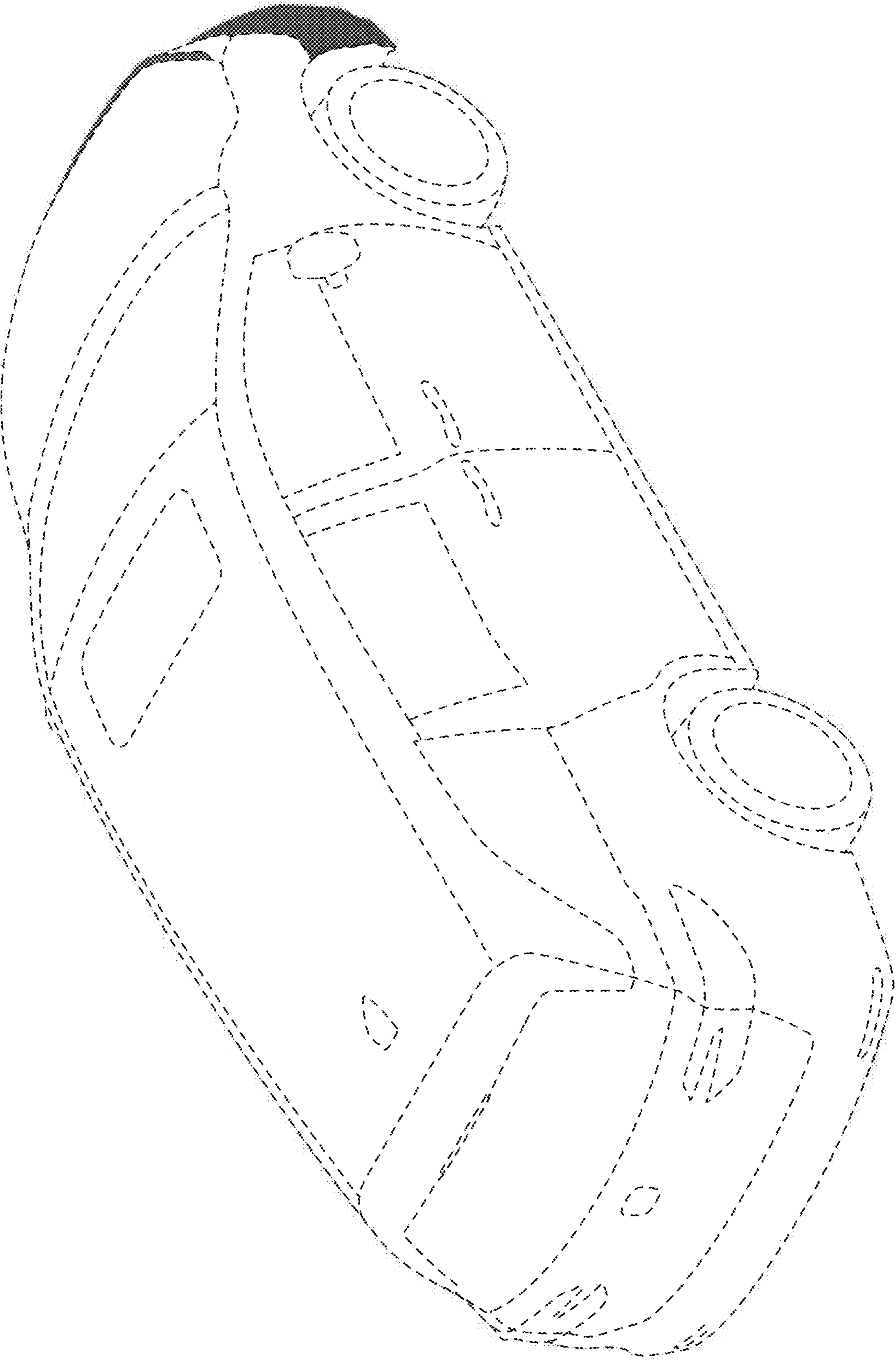

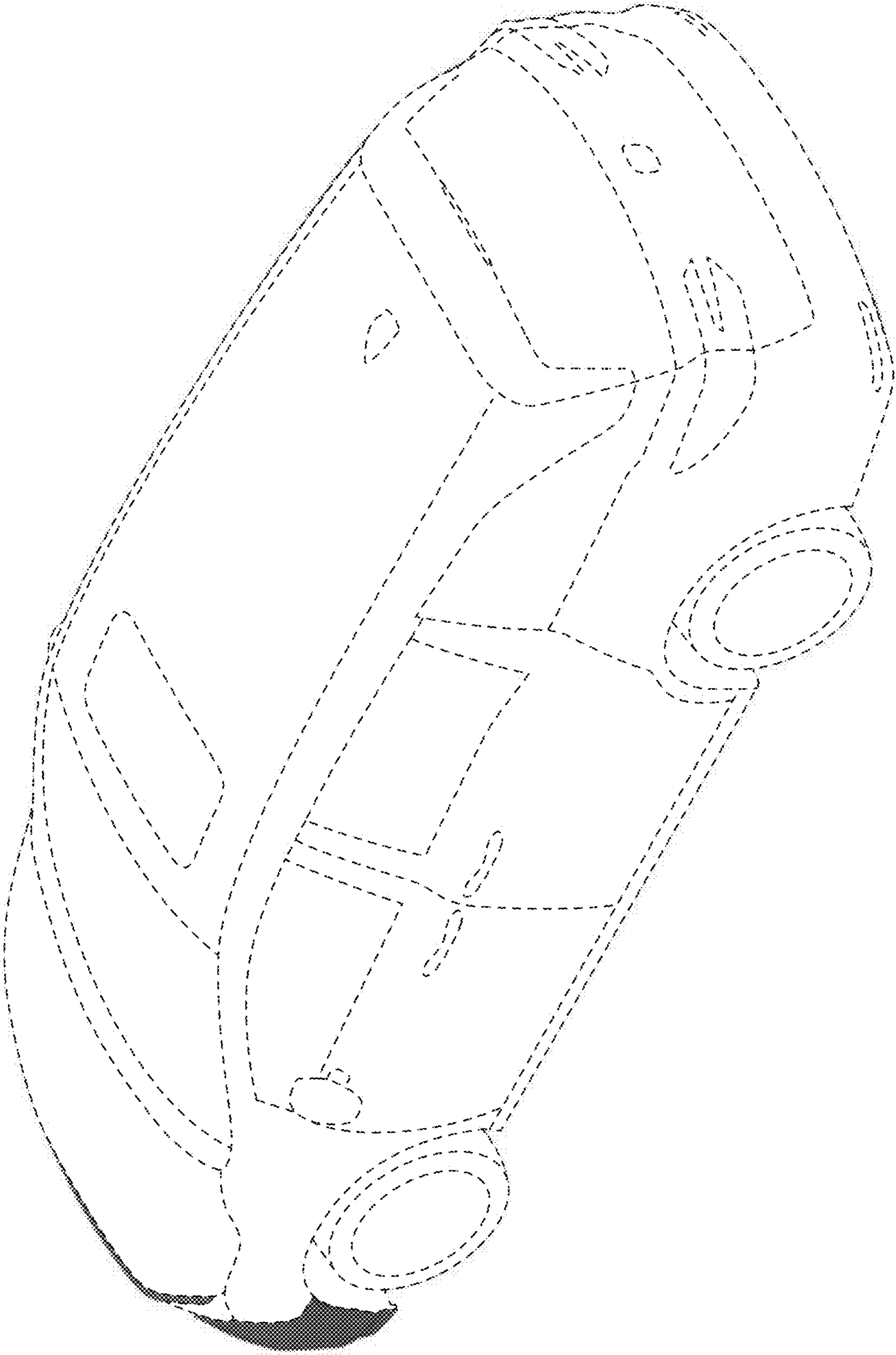

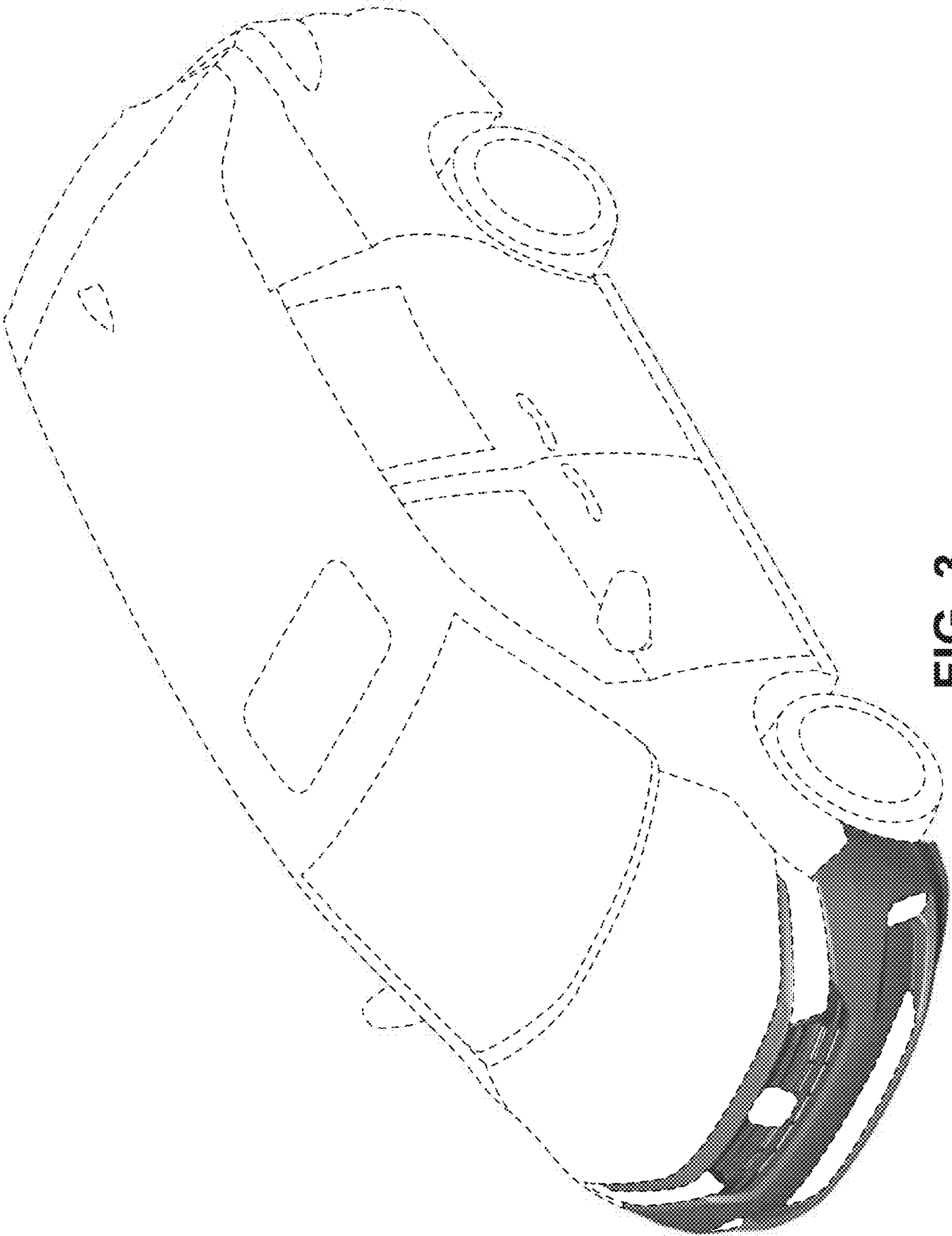

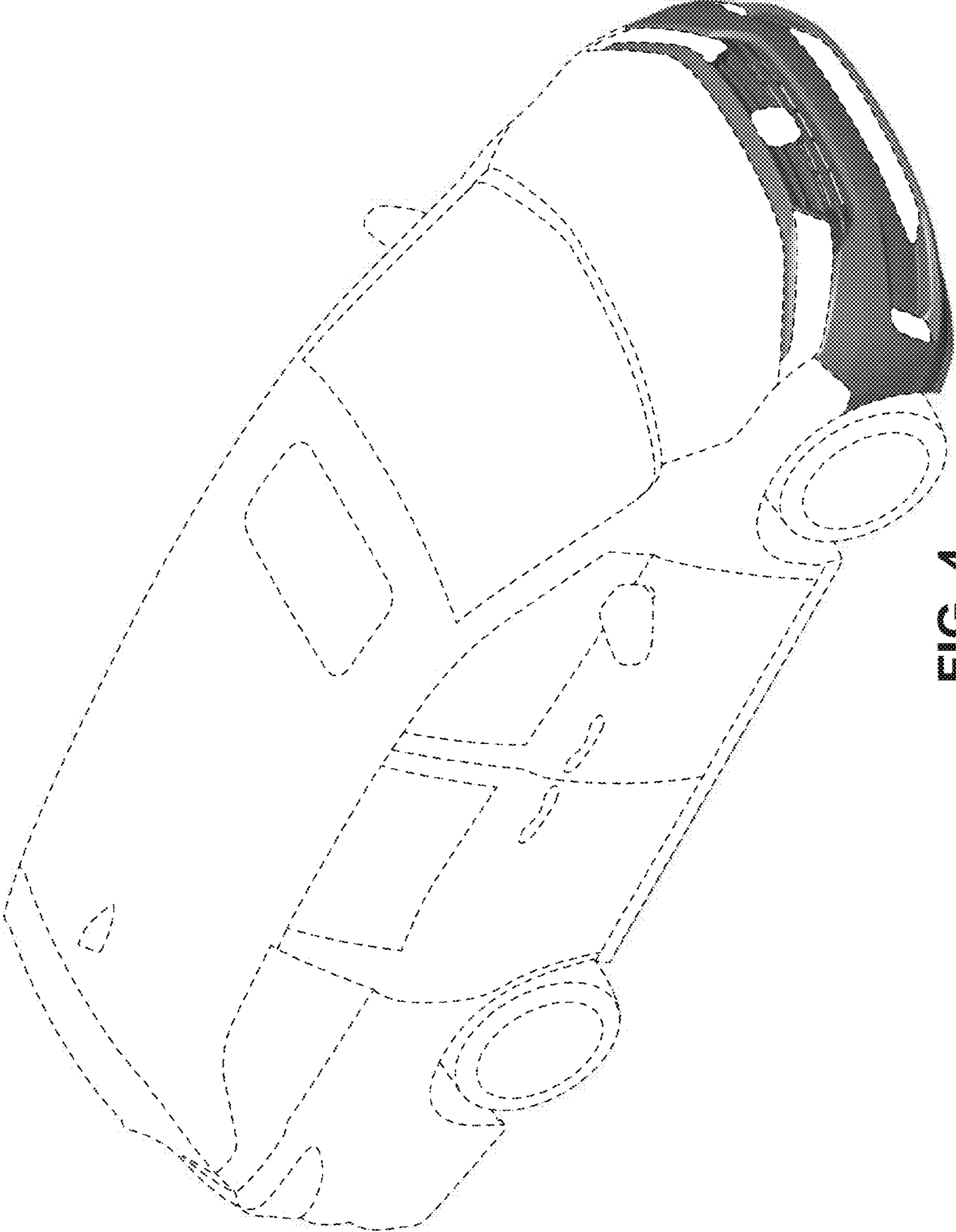
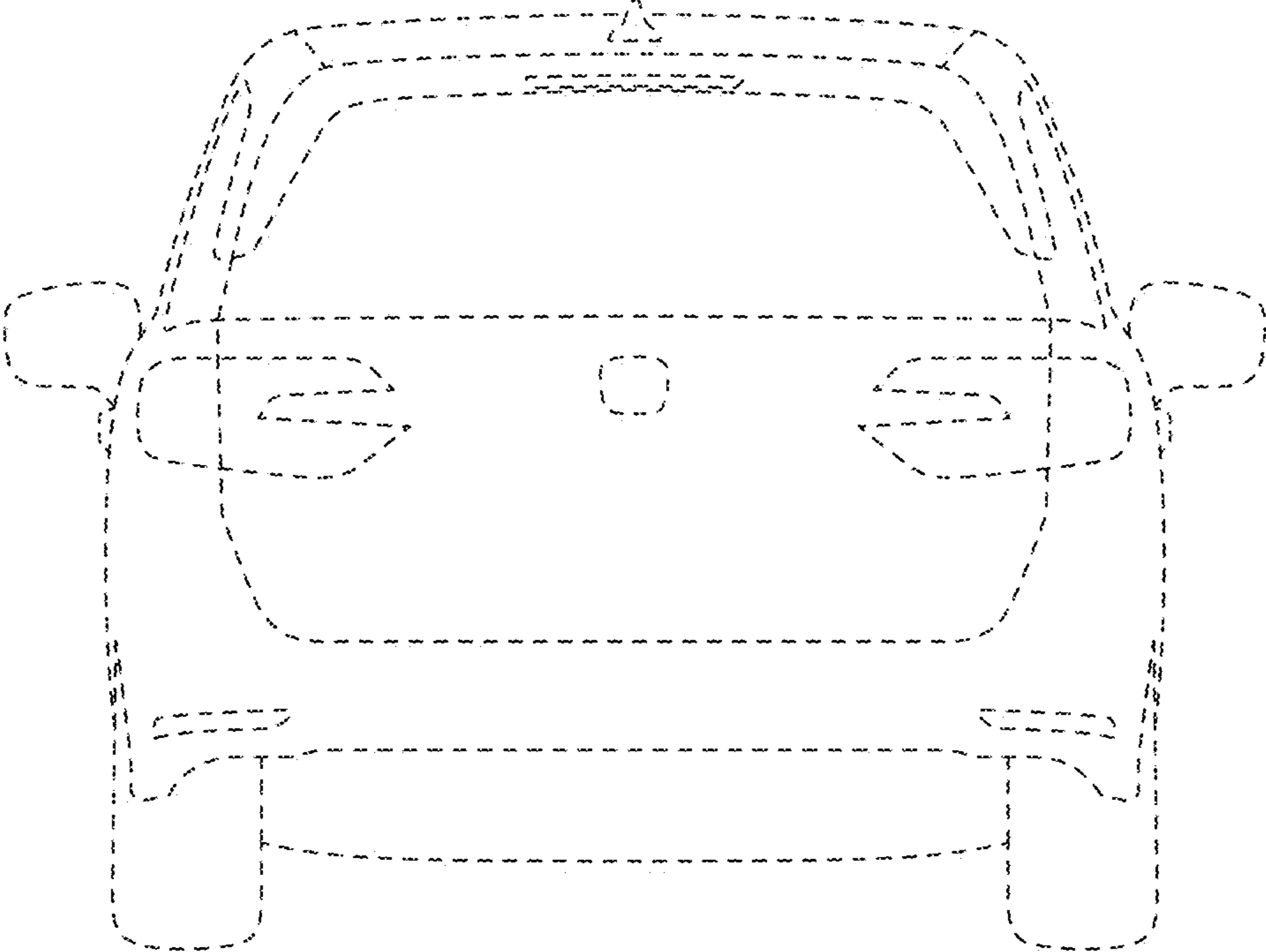
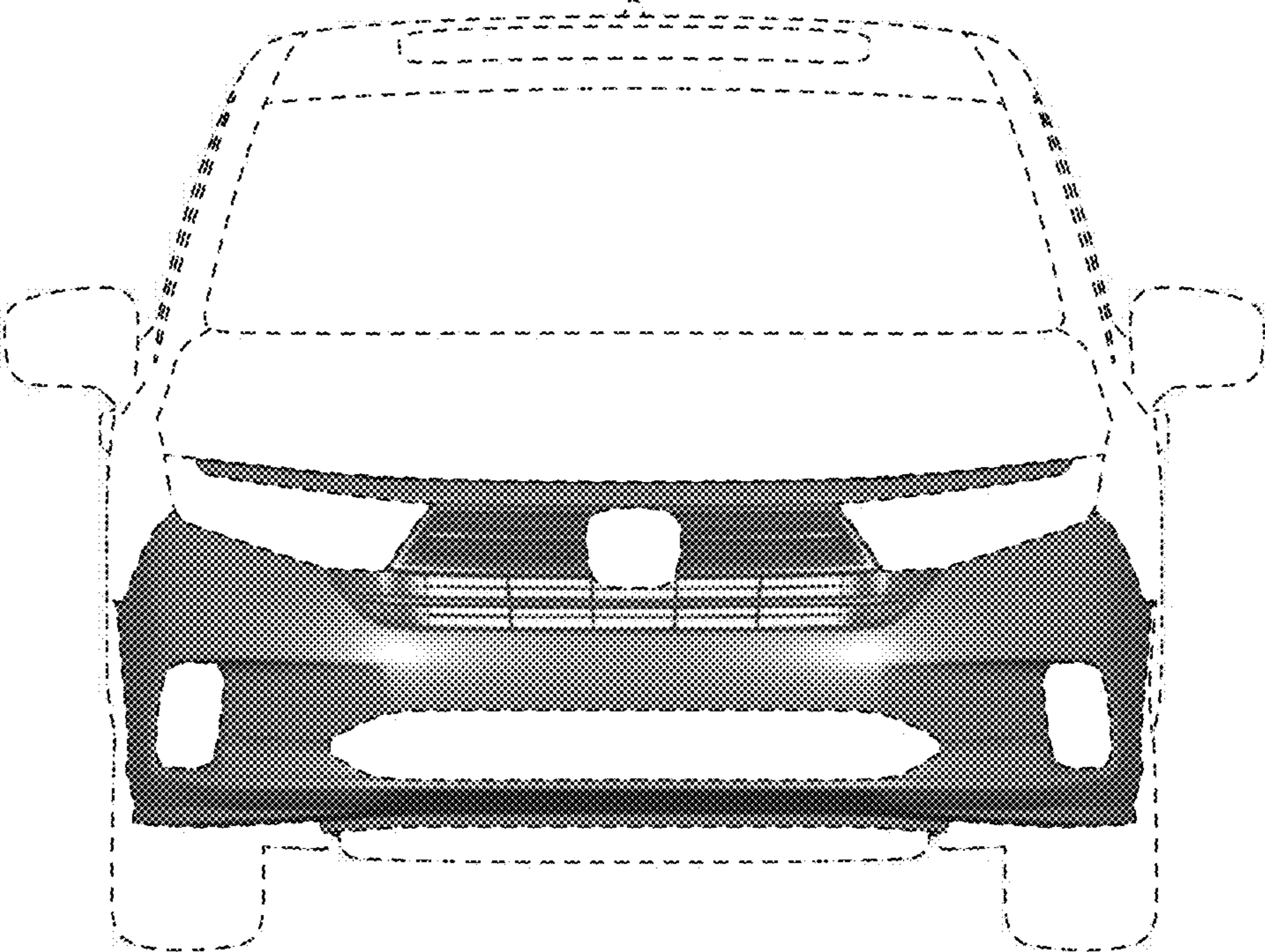

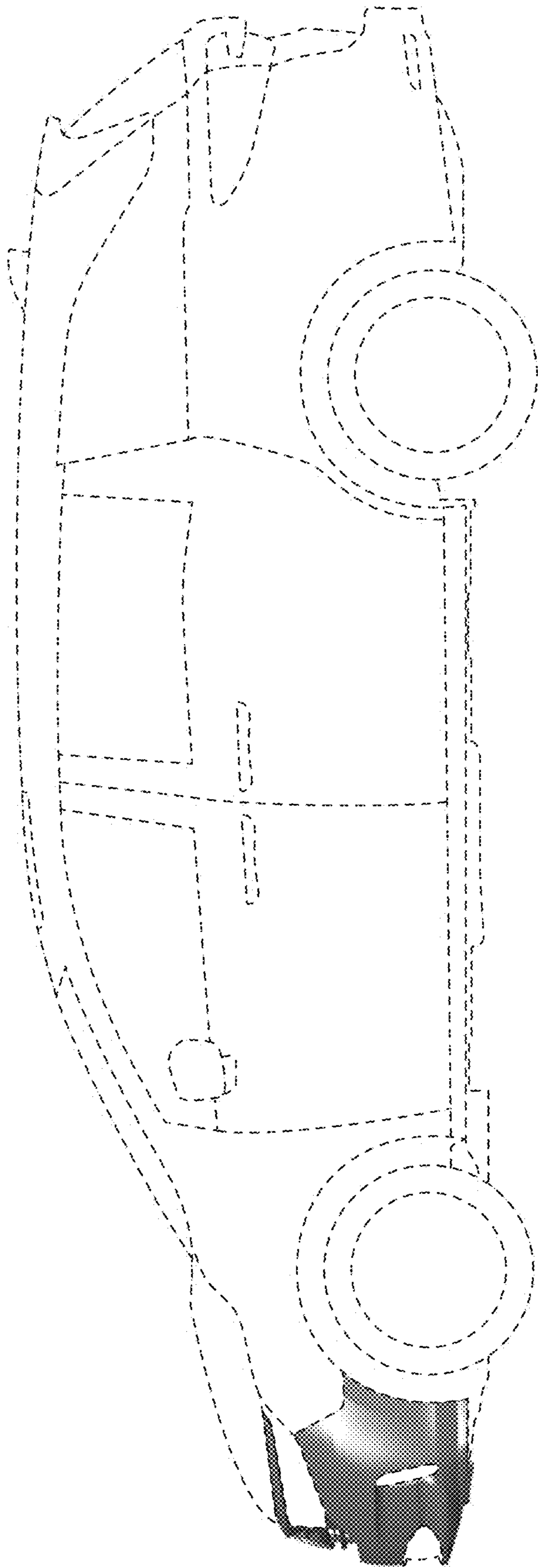
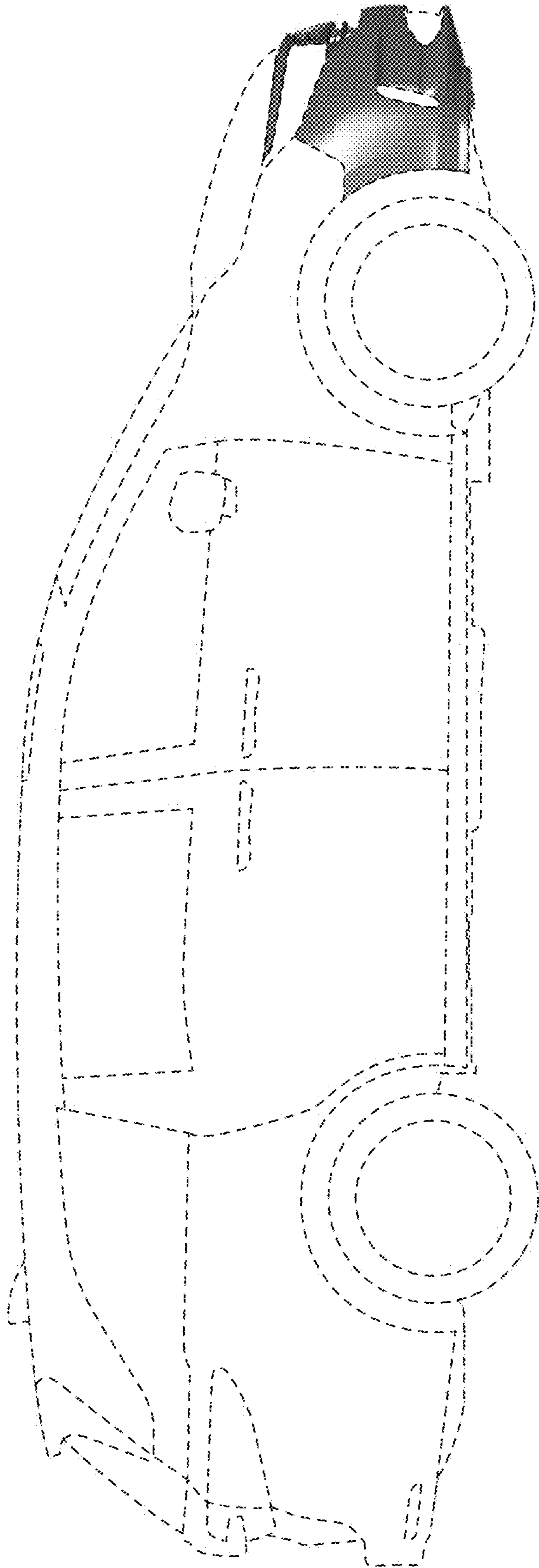

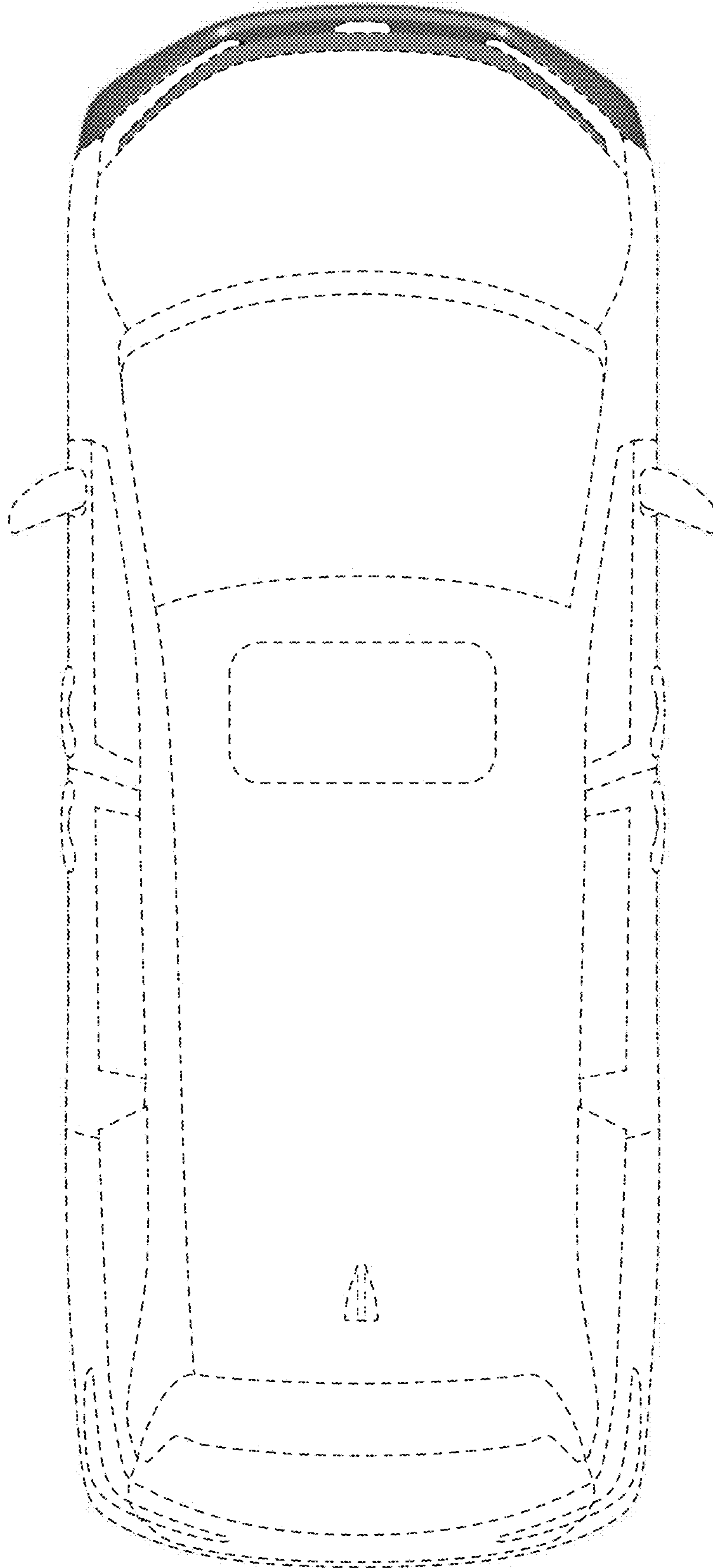
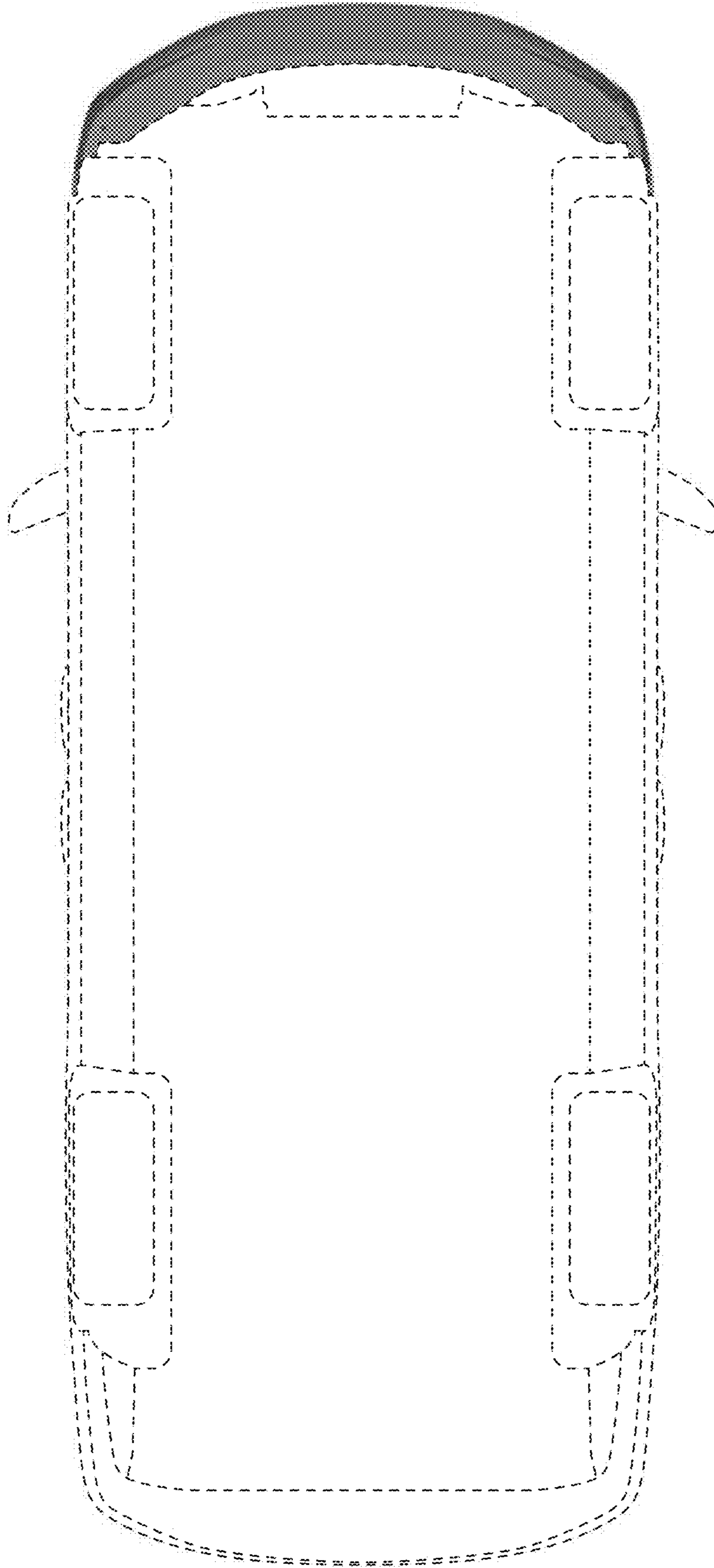
