FIG. 1 is a front view of a first embodiment of the display screen with graphical user interface, showing our design;

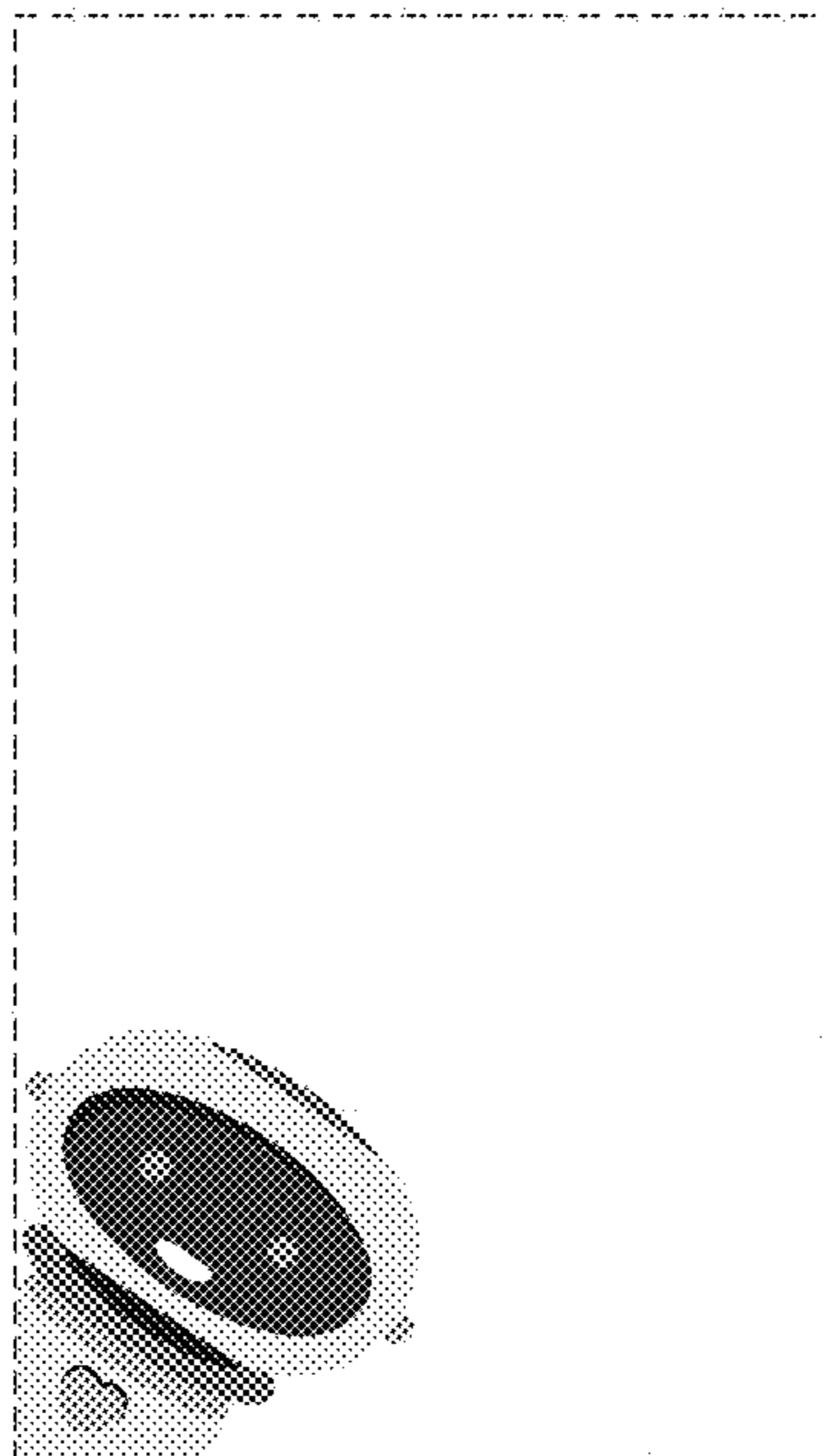
FIG. 2 is a front view of another embodiment of the display screen with graphical user interface;

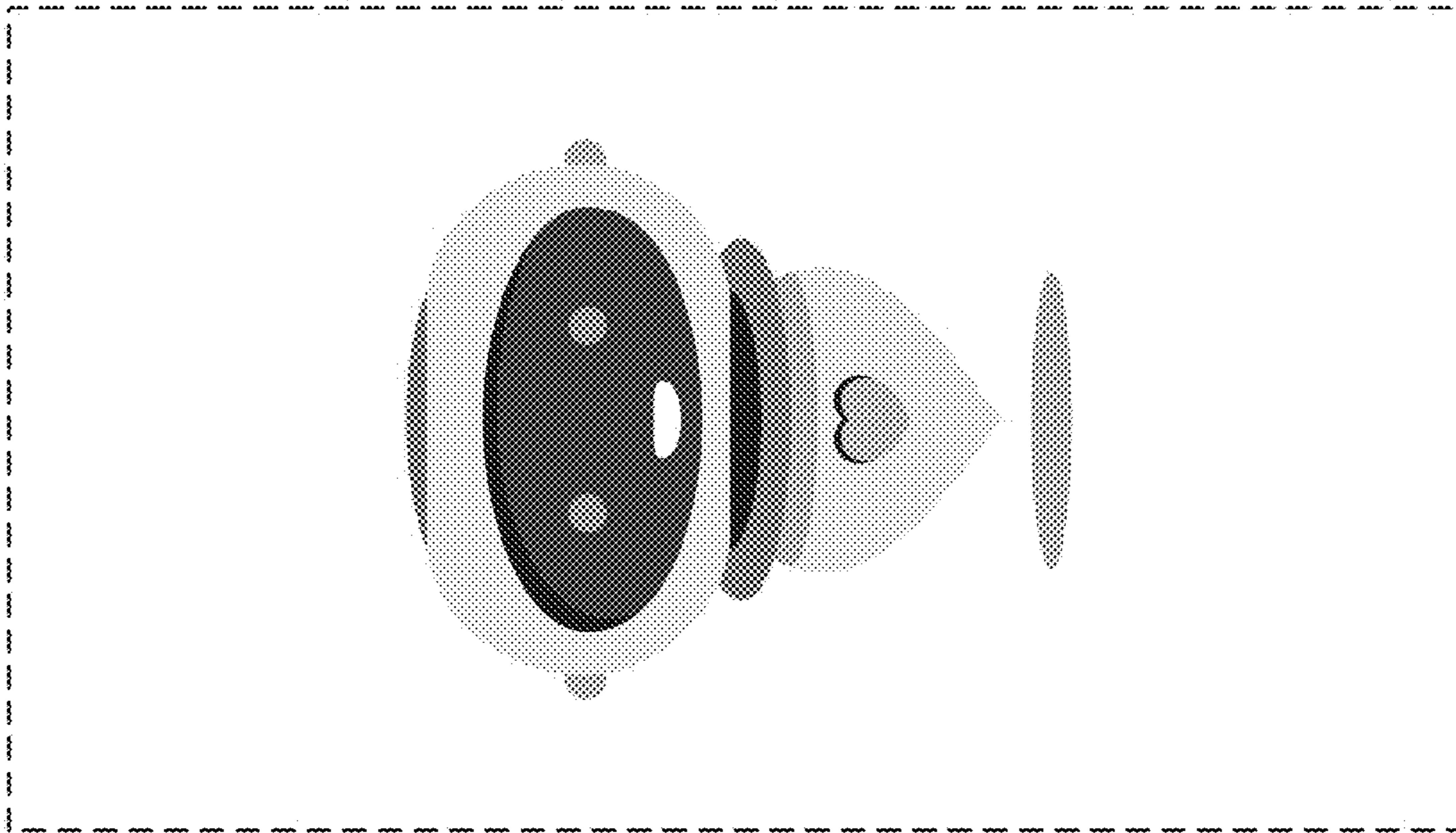

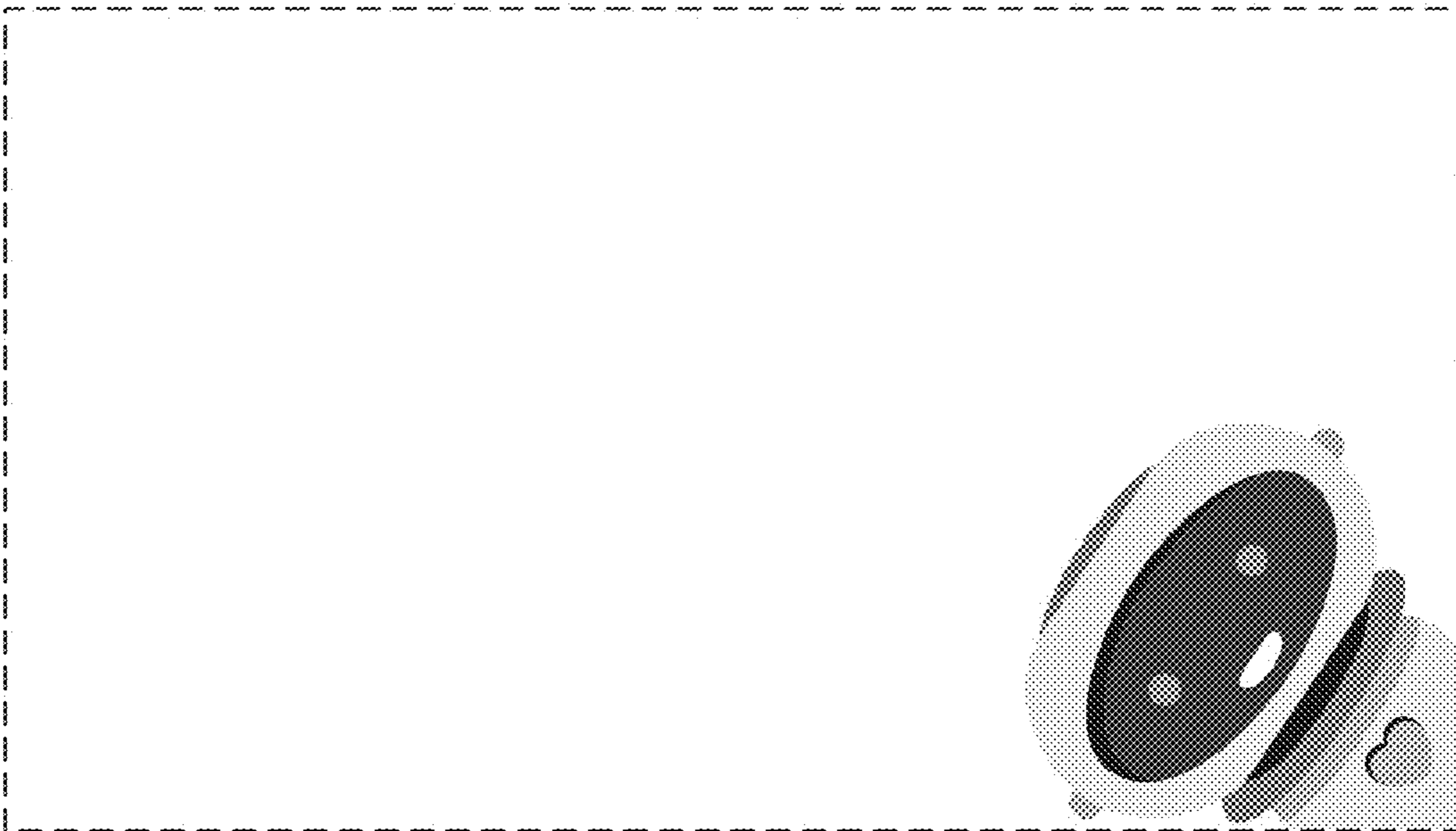

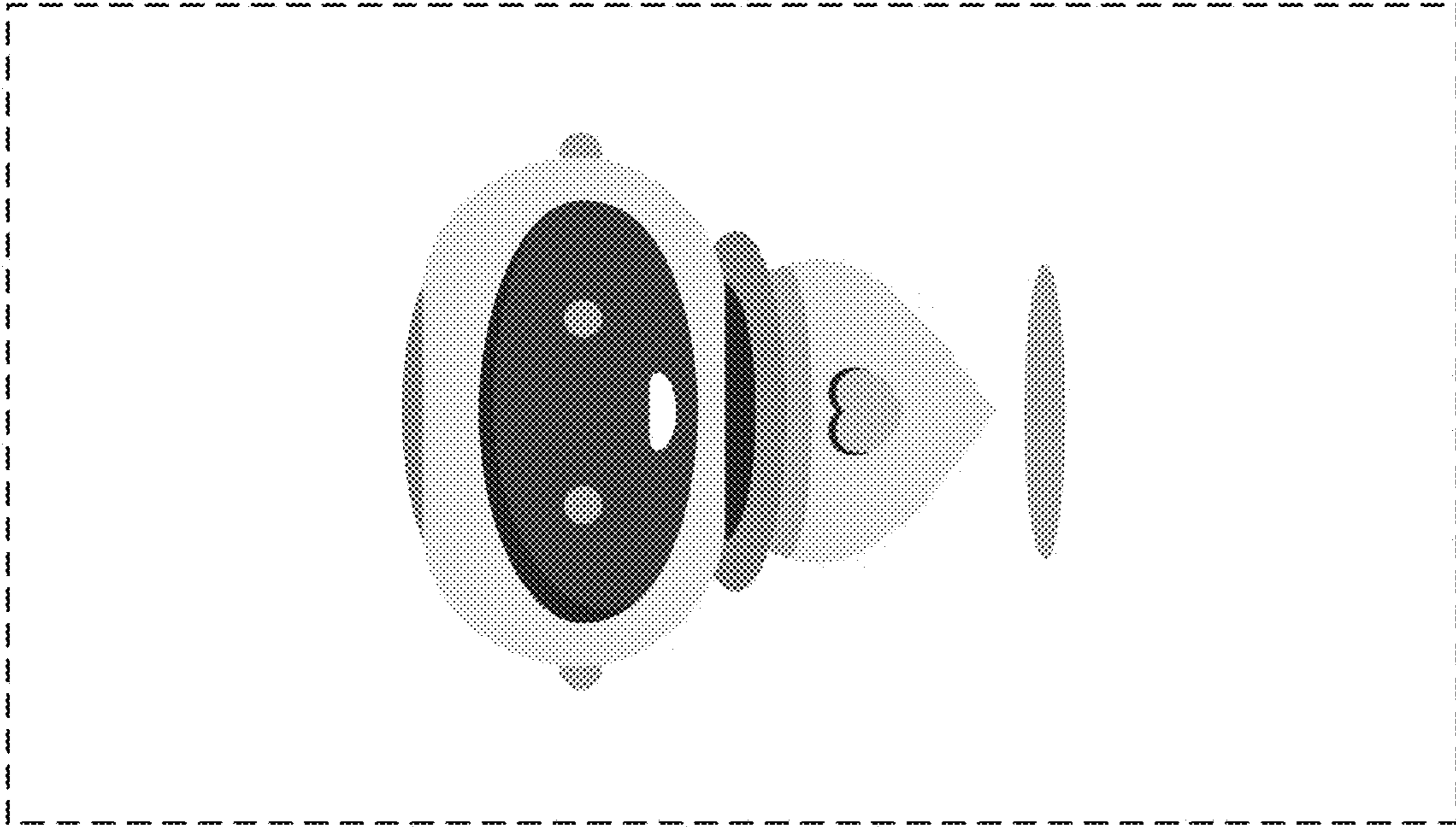

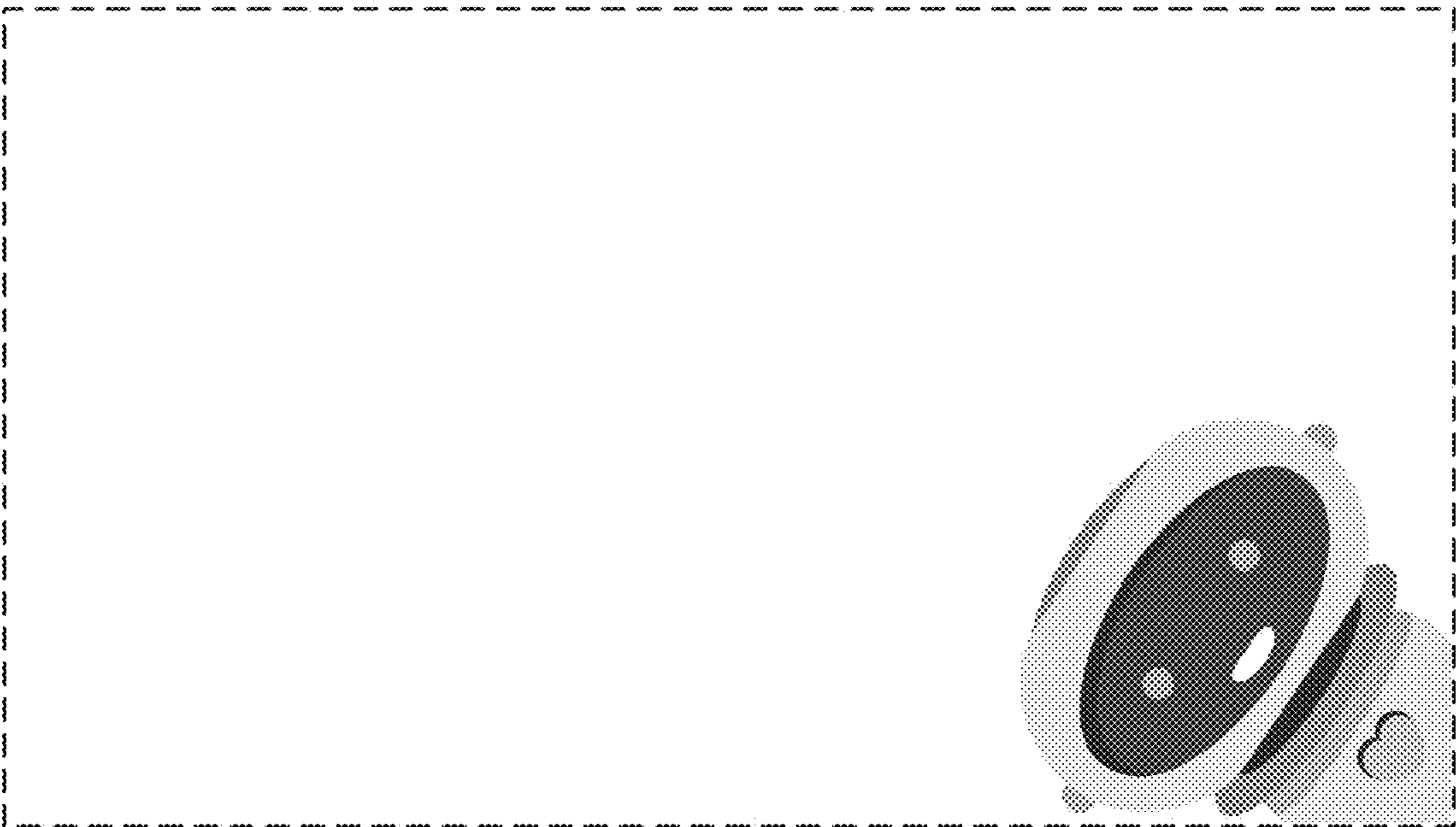
