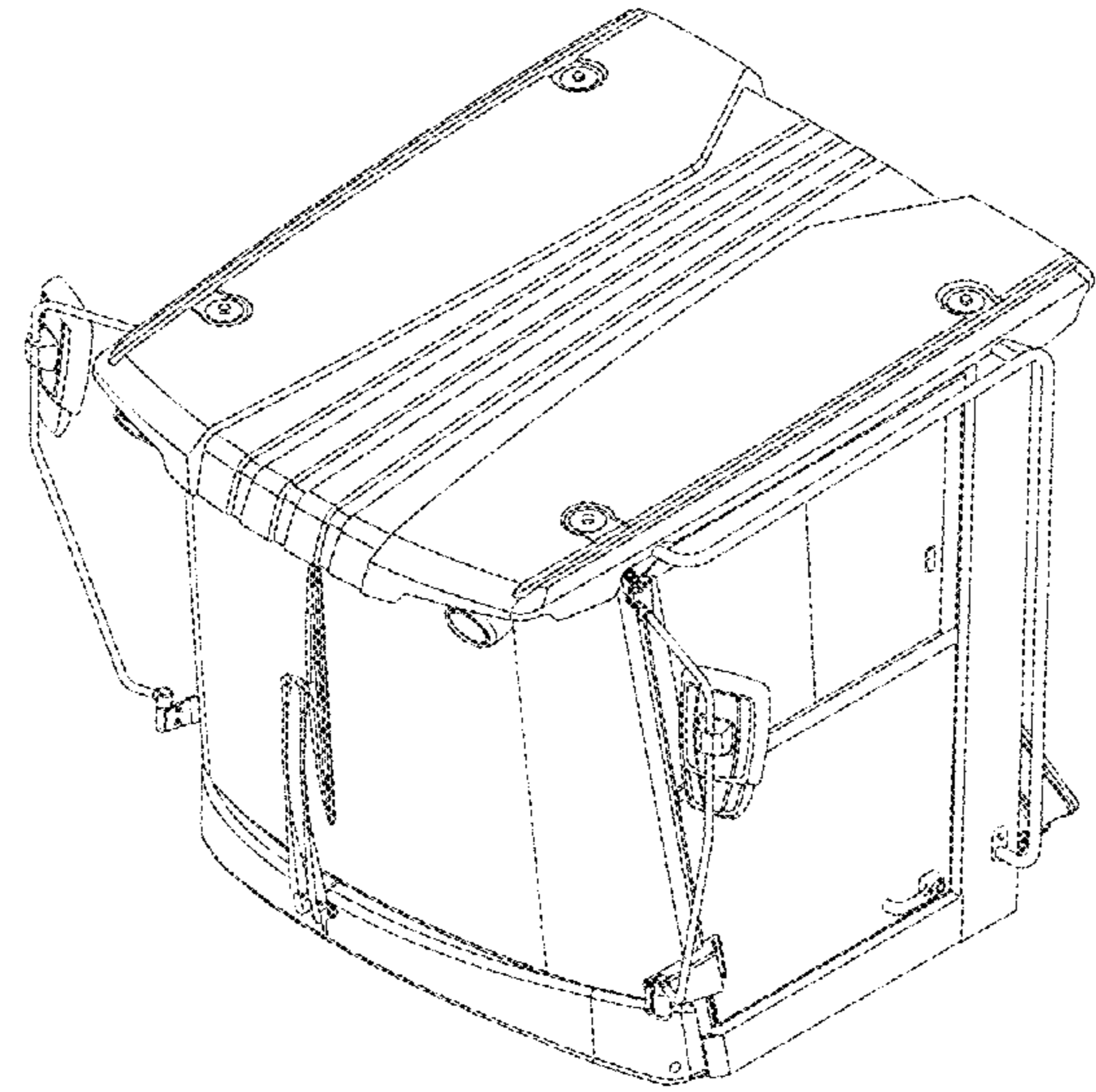
The ornamental design for the road roller cab, as shown and described.

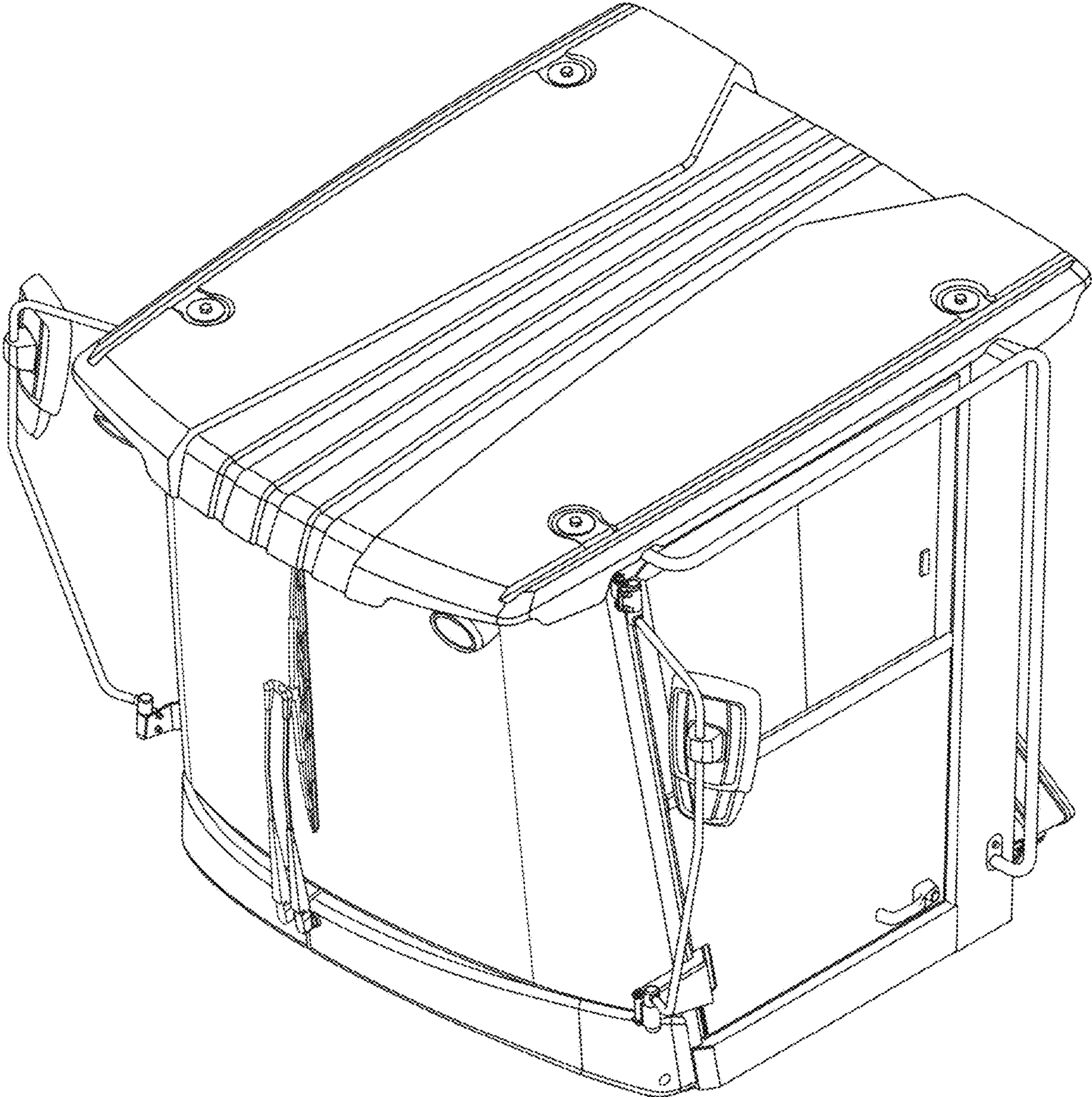

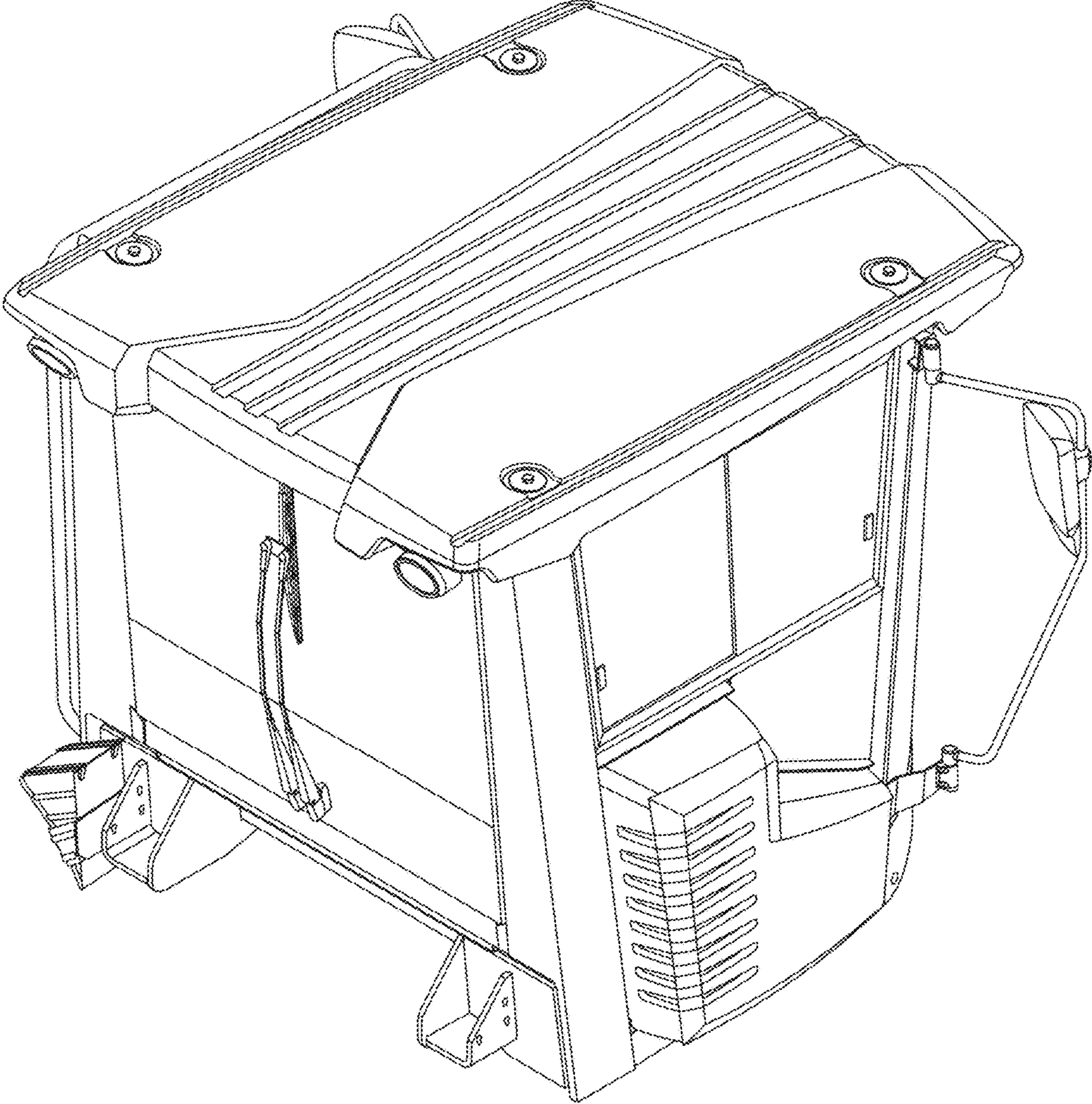

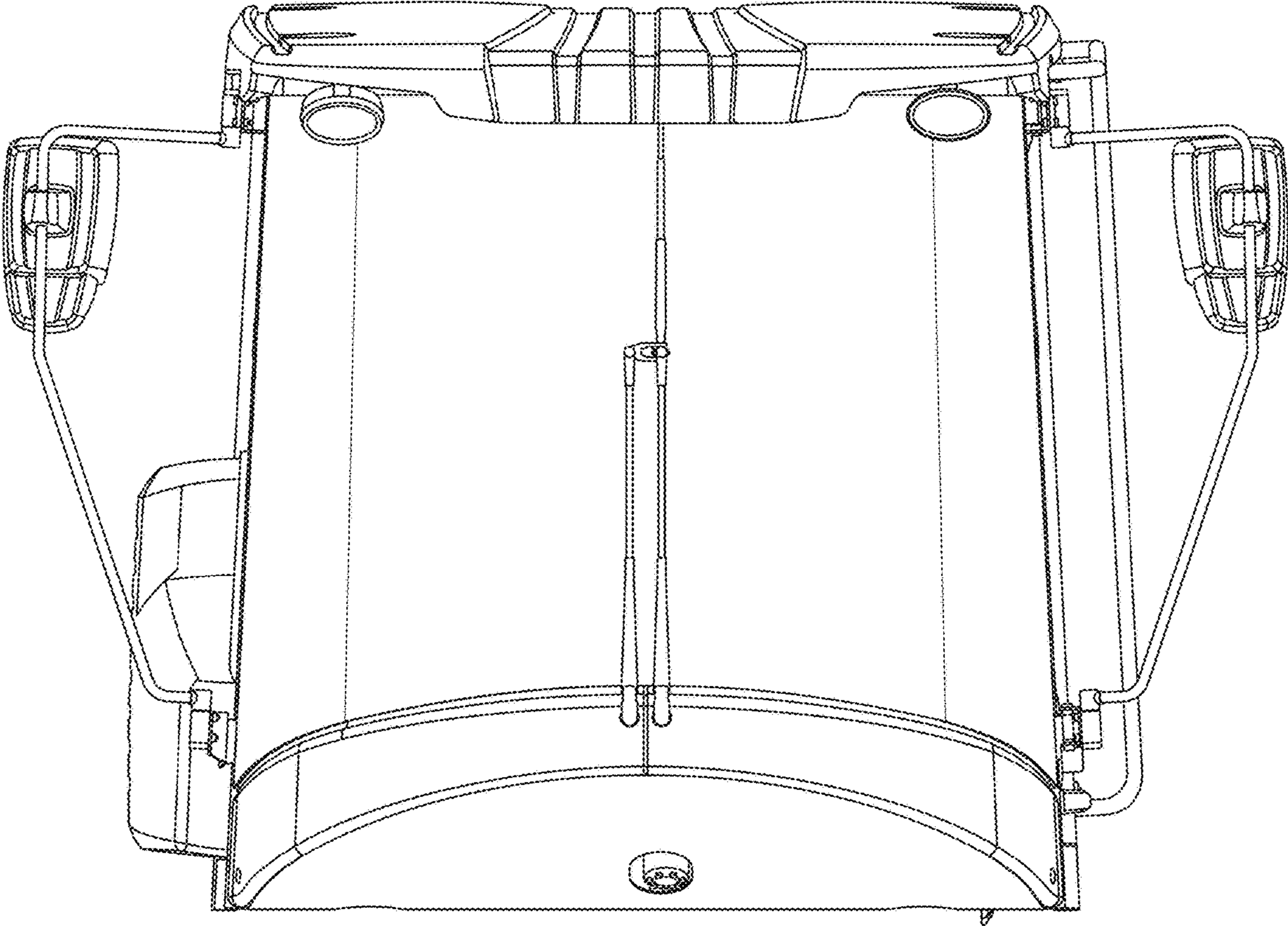

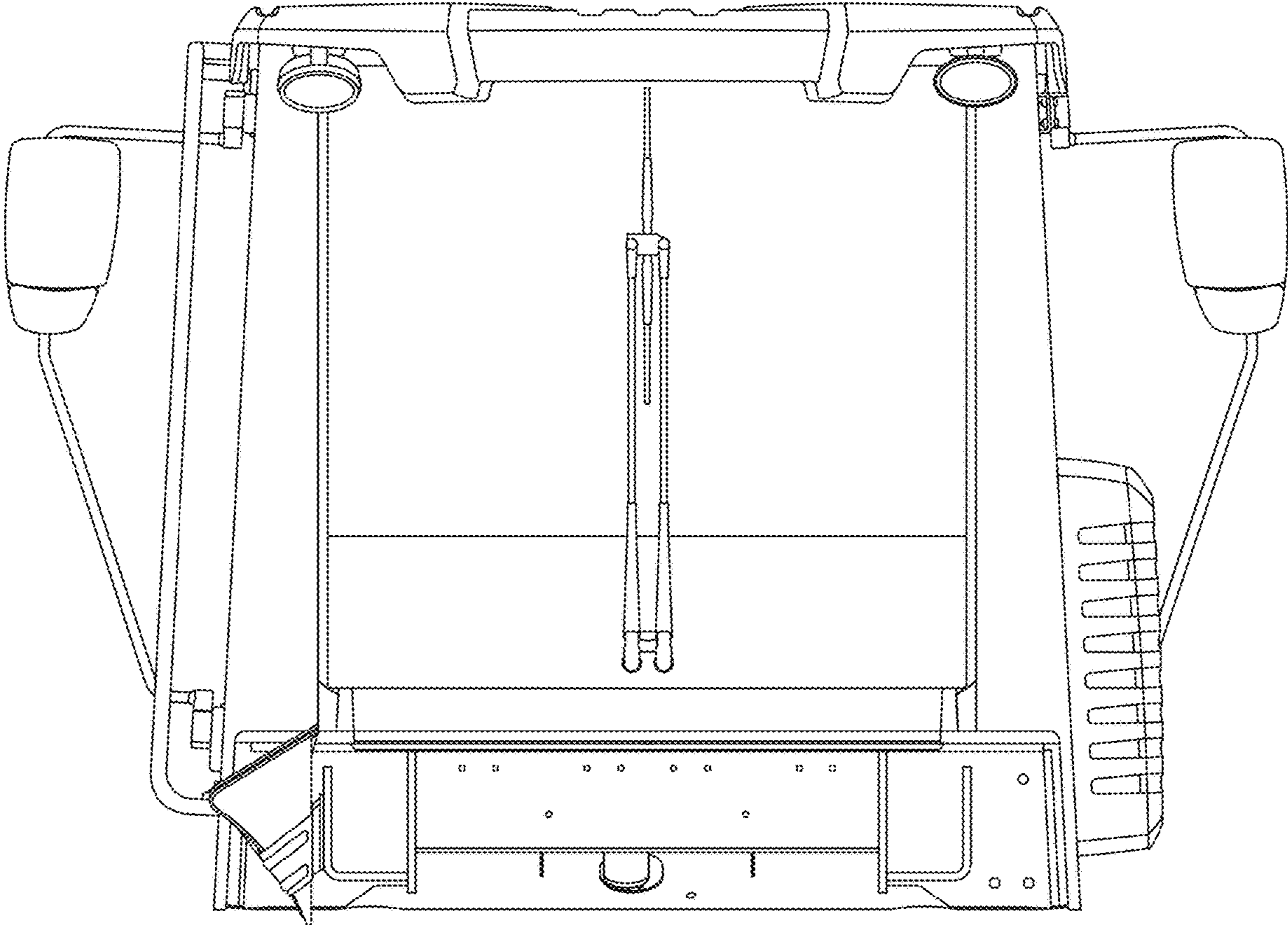

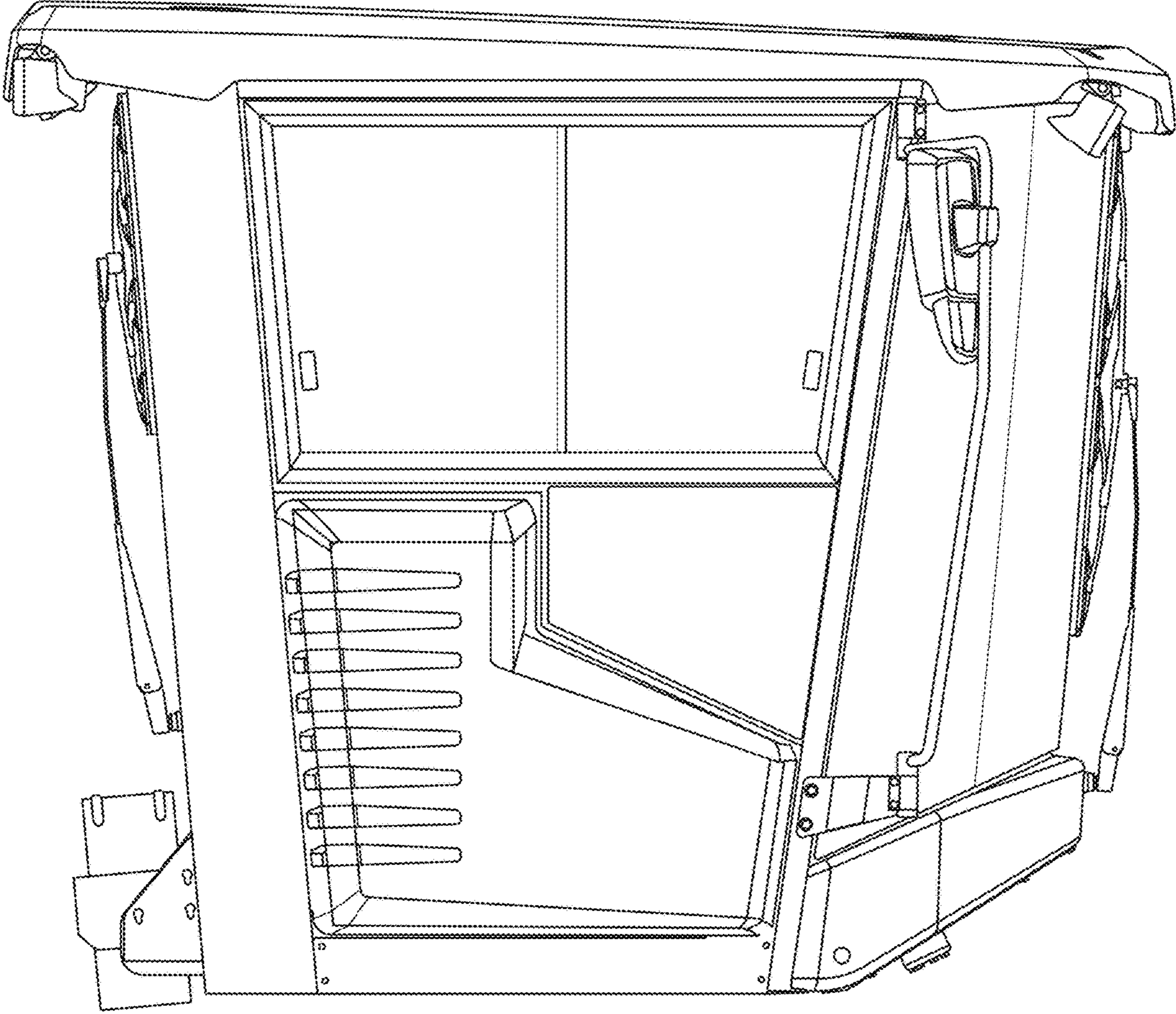

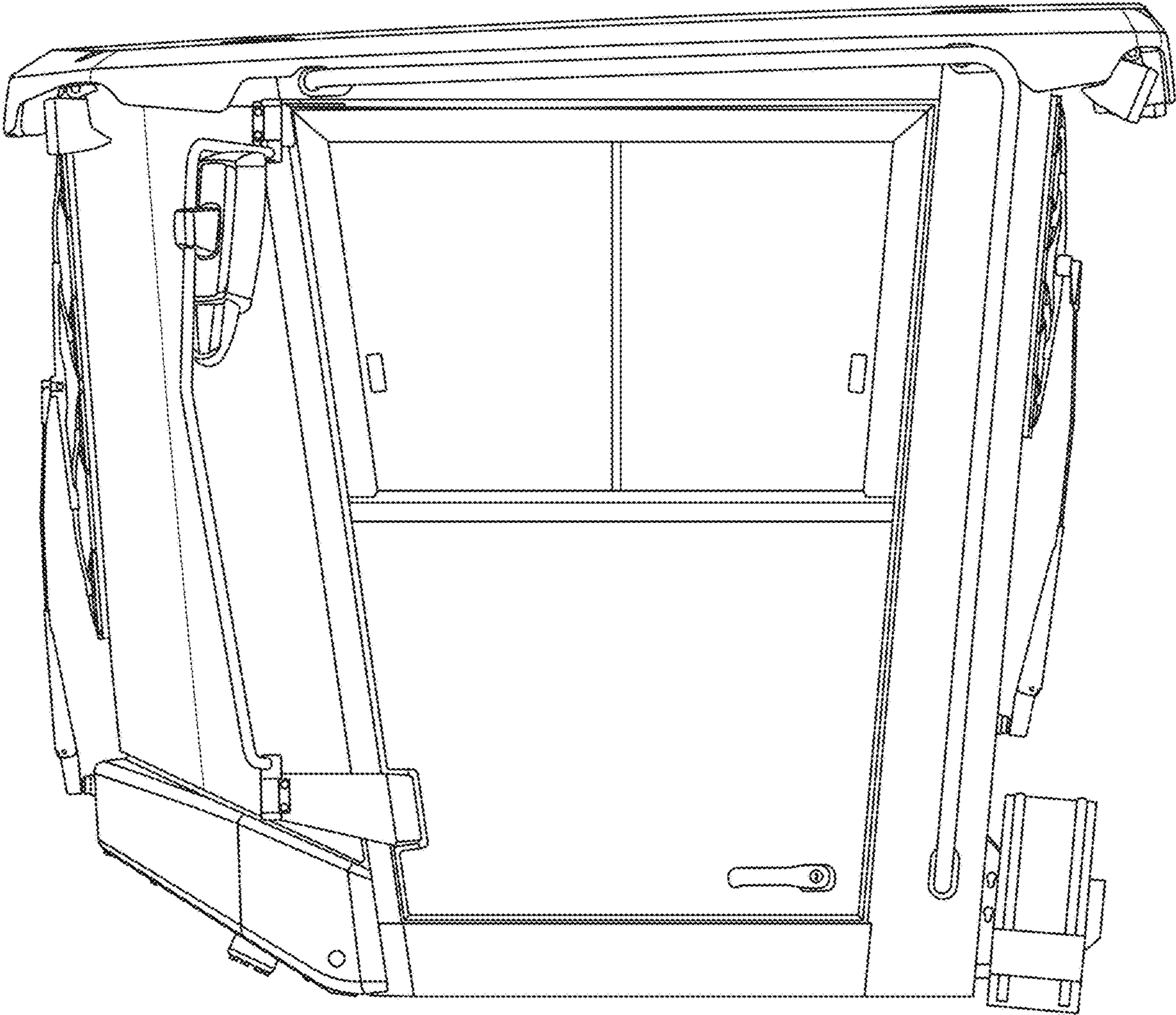

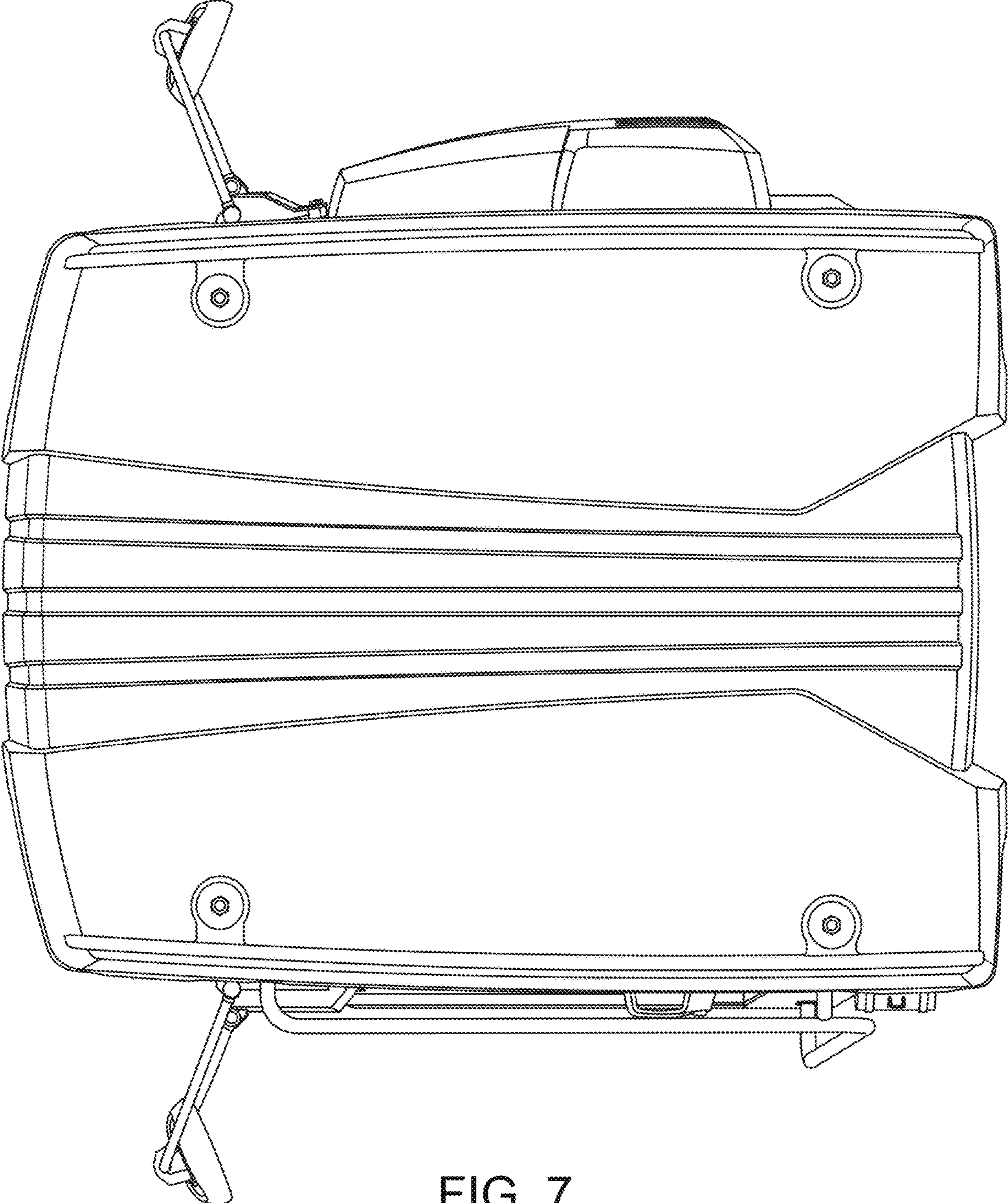
